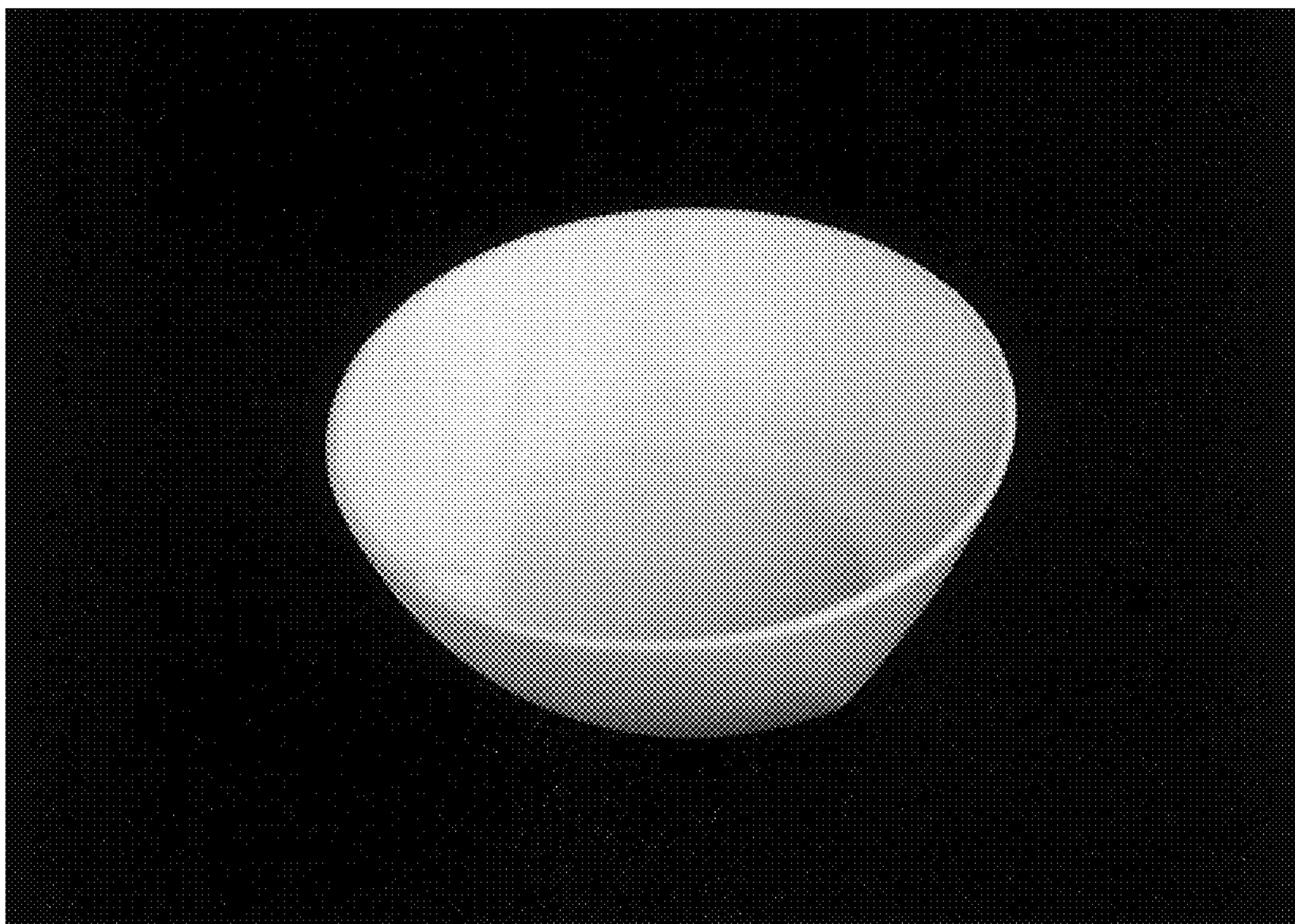
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top perspective view of a bowl showing a preferred embodiment of my design;
FIG. 2 is a top view of the bowl of FIG. 1;
FIG. 3 is a bottom view of the bowl of FIG. 1;
FIG. 4 is a front view of the bowl of FIG. 1, the rear view being a mirror image thereof; and,
FIG. 5 is a right view of the bowl of FIG. 1, the left view being a mirror image thereof.

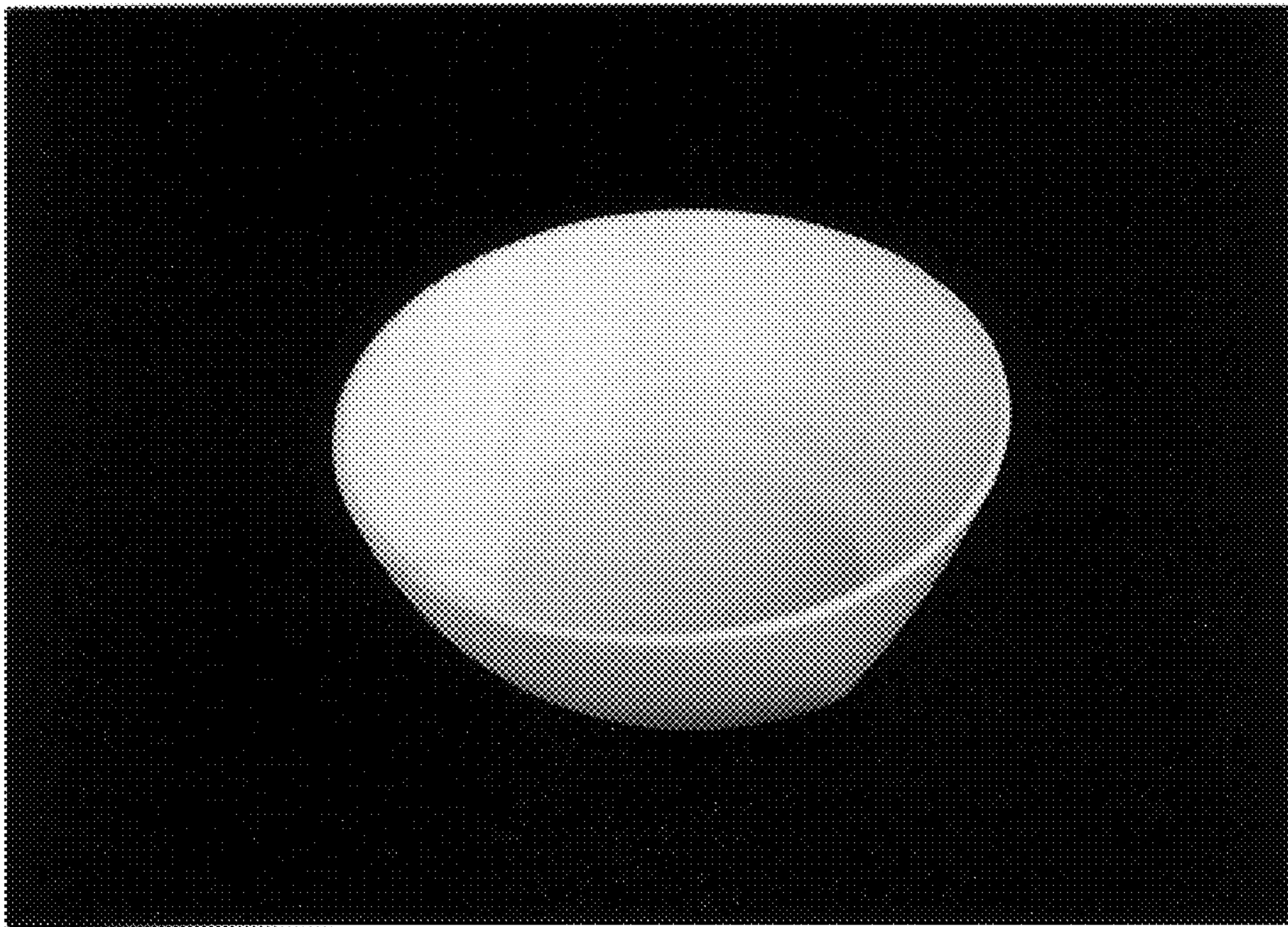

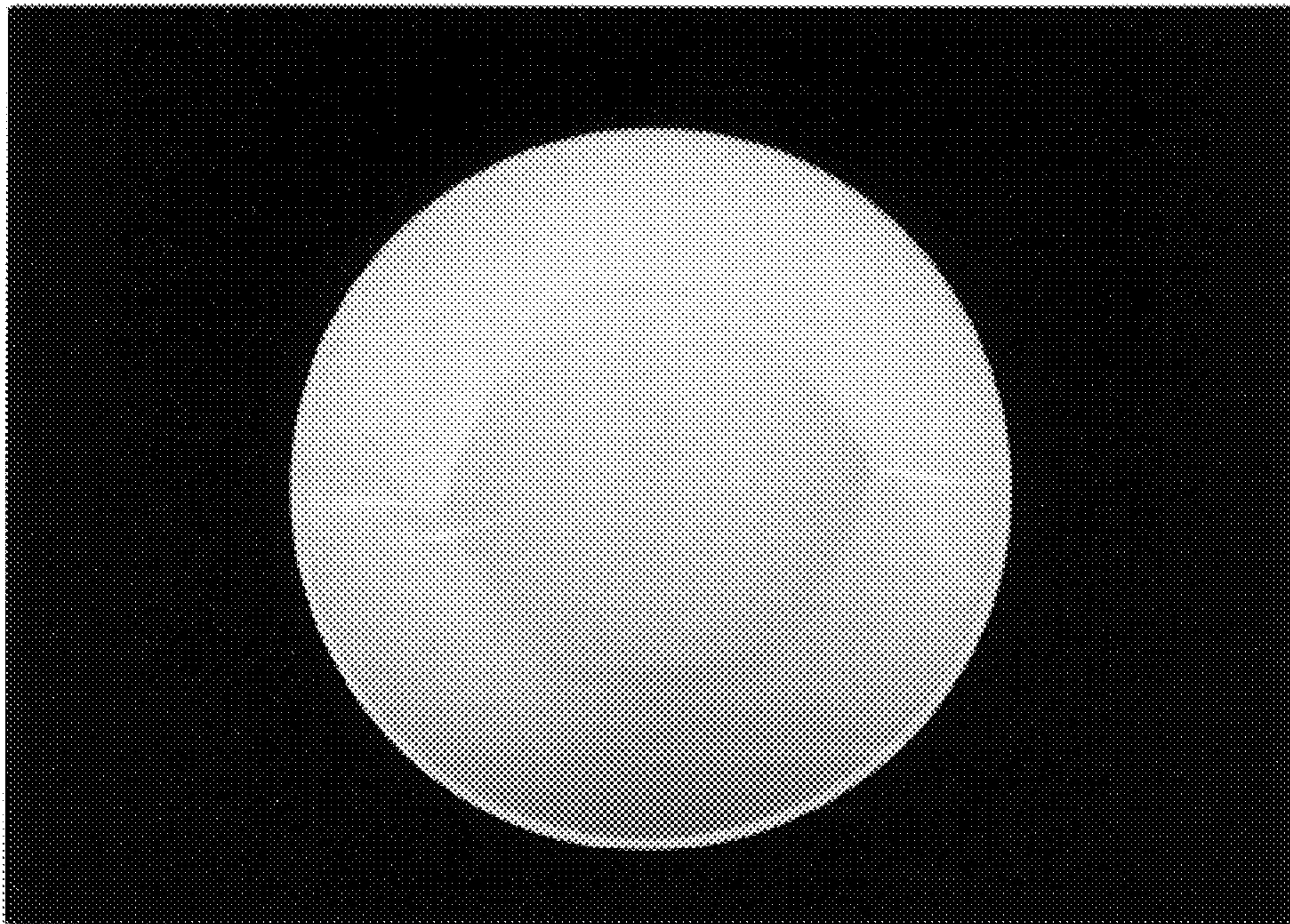

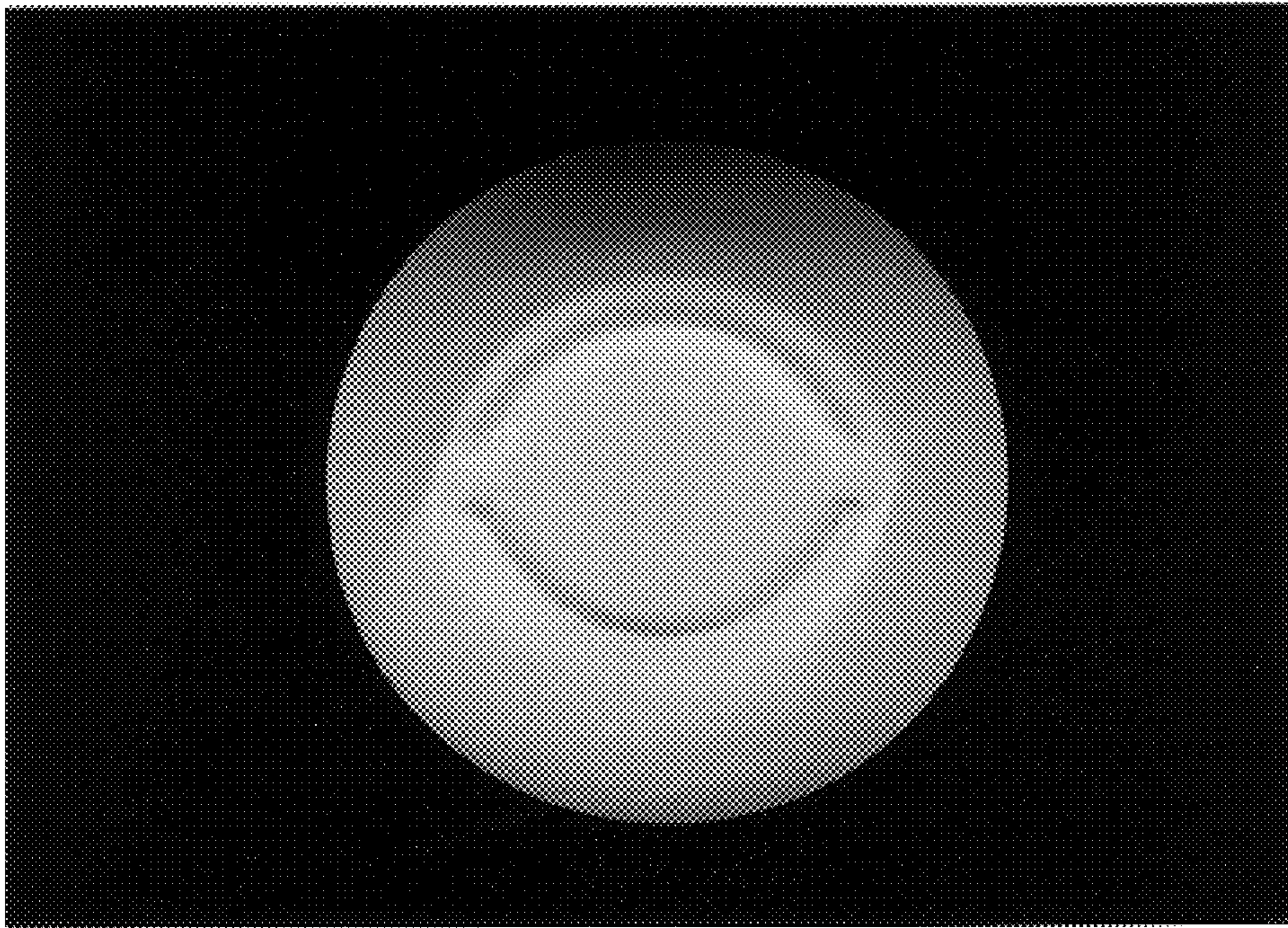

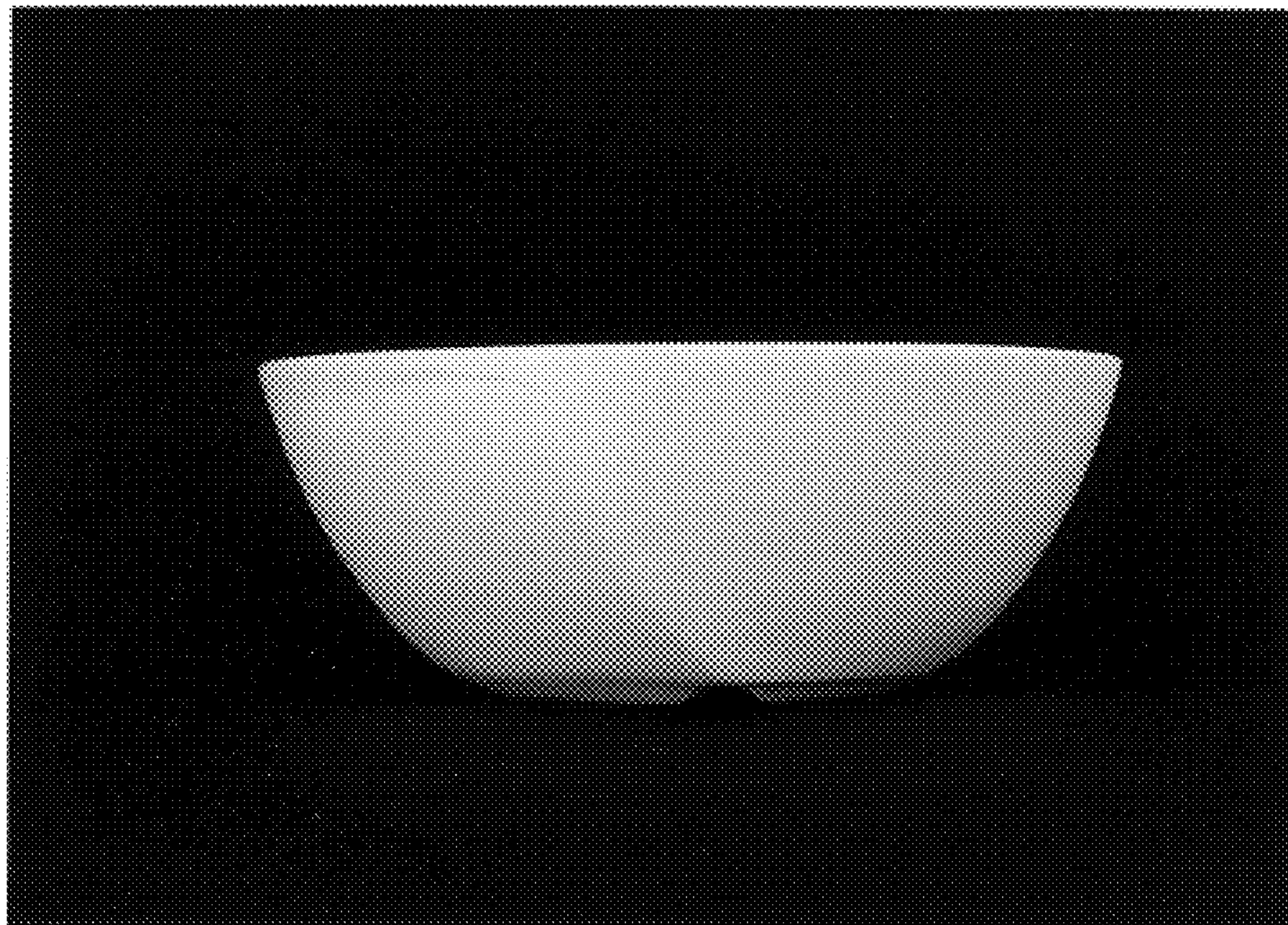

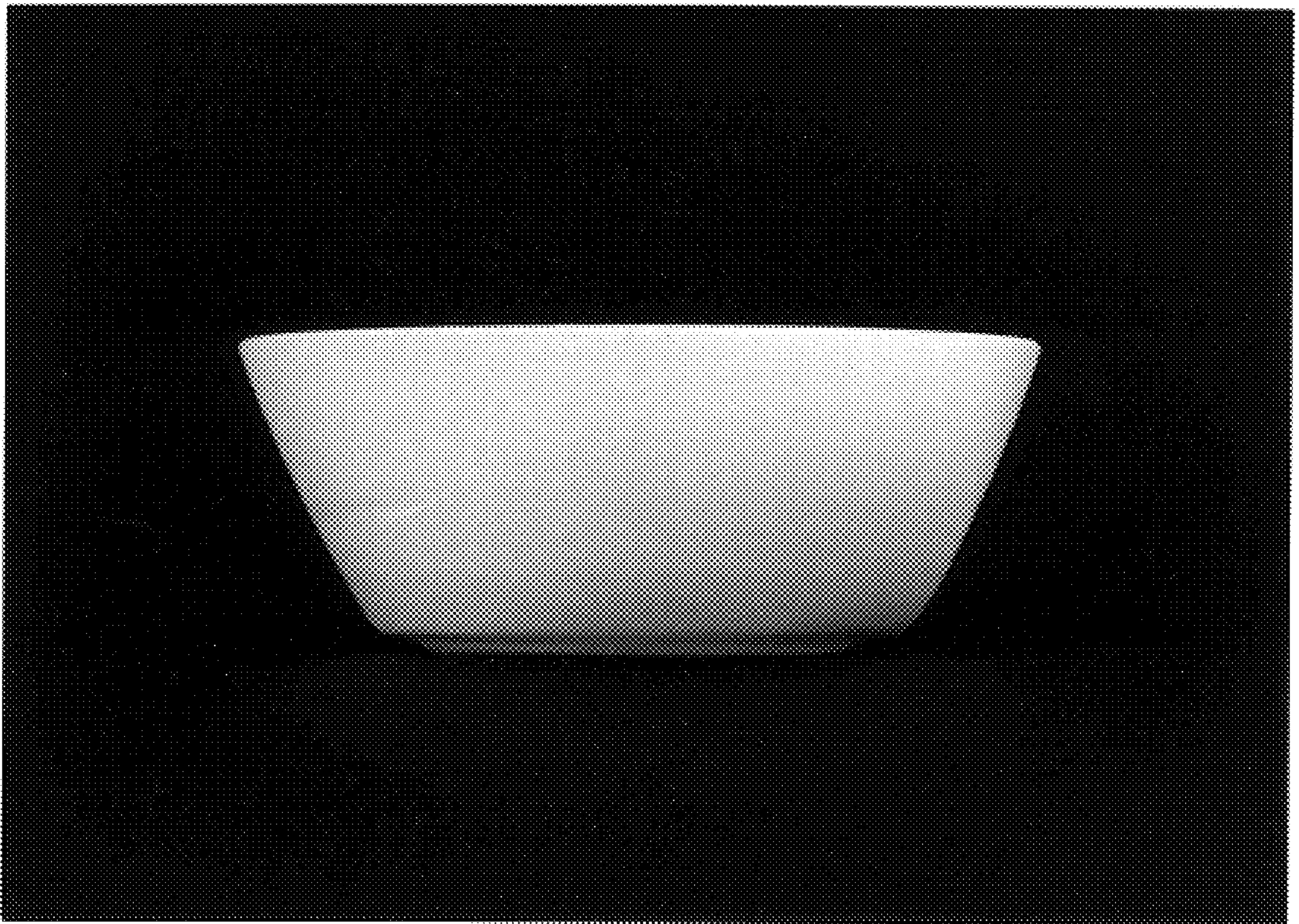
