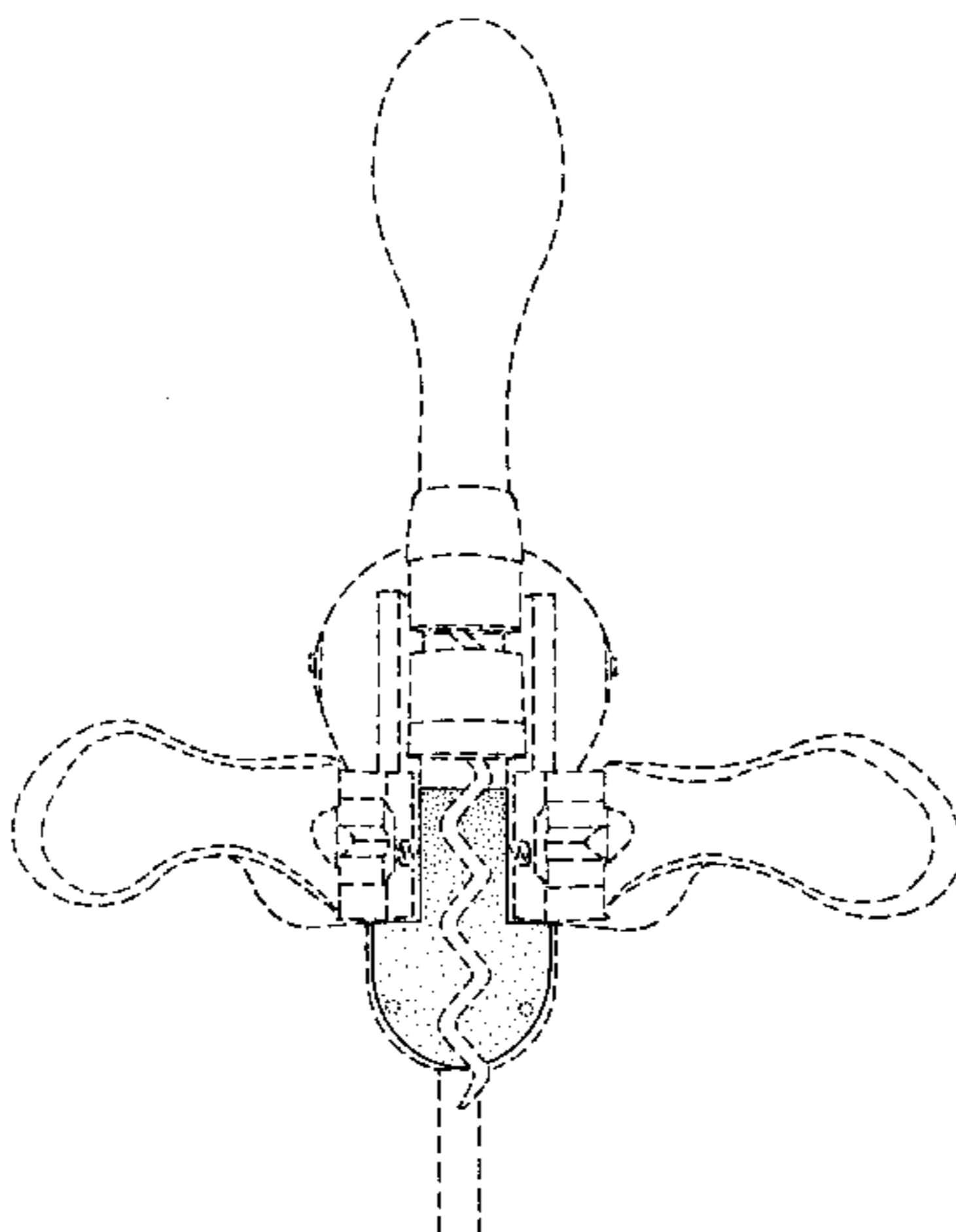
(57) **CLAIM**

The ornamental design for portion of cork extractor, as shown and described.

**DESCRIPTION**

FIG. 1 is a rear perspective view of a portion of cork extractor showing my new design; and, FIG. 2 is a right side and rear perspective view thereof, shown with the right side lower arm removed for clarity. The dashed lines shown in FIGS. 1-2 represent environmental subject matter and form no part of the claimed design. The dotted lines shown in FIGS. 1-2 represent the border between claimed subject matter and unclaimed environmental subject matter and form no part of the claimed design.

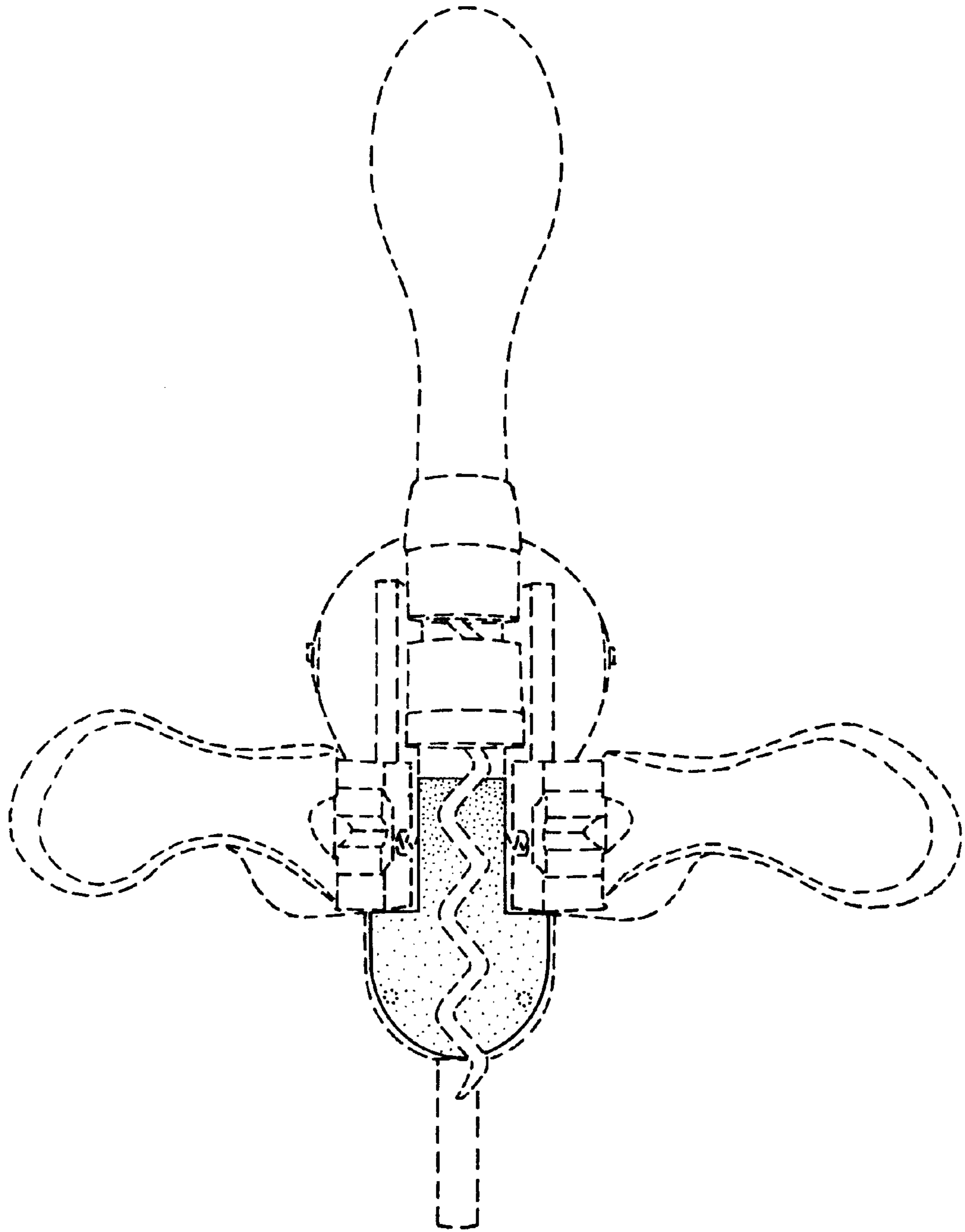

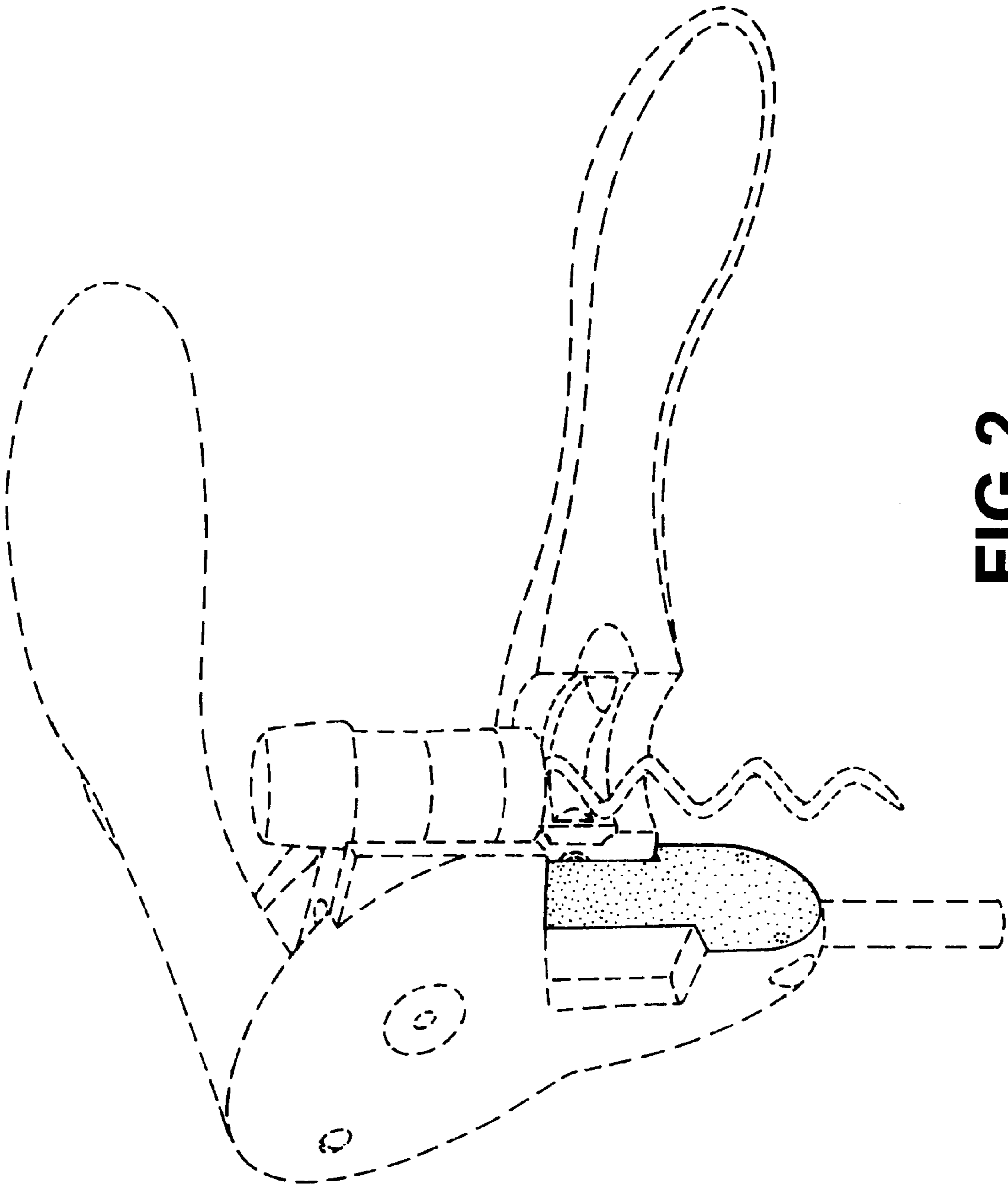
