**DESCRIPTION**

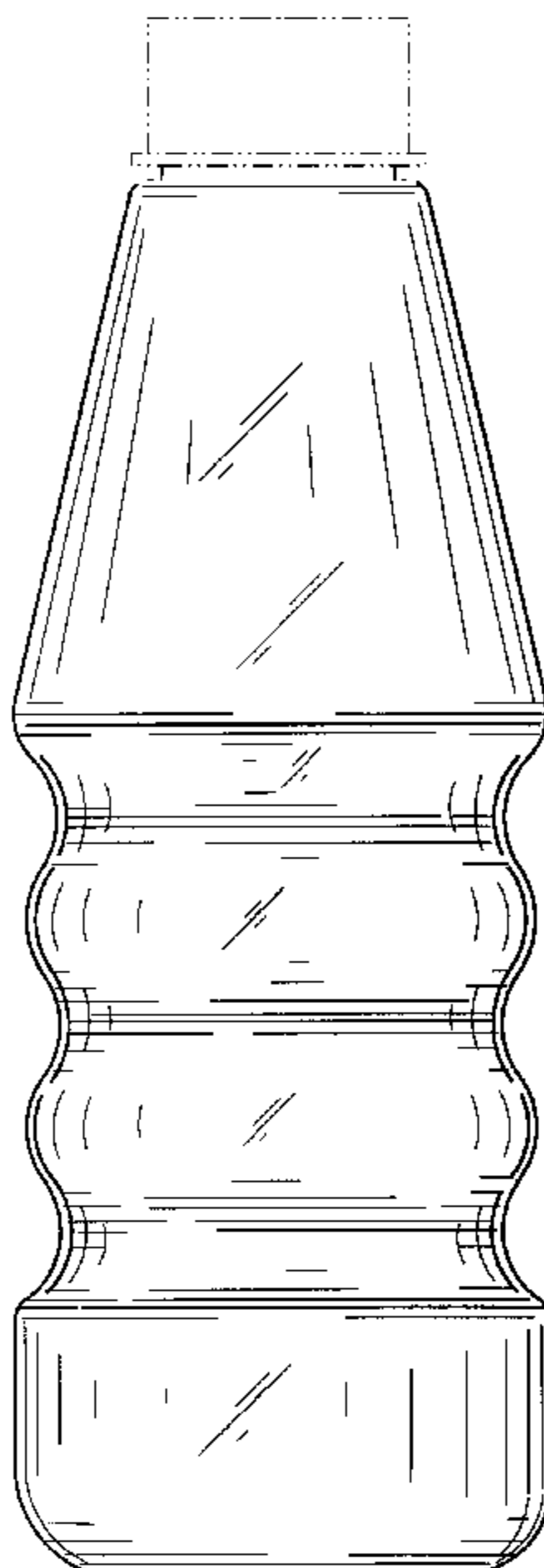
FIG. 1 is a perspective view of a bottle showing our new design;

FIG. 2 is a front elevational view of the bottle depicted in FIG. 1, the rear and side elevational views being identical; FIG. 3 is a top plan view of the bottle depicted in FIG. 2; and,

FIG. 4 is a bottom plan view of the bottle depicted in FIG. 2.

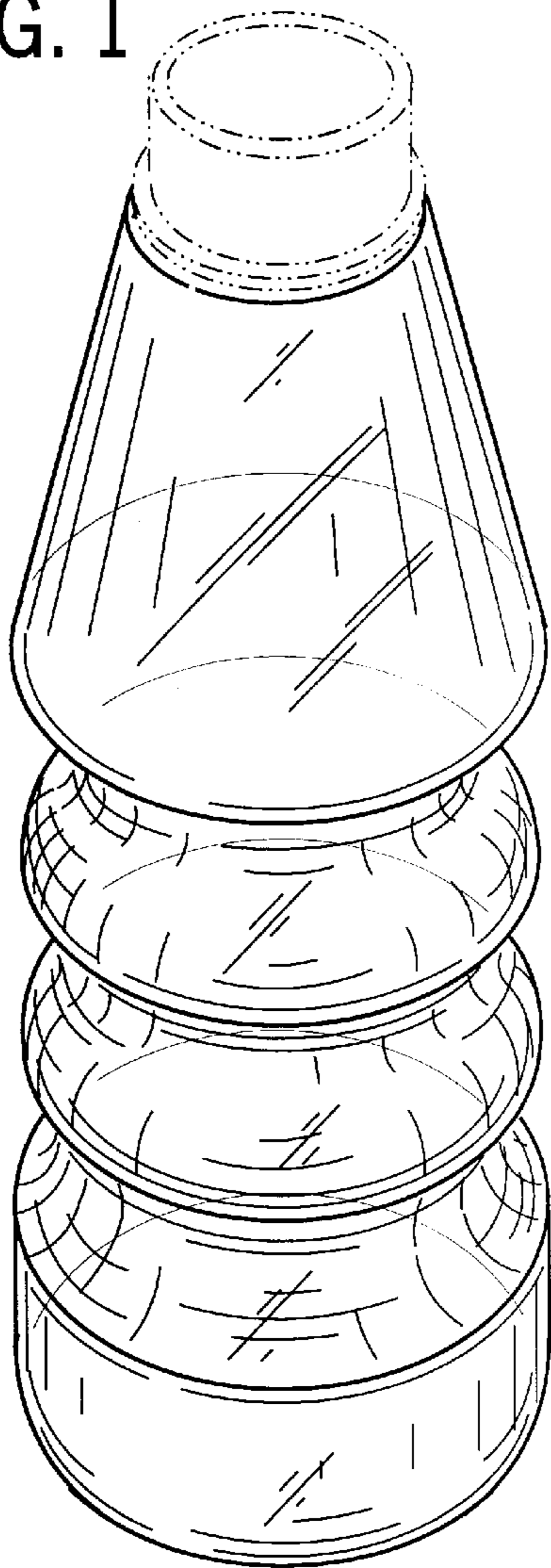

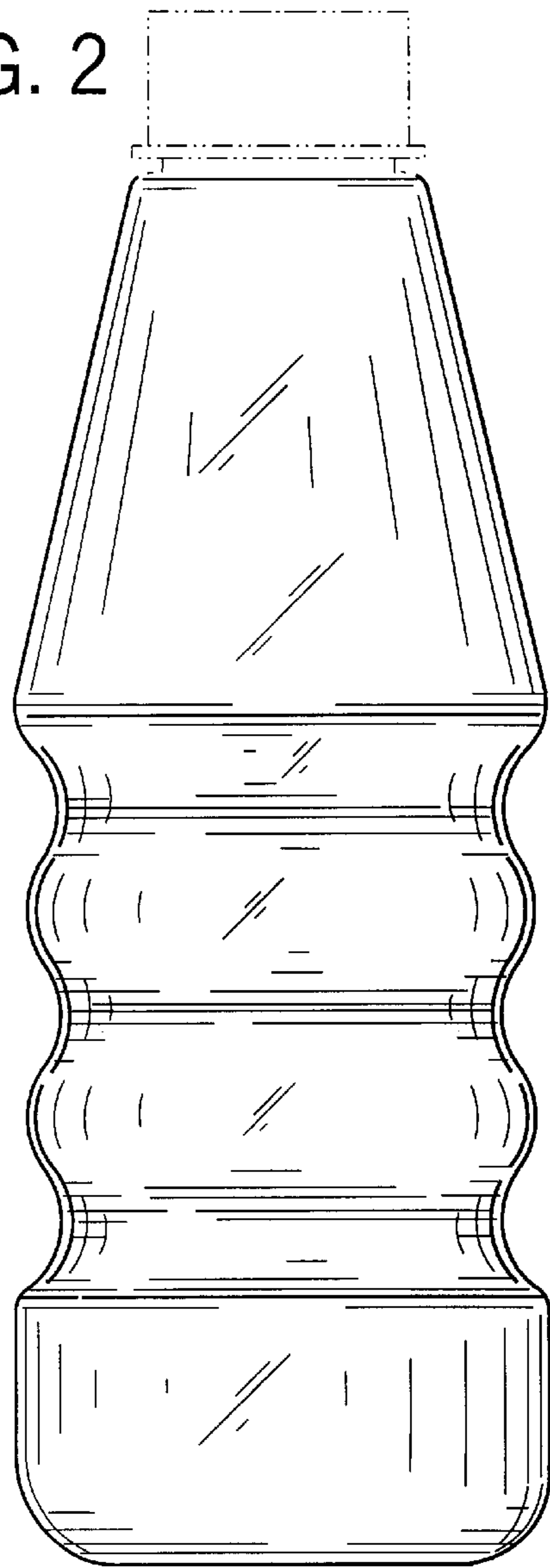

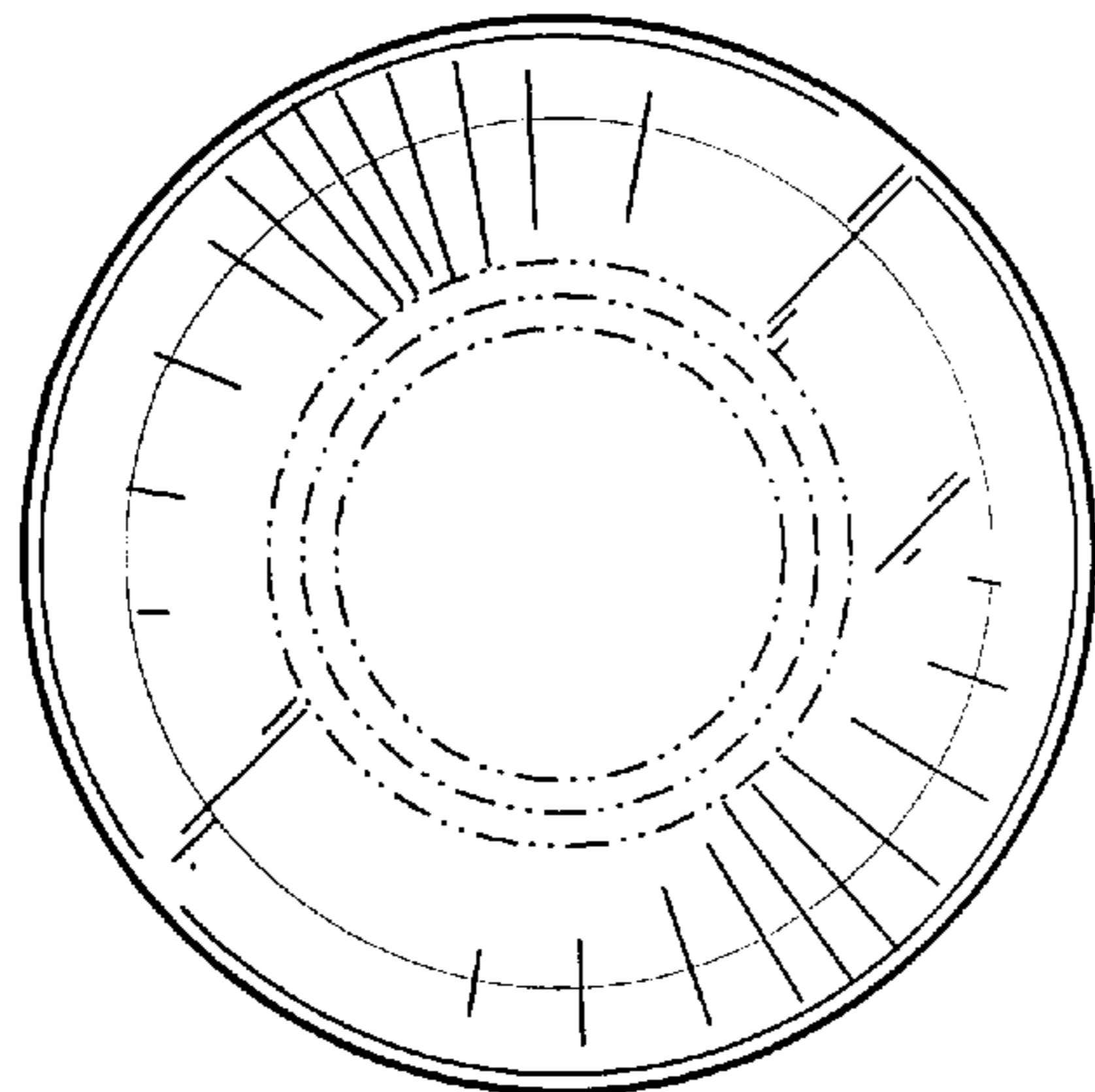
