FIG. 5 is a right side view of the night light volatile dispenser of FIG. 1.

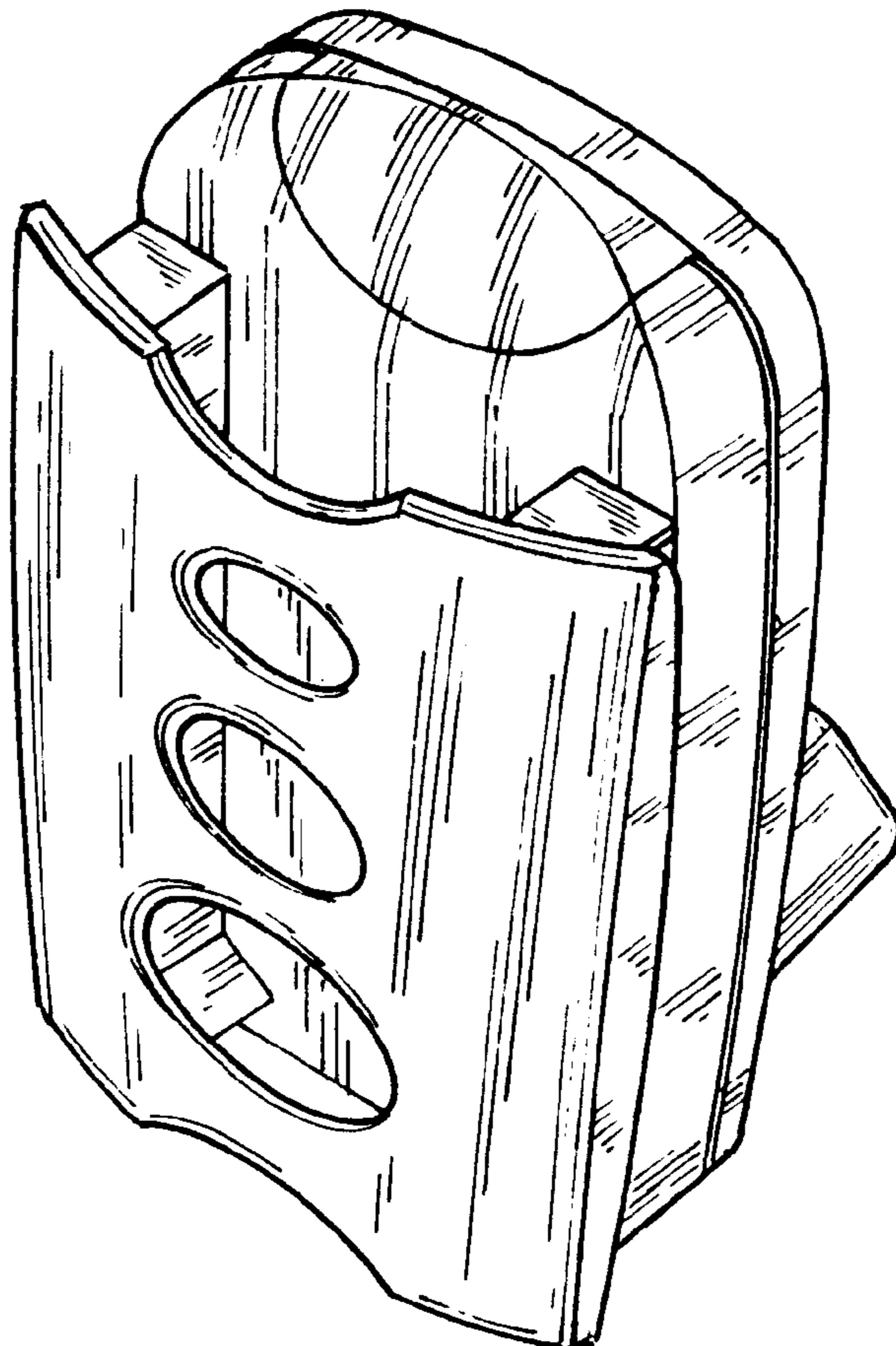
FIG. 6 is a top plan view of the night light volatile dispenser of FIG. 1; and,

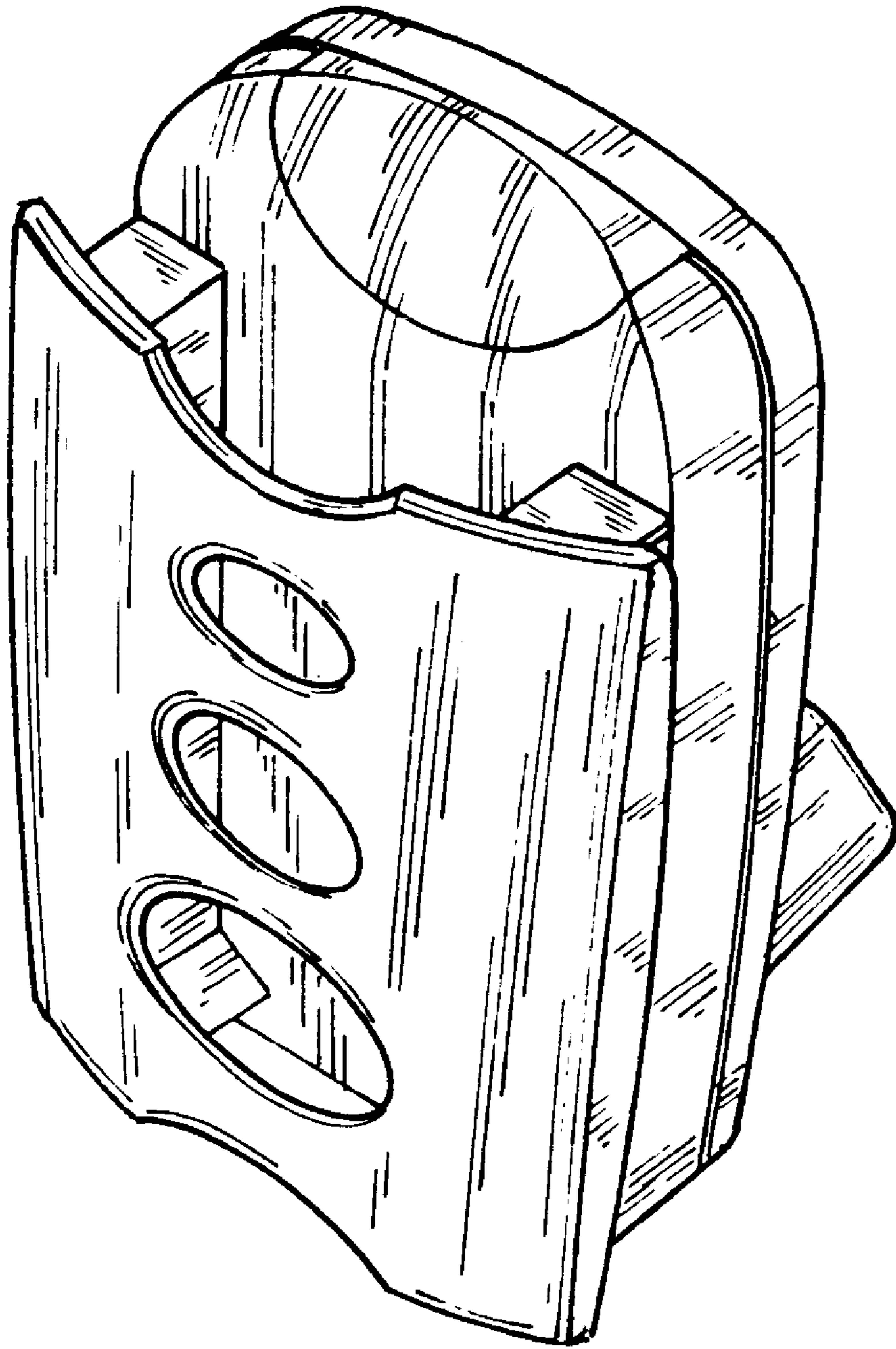

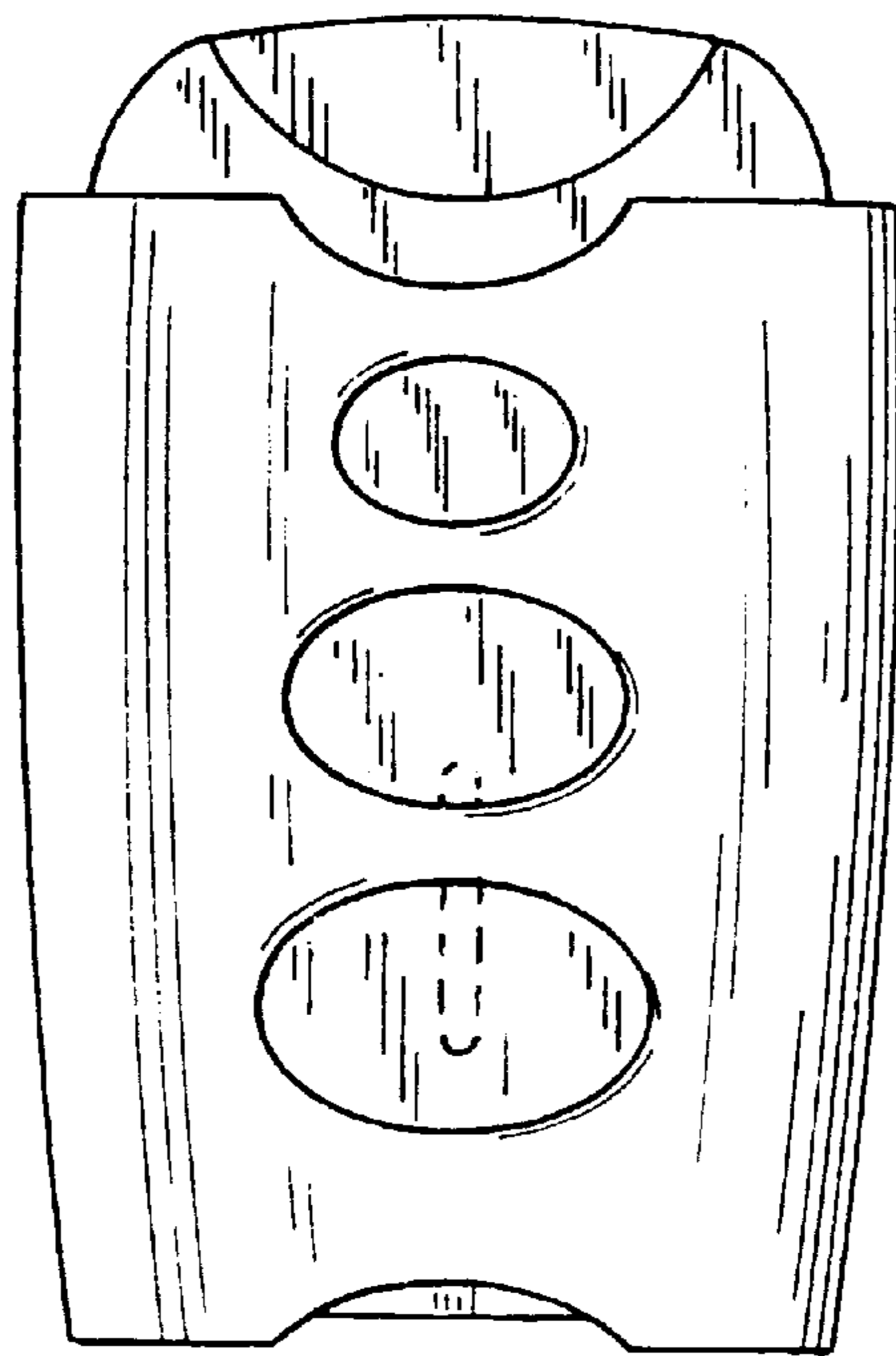

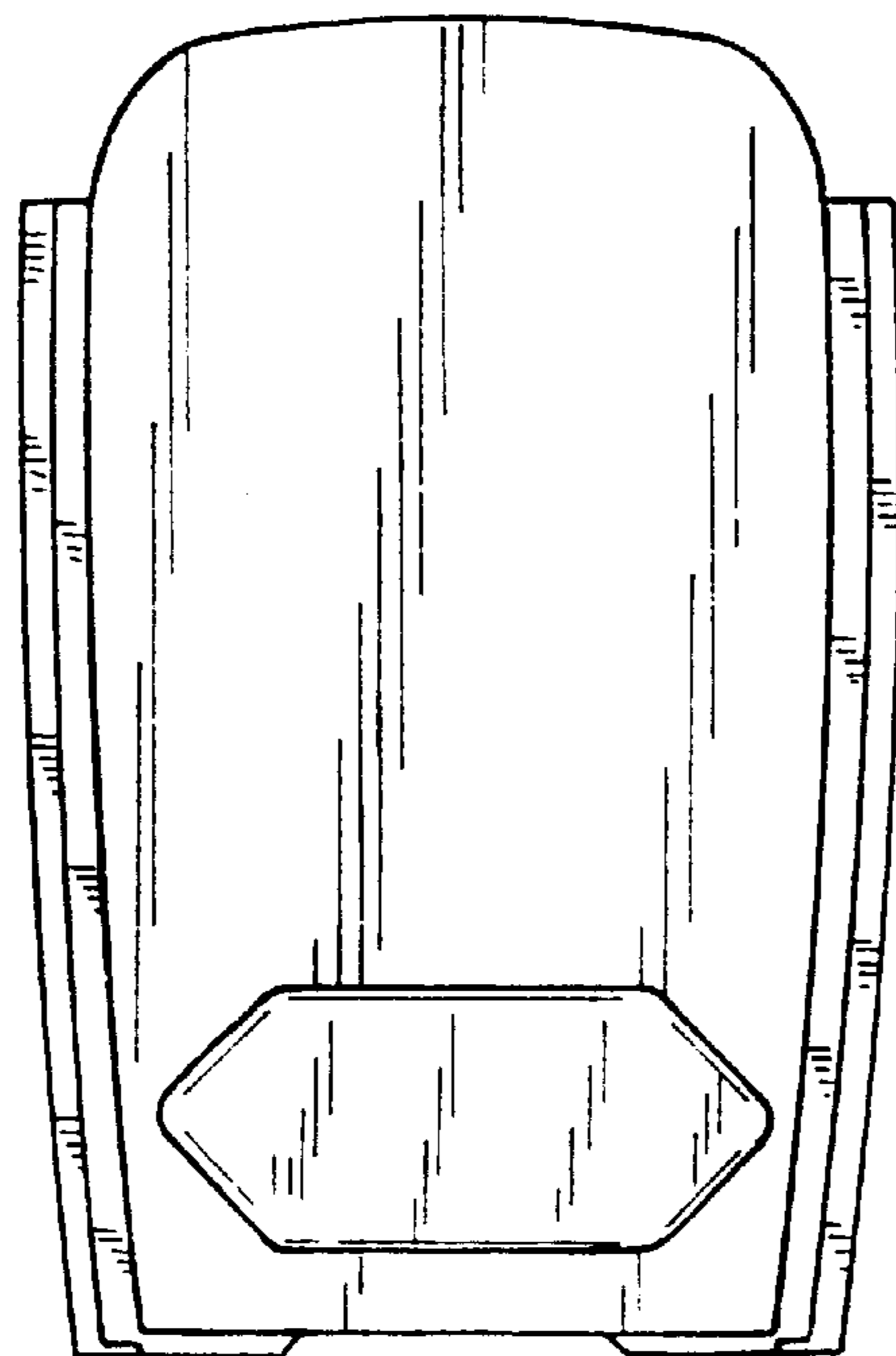

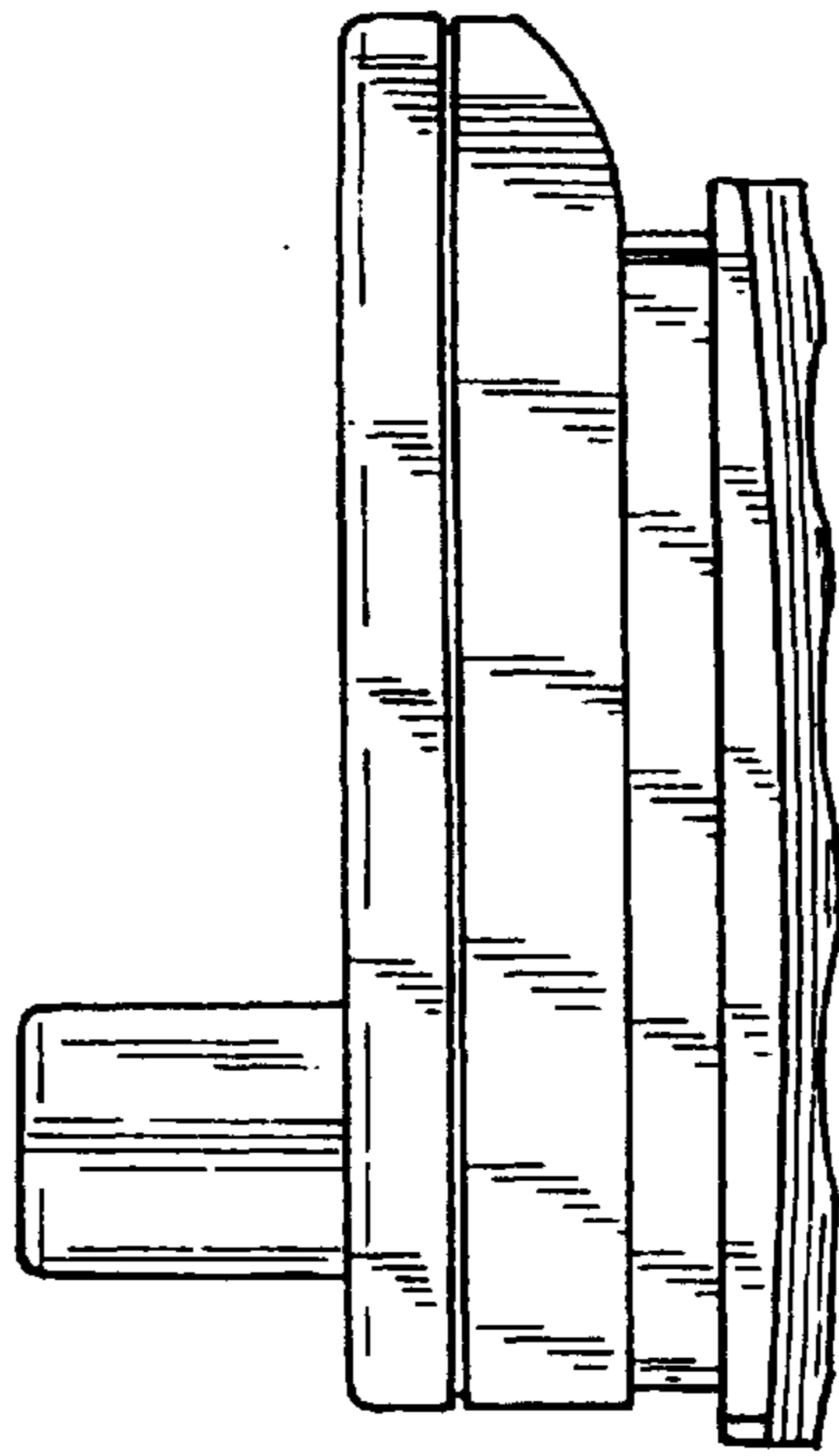

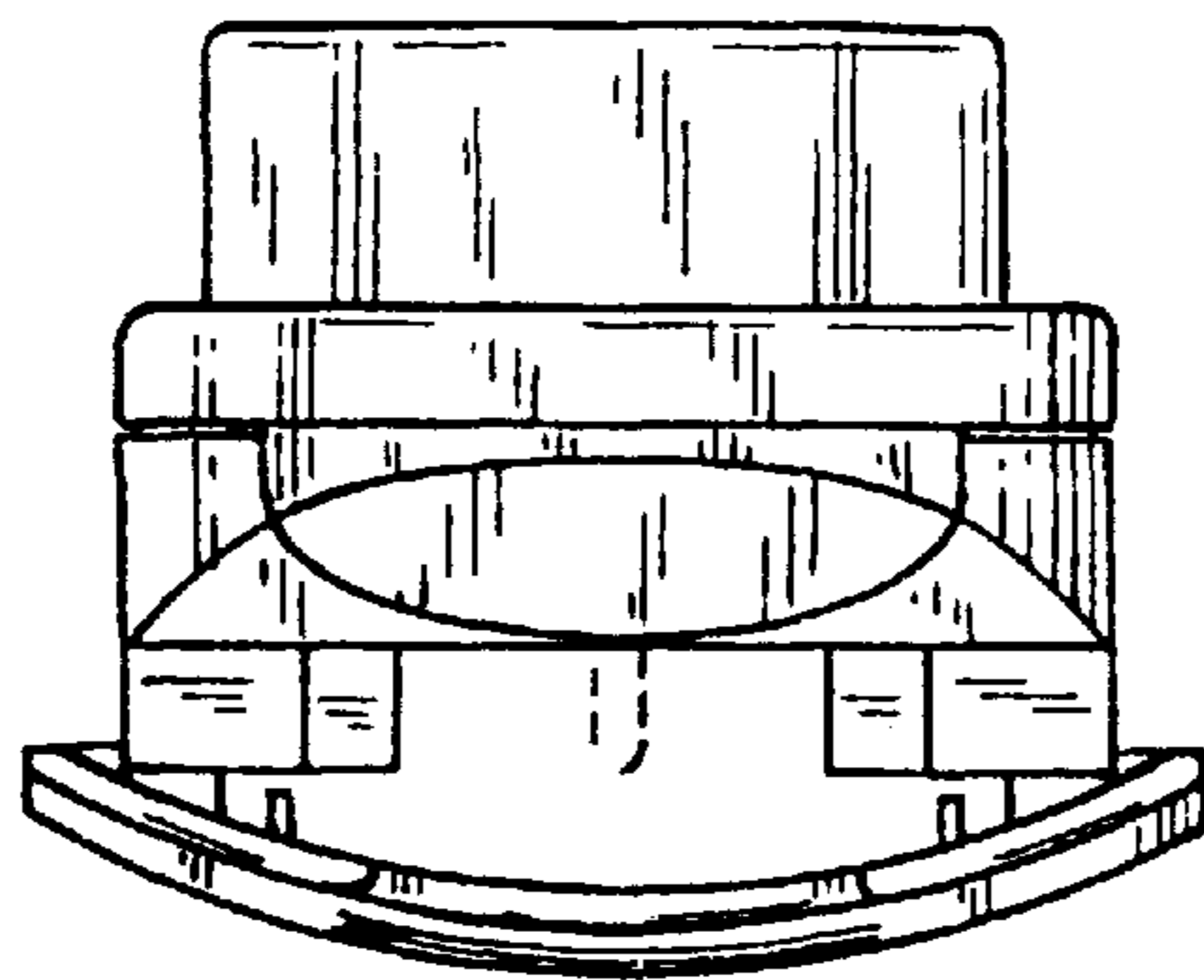

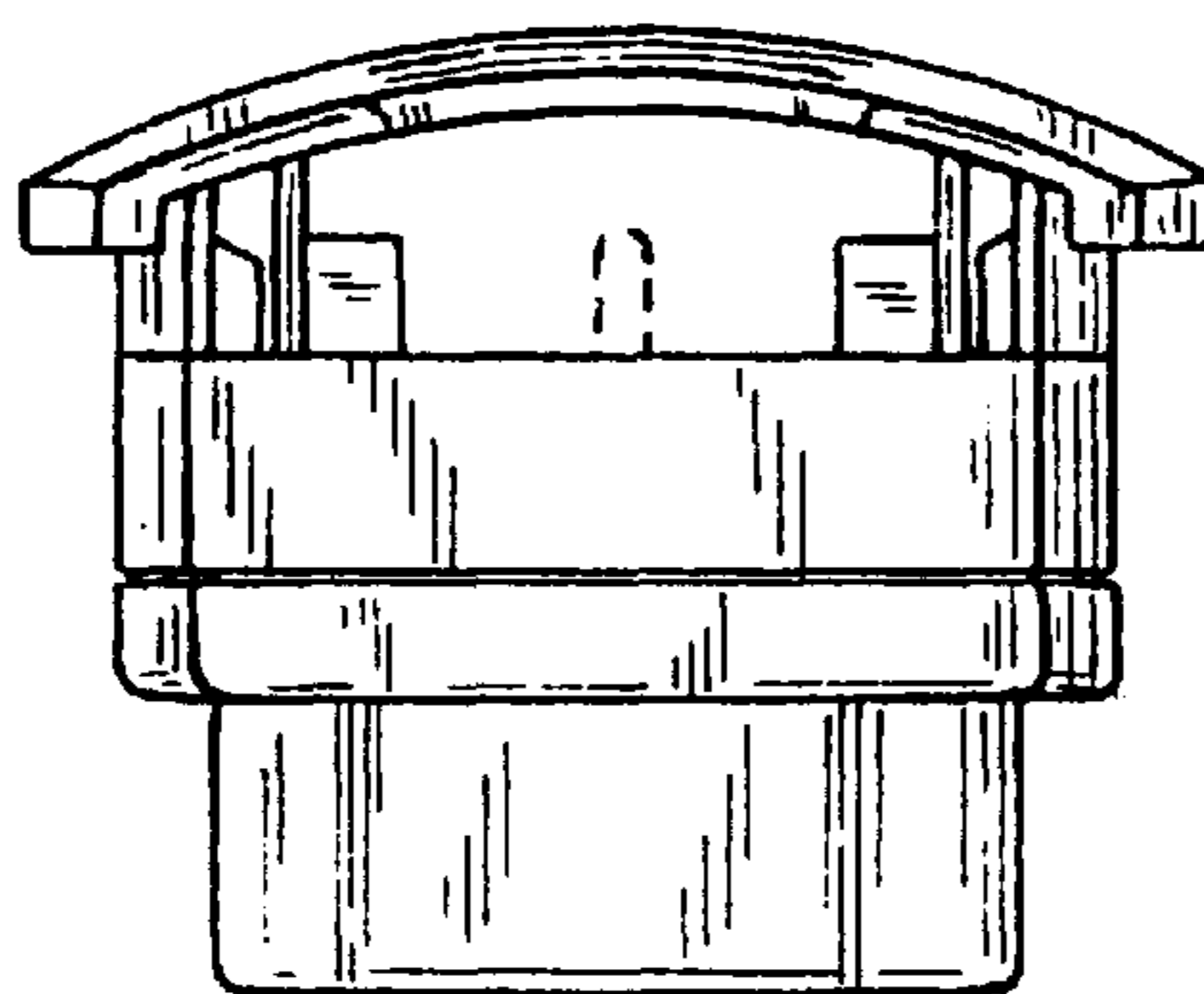

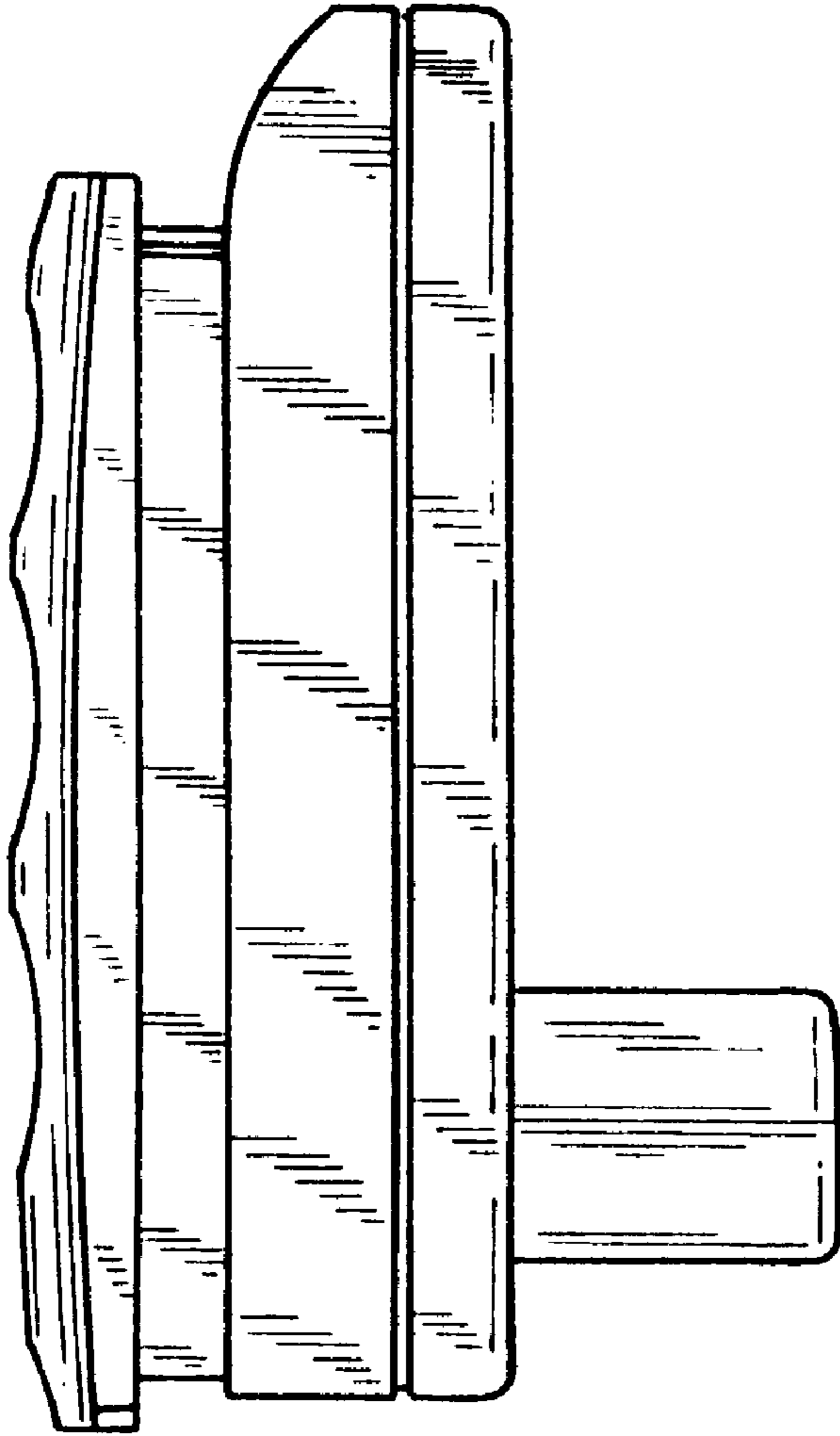
