The ornamental design for the pendant lighting fixture, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view from below of the pendant lighting fixture in accordance with my design;

FIG. 2 is a top plan view of the pendant lighting fixture in accordance with my design;

FIG. 3 is a front elevational view of the pendant lighting fixture in accordance with my design;

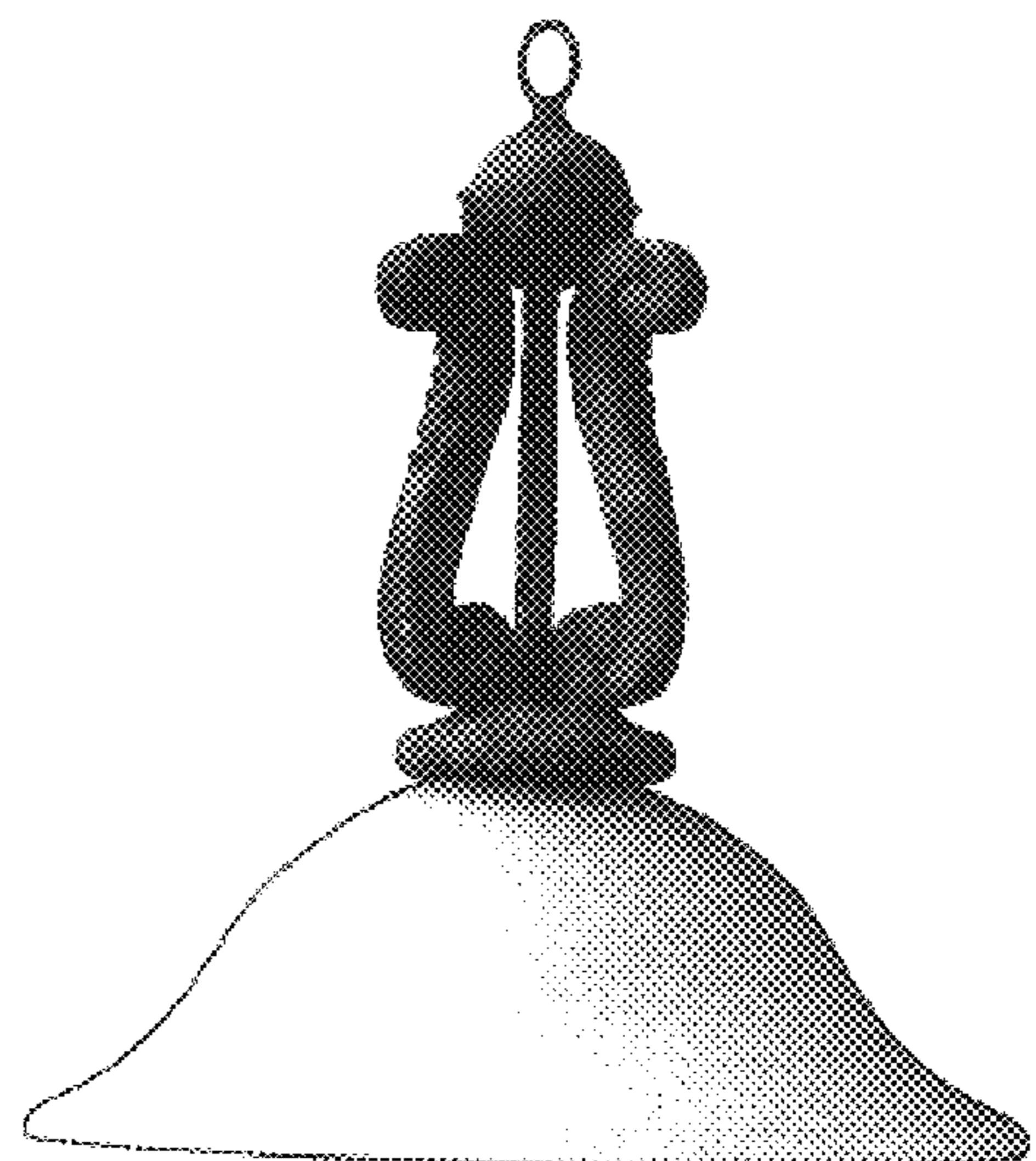
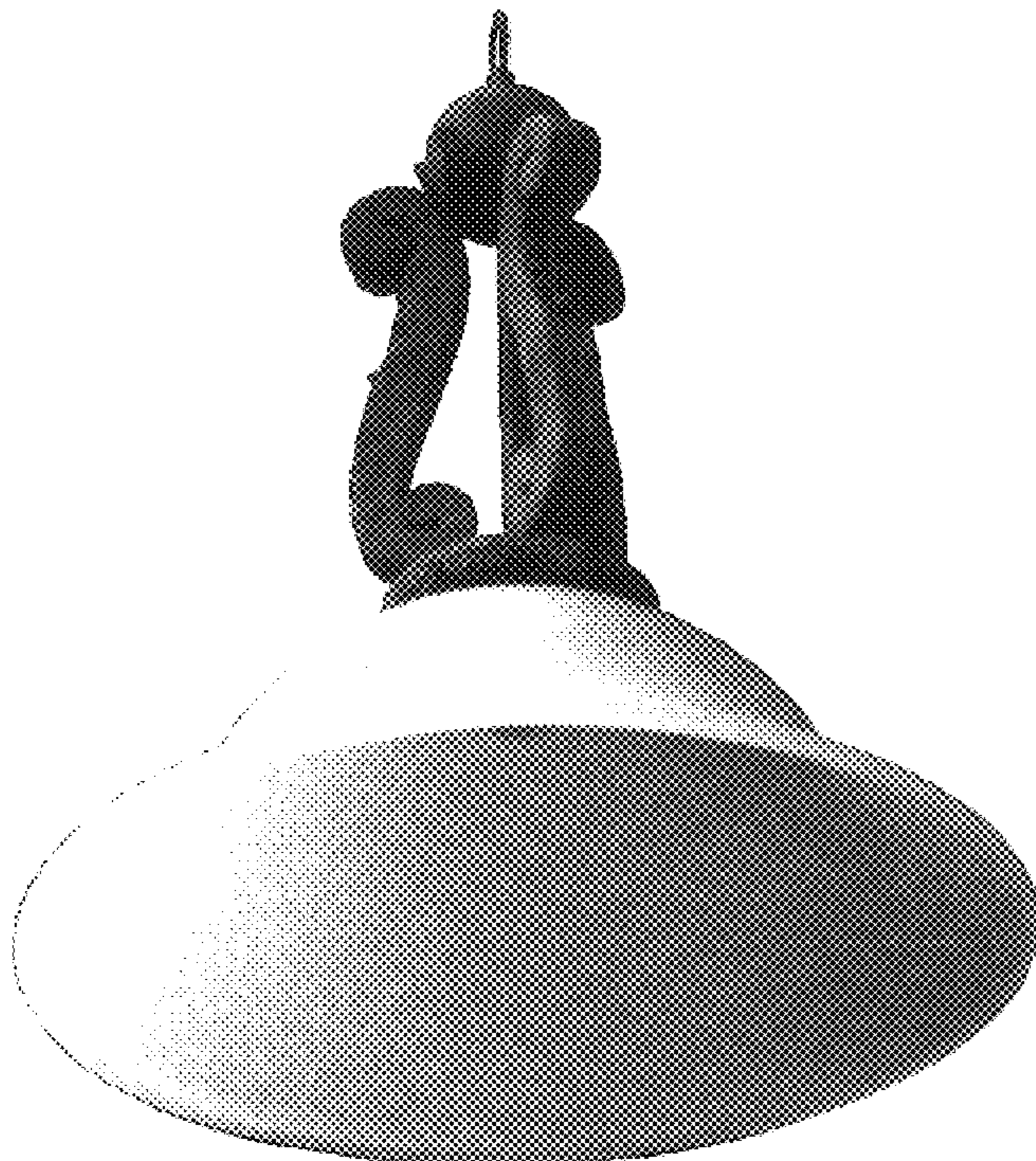
FIG. 4 is a left elevational view of the pendant lighting fixture in accordance with my design; and,

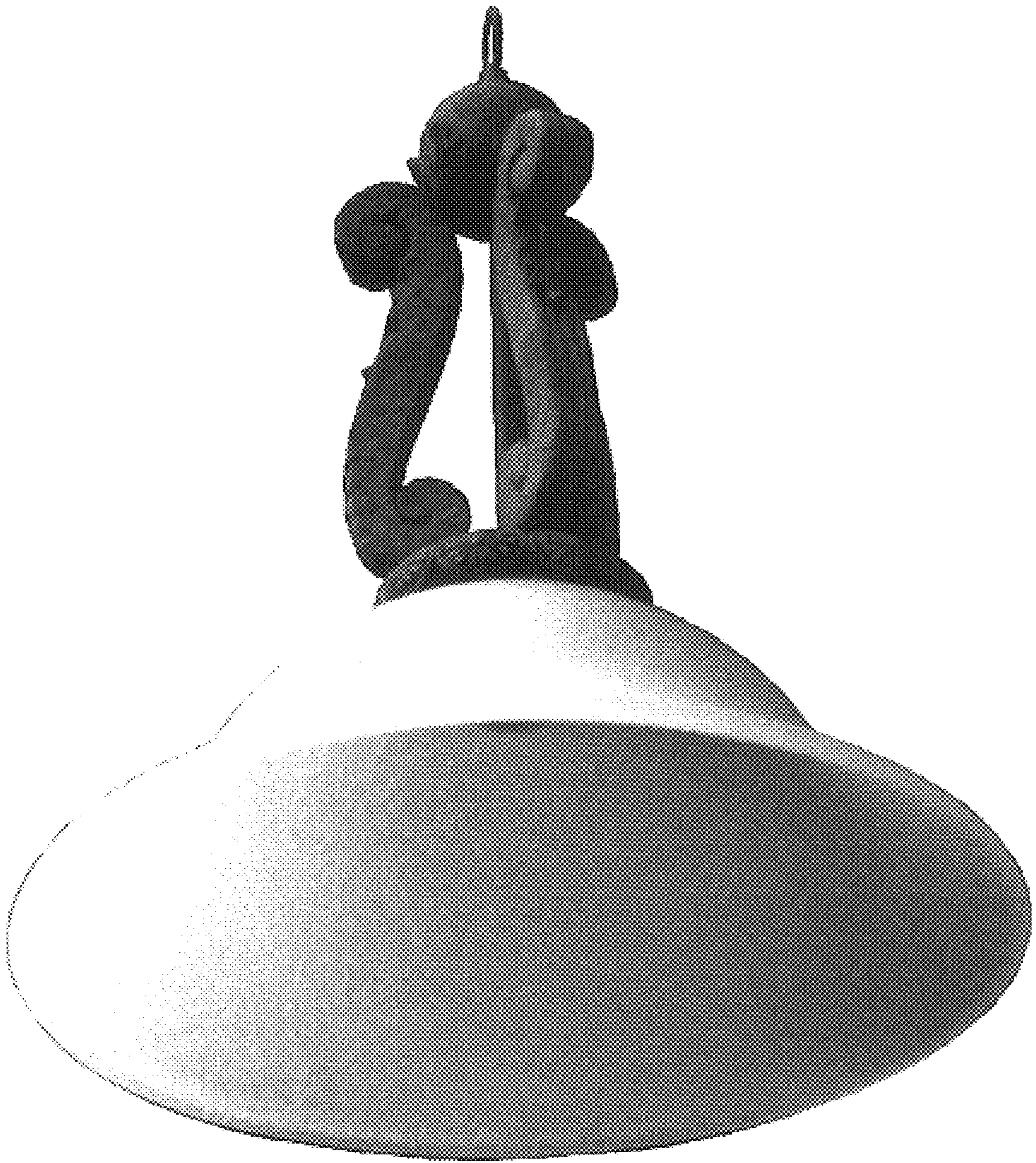

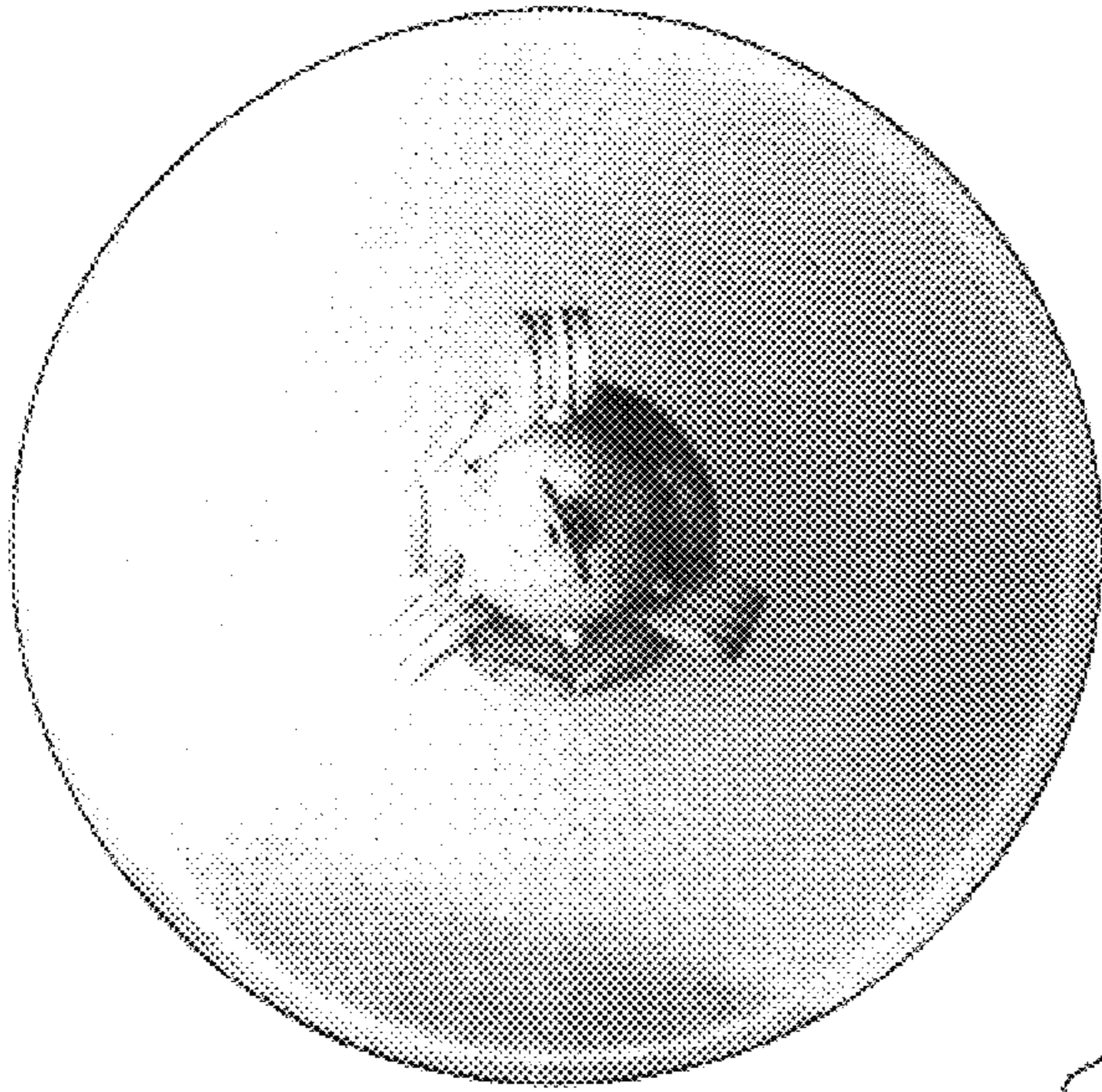

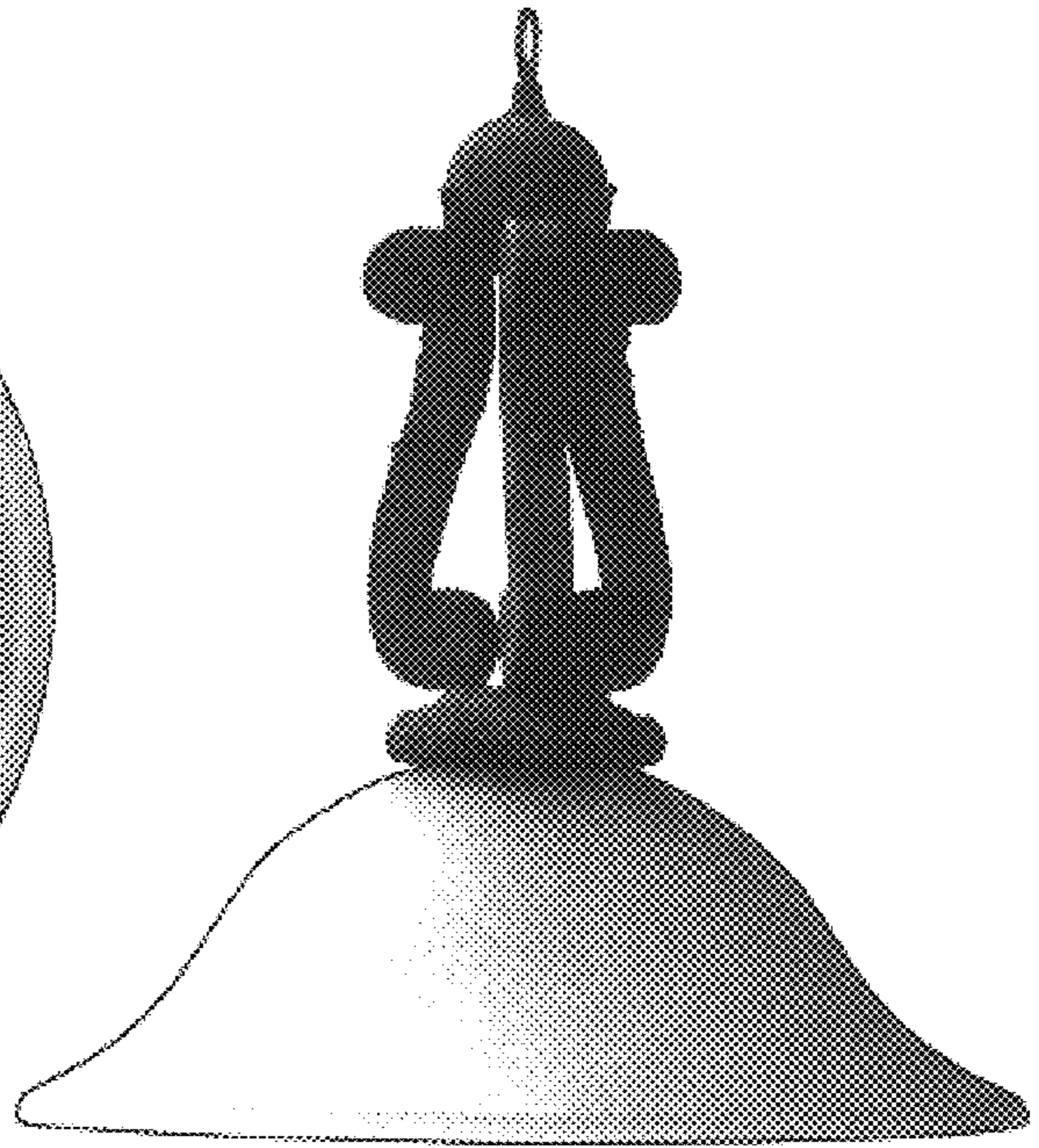

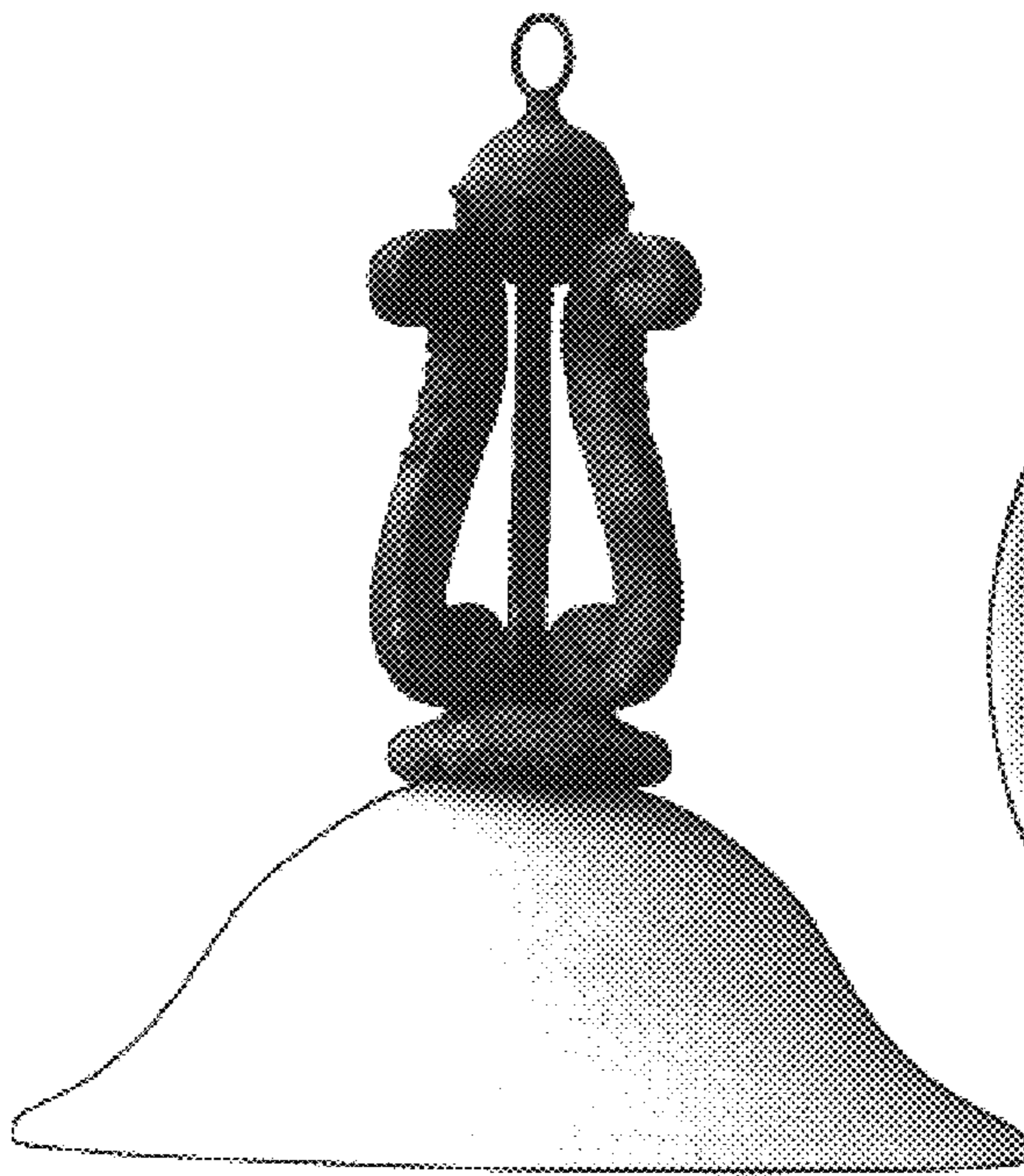

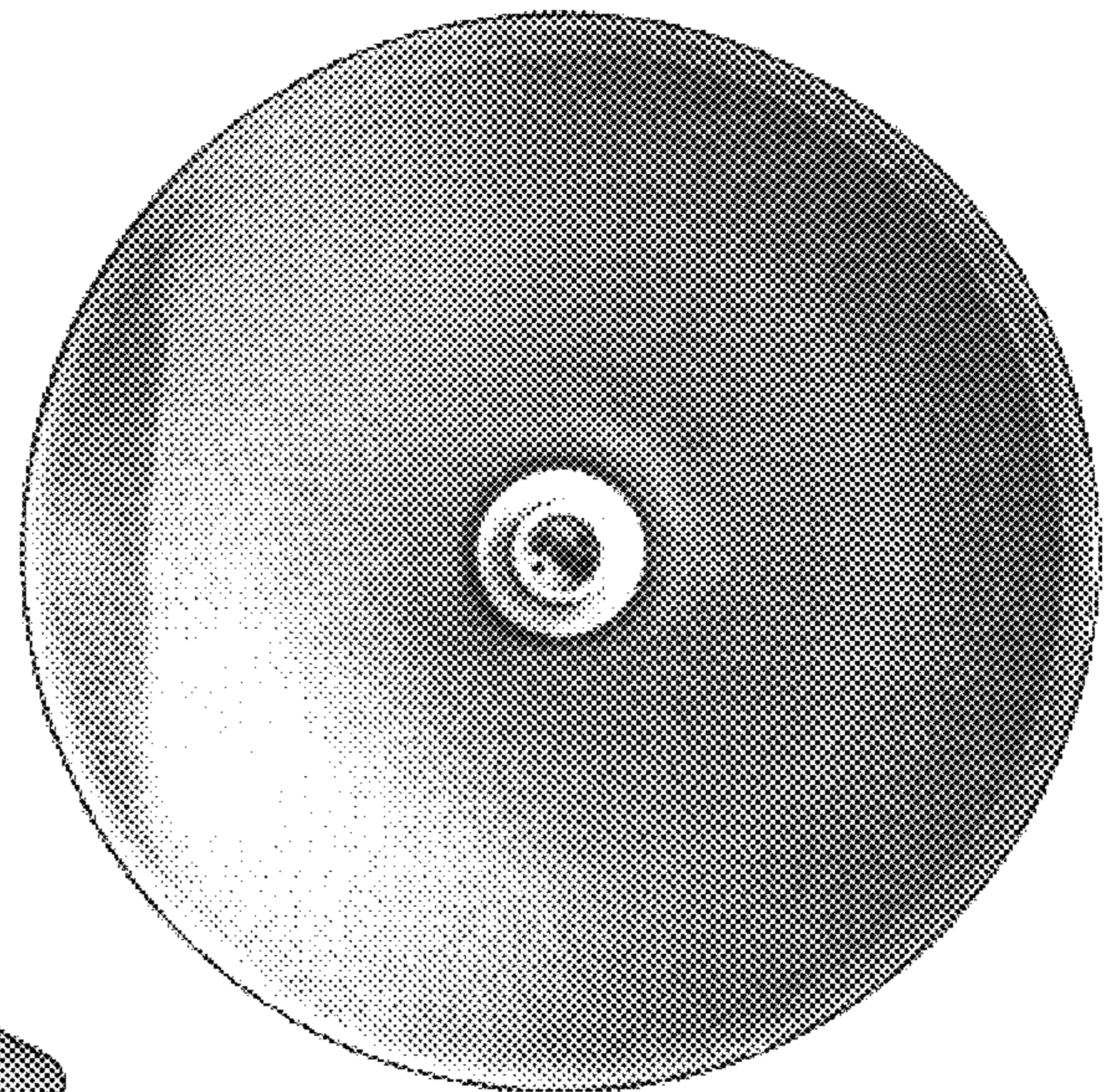
