(57) **CLAIM**

The ornamental design for cigarette pack, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view showing the new cigarette pack design, with the lid in the open position;

FIG. 2 is a right side view thereof, with the lid closed;

FIG. 3 is a front view thereof, with the lid closed;

FIG. 4 is a left-side view thereof, with the lid closed;

FIG. 5 is a bottom view thereof, with the top view being a mirror image thereof;

FIG. 6 is a rear view thereof, with the lid closed.

FIG. 7 is a perspective view showing the second embodiment of the new cigarette pack design, with the lid in the open position;

FIG. 8 is a right side view thereof, with the lid closed;

FIG. 9 is a front view thereof, with the lid closed;

FIG. 10 is a left-side view thereof, with the lid closed;

FIG. 11 is a bottom view thereof, with the top view being a mirror image thereof;

FIG. 12 is a rear view thereof, with the lid closed.

FIG. 13 is a perspective view showing the third embodiment of the new cigarette pack design, with the lid in the open position;

FIG. 14 is a right side view thereof, with the lid closed;

FIG. 15 is a front view thereof, with the lid closed;

FIG. 16 is a left-side view thereof, with the lid closed;

FIG. 17 is a bottom view thereof, with the top view being a mirror image thereof; and,

FIG. 18 is a rear view thereof, with the lid closed.

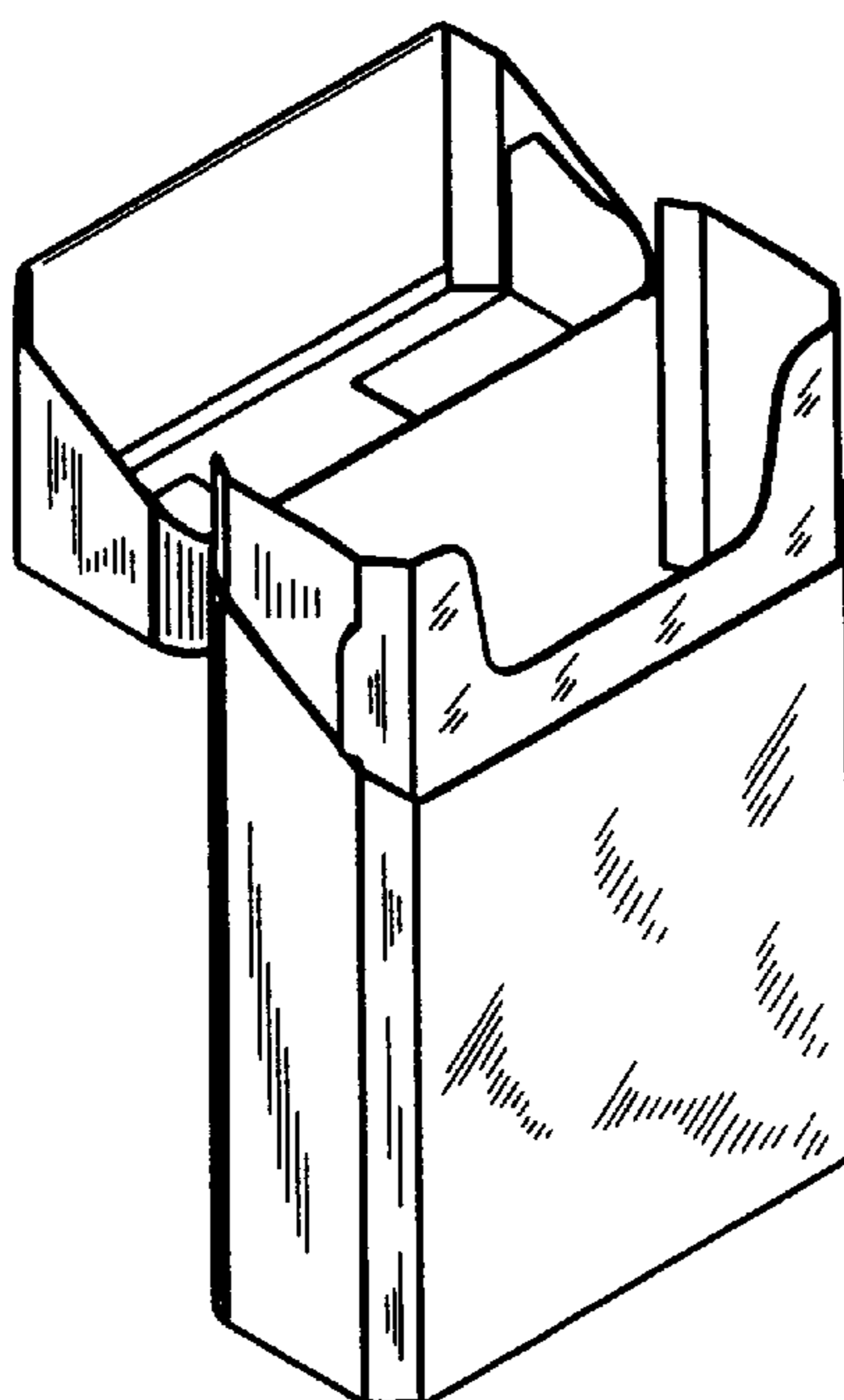

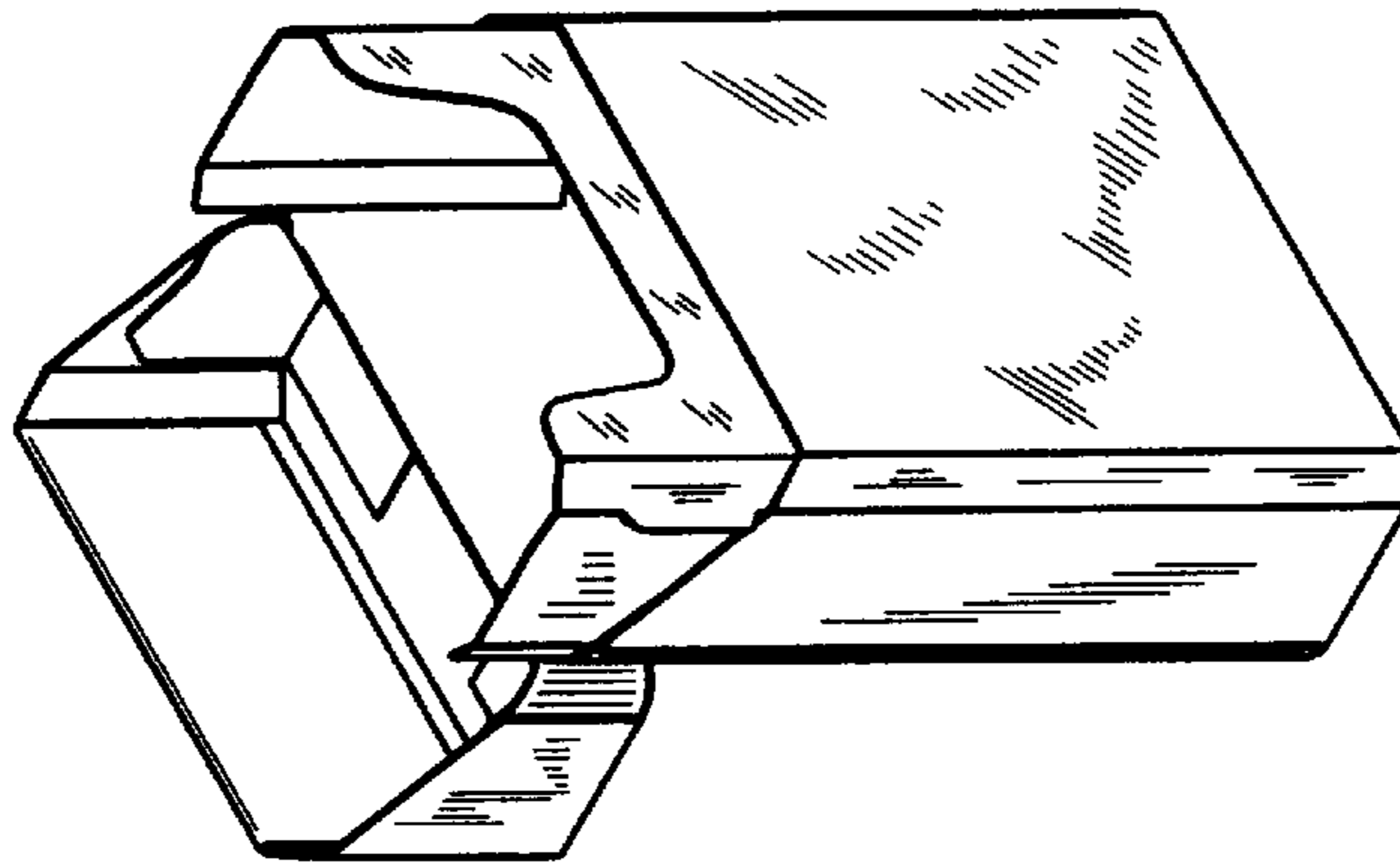

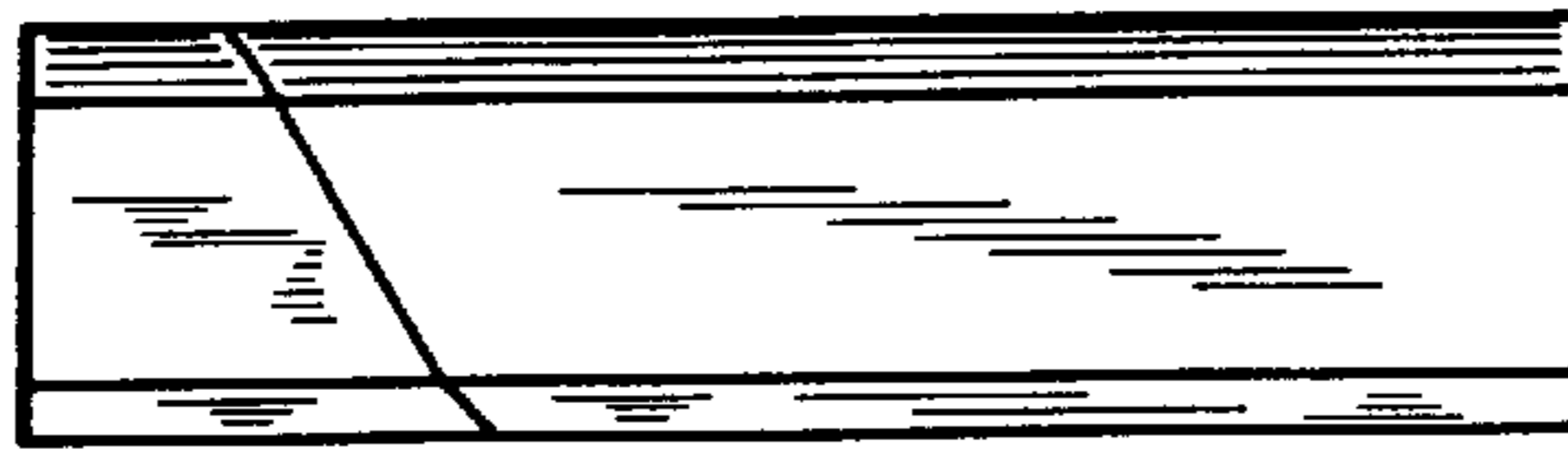

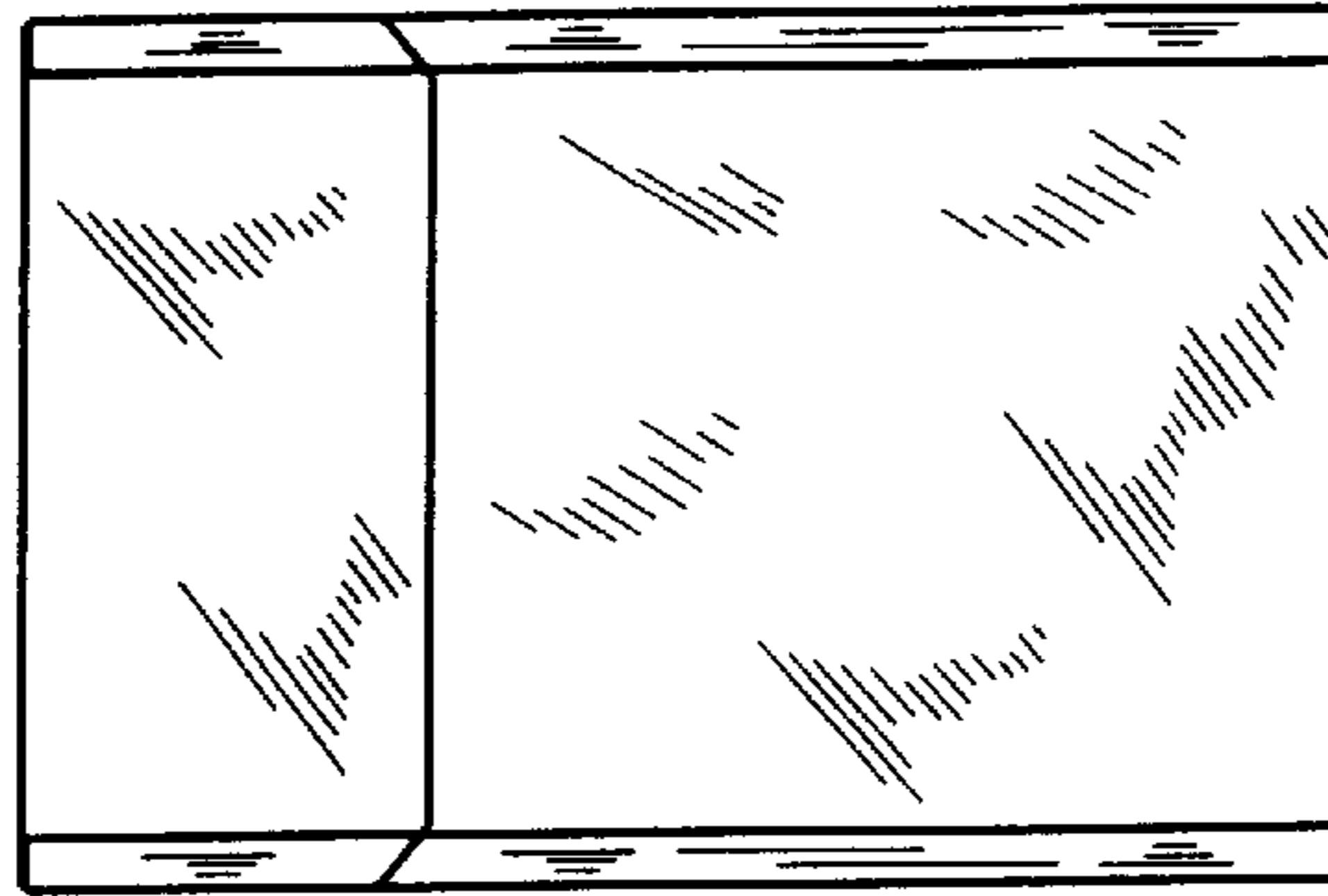

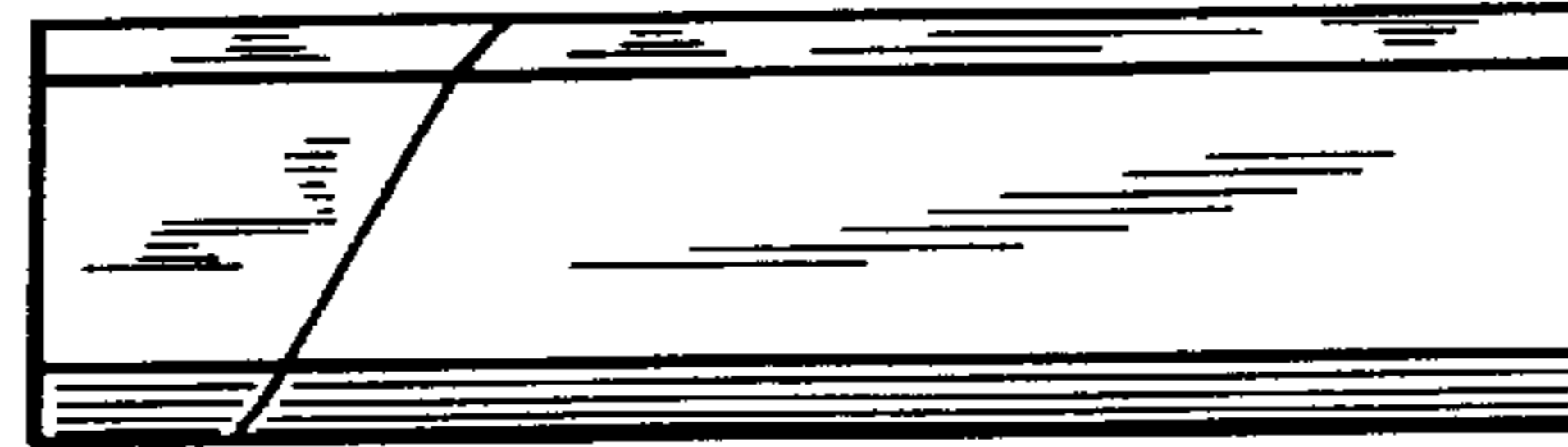

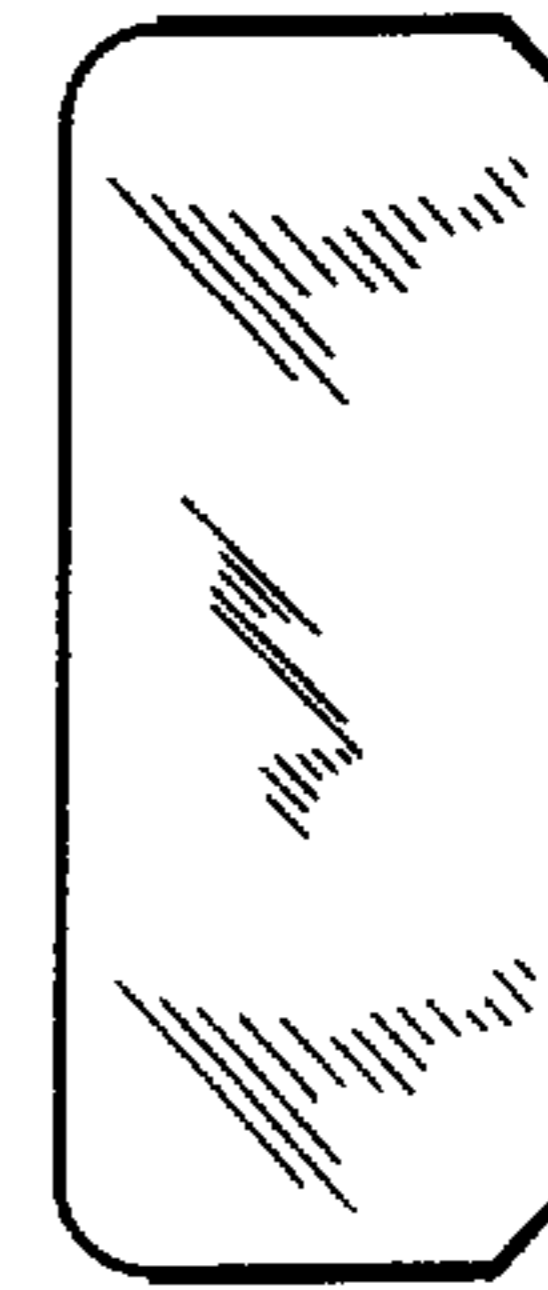
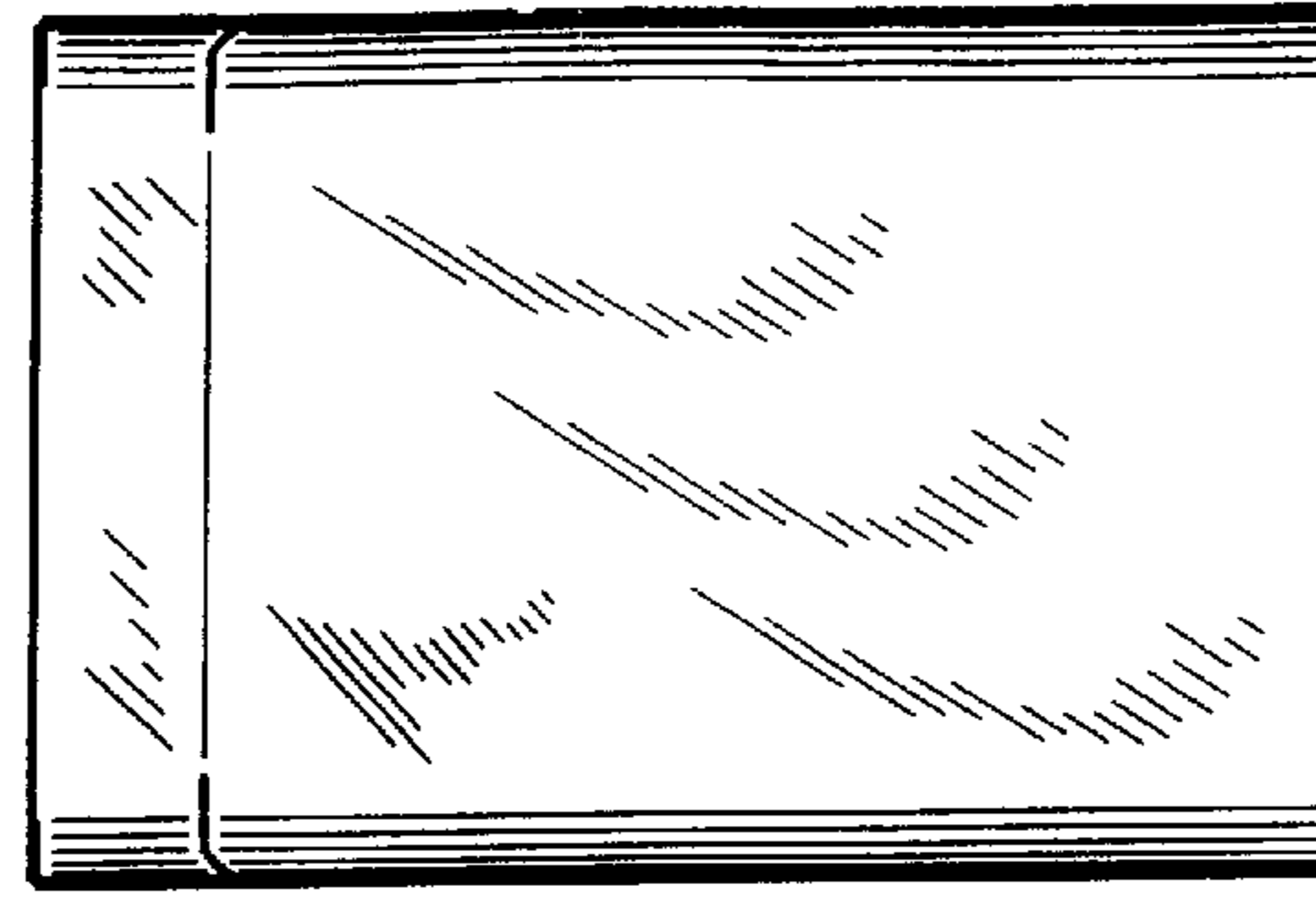

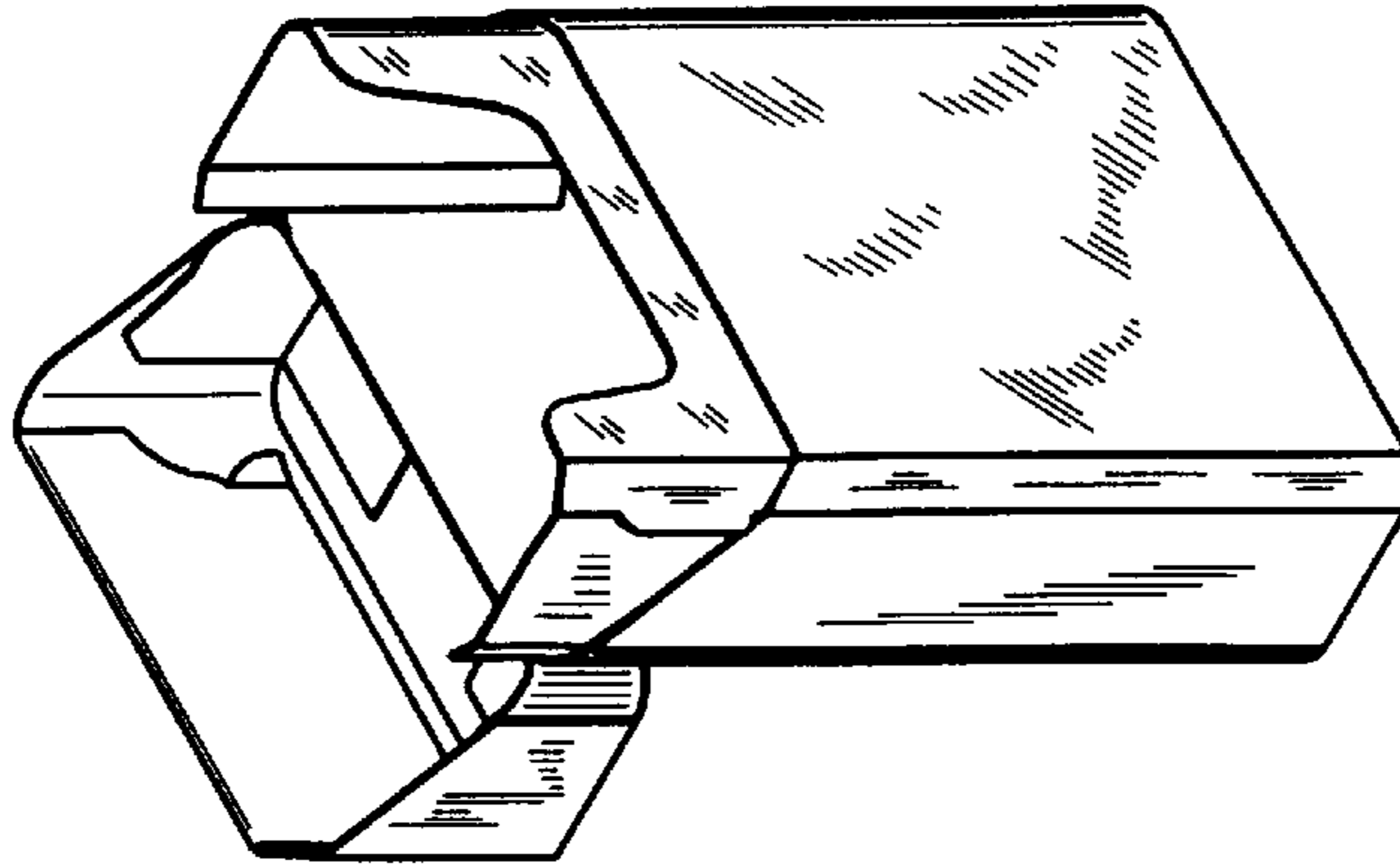

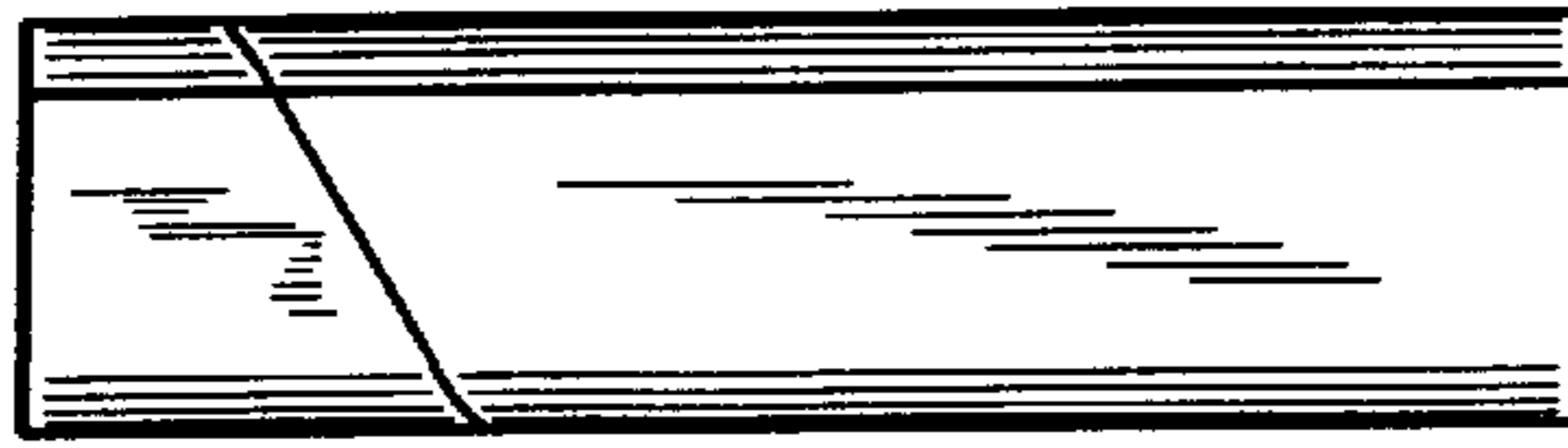

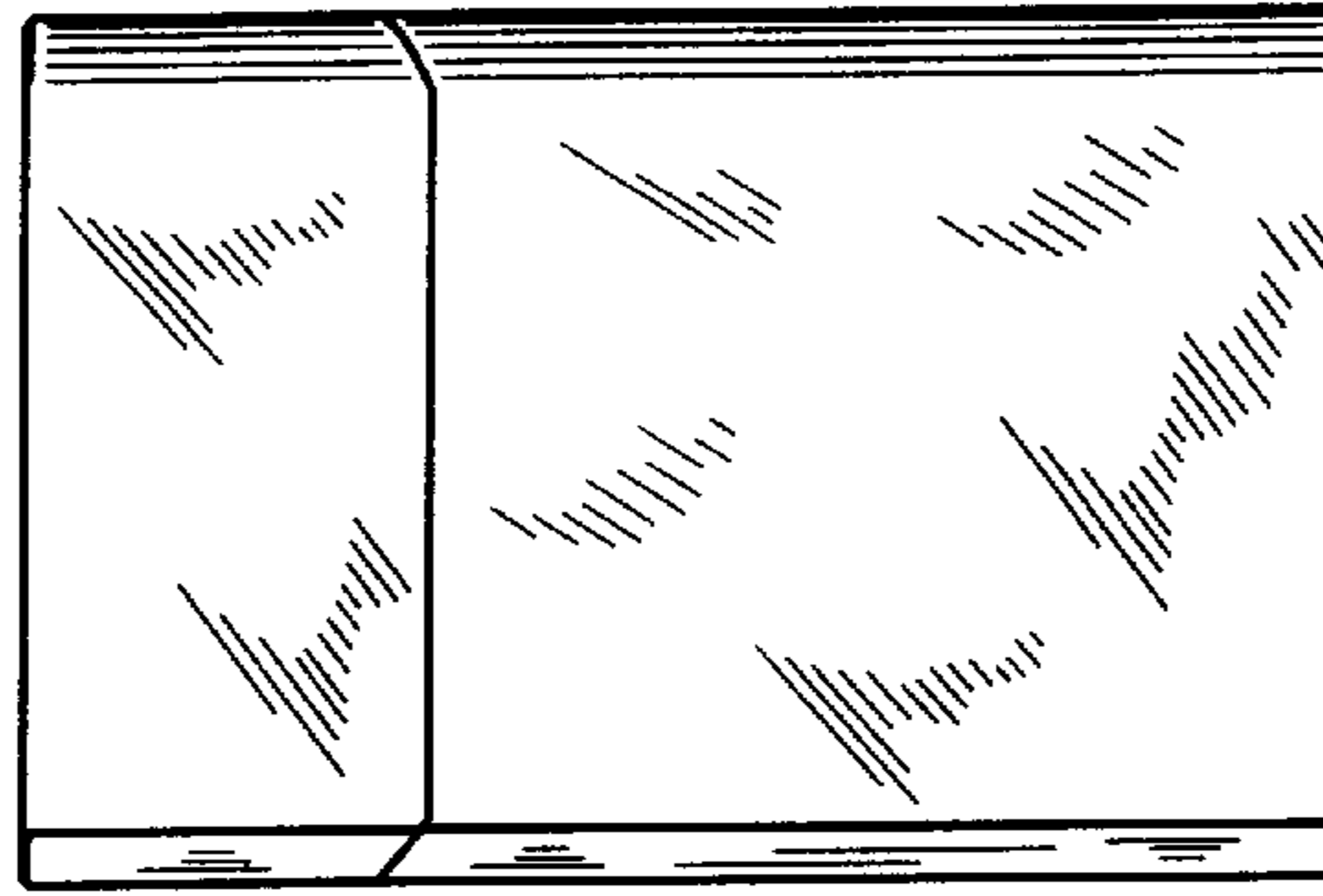

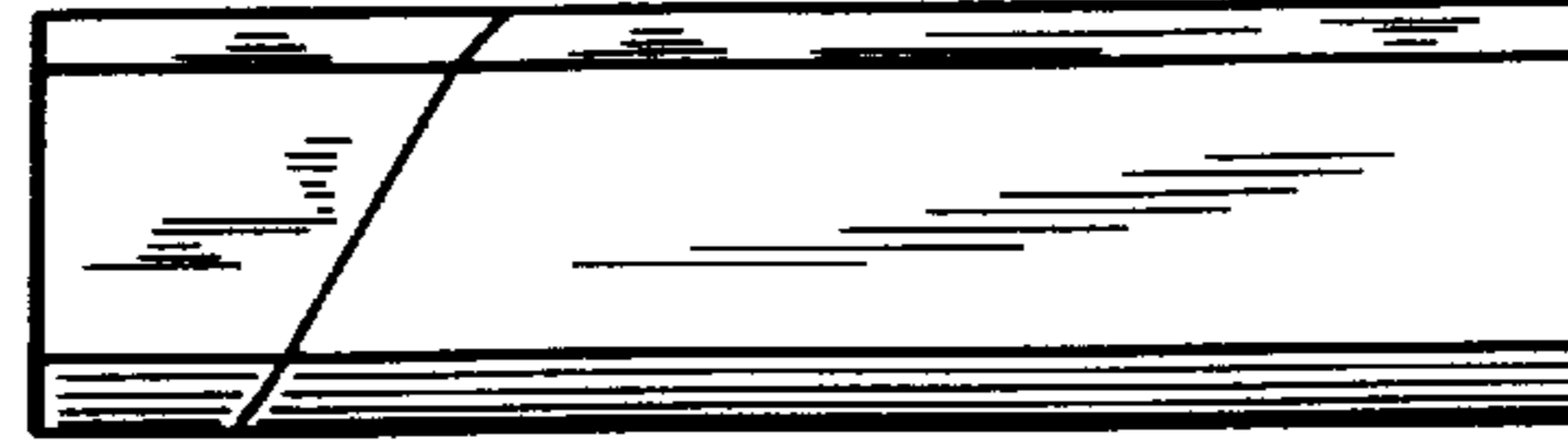

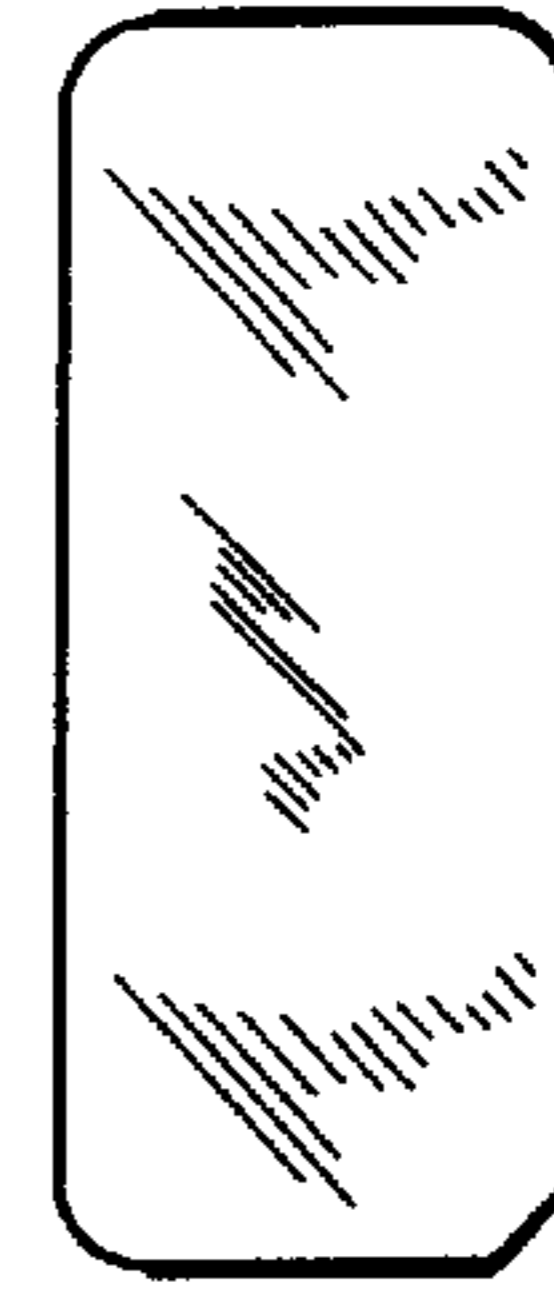
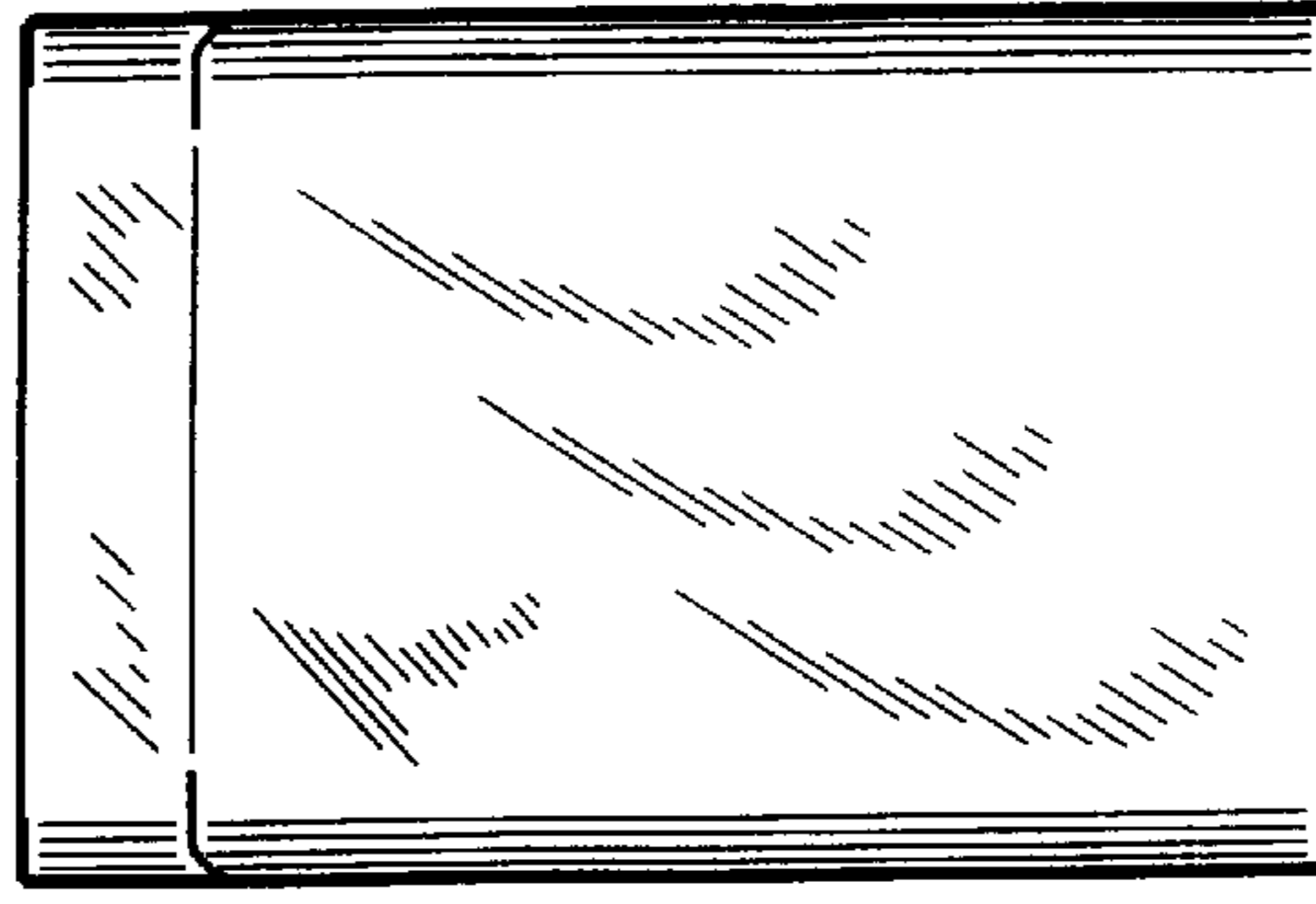

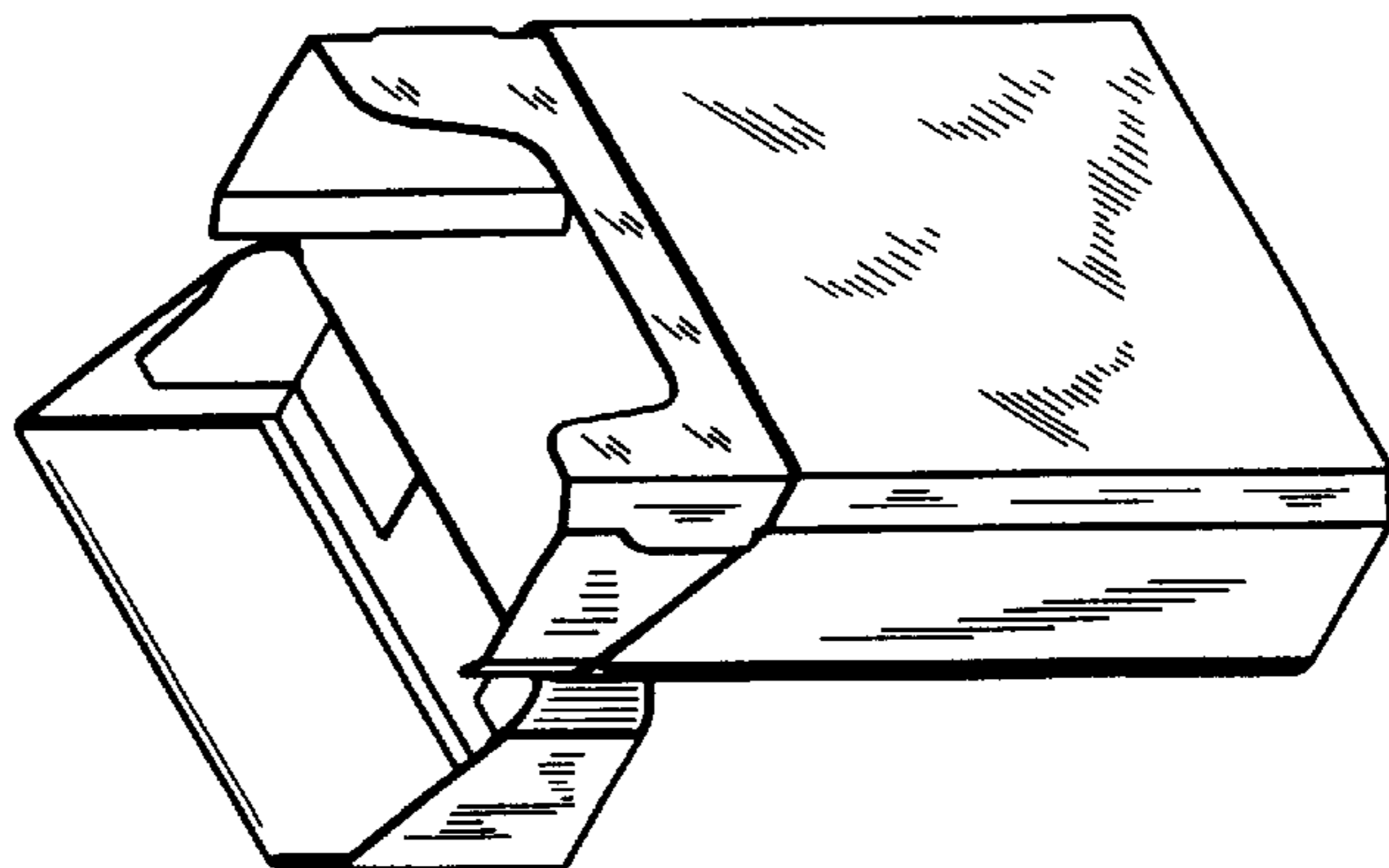

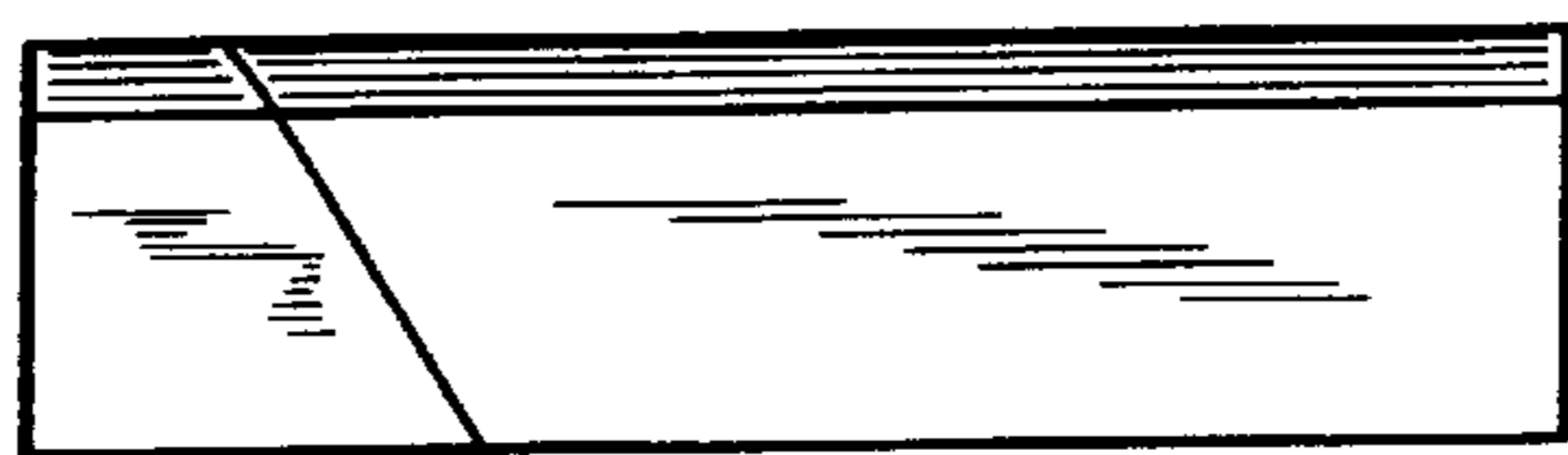

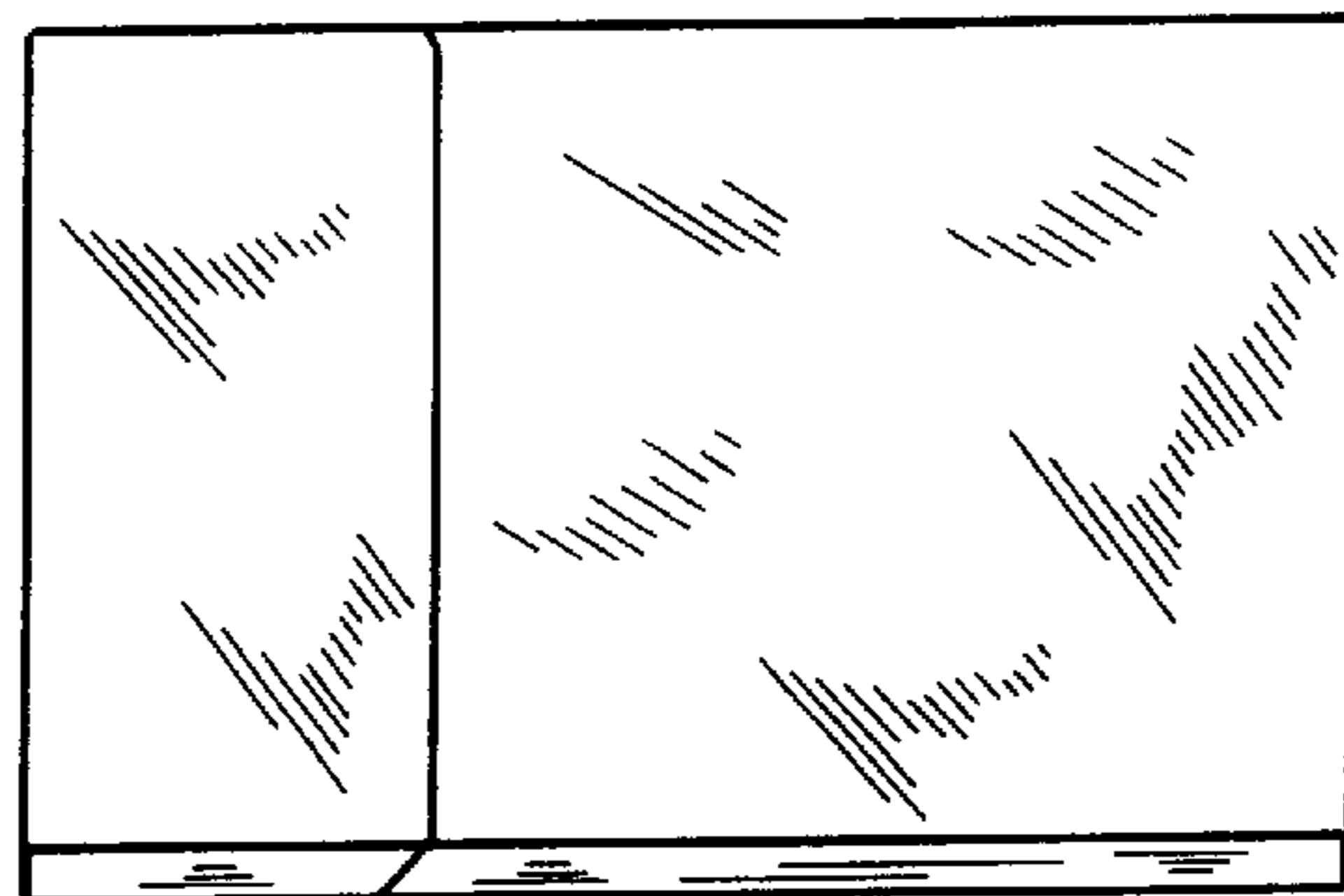

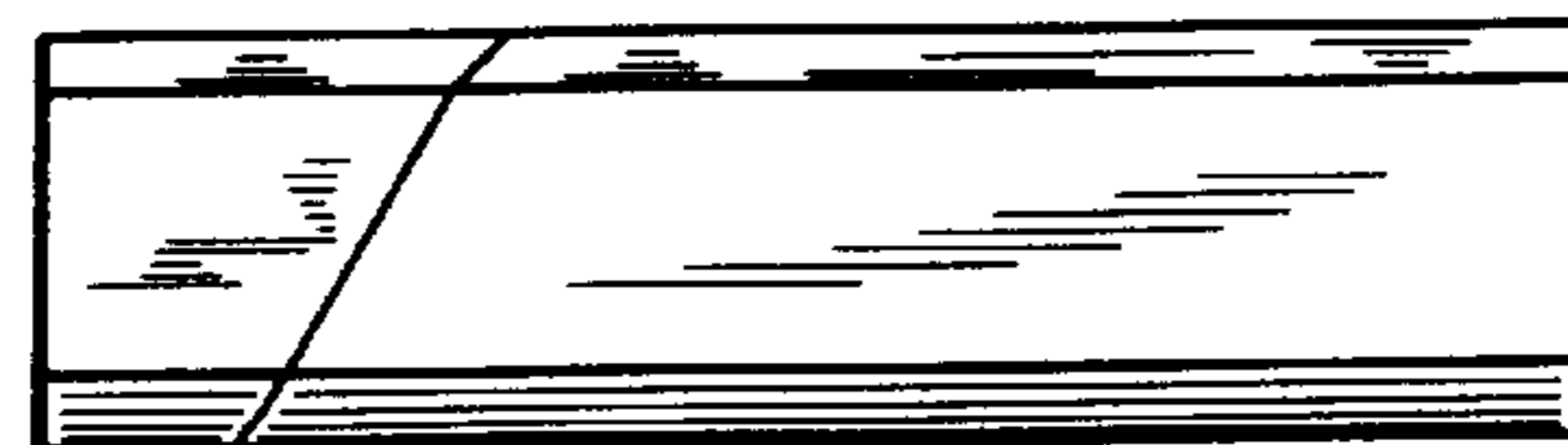

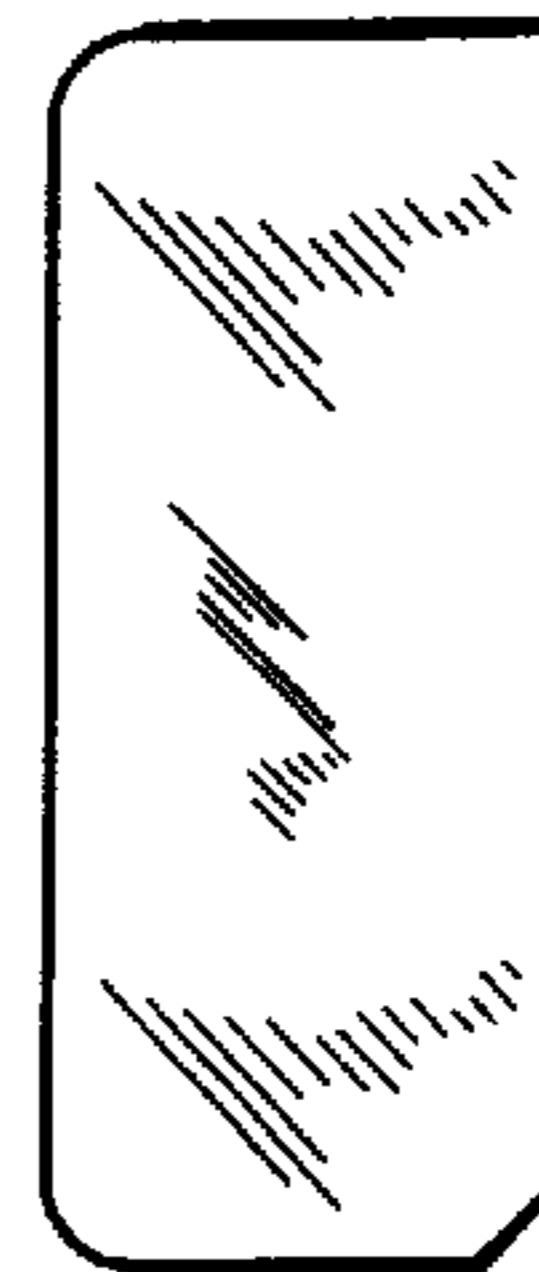
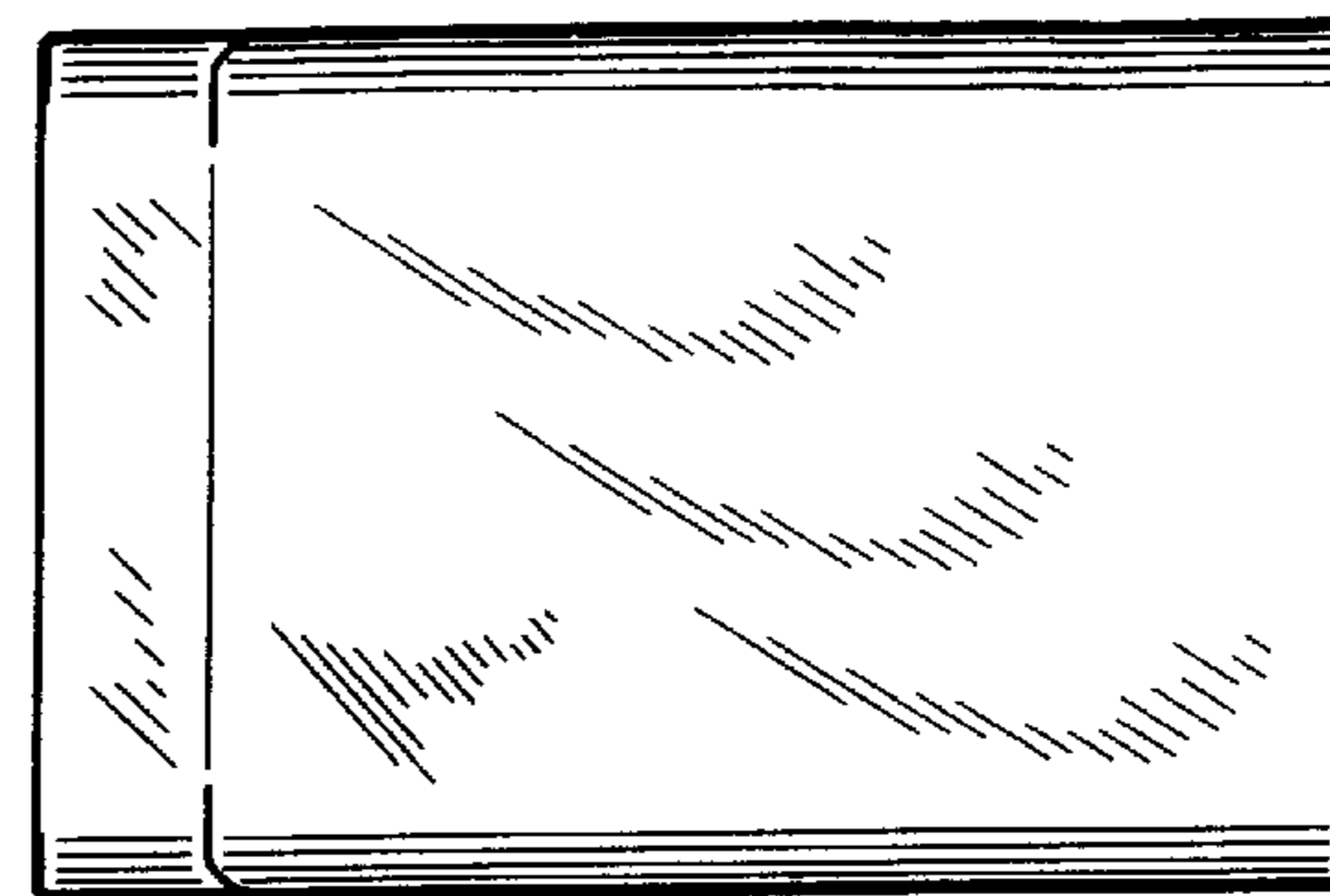
