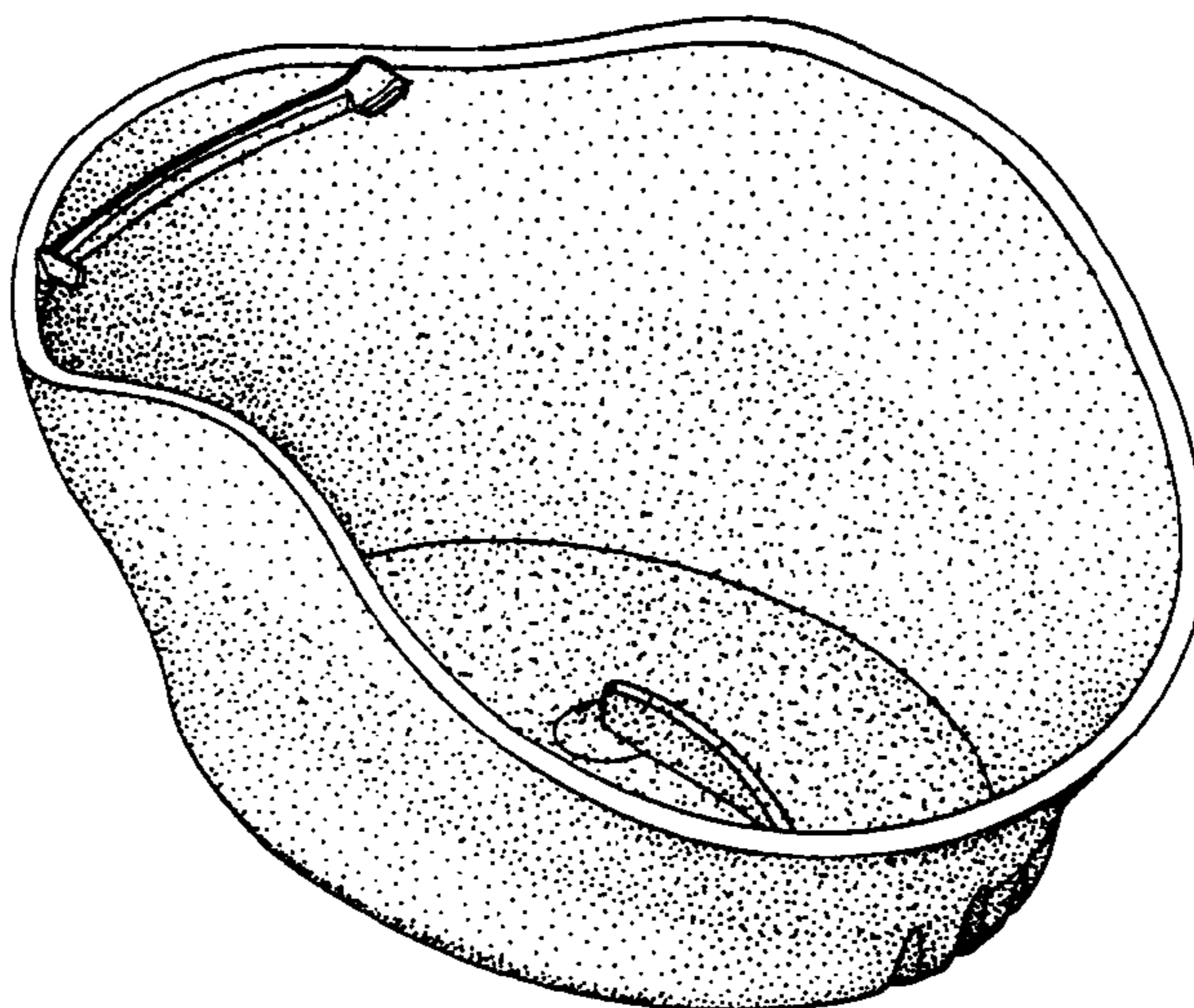
(57) **CLAIM**

The ornamental design for a base for scalp applicator, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an base for scalp applicator, embodying our new design;
 FIG. 2 is a top view thereof;
 FIG. 3 is a bottom view thereof;
 FIG. 4 is a right side elevational view thereof; the left side being a mirror image;
 FIG. 5 is a rear elevational view thereof; and,
 FIG. 6 is a front elevational view thereof.
 The broken line showing of scalp applicator in FIG. 4 is for illustrative purposes only and forms no part of the claimed design.

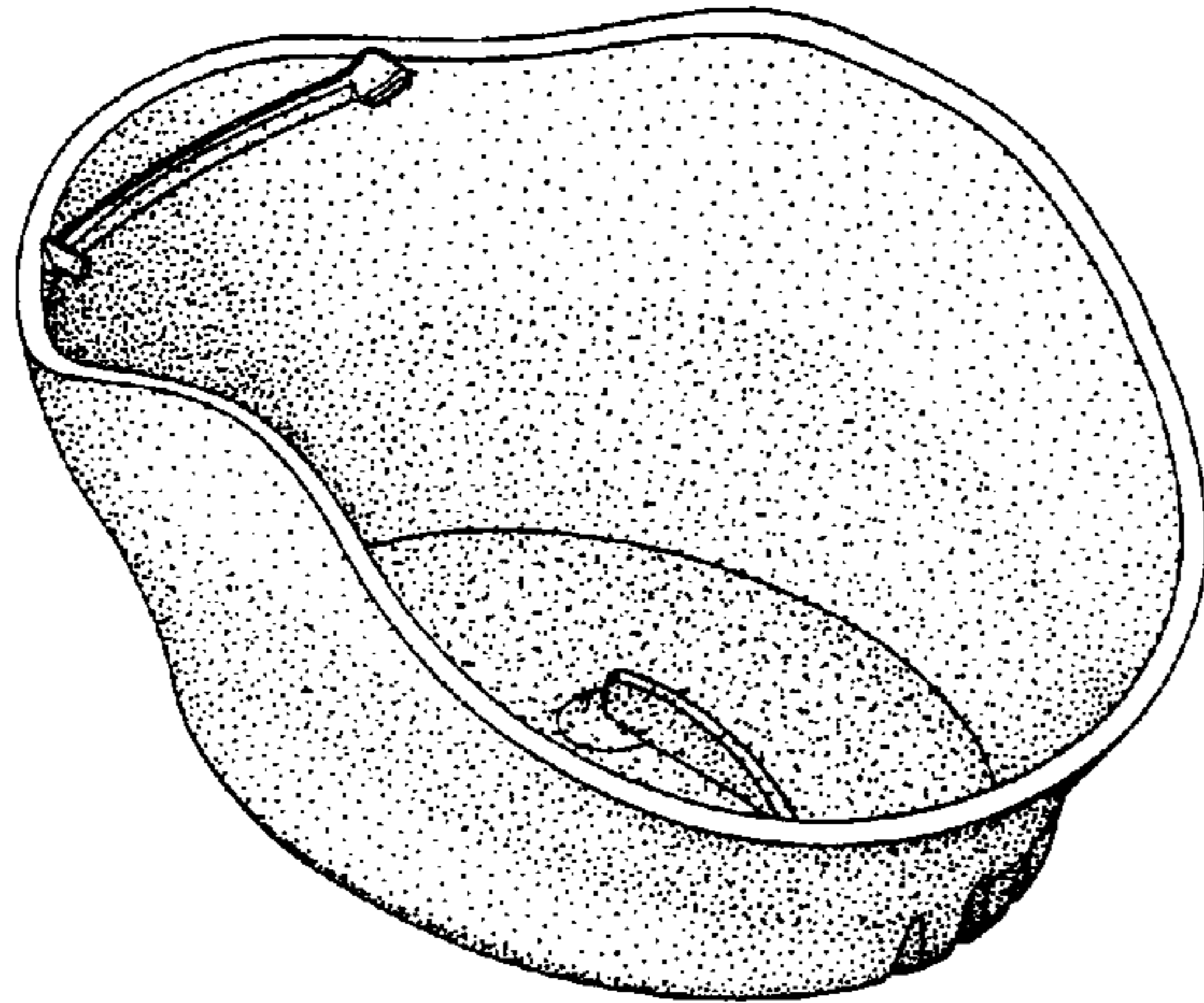

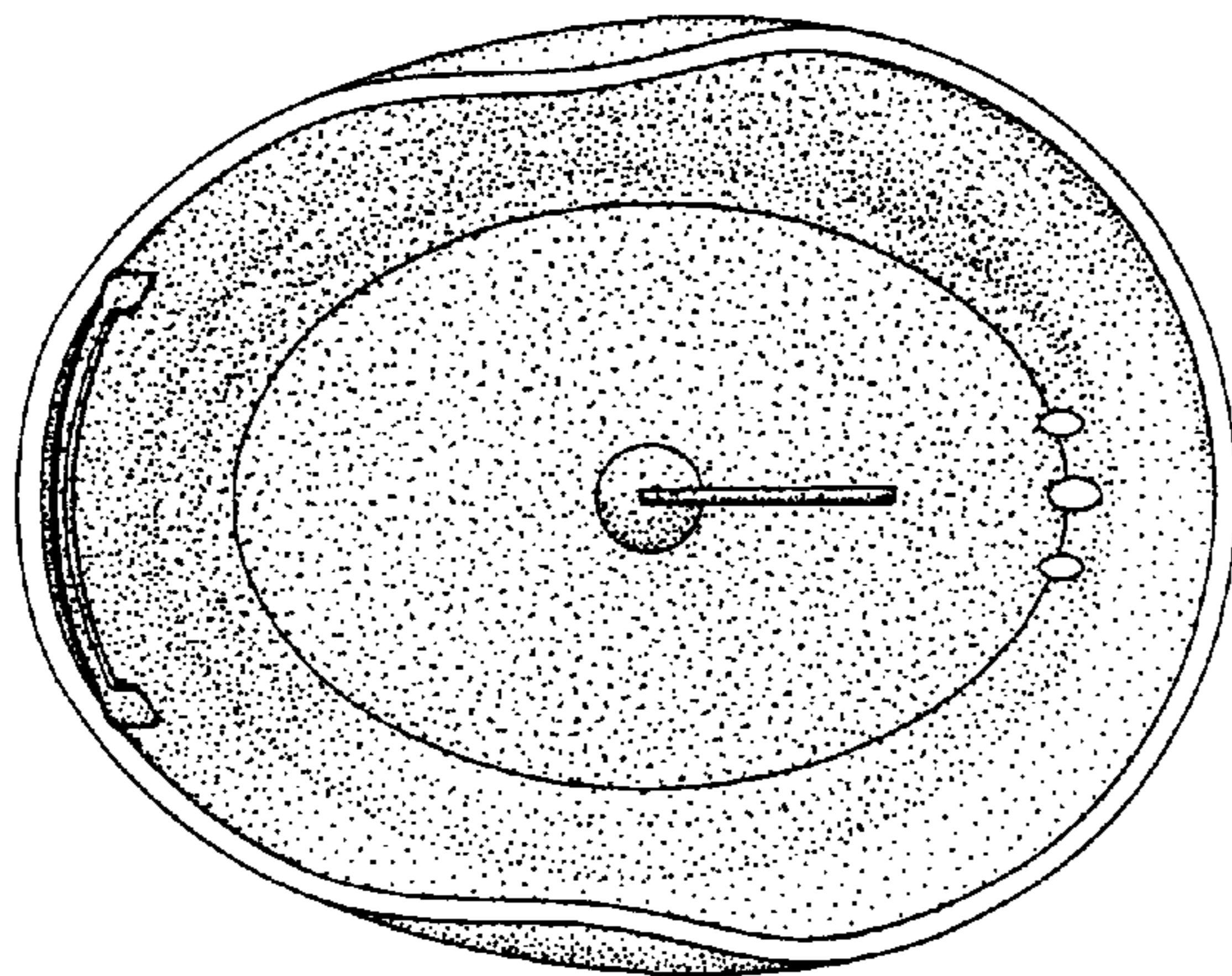

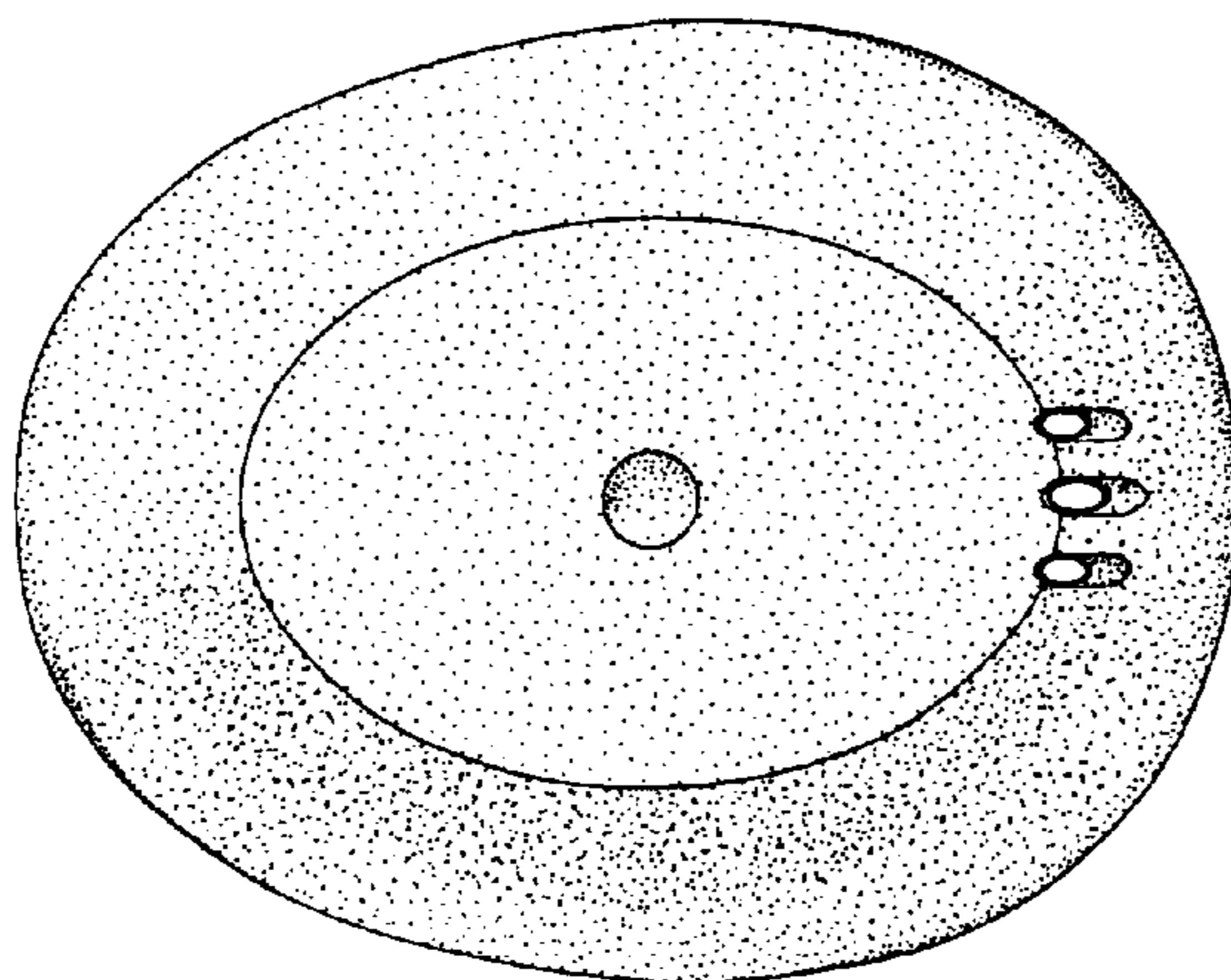

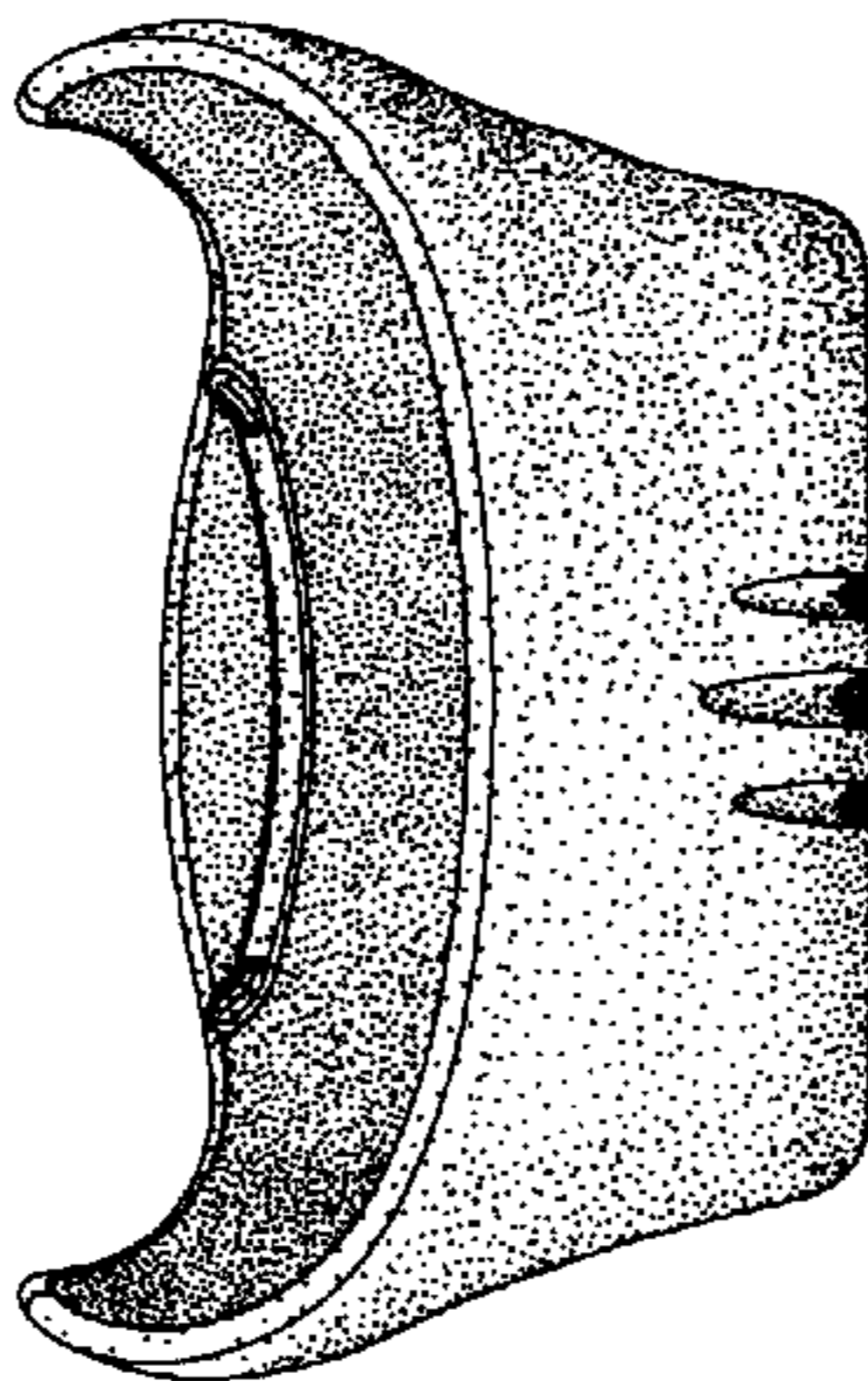

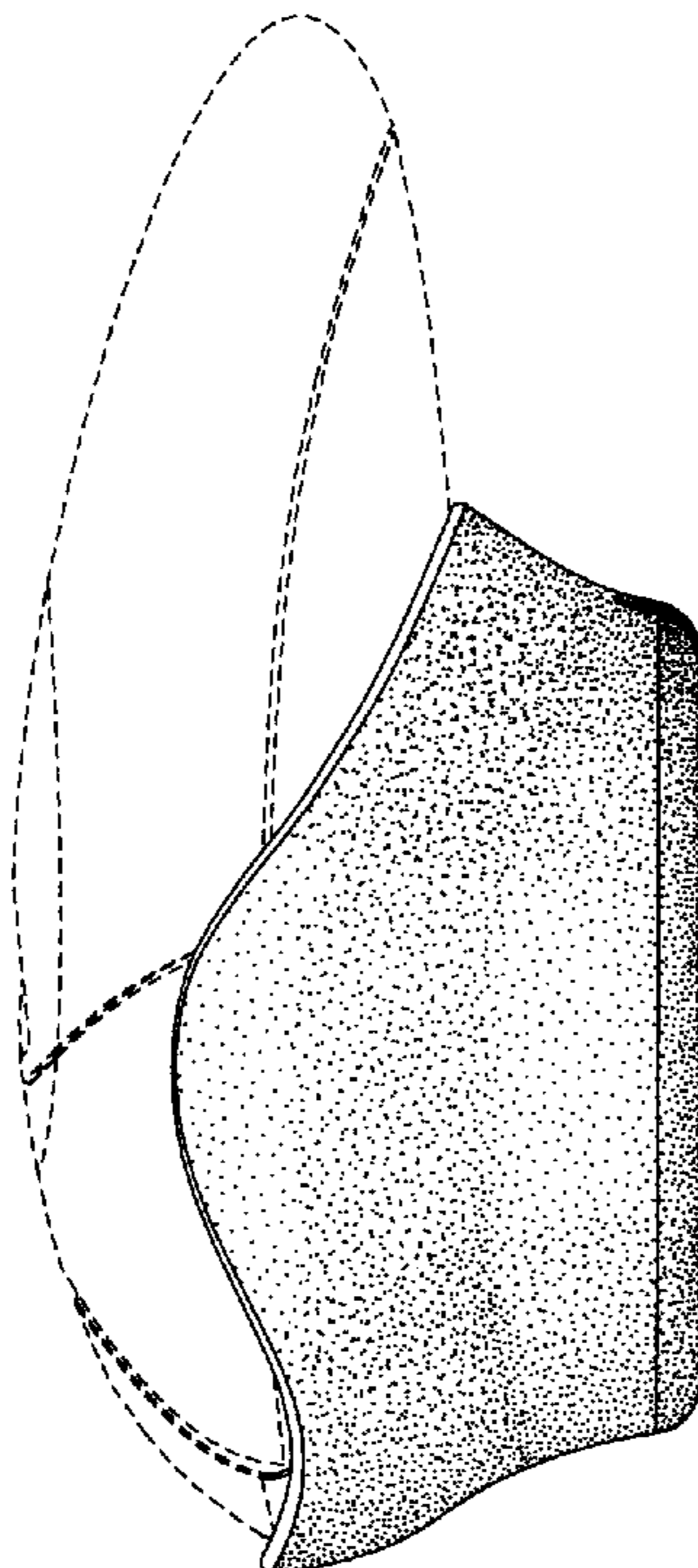

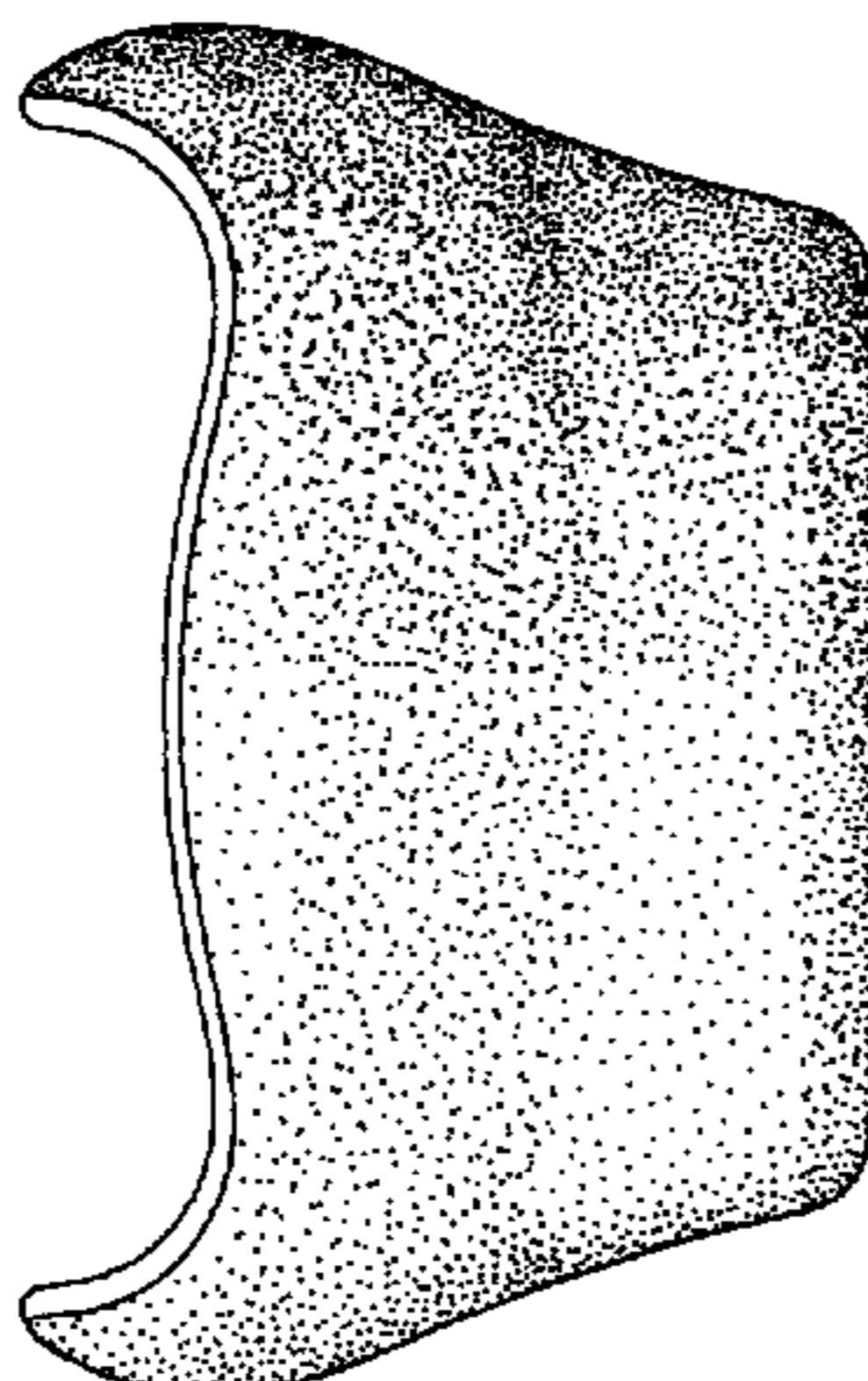
