(57) **CLAIM**

The ornamental design for a combined hand cleaner and hand cleaner base, as shown and described.

DESCRIPTION

FIG. 1 is a side elevational view of the hand cleaner portion of our new design, shown separate from the assembly for completeness of disclosure;

FIG. 2 is a side elevational view seen from the left or right of FIG. 1;

FIG. 3 is a bottom plan view of FIG. 1;

FIG. 4 is a top plan view of FIG. 1;

FIG. 5 is a side elevational view of the assembled design;

FIG. 6 is a side elevational view seen from the left or right of FIG. 5;

FIG. 7 is a side elevational view of the base portion of our design shown separately for clarity and completeness of disclosure;

FIG. 8 is a side elevational view seen from the left or right side of FIG. 7;

FIG. 9 is a bottom plan view of FIG. 7; and,

FIG. 10 is a top plan view of FIG. 7.

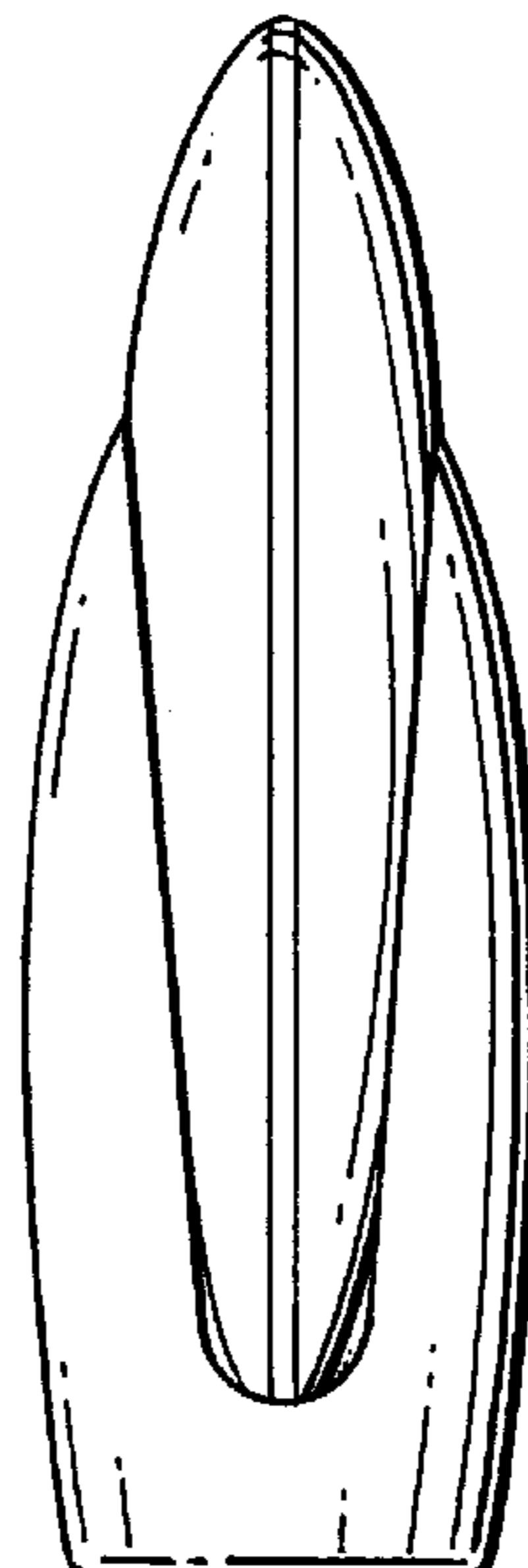
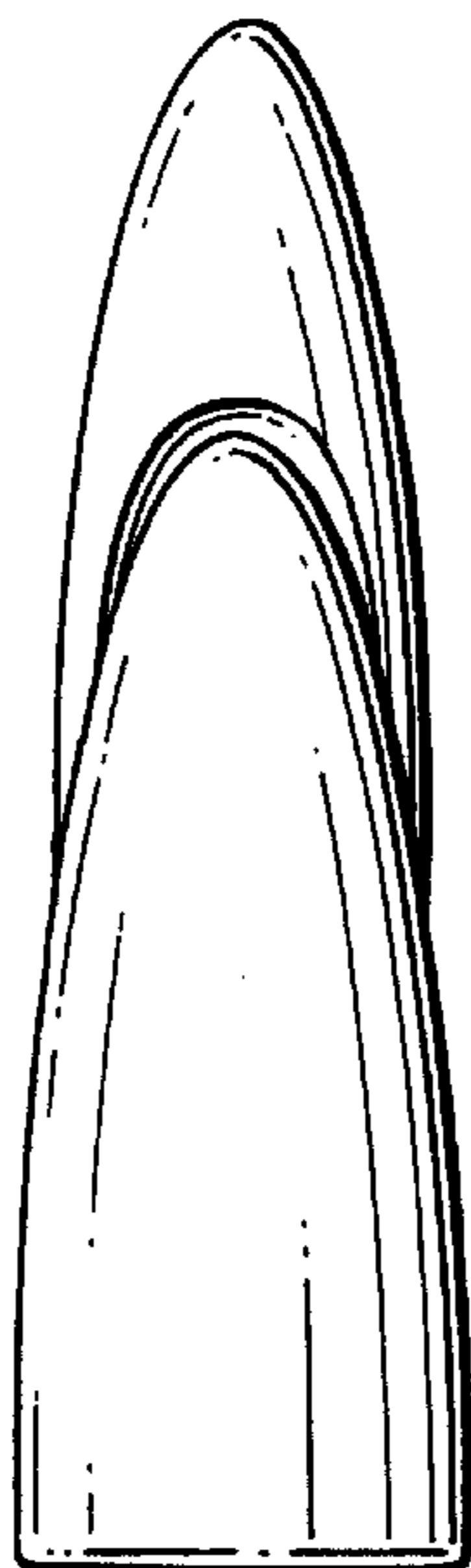

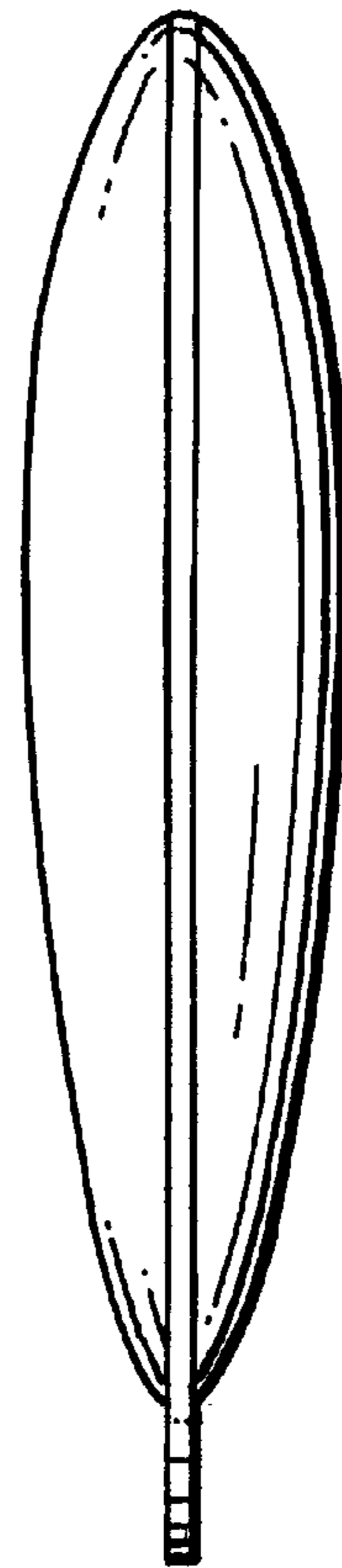

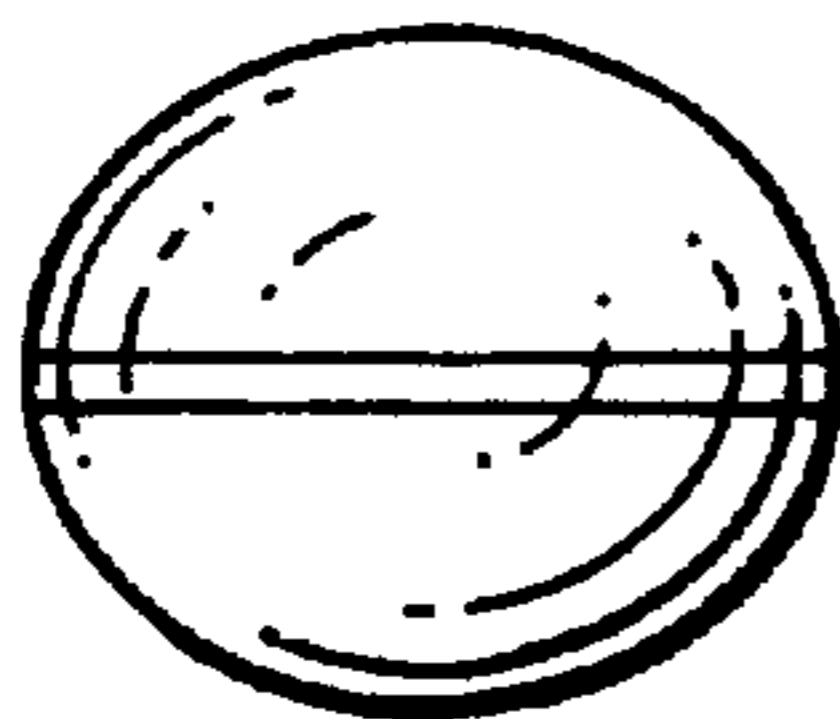

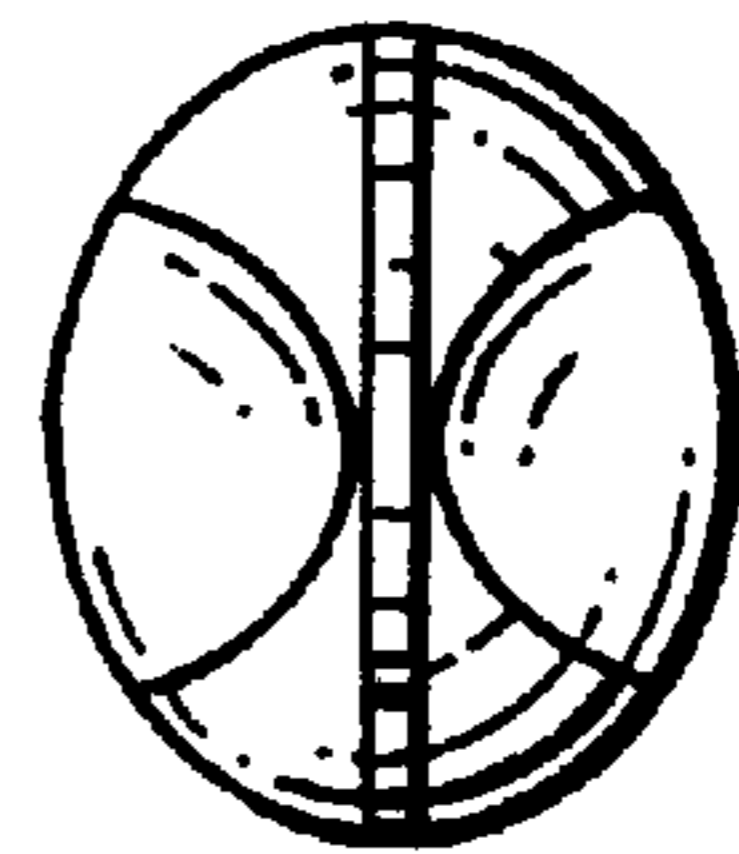

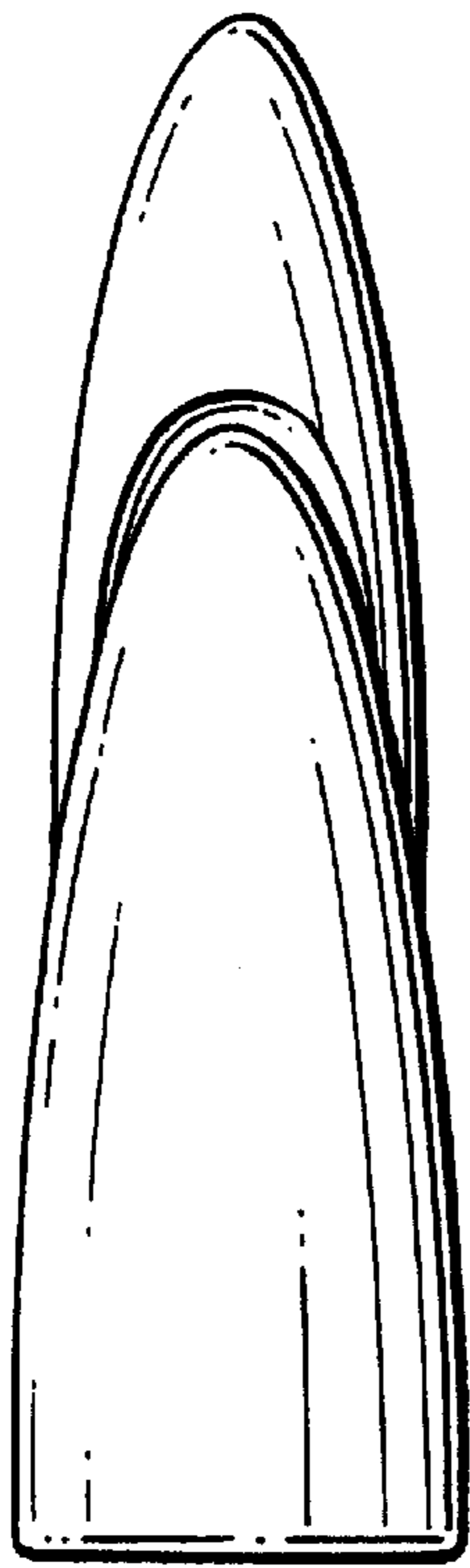

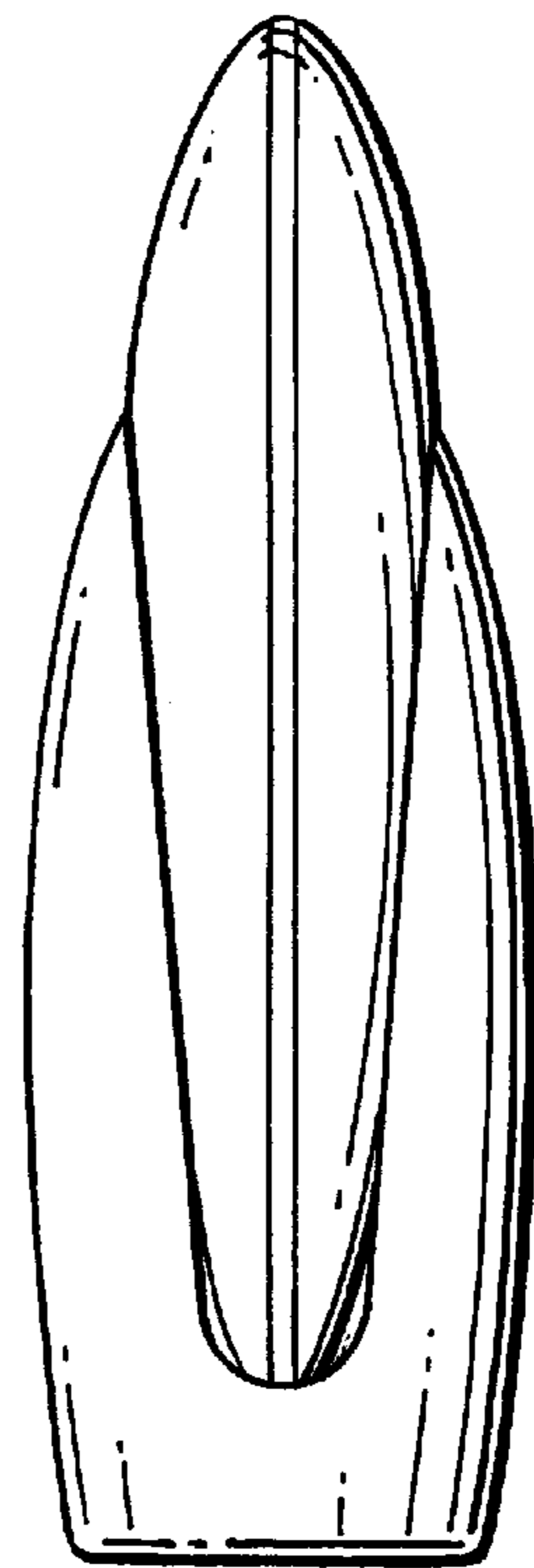

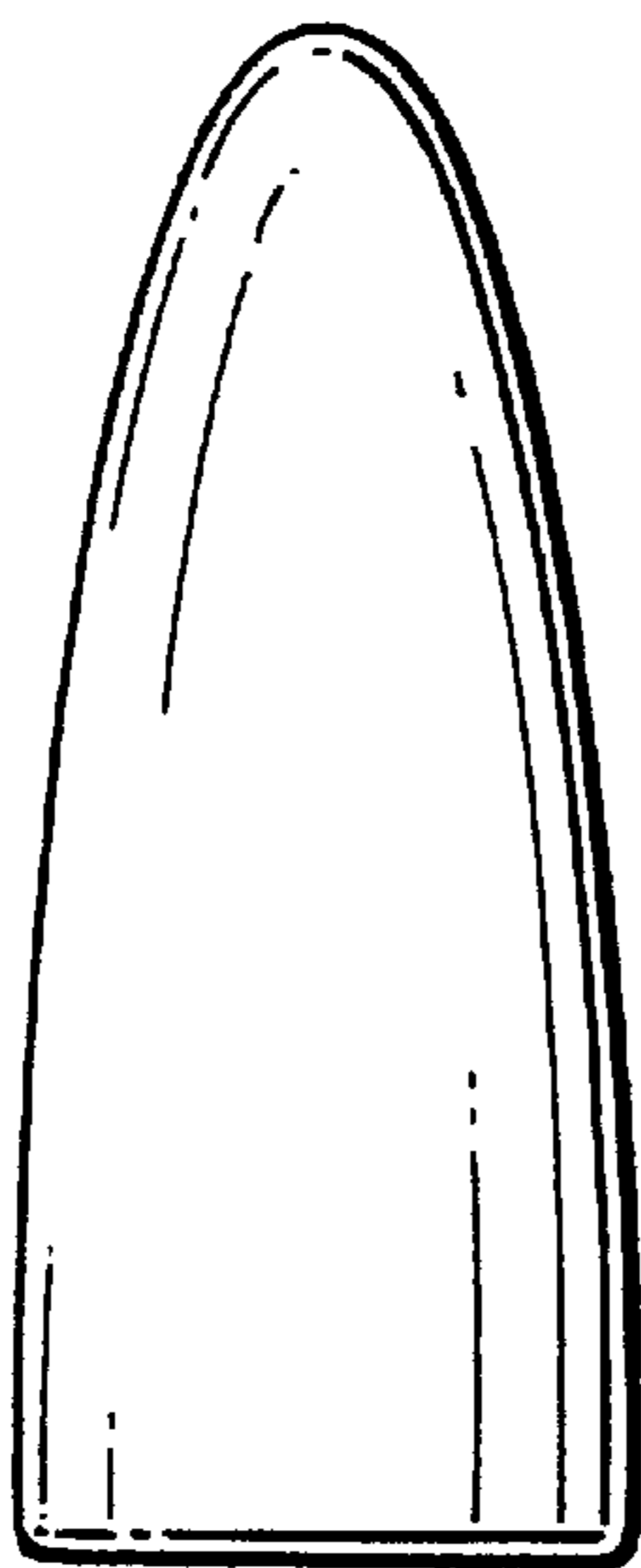

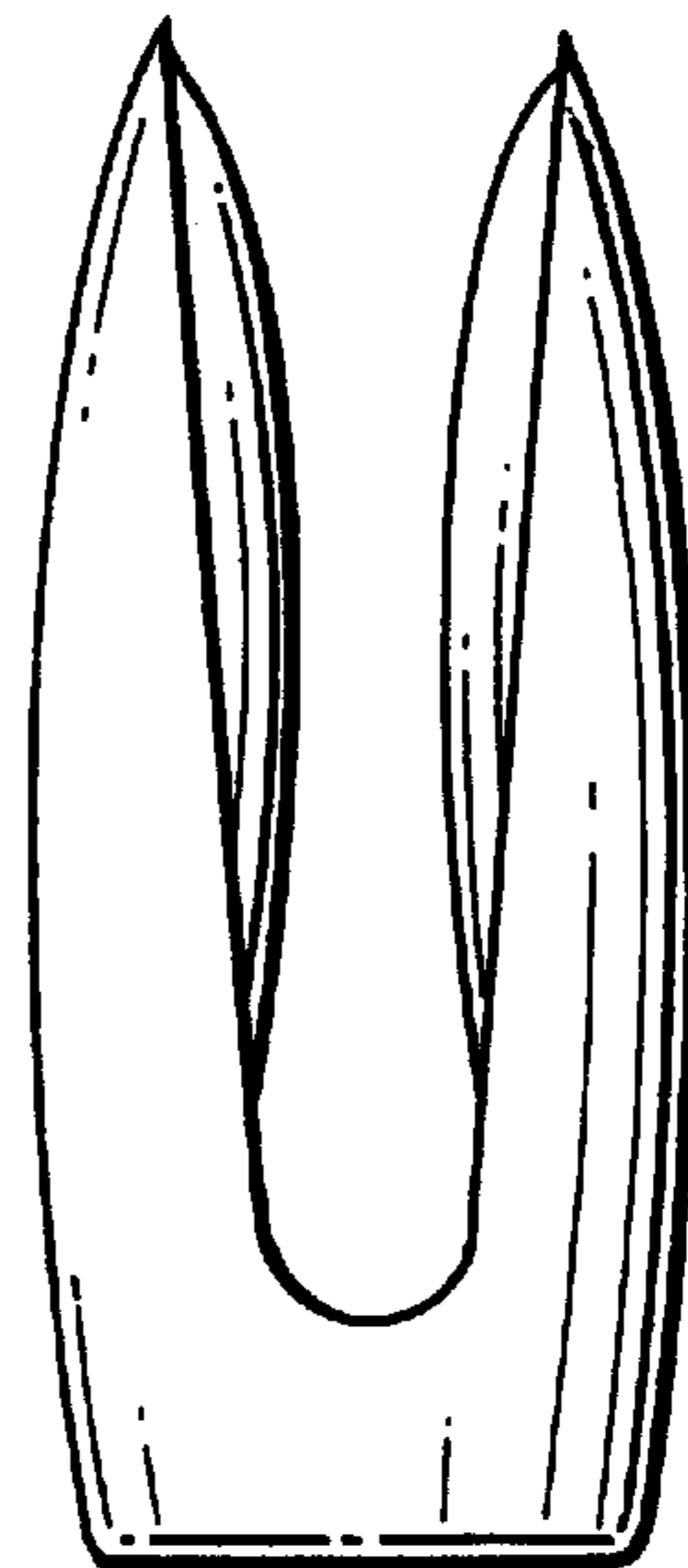

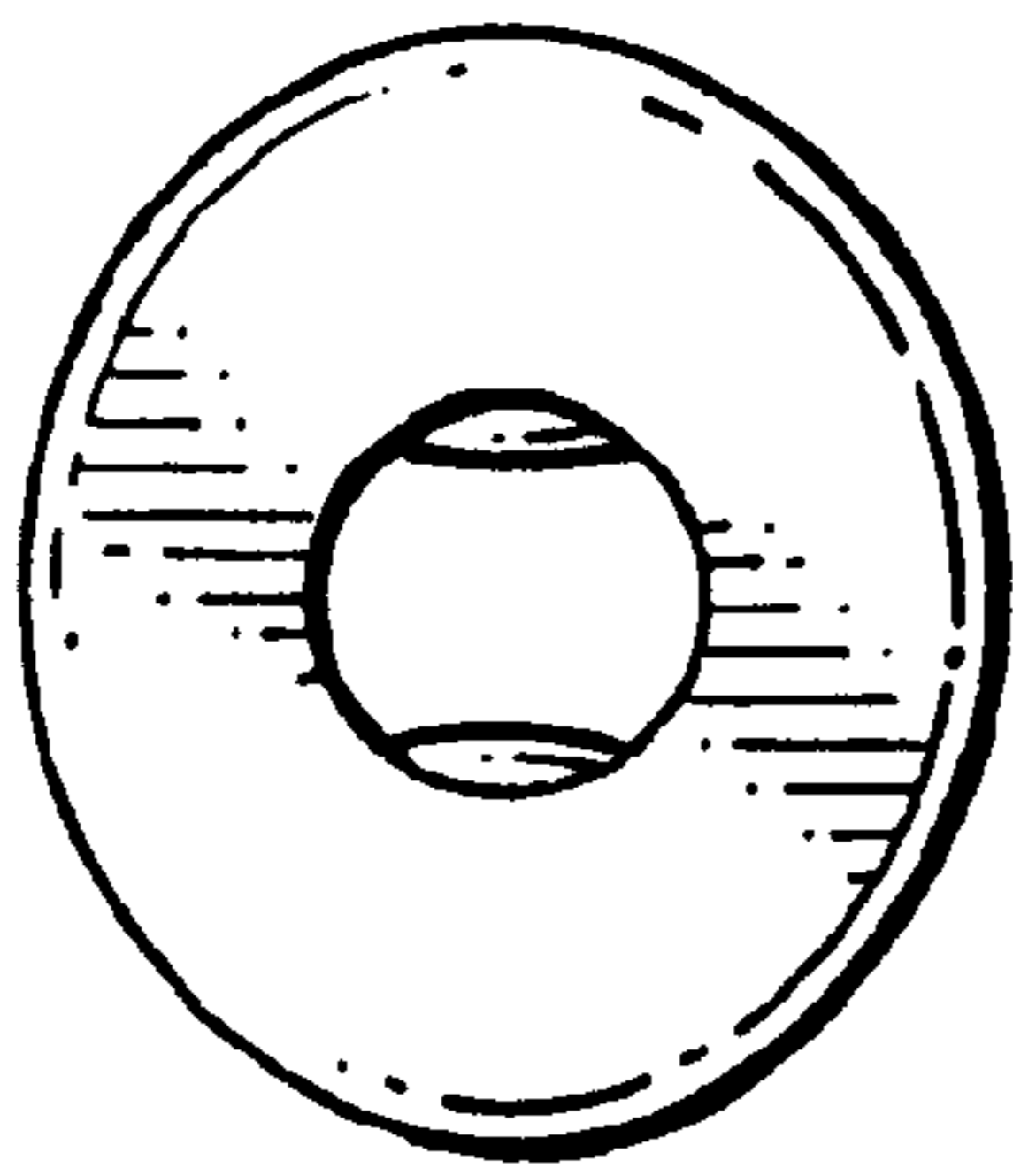

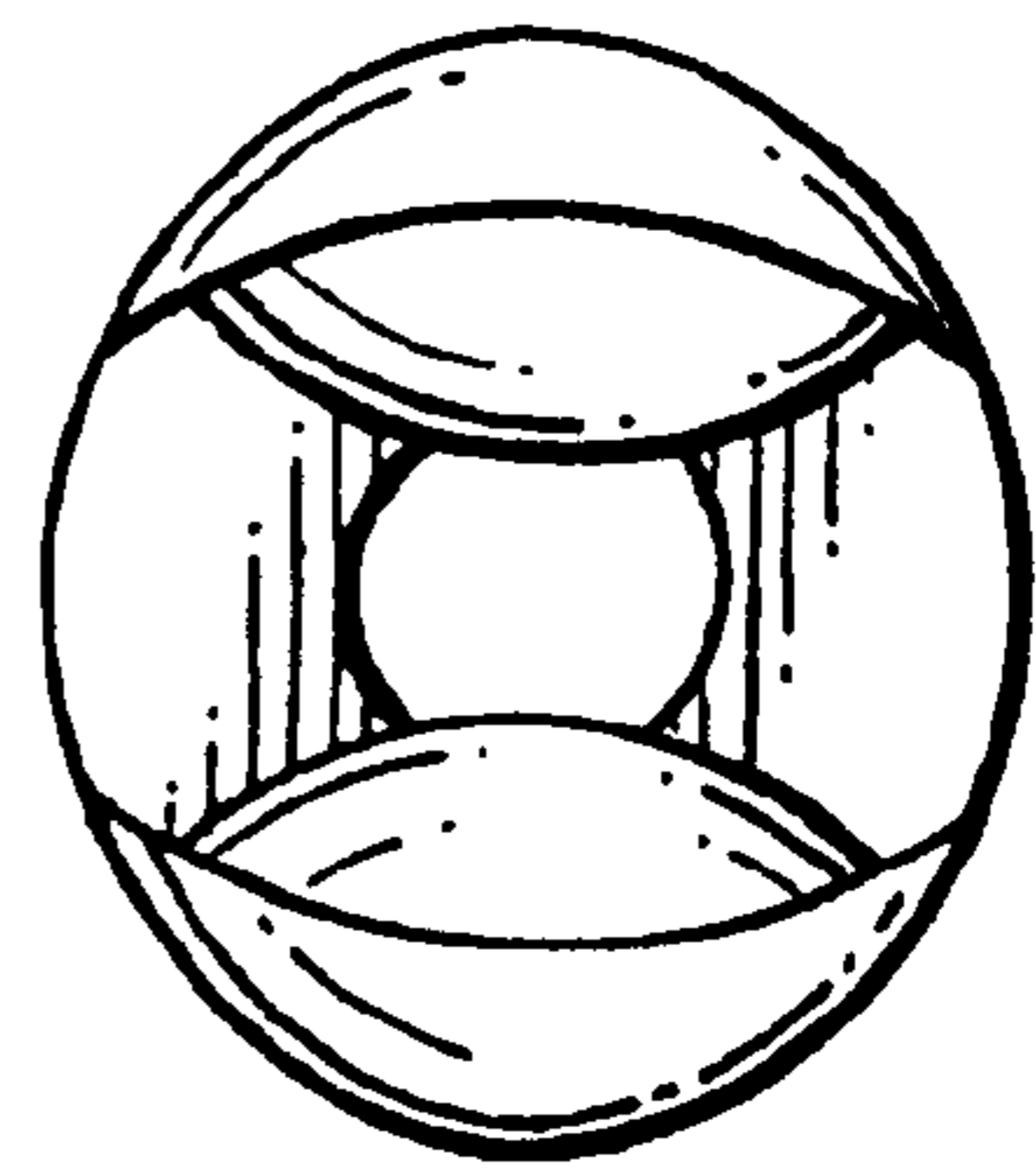
