DESCRIPTION

FIG. 1 is a bottom front perspective view showing my new design;

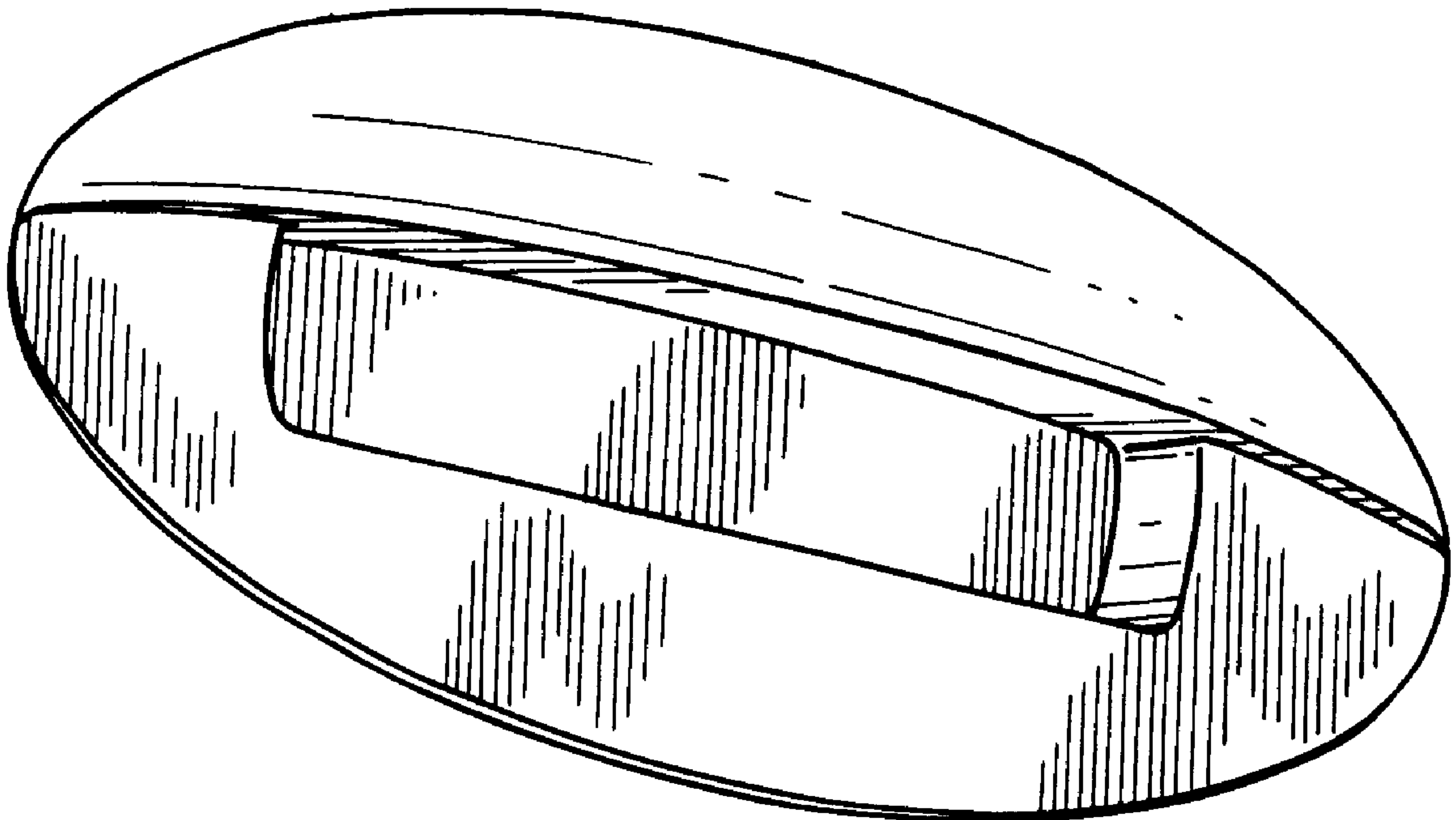

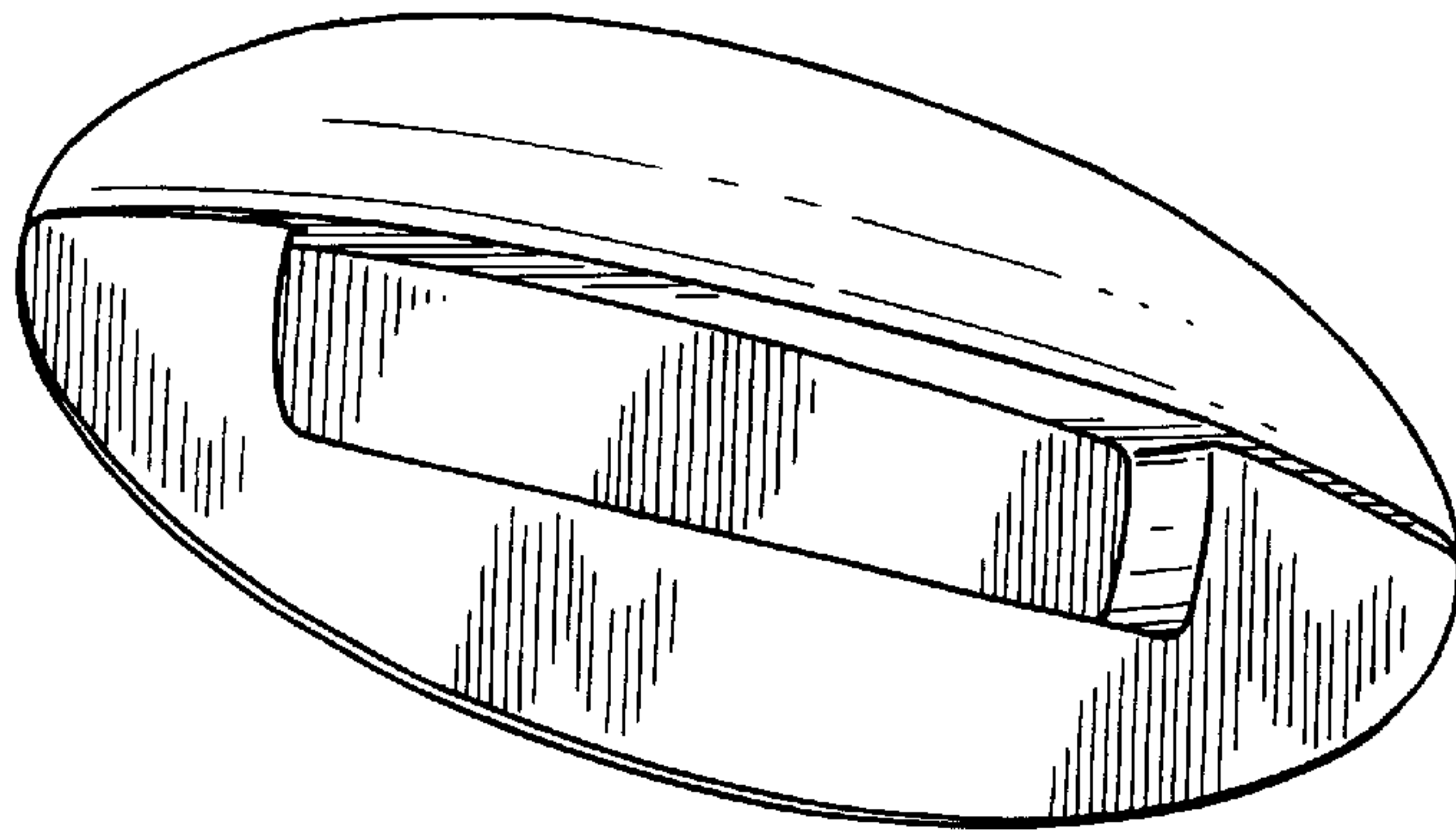

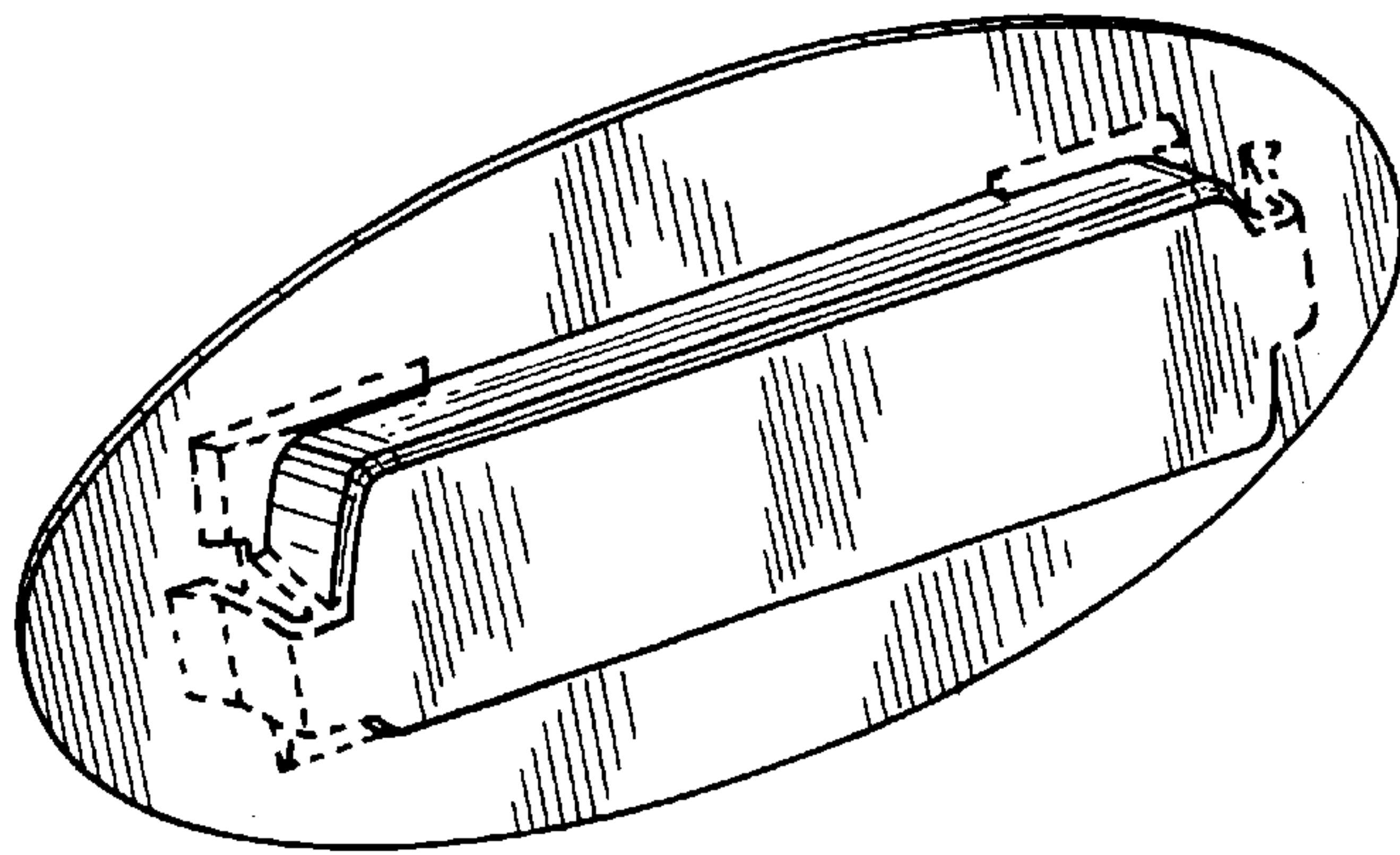

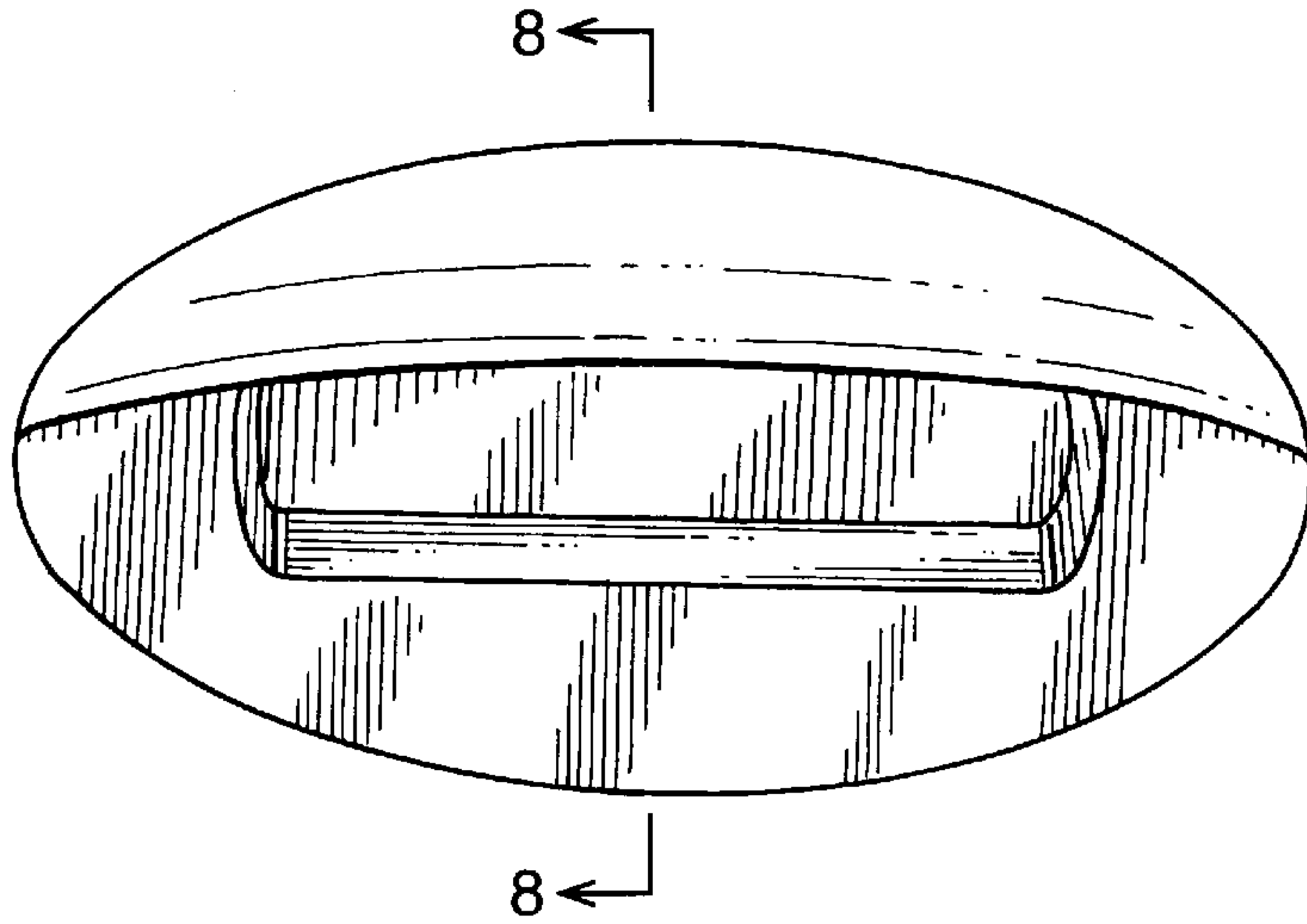

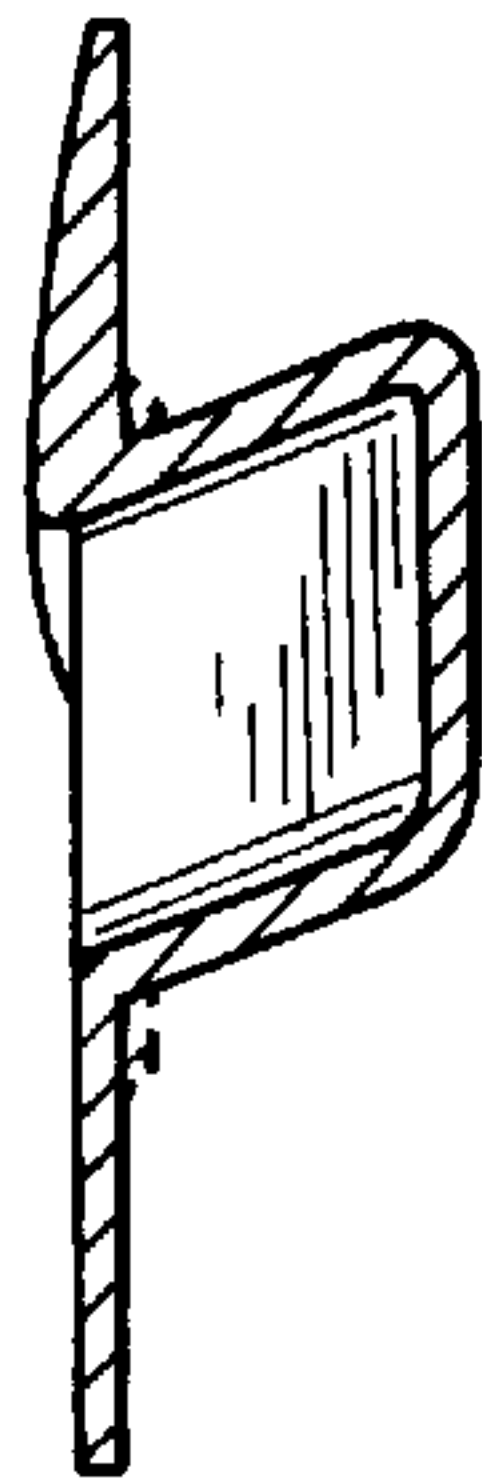

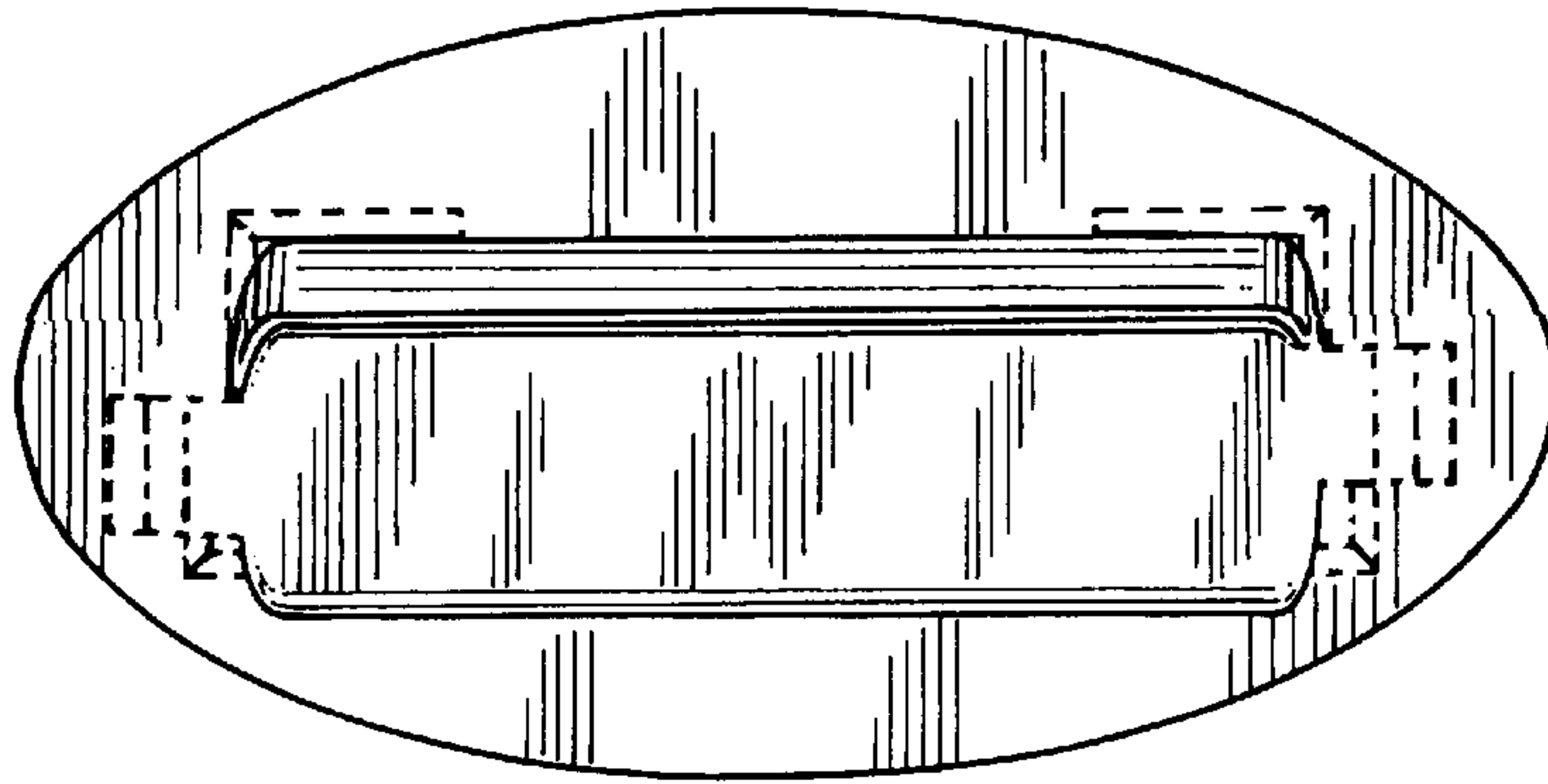

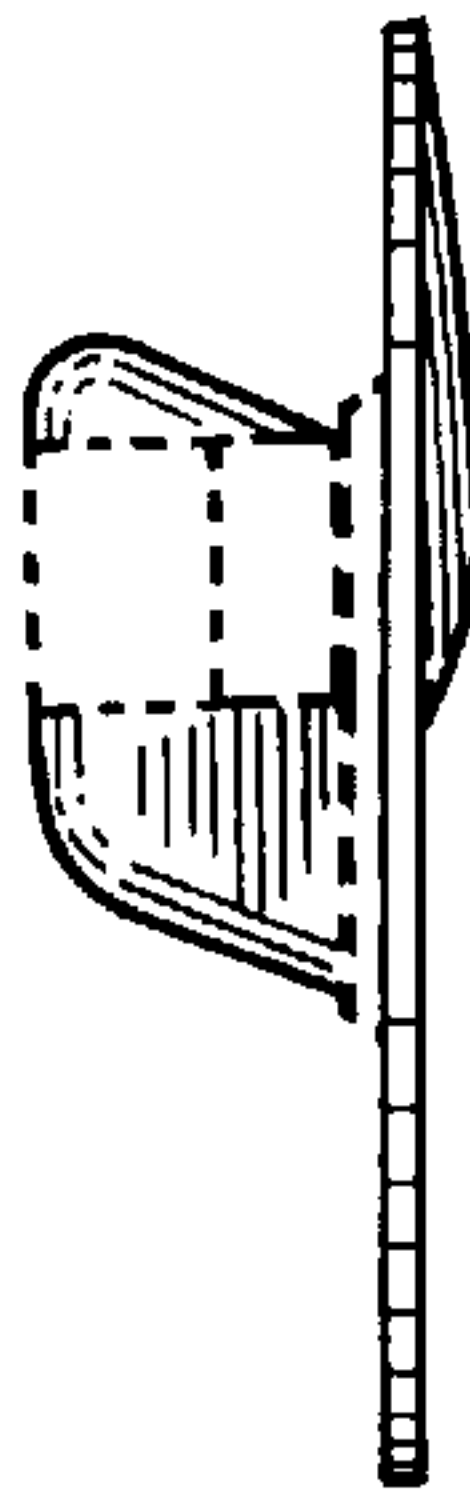
