DESCRIPTION

FIG. 1 is a perspective view of a shelf display according to the invention;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a top plan view thereof;
FIG. 5 is a bottom plan view thereof;
FIG. 6 is a side elevational view from one side thereof; and,
FIG. 7 is a side elevational view from the other side thereof.

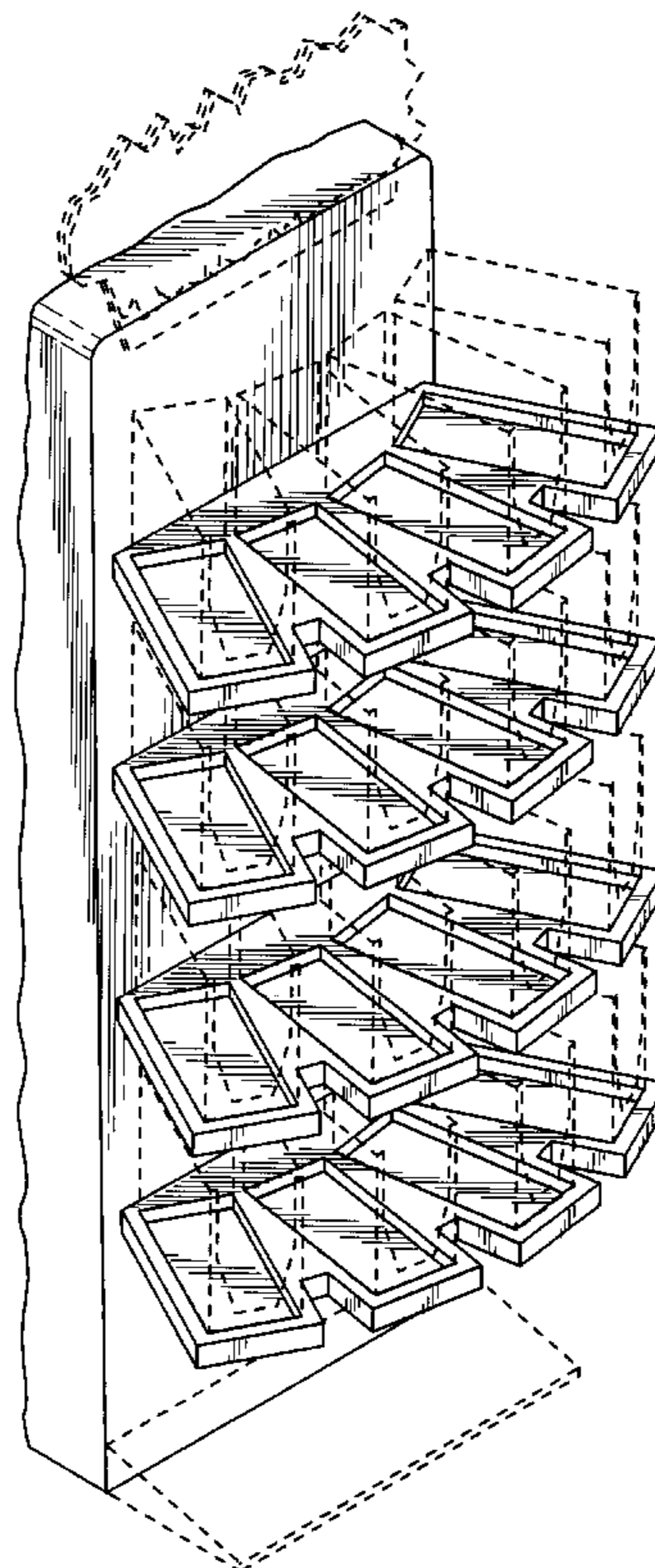

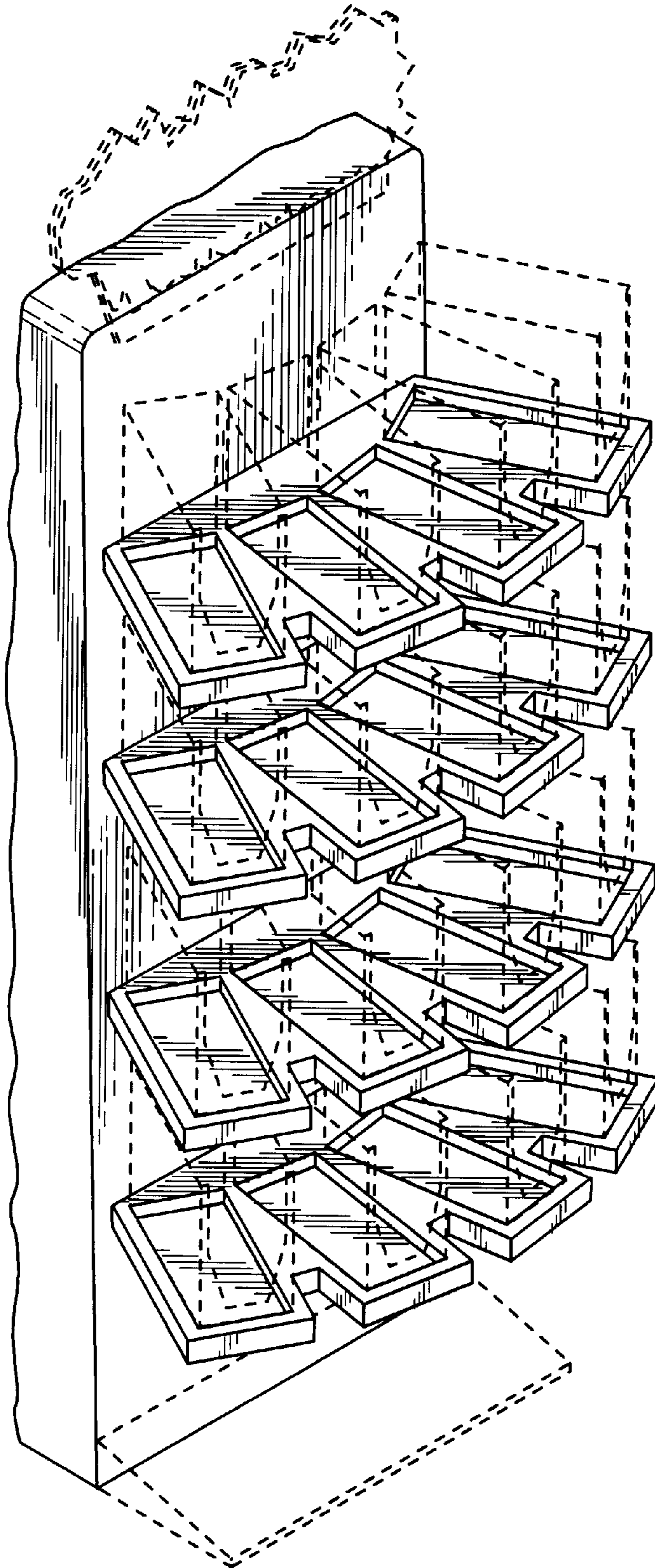

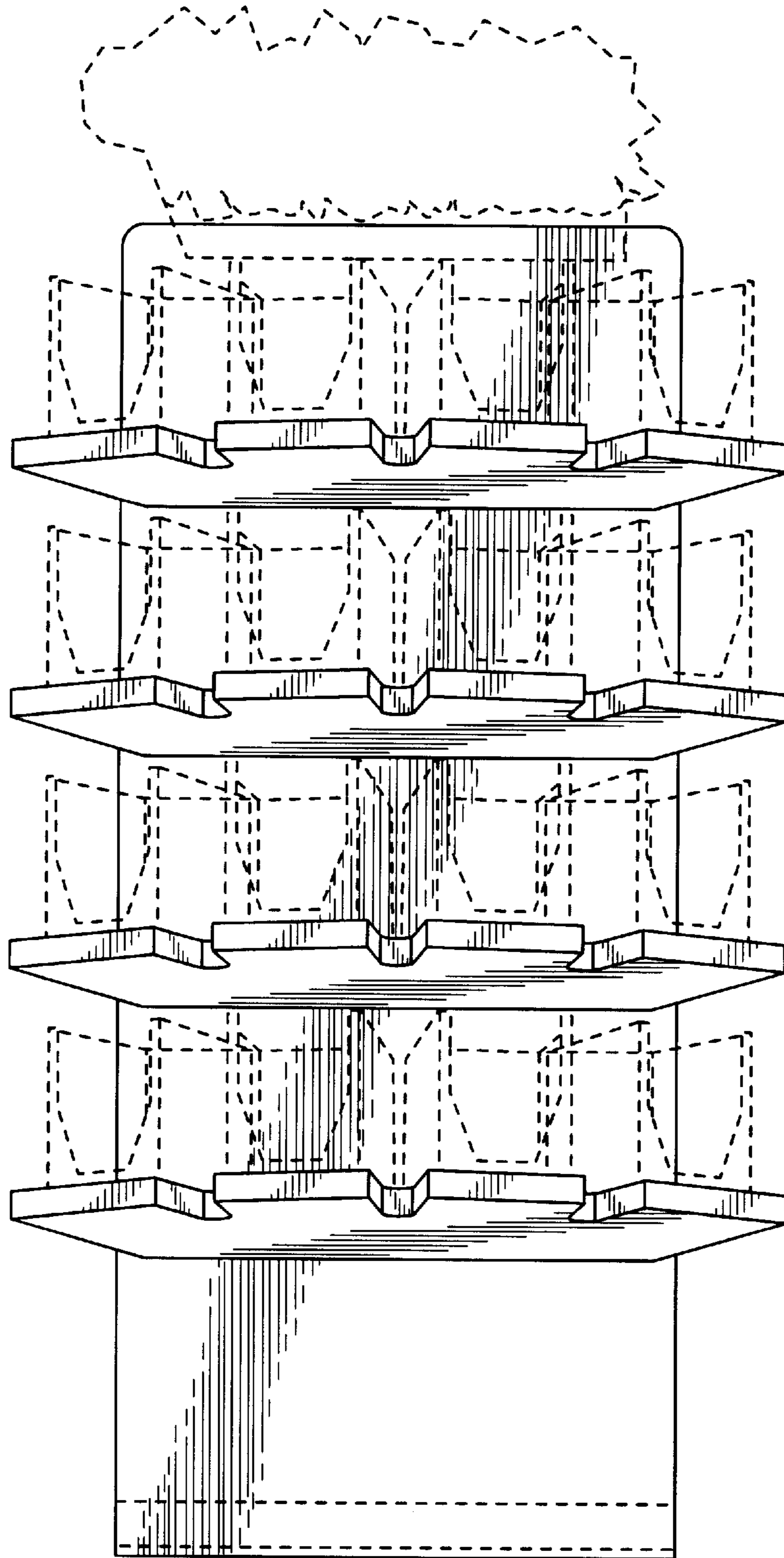

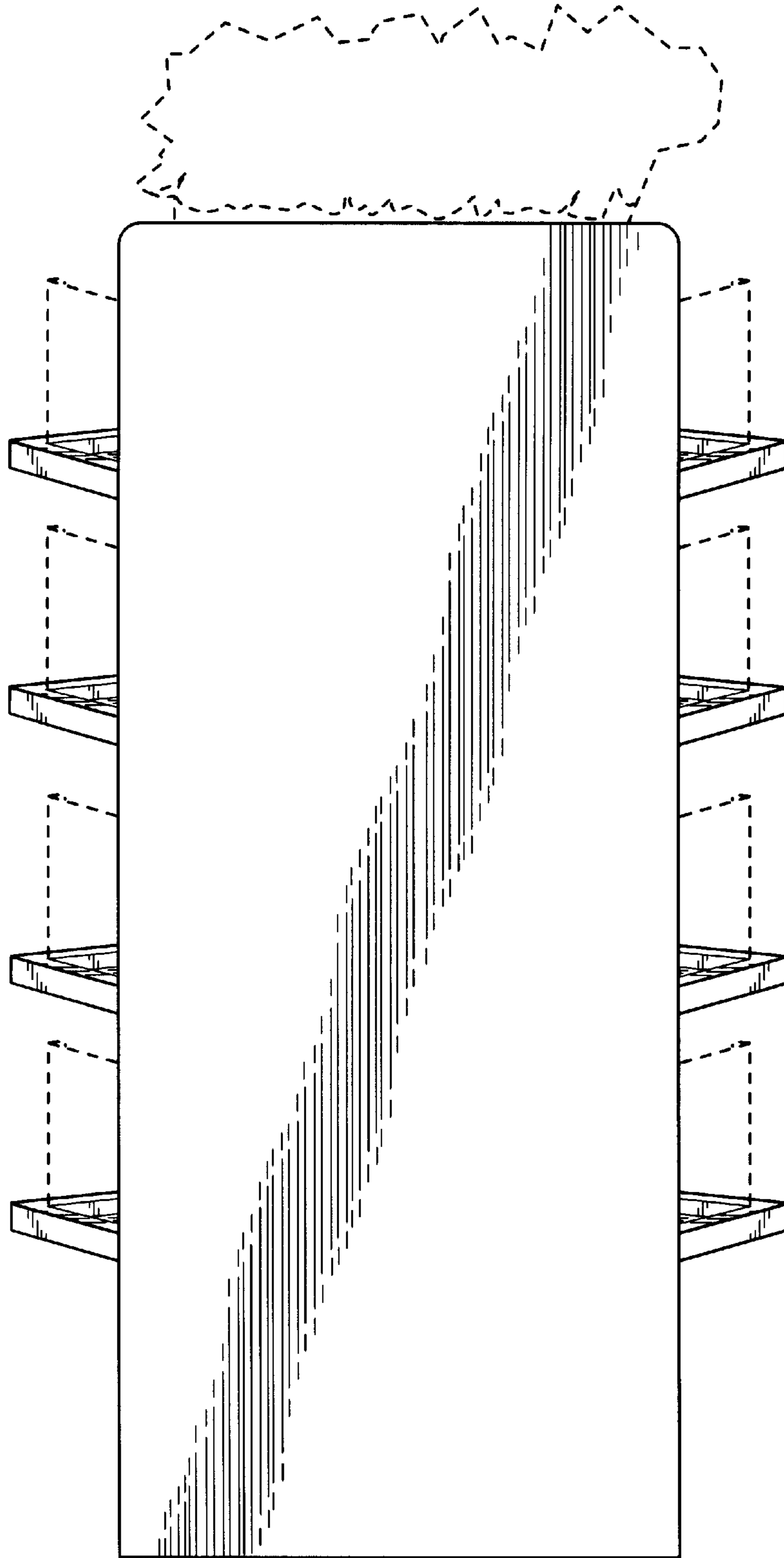

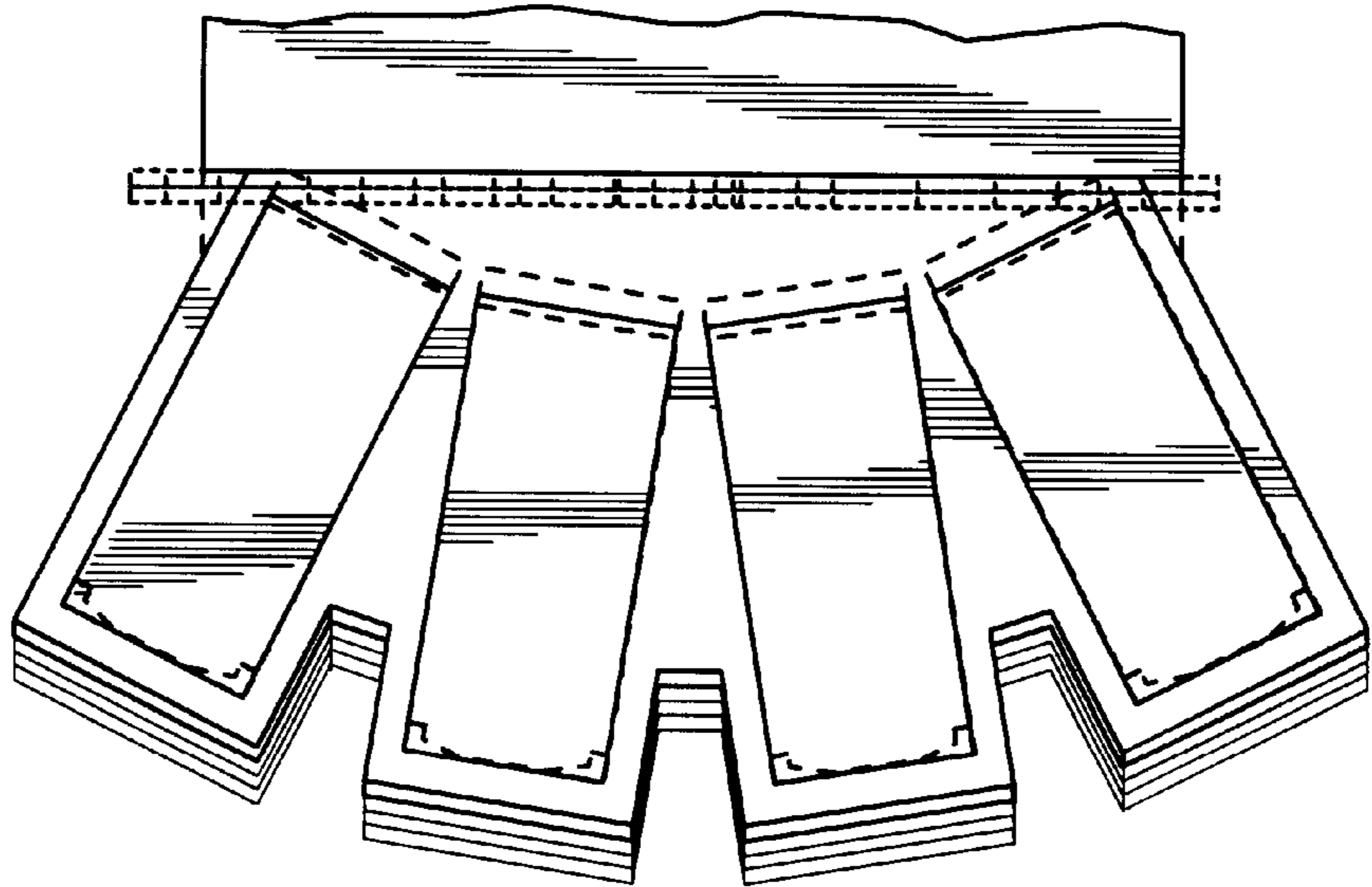

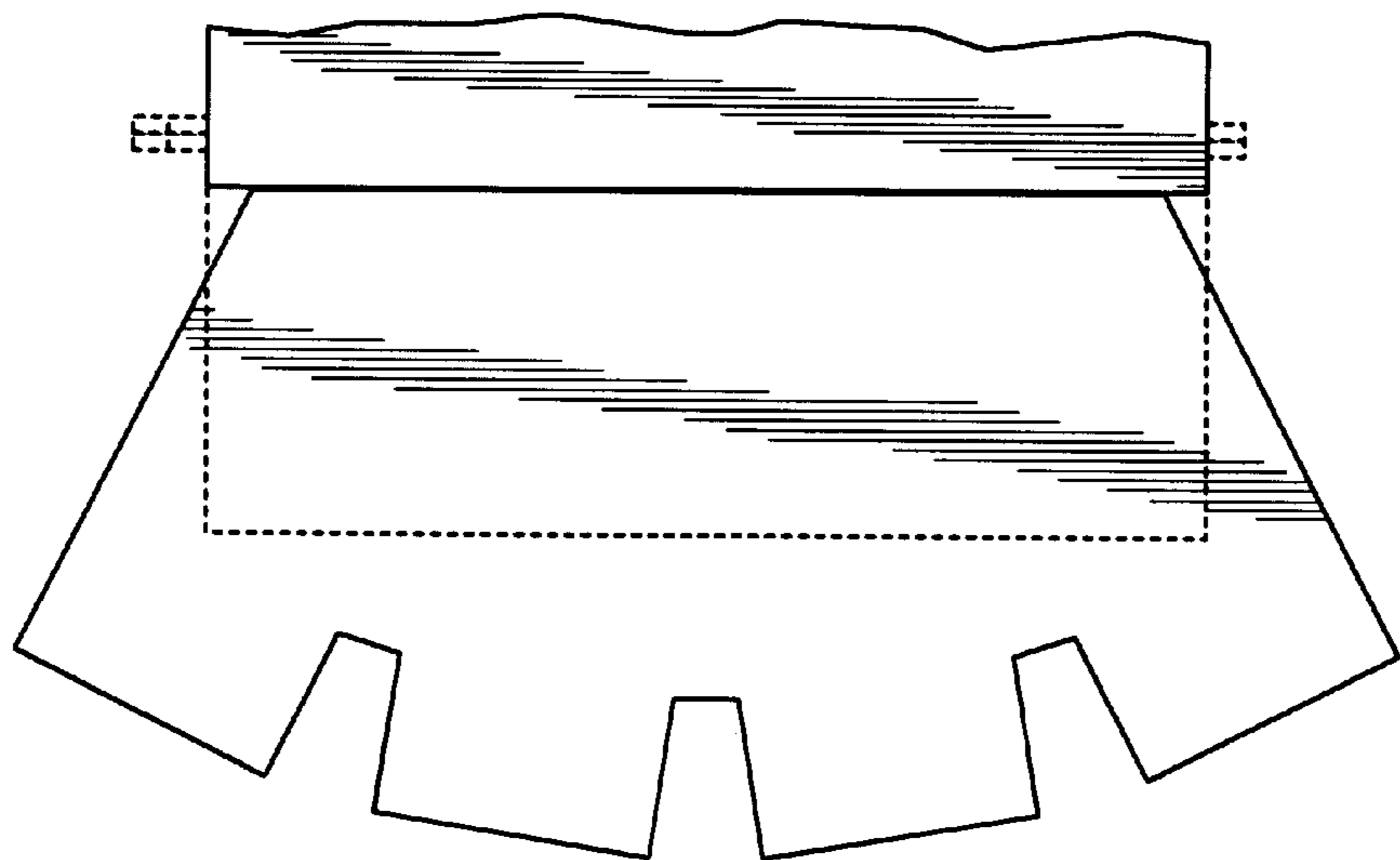

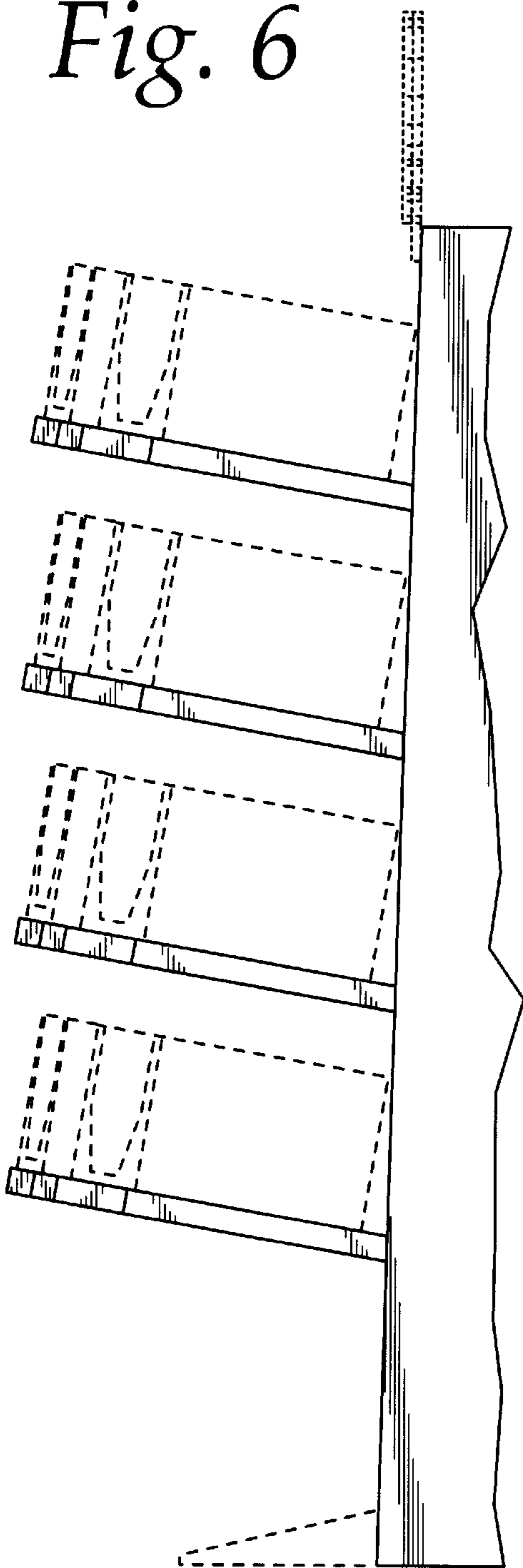
