**DESCRIPTION**

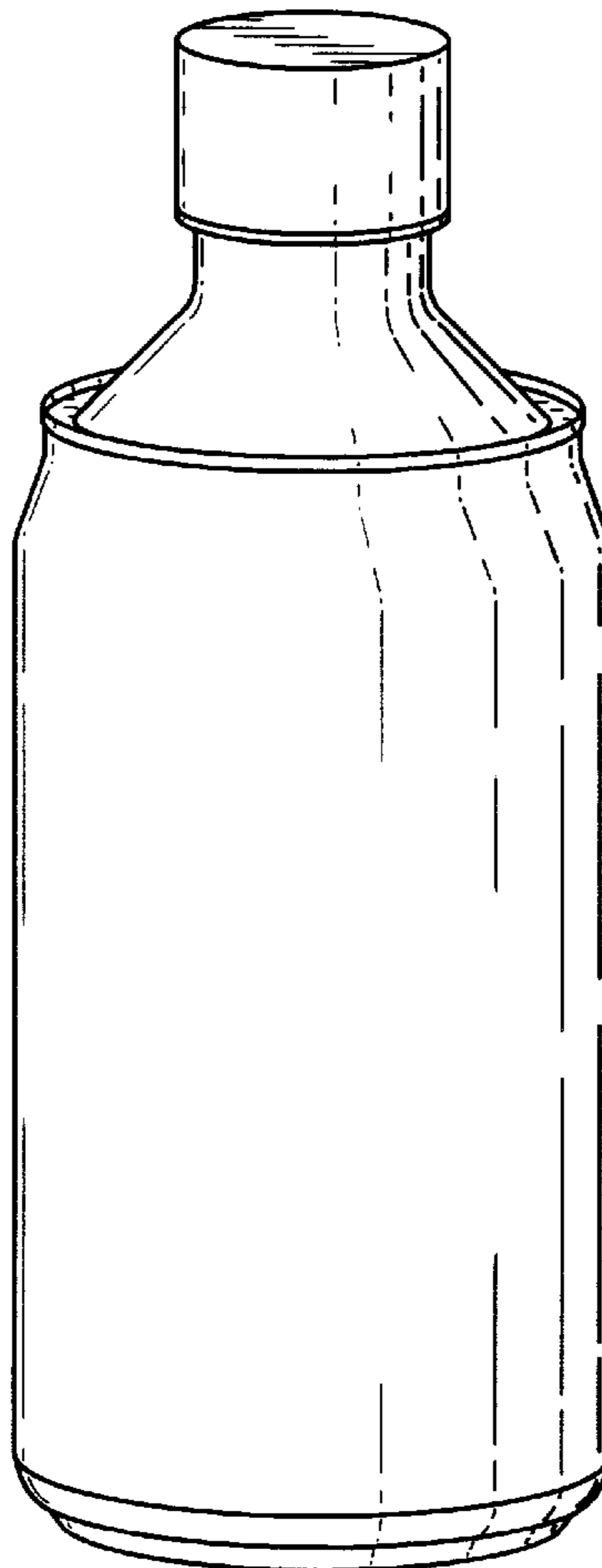
FIG. 1 is a perspective view of a drinking can showing my new design;

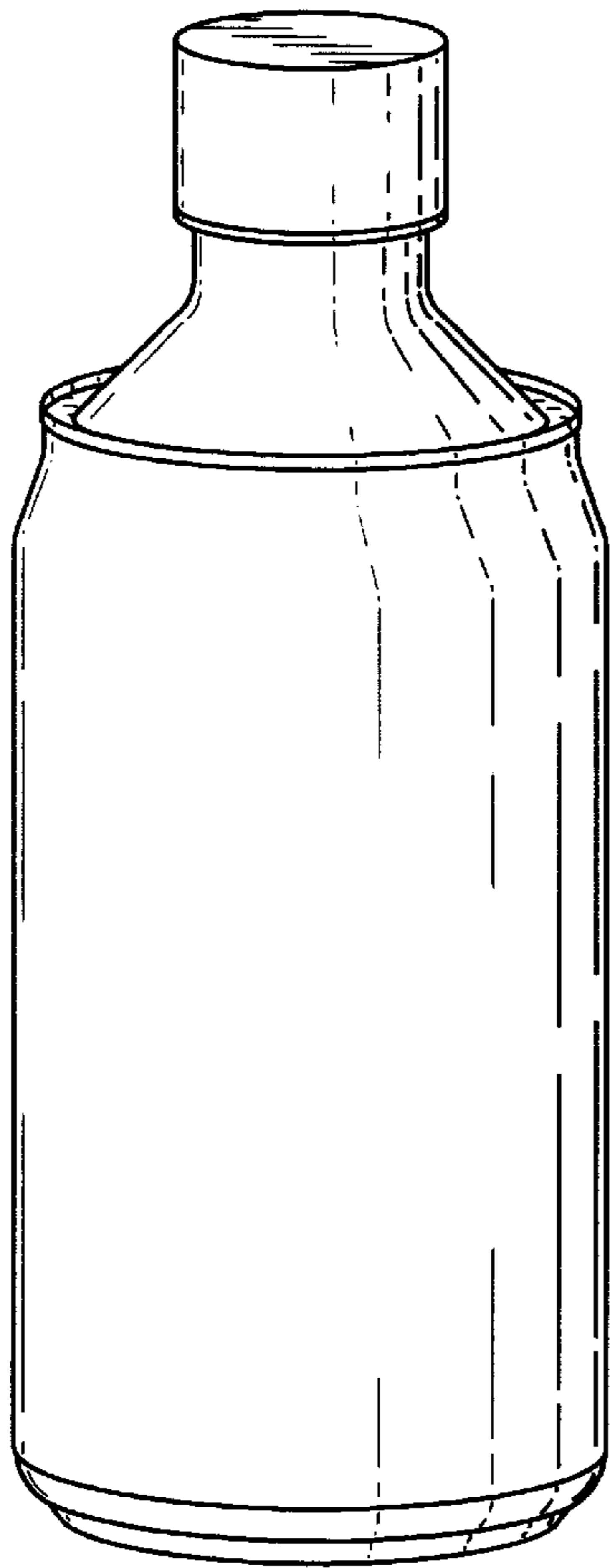
FIG. 2 is a front view thereof;

FIG. 3 is a top plan view thereof; and,

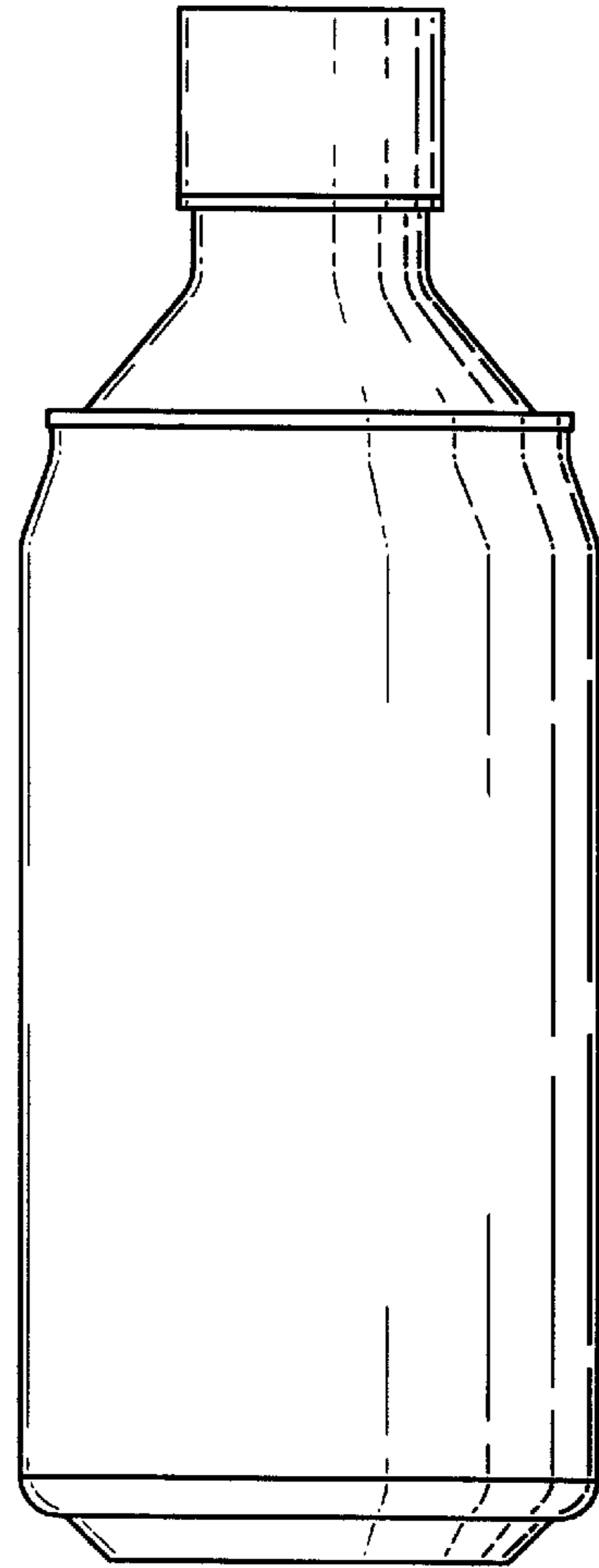
FIG. 4 is a bottom plan view thereof.

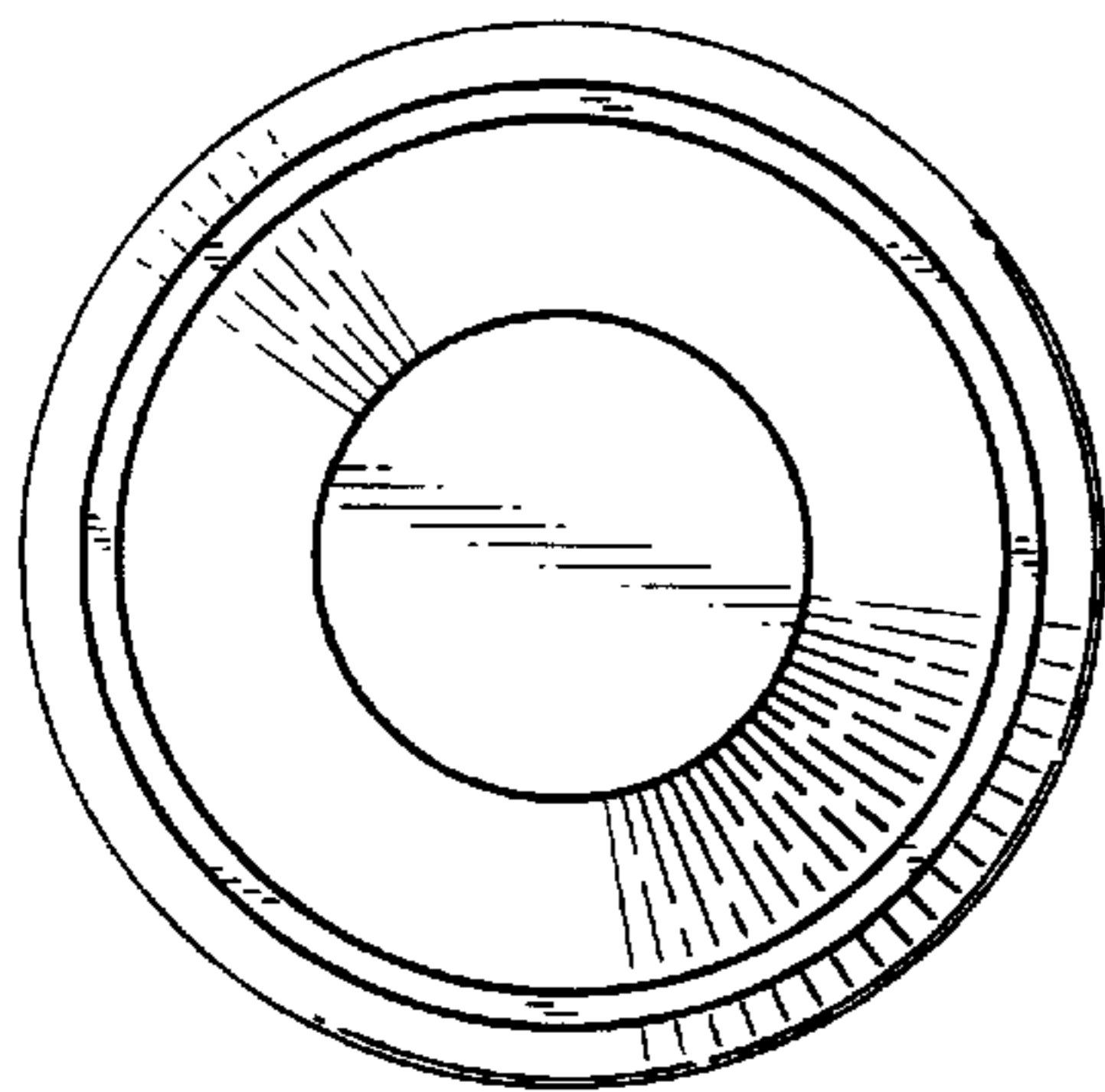




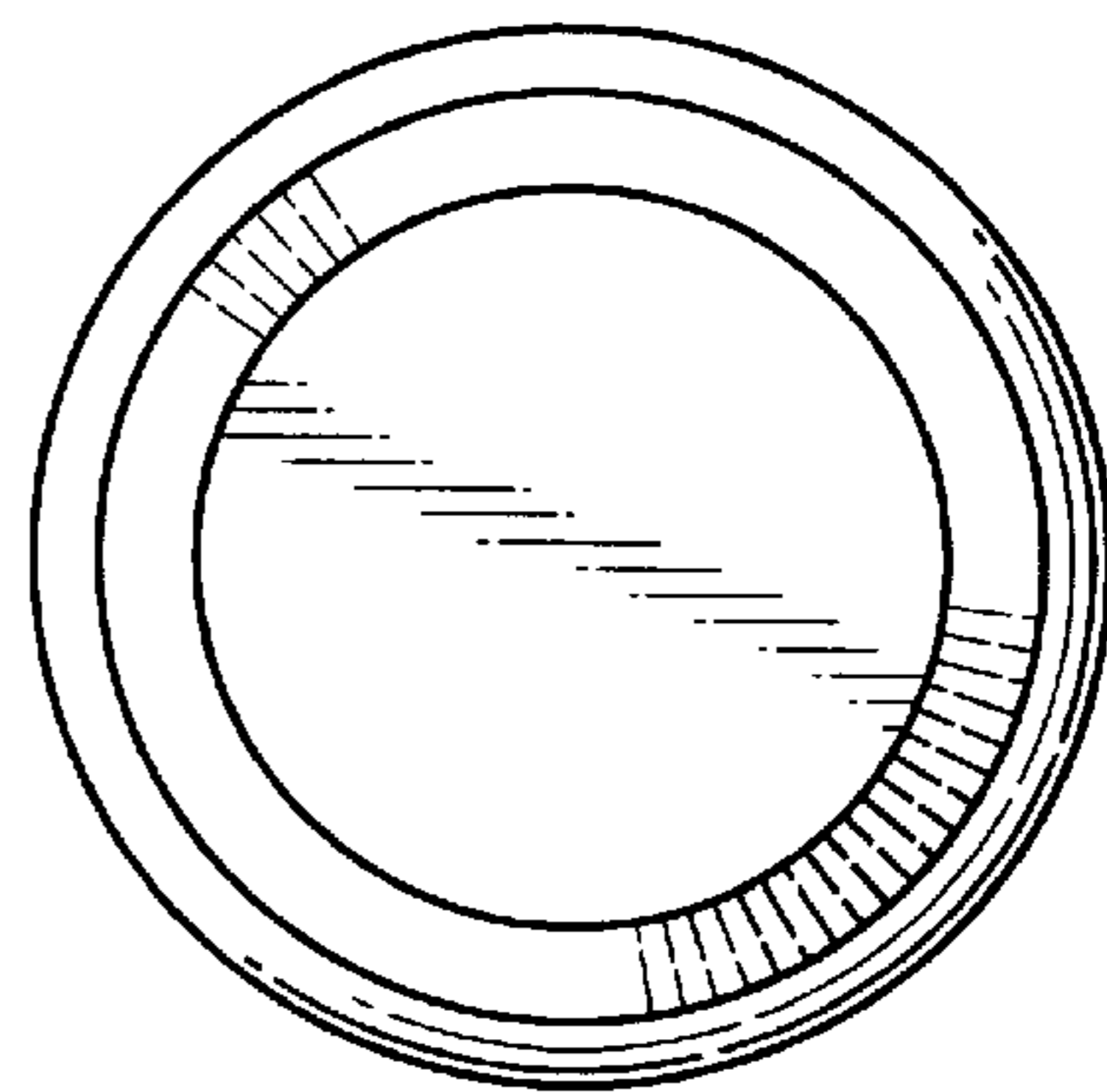
