(57) **CLAIM**

The ornamental design for a ballpoint pen, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the front, bottom and right side of a ballpoint pen showing our new design;
 FIG. 2 is a front elevational view thereof;
 FIG. 3 is a right side elevational view thereof;
 FIG. 4 is a rear elevational view thereof;
 FIG. 5 is a top plan view thereof;
 FIG. 6 is a bottom view thereof;
 FIG. 7 is a cross sectional view thereof;
 FIG. 8 is a front elevational view thereof, with the cover removed;
 FIG. 9 is a right side elevational view thereof;
 FIG. 10 is a top plan view thereof;
 FIG. 11 is a bottom view thereof;
 FIG. 12 is a front elevational of the cover removed from the pen;
 FIG. 13 is a right side view thereof;
 FIG. 14 is a rear elevational view thereof;
 FIG. 15 is a top plan view thereof; and,
 FIG. 16 is a bottom view thereof.

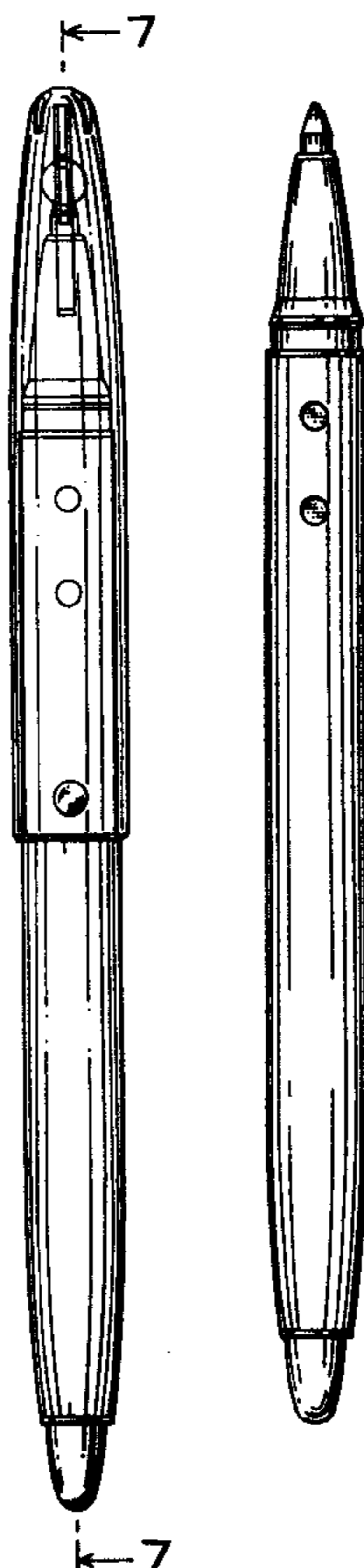

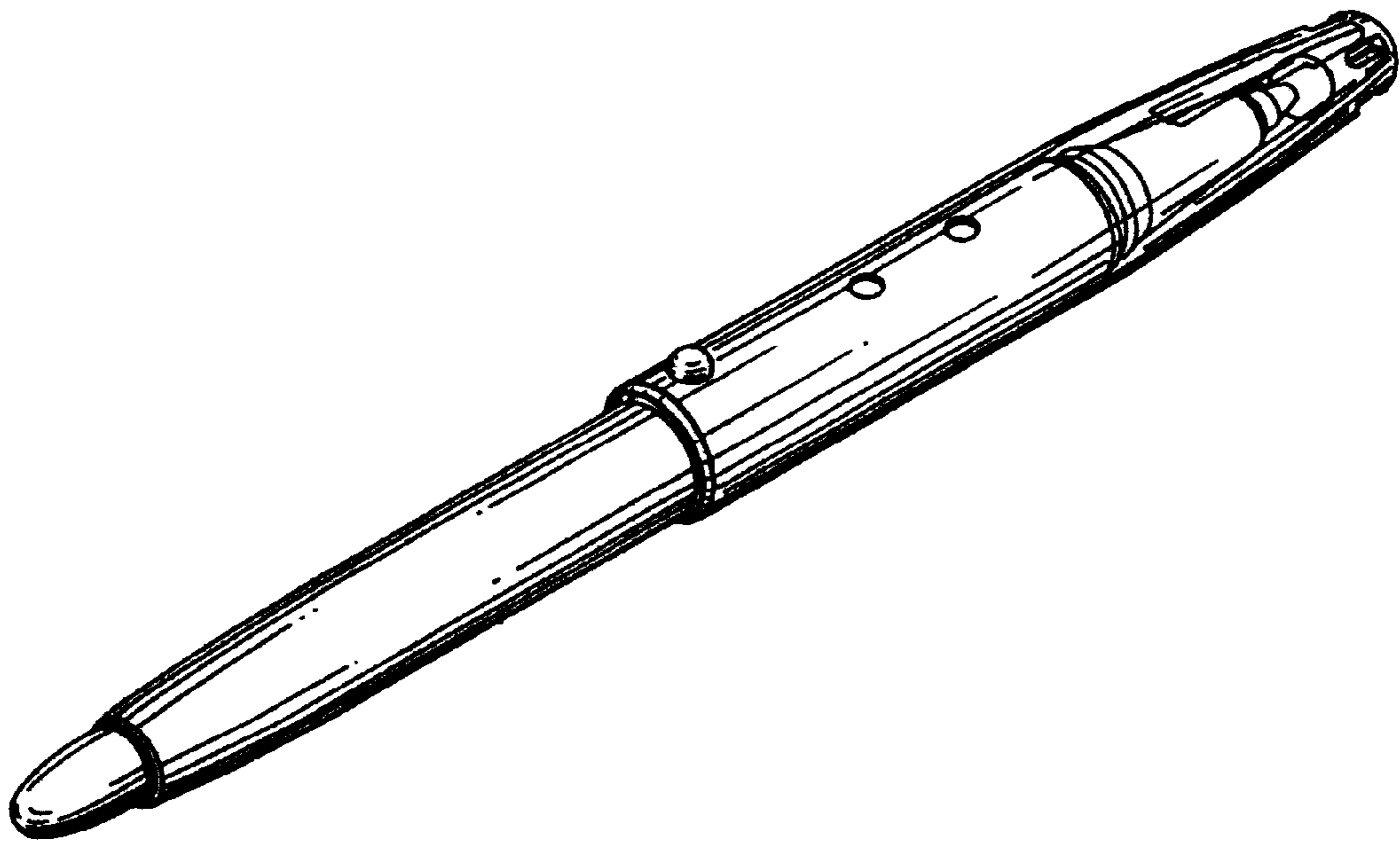

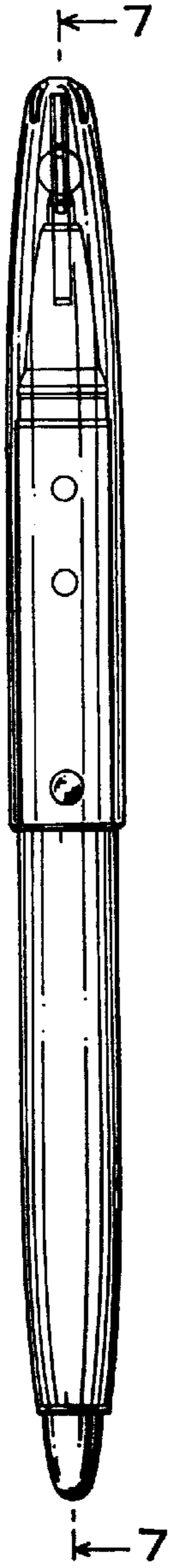

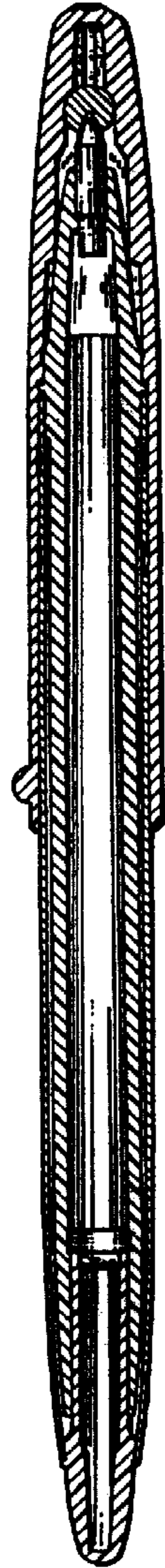

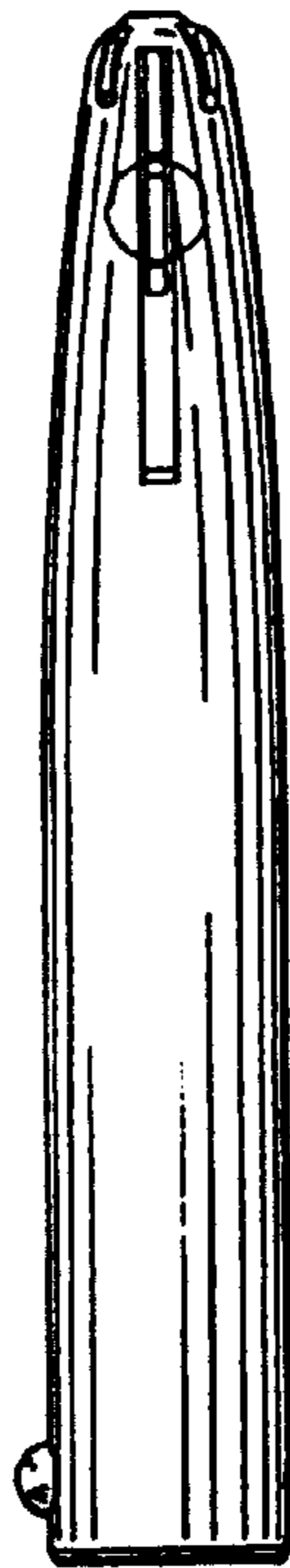
