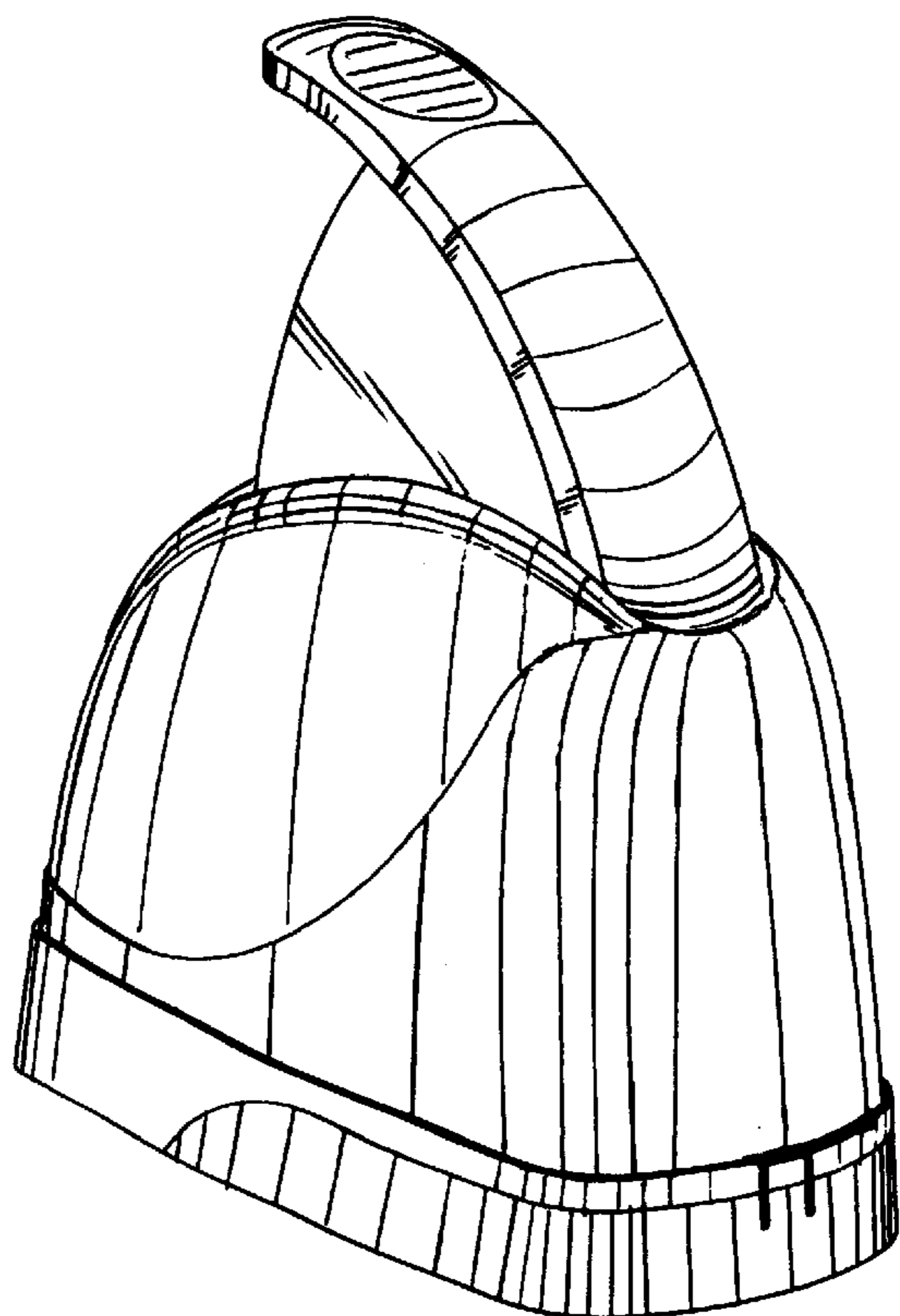
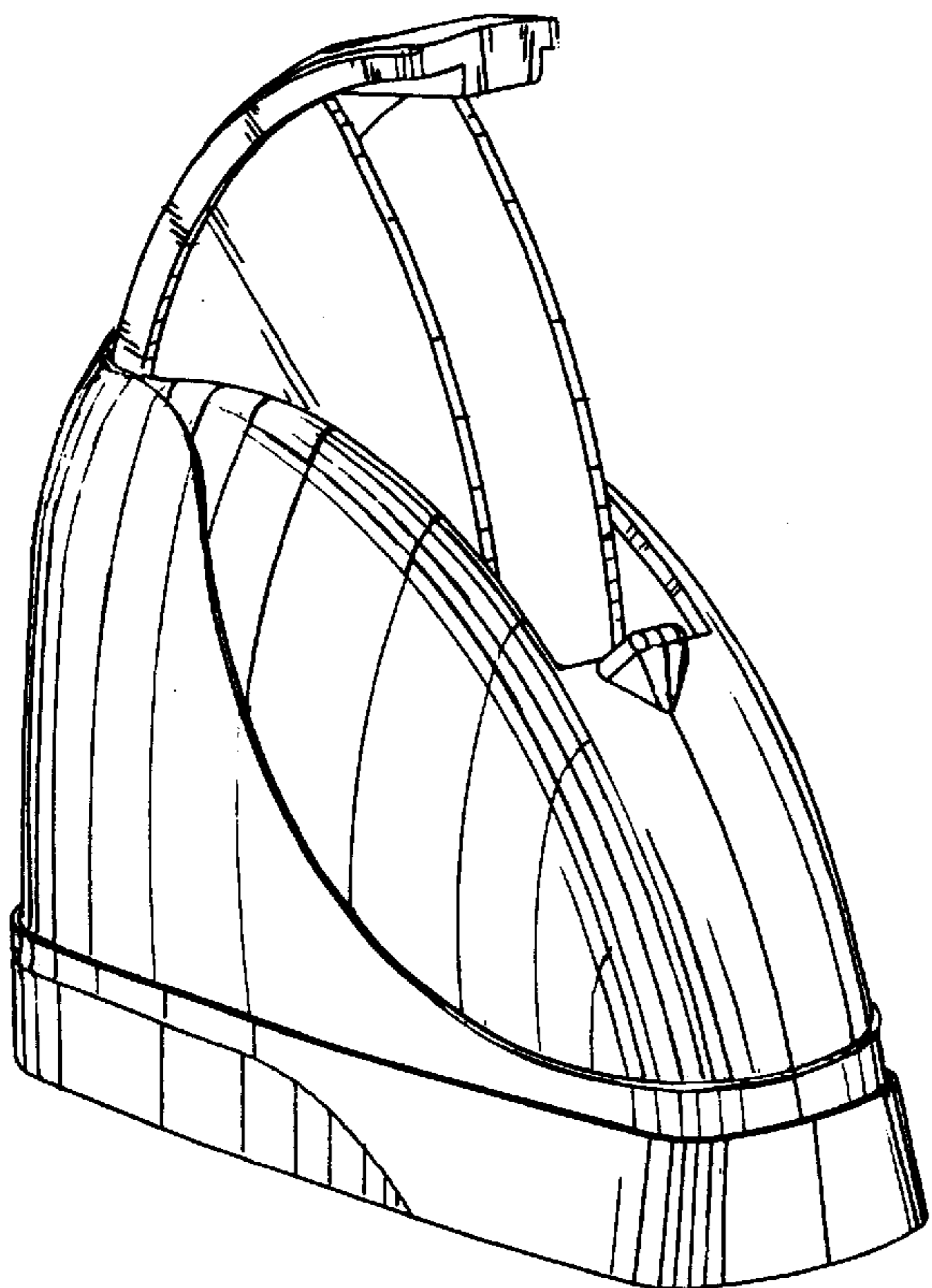
(57) **CLAIM**

The ornamental design for the adhesive tape dispenser, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of an adhesive tape dispenser with our new design;
 FIG. 2 is a rear perspective view of FIG. 1;
 FIG. 3 is a further front perspective view of FIG. 1, showing the dispenser's detachable base;
 FIG. 4 is a rear elevational view of FIG. 1;
 FIG. 5 is a top plan view of FIG. 1;
 FIG. 6 is a right side elevational view of FIG. 1, the opposite side being a mirror image of that shown;
 FIG. 7 is a bottom plan view of FIG. 1; and,
 FIG. 8 is a front elevational view of FIG. 1.

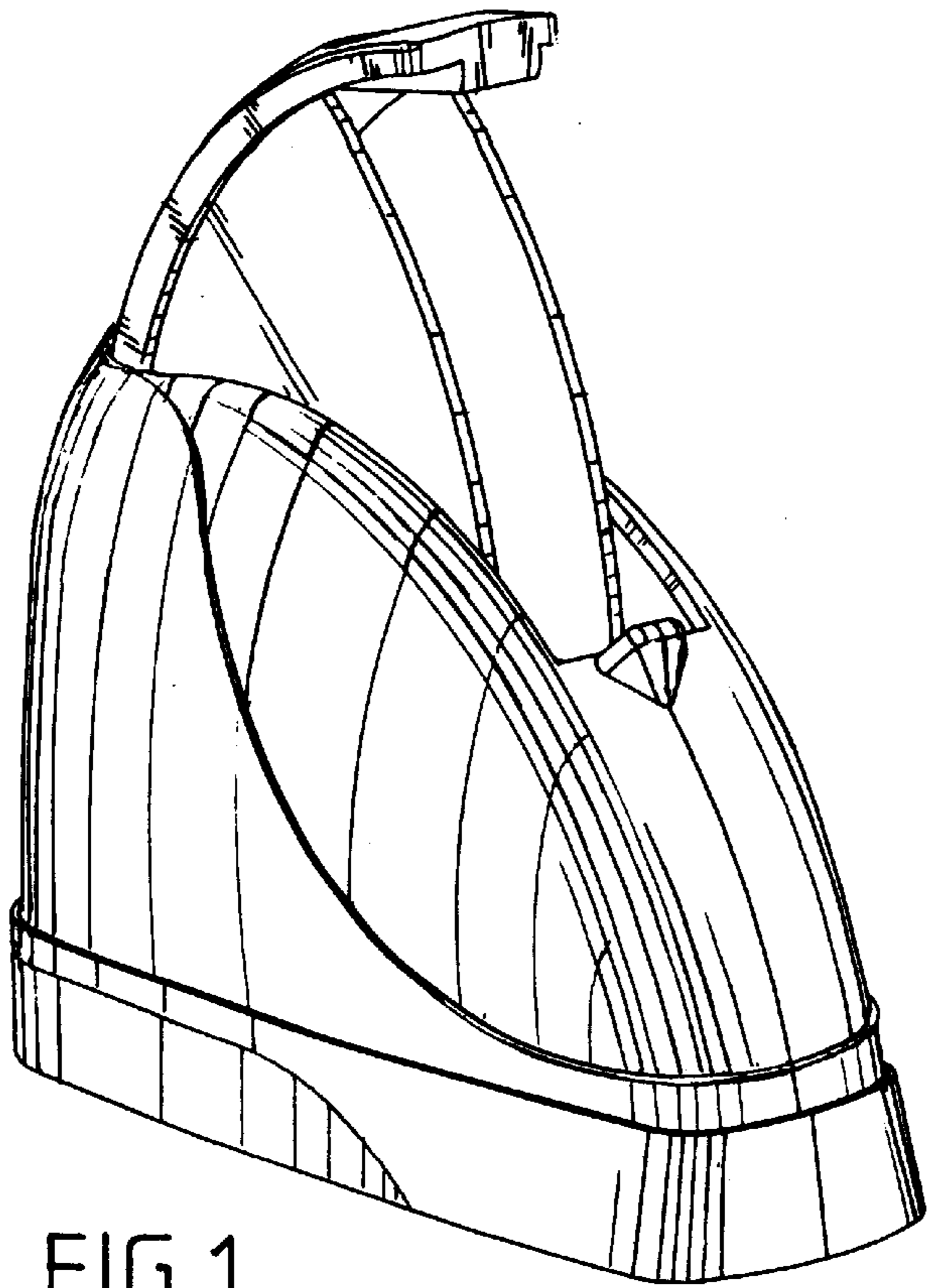

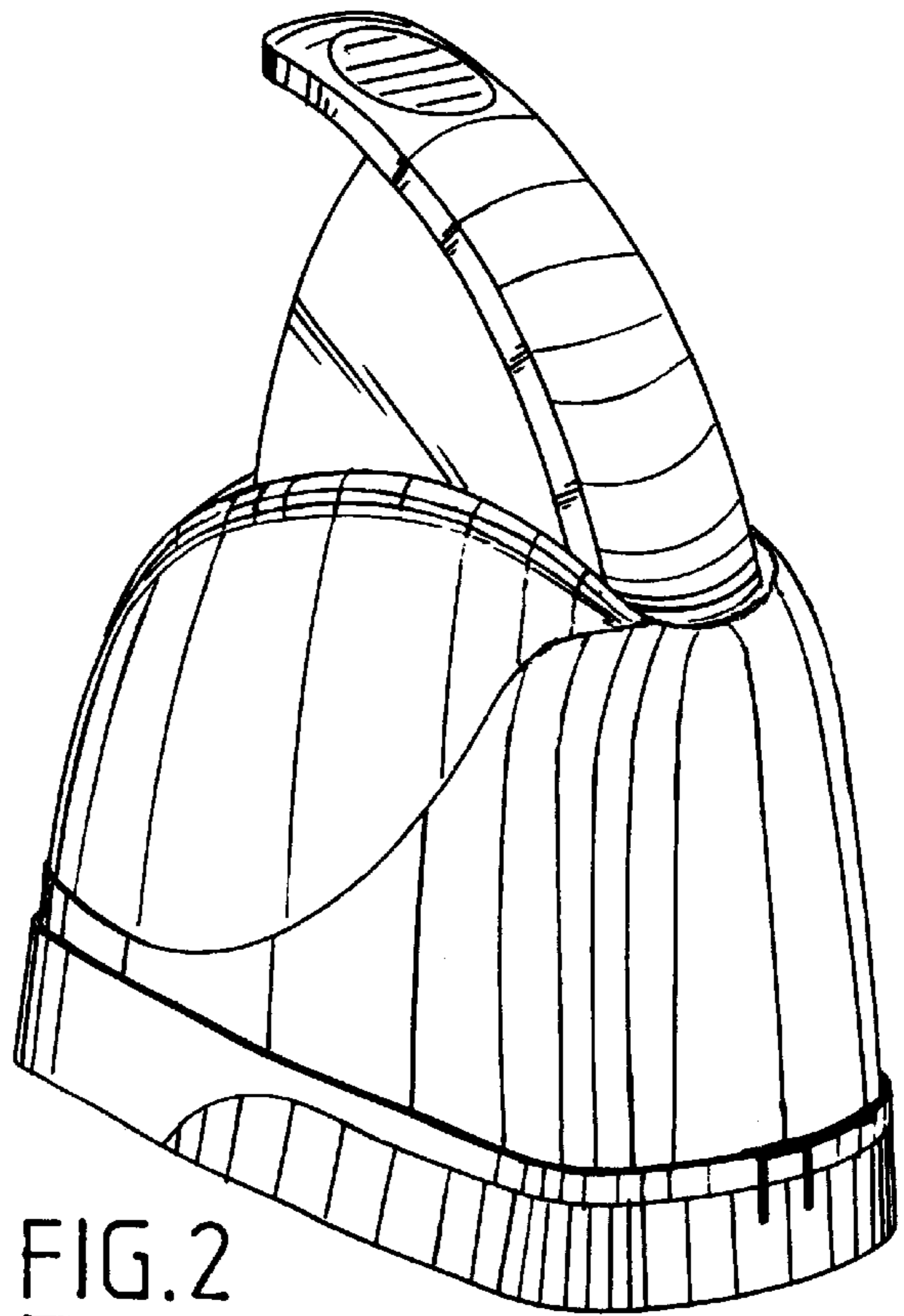

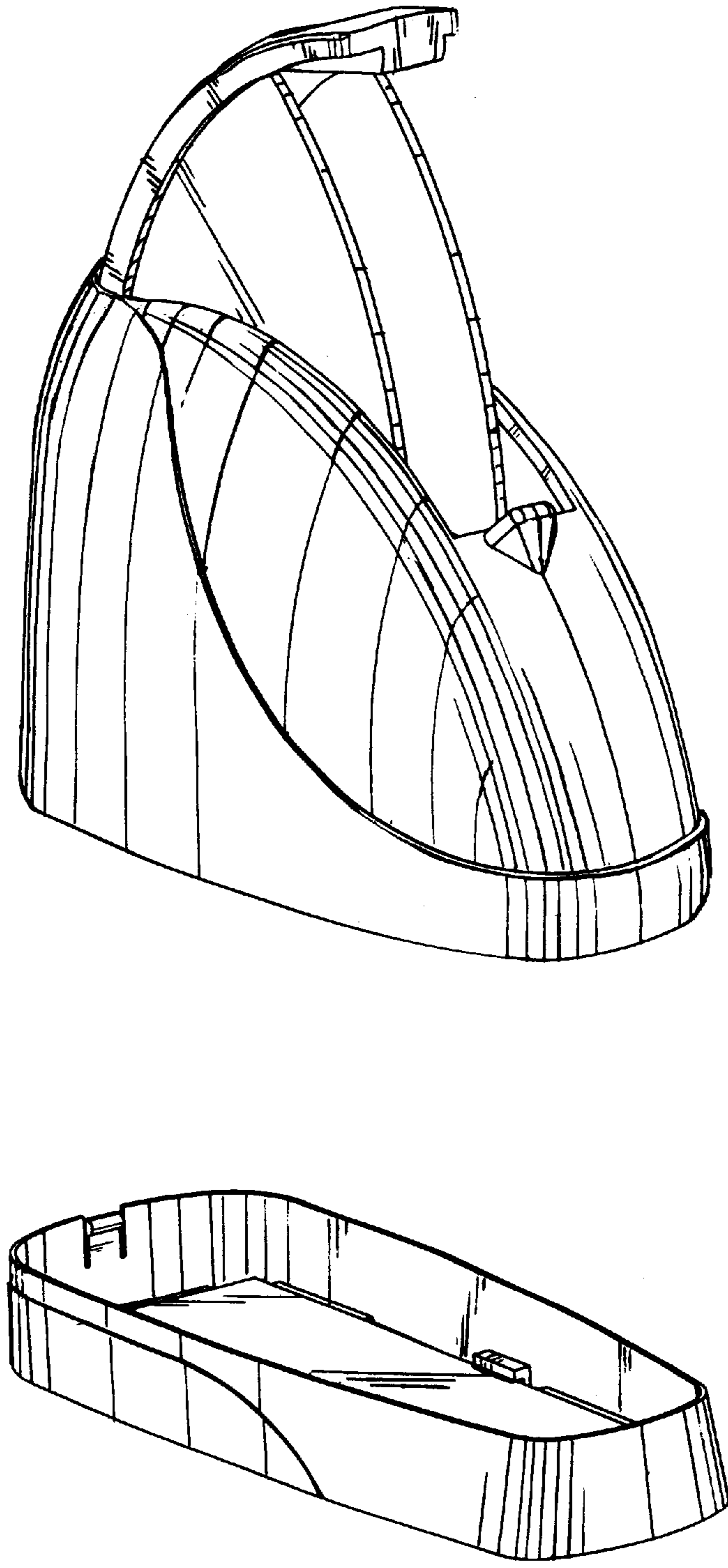

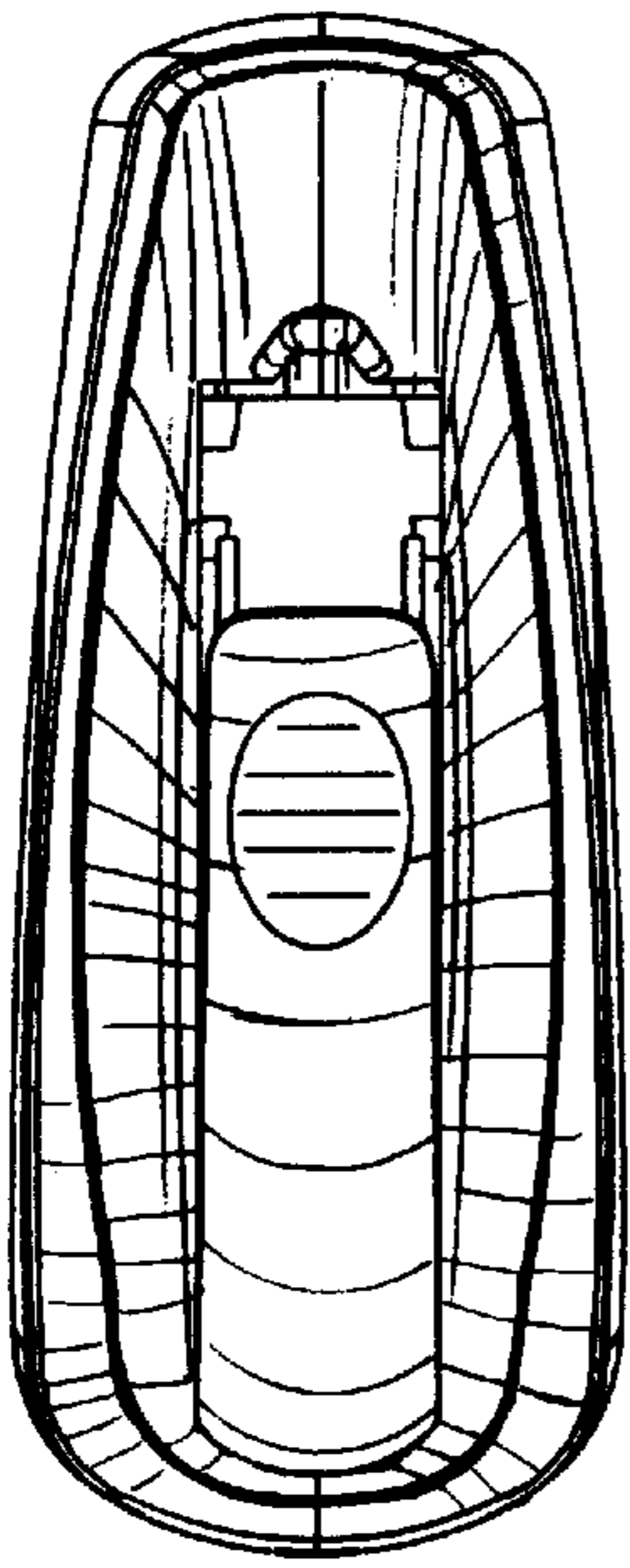

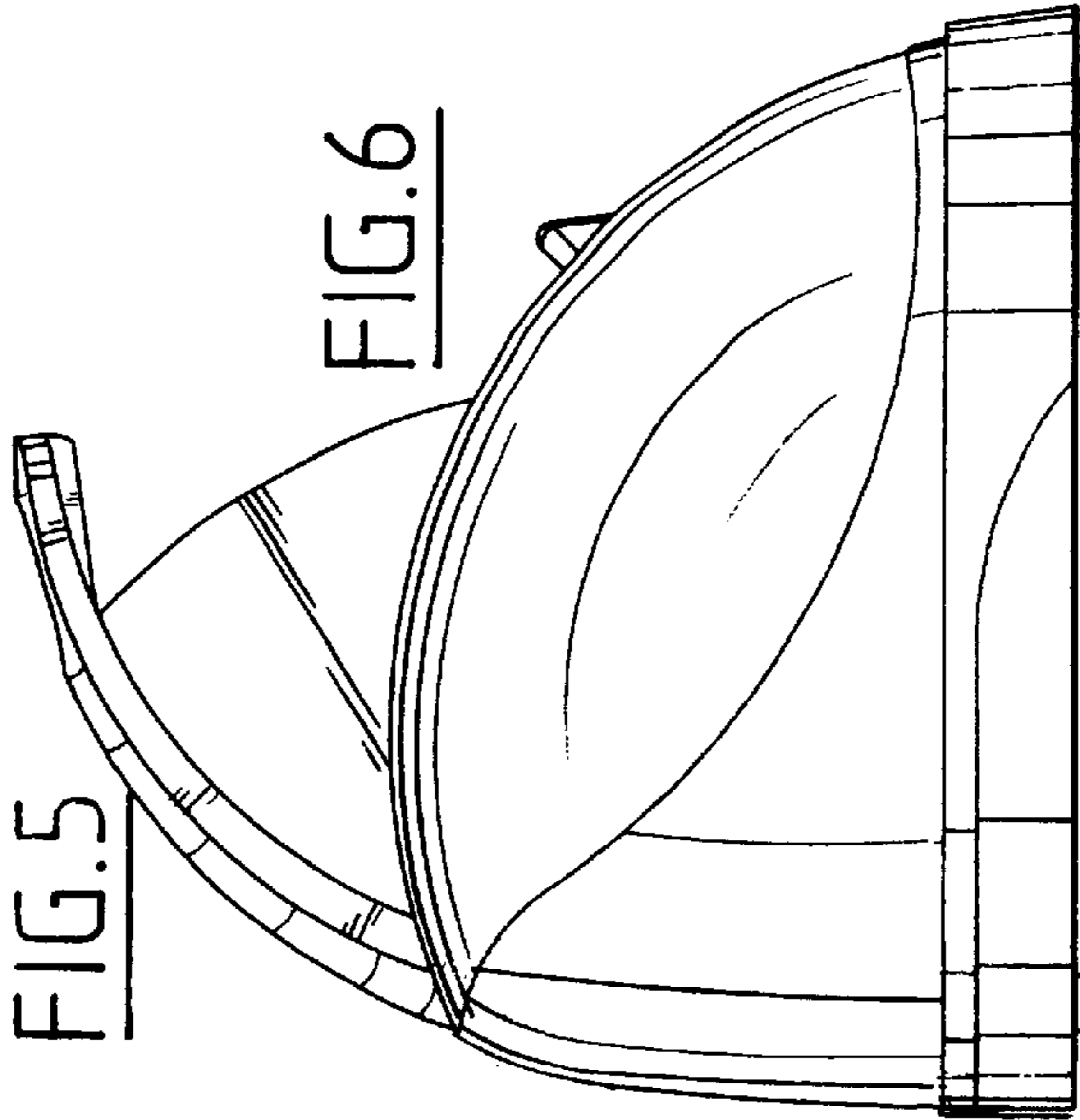

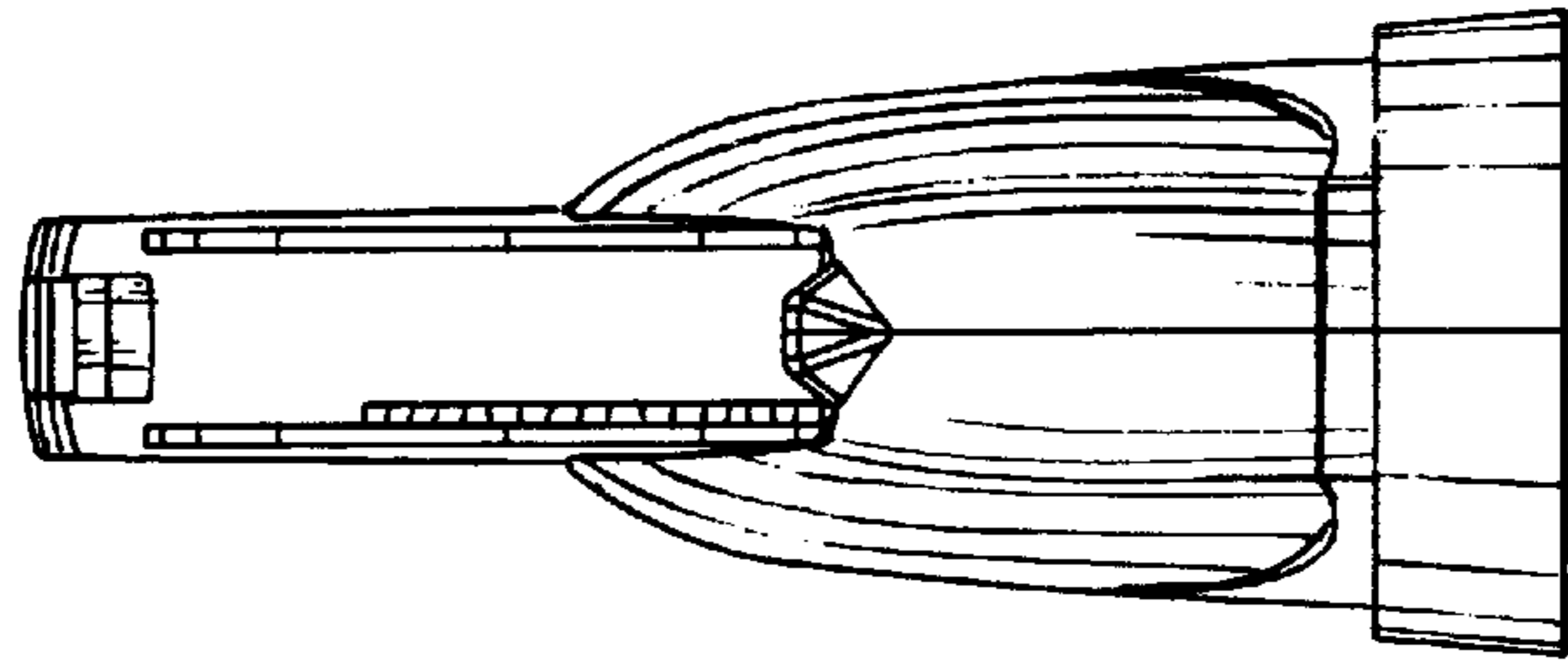

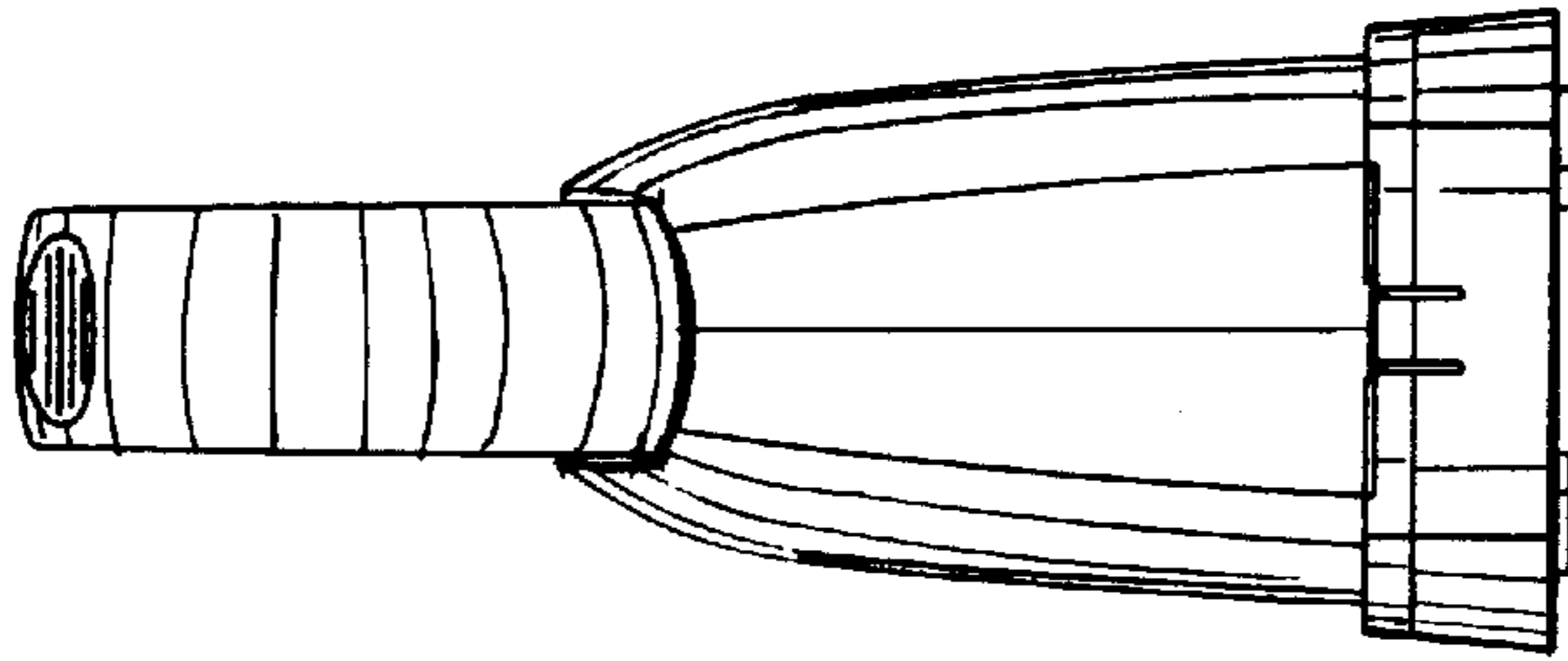

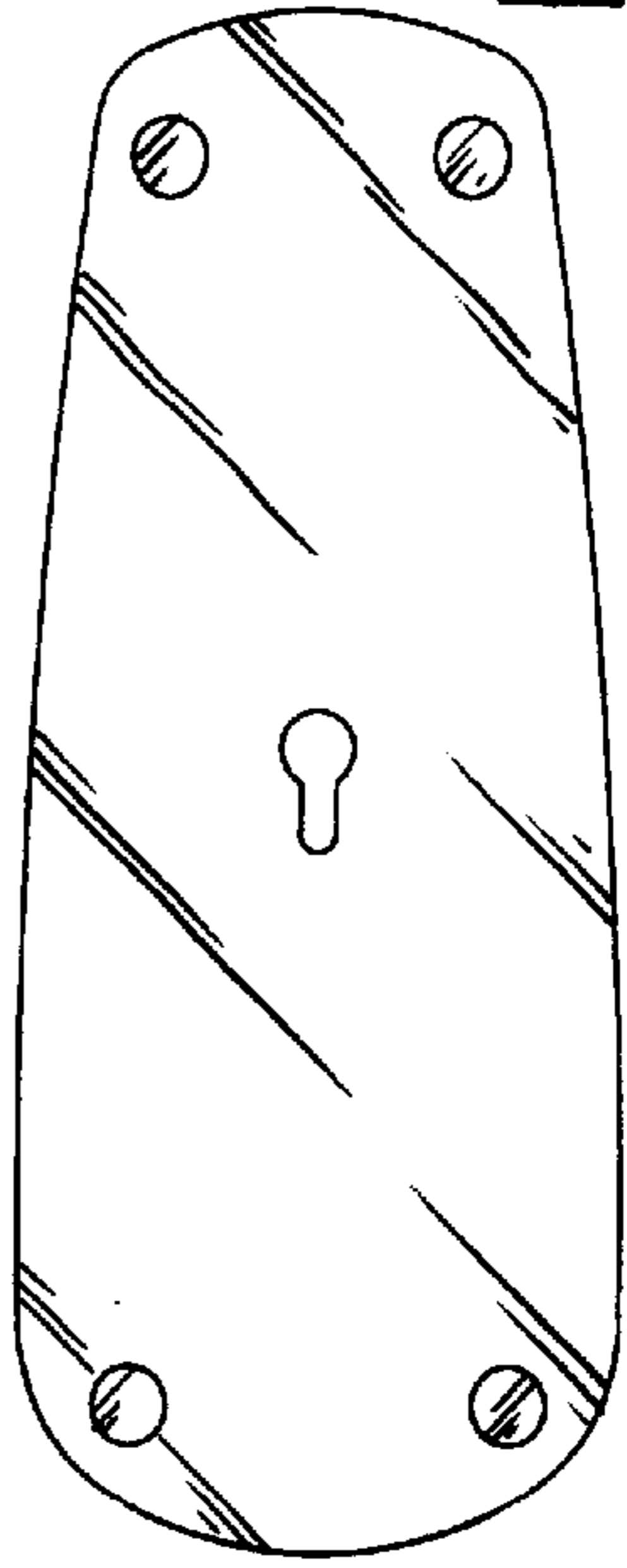
