(57) **CLAIM**

The ornamental design for a reflective whale sign, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a reflective whale sign showing my new design; the large broken lines representing environment and forming no part of the claimed design;

FIG. 2 is a rear elevation view of the invention illustrated in FIG. 1;

FIG. 3 is a left perspective view of the invention illustrated in FIG. 1;

FIG. 4 is a right elevation view of the invention illustrated in FIG. 1;

FIG. 5 is a left elevation view of the invention illustrated in FIG. 1;

FIG. 6 is a top plan view of the invention illustrated in FIG. 1; and,

FIG. 7 is a bottom plan view of the invention illustrated in FIG. 1.

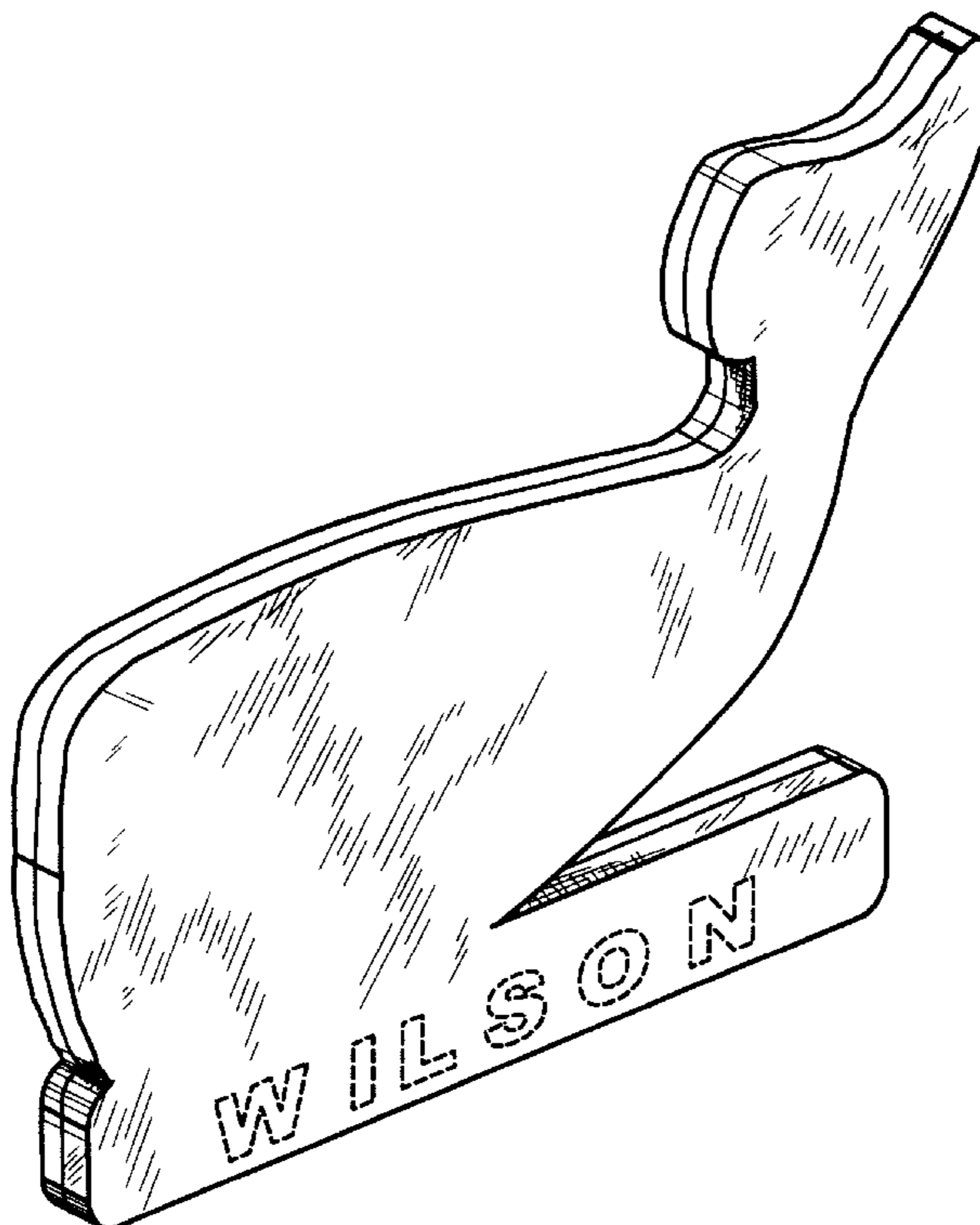

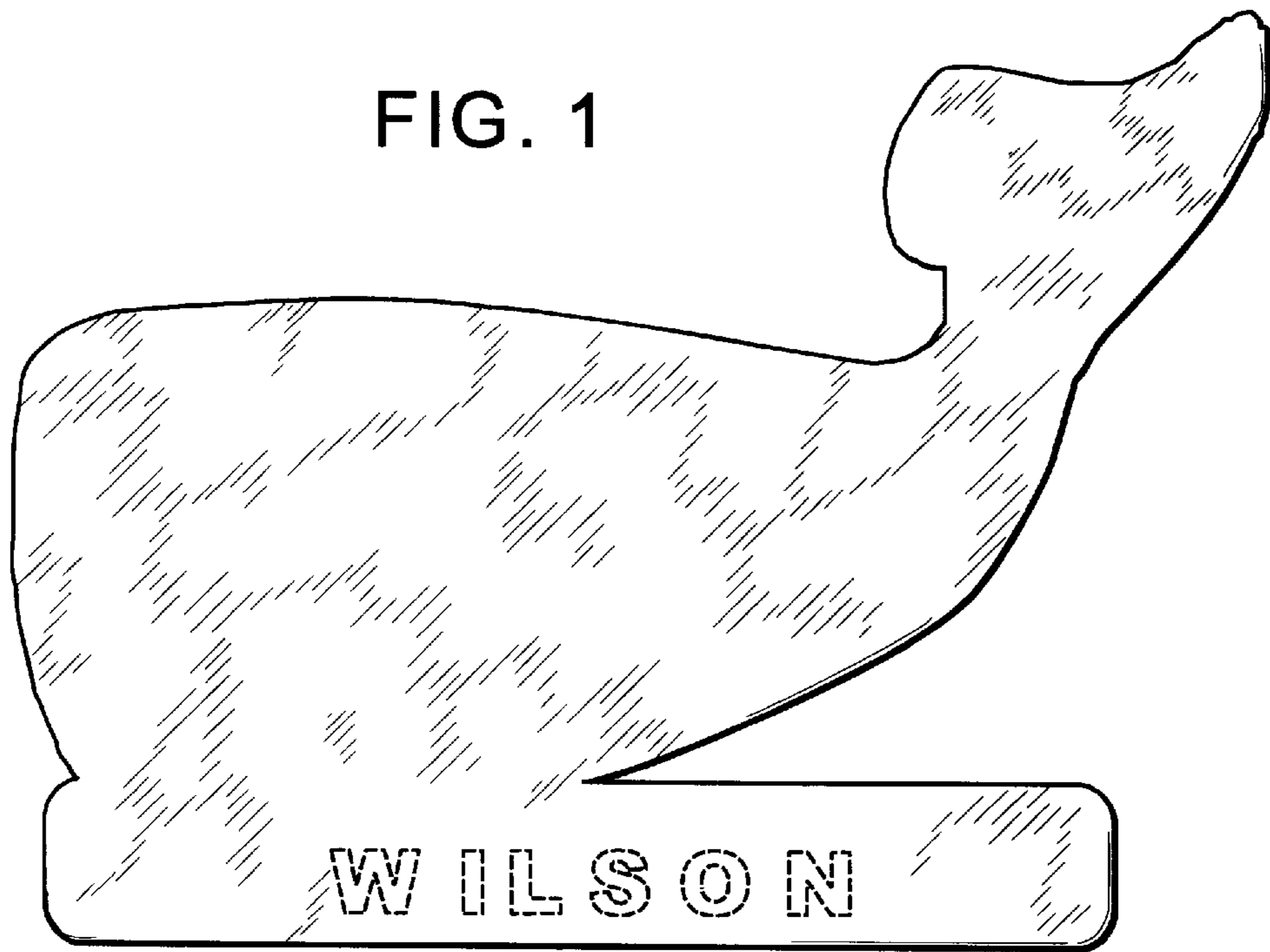
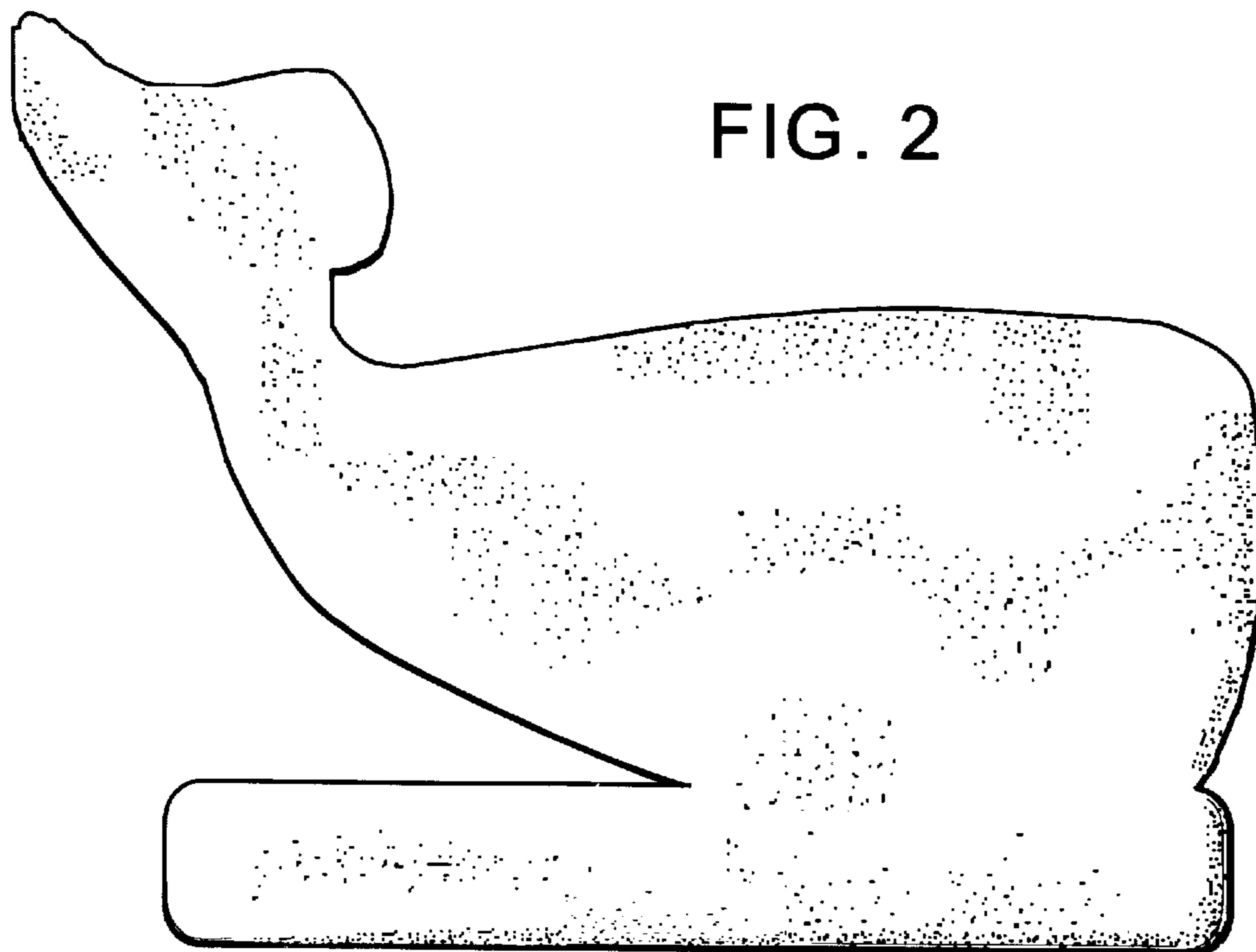

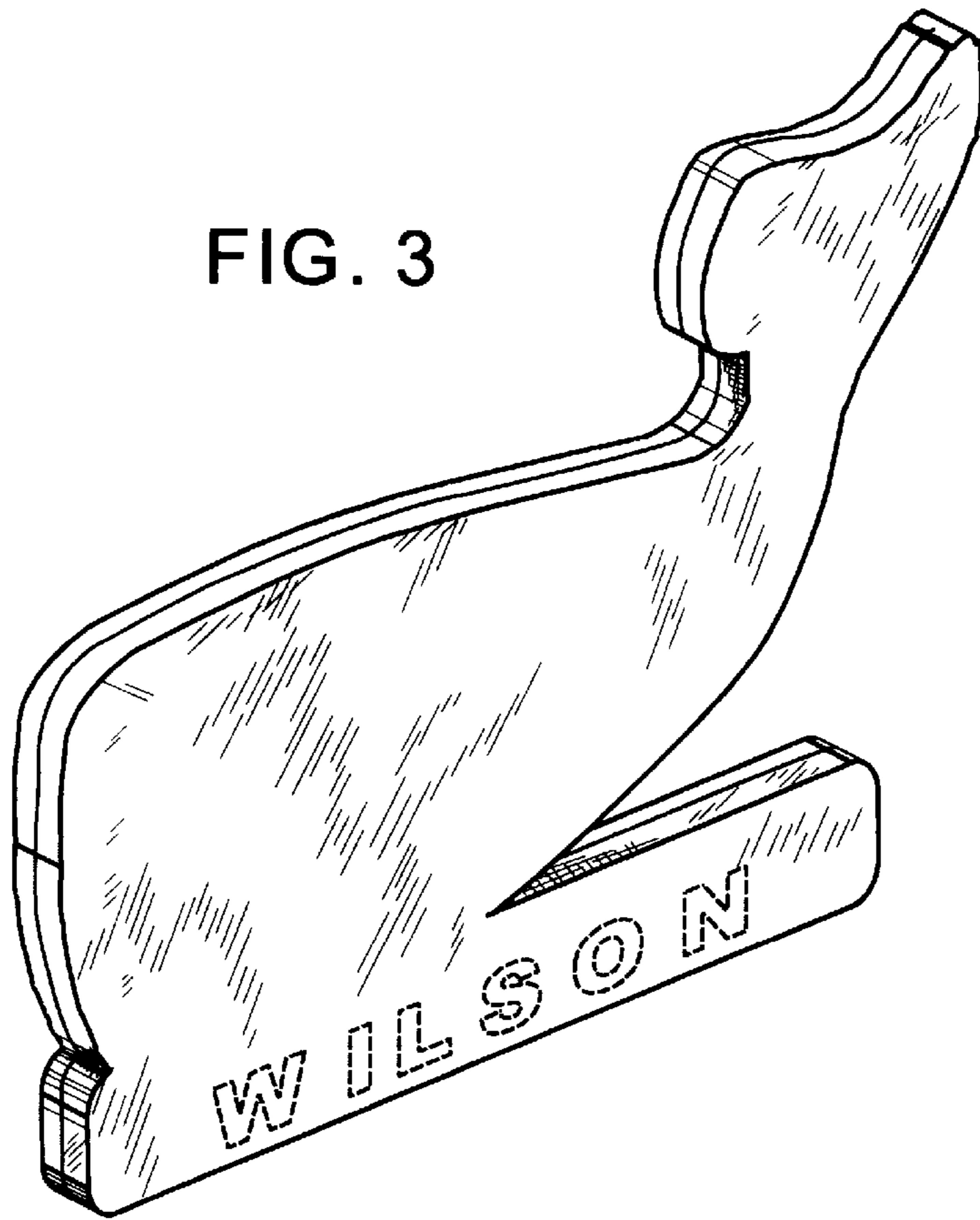

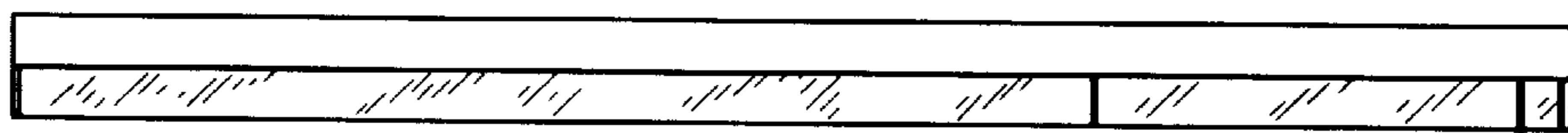

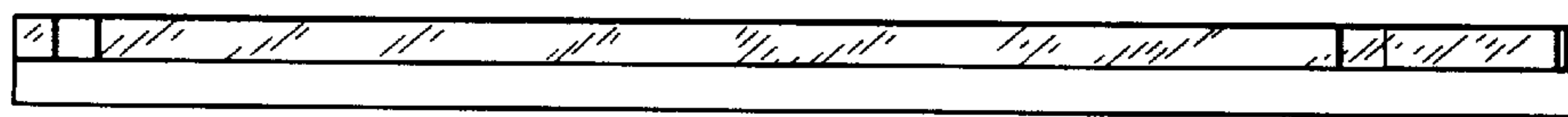
