The ornamental design for a wagering device display, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the wagering device display;

FIG. 2 is a front elevational view of the wagering device display;

FIG. 3 is a rear elevational view of the wagering device display;

FIG. 4 is a top plan view of the wagering device display;

FIG. 5 is a right side elevational view of the wagering device display; and,

FIG. 6 is a left side elevational view of the wagering device display.

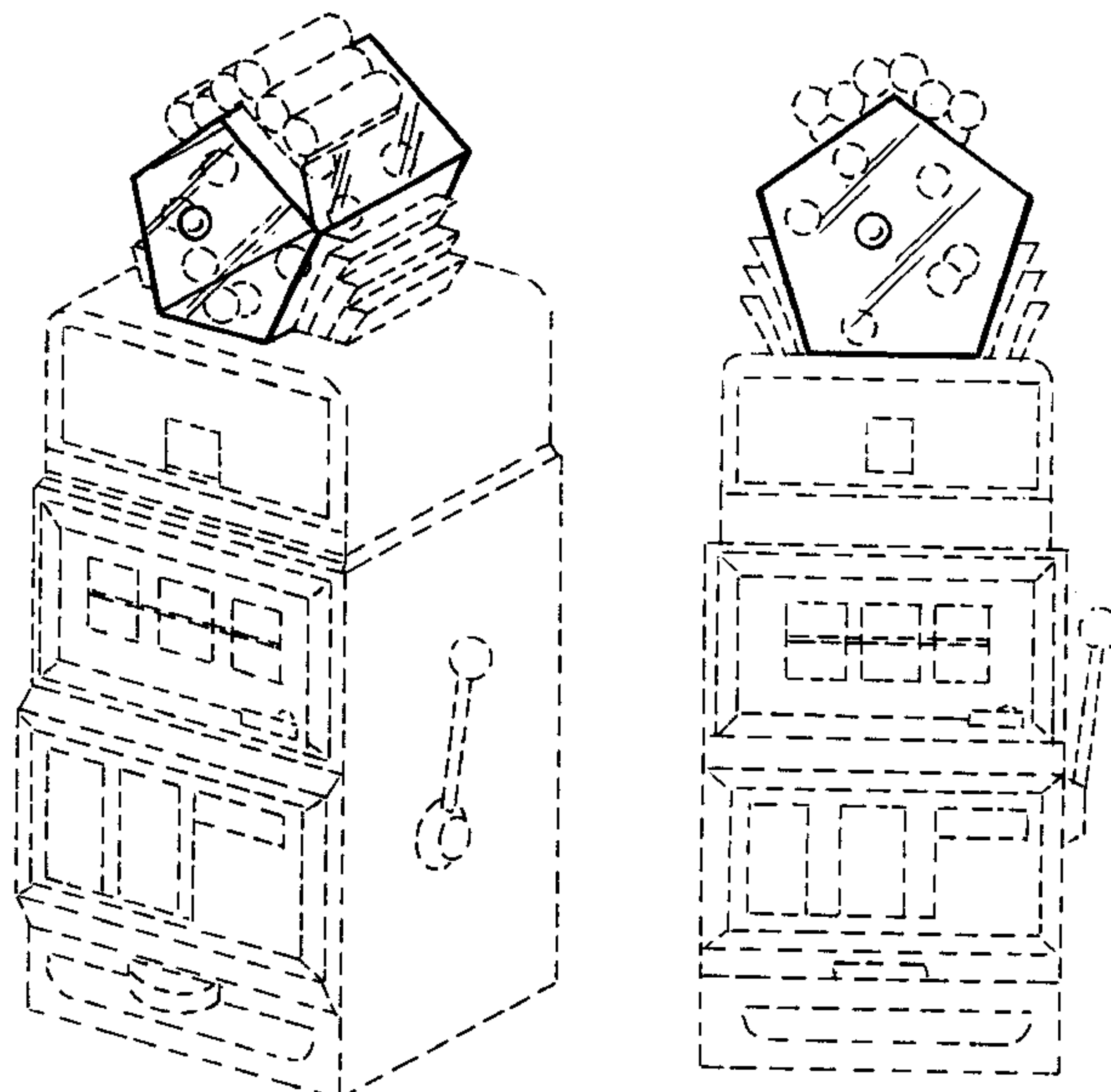

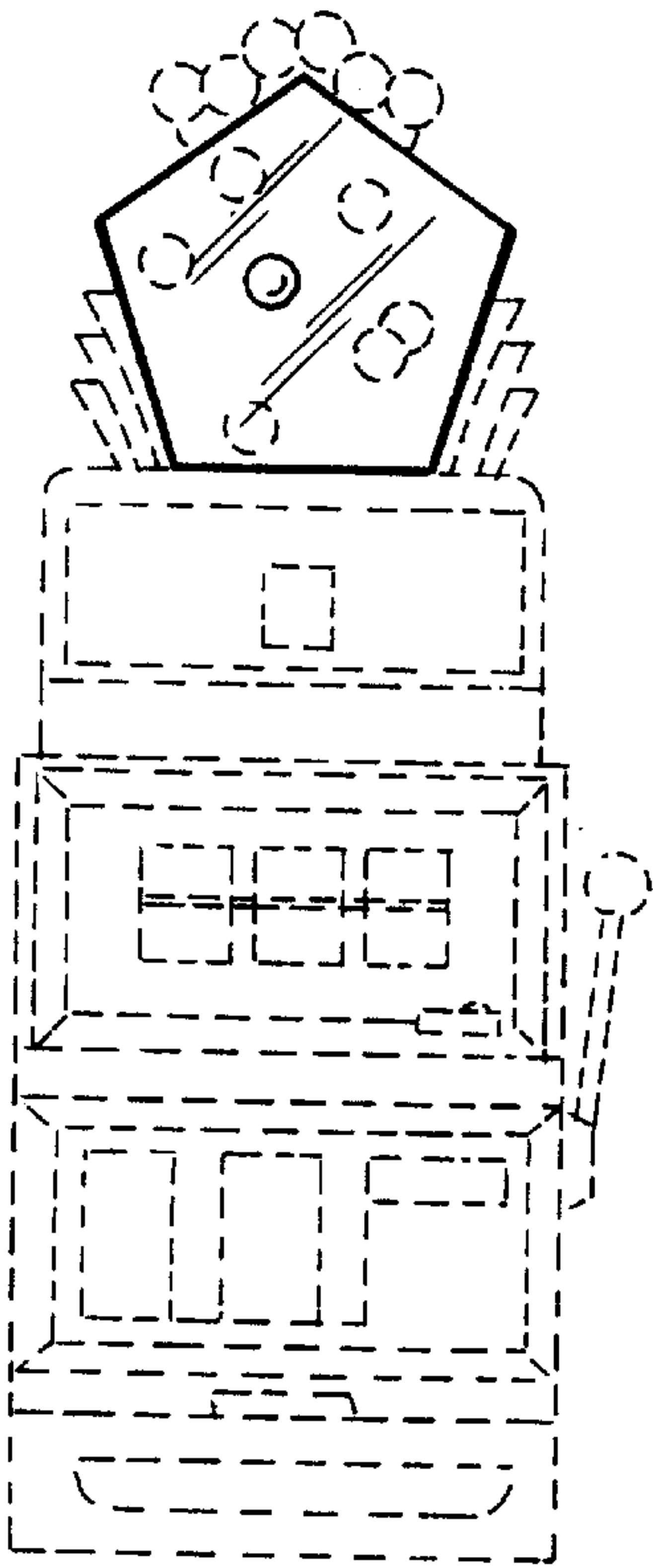
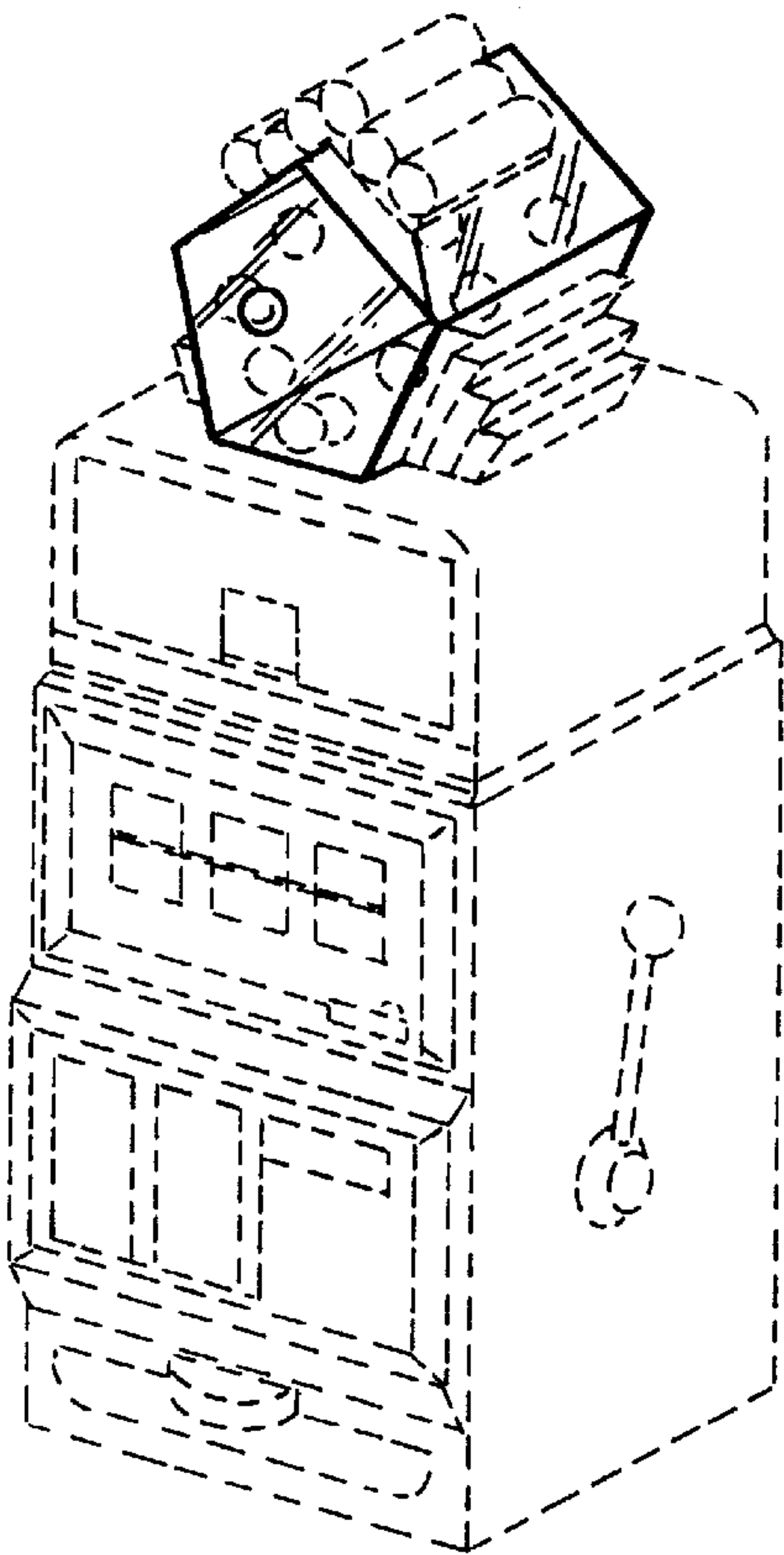

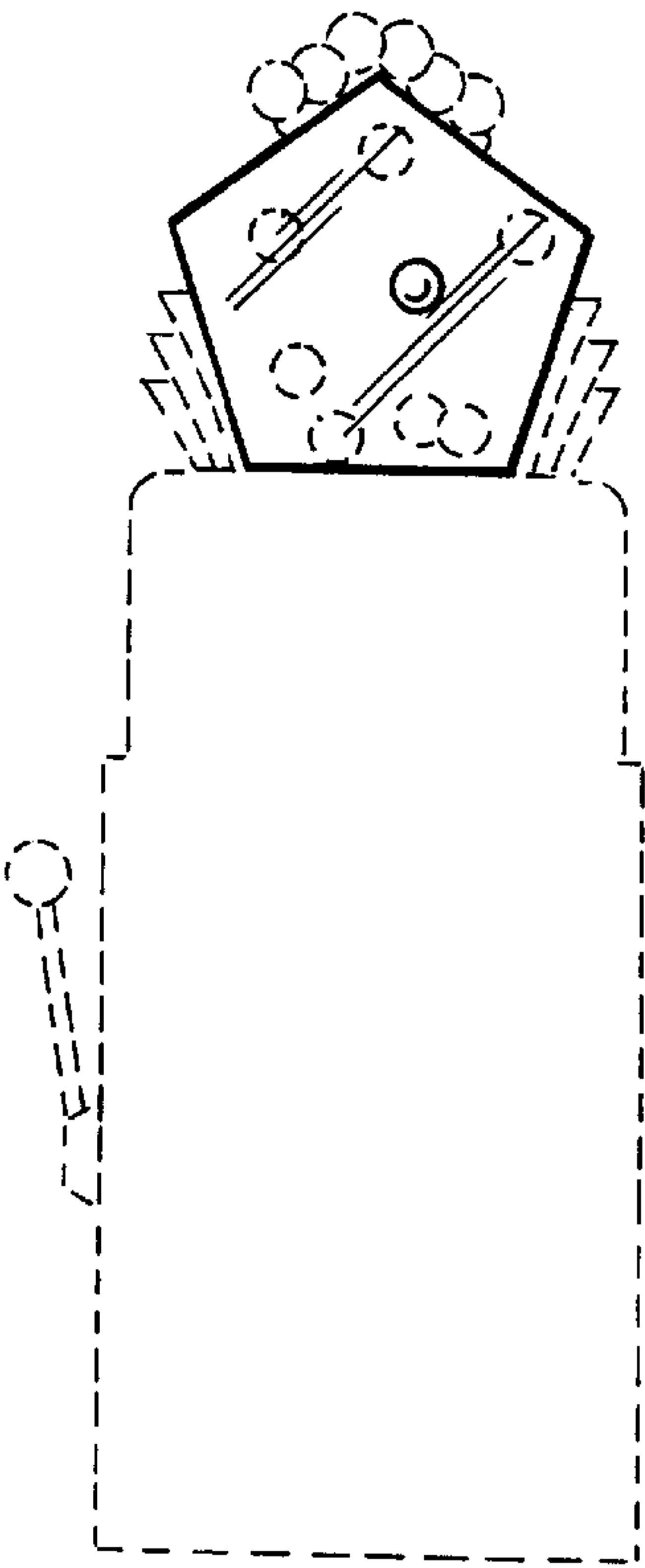

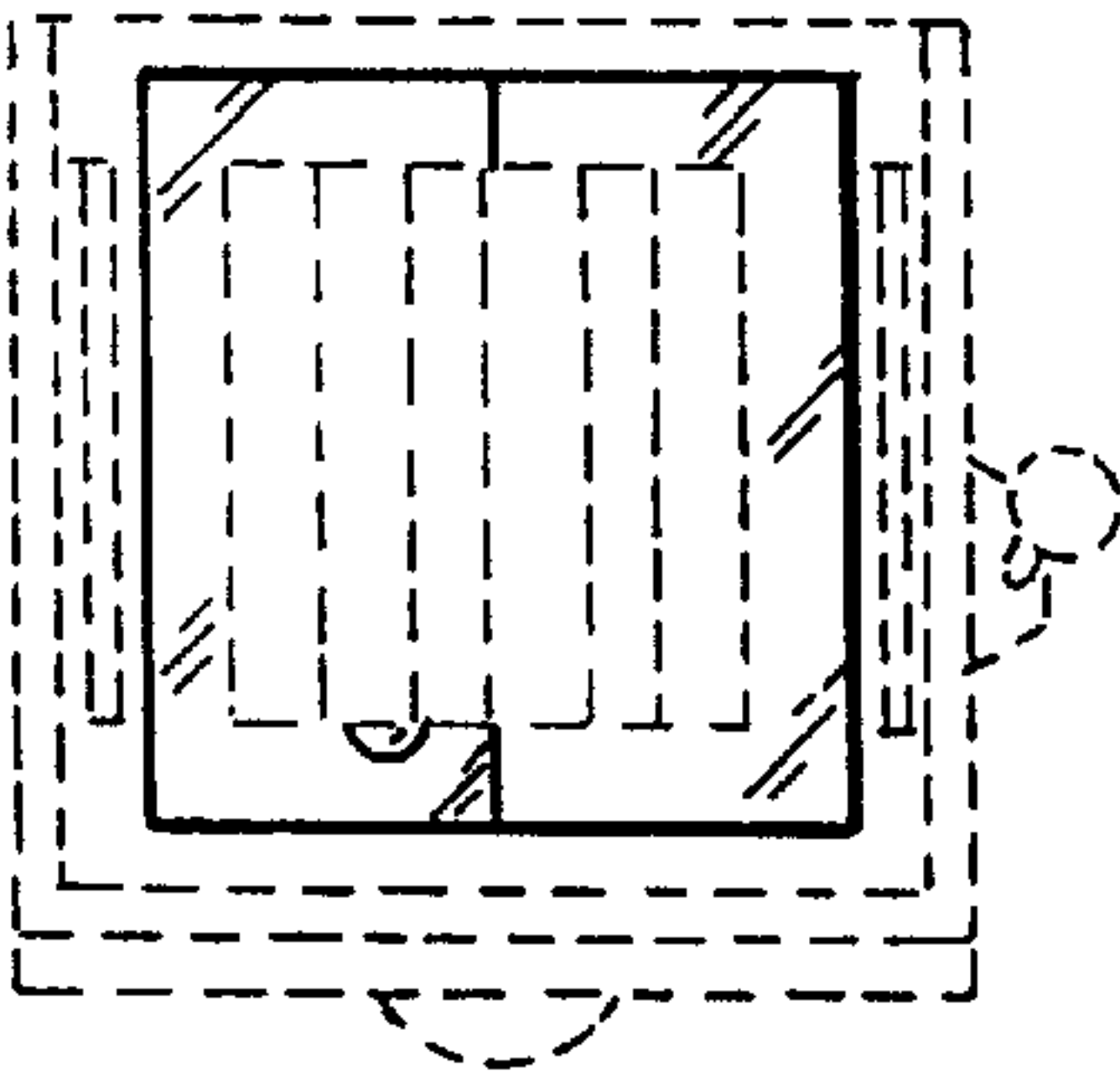

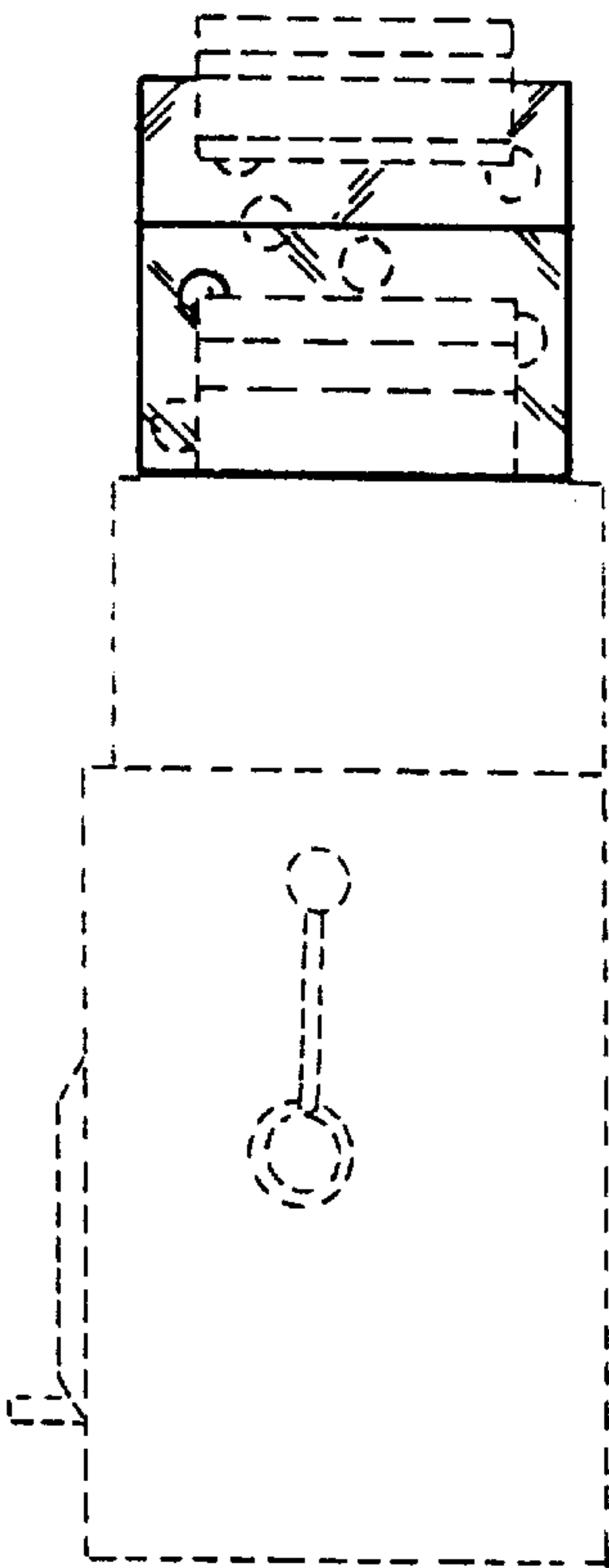

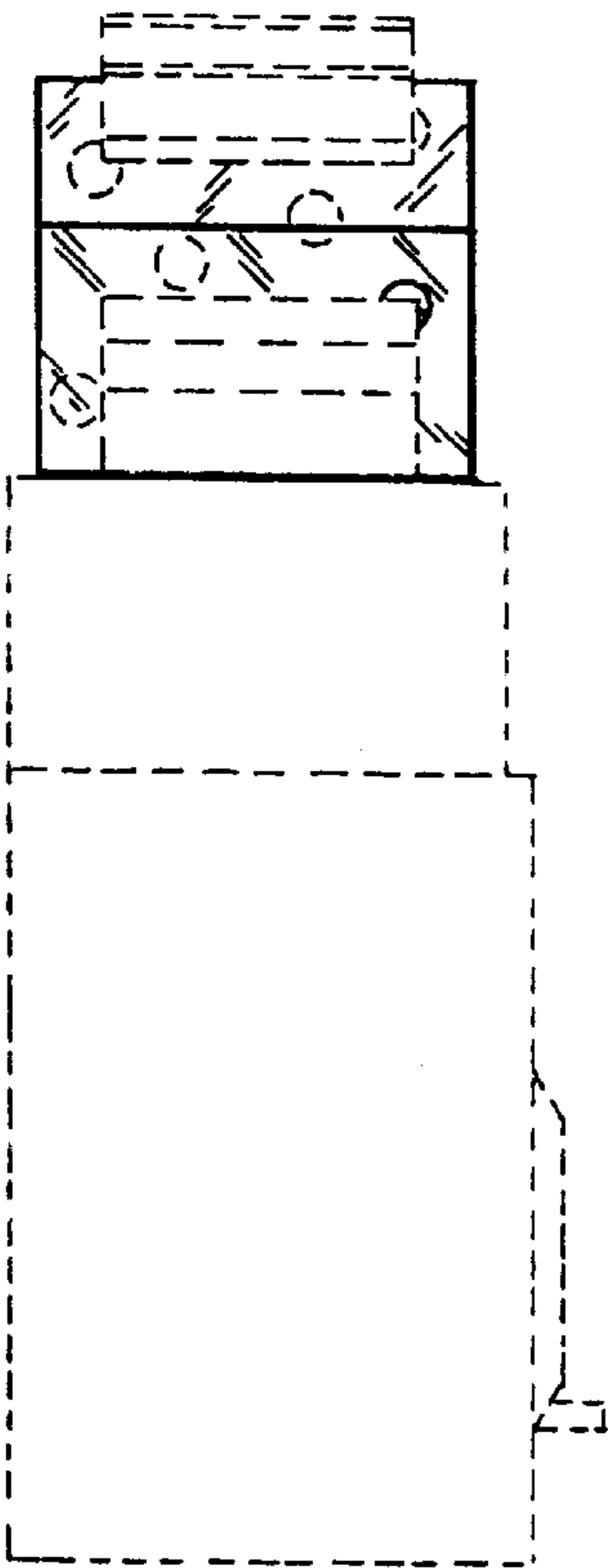
