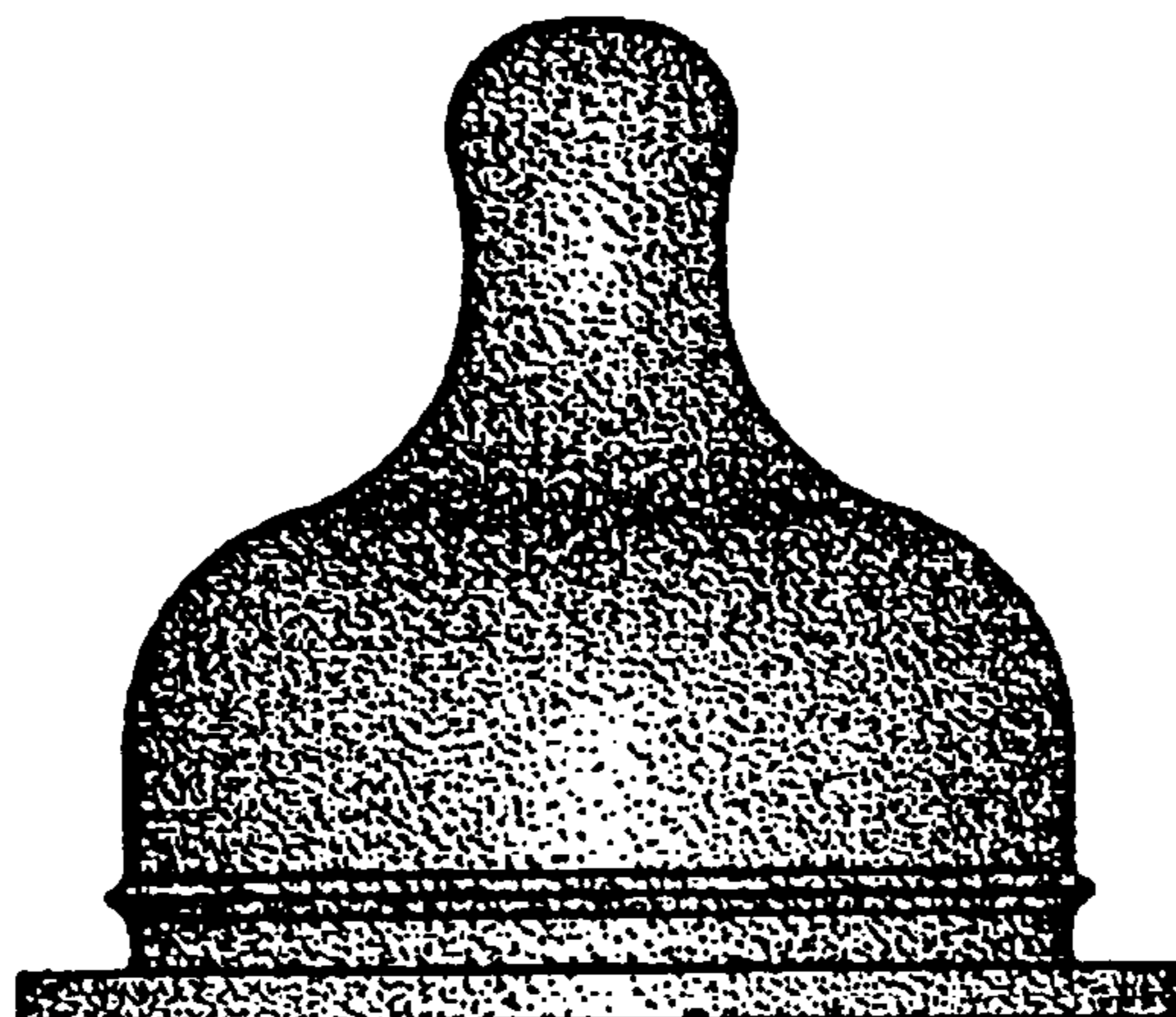
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a nipple showing my new design;
FIG. 2 is a side elevation view of the nipple of FIG. 1;
FIG. 3 is a top view of the nipple of FIG. 1;
FIG. 4 is bottom view of the nipple of FIG. 1; and,
FIG. 5 is a side elevation view along line 5—5 of FIG. 3.

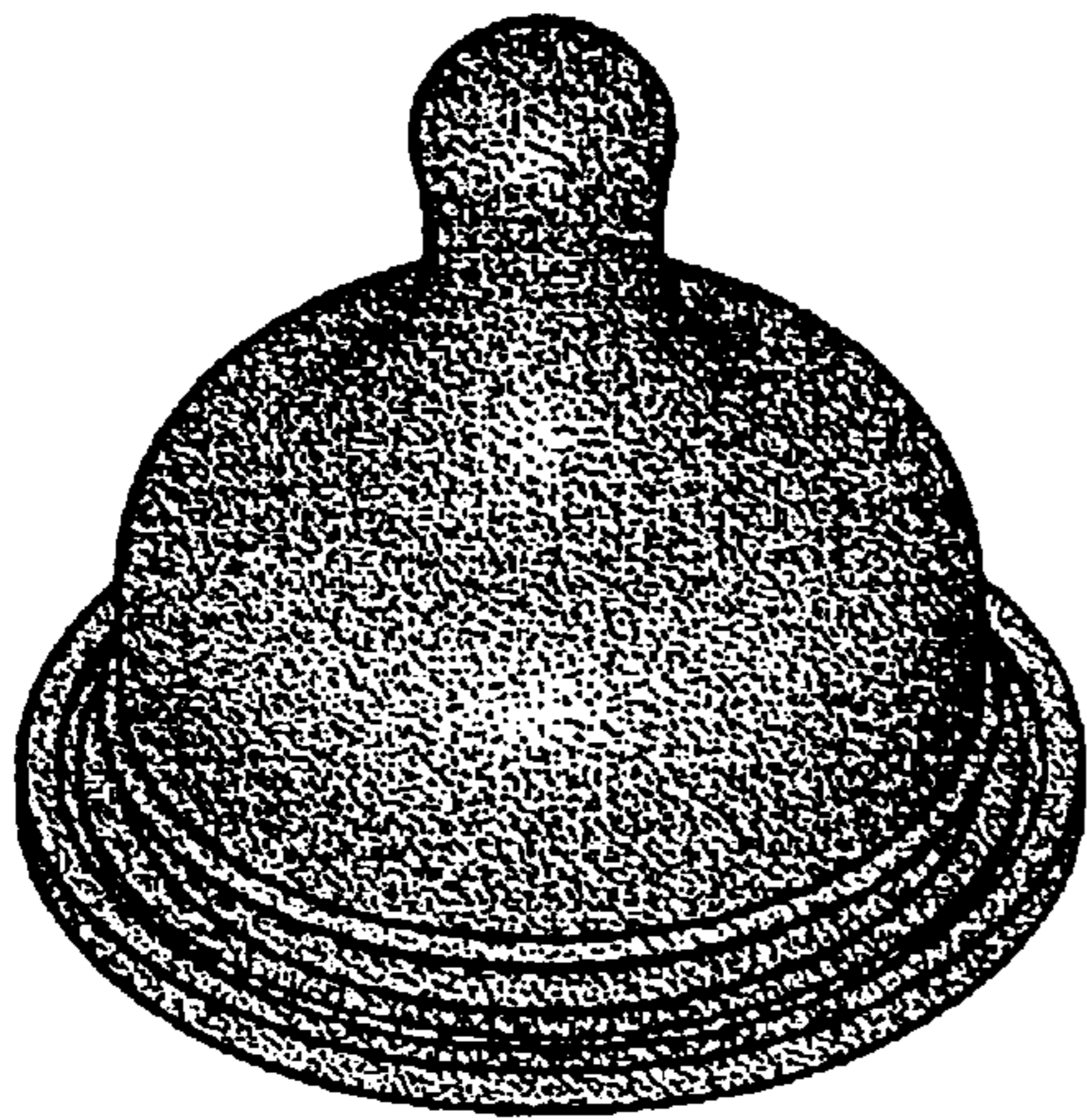

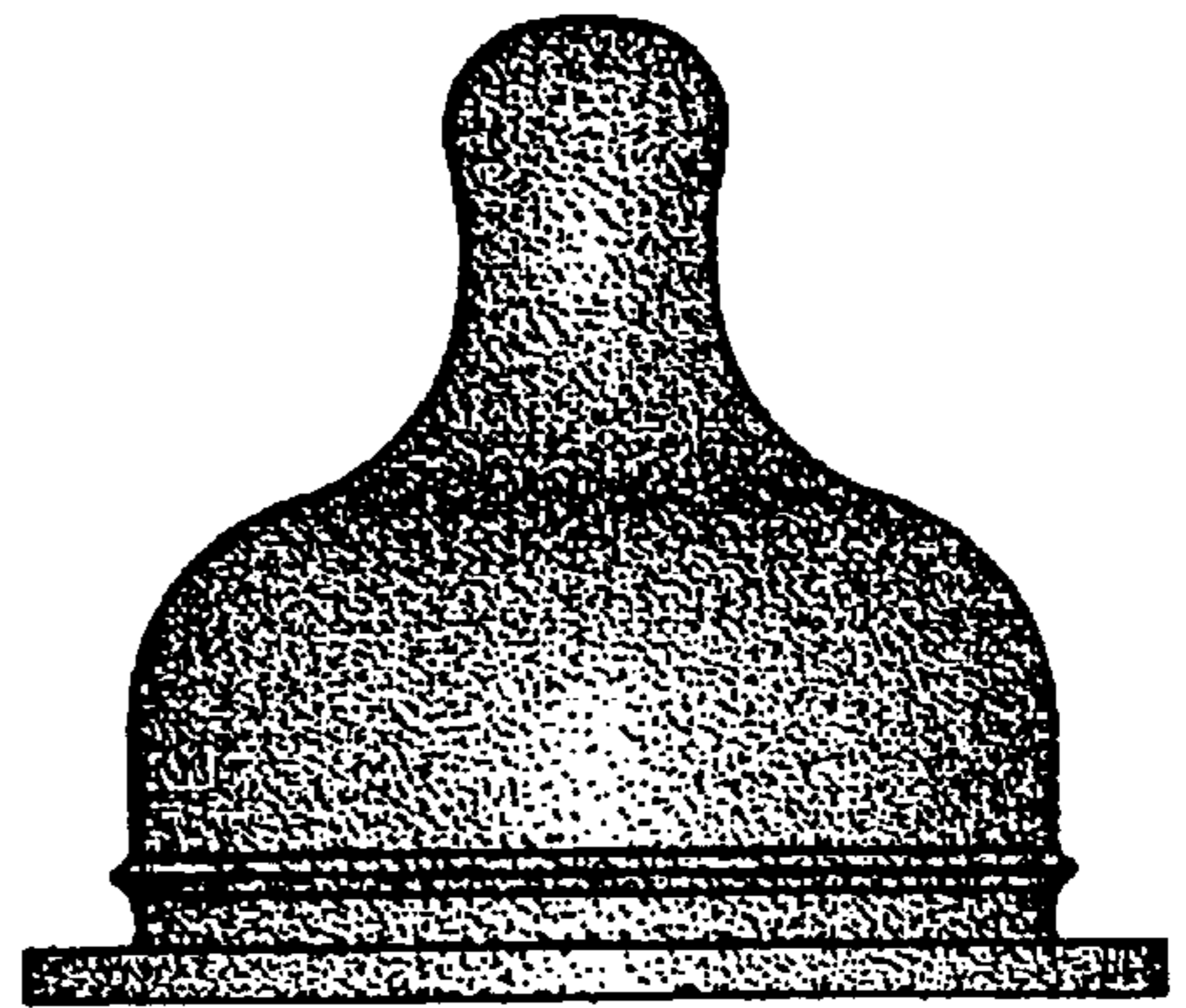

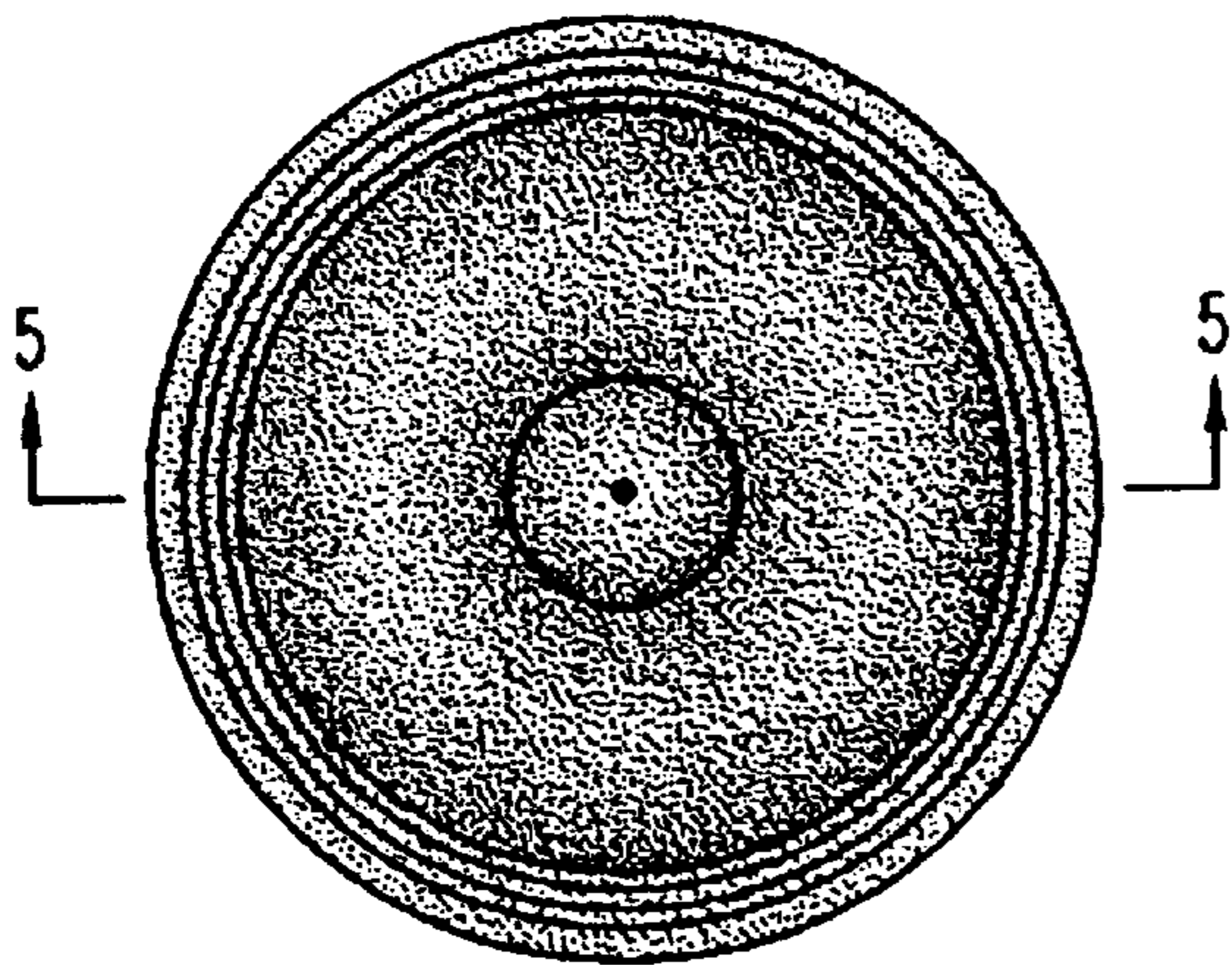

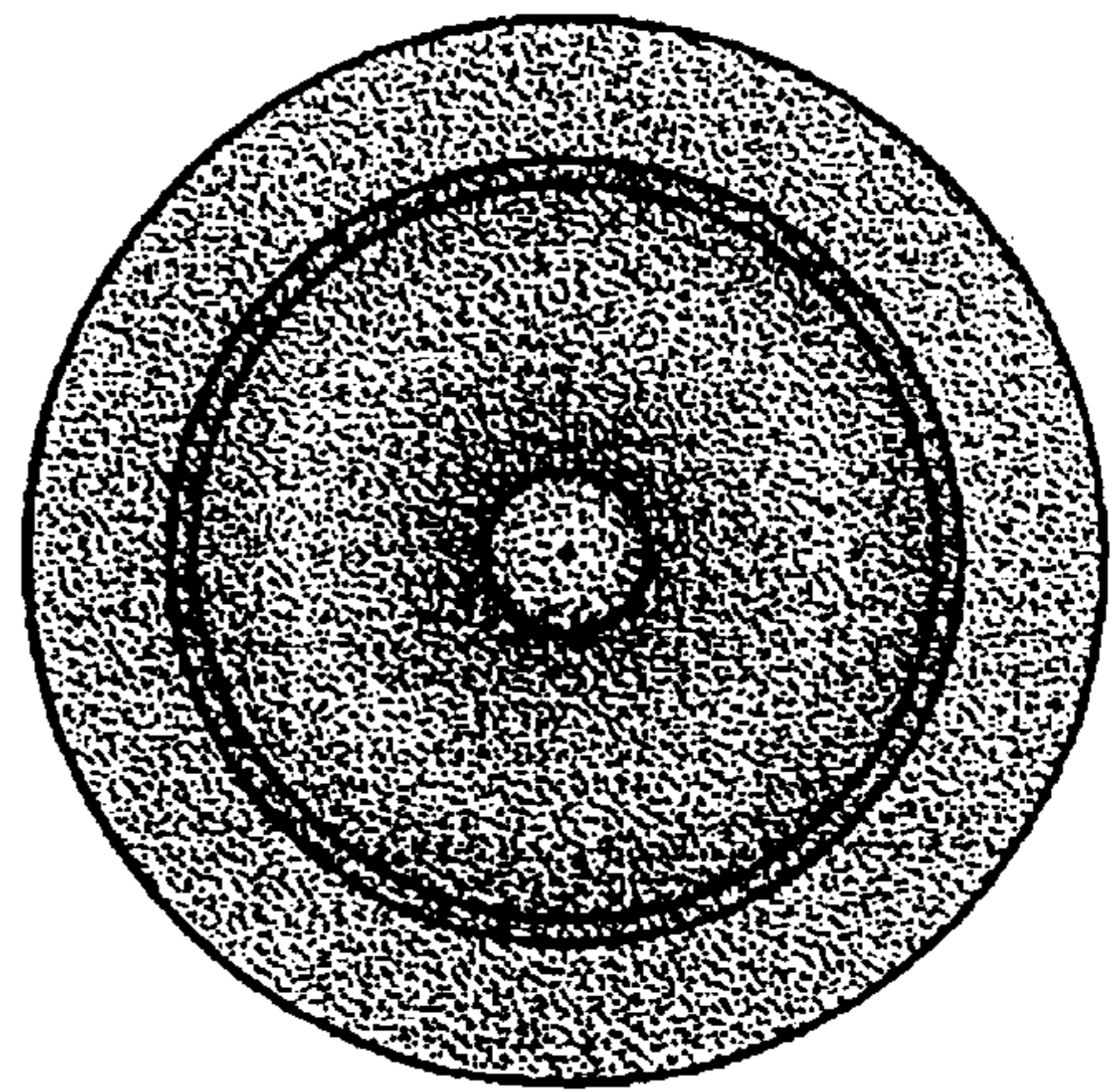

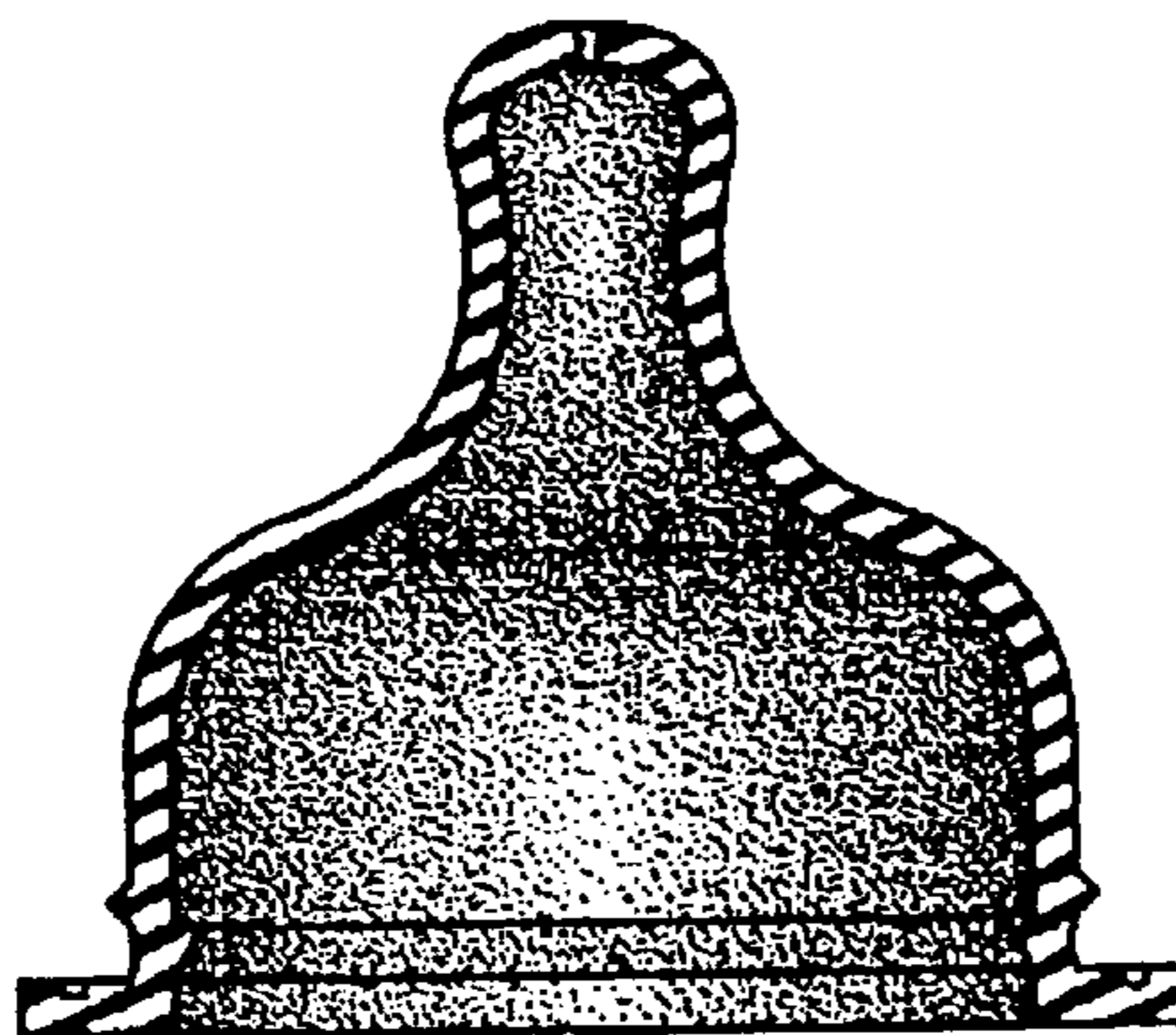
