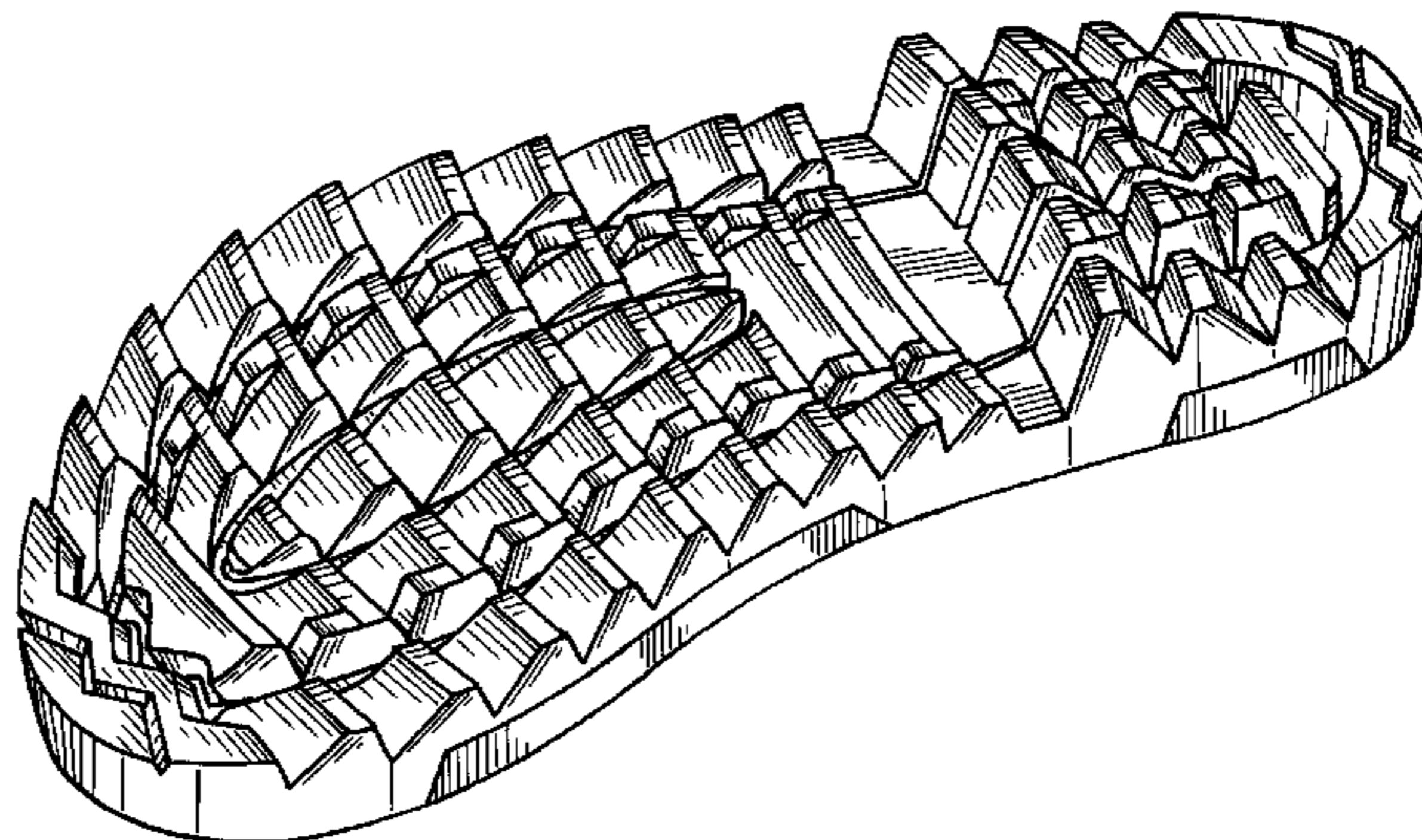
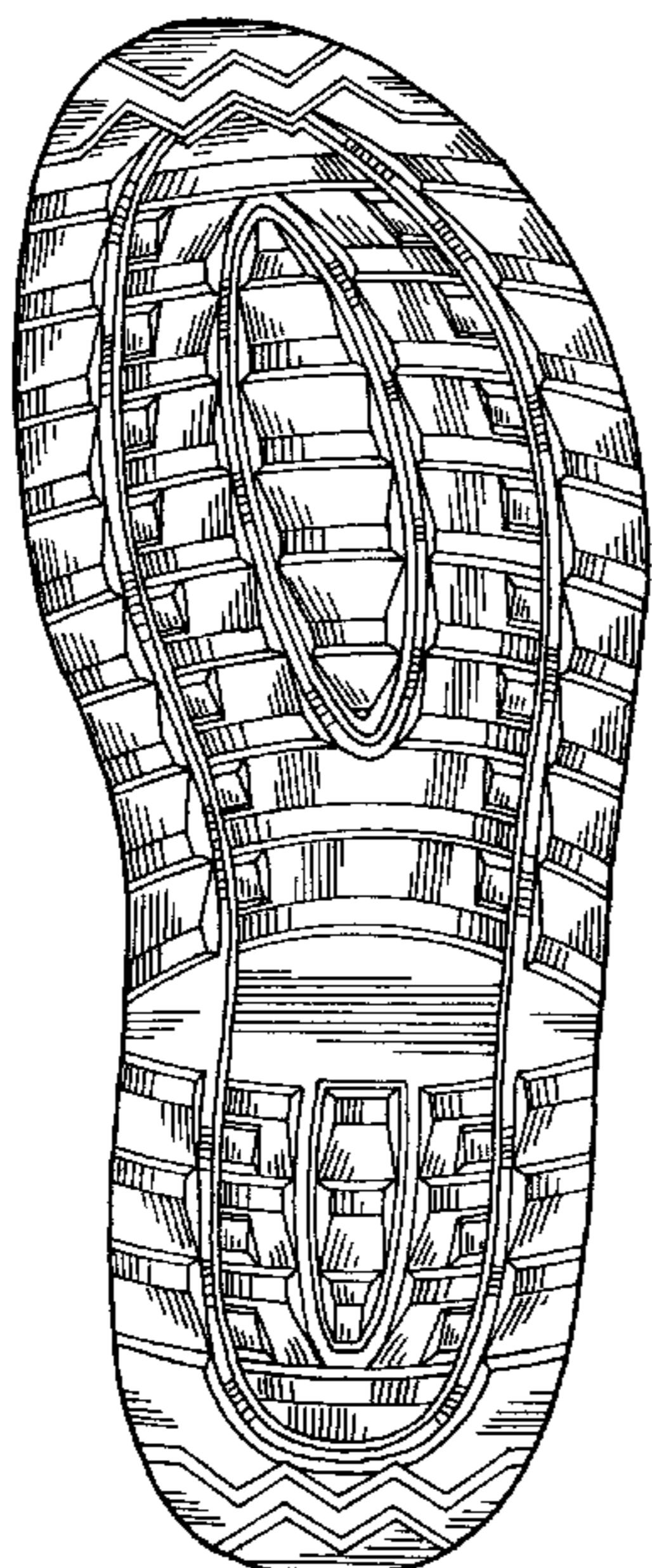
(57) **CLAIM**

The ornamental design for a shoe sole assembly with outsole and midsole, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a left shoe sole assembly with outsole and midsole, showing our new design;
 FIG. 2 is a front elevational view;
 FIG. 3 is a rear elevational view;
 FIG. 4 is a side elevational view when viewed from the right side of FIG. 6;
 FIG. 5 is a side elevational view when viewed from the left side of FIG. 6;
 FIG. 6 is a top plan view;
 FIG. 7 is a bottom plan view;
 FIG. 8 is a bottom perspective view of the first embodiment of the left shoe sole assembly with outsole and midsole, showing our new design;

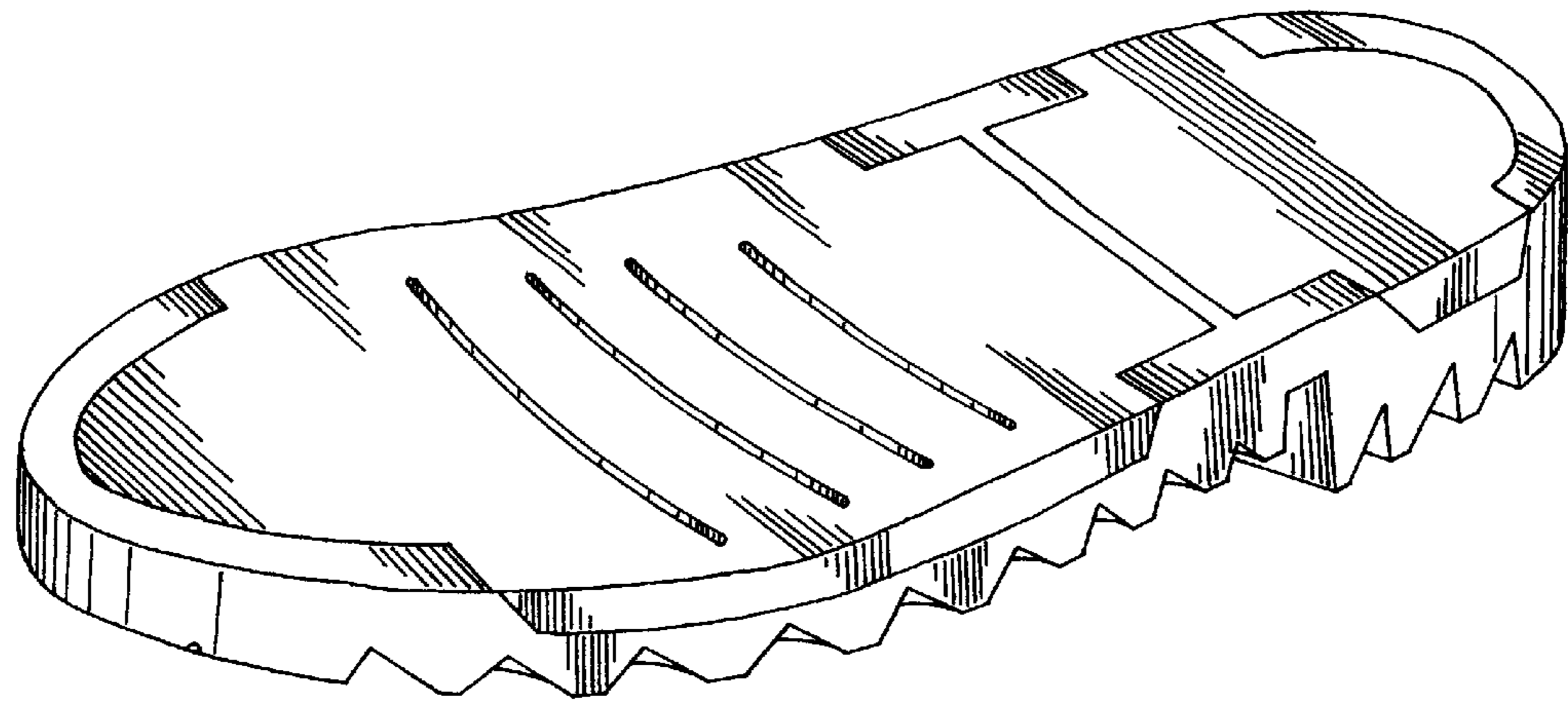

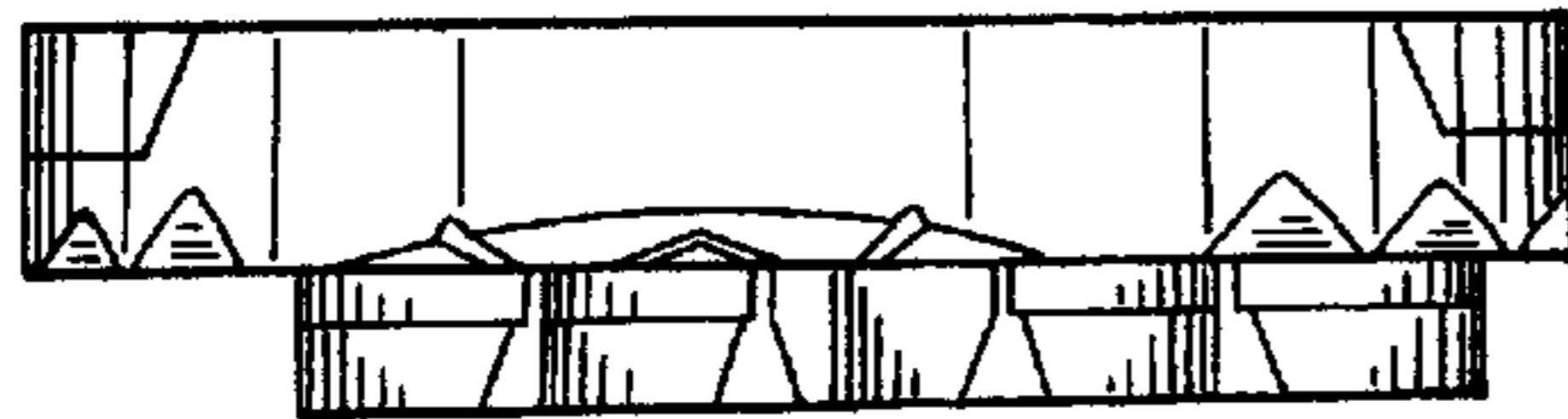

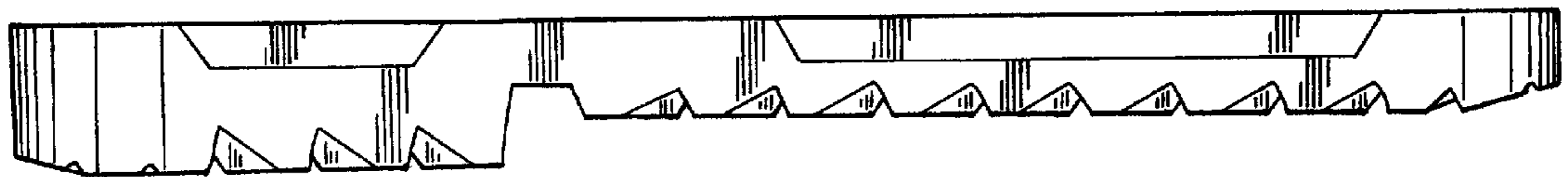

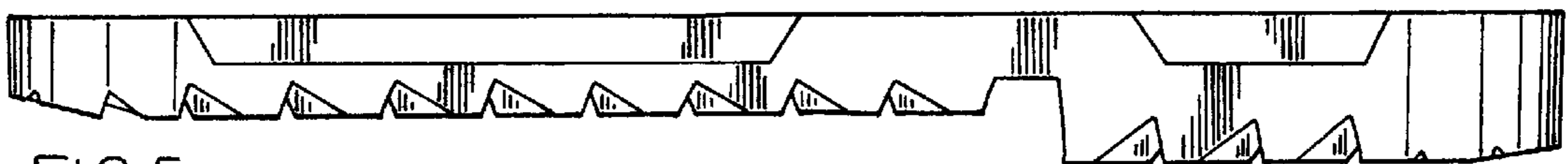

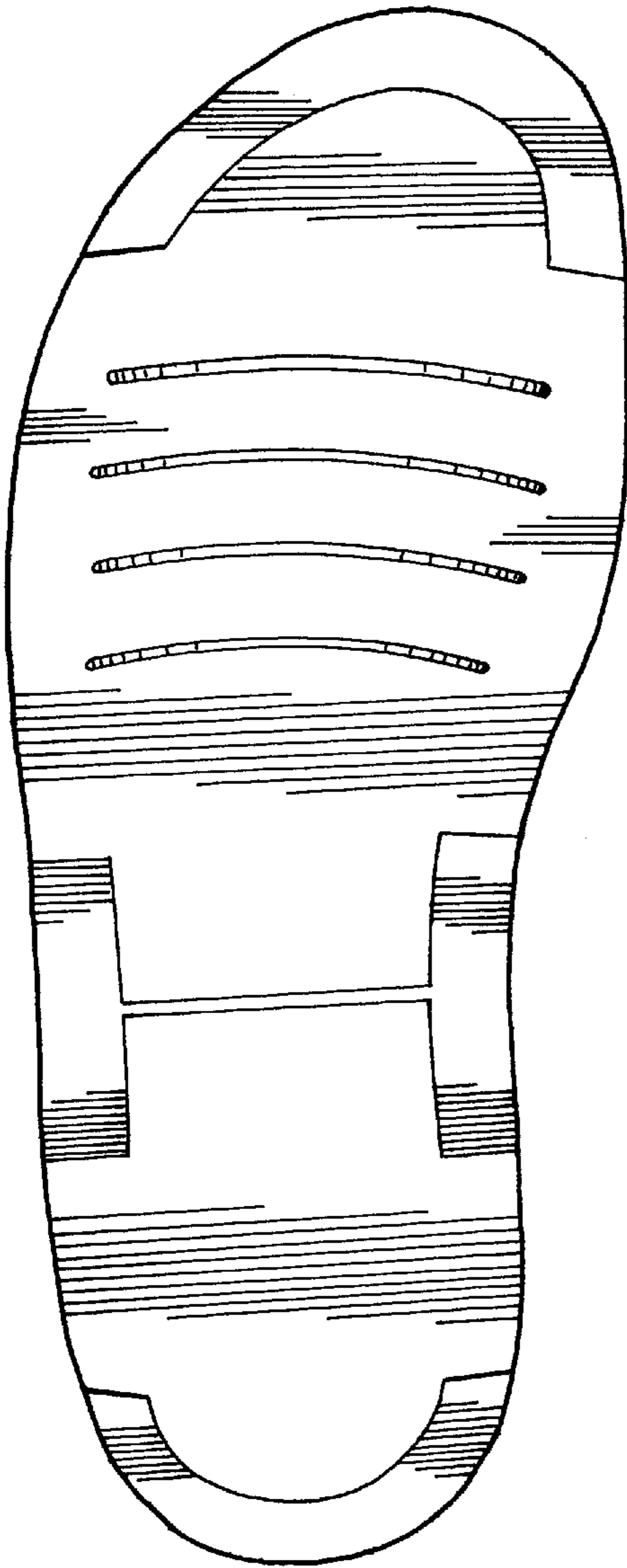

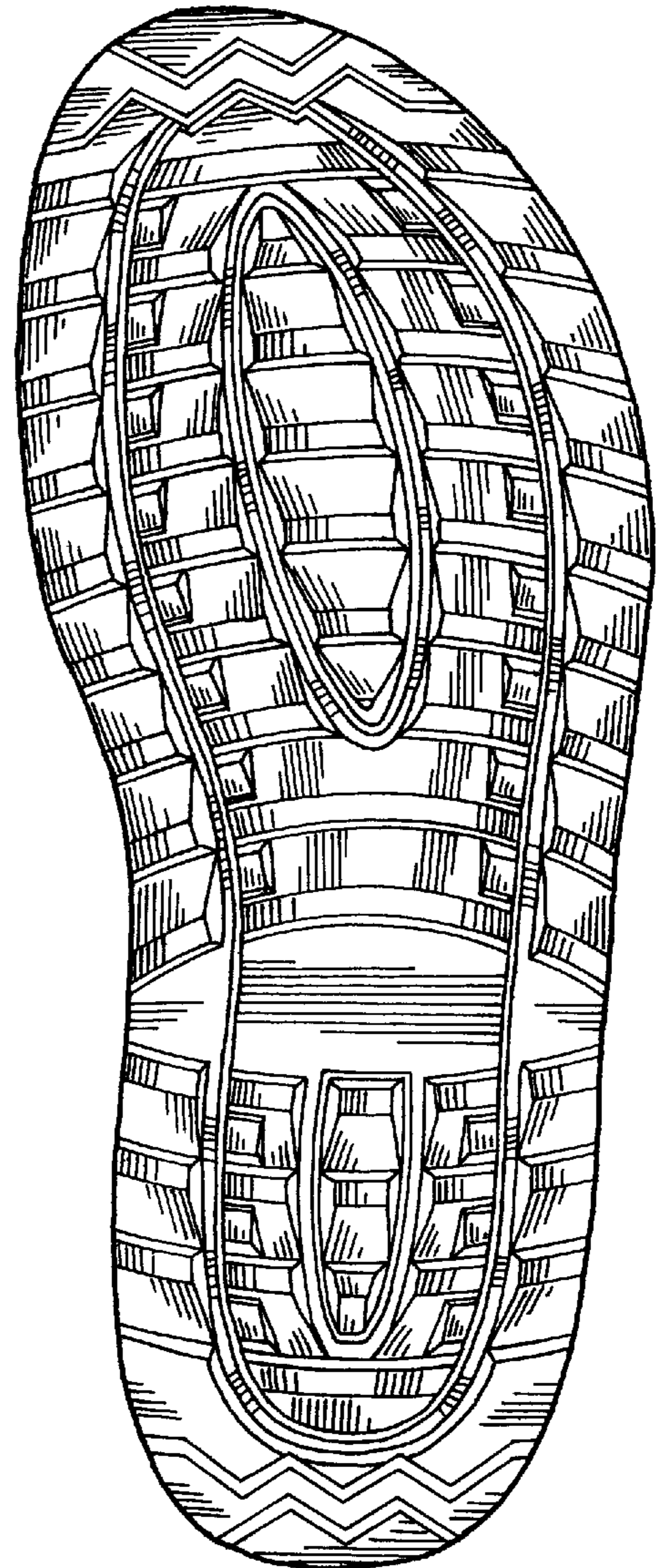

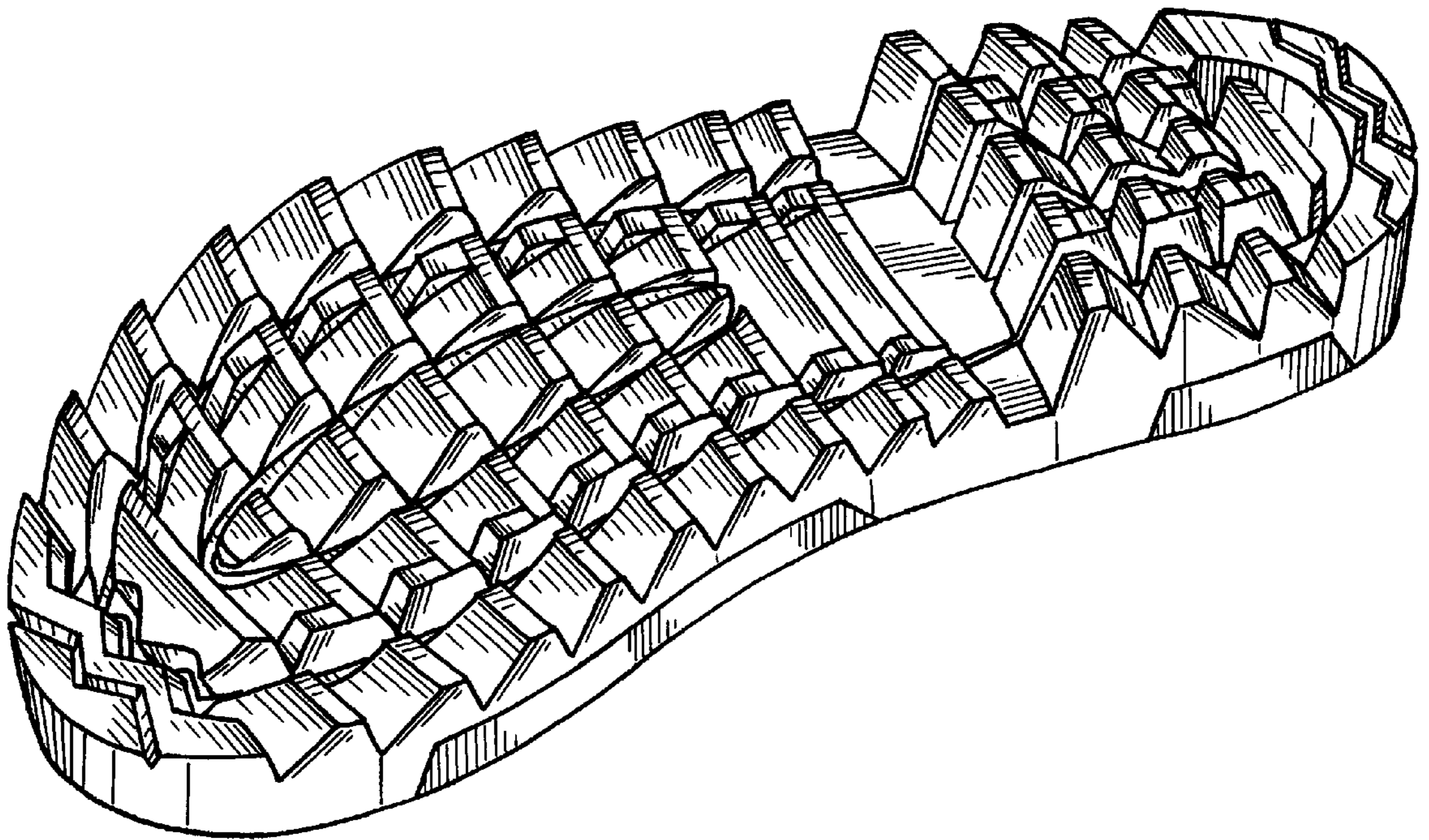

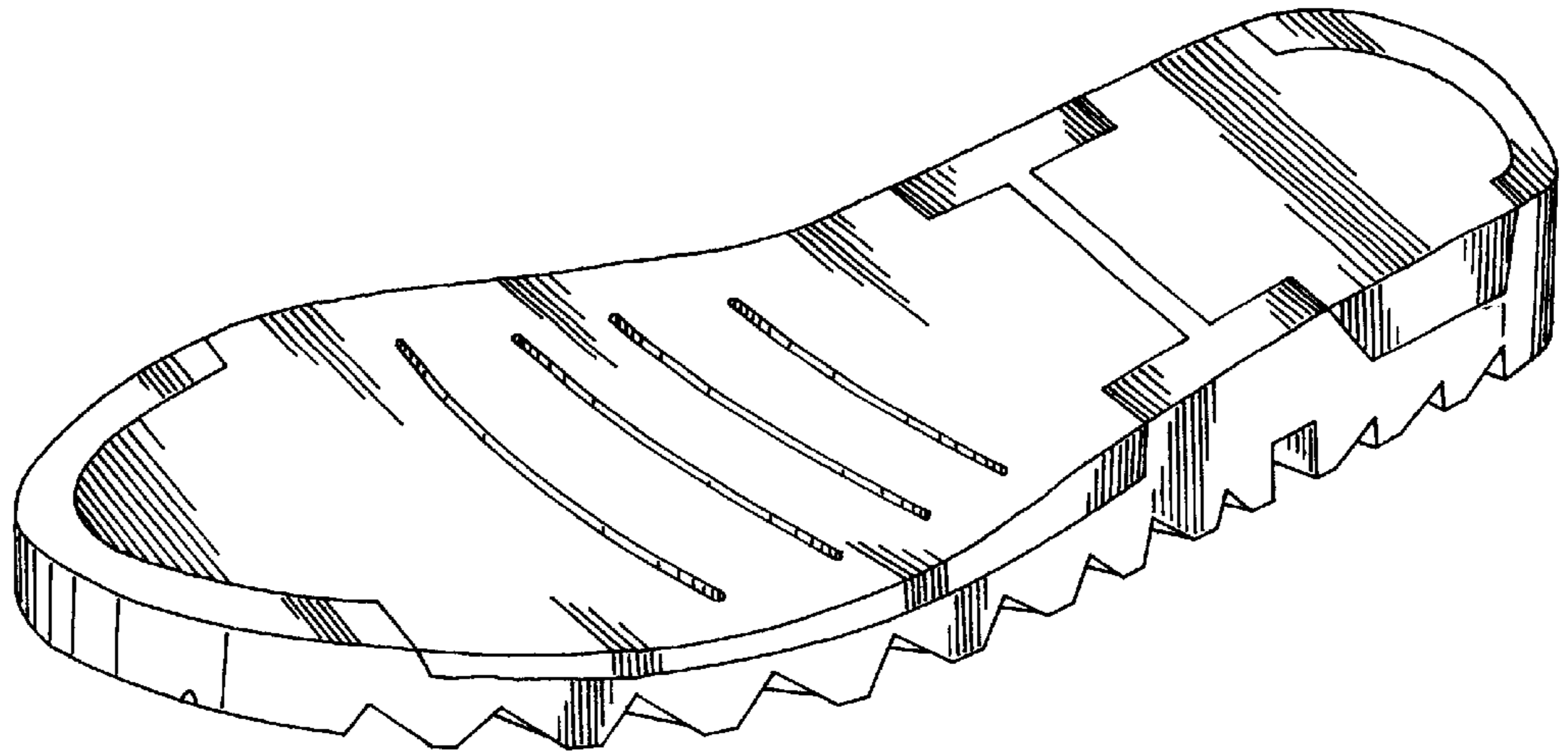

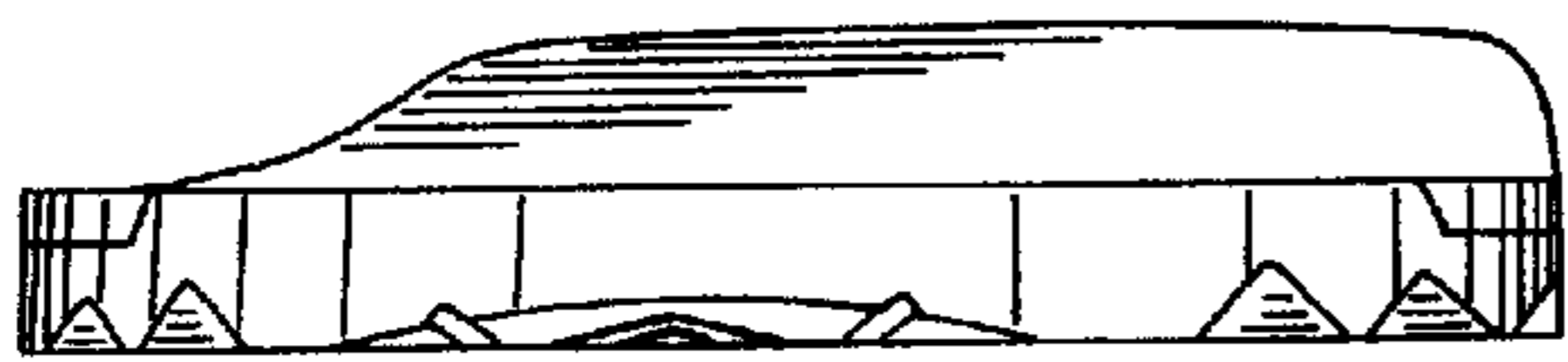

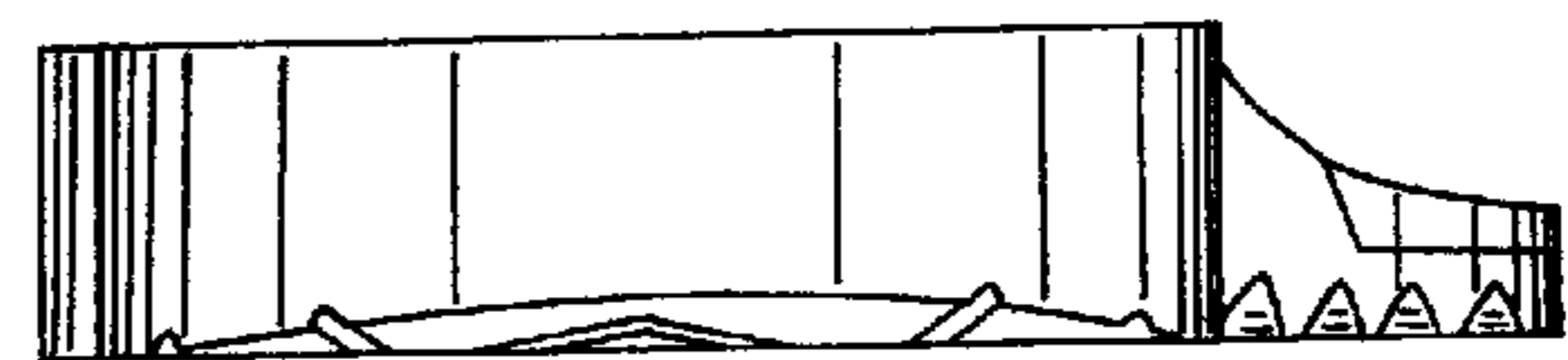

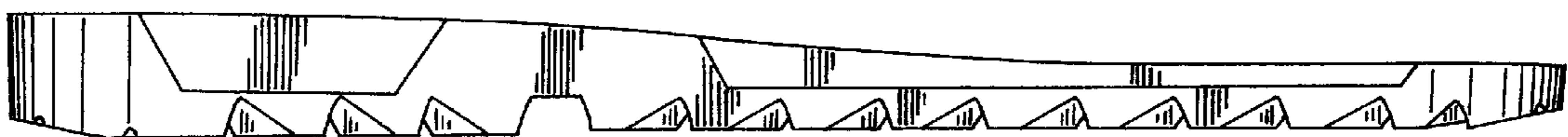

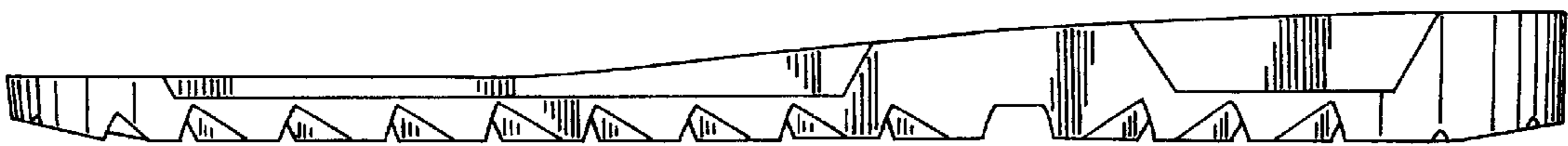

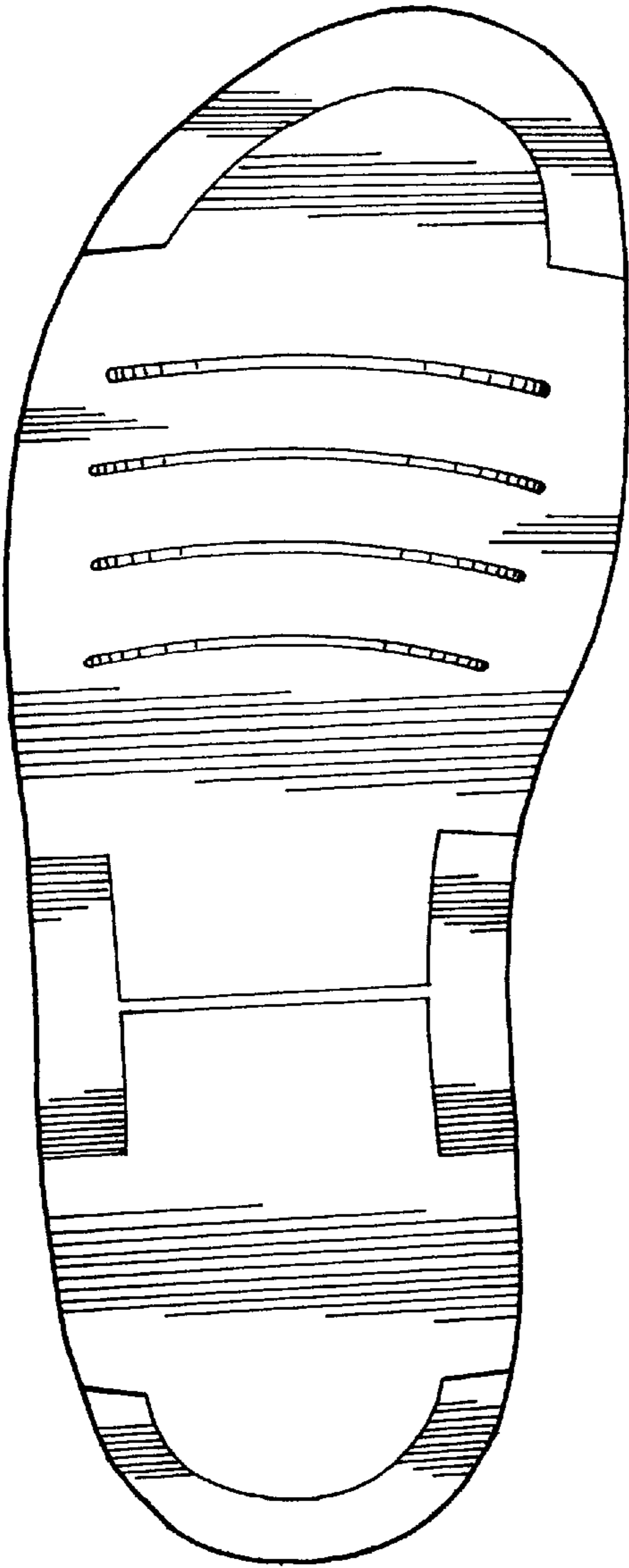

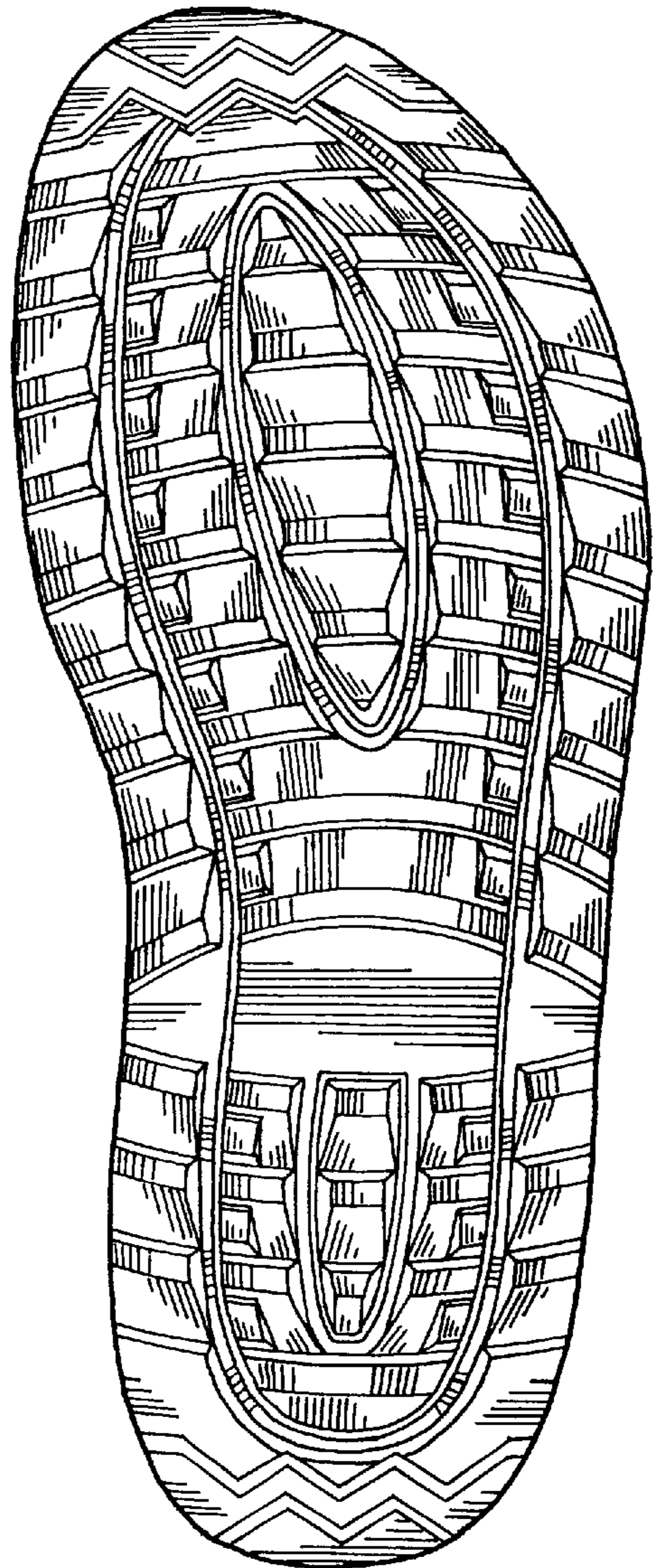

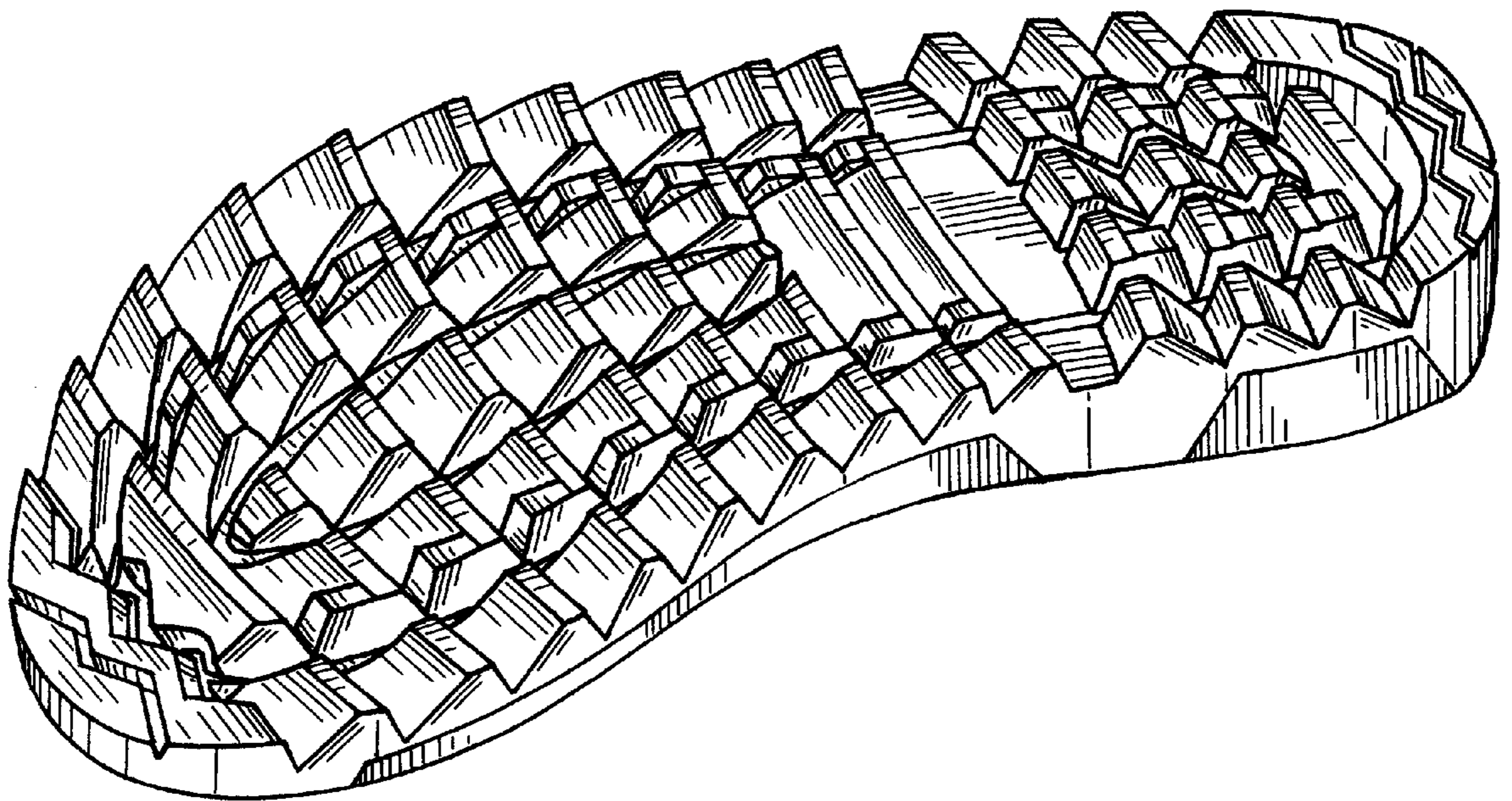
