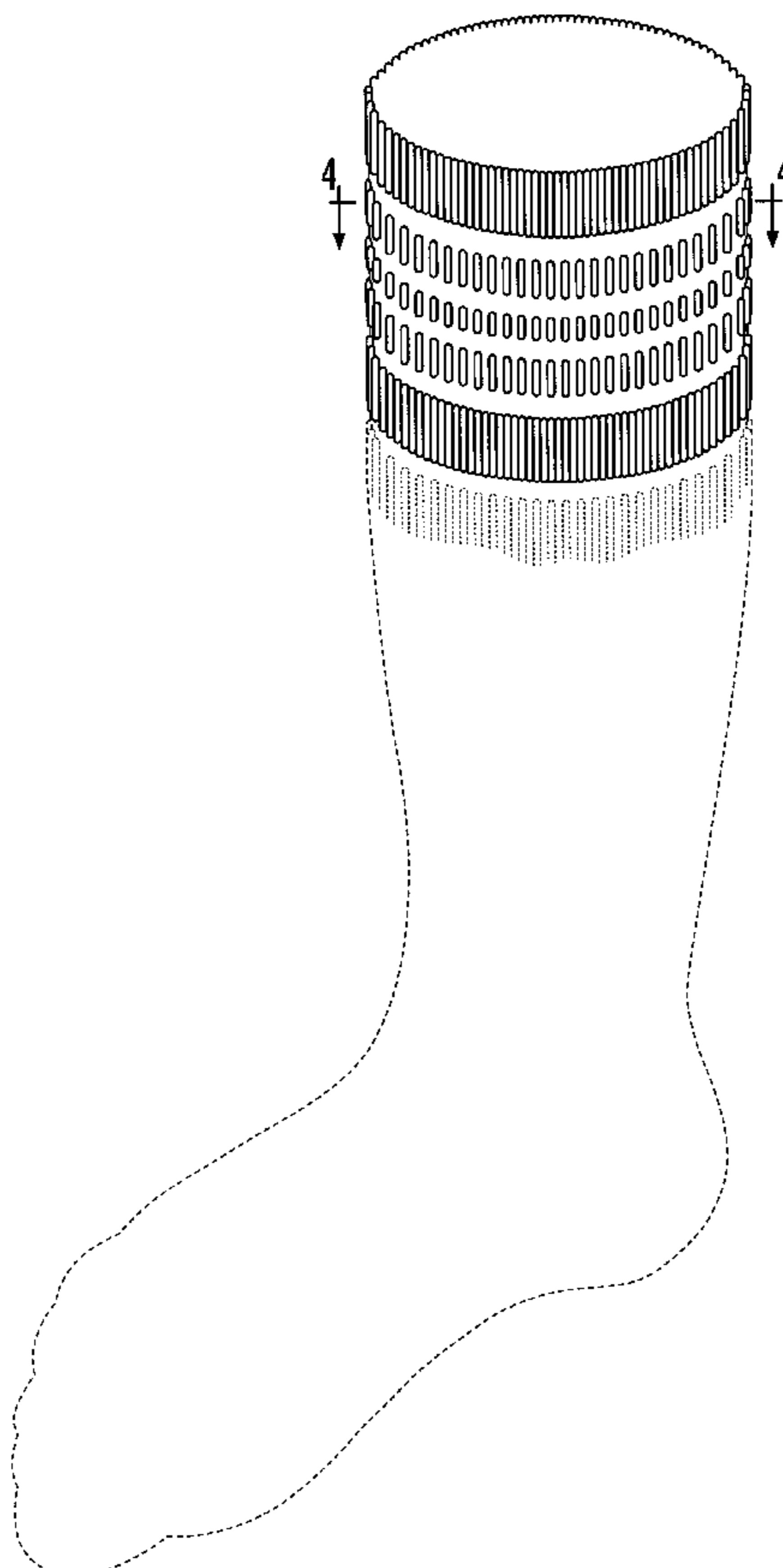
(57) **CLAIM**

The ornamental design for a top band for an article of hosiery, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an article of hosiery showing an embodiment of our invention;  
 FIG. 2 is a side plan view thereof, the opposite side being a mirror image thereof;  
 FIG. 3 is a rear perspective view thereof; and,  
 FIG. 4 is a sectional view taken along line 4—4 of FIG. 1.  
 The broken lines shown herein are for illustrative purposes only and form no part of the claimed design.

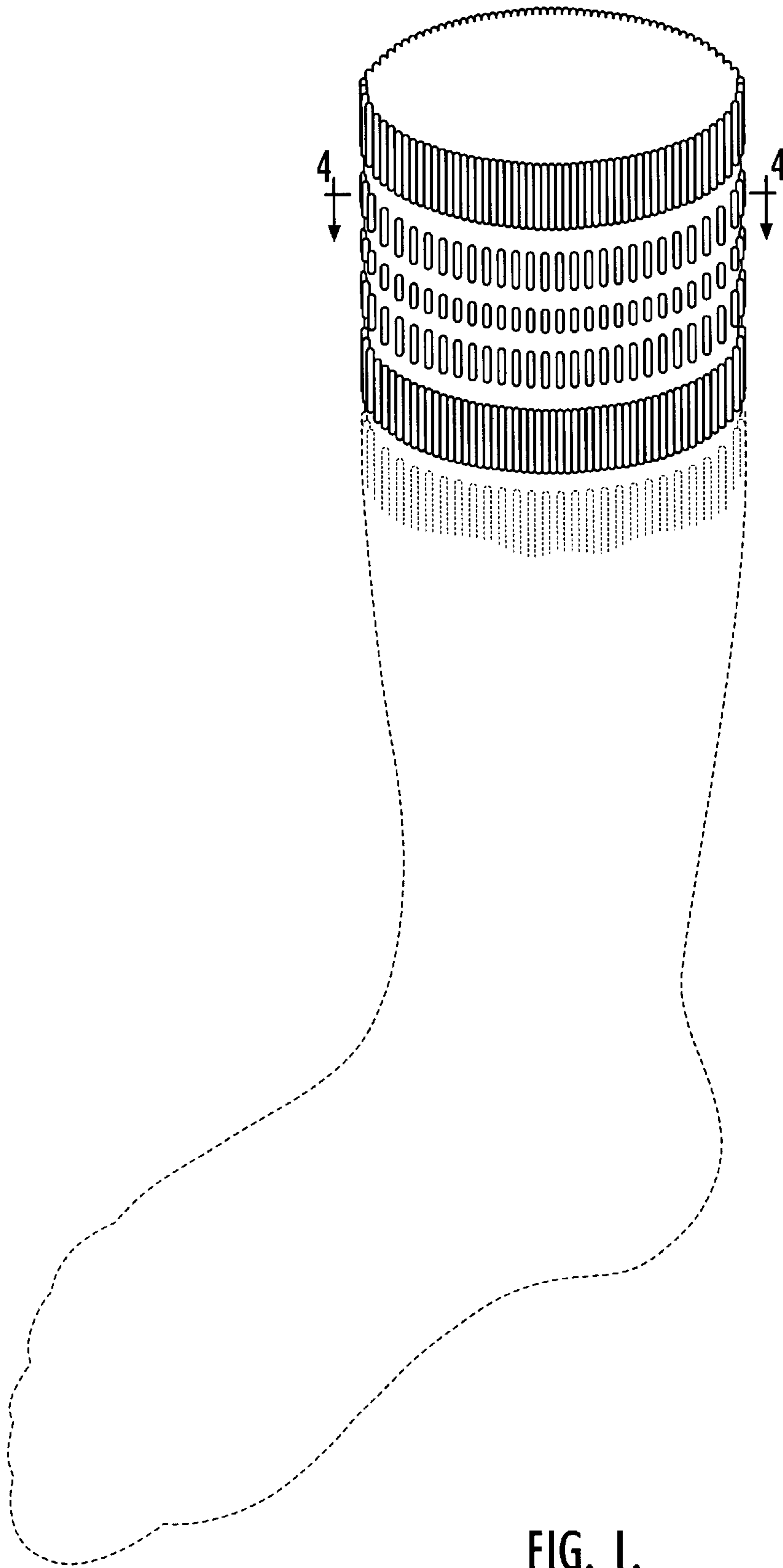

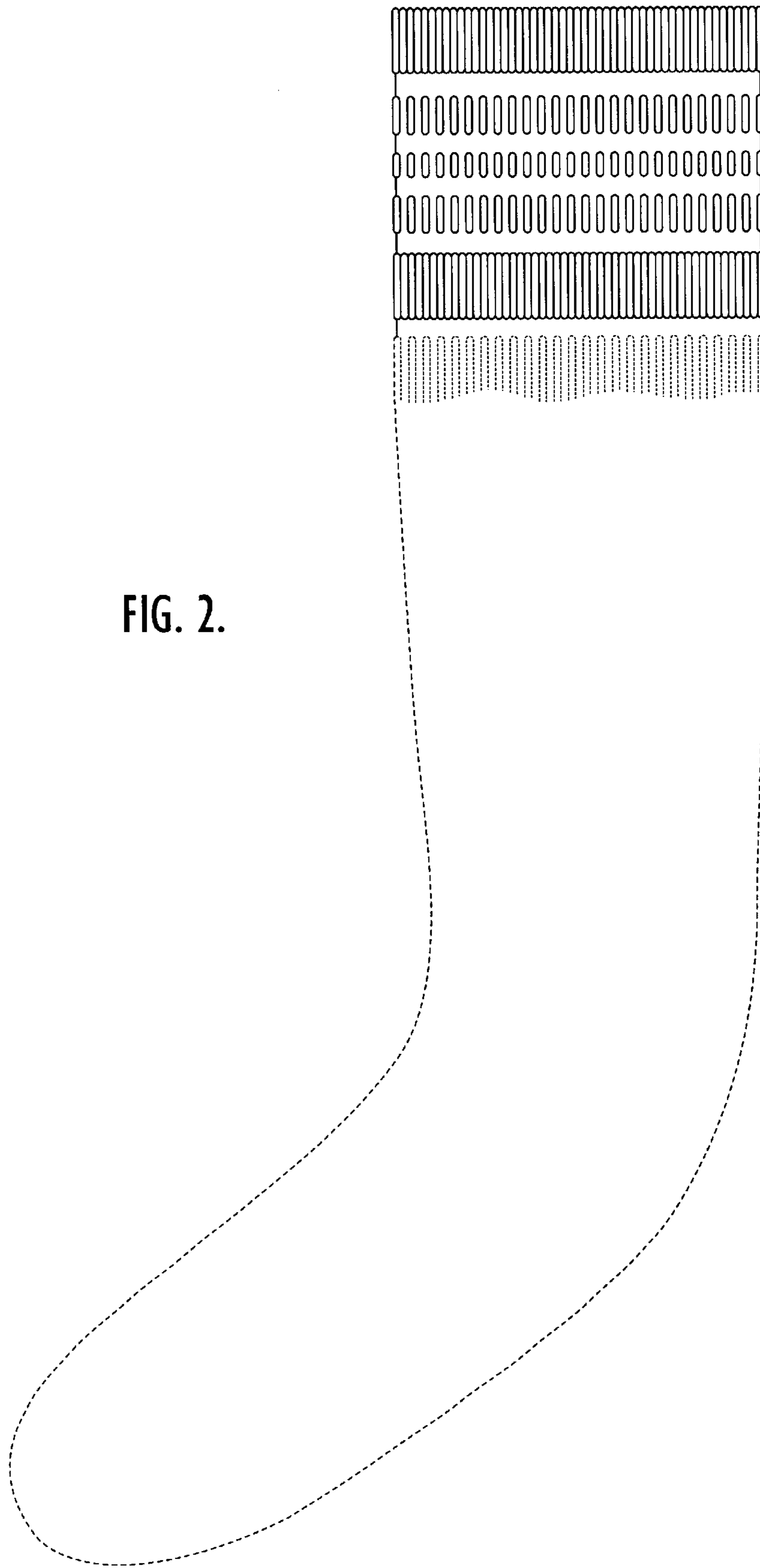

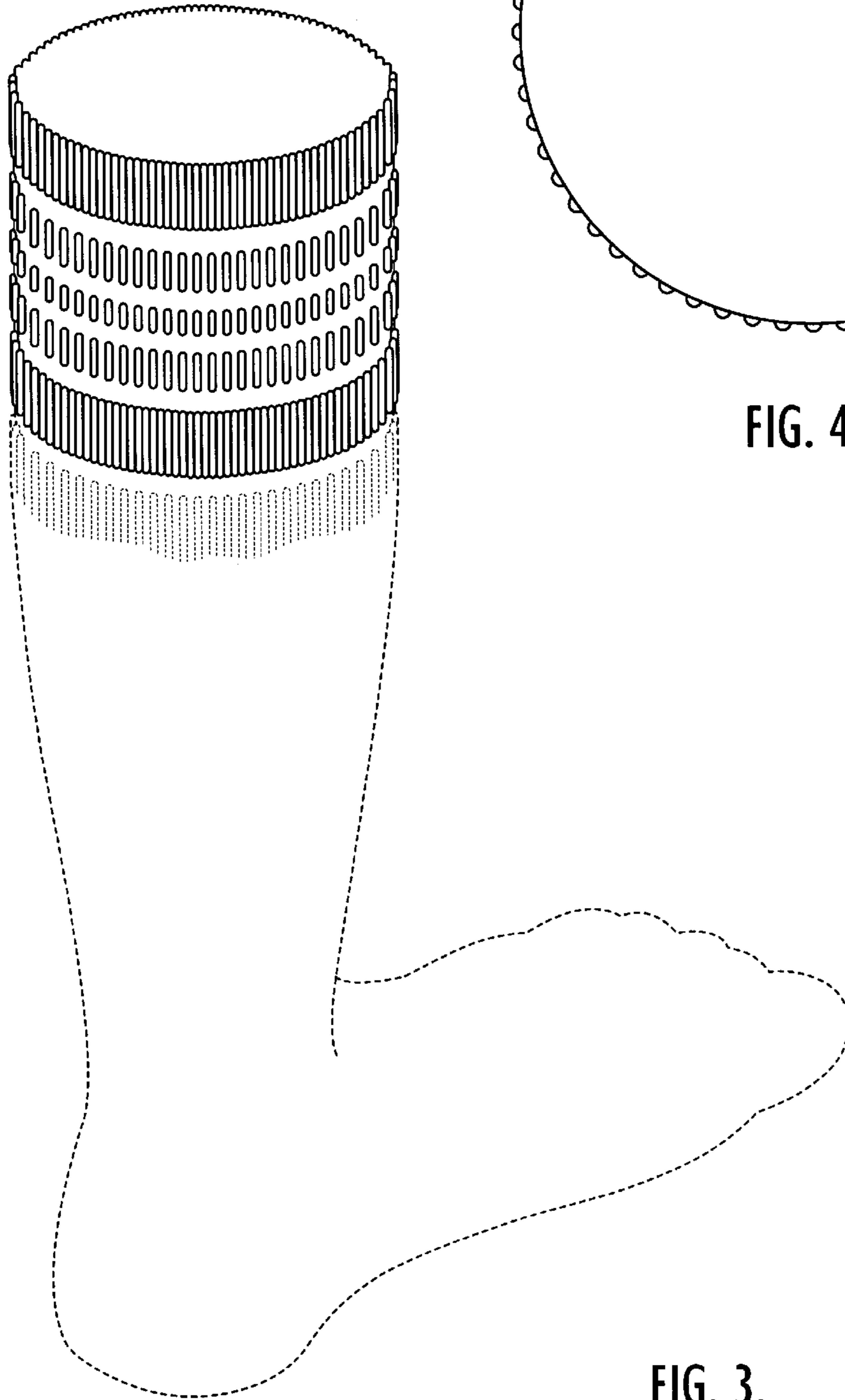

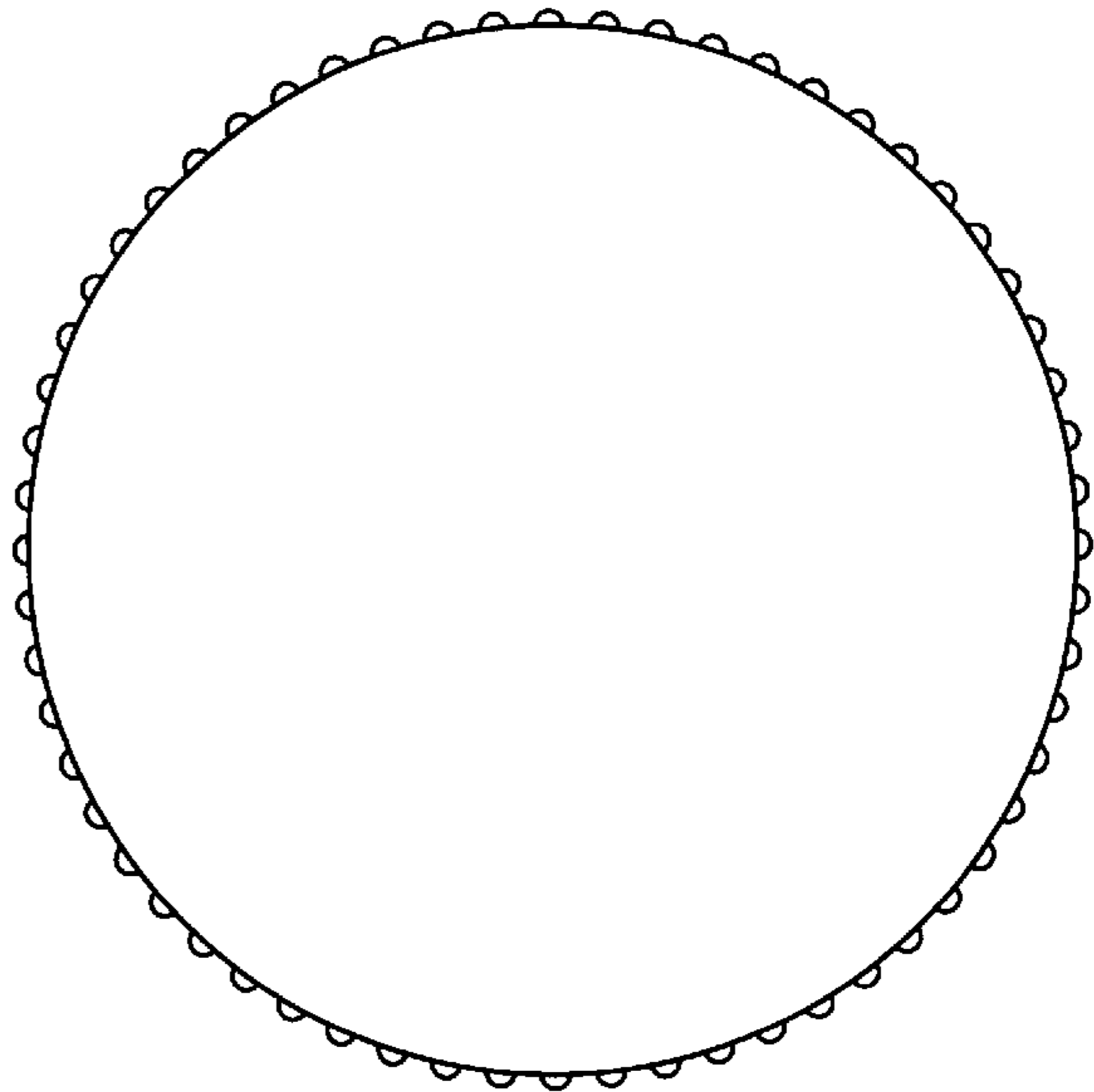
