FIG. 6 is an opposing side view of the container in the closed position;

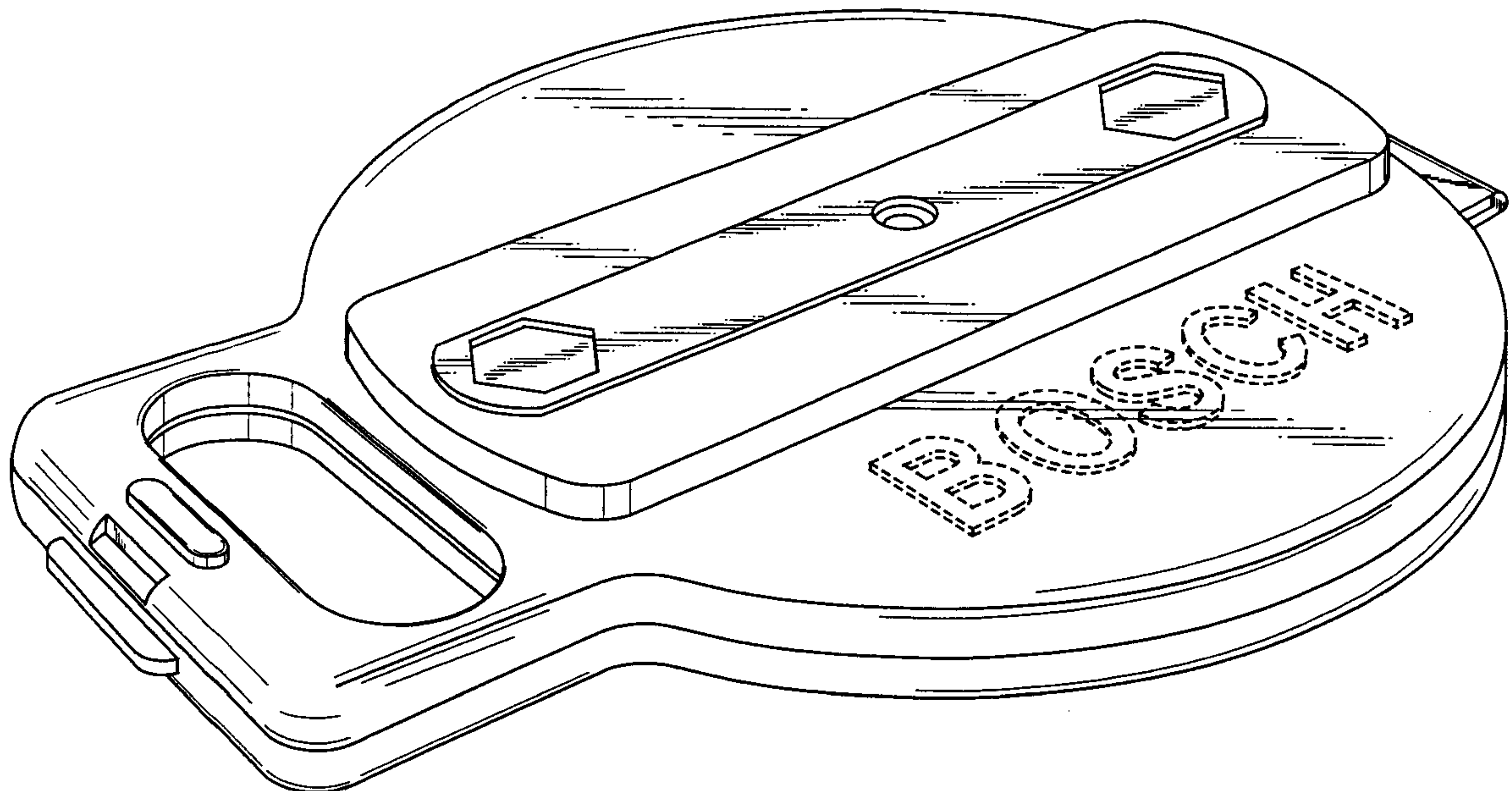
FIG. 7 is top view of the container; and,

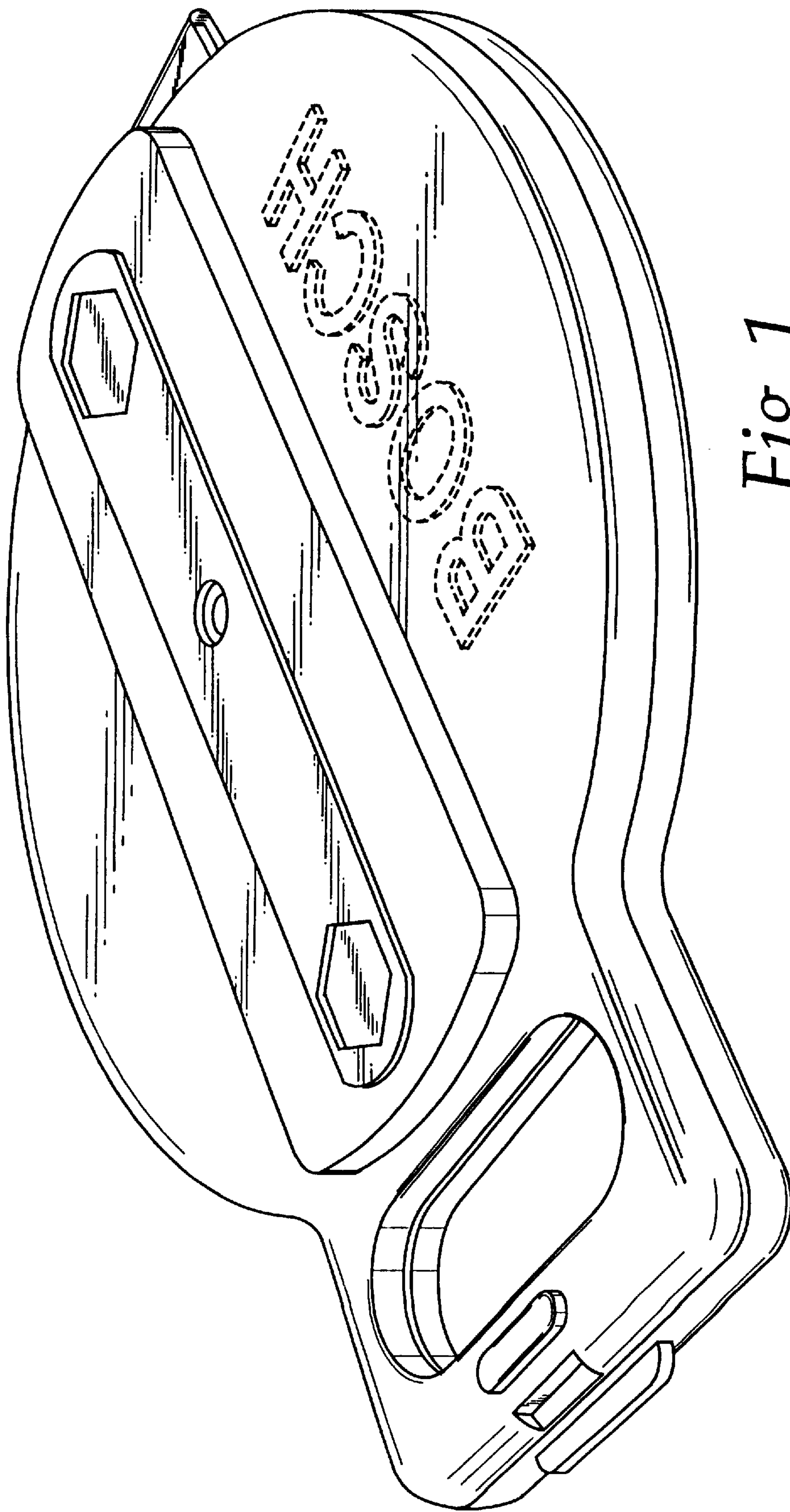
FIG. 8 is a bottom view of the container.

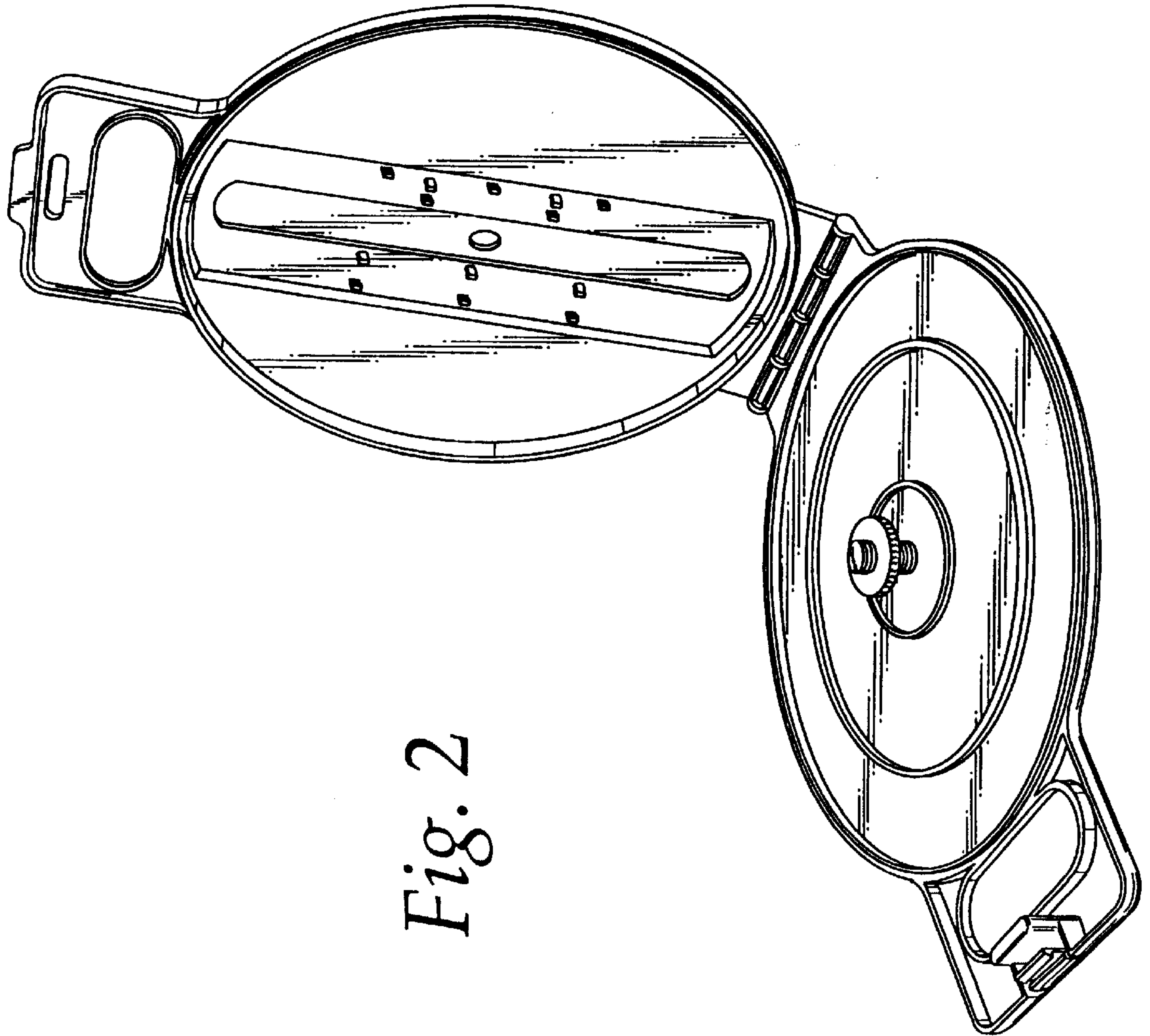


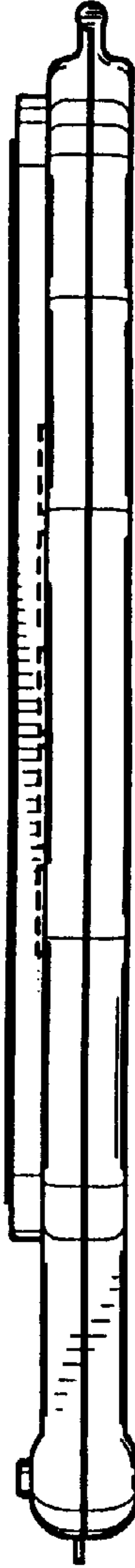

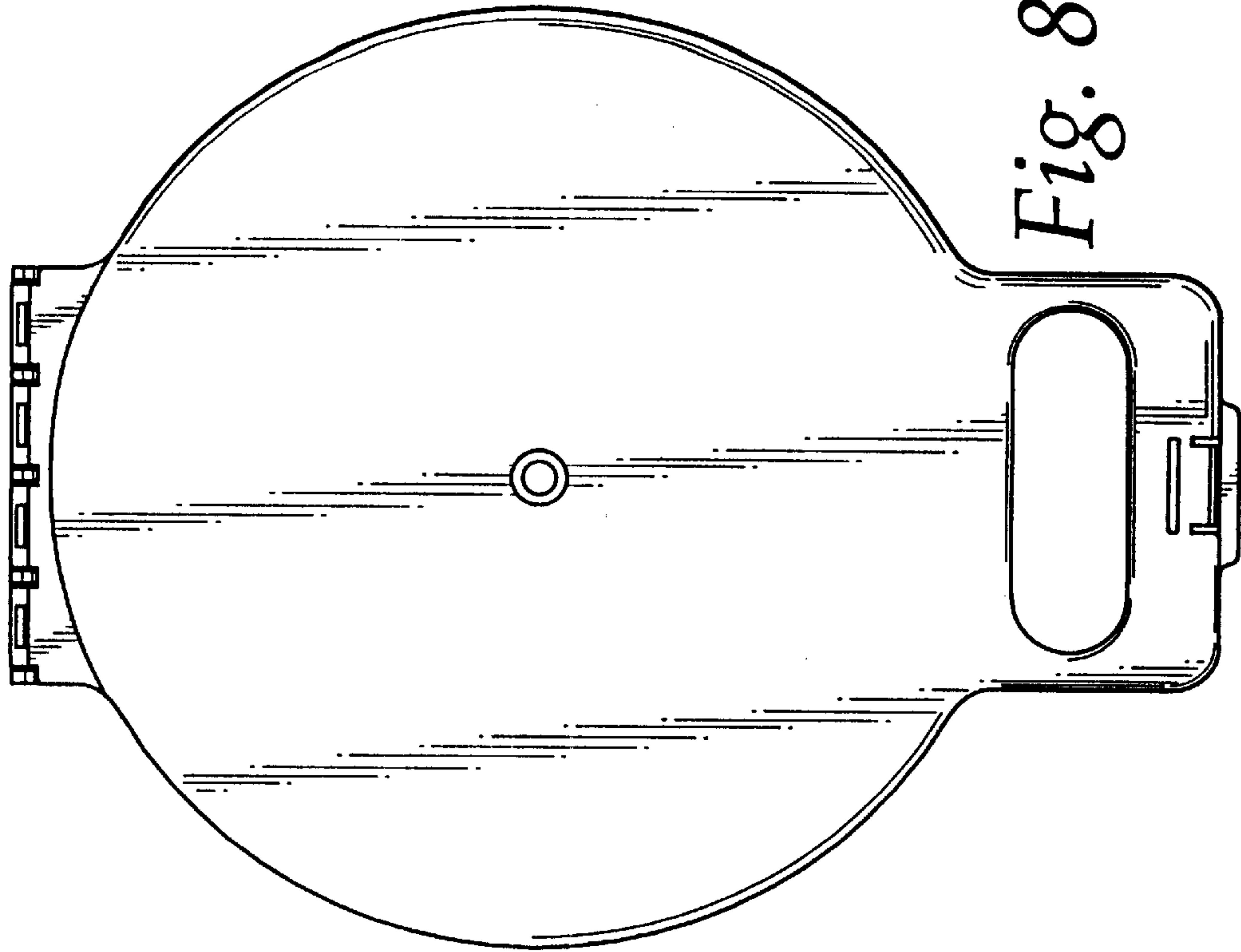

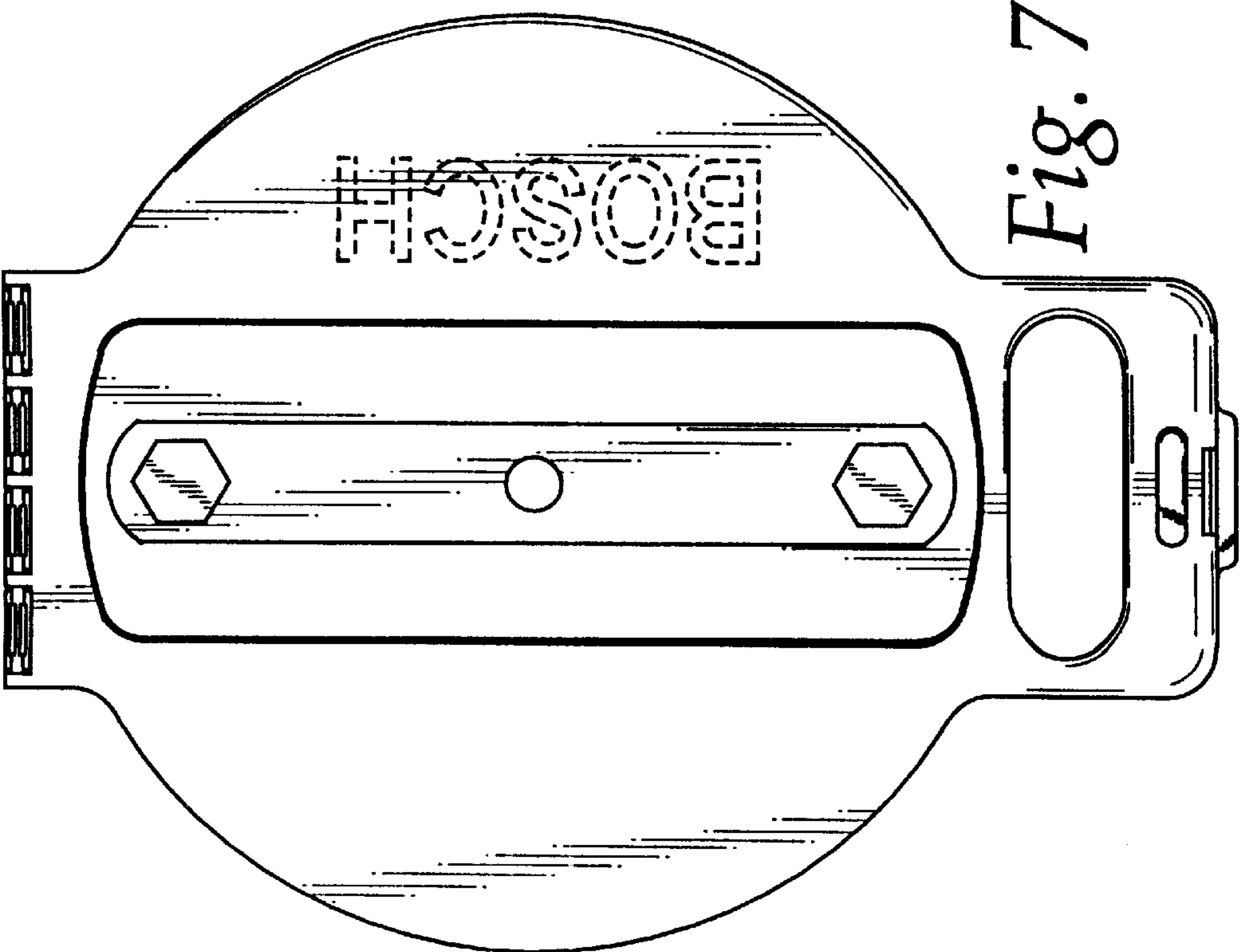
