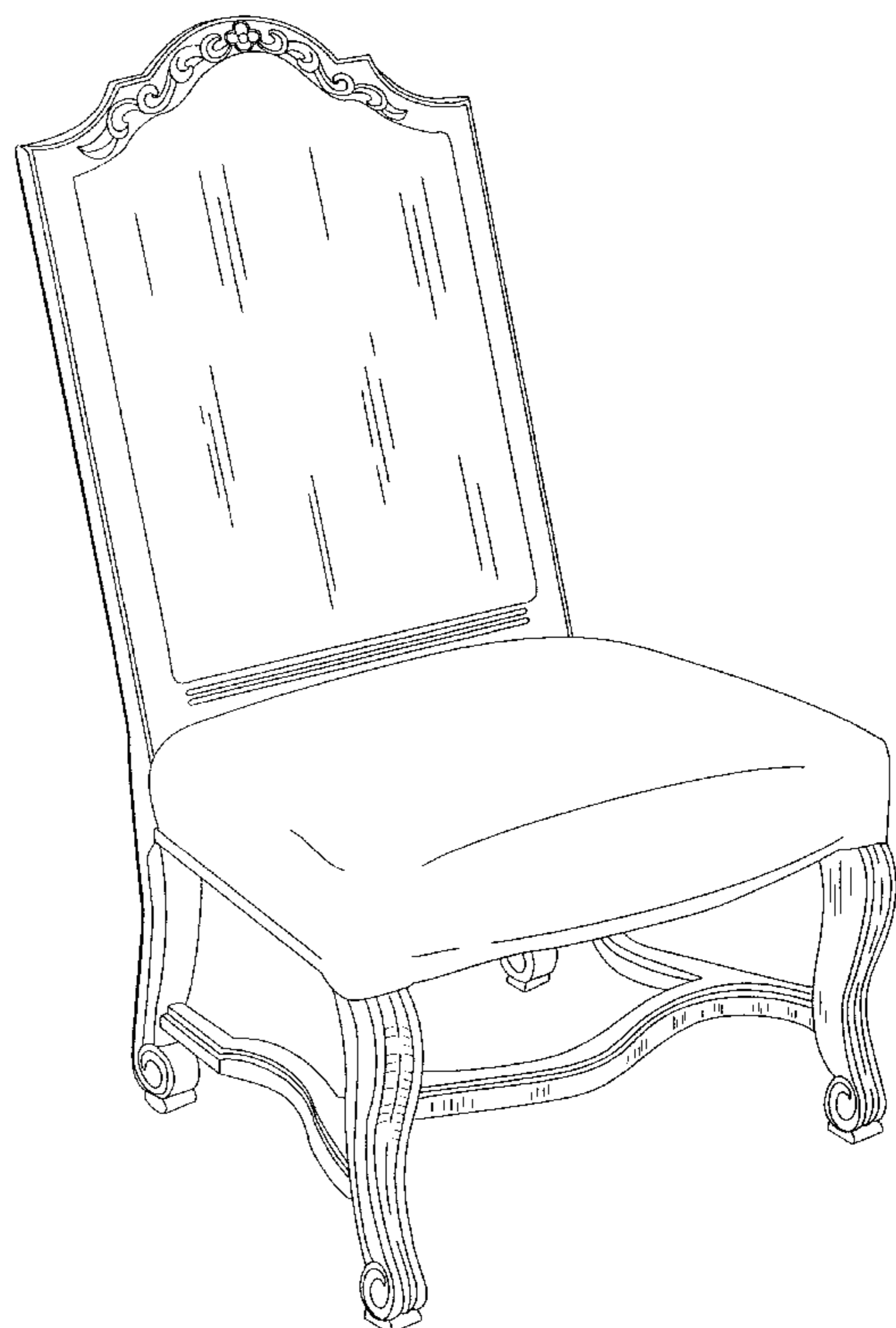
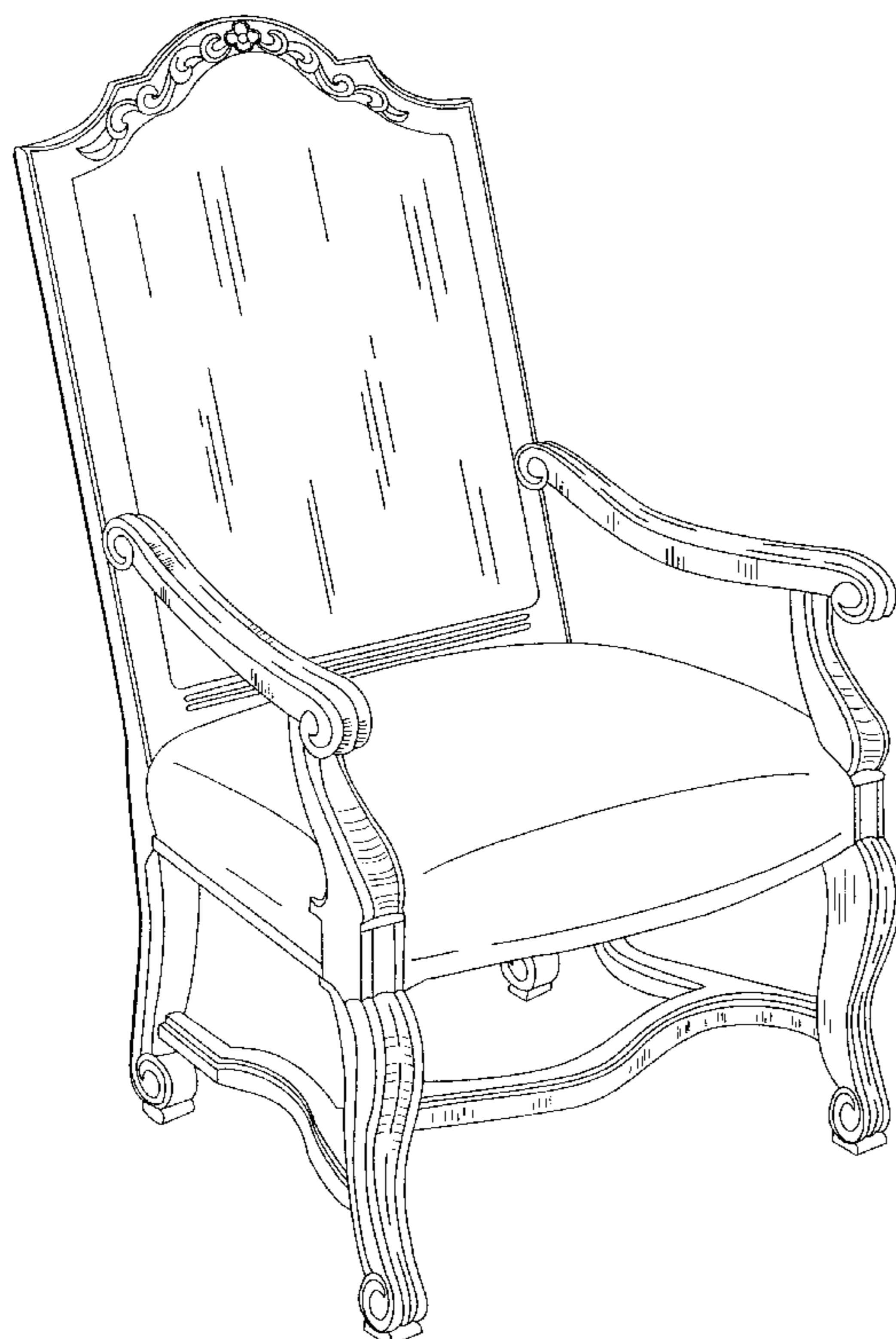
(57) **CLAIM**

The ornamental design for a chair, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a chair showing my new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a side view, the opposite side being a mirror image thereof;
FIG. 4 is a back view; and,
FIG. 5 is a perspective view of a second embodiment of the chair wherein the sole difference is the absence of armrest members.

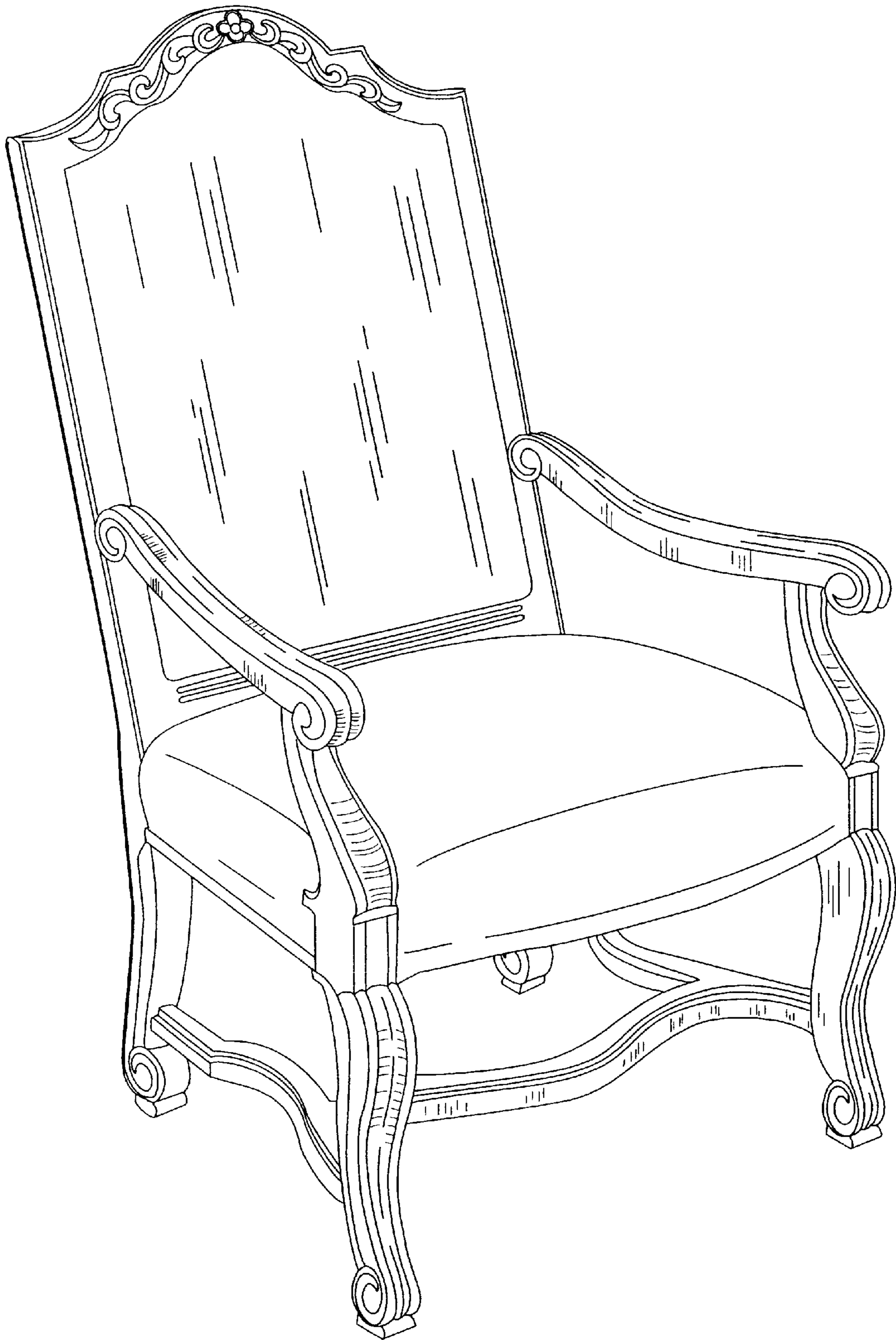

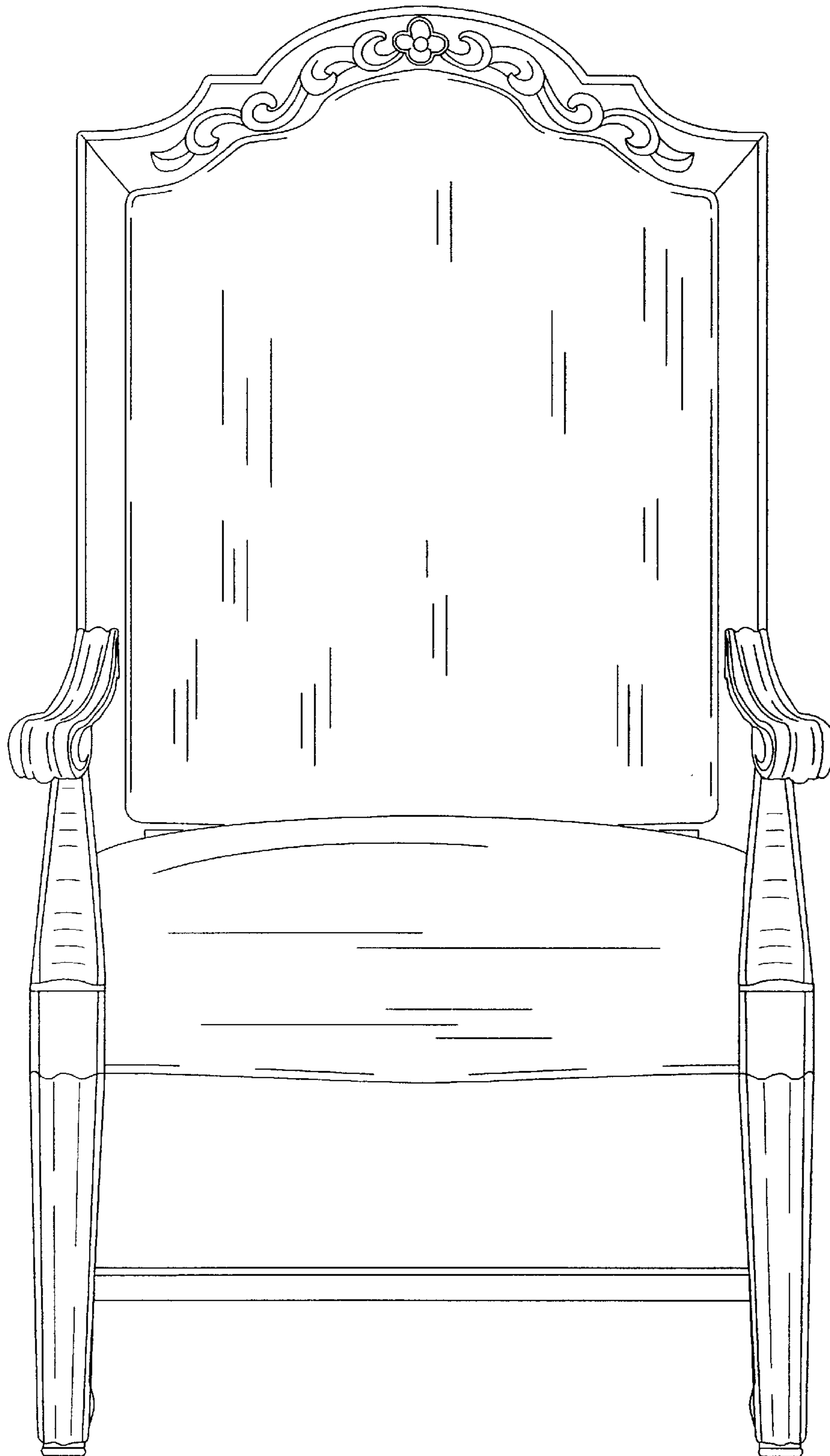

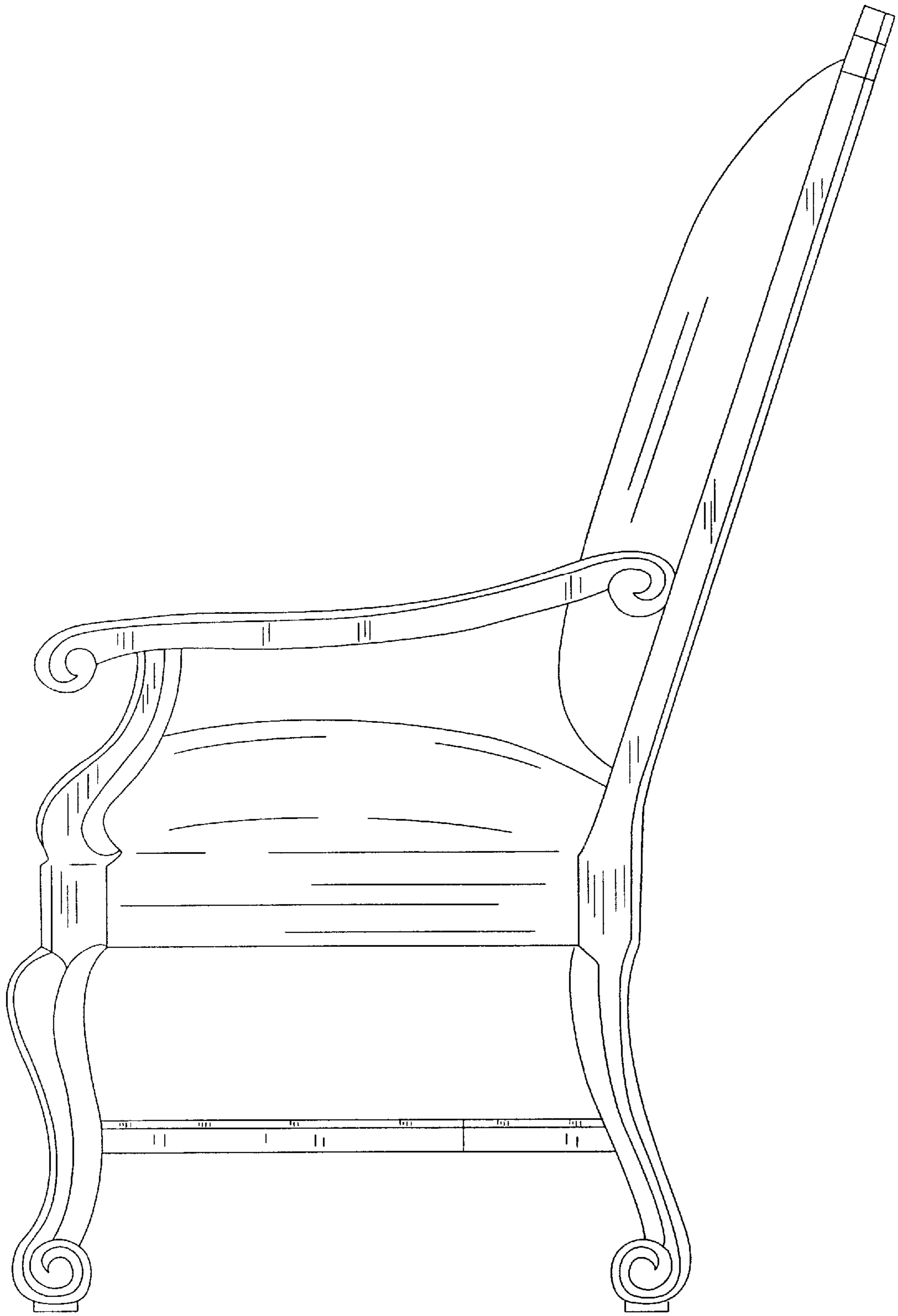

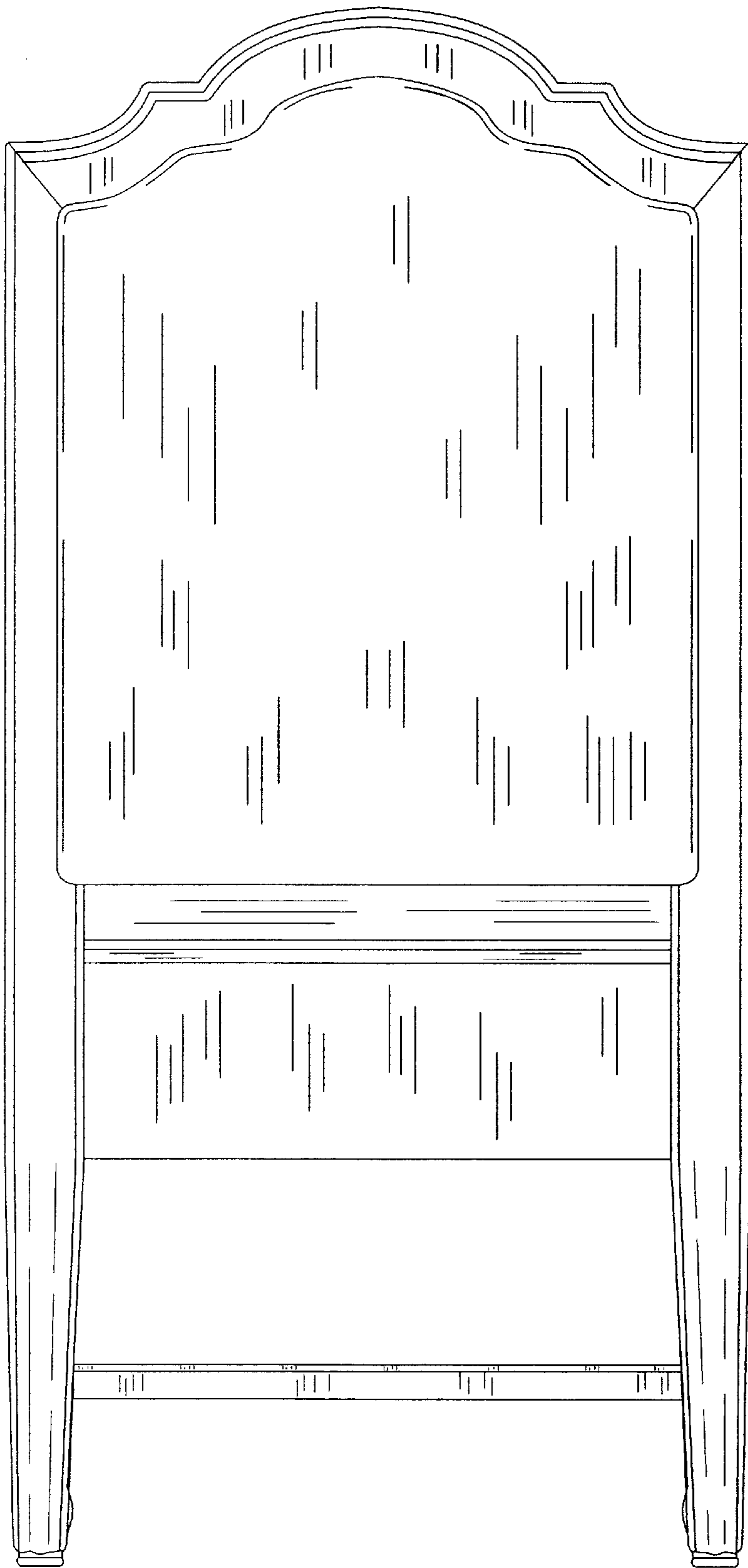

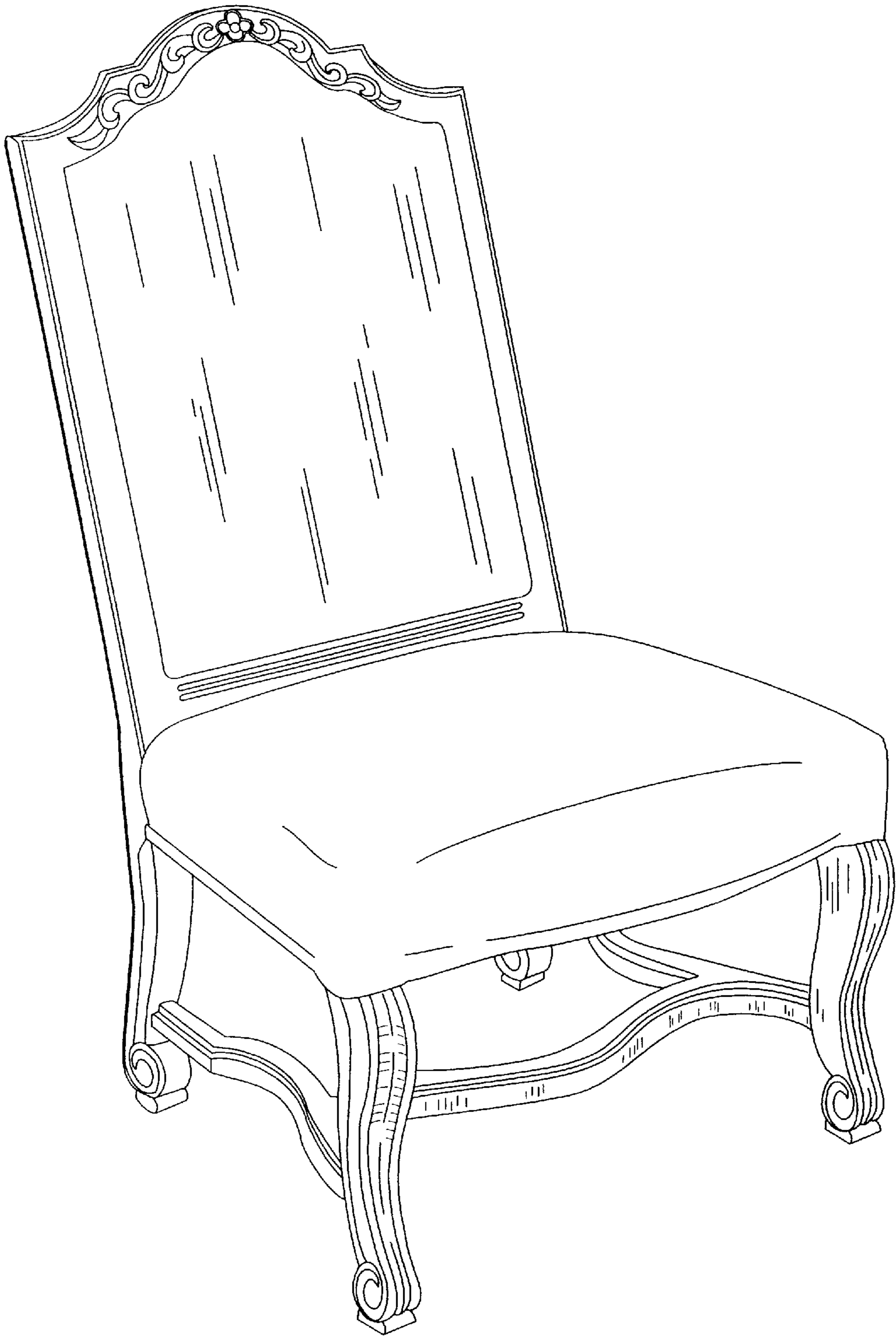
