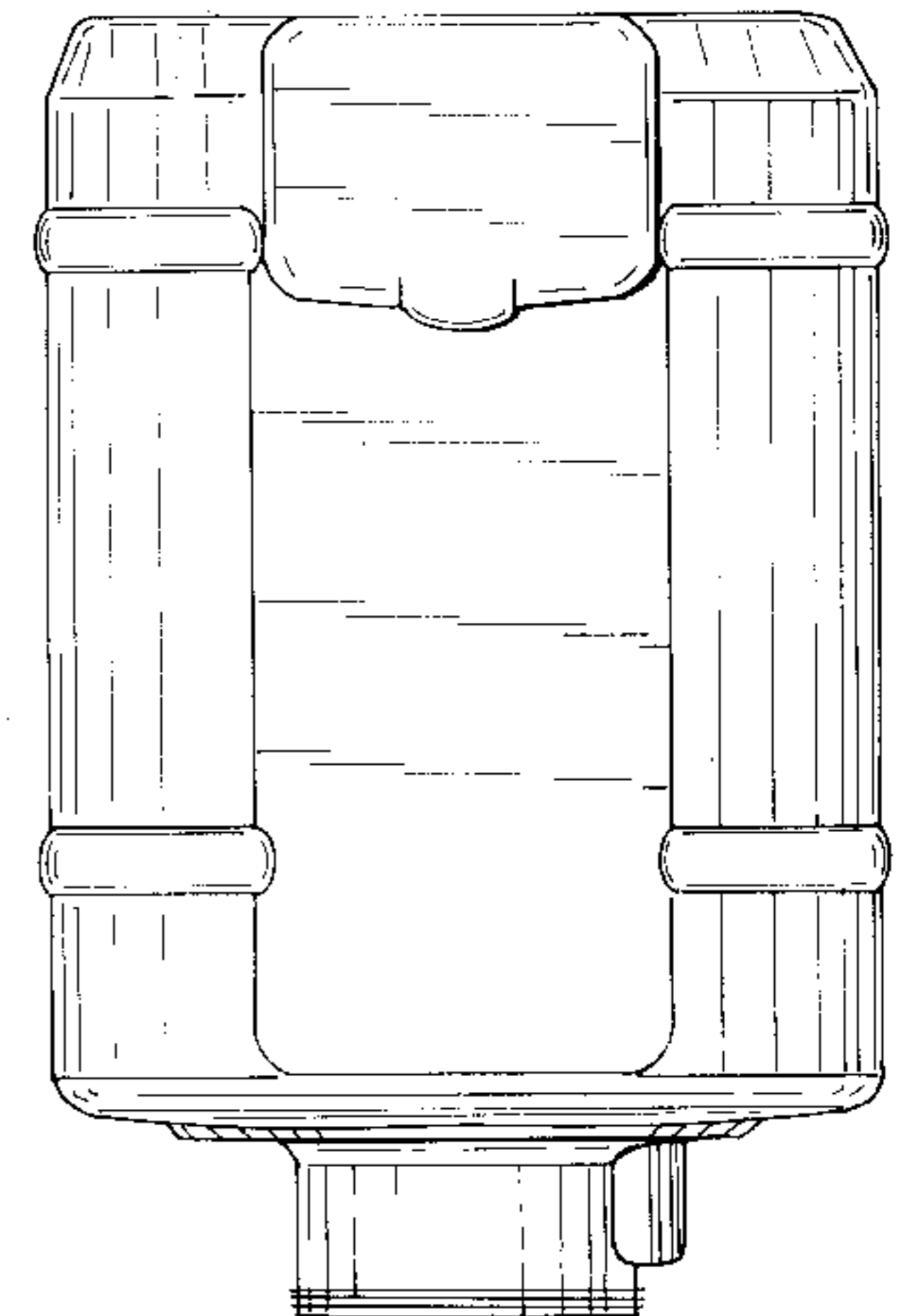
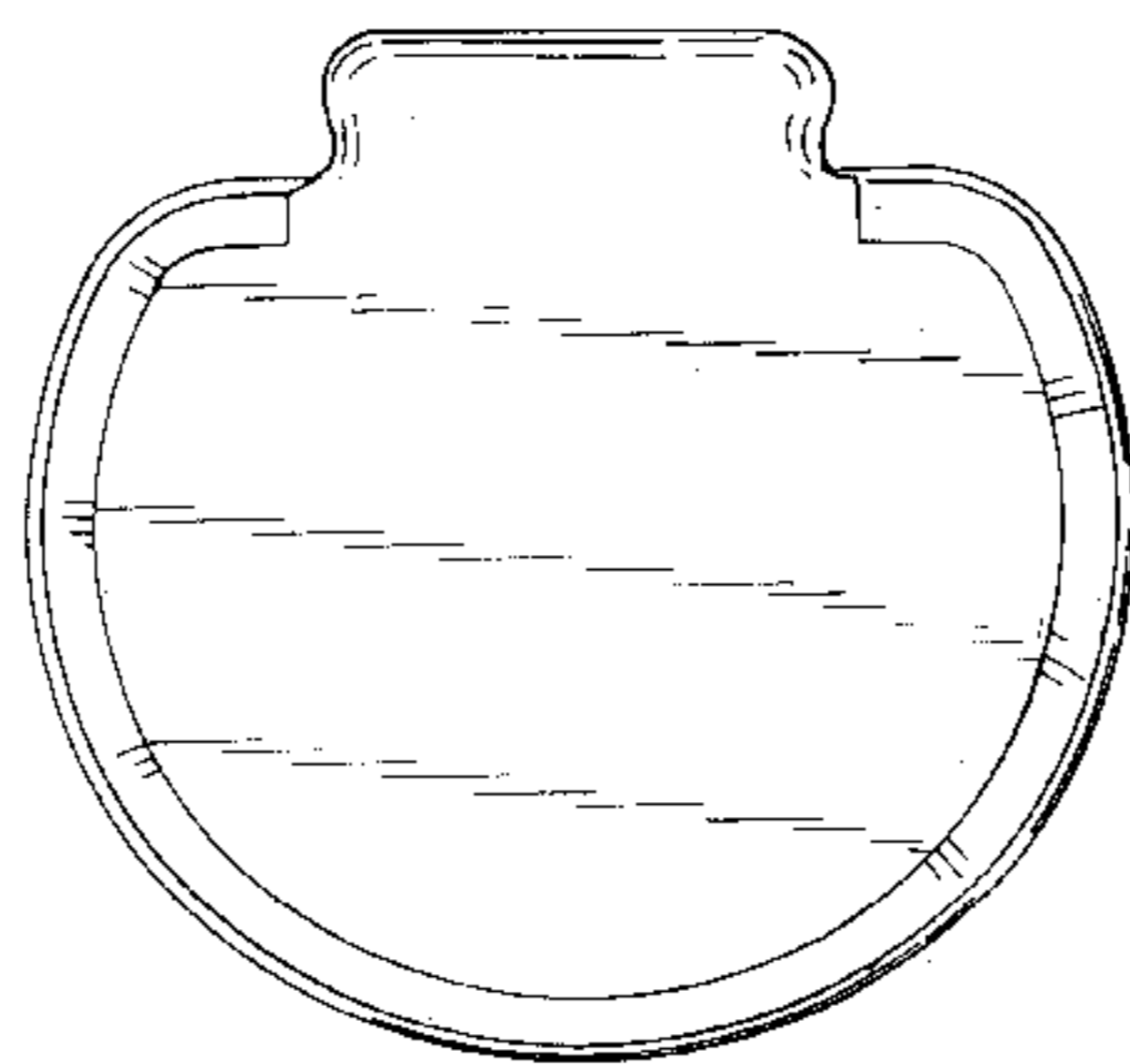
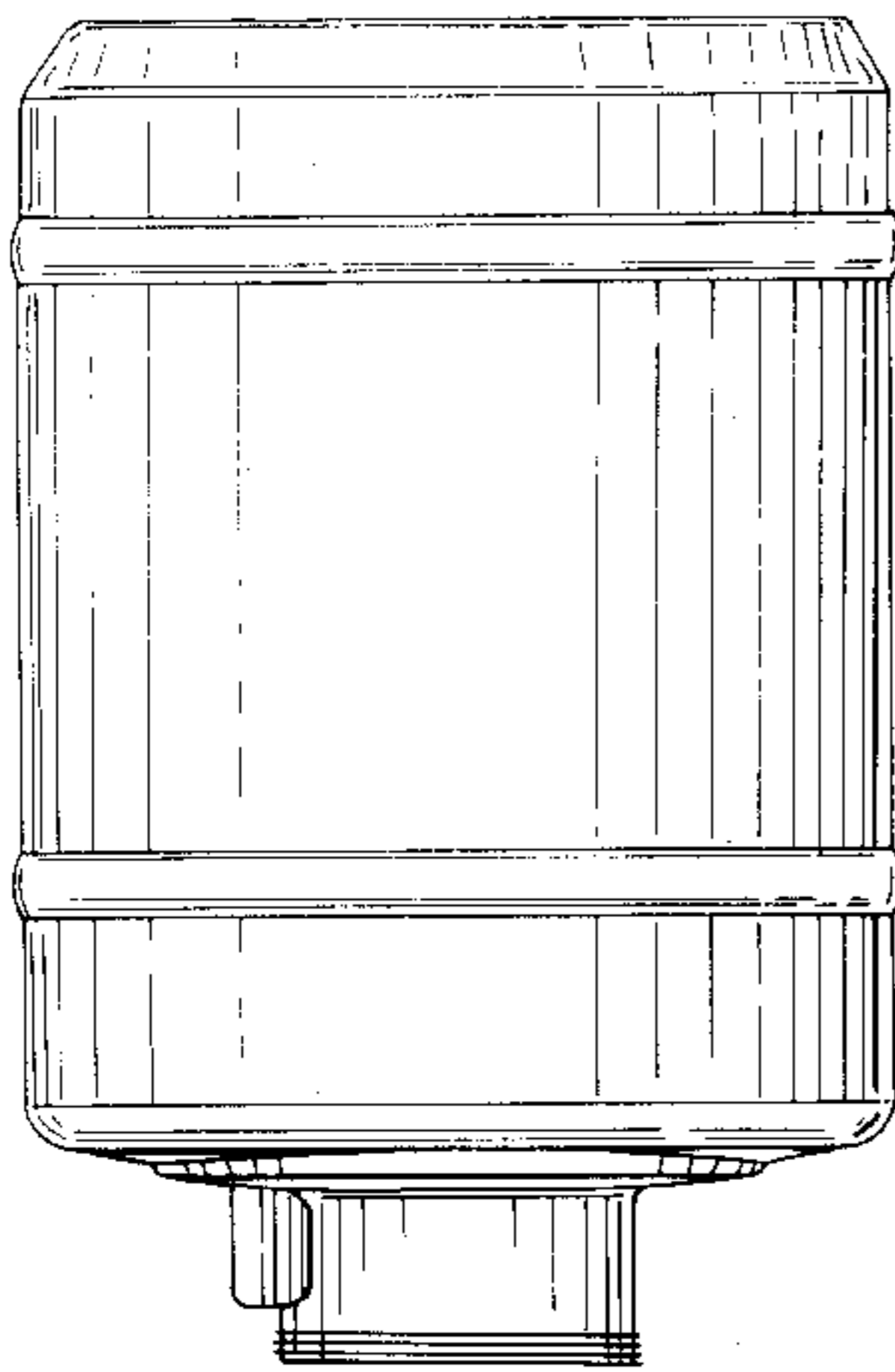
(57) **CLAIM**

The ornamental design for the soap container with plain top and top lug, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the soap container with plain top and top lug embodying our new design;
 FIG. 2 is a top view of the soap container with plain top and top lug illustrated in FIG. 1;
 FIG. 3 is a rear view of the soap container with plain top and top lug illustrated in FIG. 1;
 FIG. 4 is a bottom view of the soap container with plain top and top lug illustrated in FIG. 1;
 FIG. 5 is a right side view of the soap container with plain top and top lug illustrated in FIG. 1; and,
 FIG. 6 is a left side view of the soap container with plain top and top lug illustrated in FIG. 1.

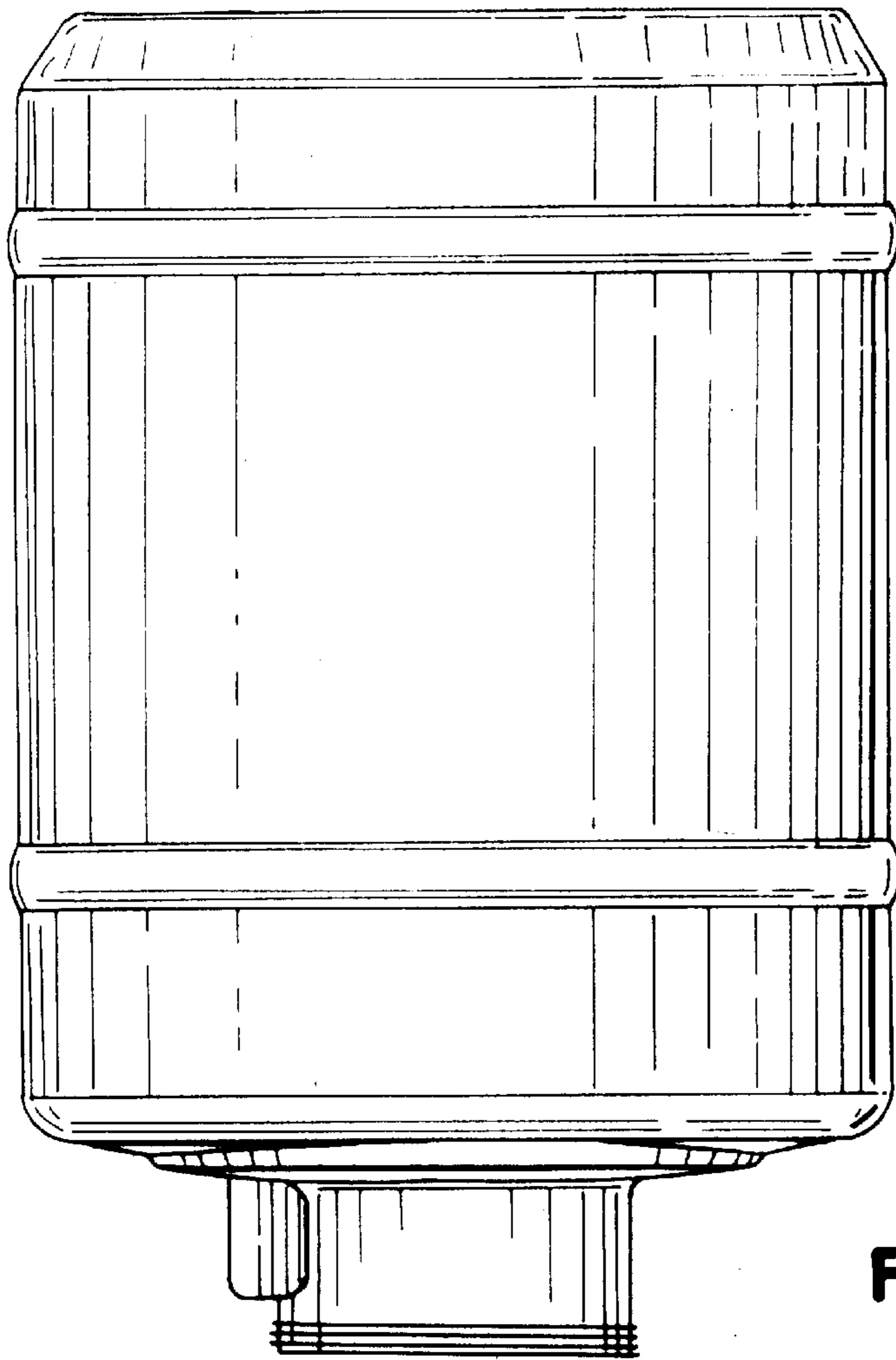

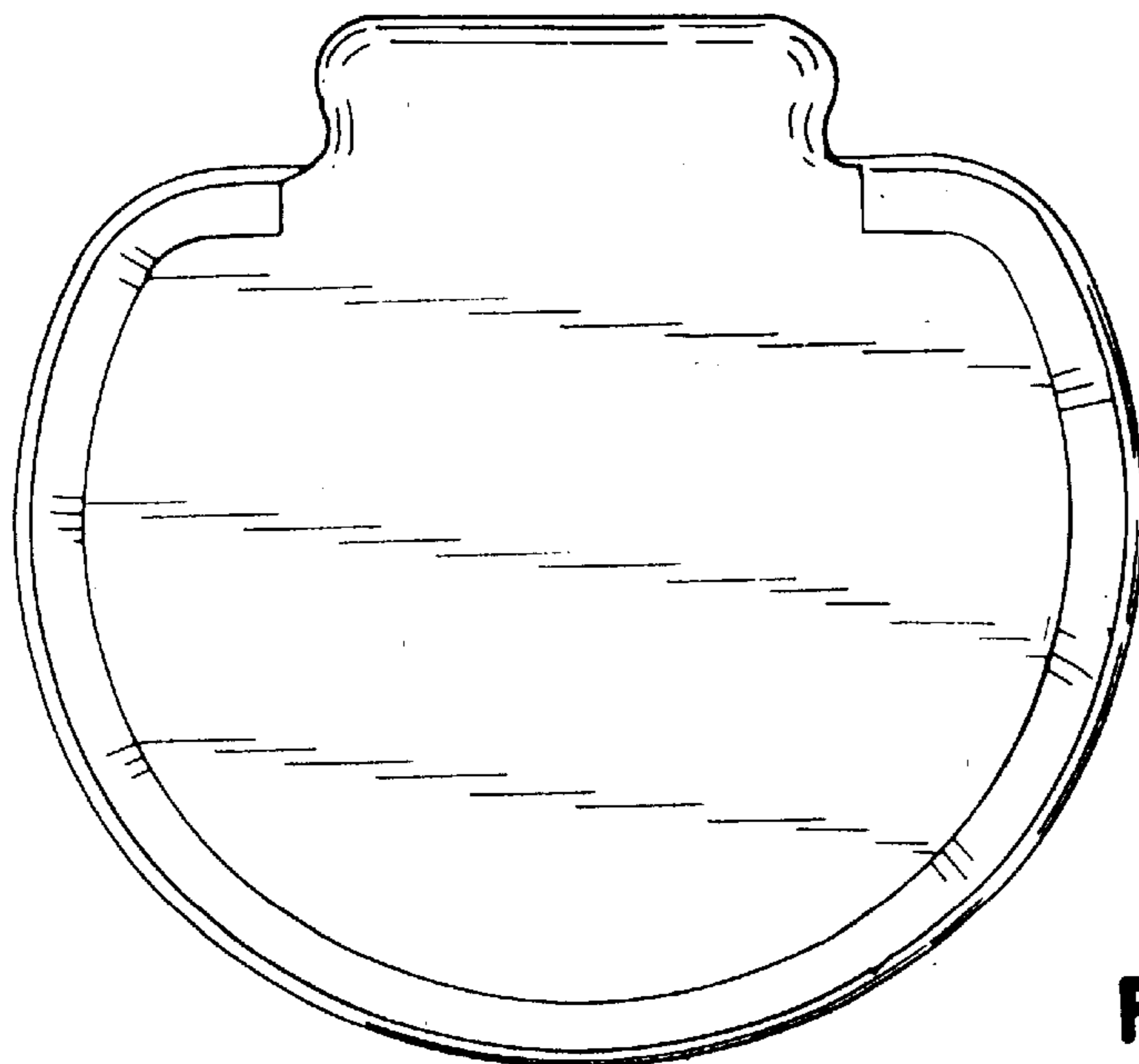

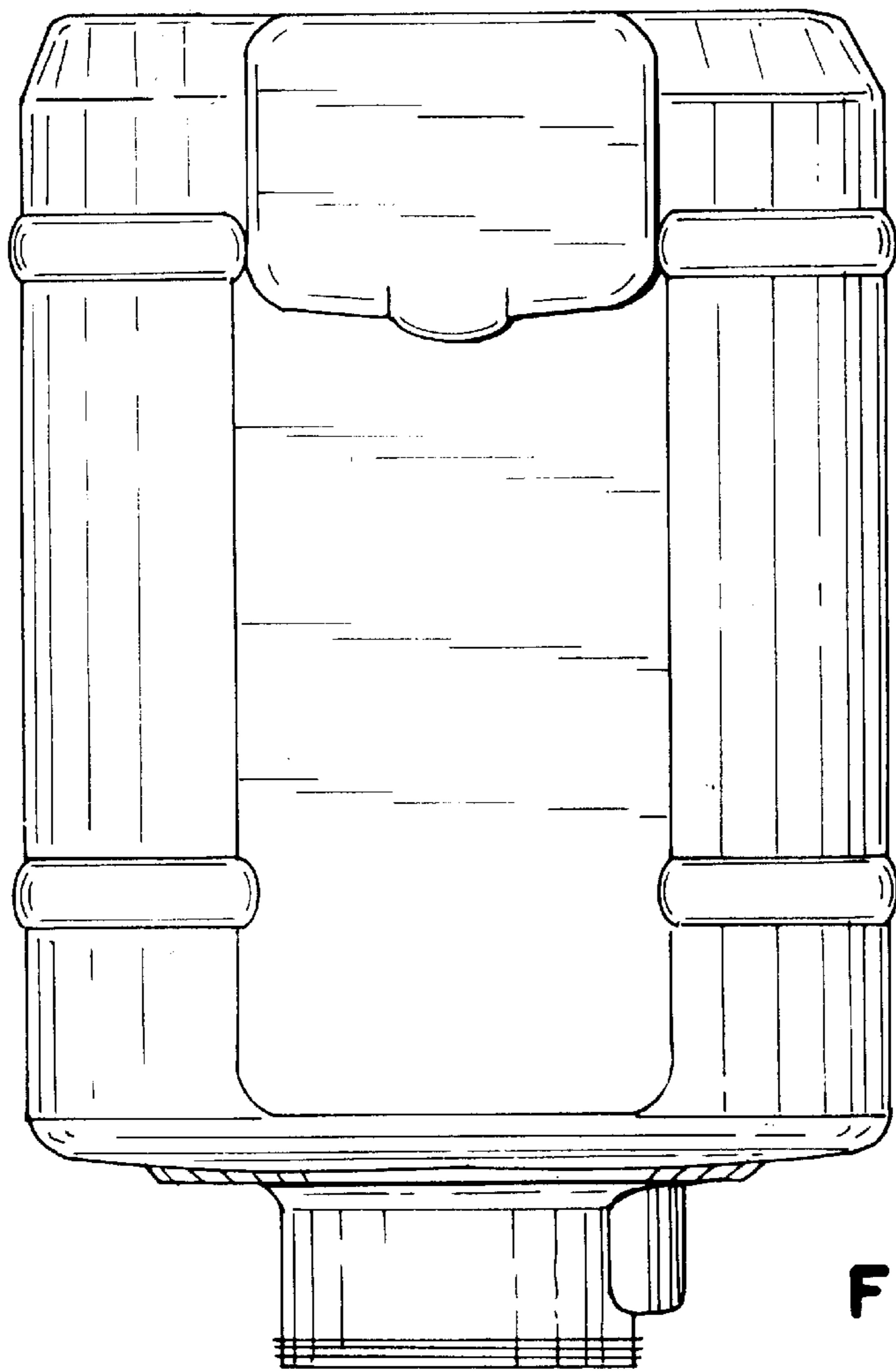

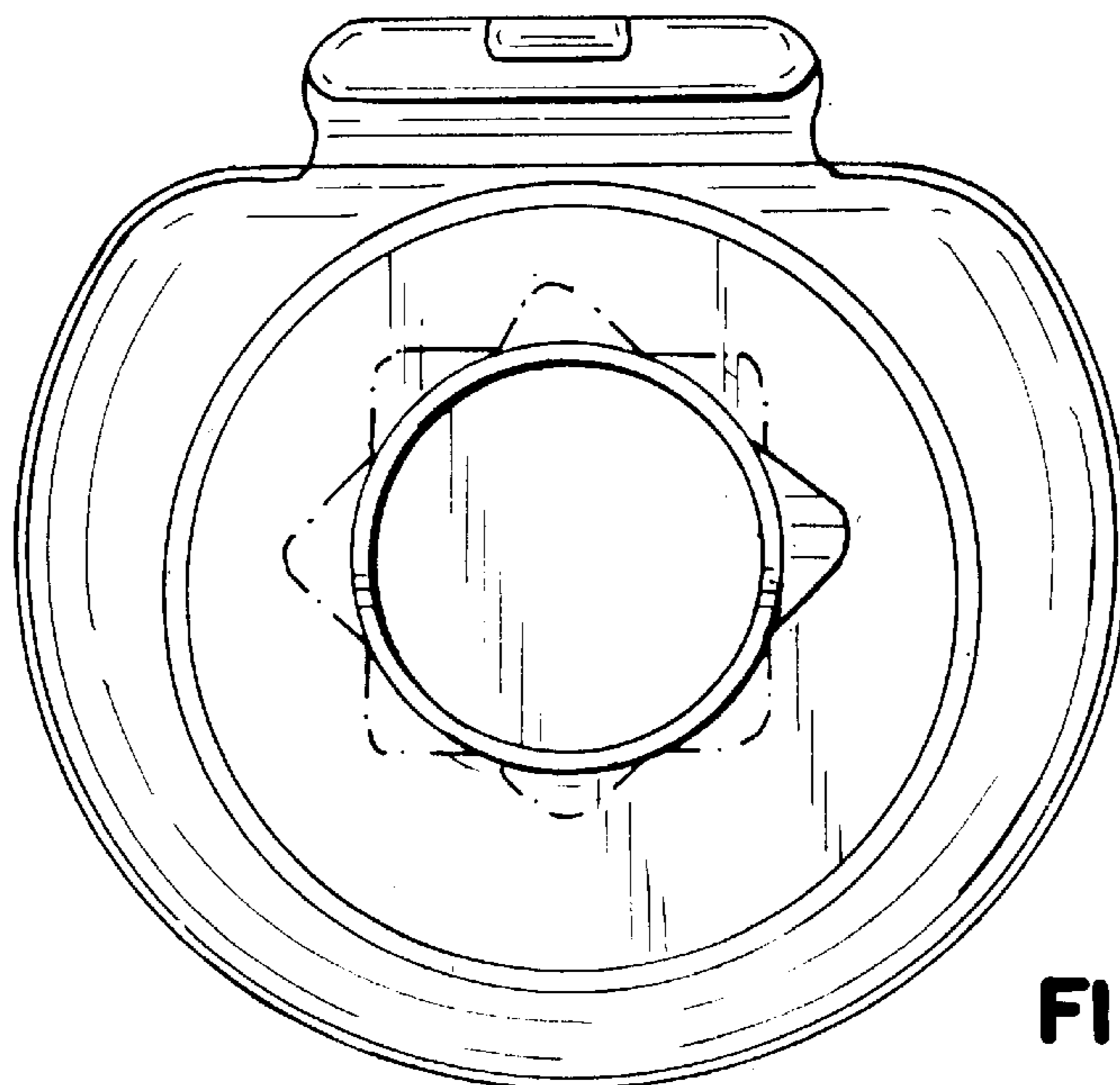

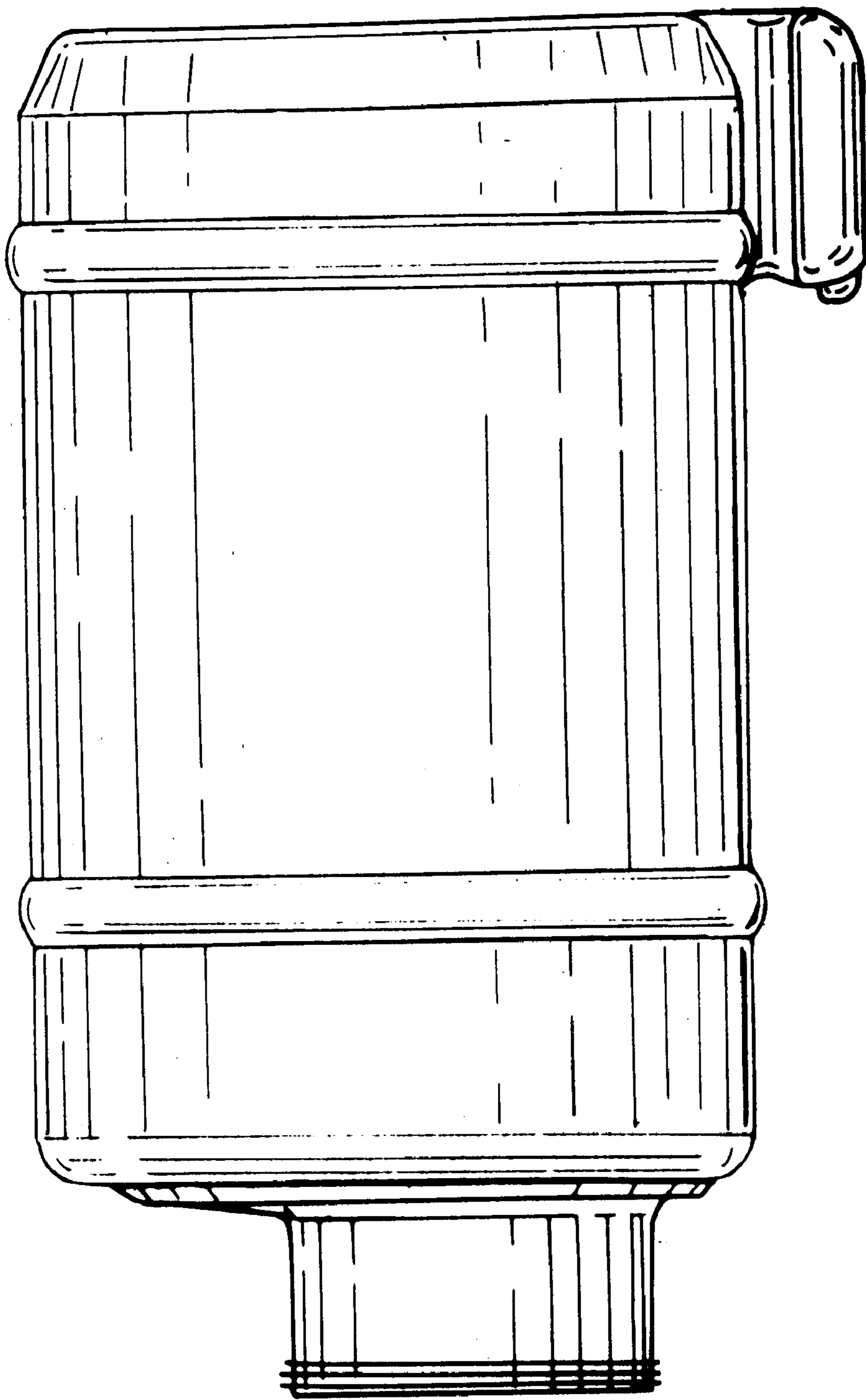

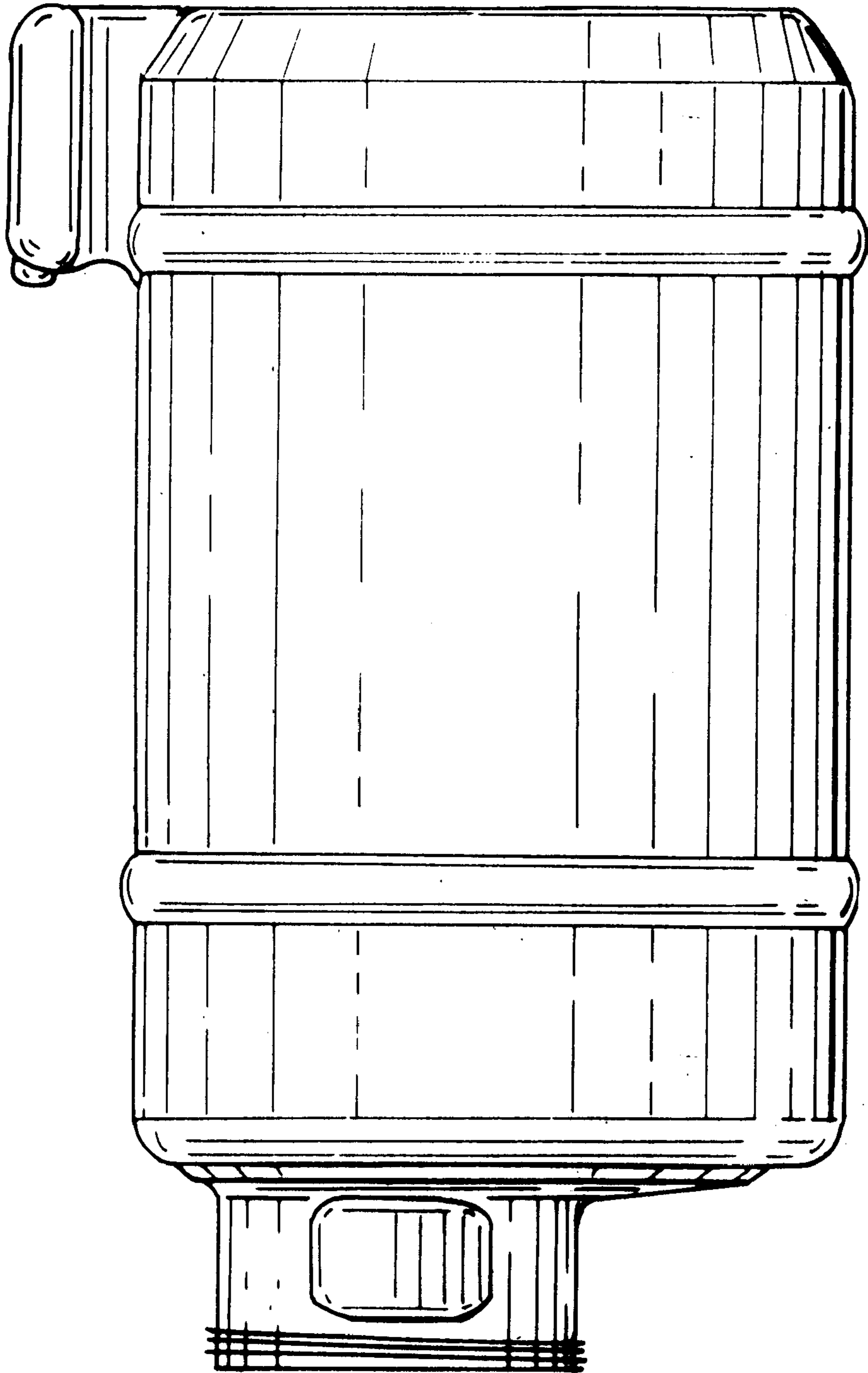
