(57) **CLAIM**

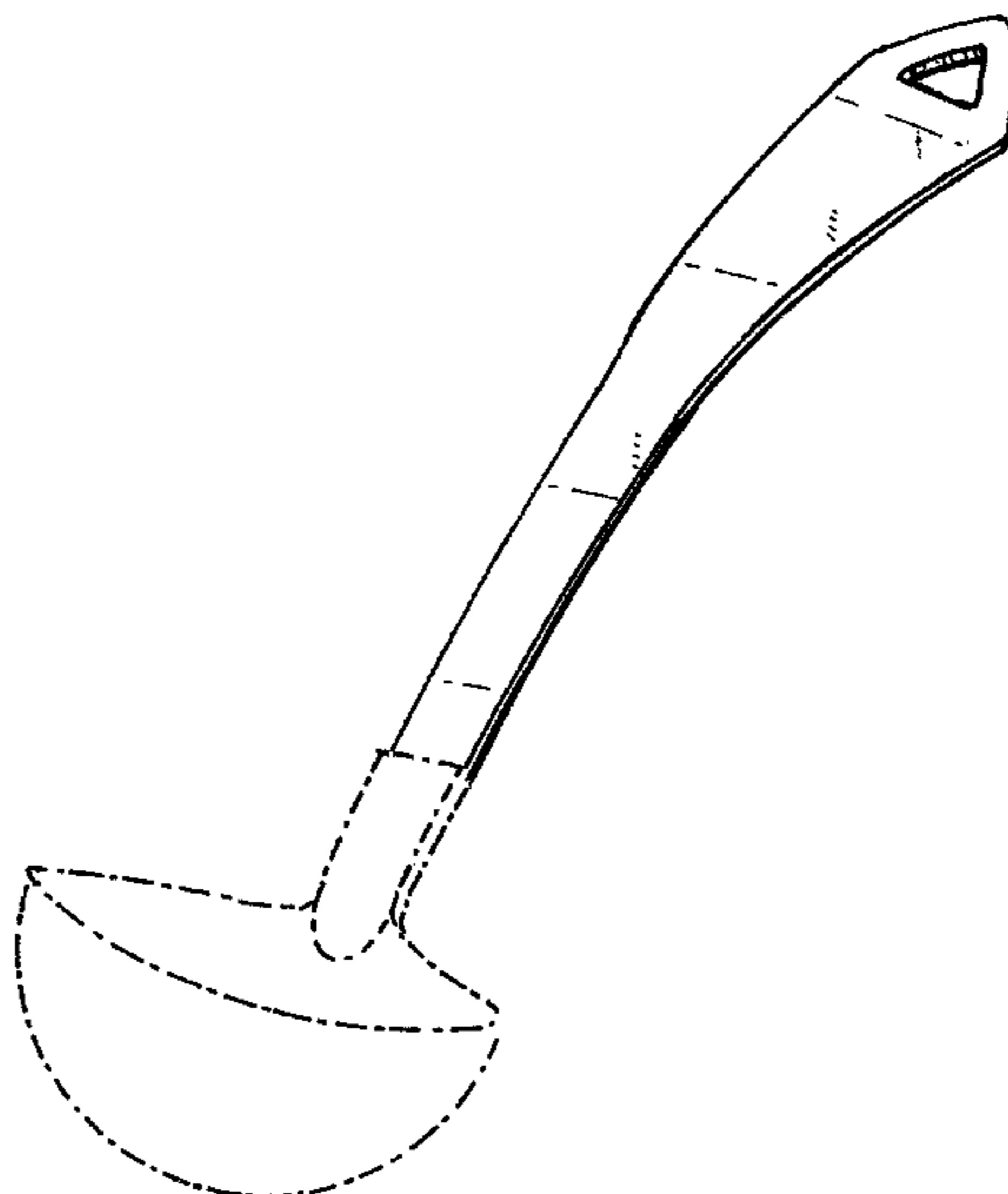
The ornamental design for a utensil handle, as shown and described.

DESCRIPTION

FIG. 1 is a side, top perspective view of the utensil handle showing my new design;
 FIG. 2 is a top view thereof;
 FIG. 3 is a bottom view thereof;
 FIG. 4 is a right side view thereof;
 FIG. 5 is a left side view thereof;
 FIG. 6 is a rear view thereof; and,
 FIG. 7 a is front view thereof.

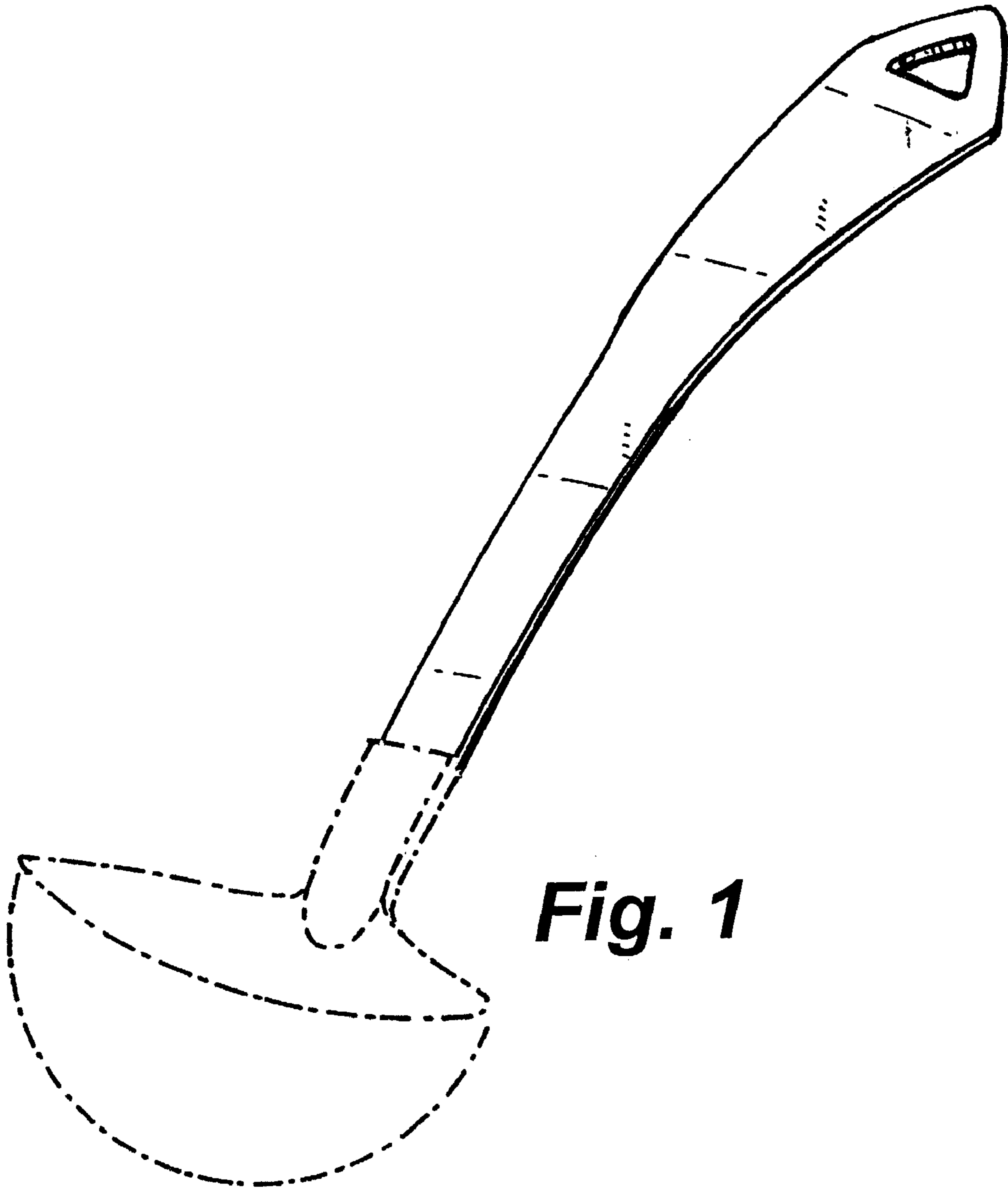

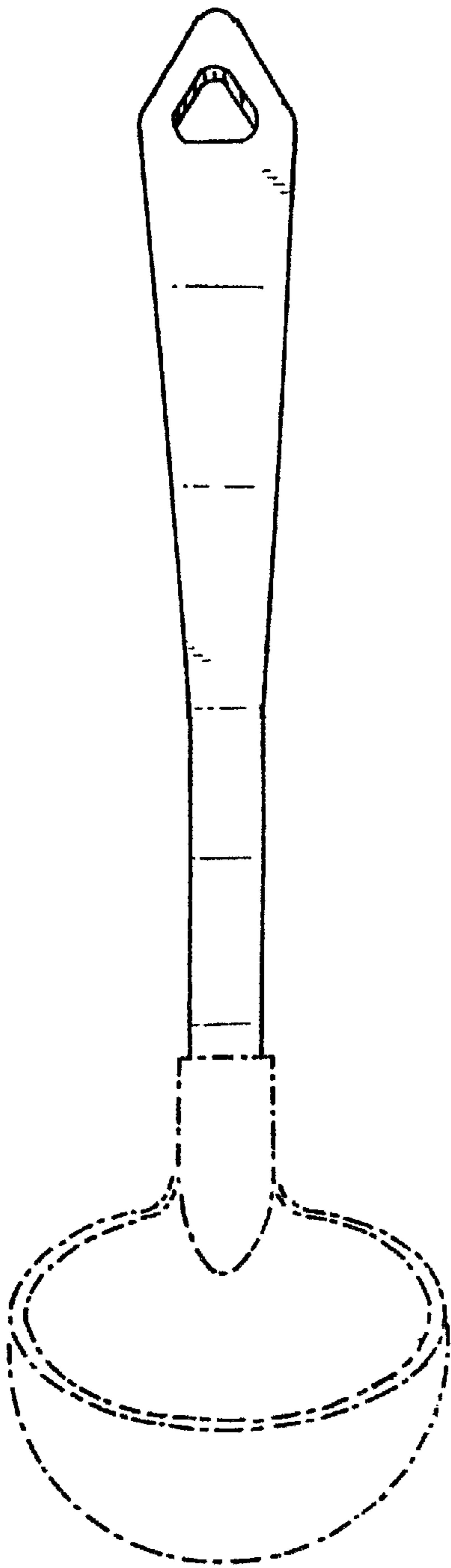

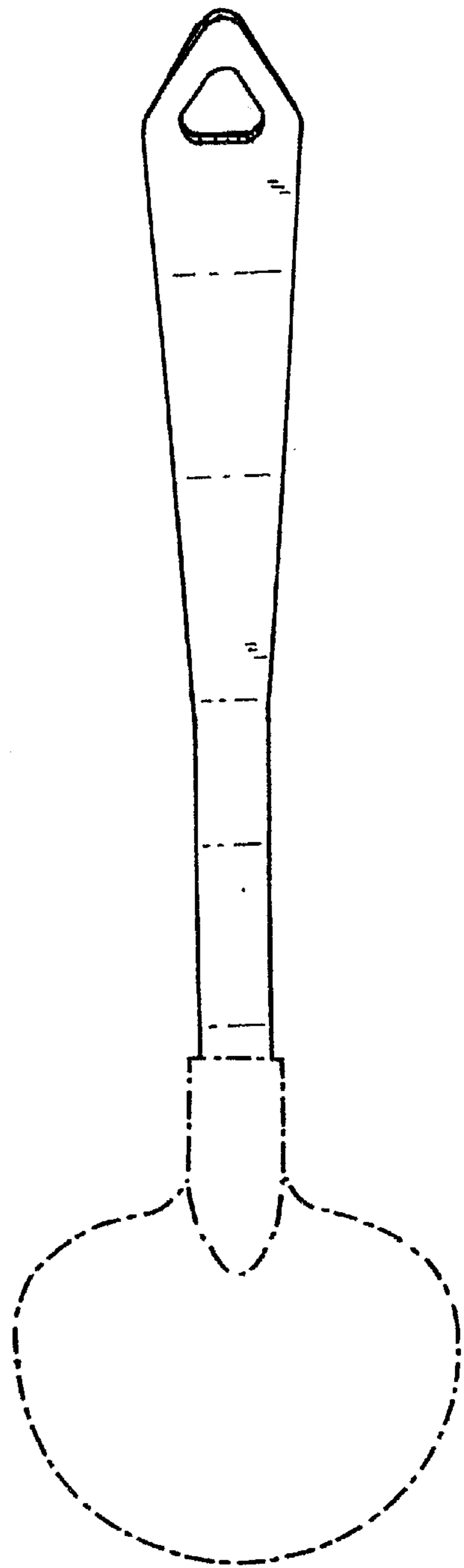
