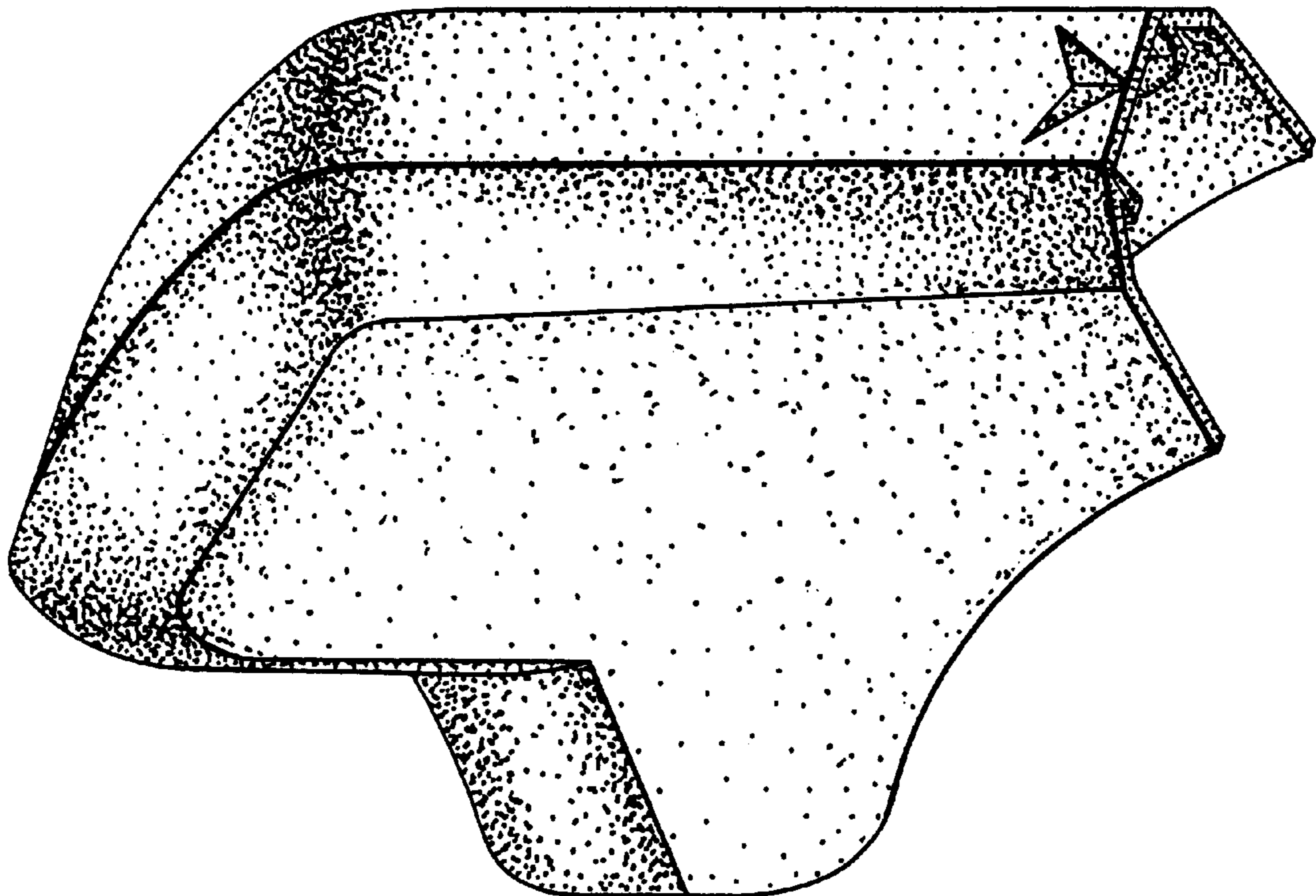
The left side elevations are mirror images of the right side elevations.

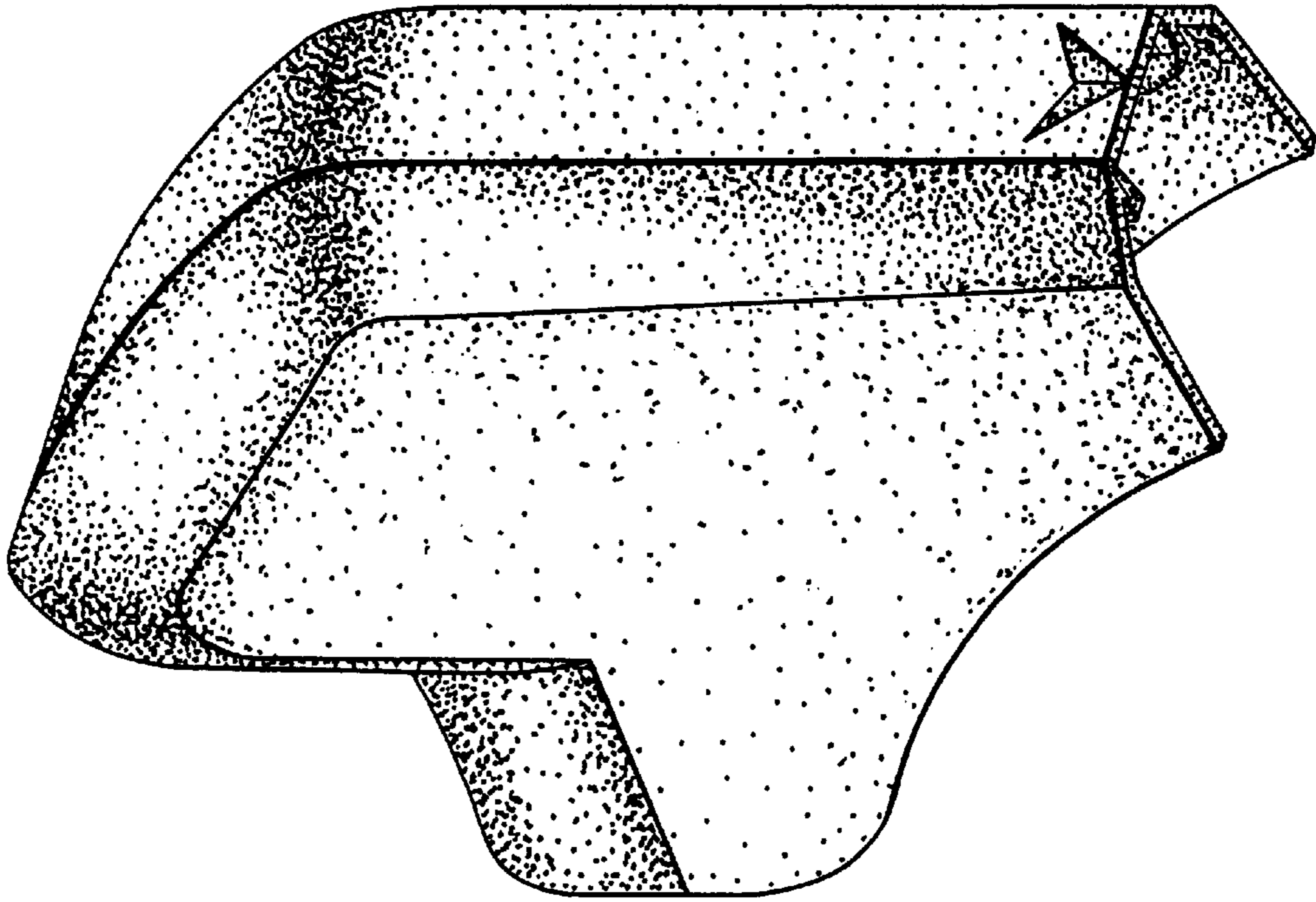

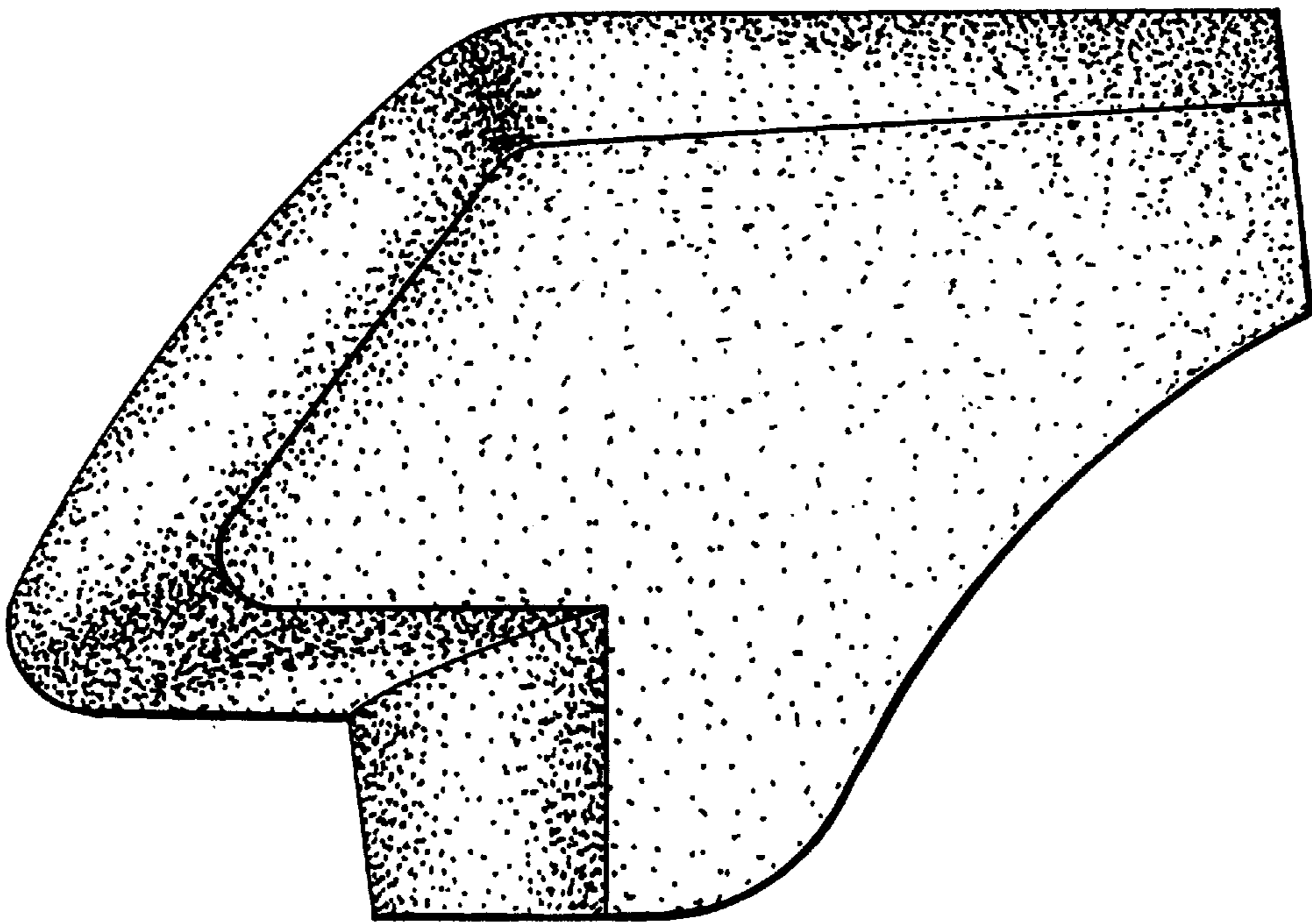

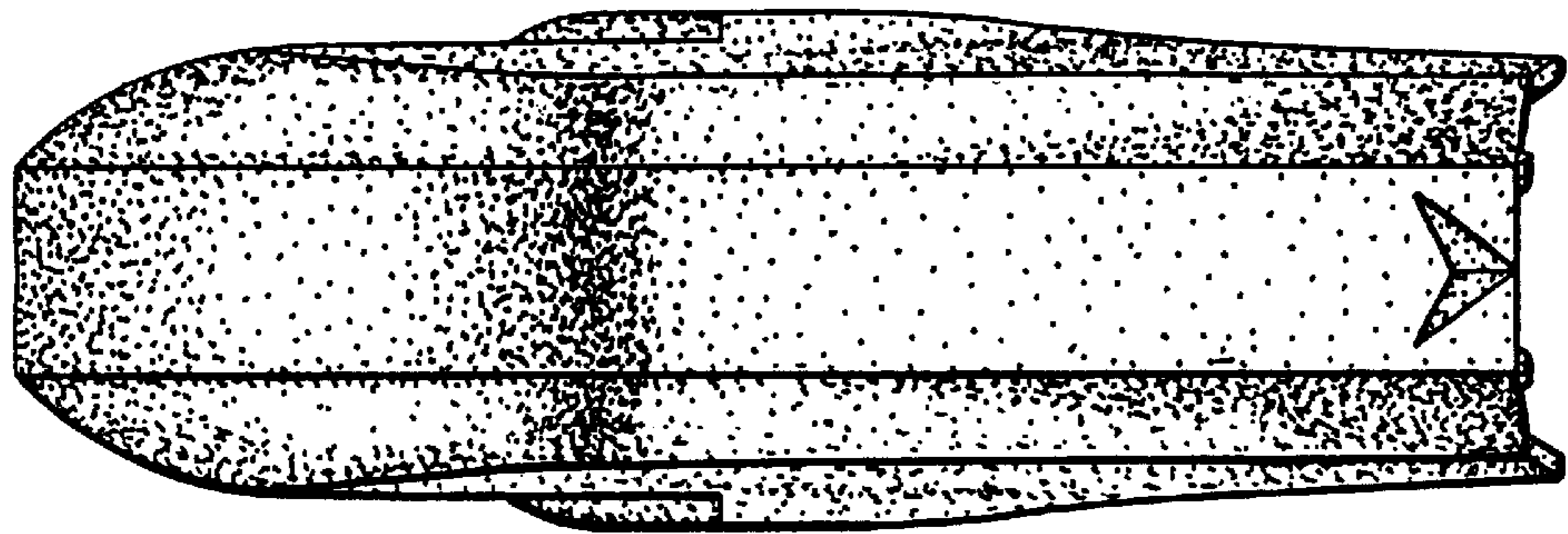

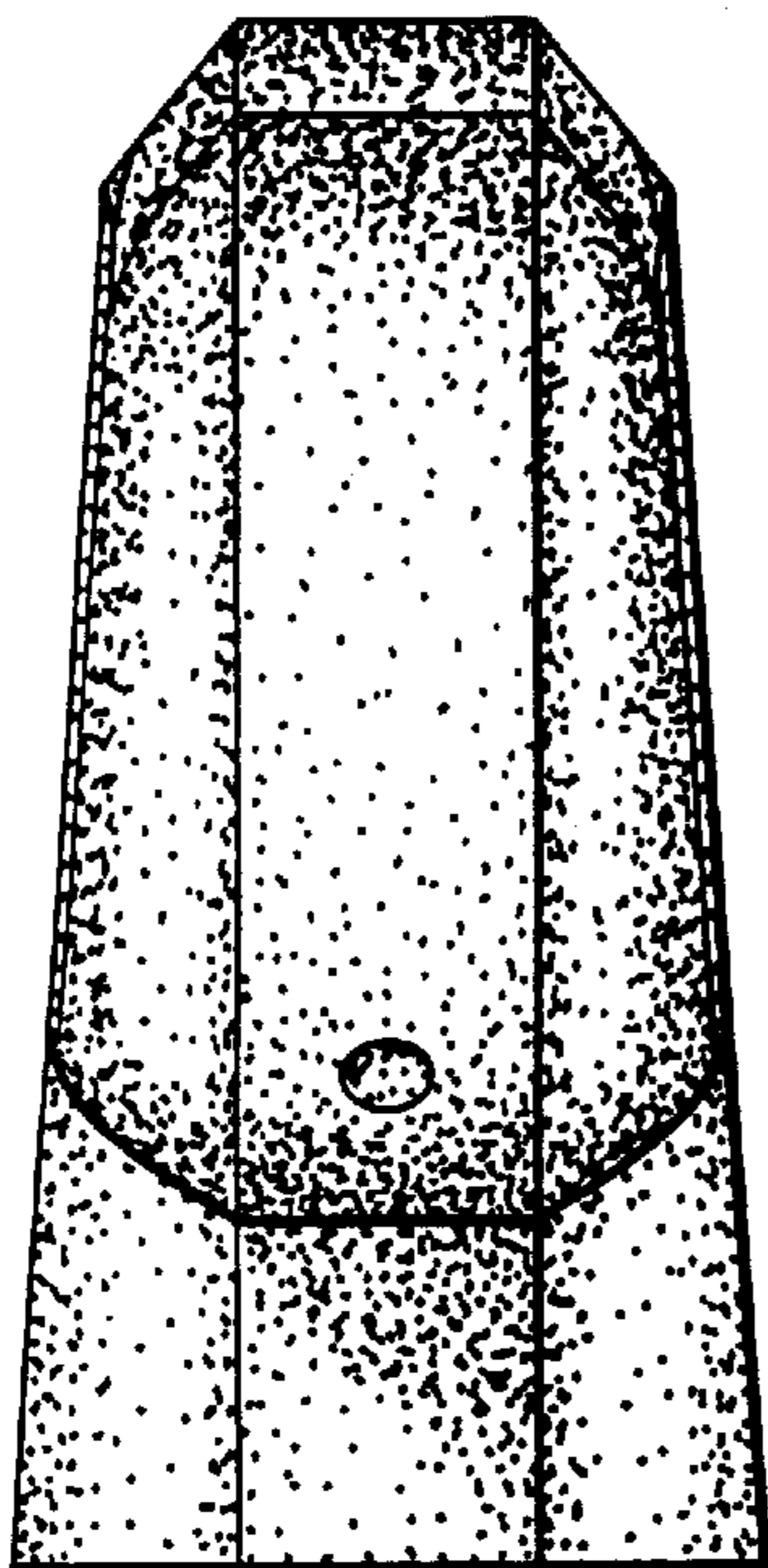

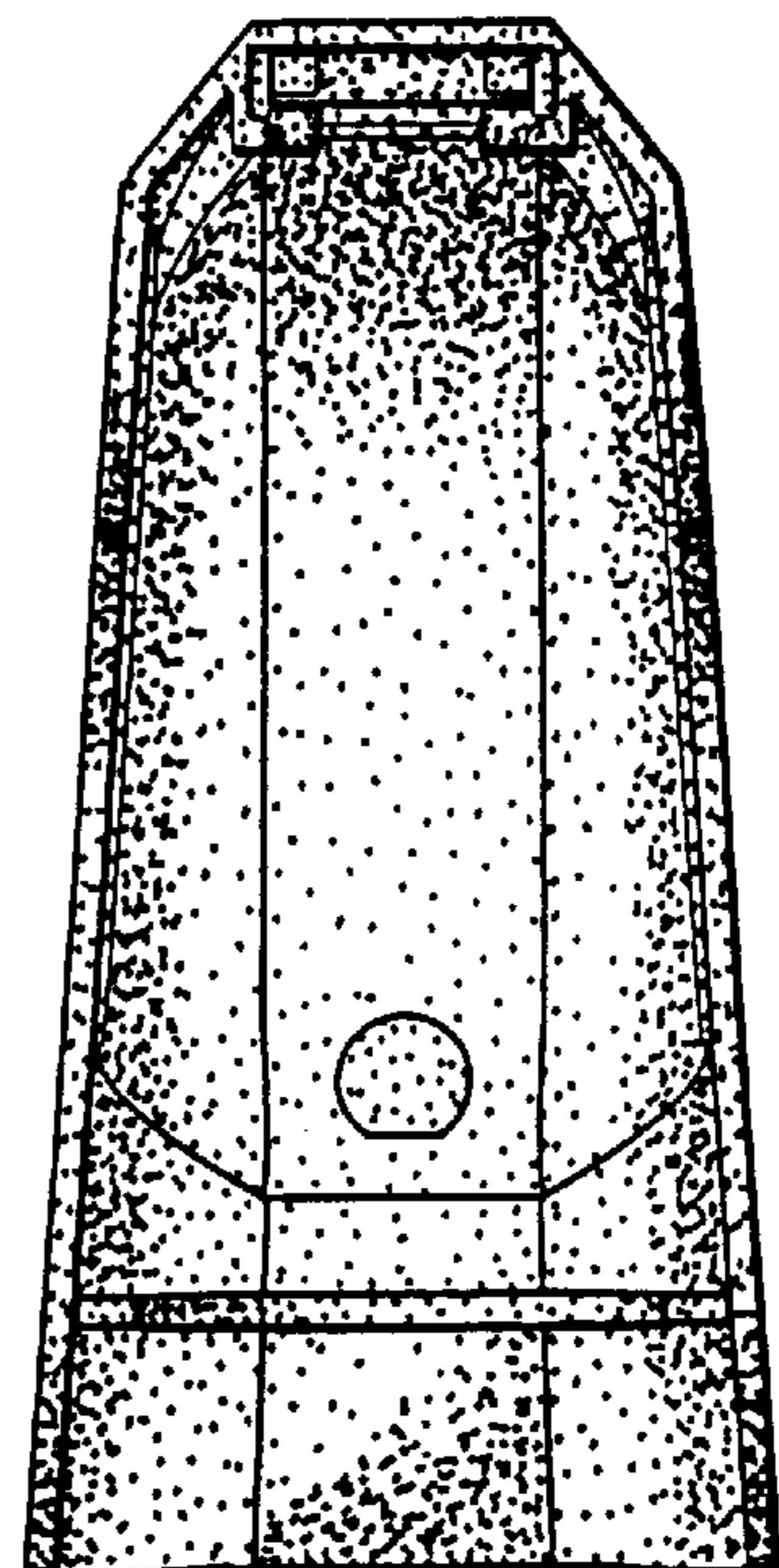

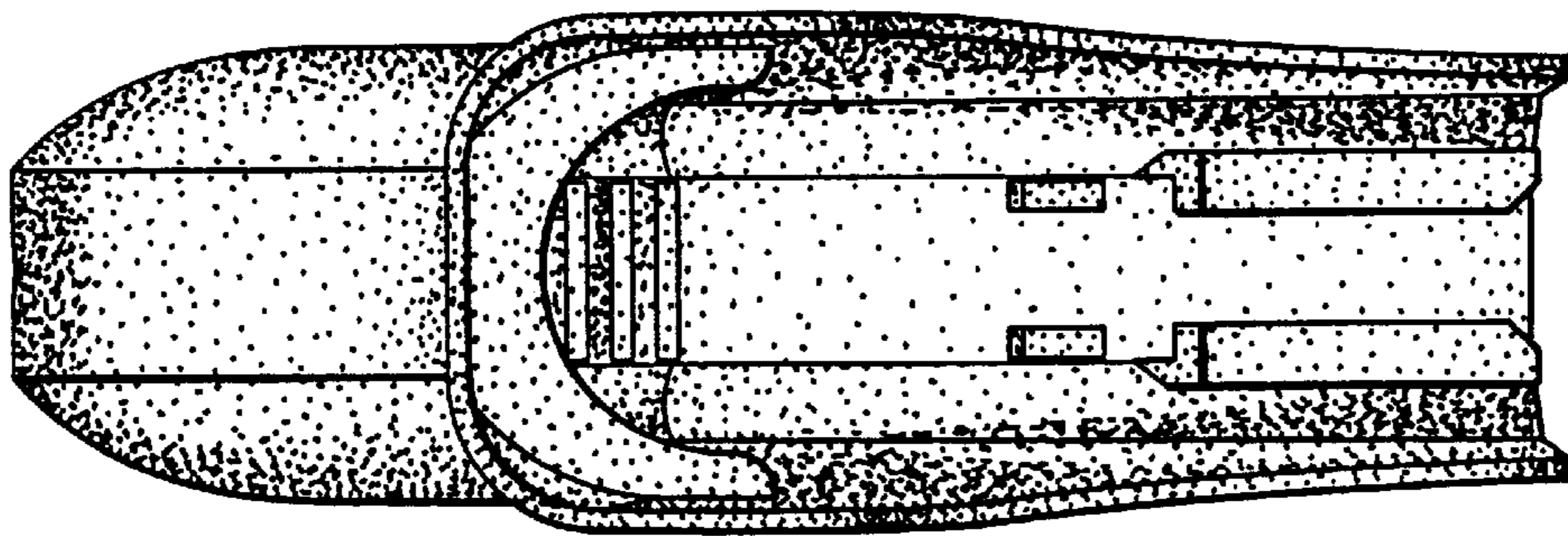

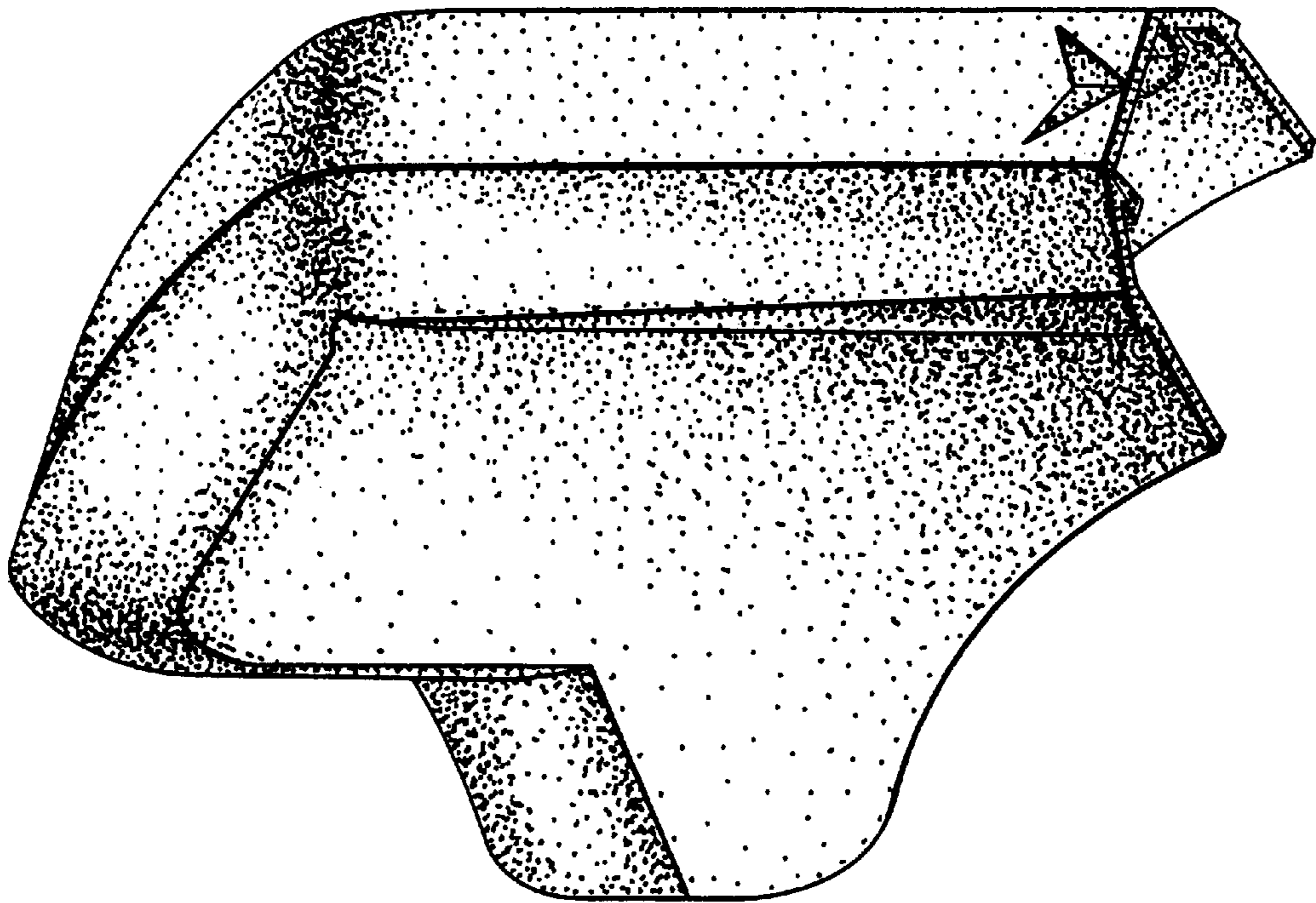

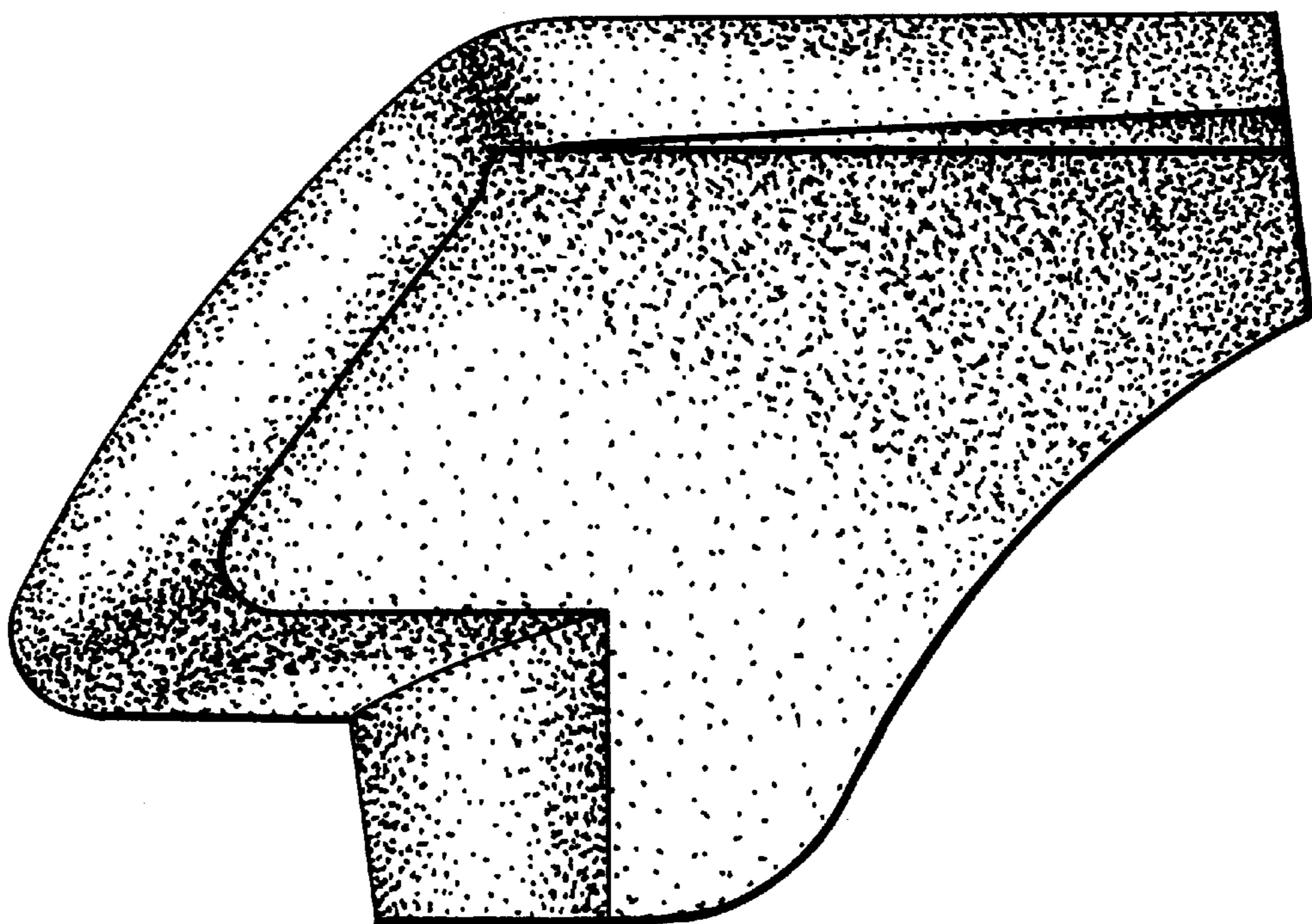

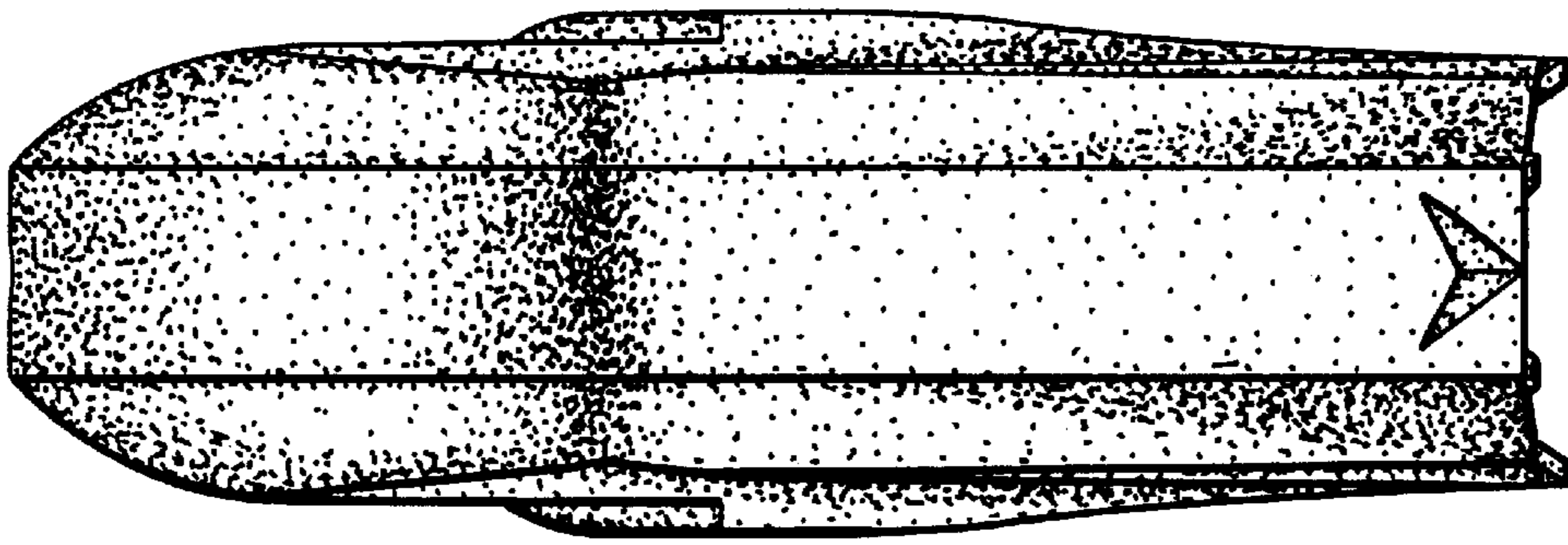

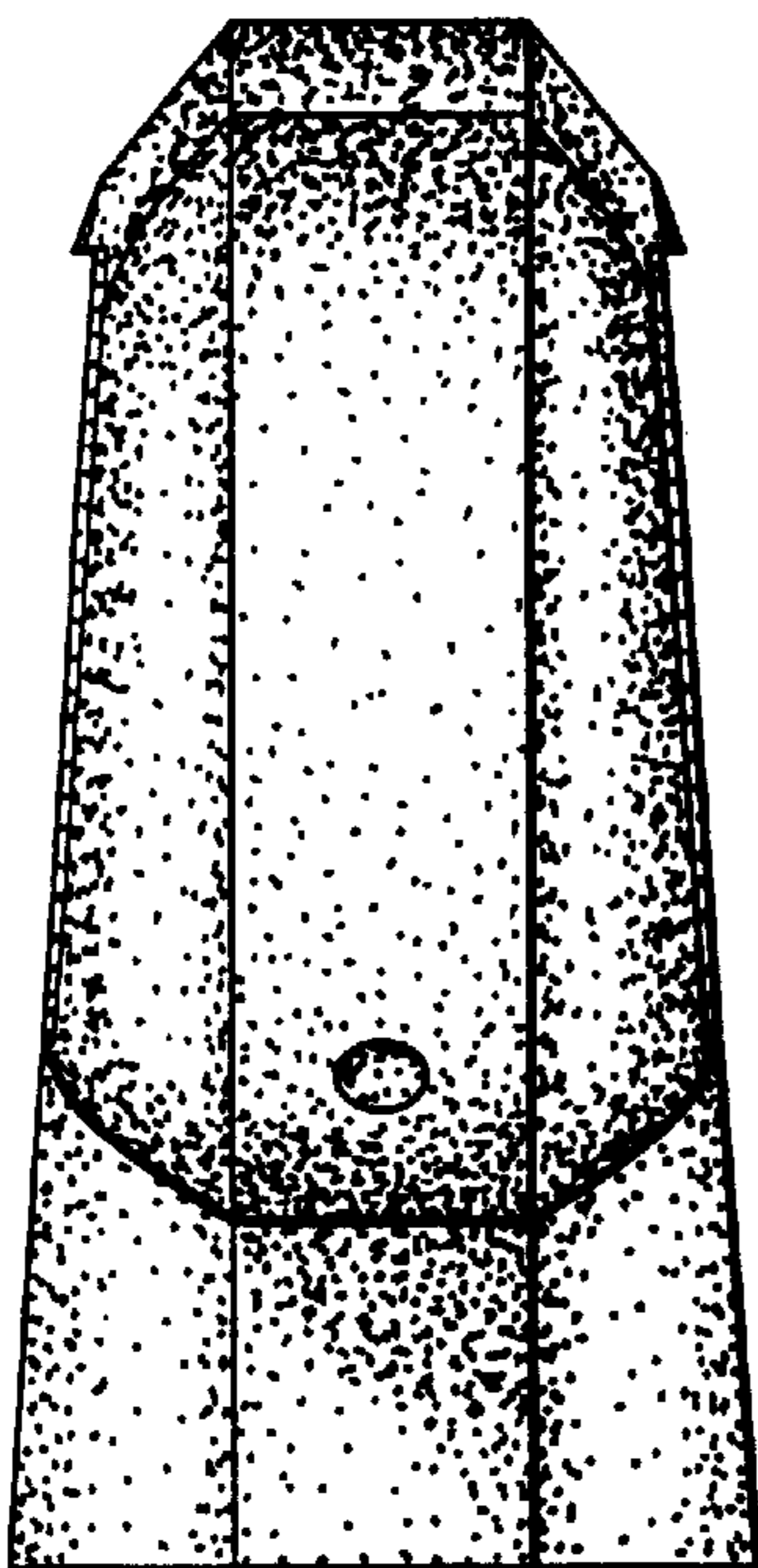

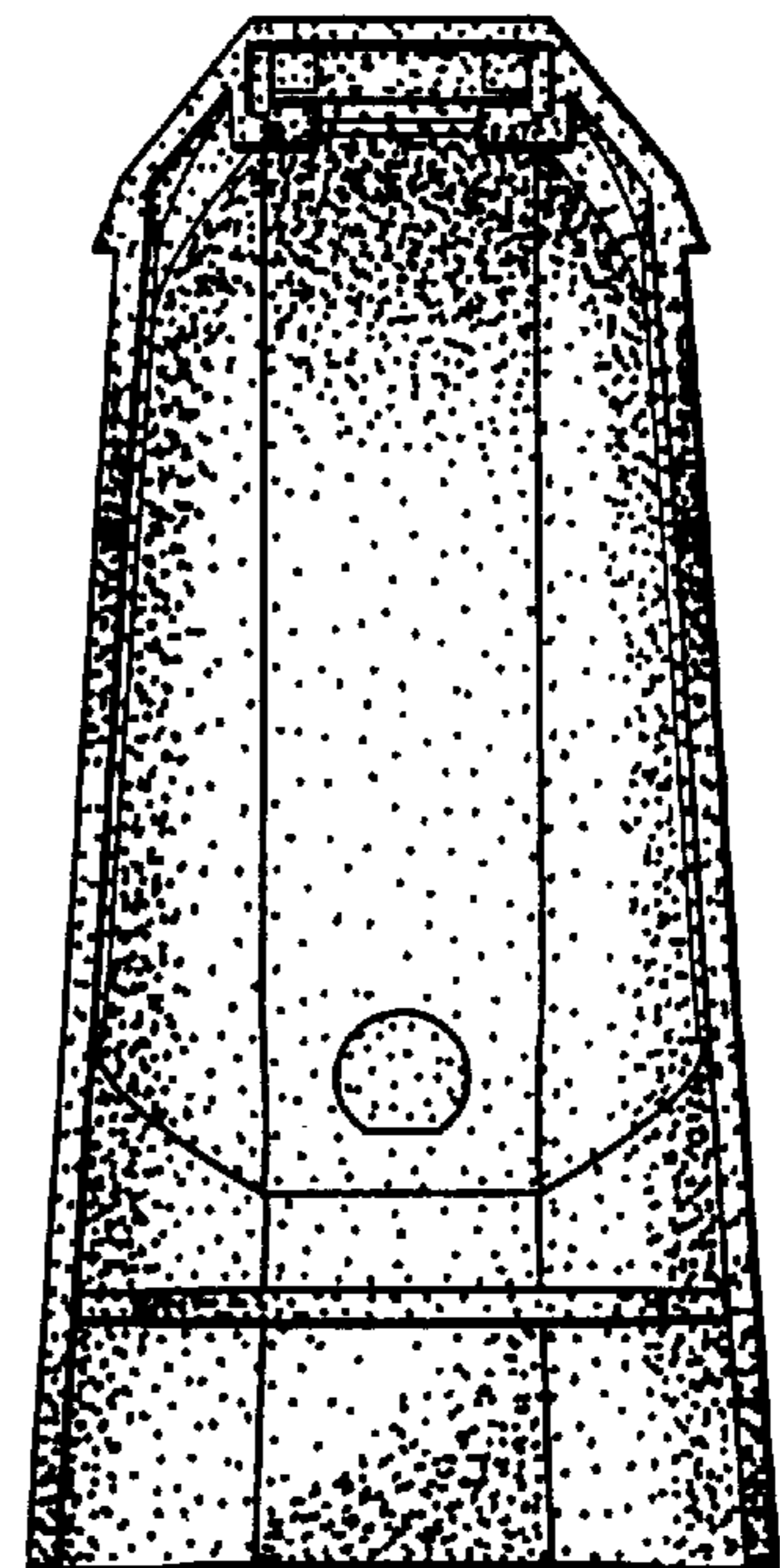

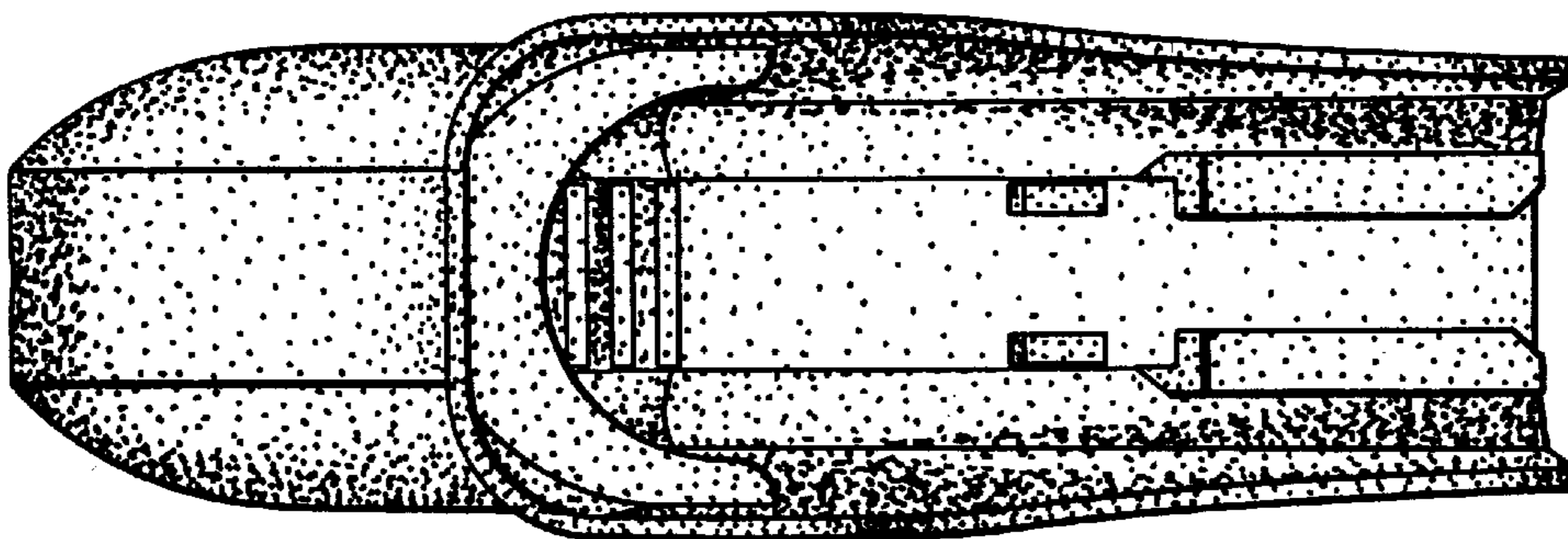
