FIG. 2 is a back view thereof, shown at an enlarged scale;

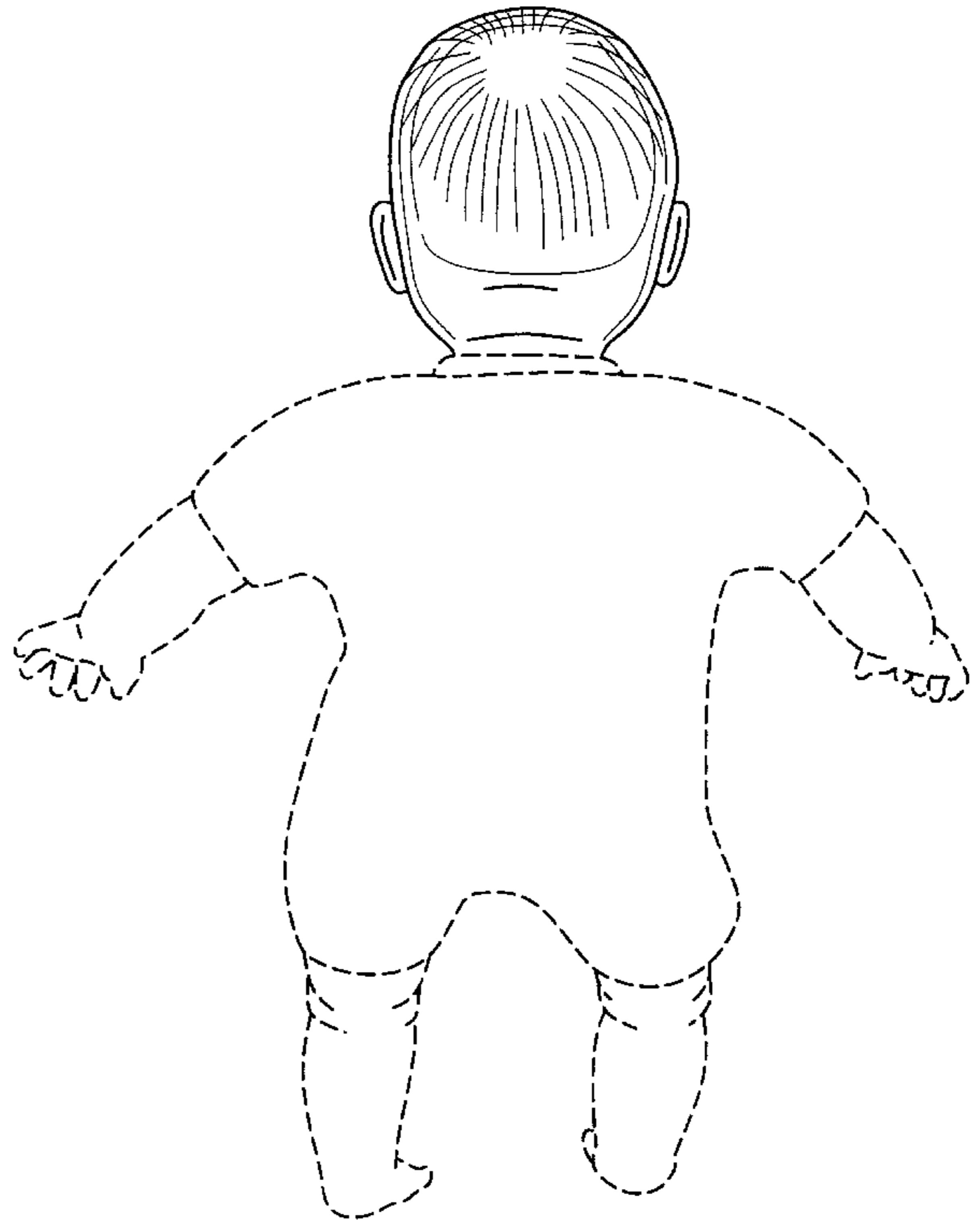
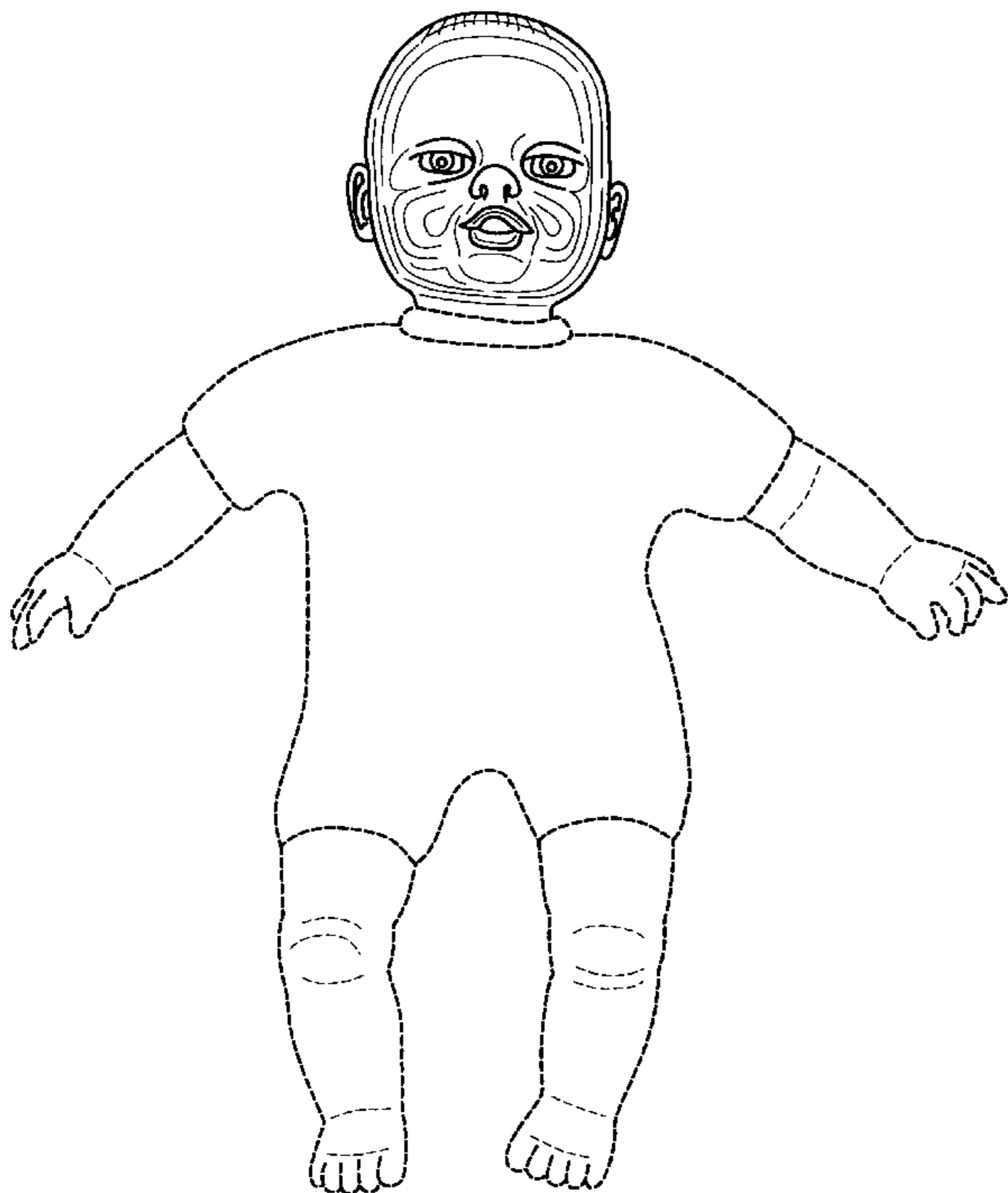
FIG. 3 is a top plan view thereof, shown at an enlarged scale;

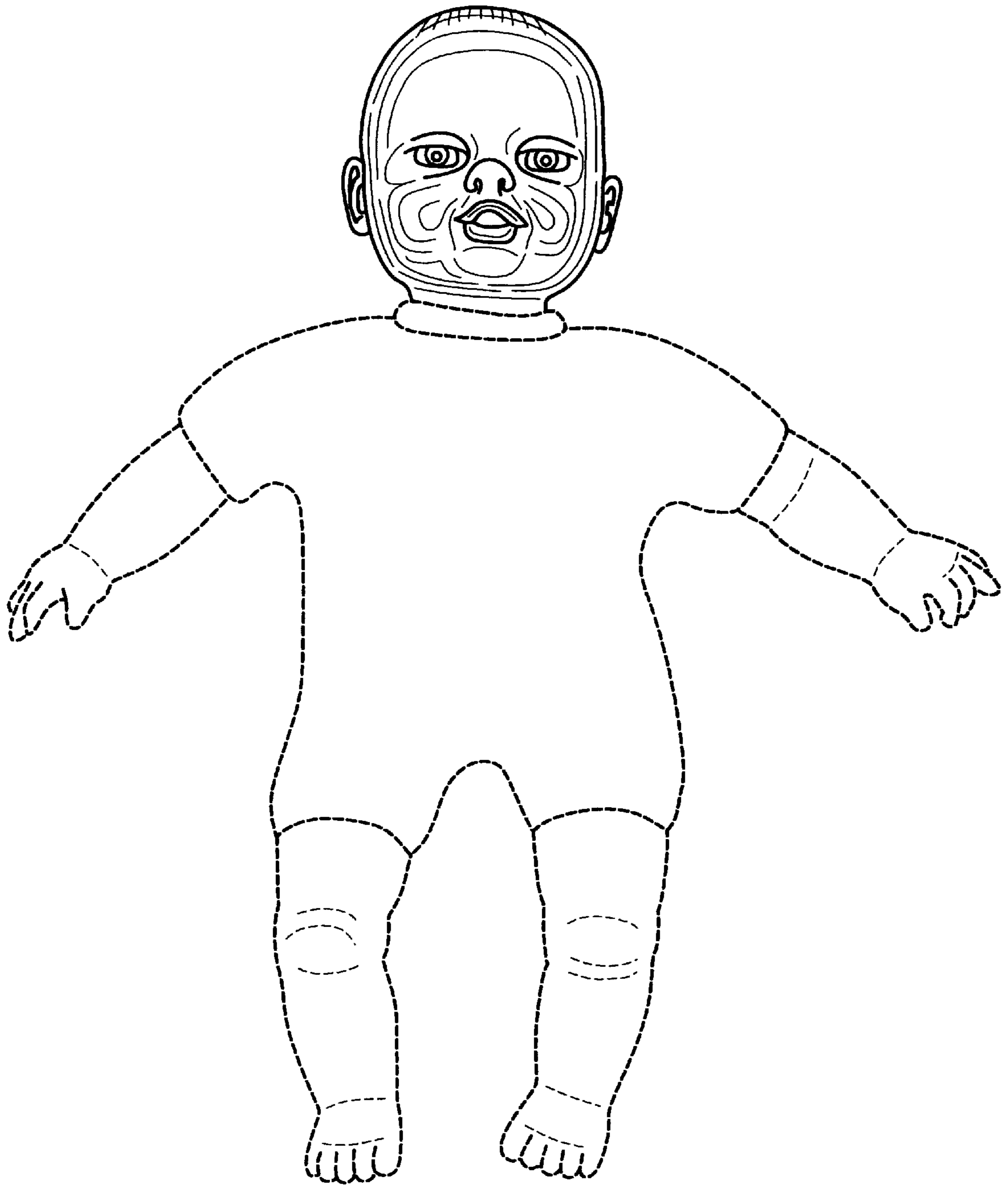

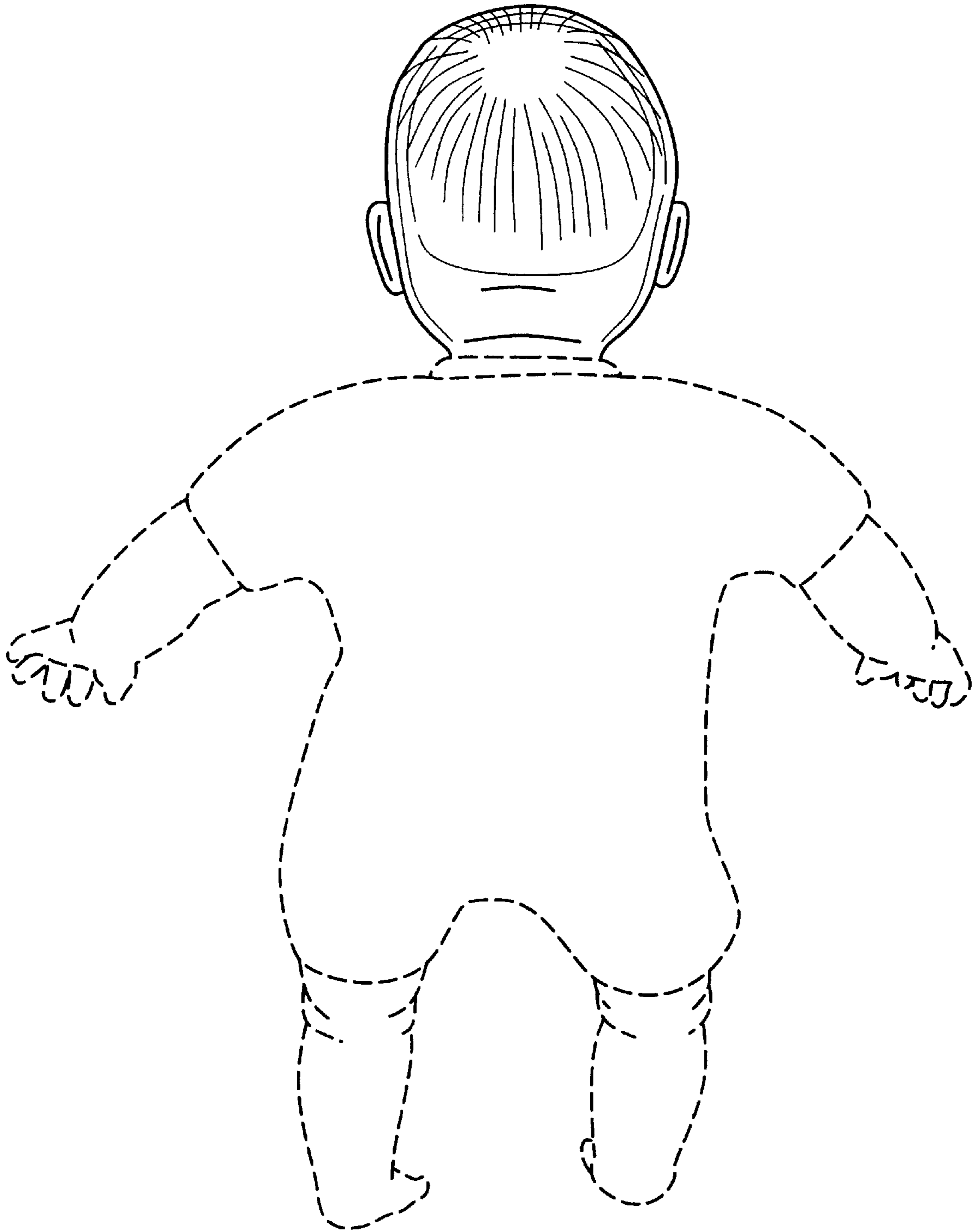

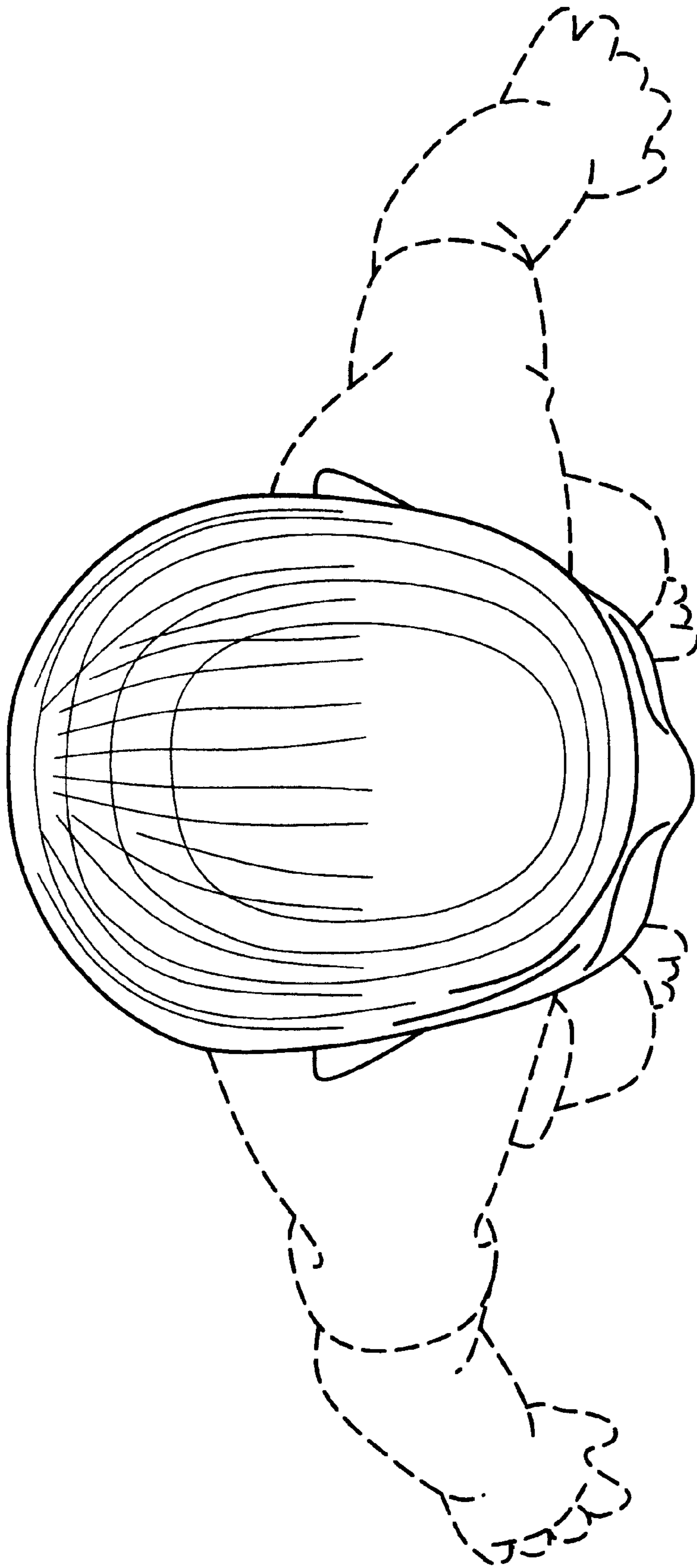

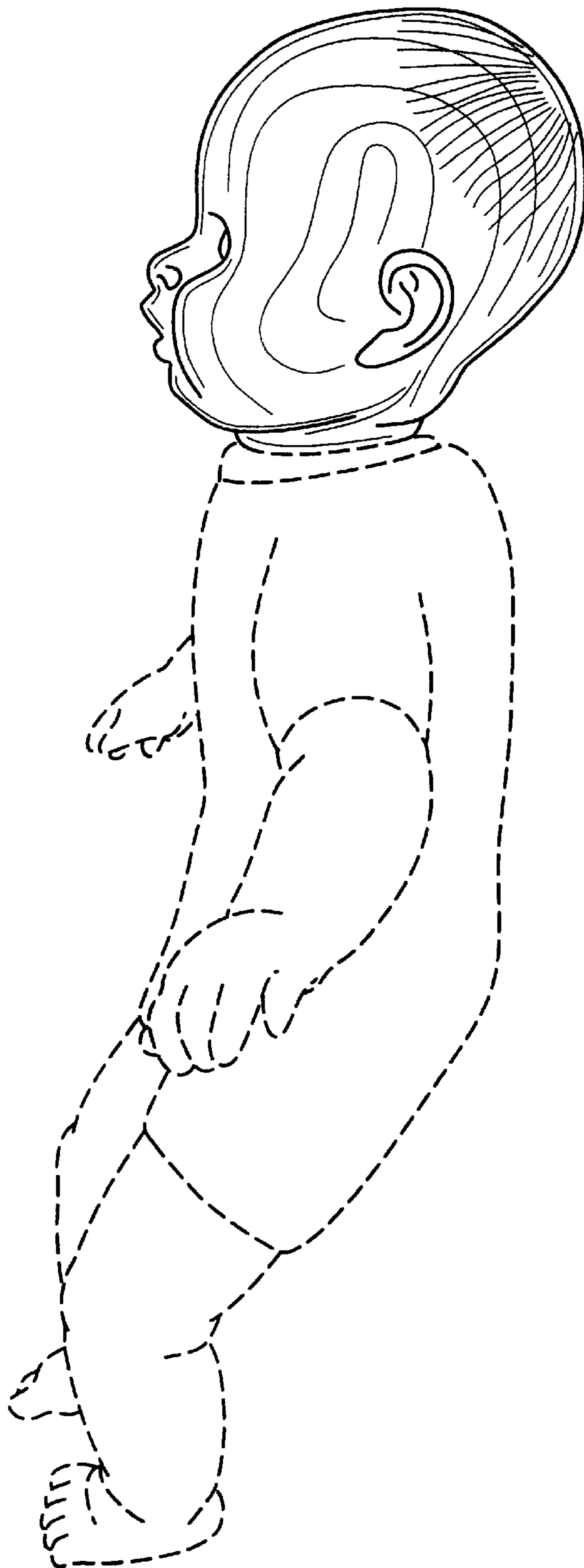

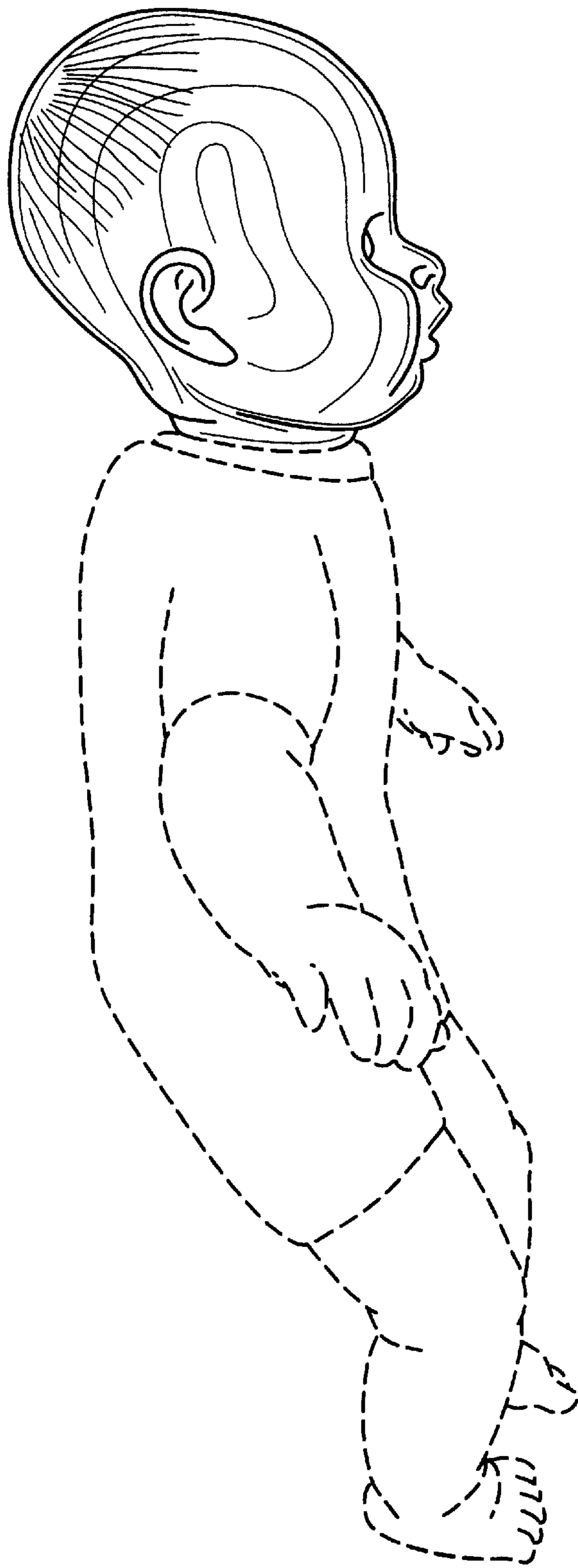
