(57) **CLAIM**

The ornamental design for a post lighting fixture, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, left side perspective view of a post lighting fixture showing my new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a bottom plan view thereof;

FIG. 4 is a front elevational view thereof;

FIG. 5 is a rear elevational view thereof, the left elevational view and the right elevational view being identical to the rear elevational view;

FIG. 6 is a front, left side perspective view of a first alternative embodiment of my new design;

FIG. 7 is a front elevational view of the first alternative embodiment of my new design;

FIG. 8 is a rear elevational view of the first alternative embodiment of my new design, the left elevational view and the right elevational view being identical to the rear elevational view, the top plan view being identical to FIG. 2, and the bottom plan view being identical to FIG. 3;

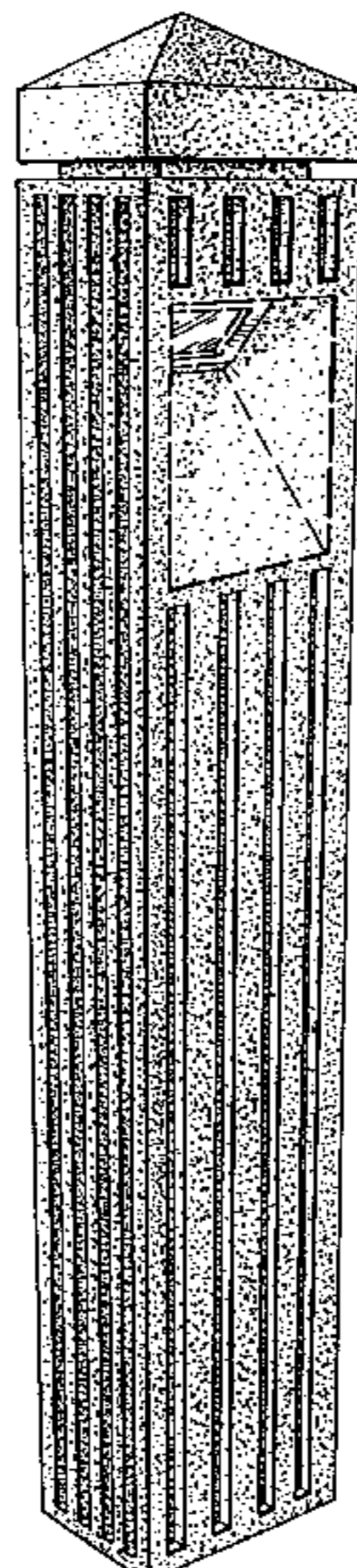
FIG. 9 is front, left side perspective view of a second alternative embodiment of my new design;

FIG. 10 is a front elevational view of the second alternative embodiment of my new design; and,

FIG. 11 is rear elevational view of the second alternative embodiment of my new design, the left elevational view and the right elevational view being identical to FIG. 5, the top plan view being identical to FIG. 2, and the bottom plan view being identical to FIG. 3.

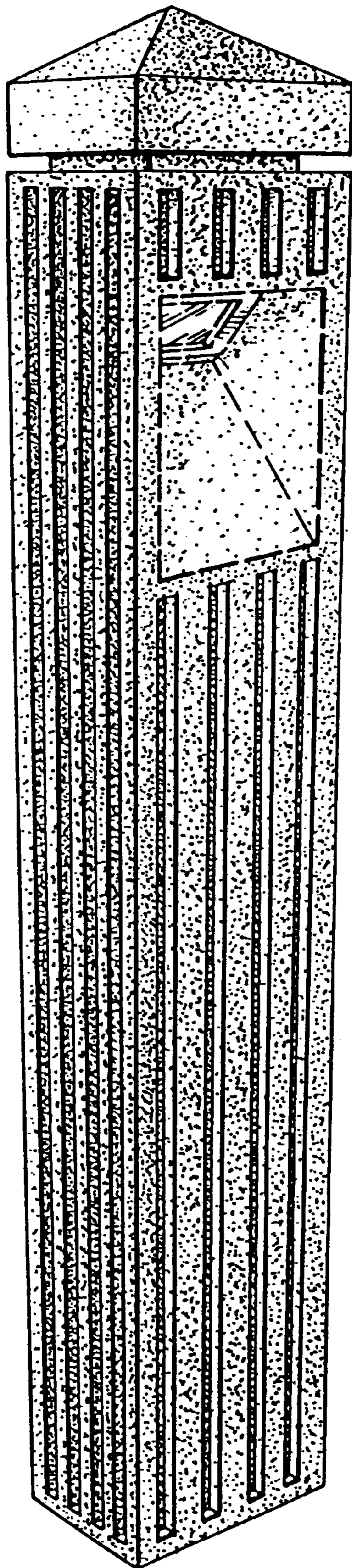

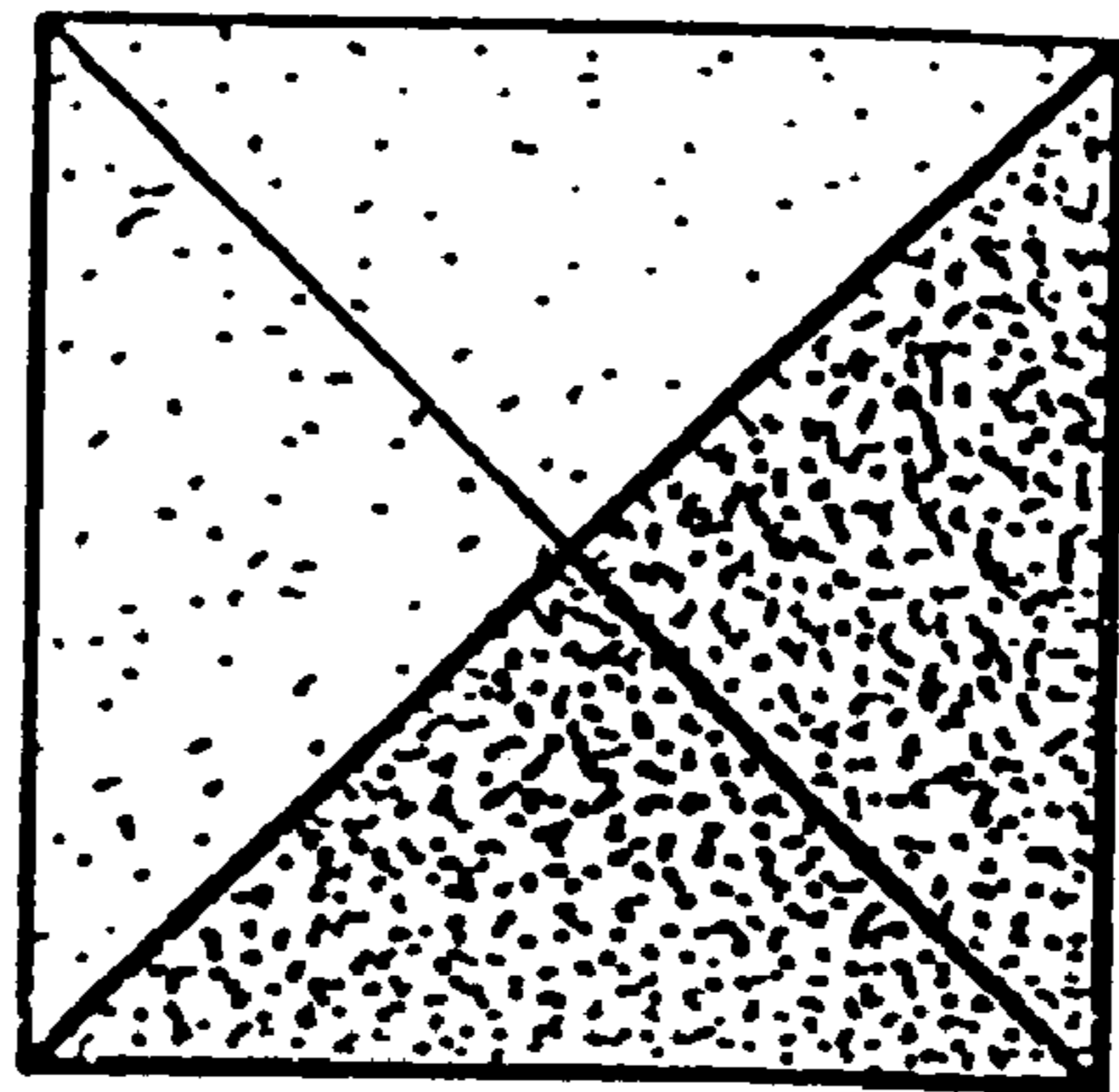

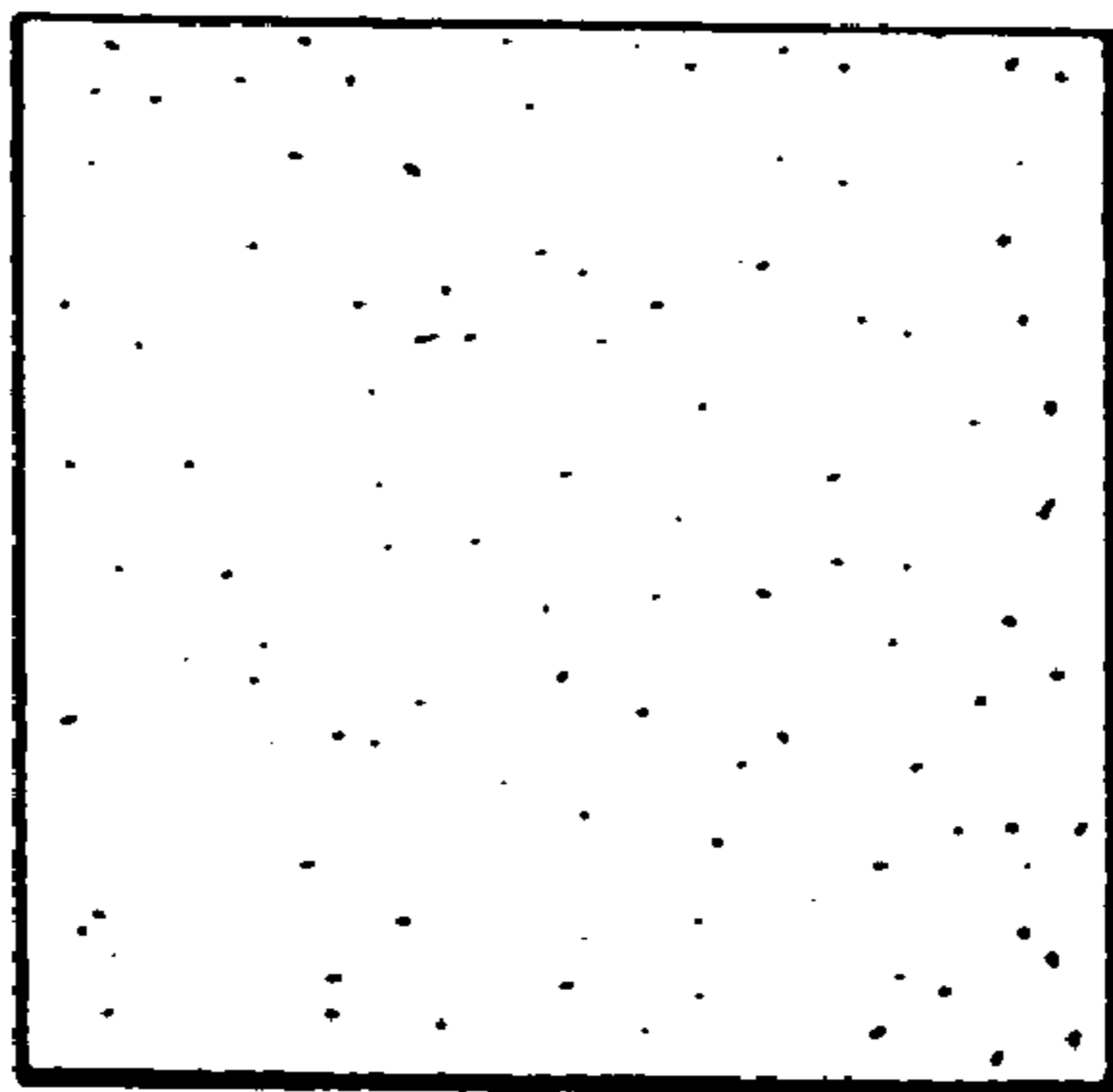

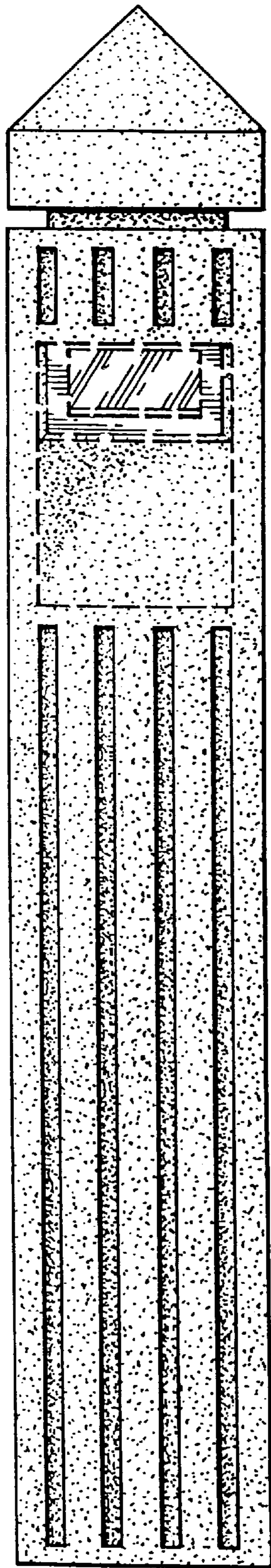

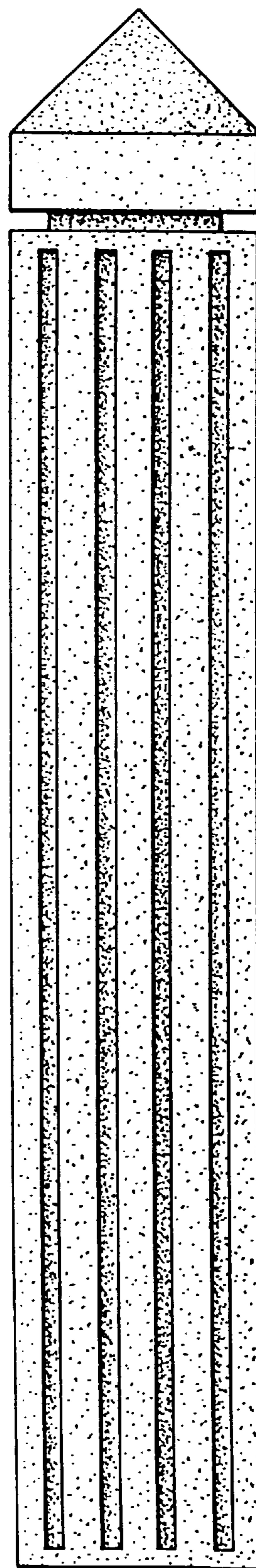

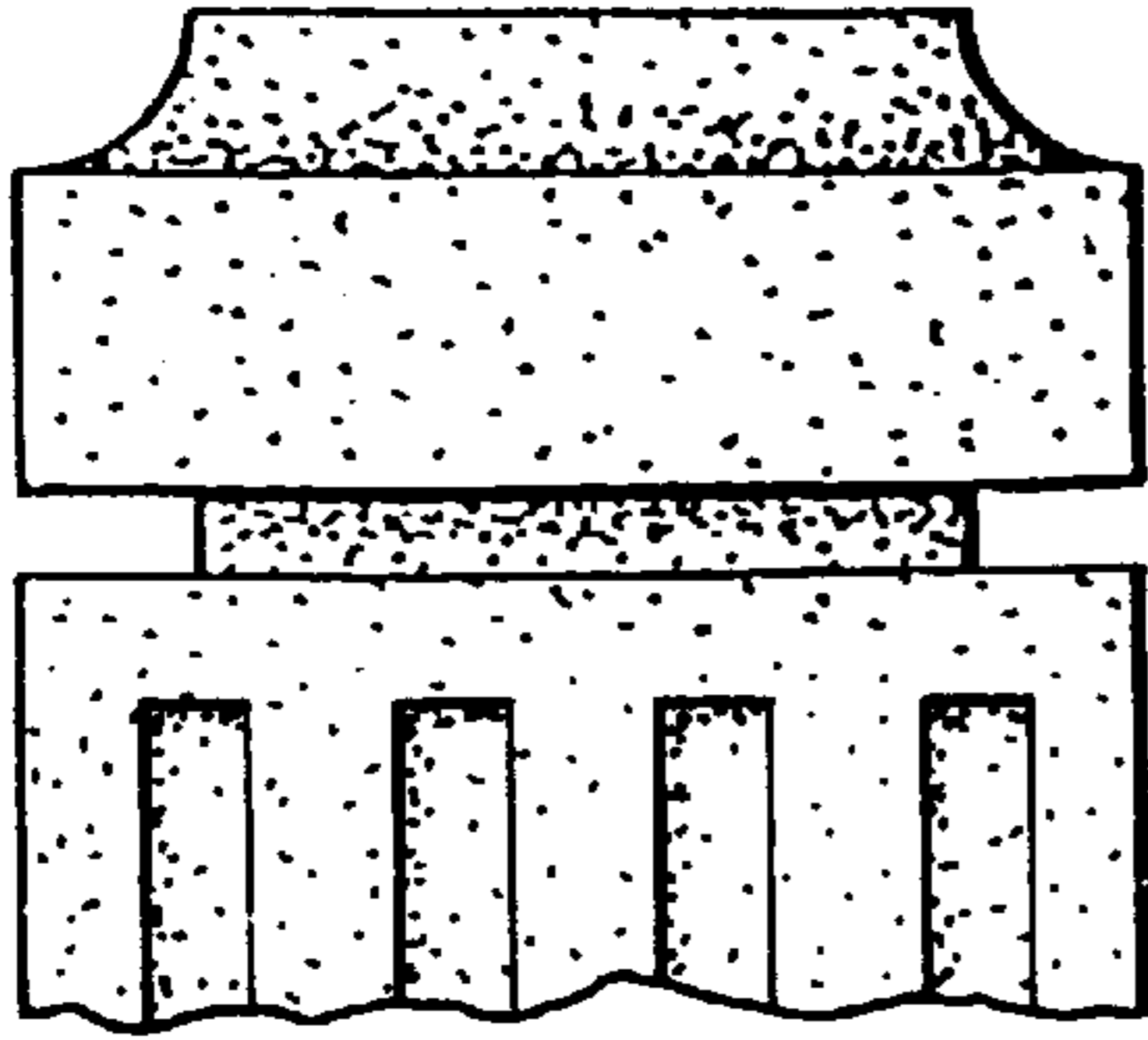

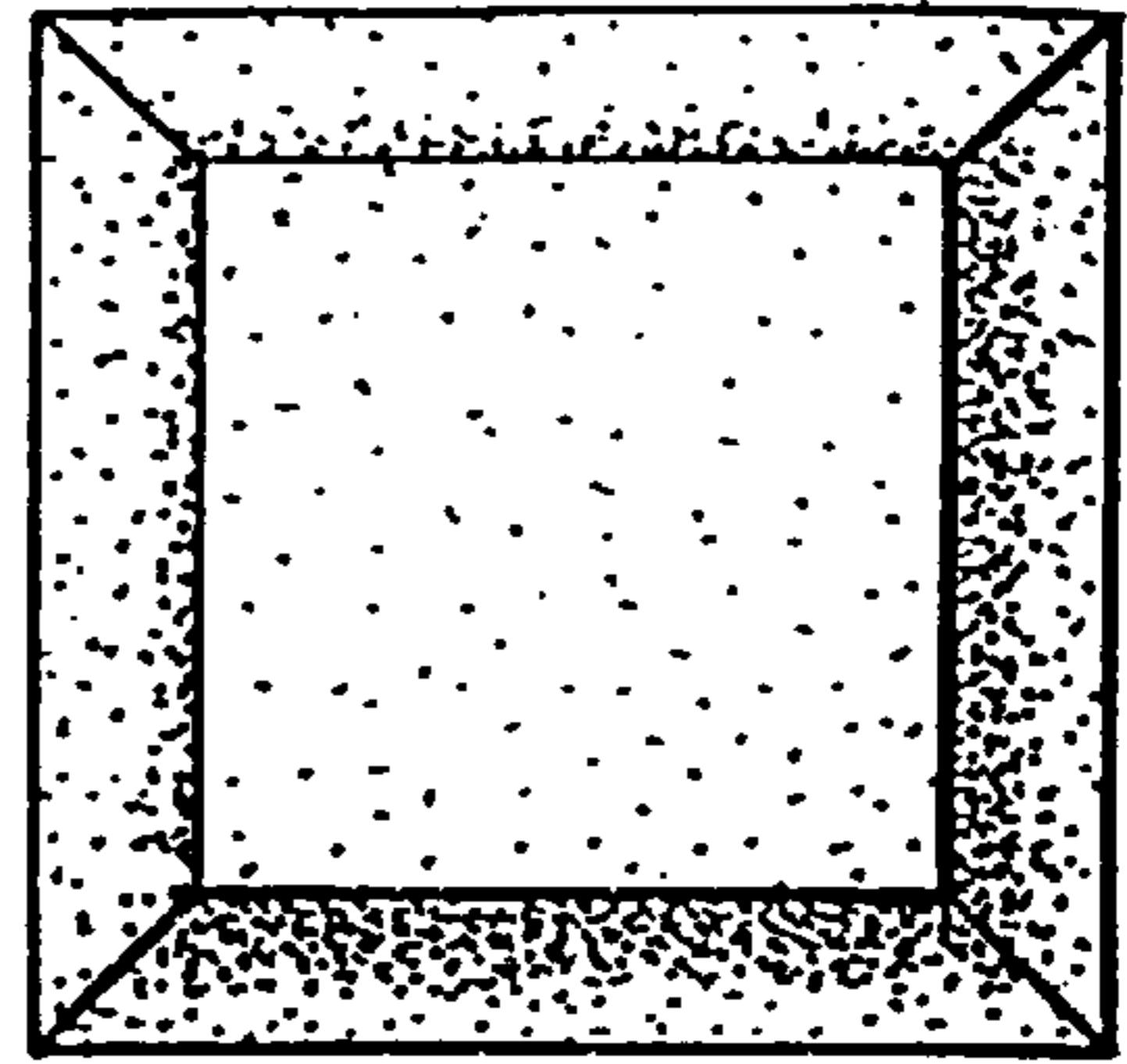

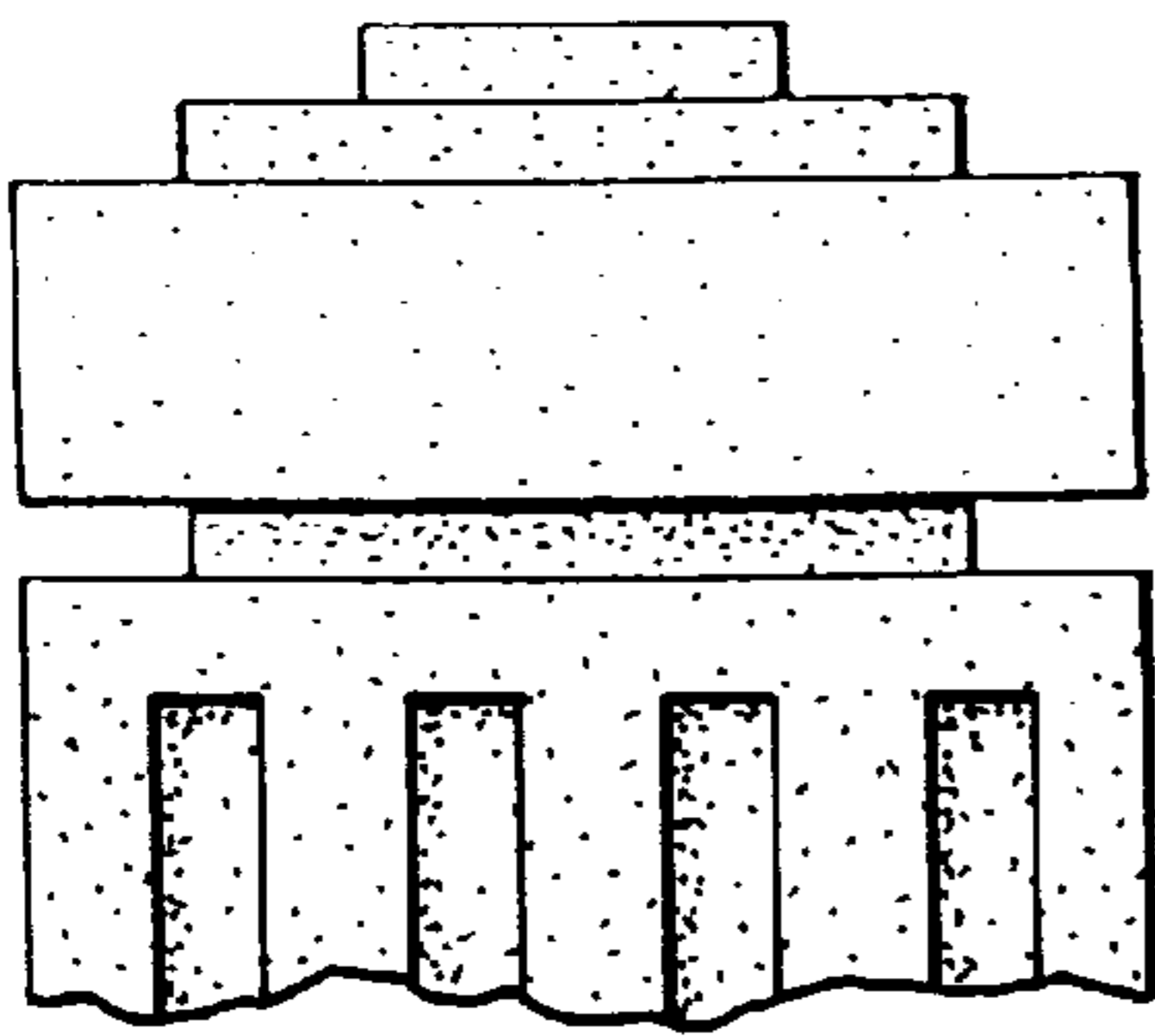

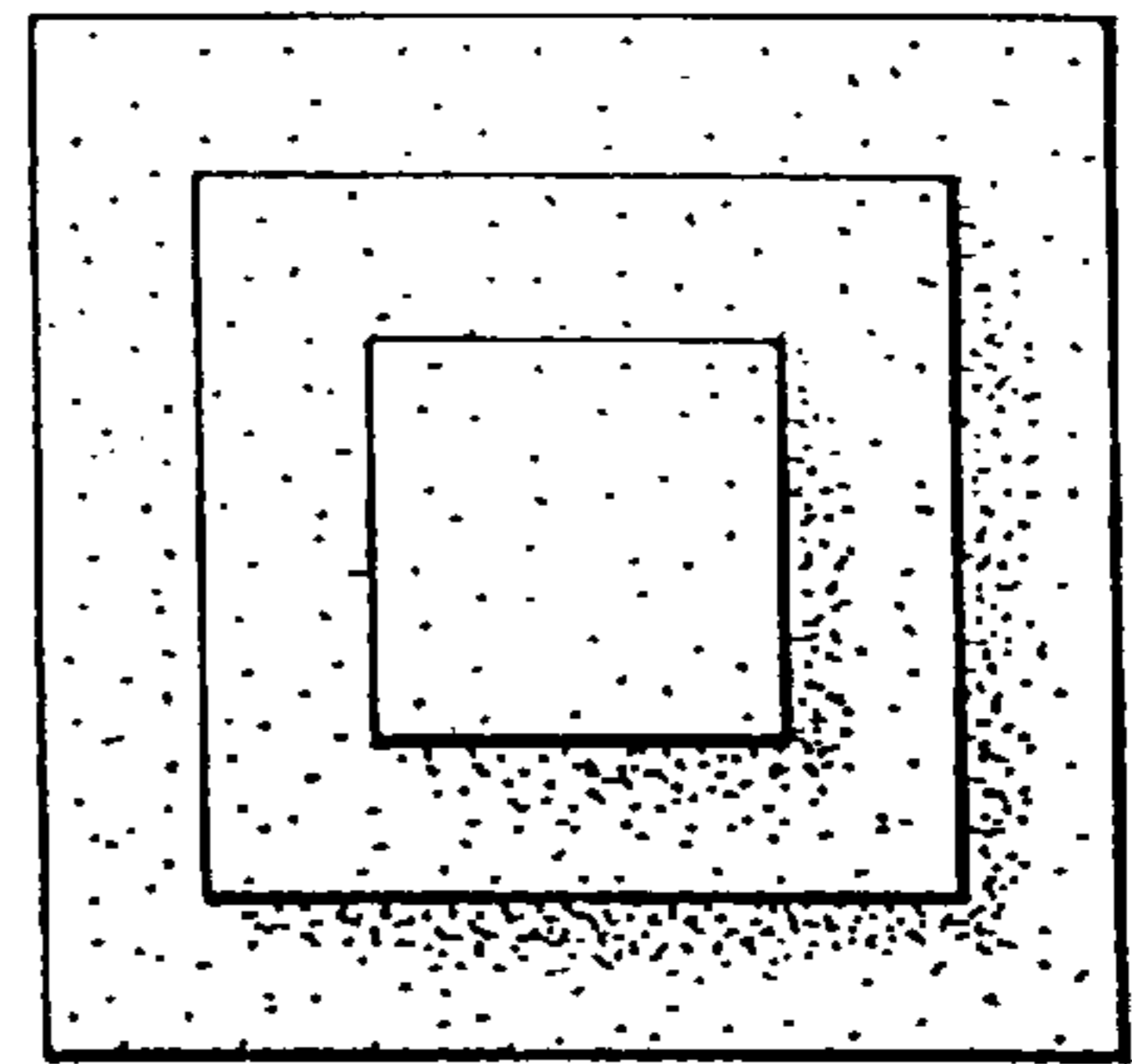

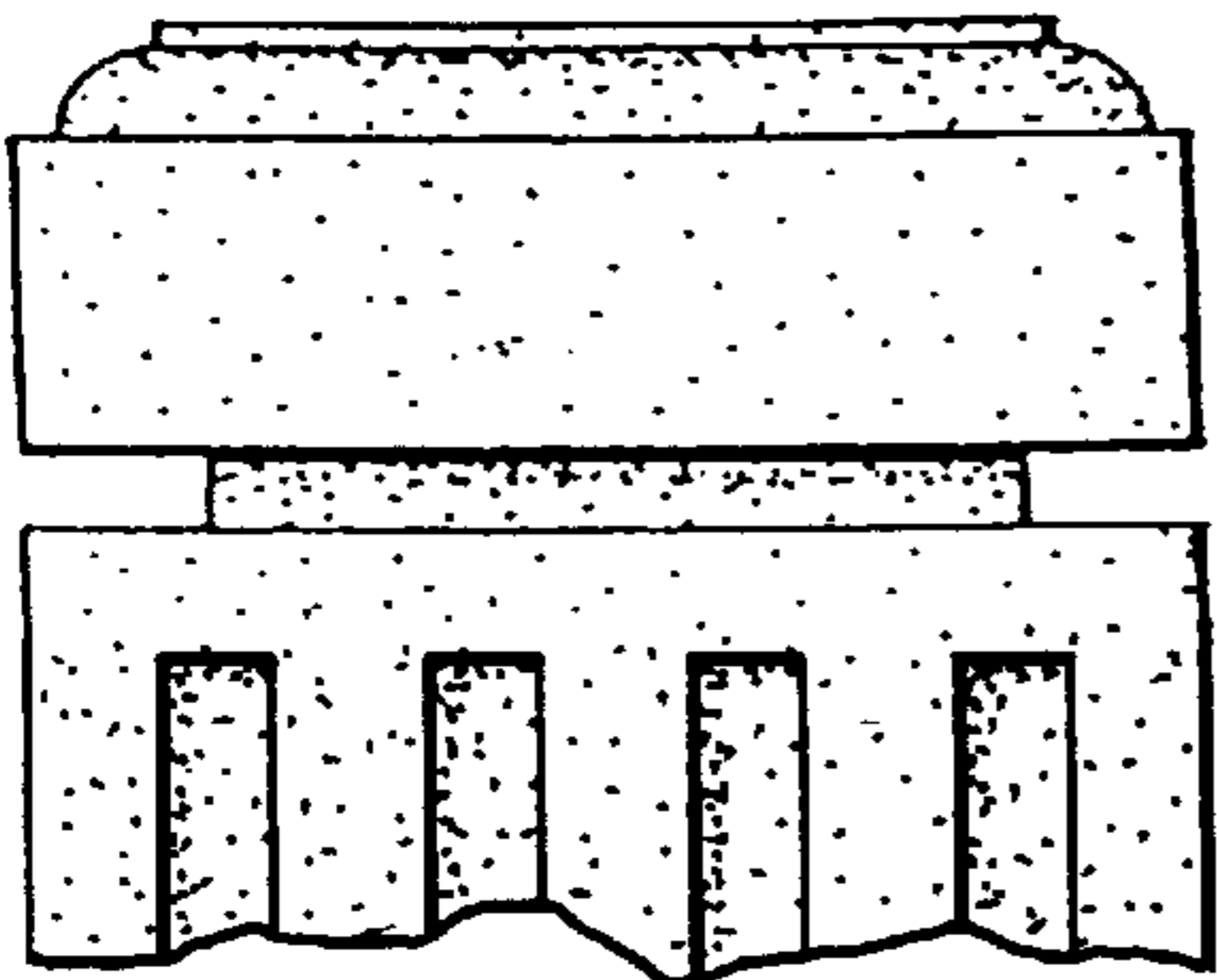

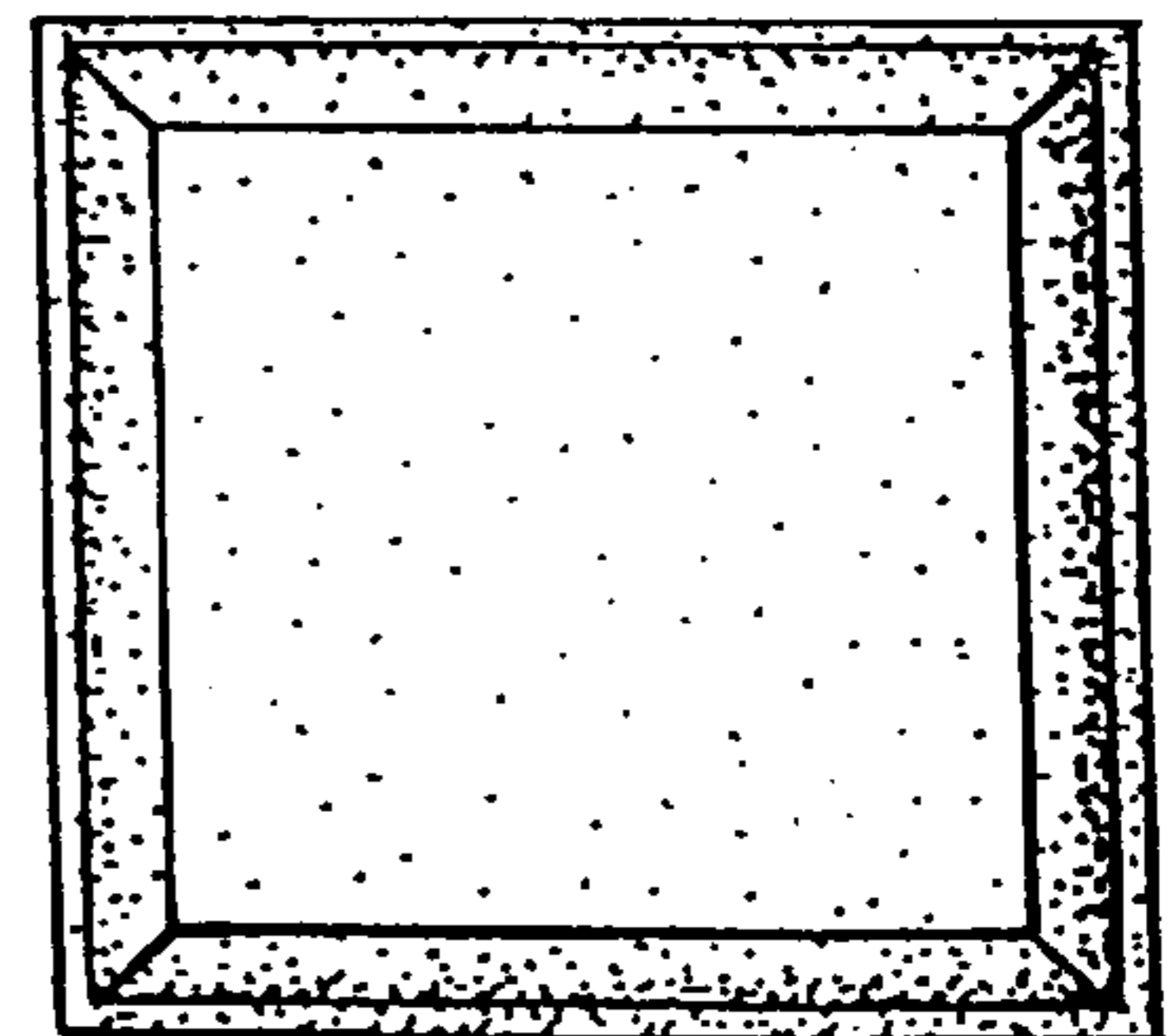
