FIG. 1 is a perspective view of a detergent tablet showing the new design;

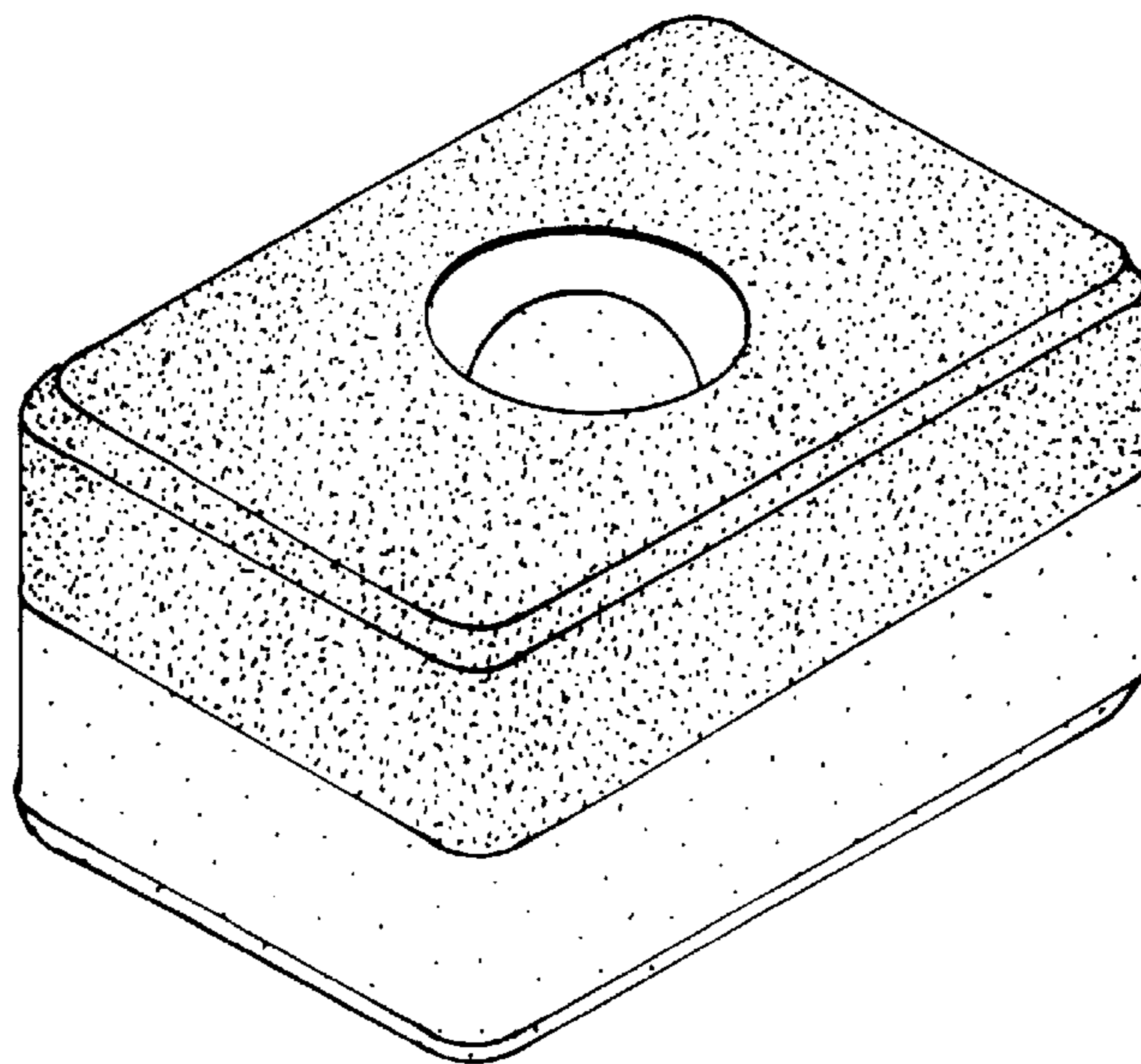
FIG. 2 is an end view thereof both sides appearing the same; FIG. 3 is a side view thereof both sides appearing the same; and,

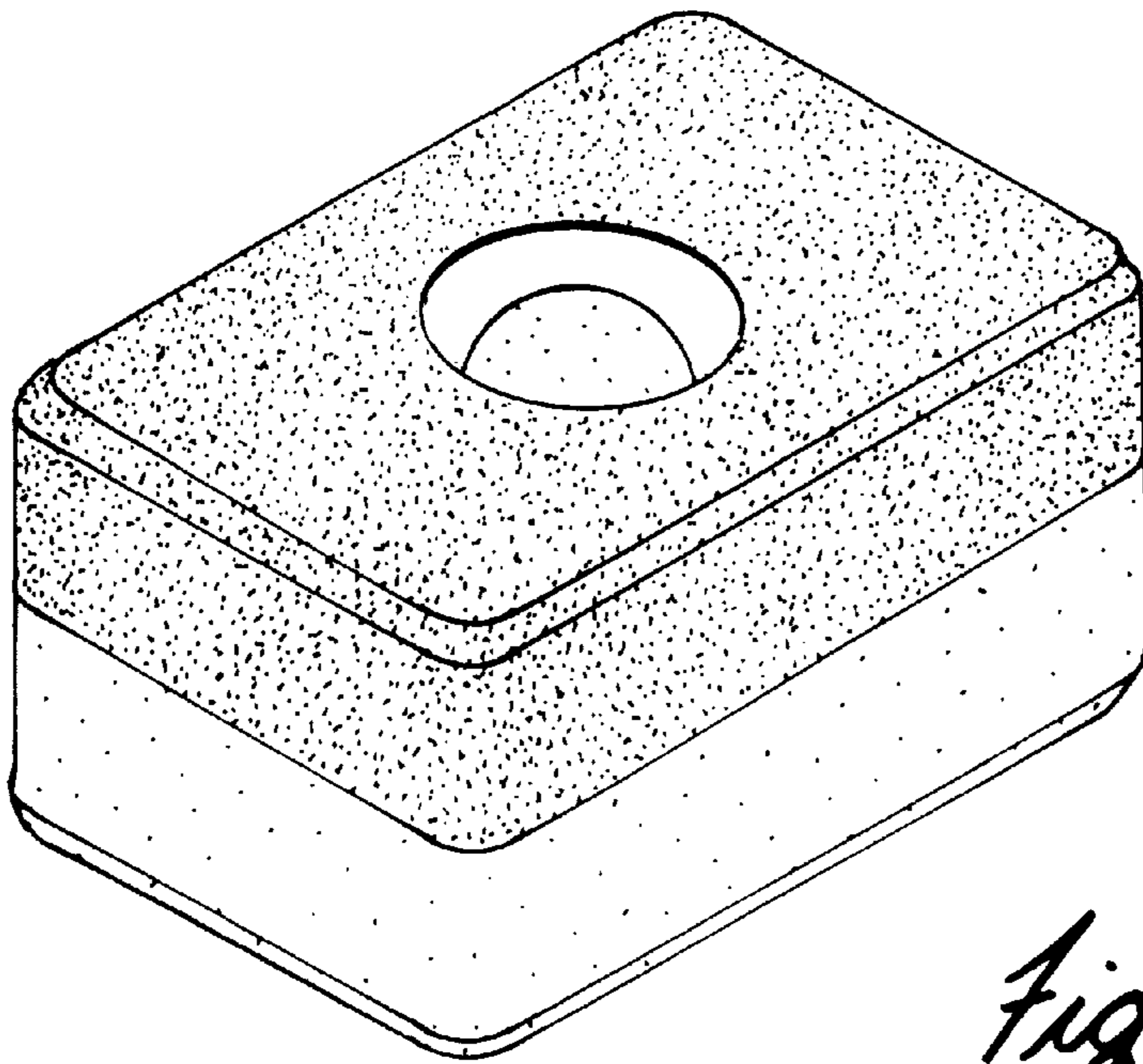
FIG. 4 is a top plan view.

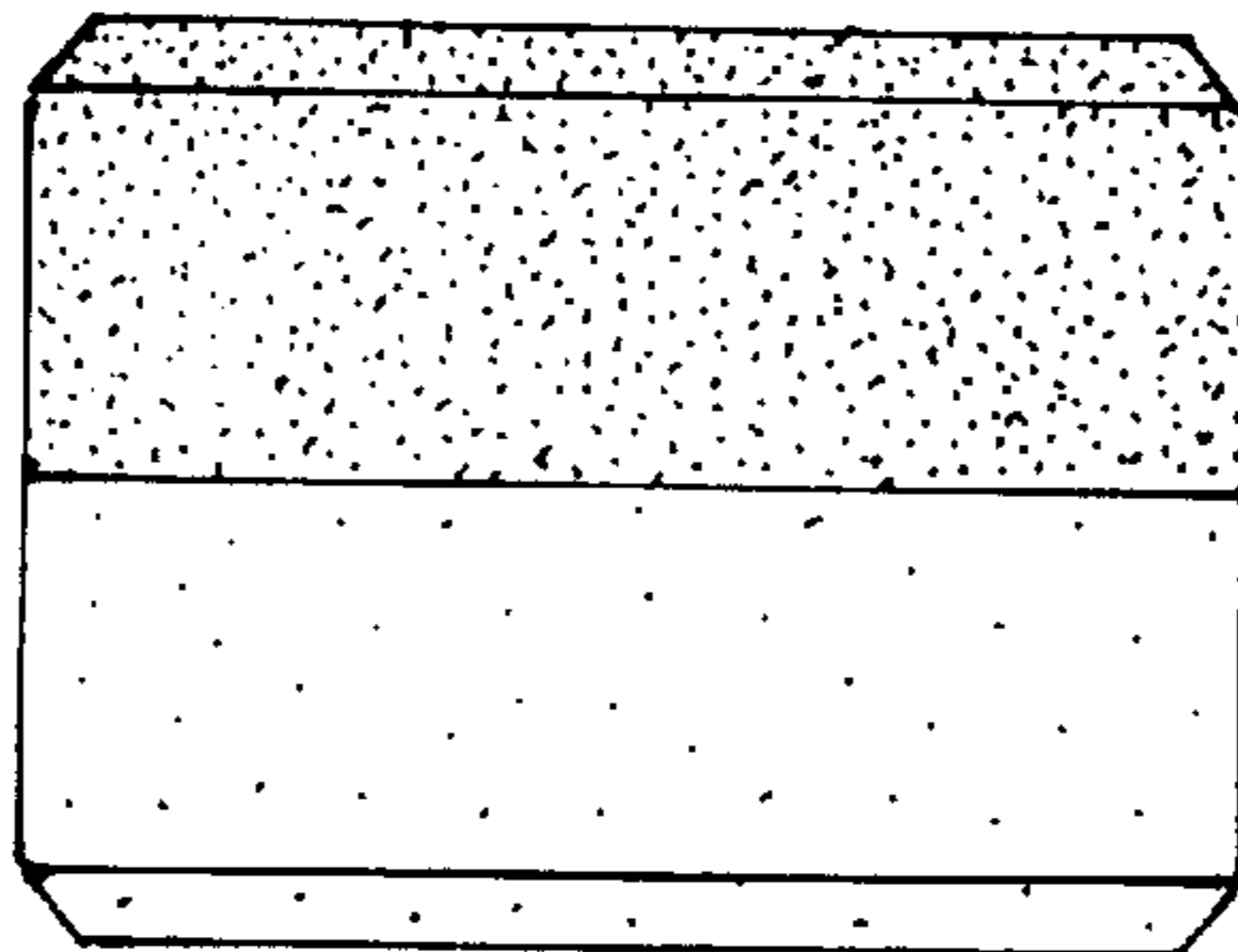
The unshaded area in FIGS. 1 and 4 forms no part of the claimed design.

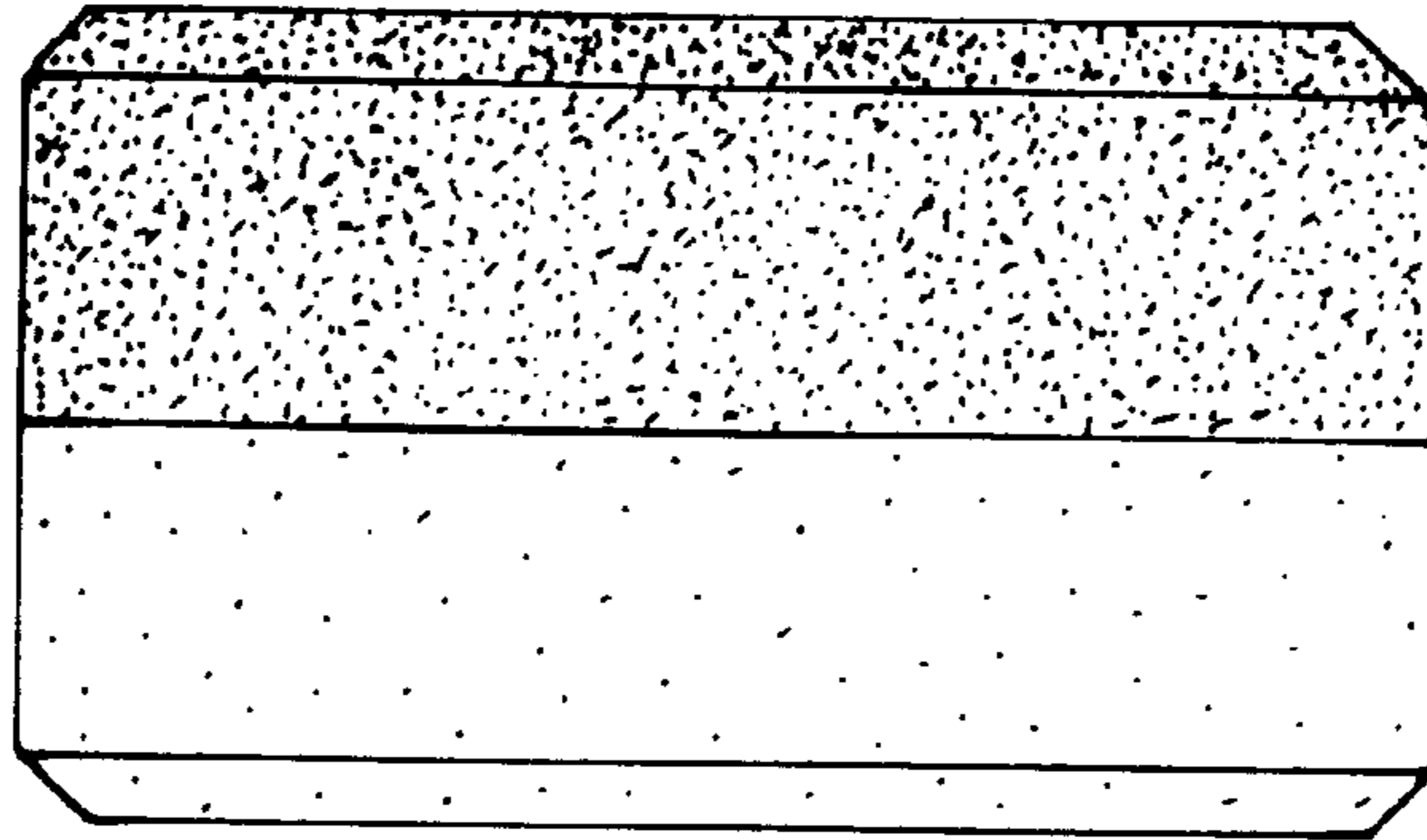




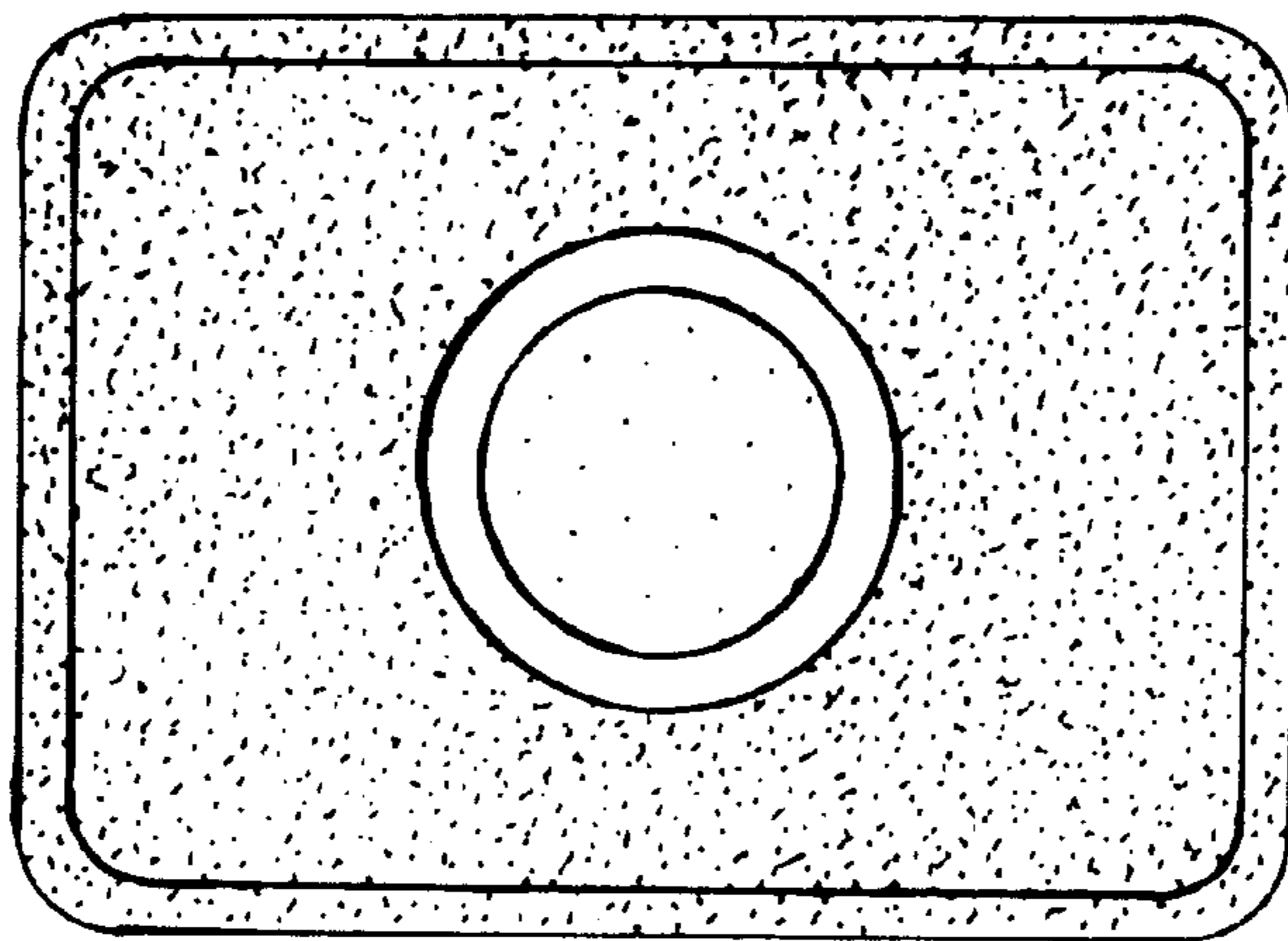
