(57) **CLAIM**

An ornamental design for a key chain pill carrier, as shown in the drawings and described in the specifications.

DESCRIPTION

FIG. 1 is a top view of the key chain pill carrier showing our new design;

FIG. 2 is a side view of the key chain pill carrier illustrating the new design;

FIG. 3 is a front view of the key chain pill carrier;

FIG. 4 is a rear view of the key chain pill carrier;

FIG. 5 is an opposite side view from the side view shown in FIG. 2 and illustrating the key chain pill carrier;

FIG. 6 is a bottom view of the key chain pill carrier; and,

FIG. 7 is a perspective view of the key chain pill carrier.

The term “aspirin pill pack”, the “TM” symbol and the “arrow” shown in raised dashed lines in FIGS. 1, 2, 3, 5, 6 and 7 are shown for descriptive purposes only and form no part of the invention.

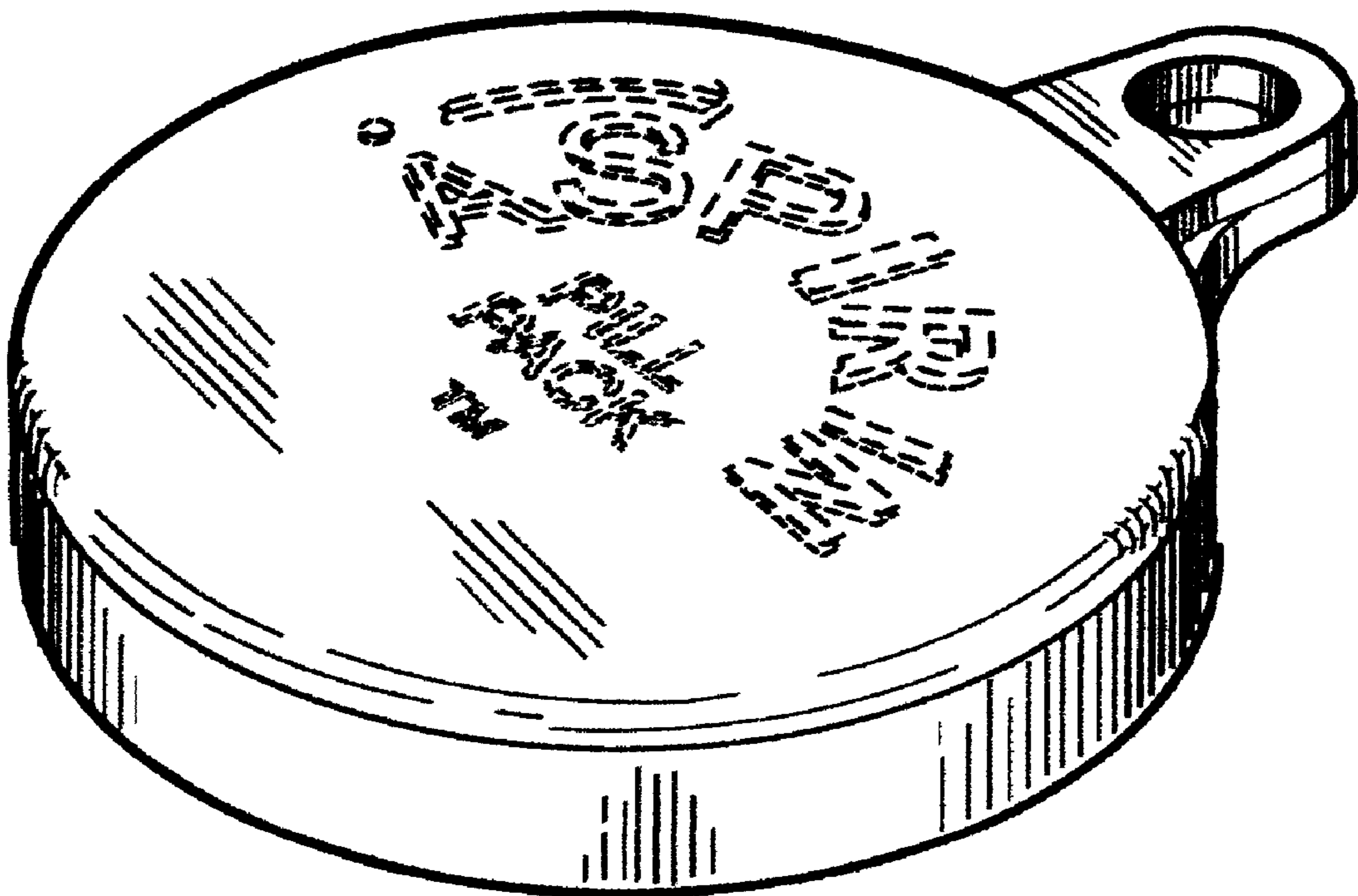

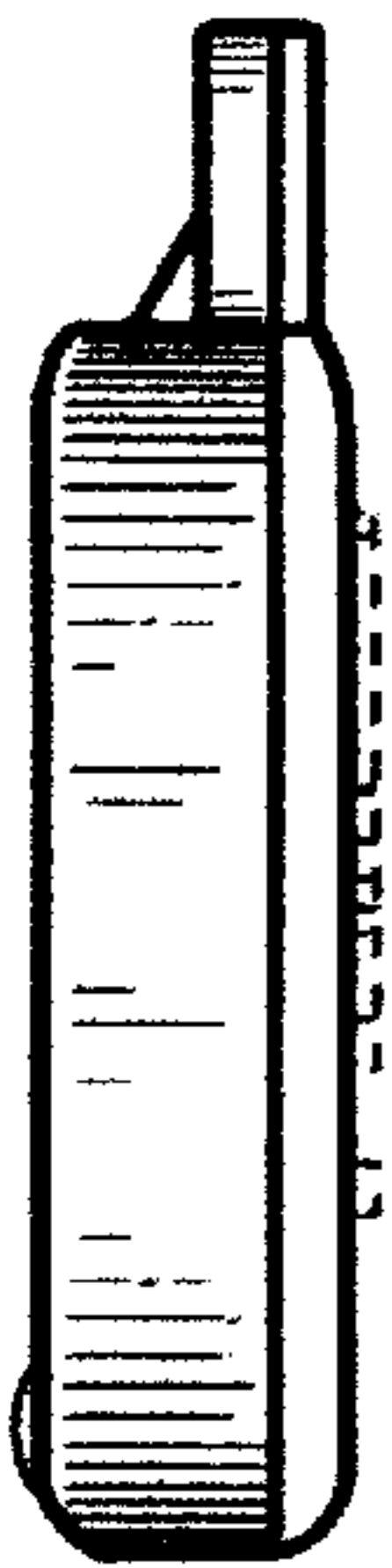

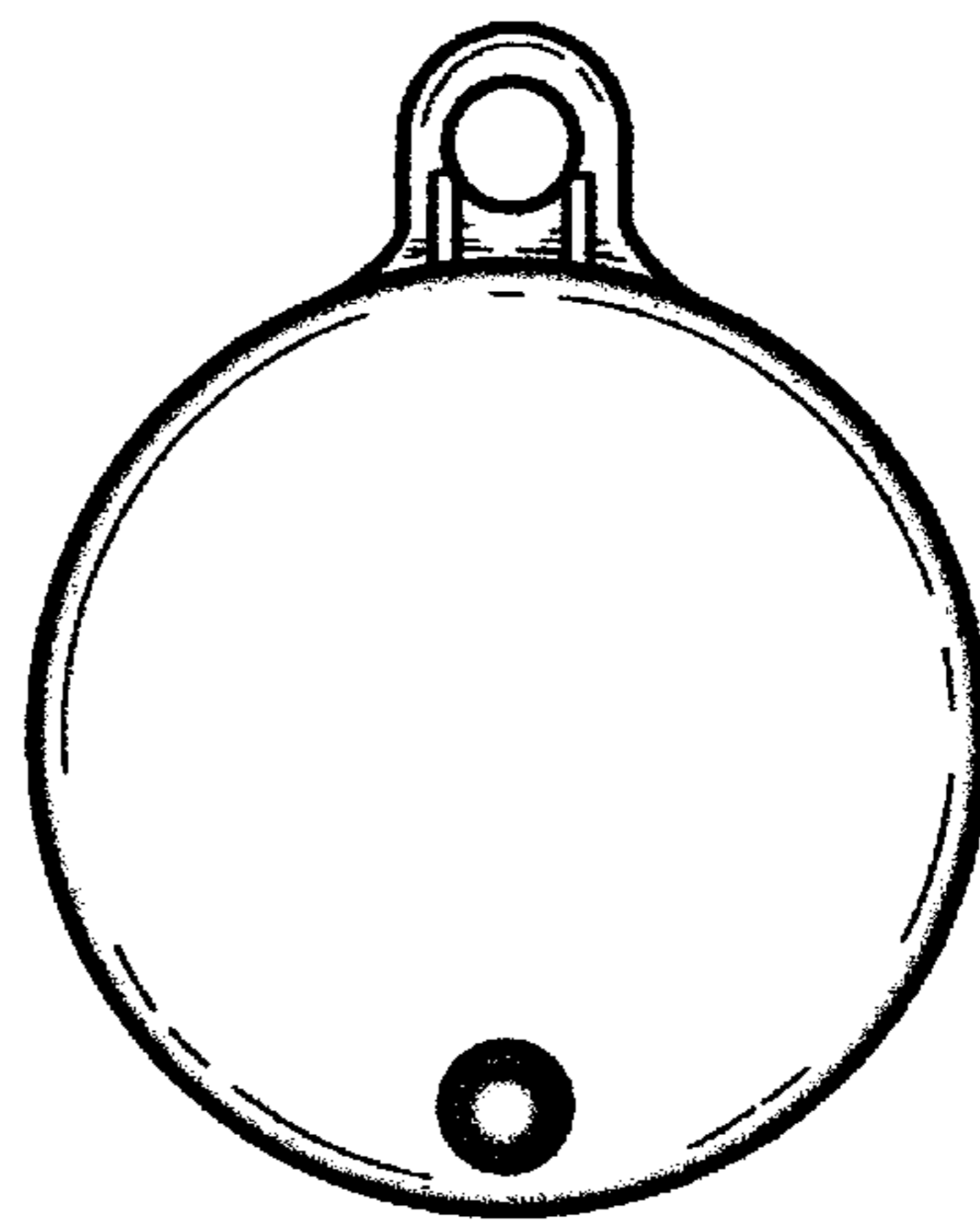

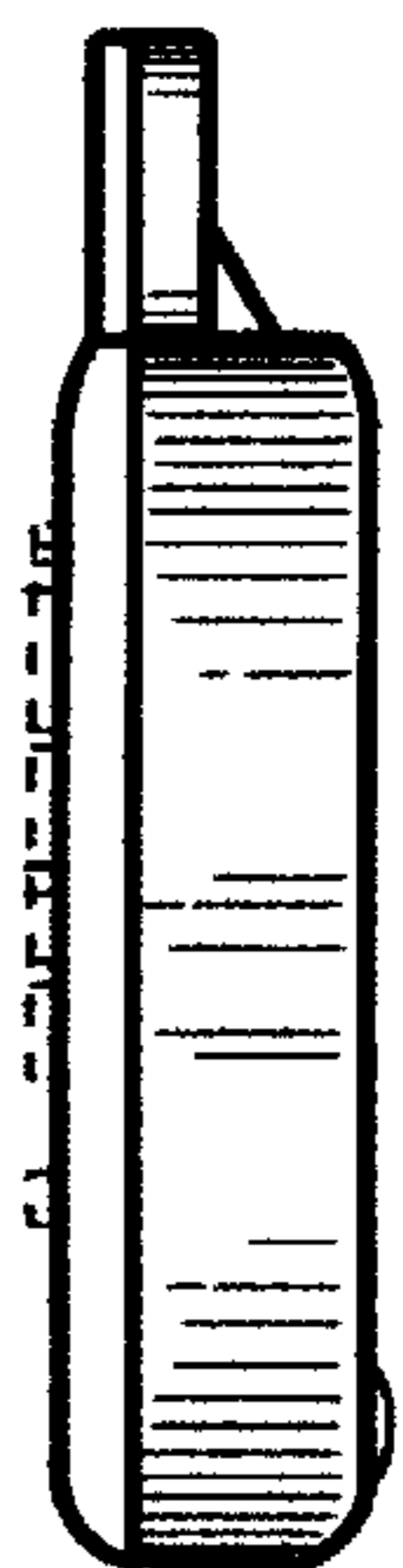

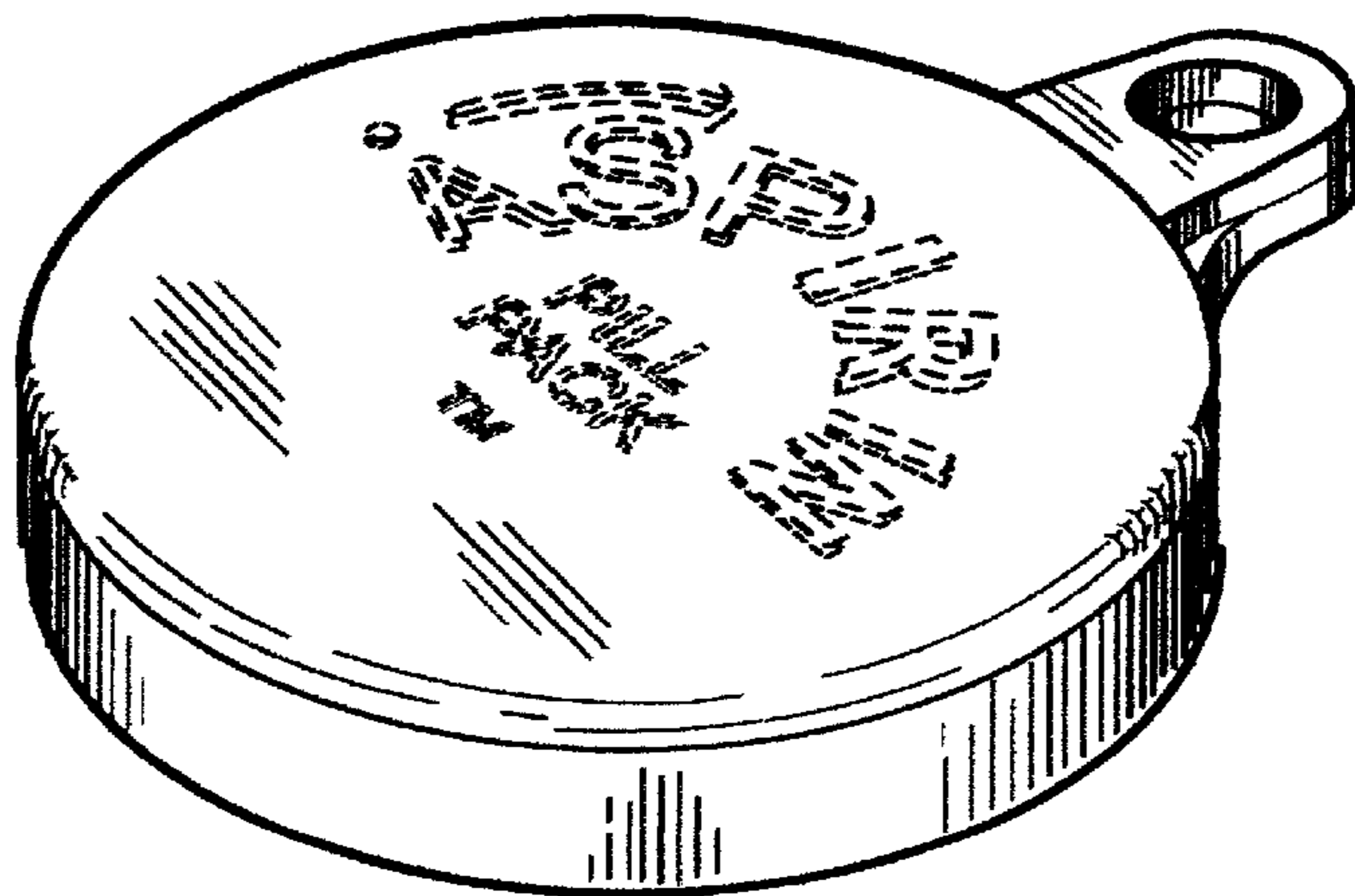
