 FIG. 14 is a top view thereof.

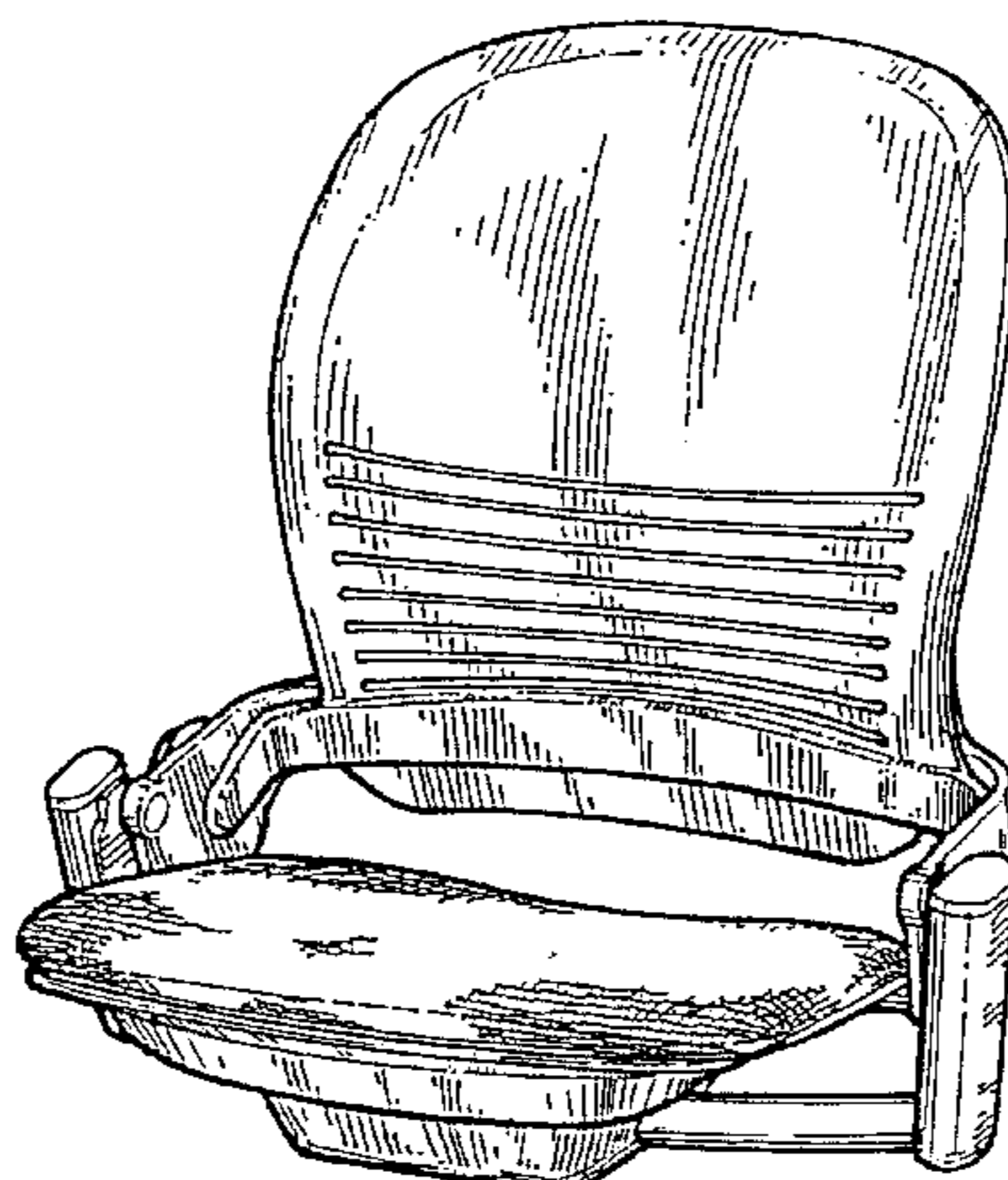

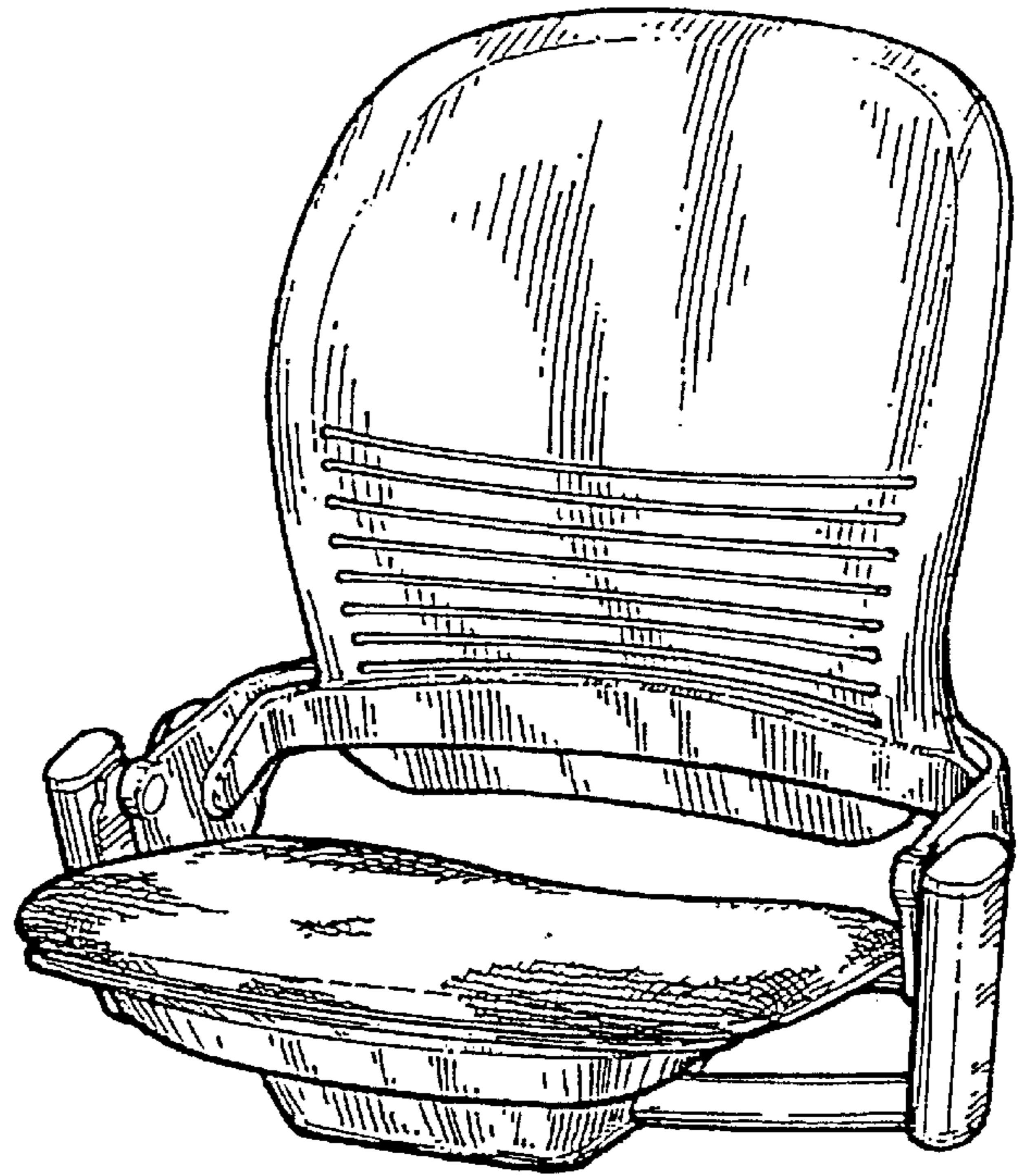

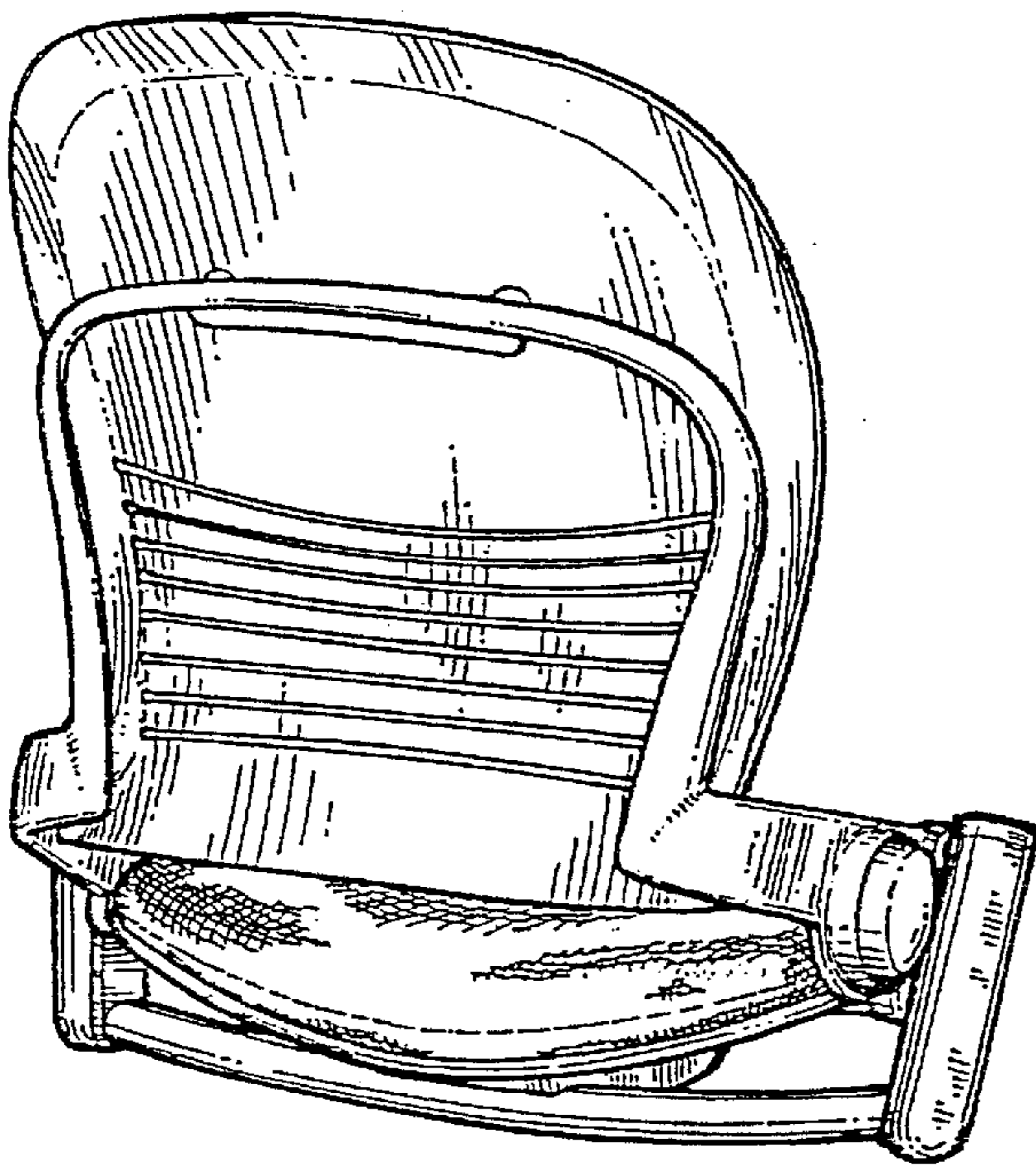

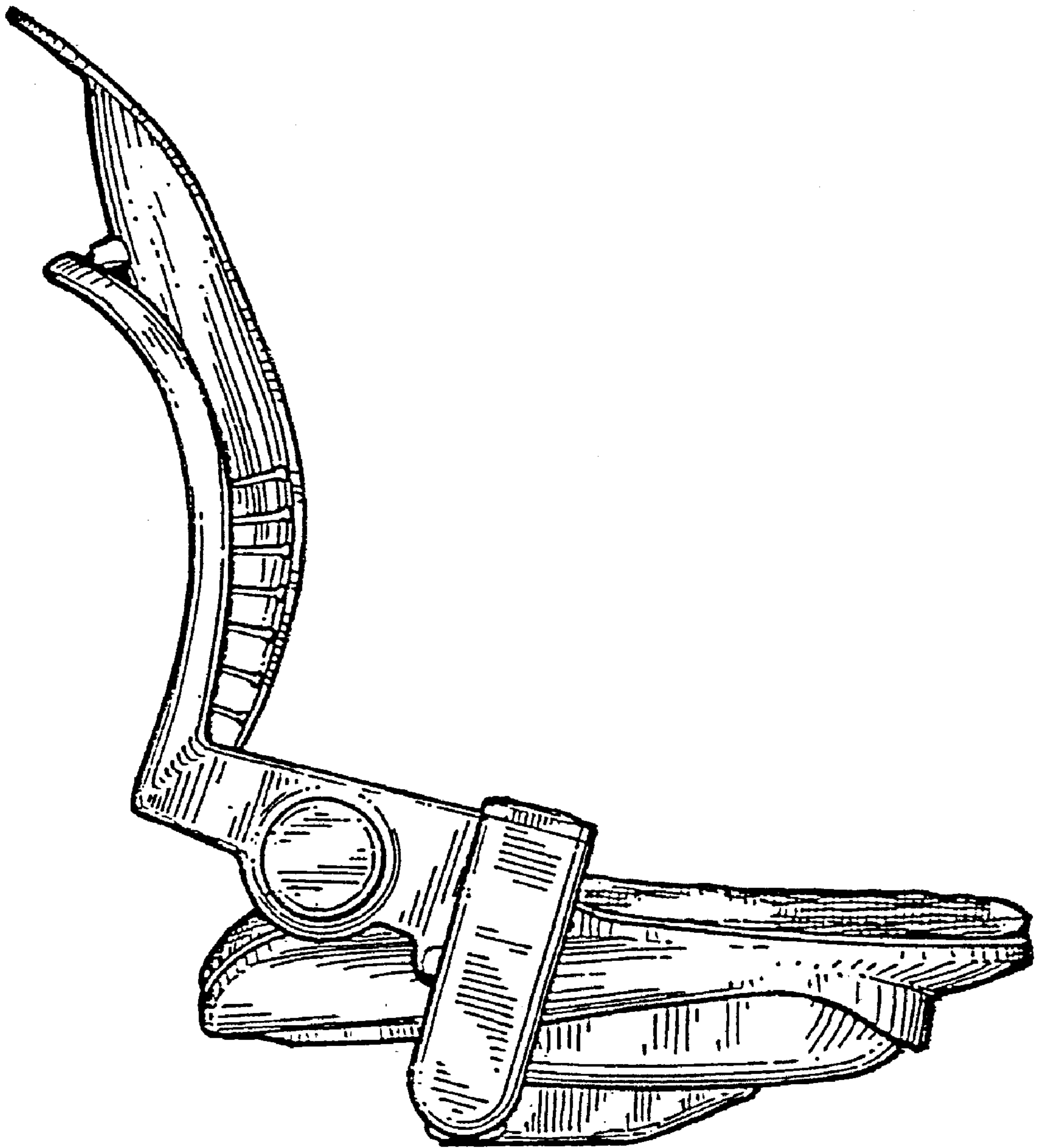

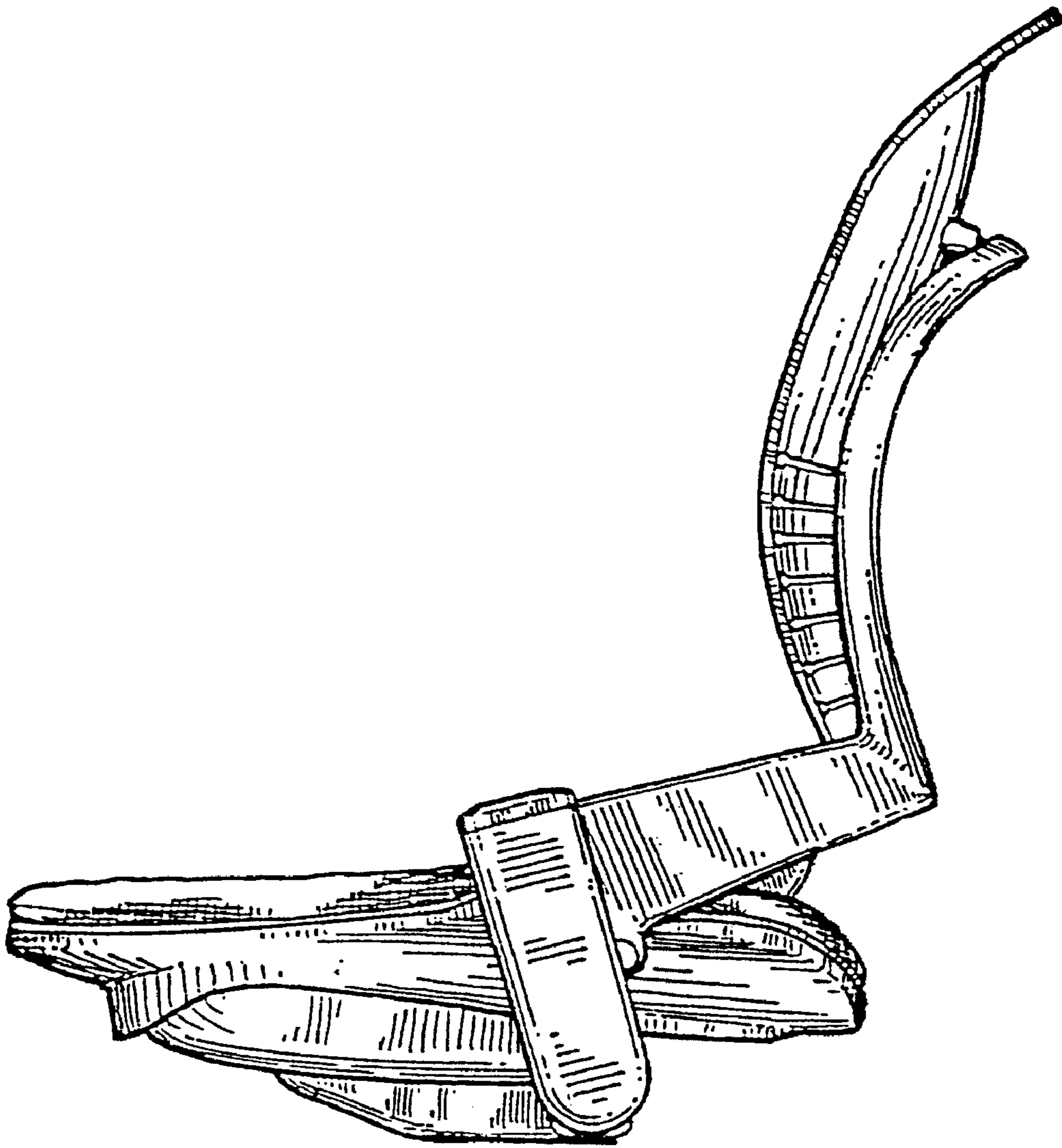

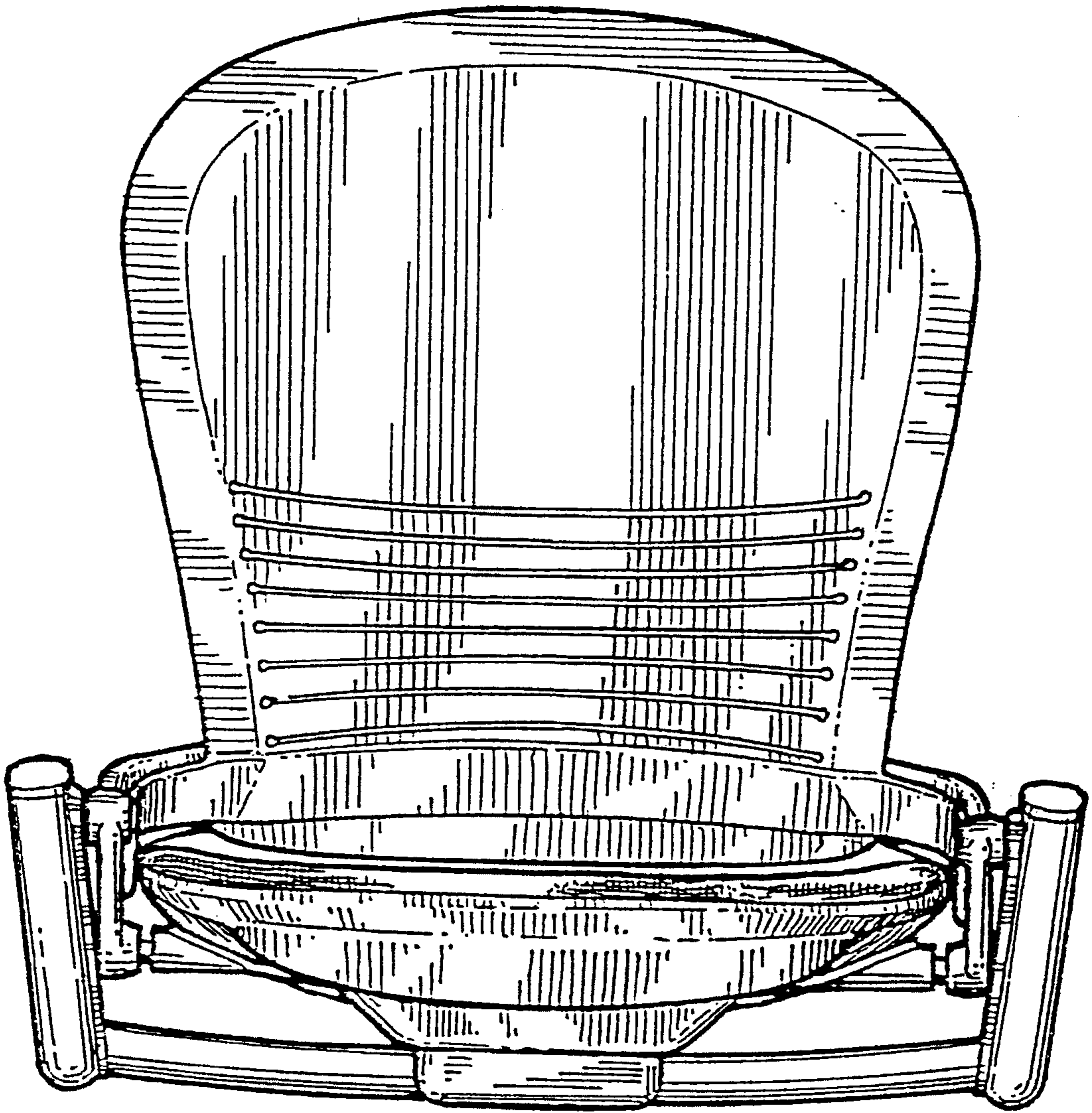

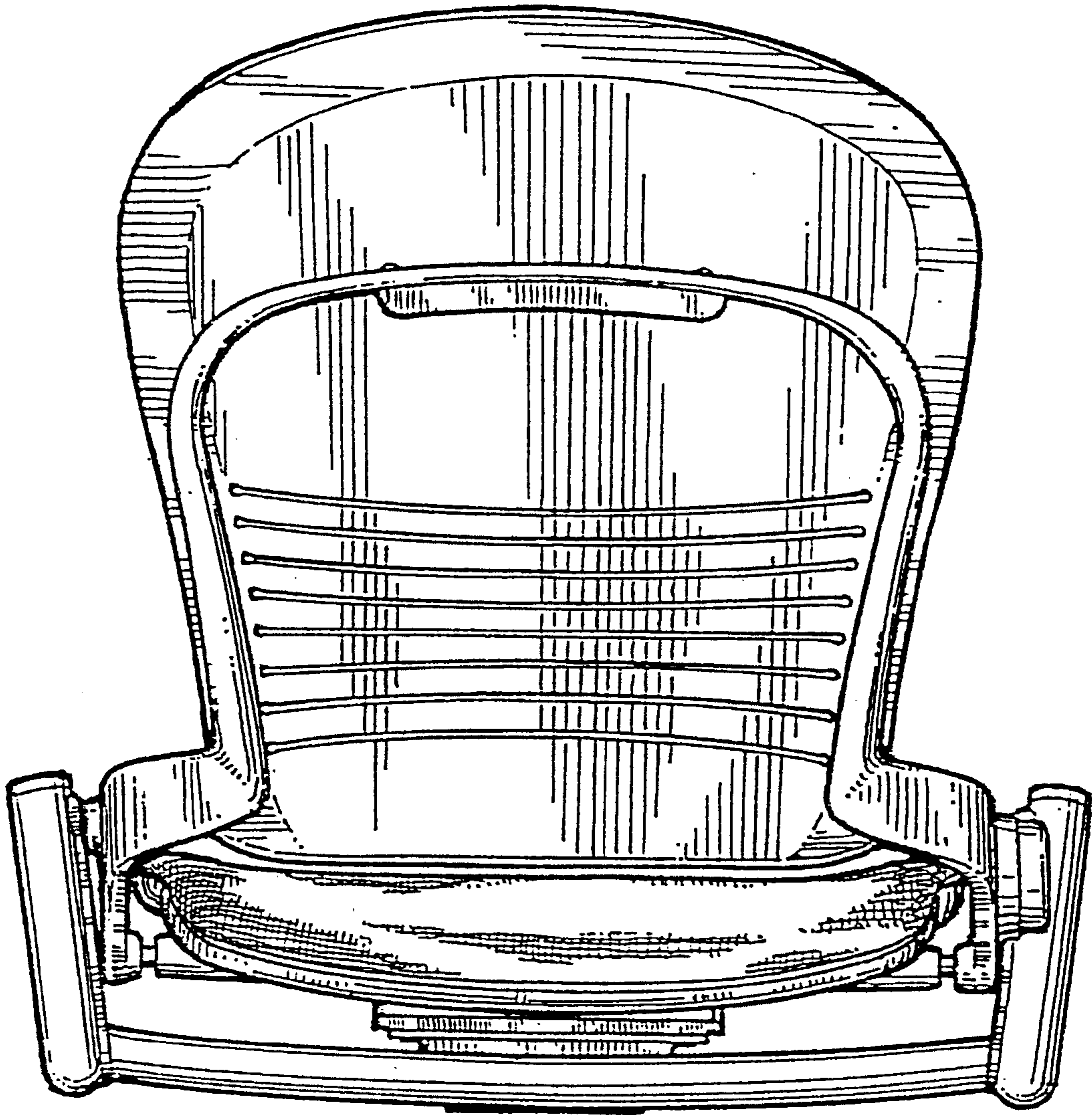

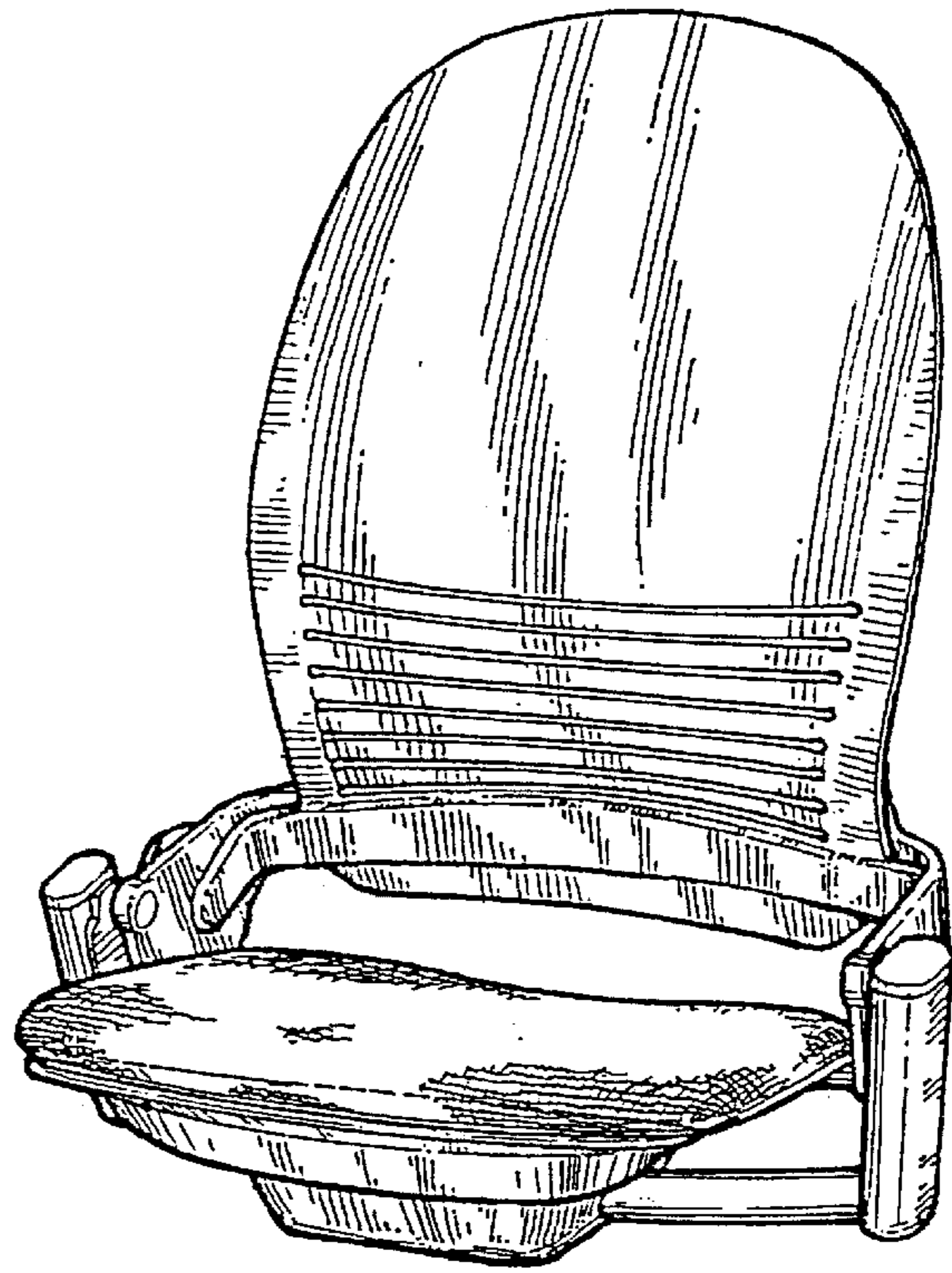

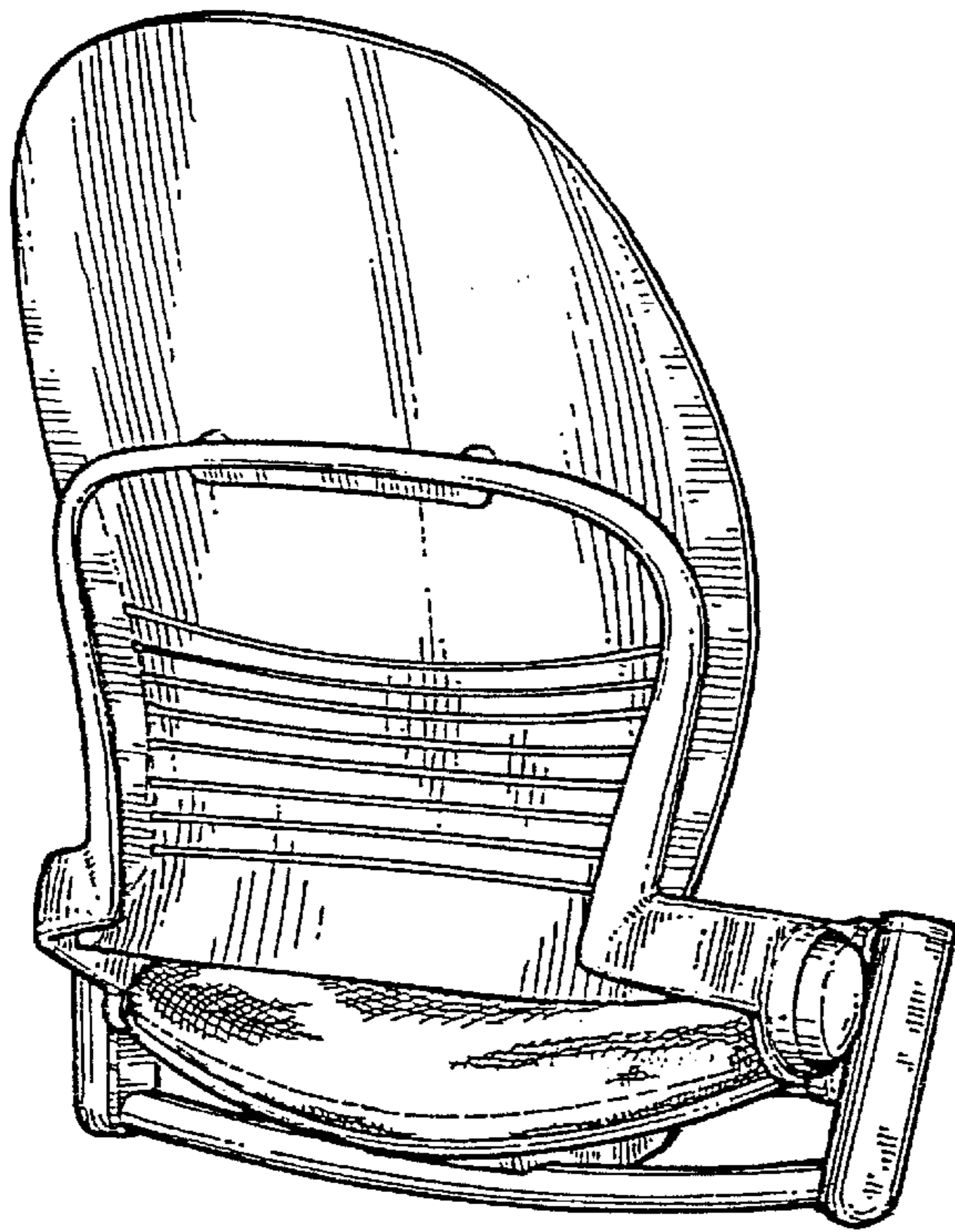

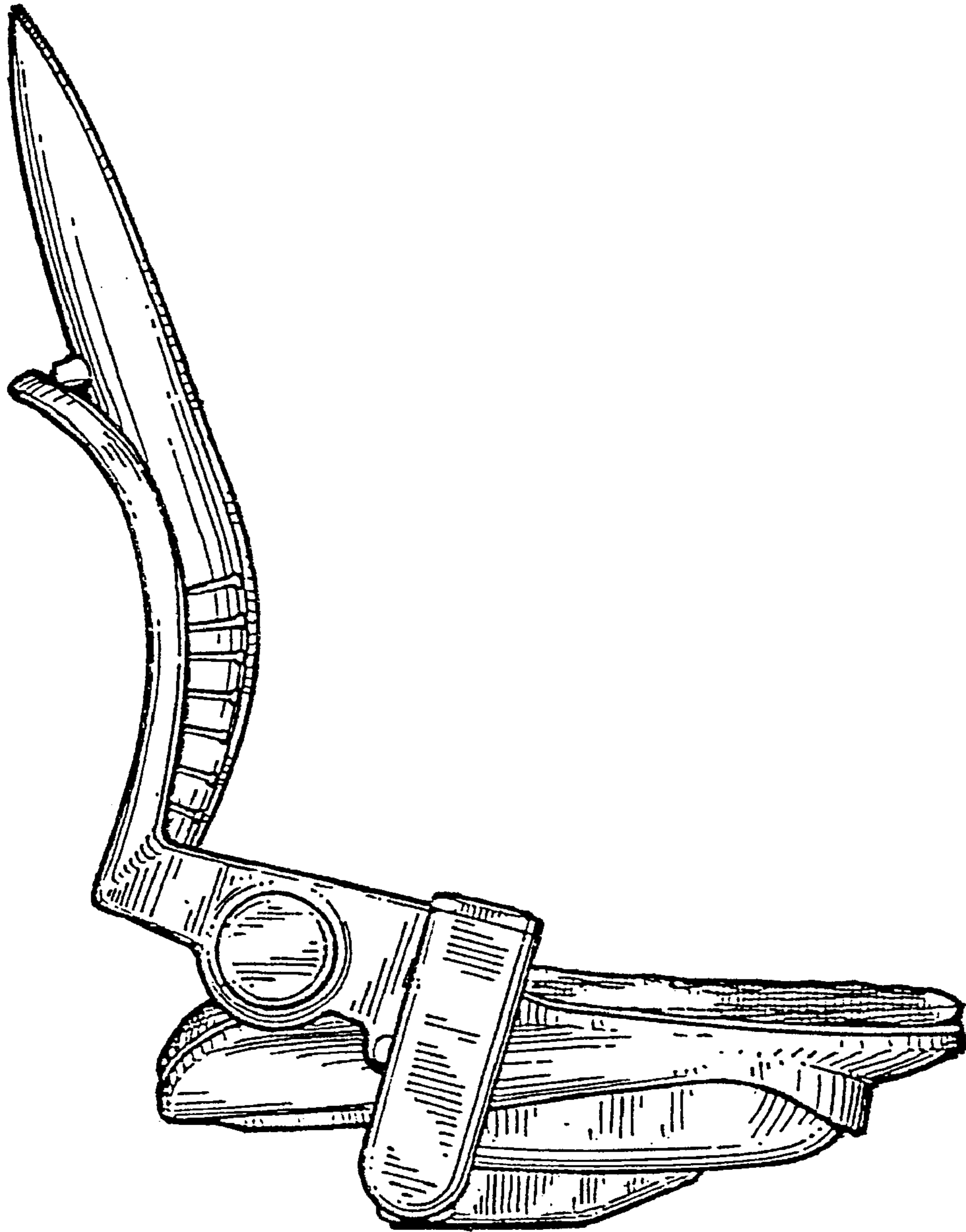

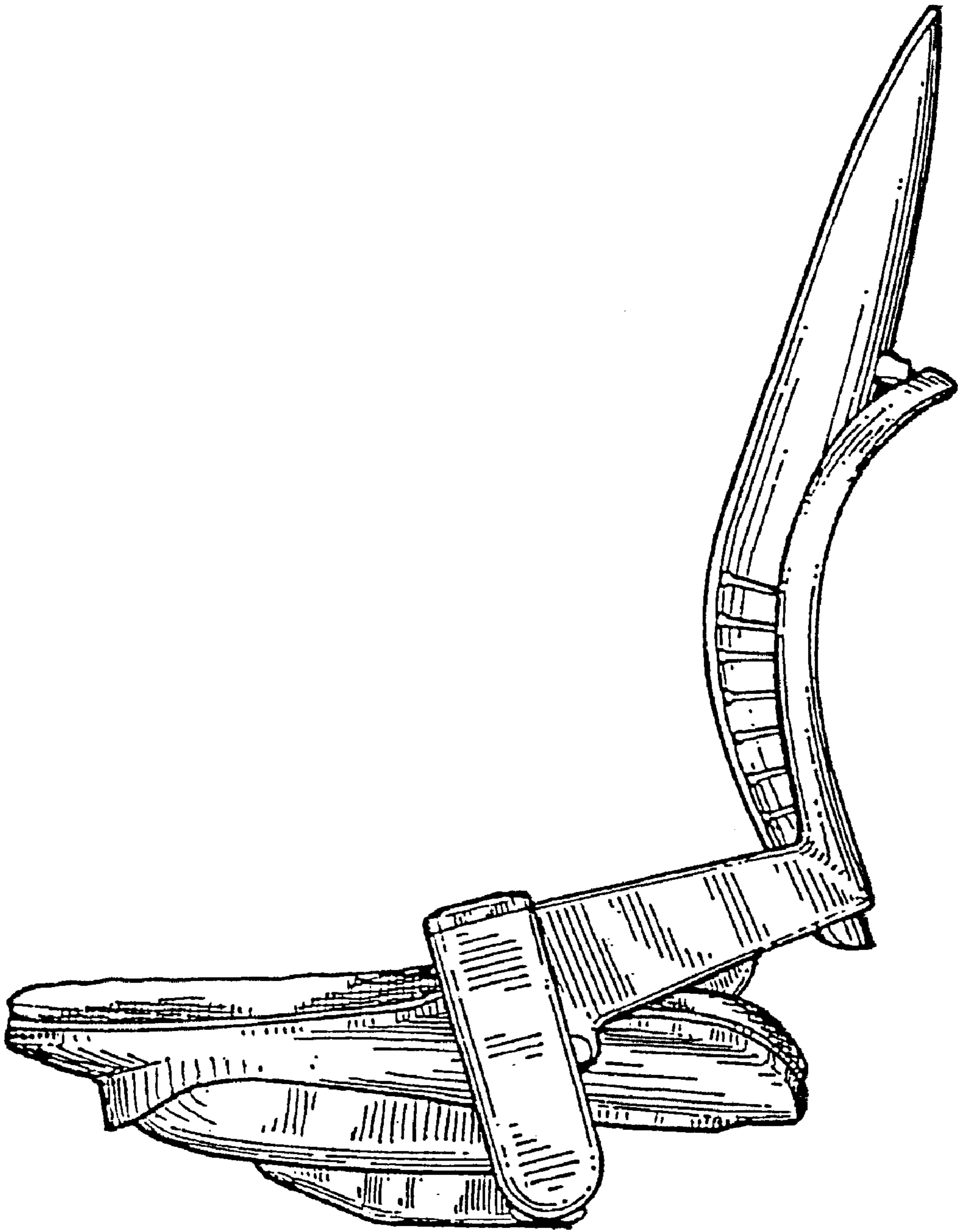

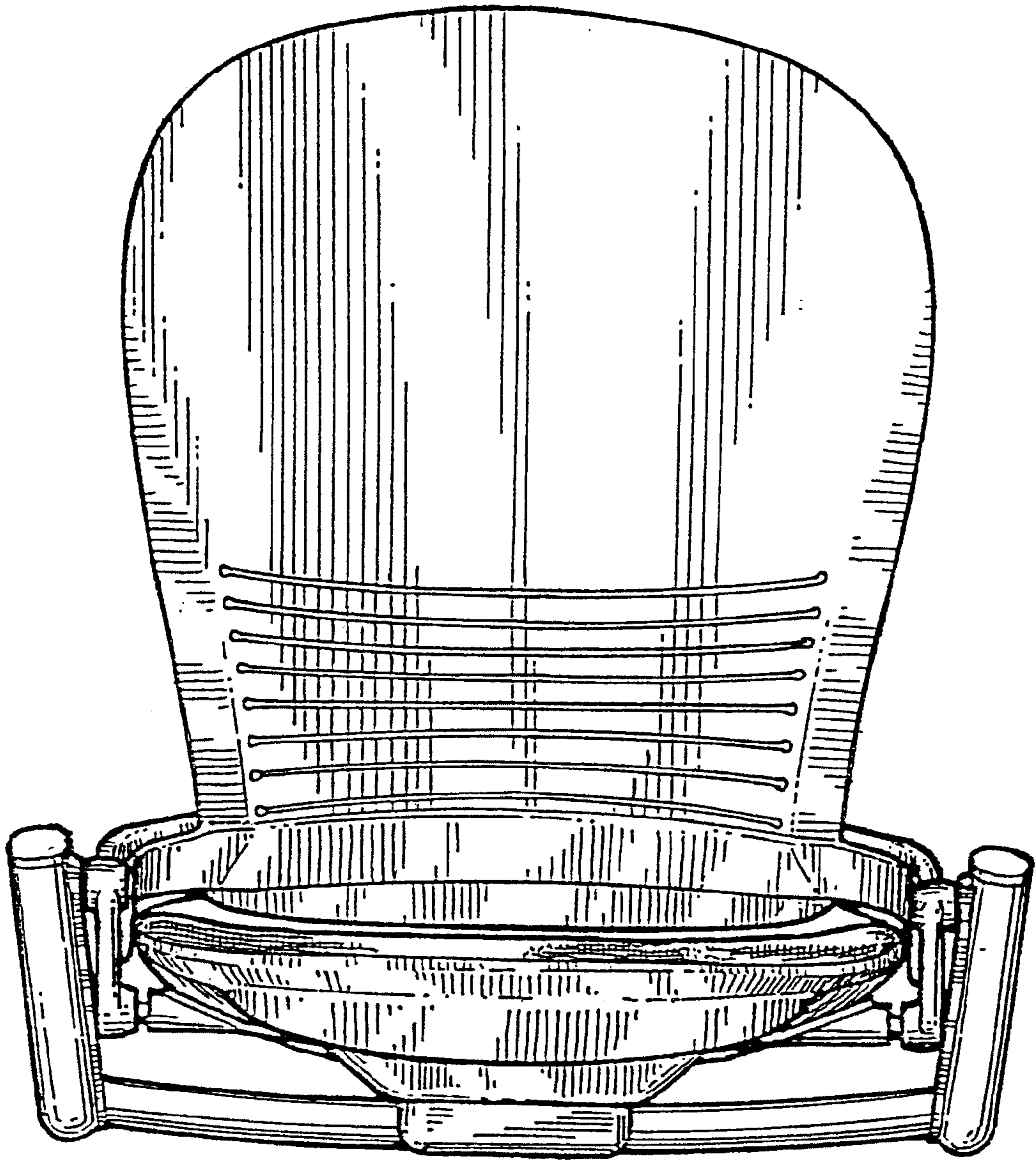

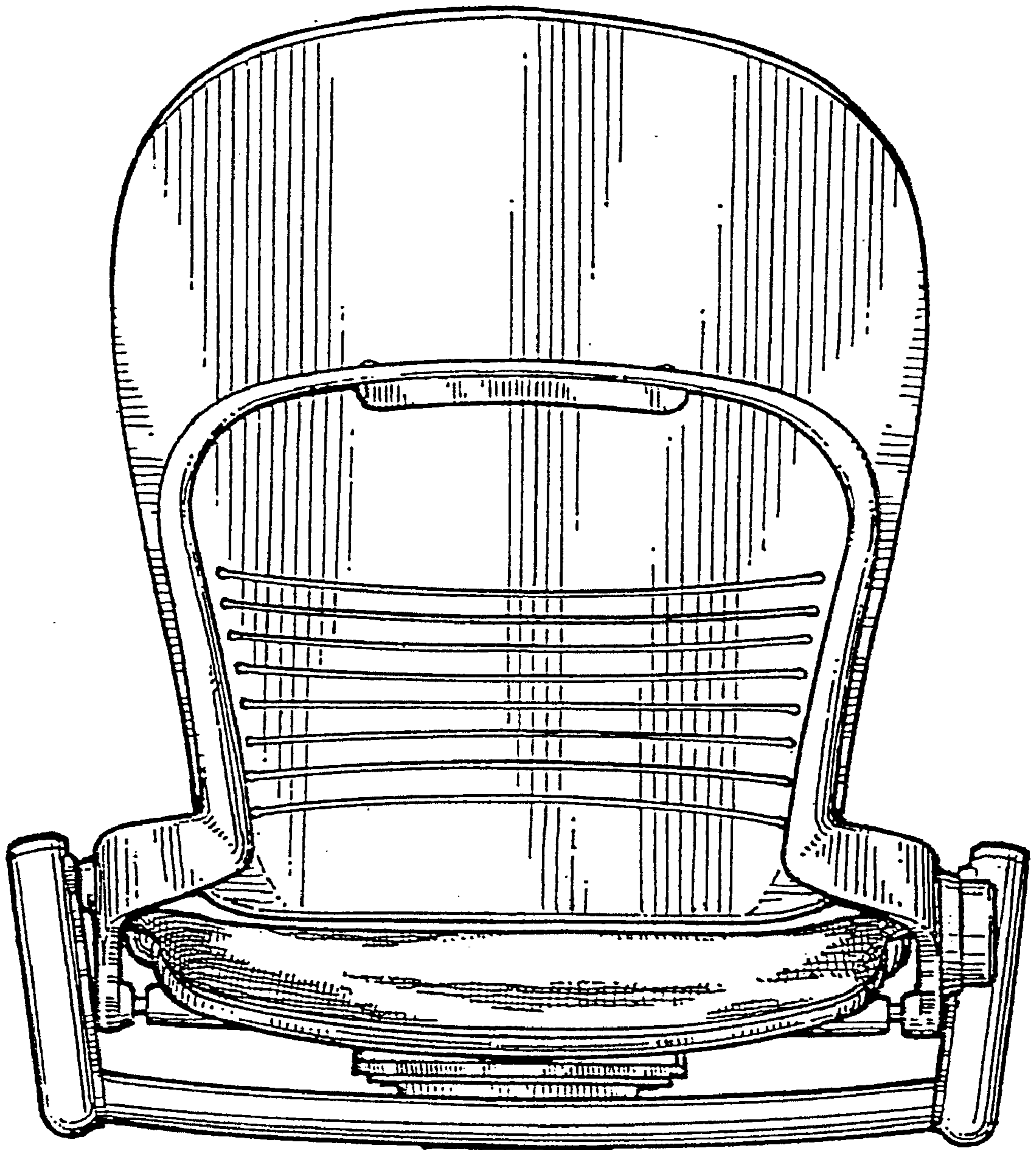
