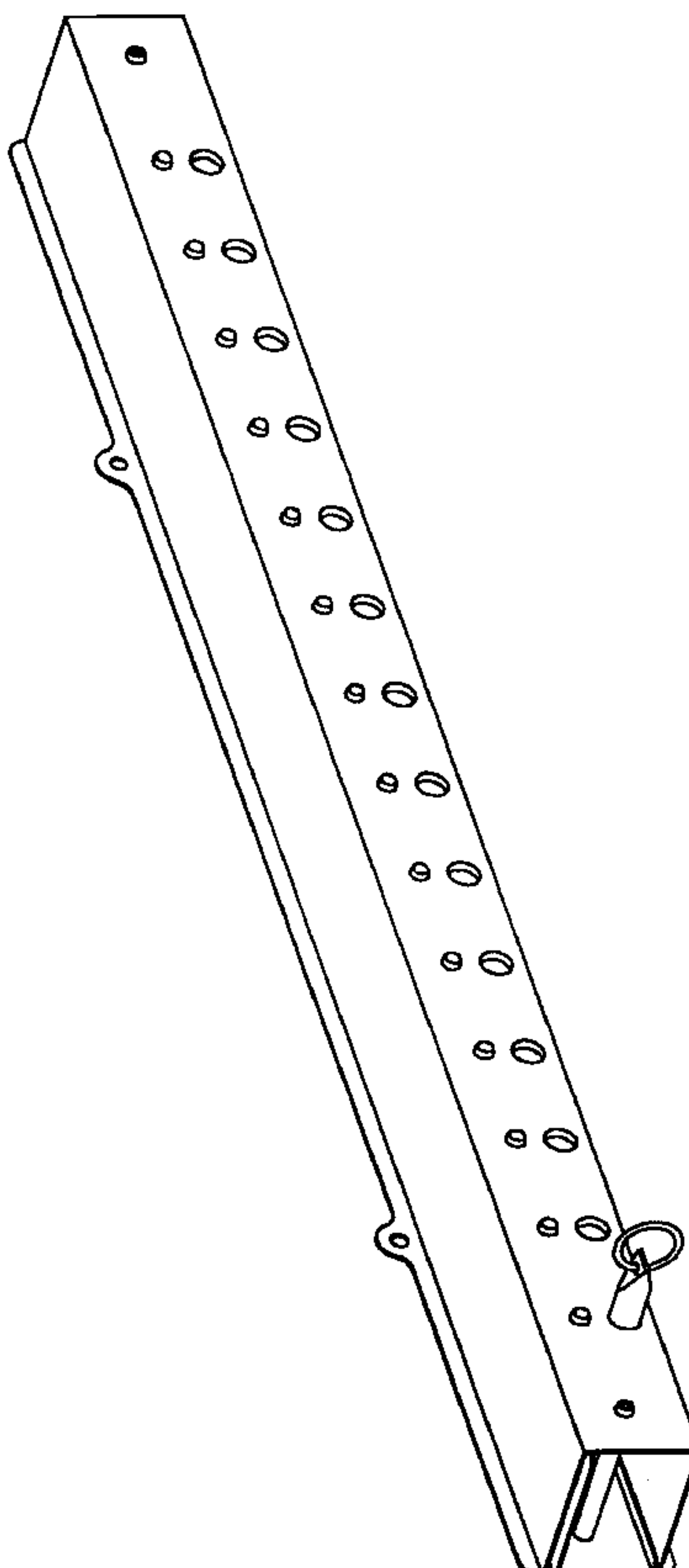
FIG. 10 is an opposite end elevational view of the key identification portion thereof; and,

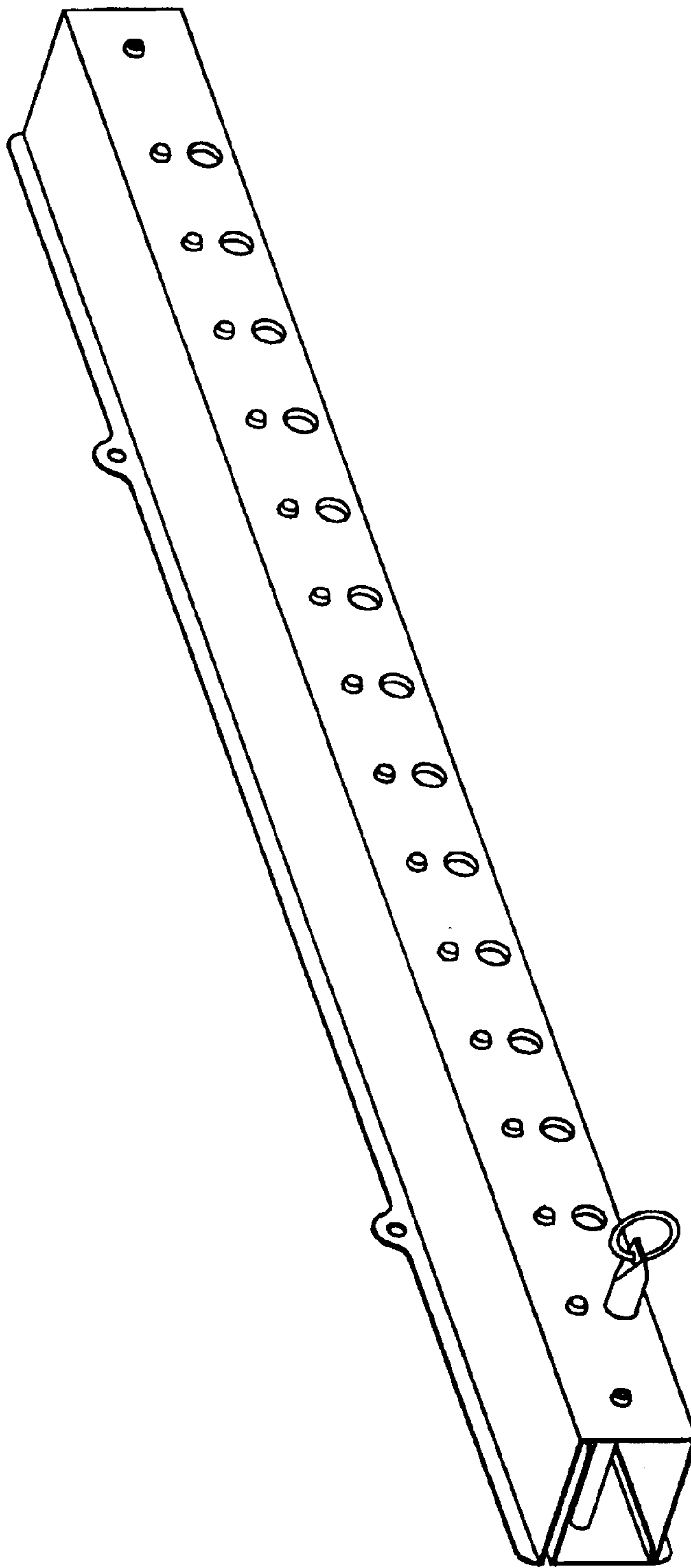

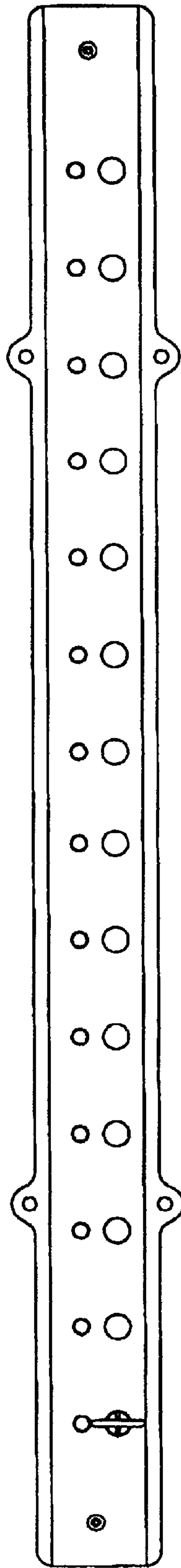

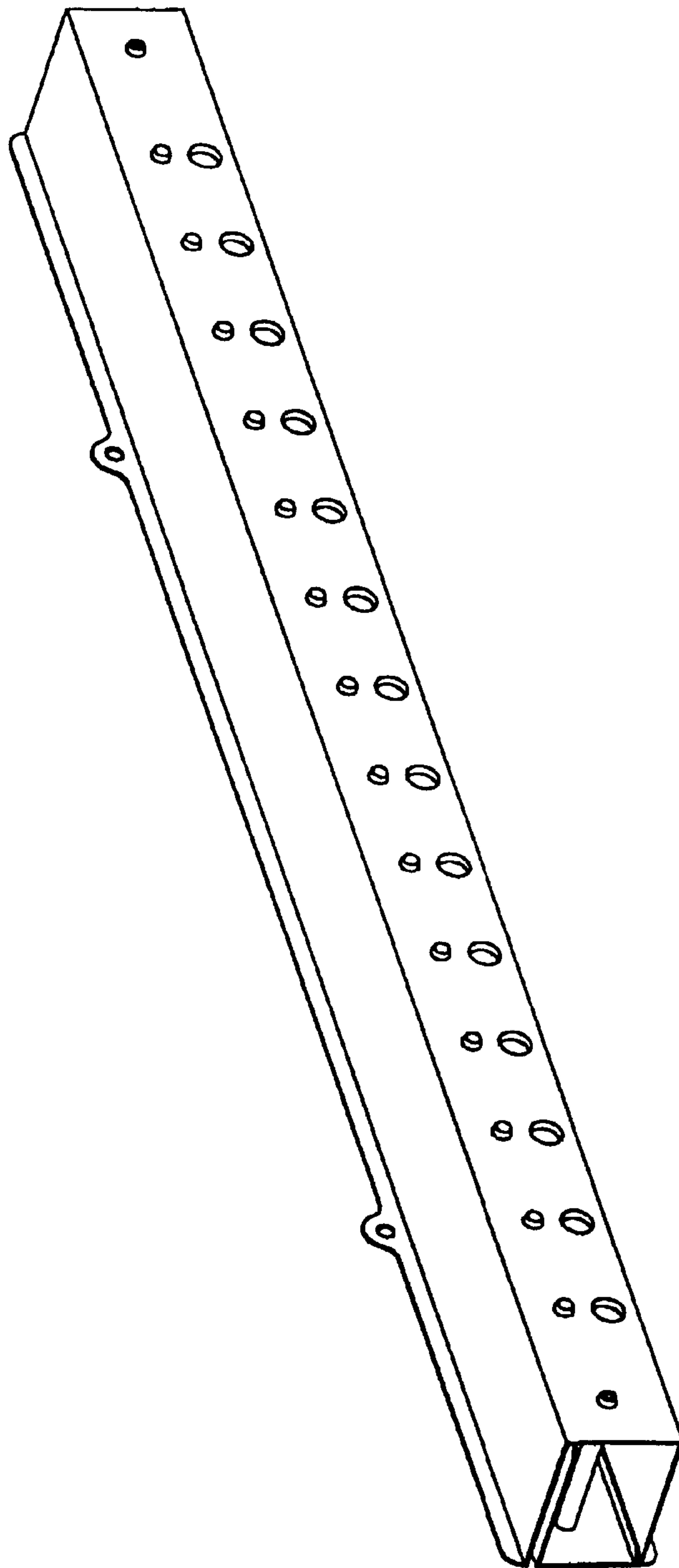

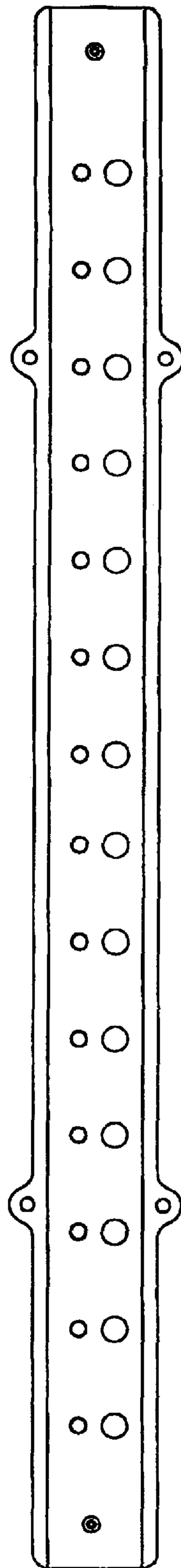

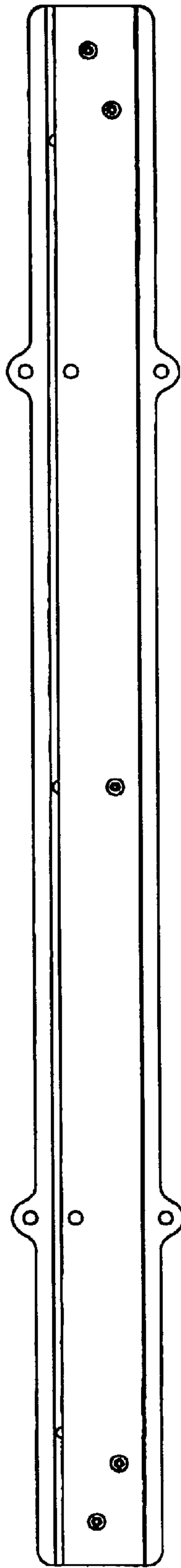

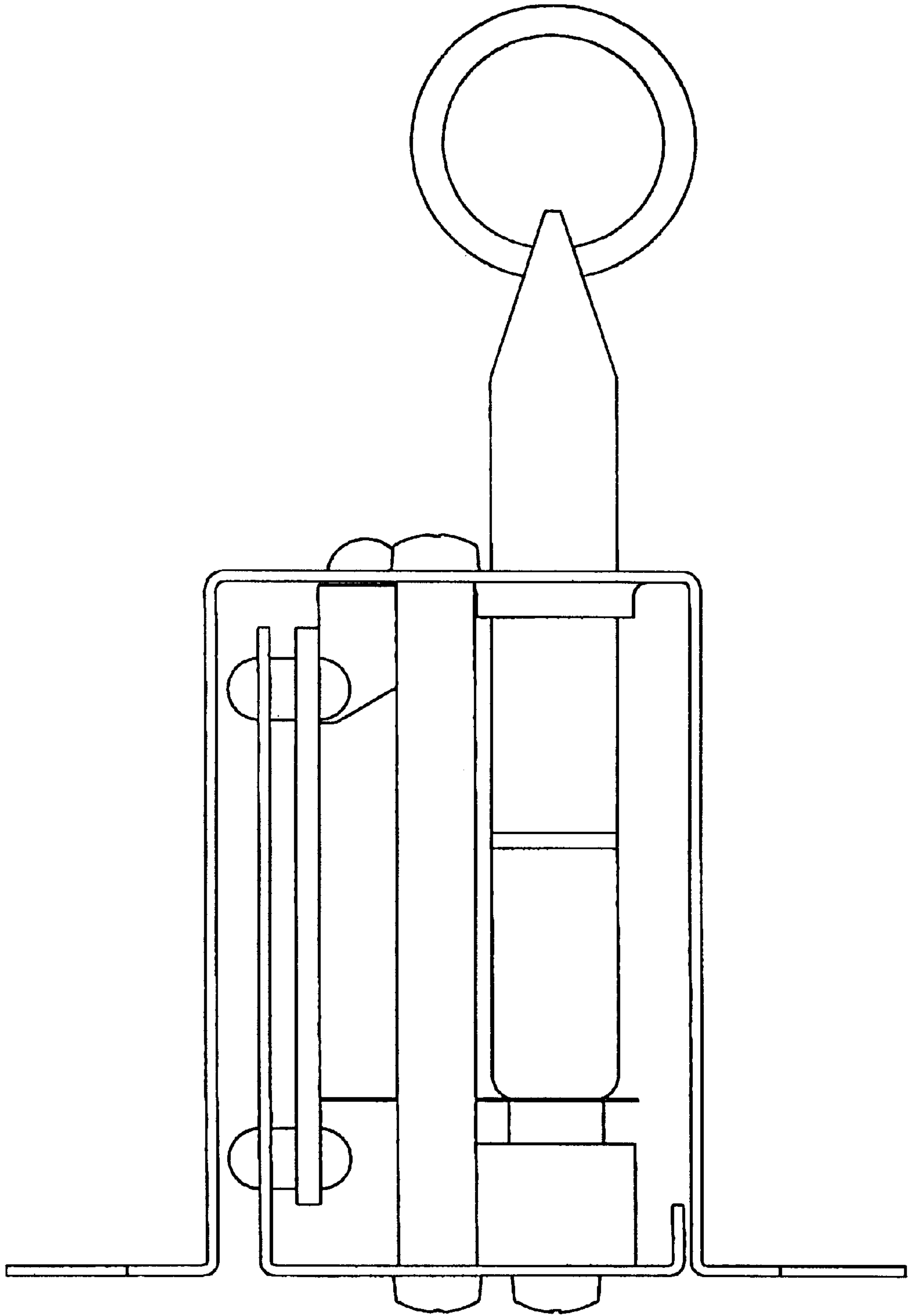
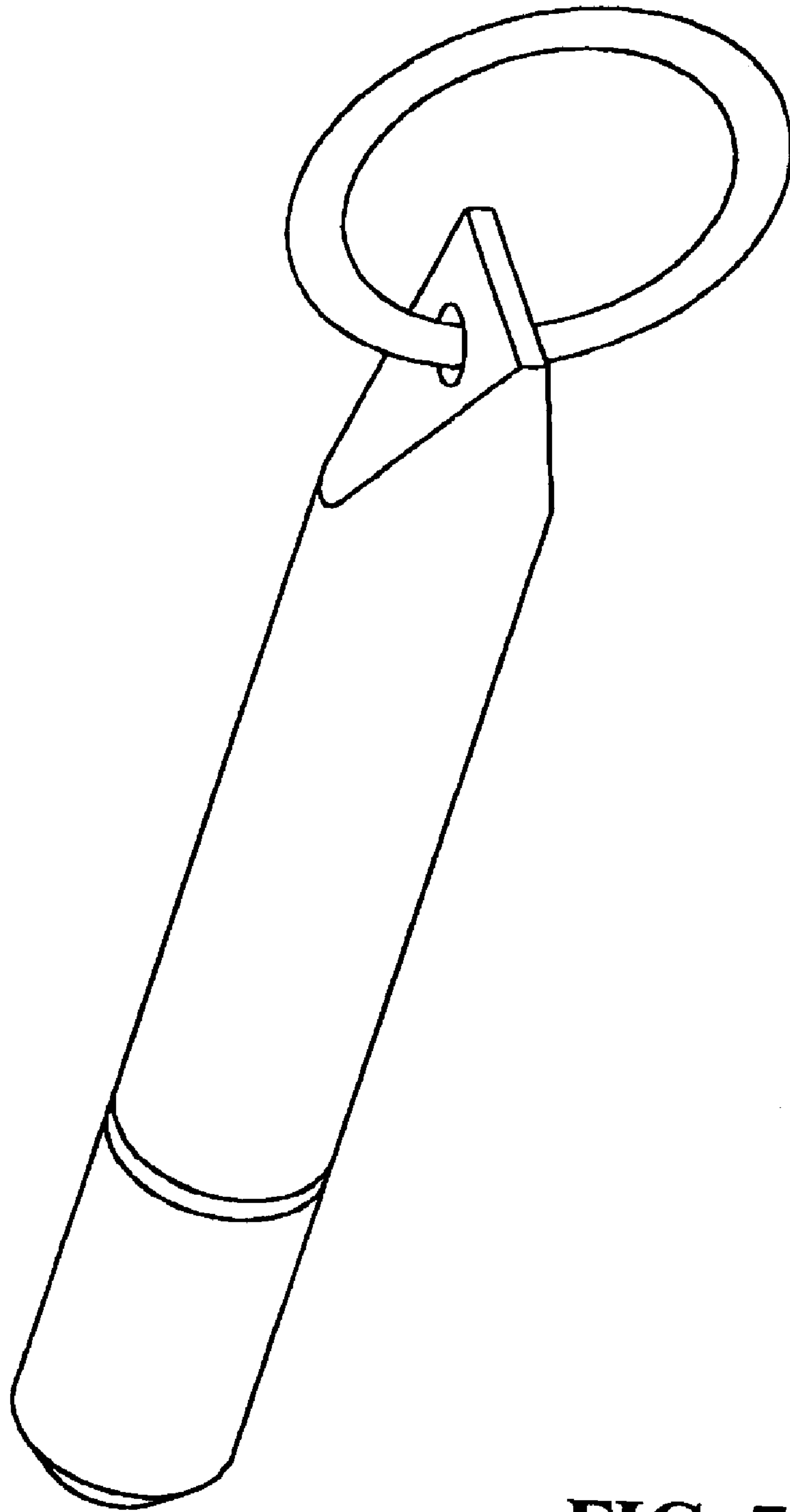

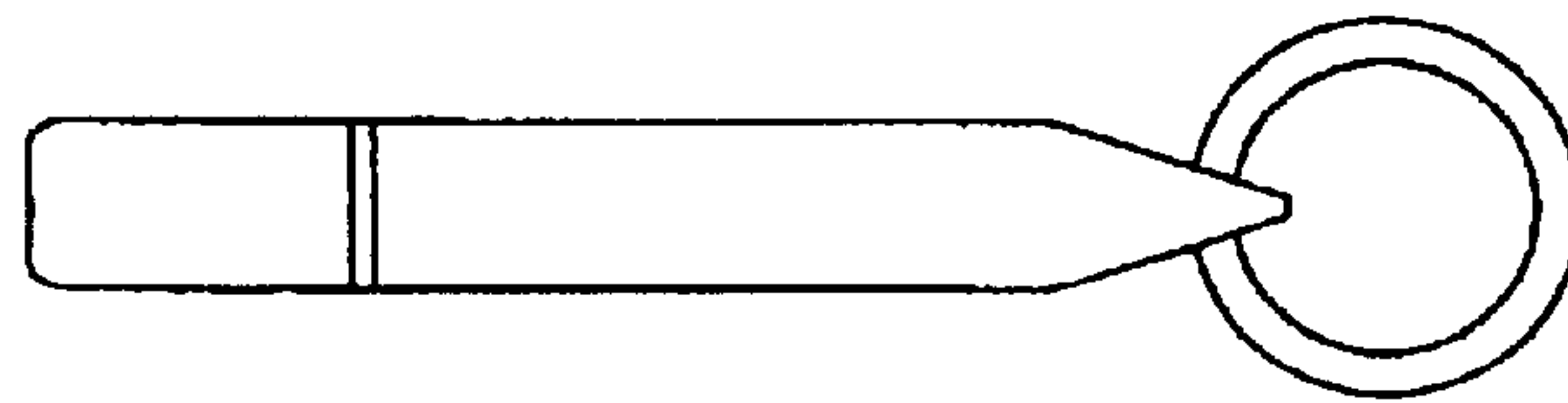

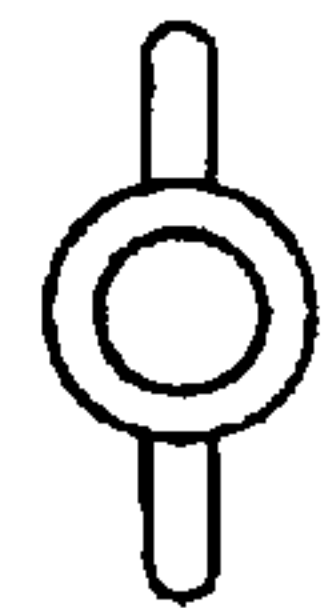
