(57) **CLAIM**

The ornamental design for a hand saw handle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a hand saw handle showing my design looking downwardly at a front and left side thereof, and showing a saw blade in phantom;

FIG. 2 is a left side elevational view of the hand saw handle and of the saw blade shown in phantom;

FIG. 3 is a top plan view of the hand saw handle and of the saw blade shown in phantom;

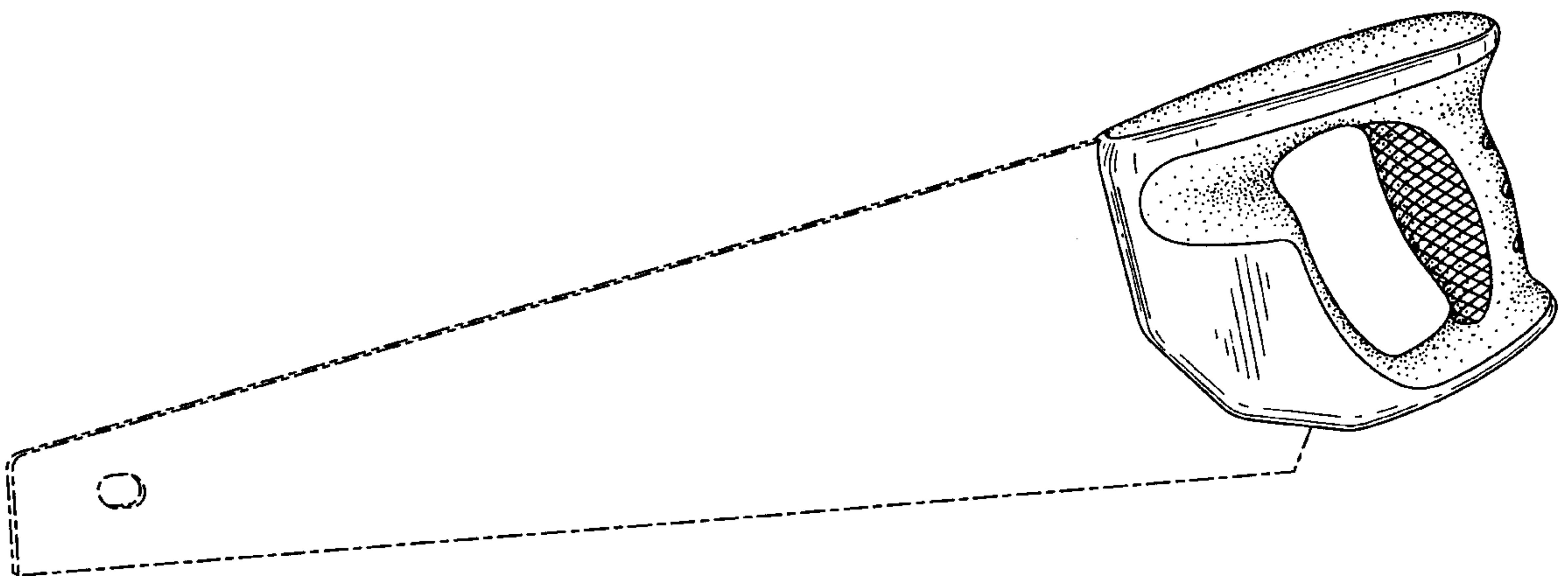
FIG. 4 is a bottom plan view of the hand saw handle and of the saw blade shown in phantom;

FIG. 5 is a front elevational view of the hand saw handle and of the saw blade shown in phantom; and,

FIG. 6 is a rear elevational view of the hand saw handle and of the saw blade shown in phantom.

The phantom dash line showing of the saw blade is for illustrative purposes only and forms no part of the claimed design.

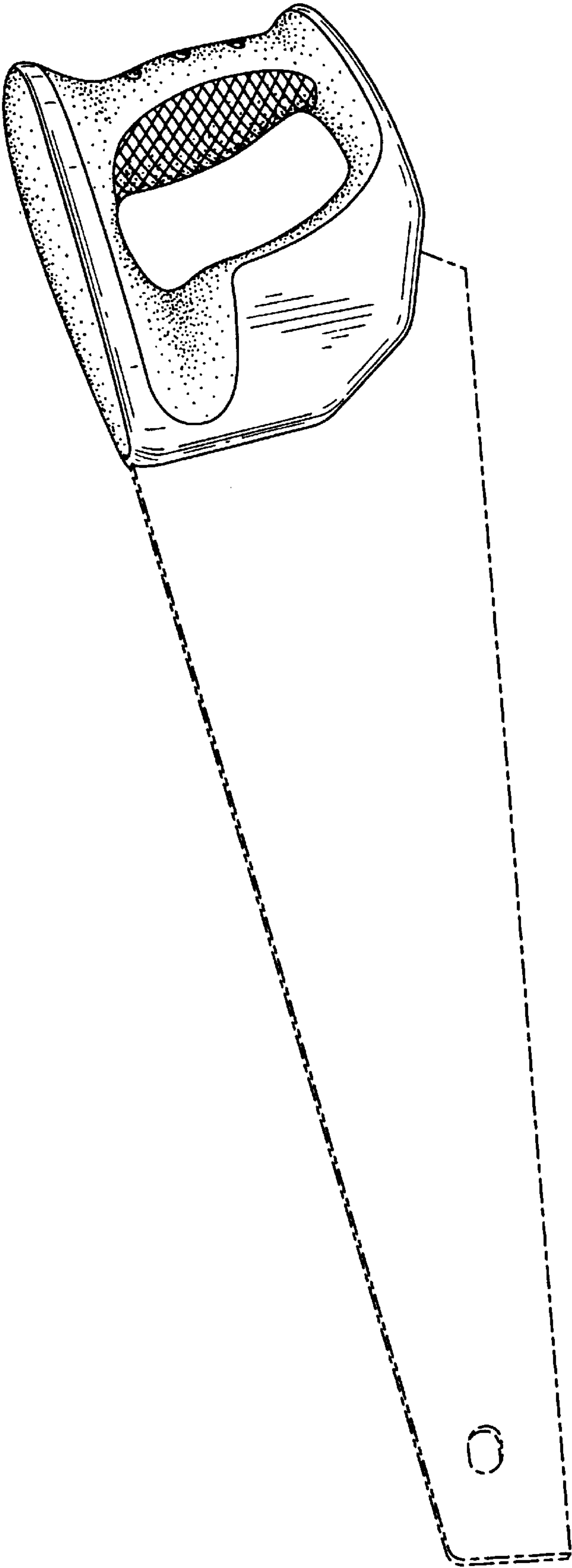

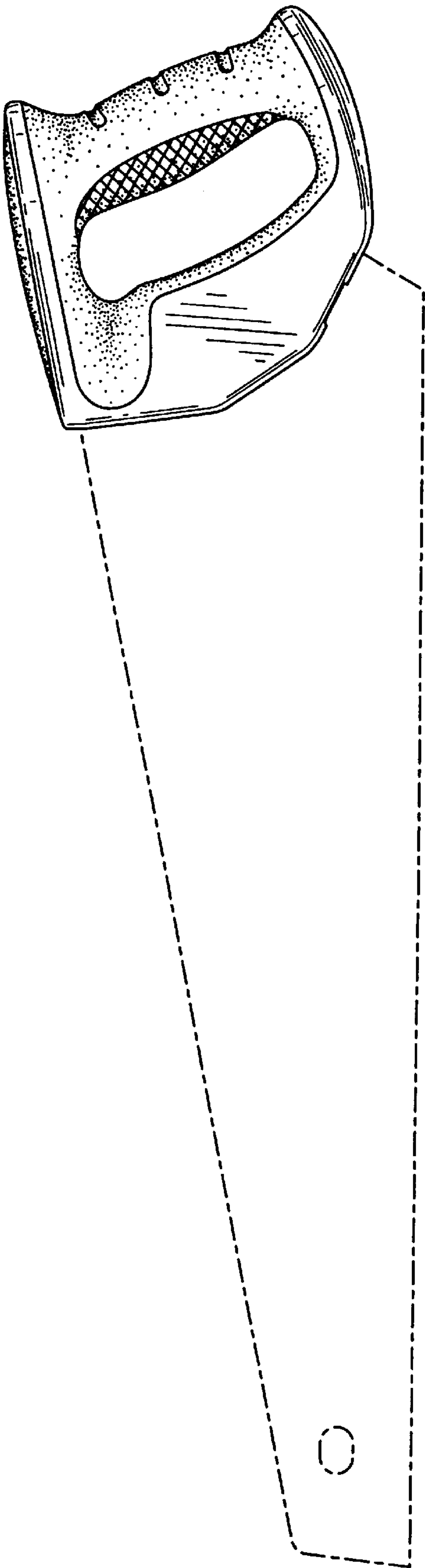

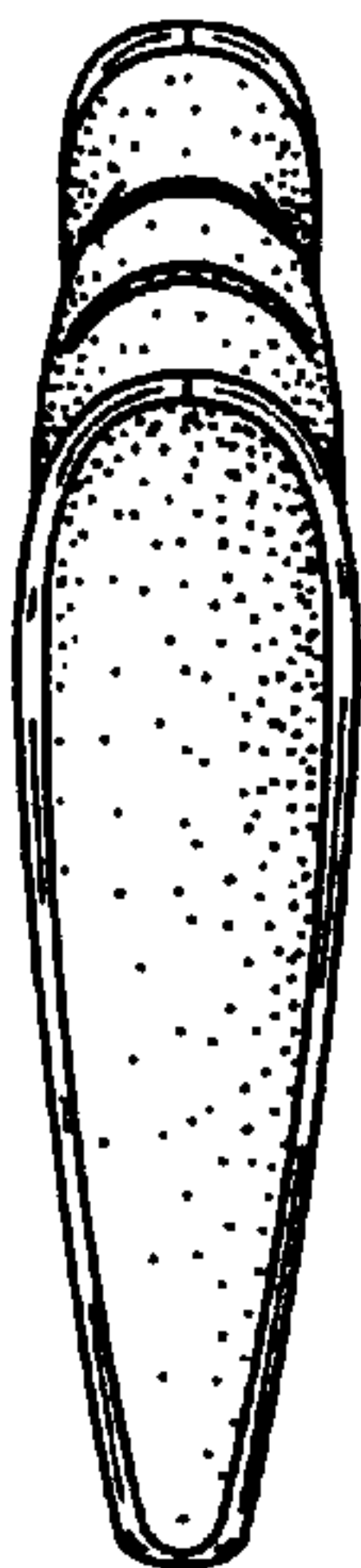

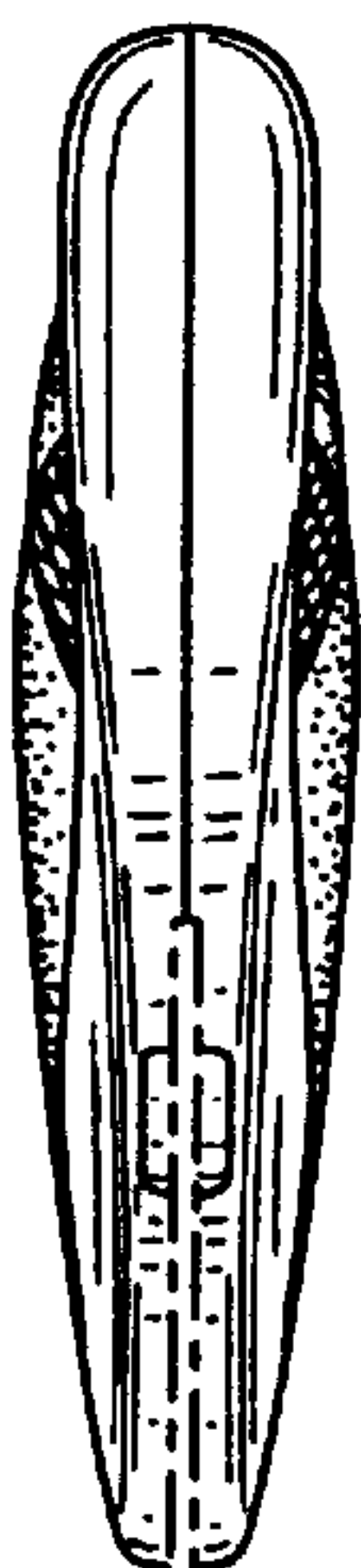

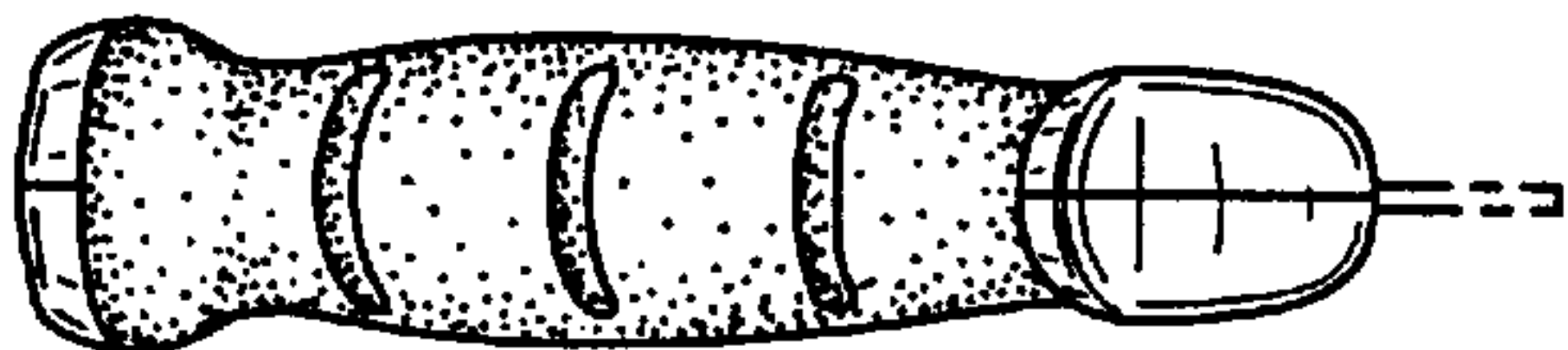
