DESCRIPTION

FIG. 1 is a top view of a track ball embodying features of the invention.

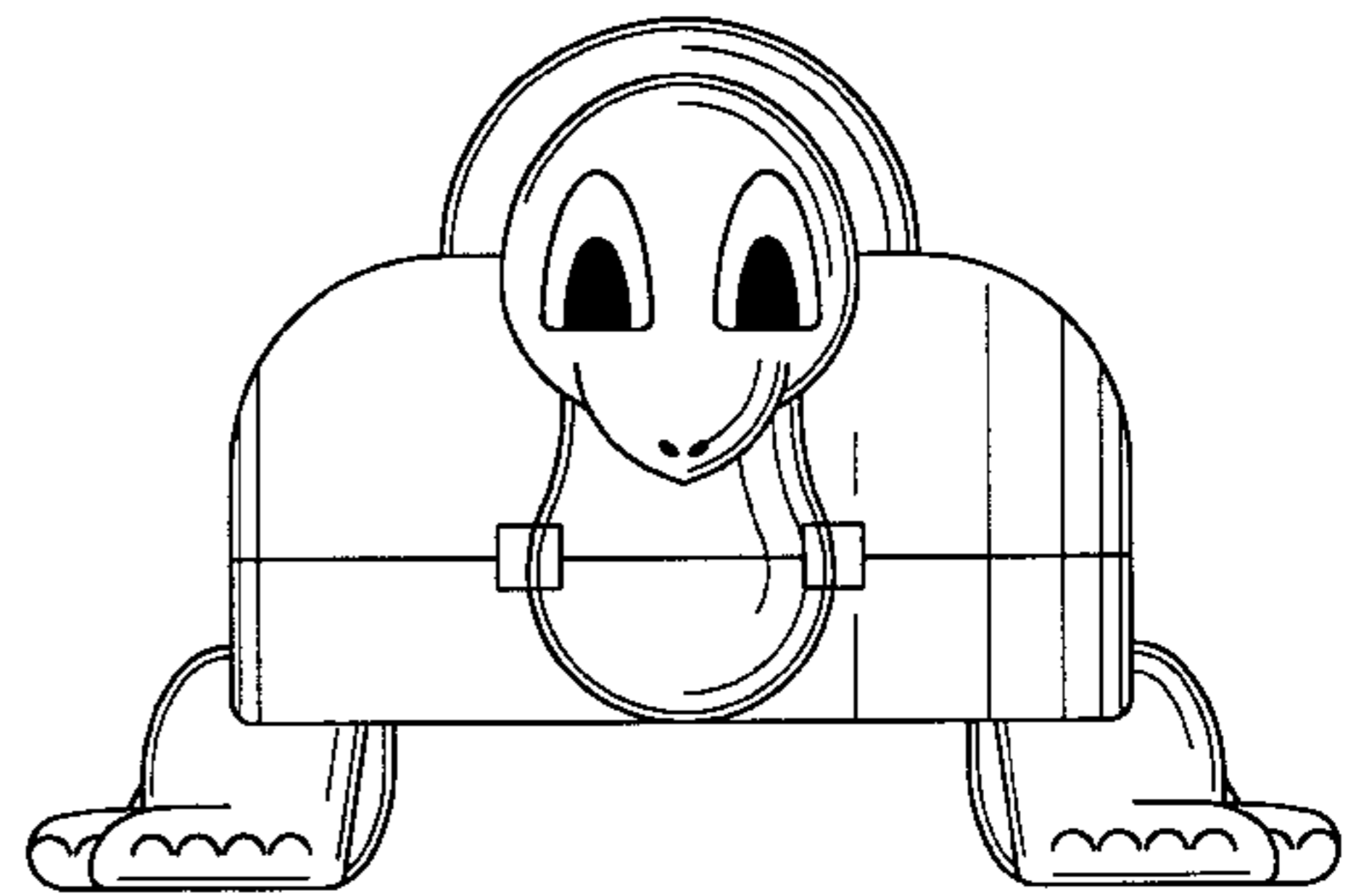
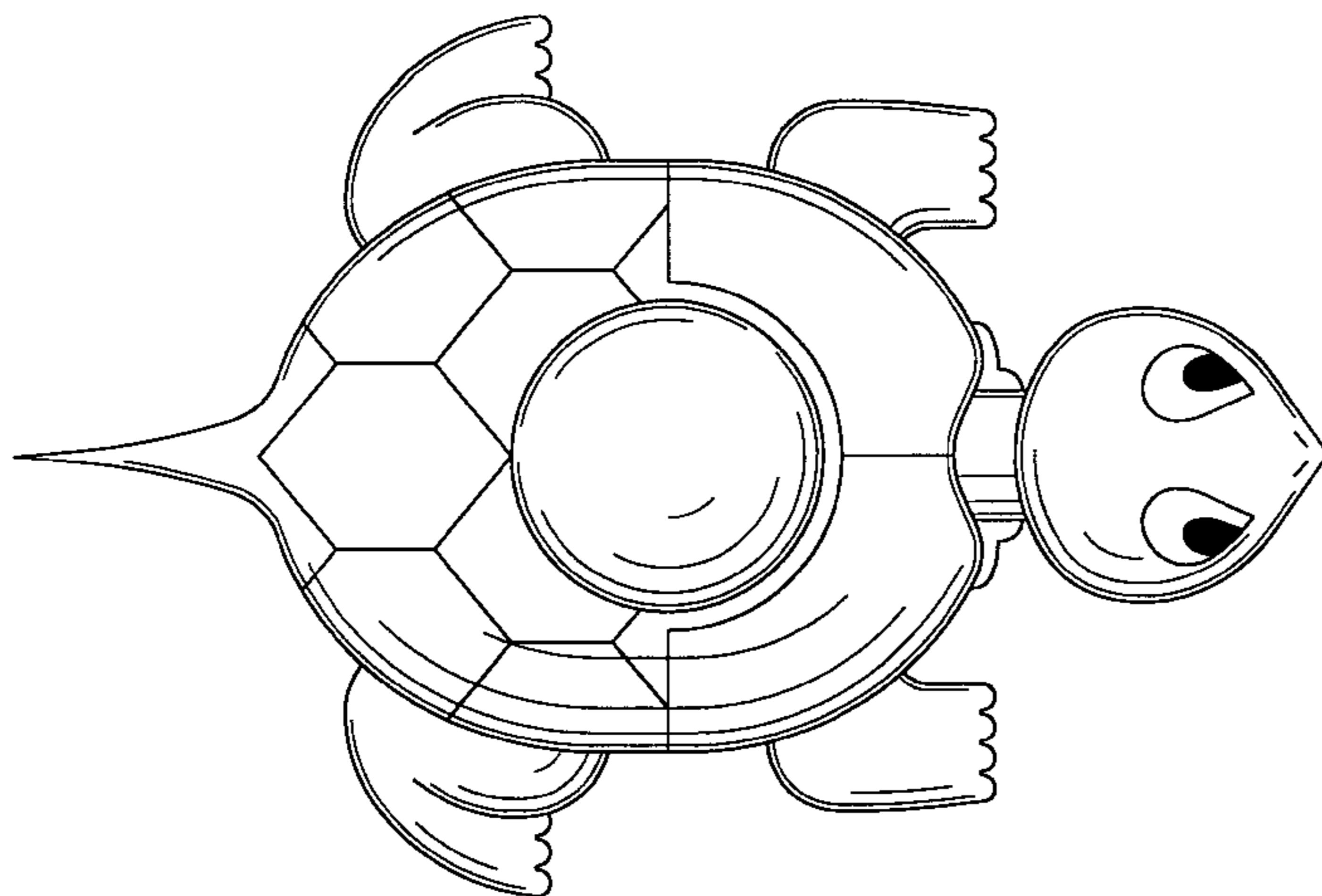
FIG. 2 is a bottom view of the track ball of FIG. 1.

FIG. 3 is a side view of the track ball of FIG. 1, with the opposite side being a mirror image.

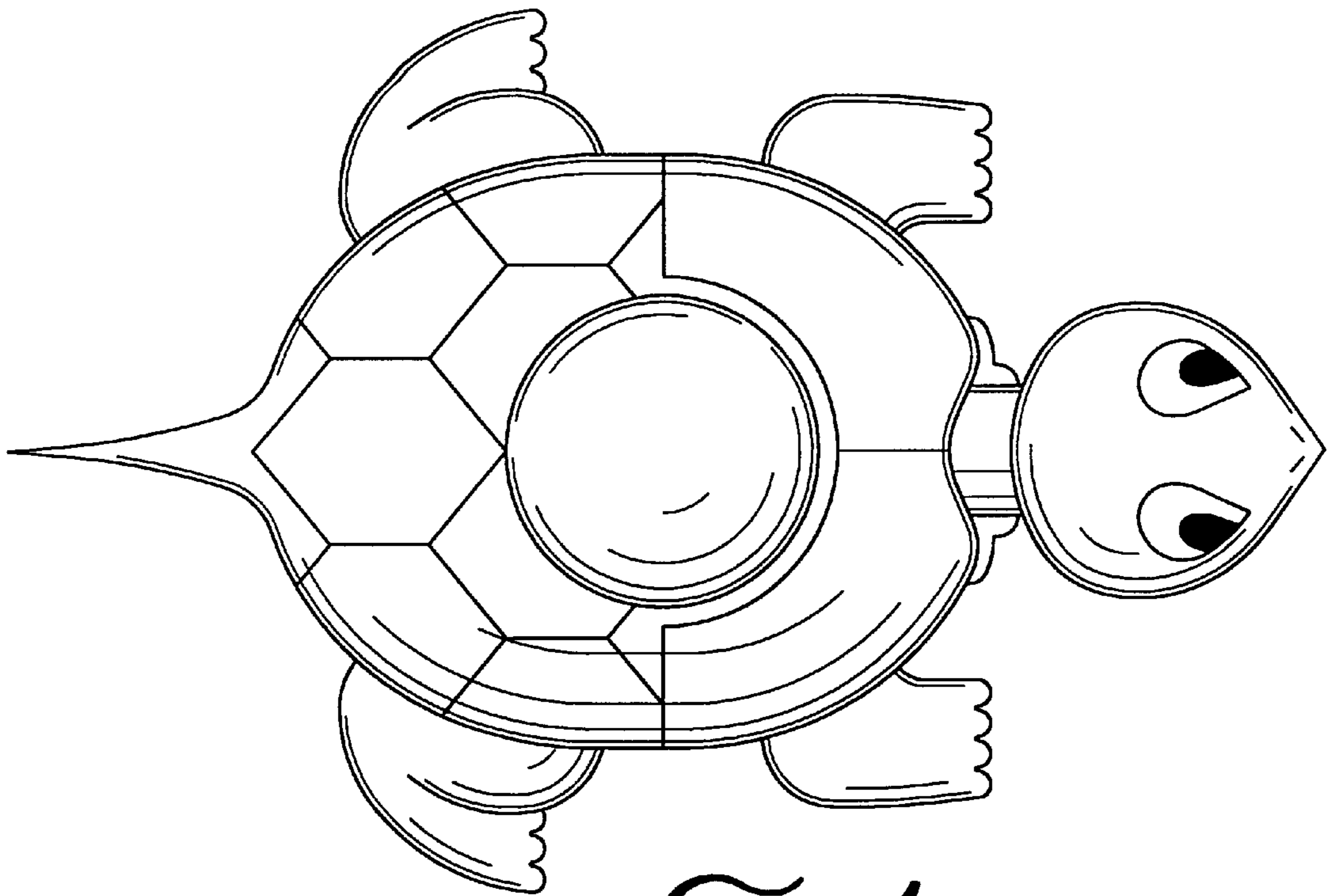

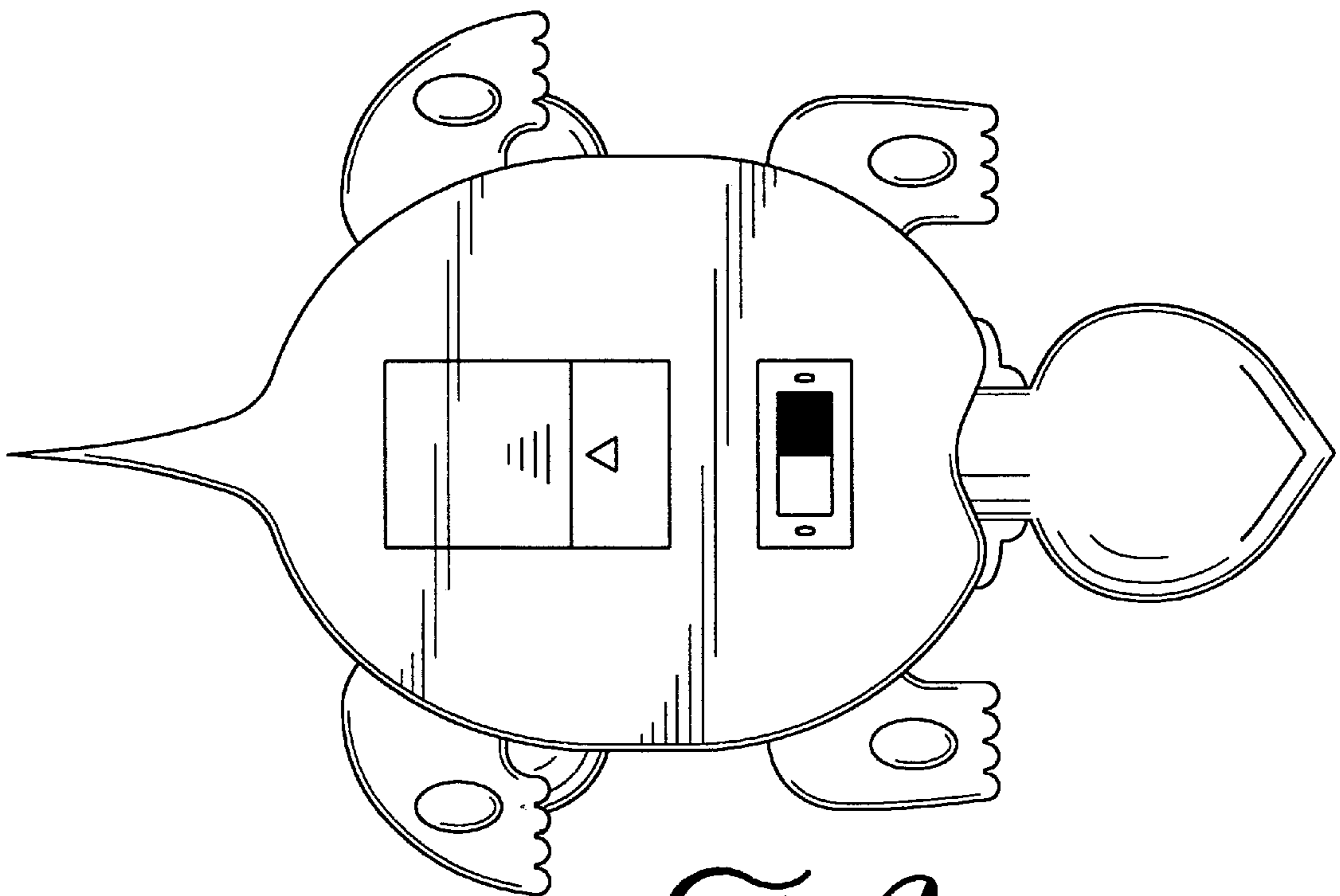

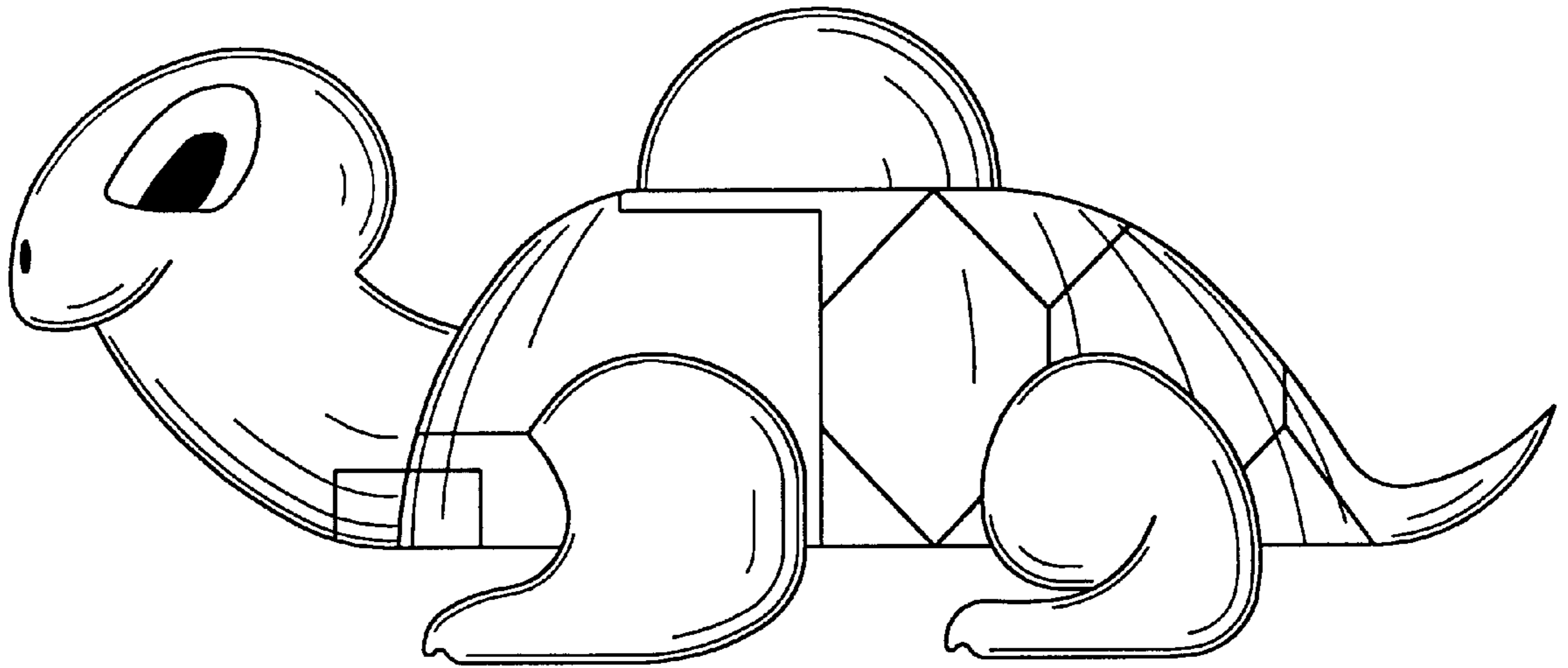

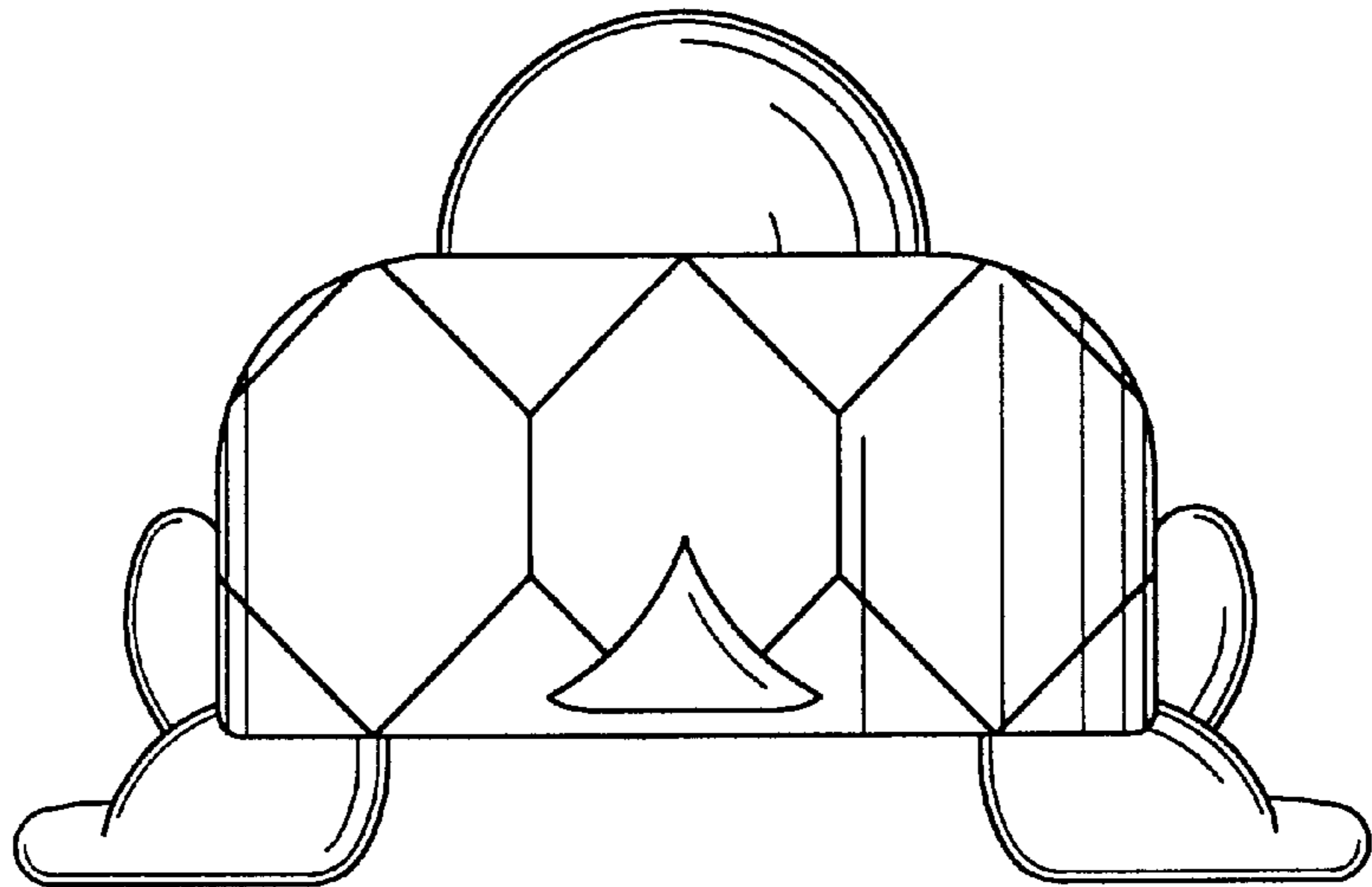

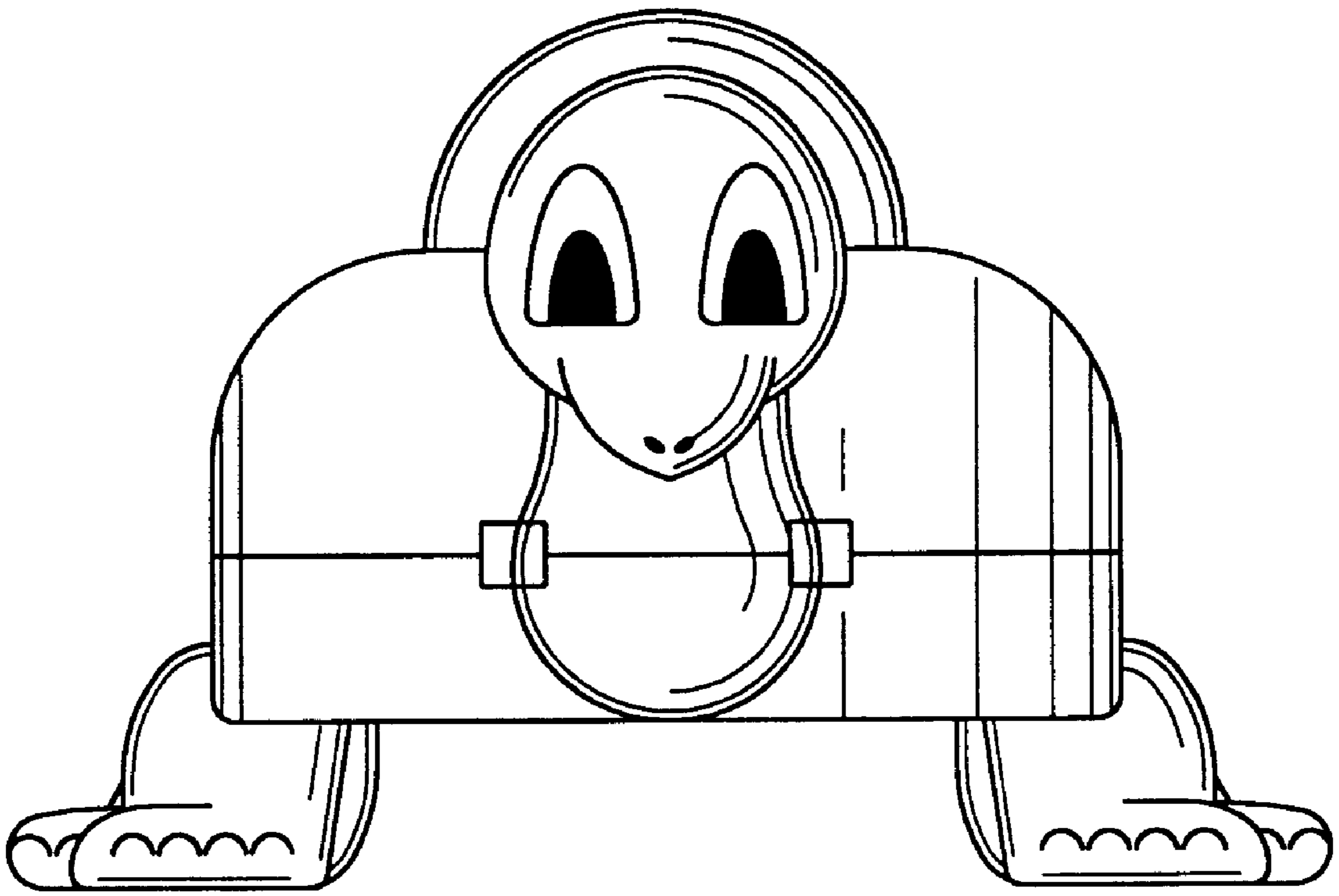
