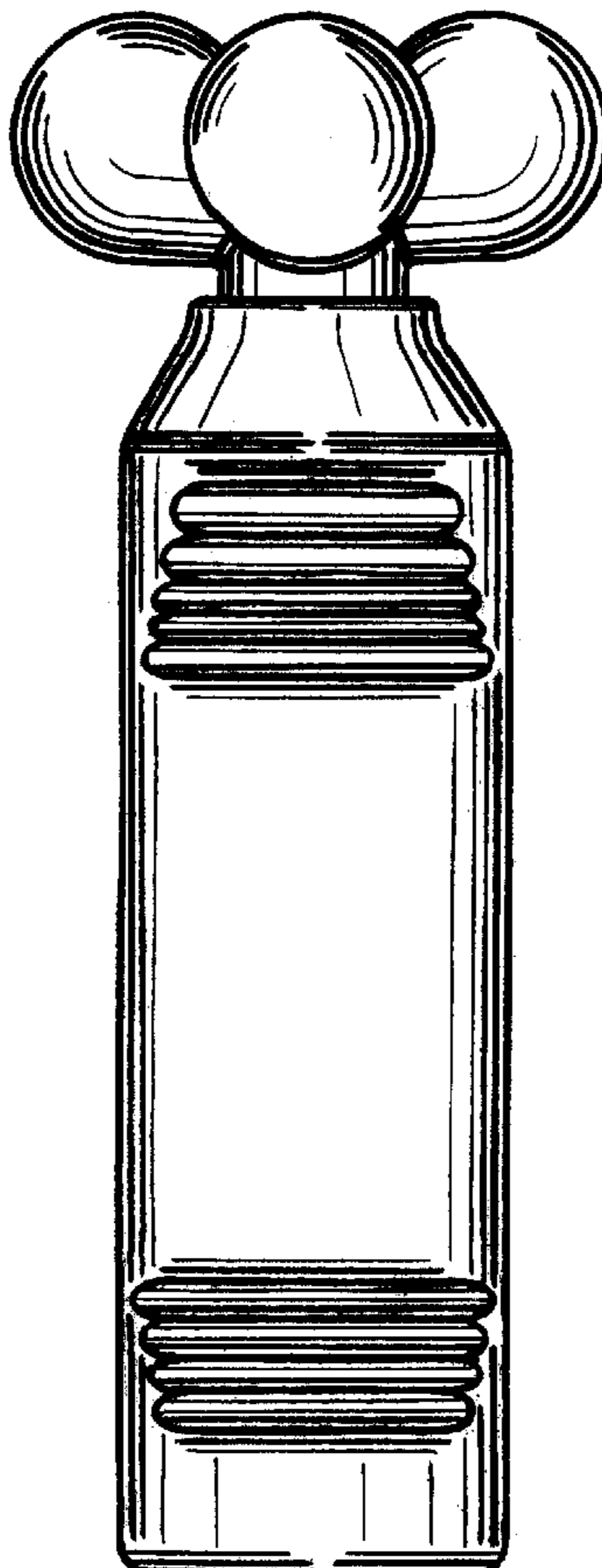

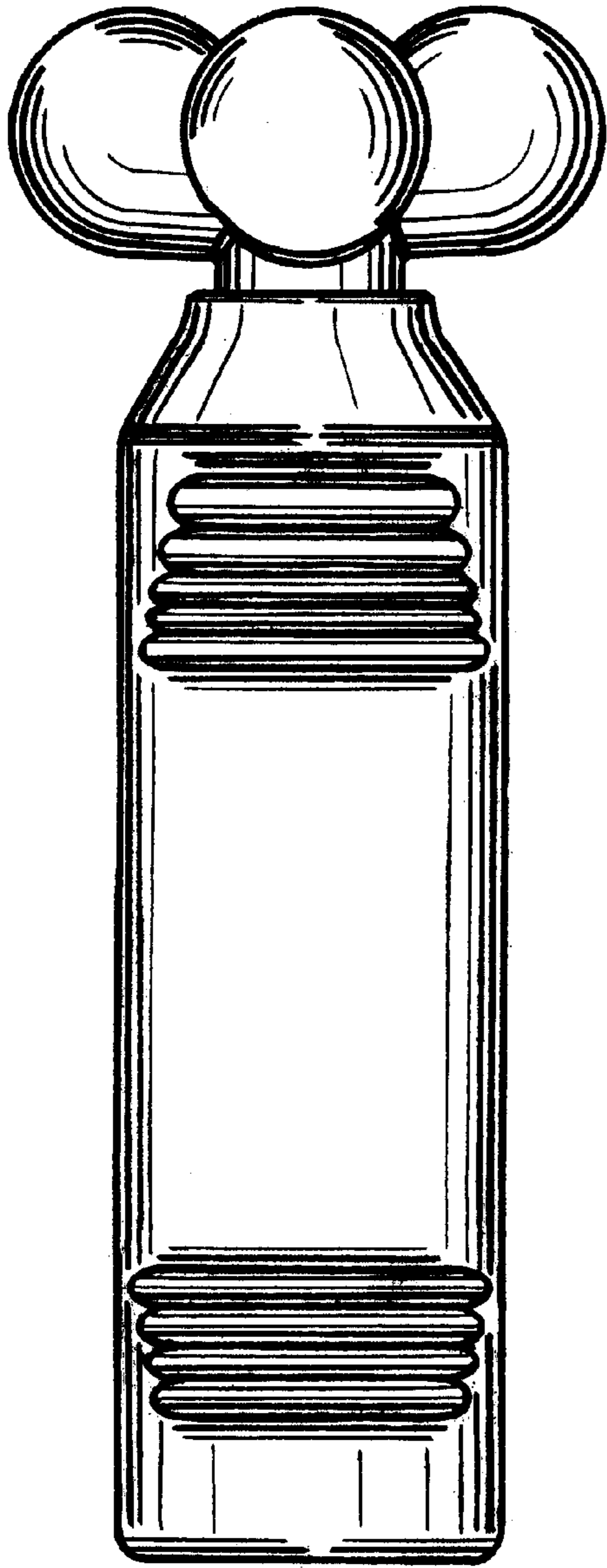
The ornamental design for a four headed marking device with a bottle, as shown.

**DESCRIPTION**

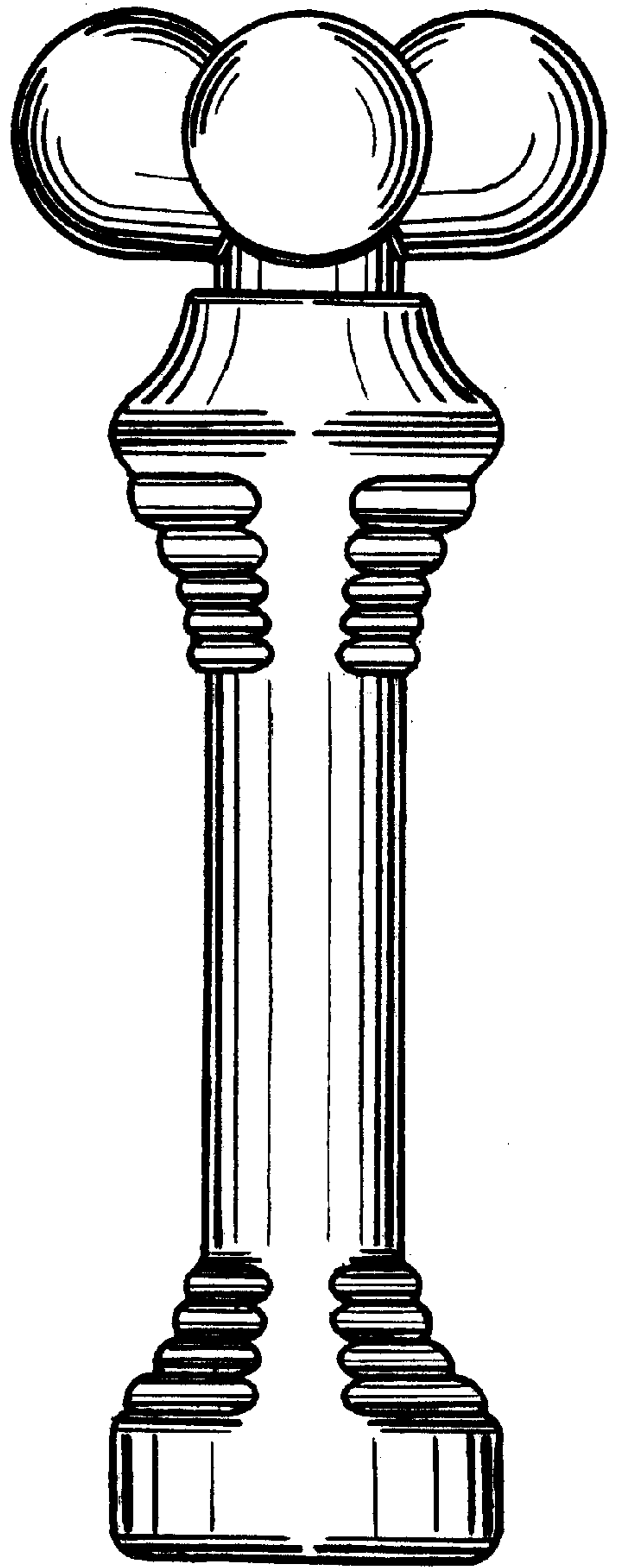

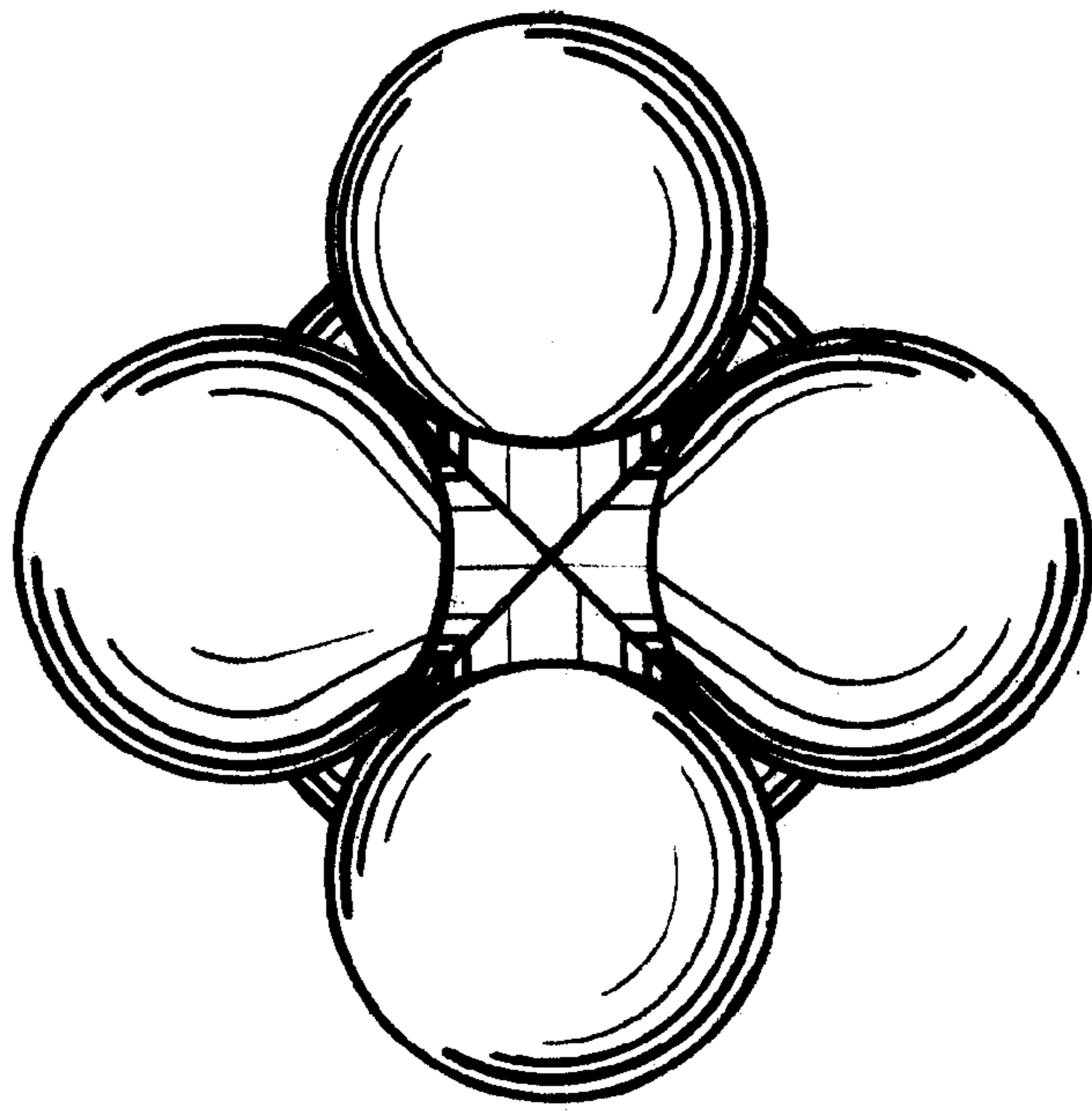

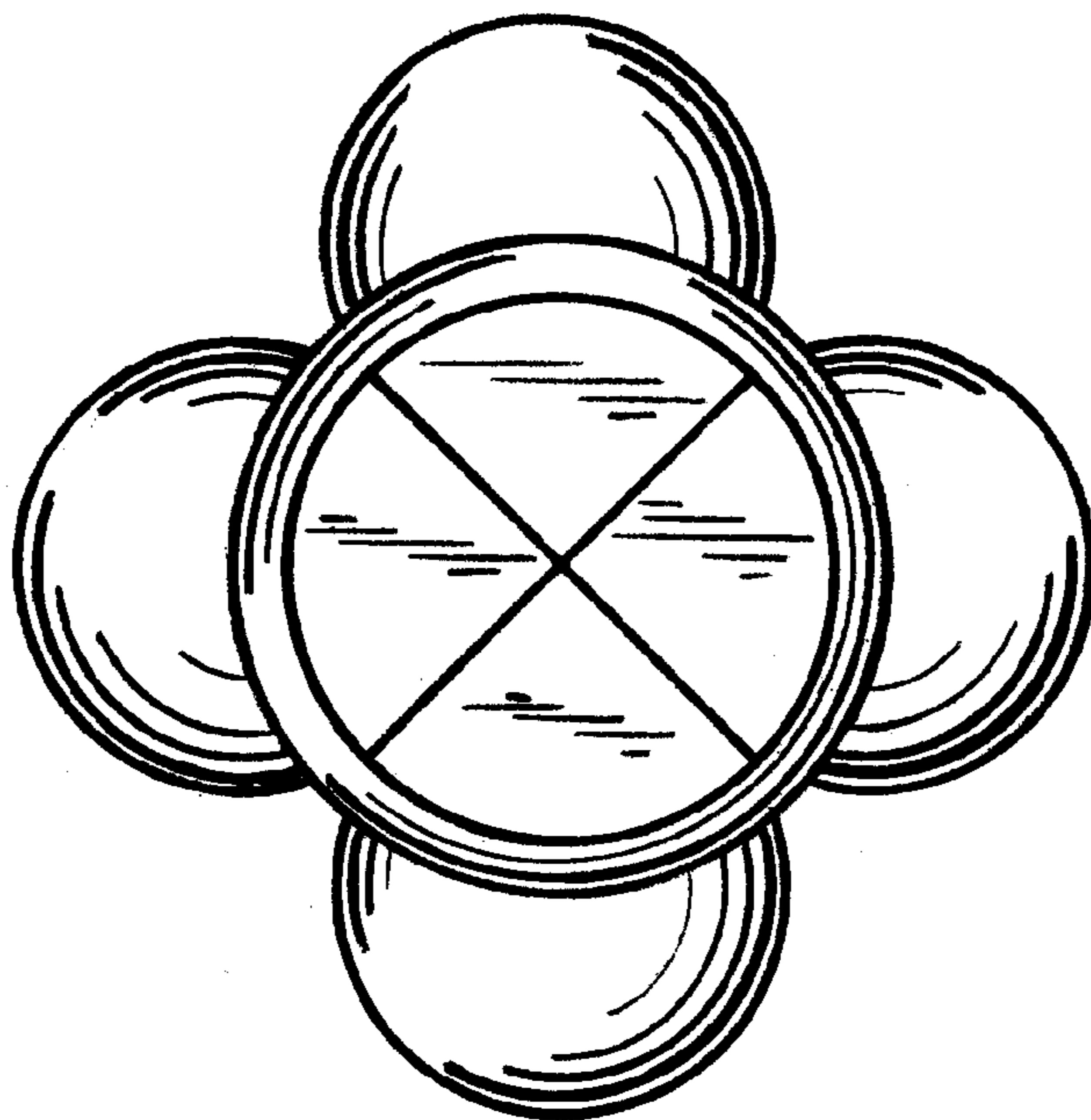
