(57) **CLAIM**

The ornamental design for the ball delivery retrieval and storage system, as shown and described.

DESCRIPTION

FIG. 1 is a perspective side view of a ball delivery retrieval and storage system.

FIG. 2 is a side view of the system of FIG. 1.

FIG. 3 is a top view of the system of FIG. 1.

FIG. 4 is a front view of the system of FIG. 1.

FIG. 5 is a back view of the system of FIG. 1.

FIG. 6 is a bottom view of the system of FIG. 1.

FIG. 7 is a partial enlarged perspective view of the top and of the system of FIG. 1.

FIG. 8 is a partial enlarged perspective view of the bottom end of the system of FIG. 1; and,

FIG. 9 is a partial enlarged perspective view of the bottom end and from a perspective different than FIG. 8 of the system of FIG. 1.
