FIG. 5 is a rear view of the dog bone-shaped light for pet collar of FIG. 1.

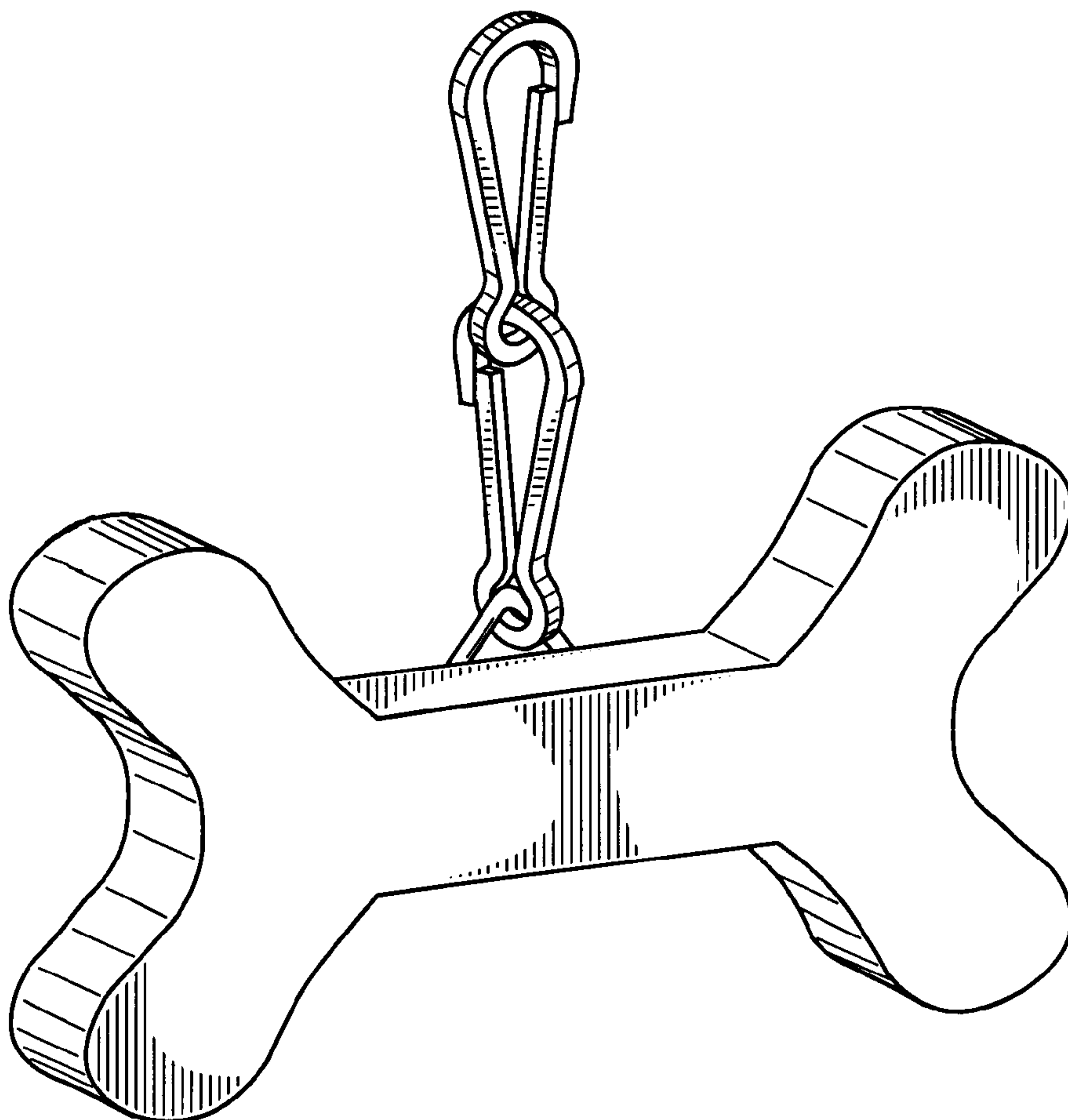
FIG. 6 is a top view of the dog bone-shaped light for pet collar of FIG. 1; and,

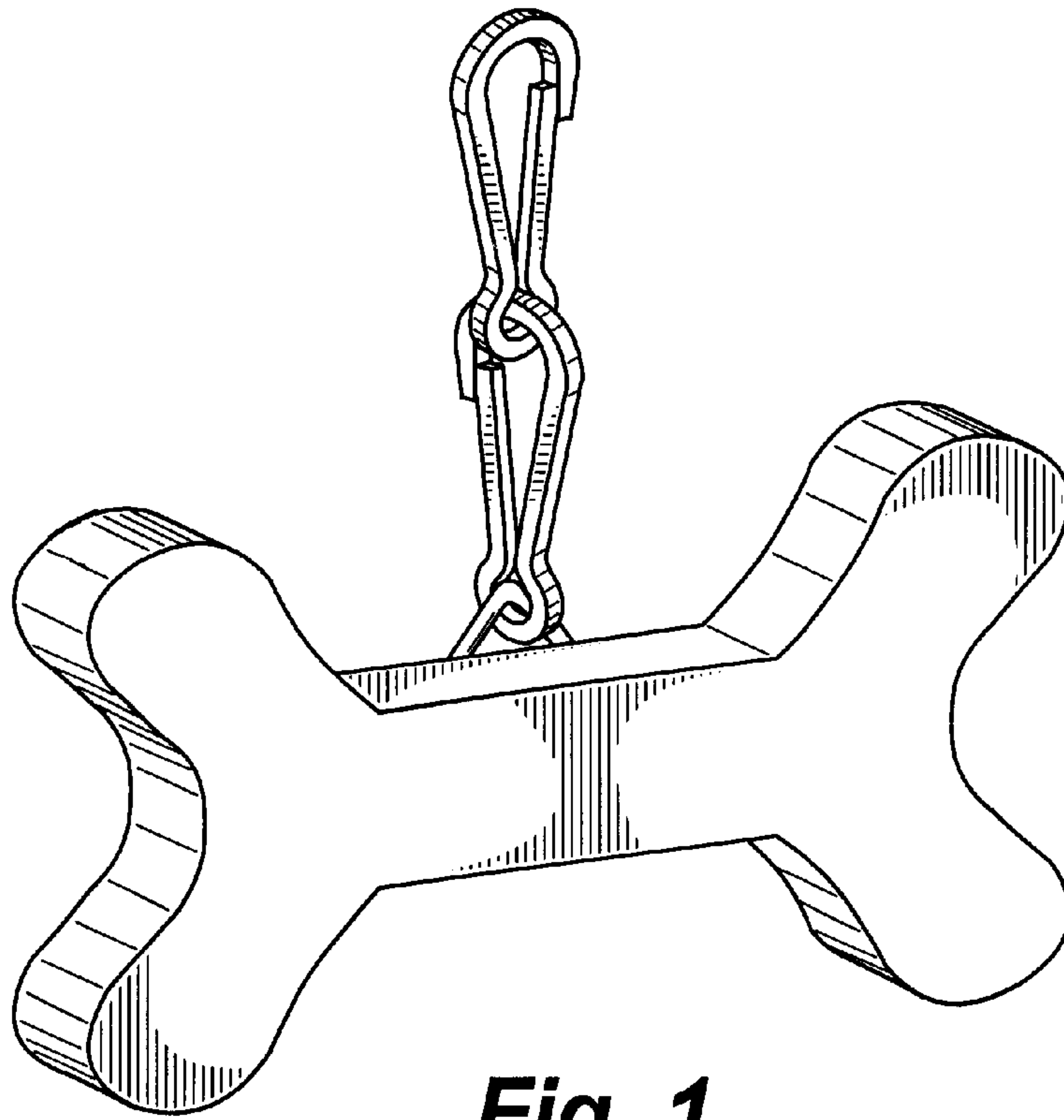
FIG. 7 is a bottom elevation view of the dog bone-shaped light for pet collar of FIG. 1.

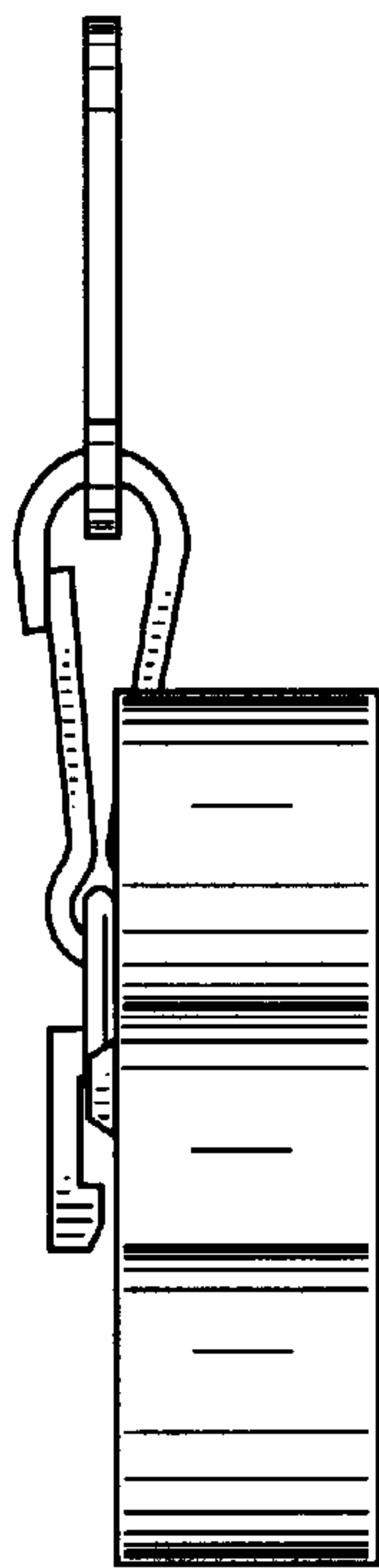

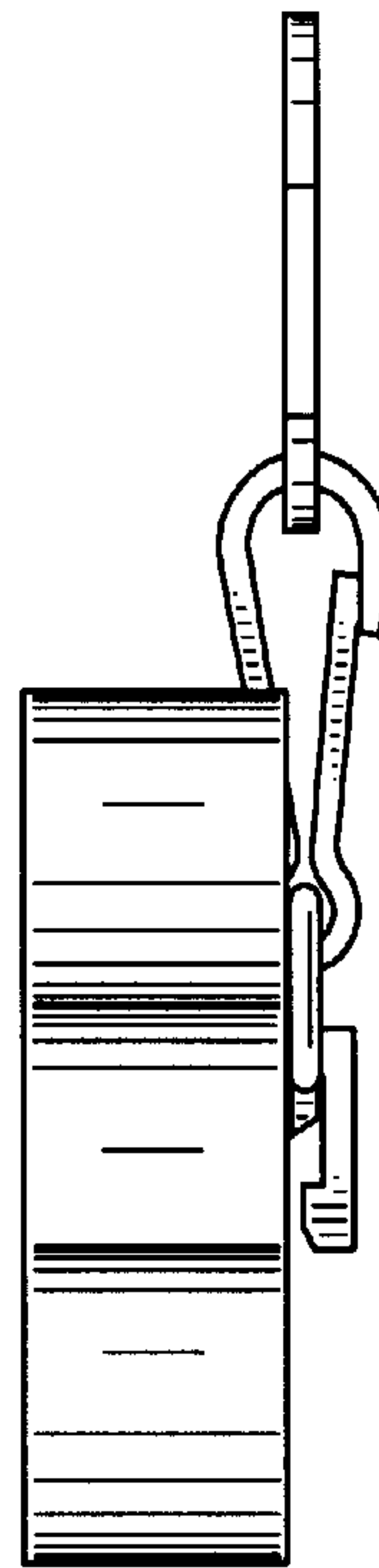

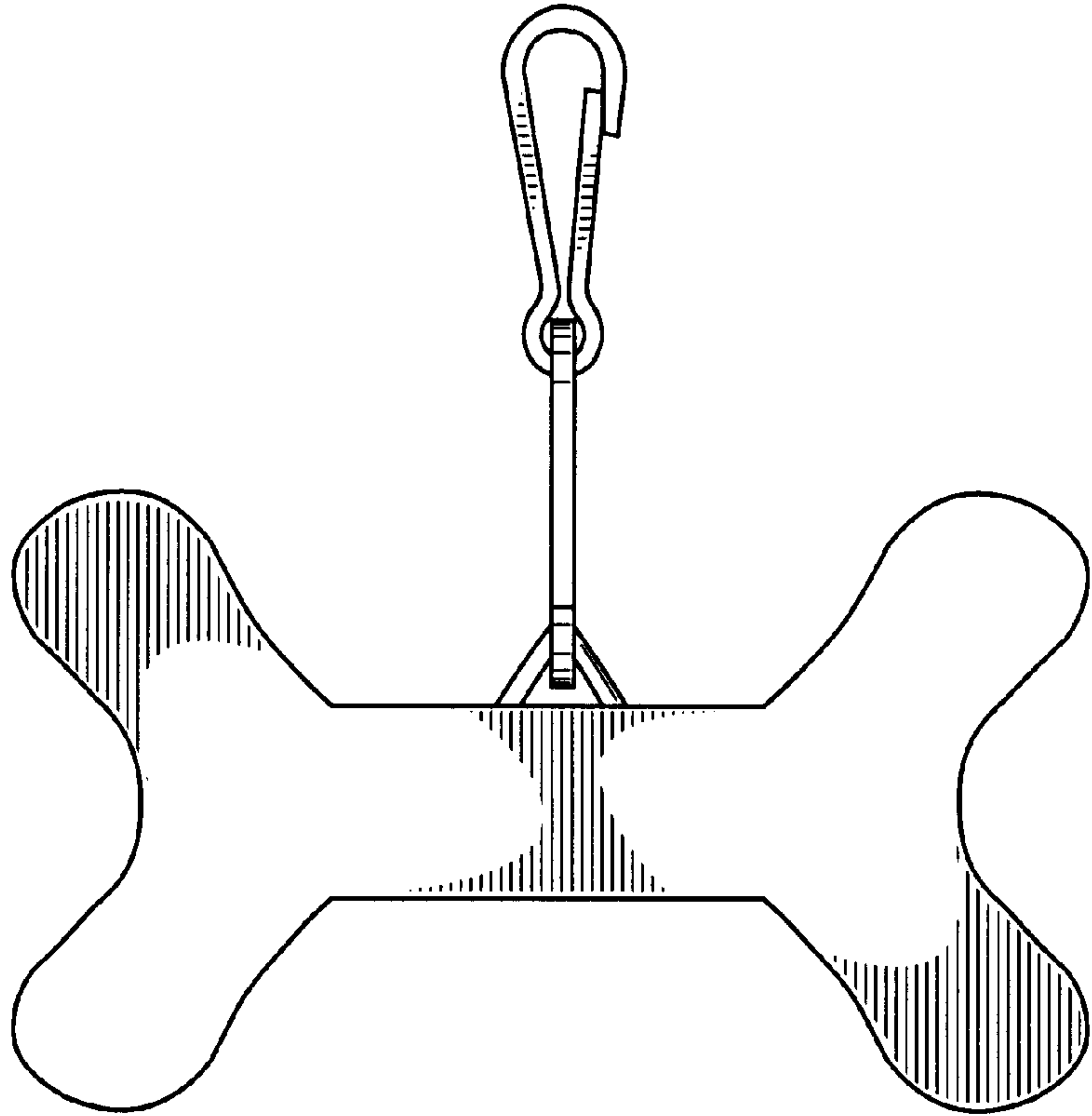

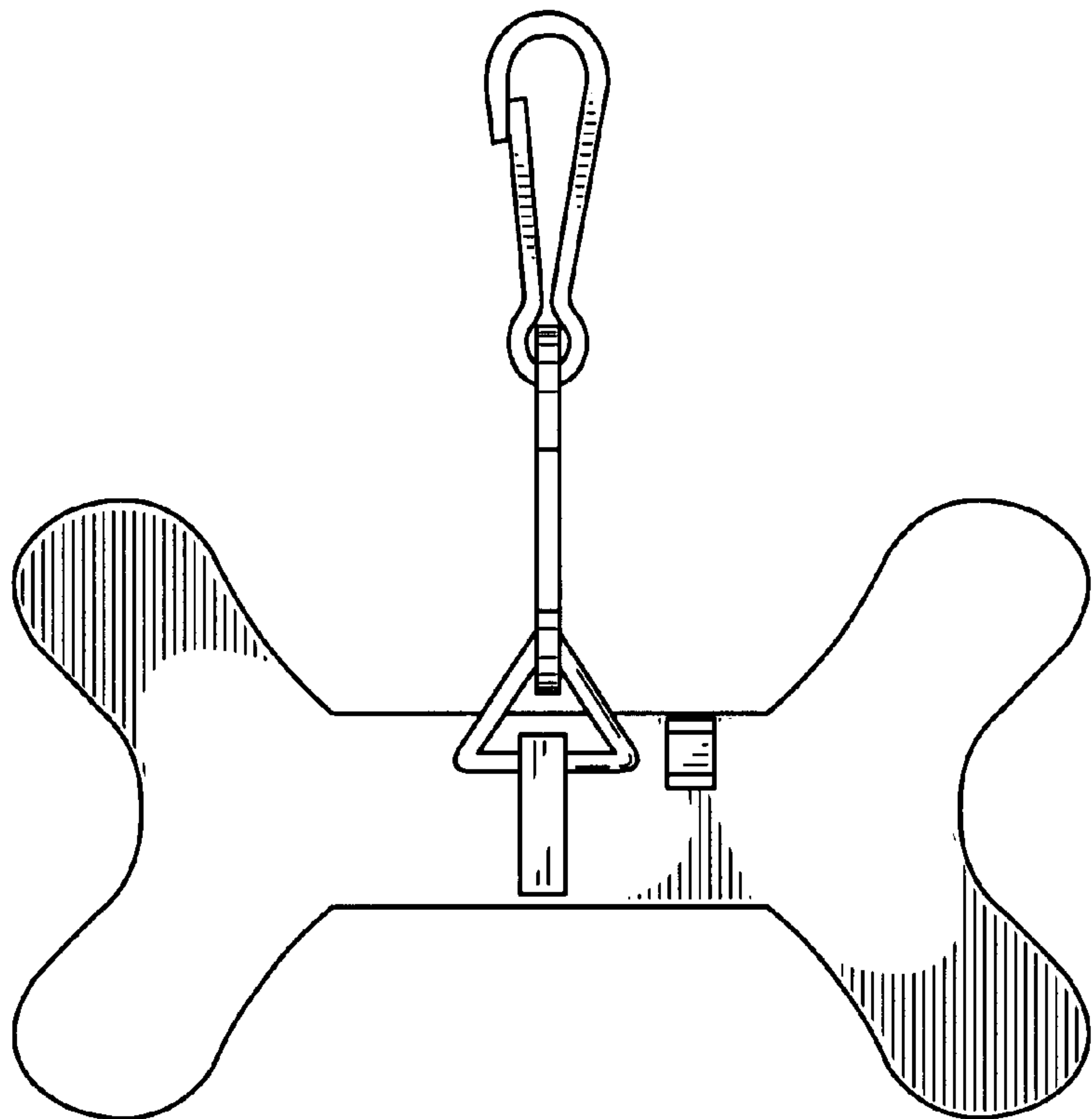


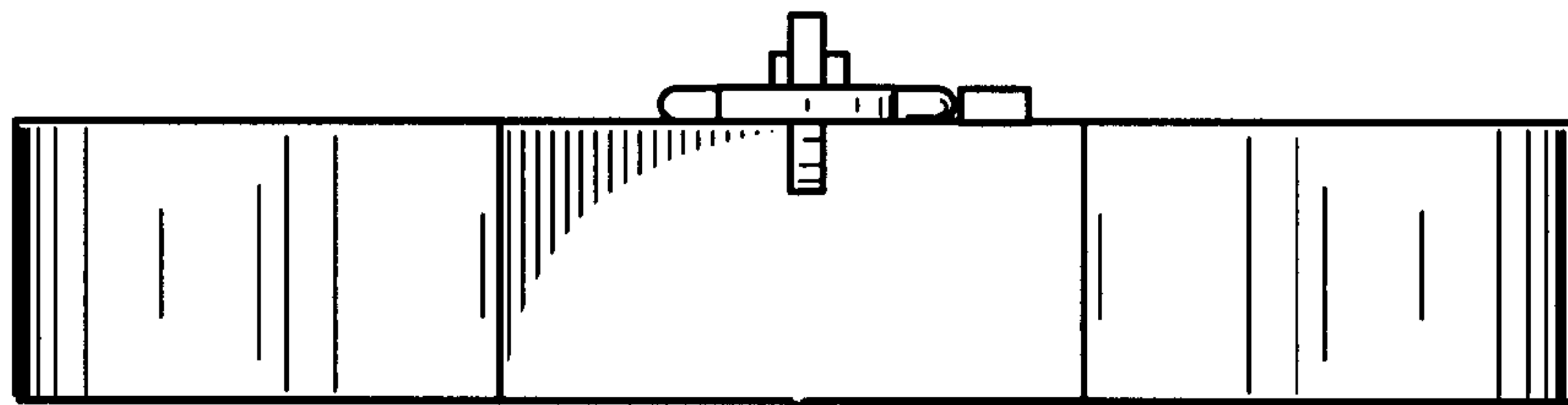

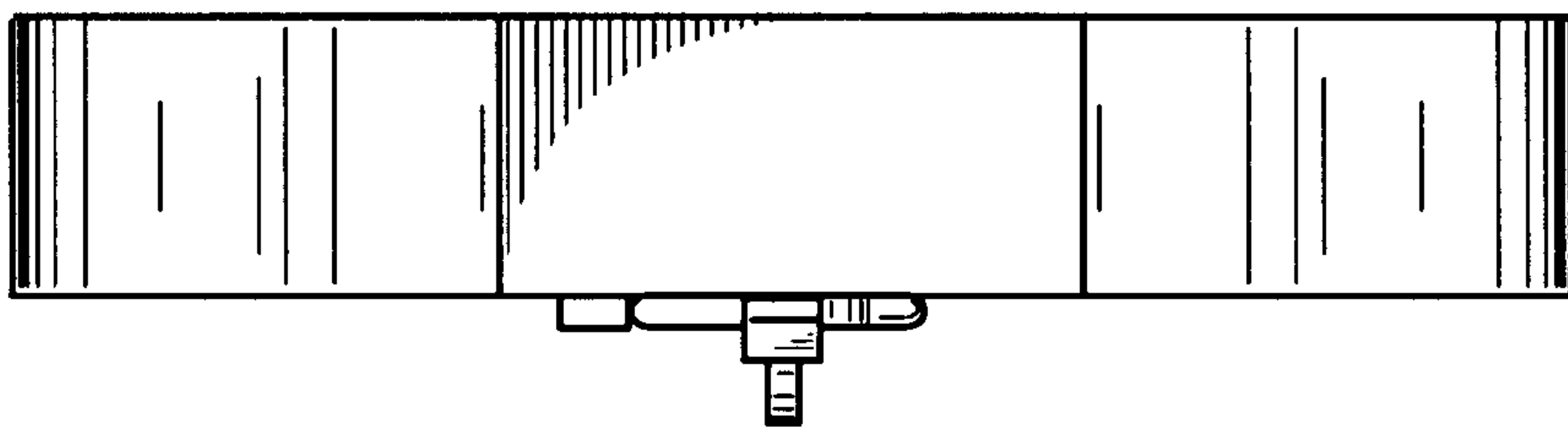
