FIG. 4 is a right-side view of an ergonomic glove, showing our new ornamental design.

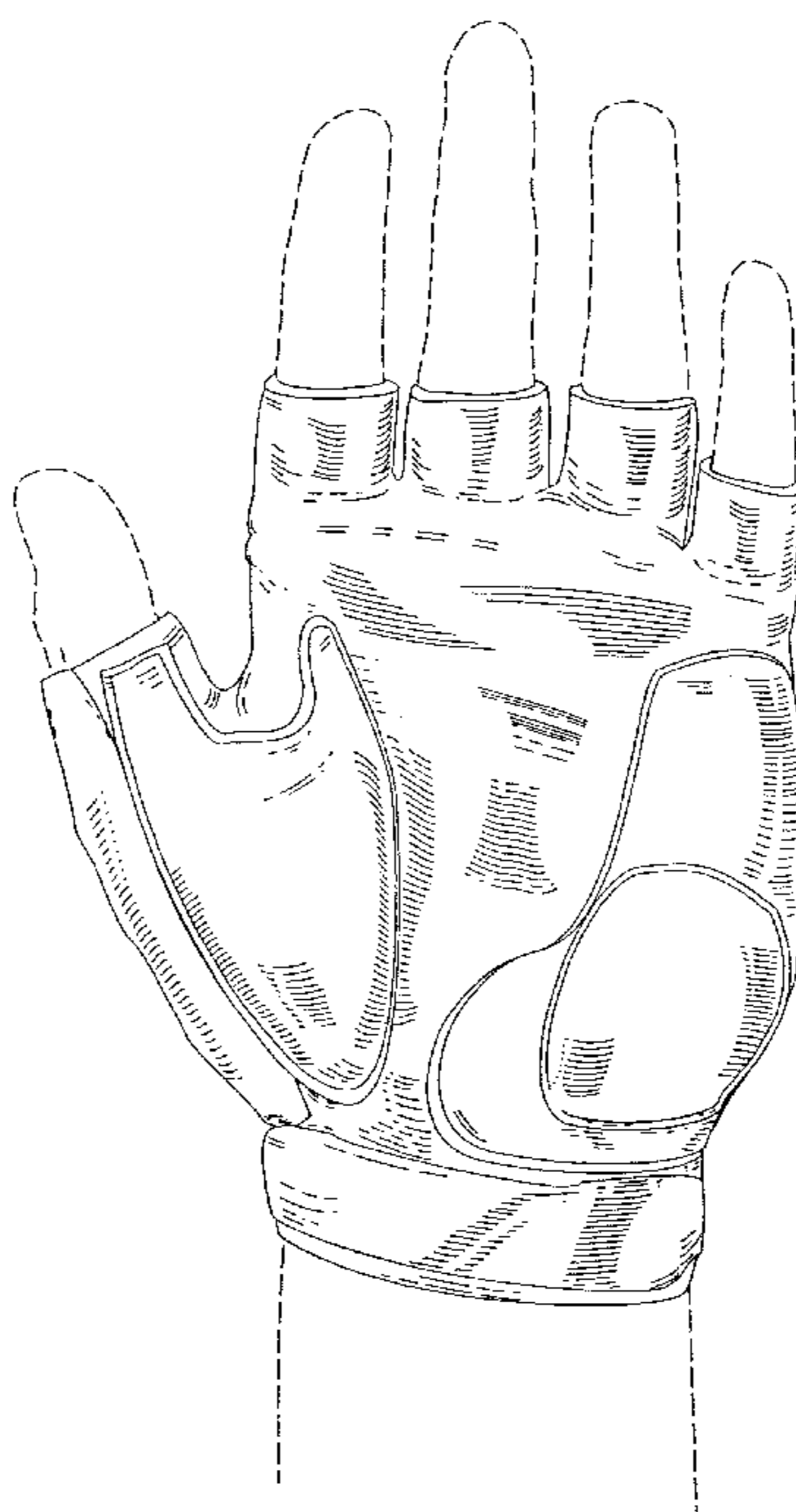
FIG. 5 is a left-side view of an ergonomic glove, showing our new ornamental design.

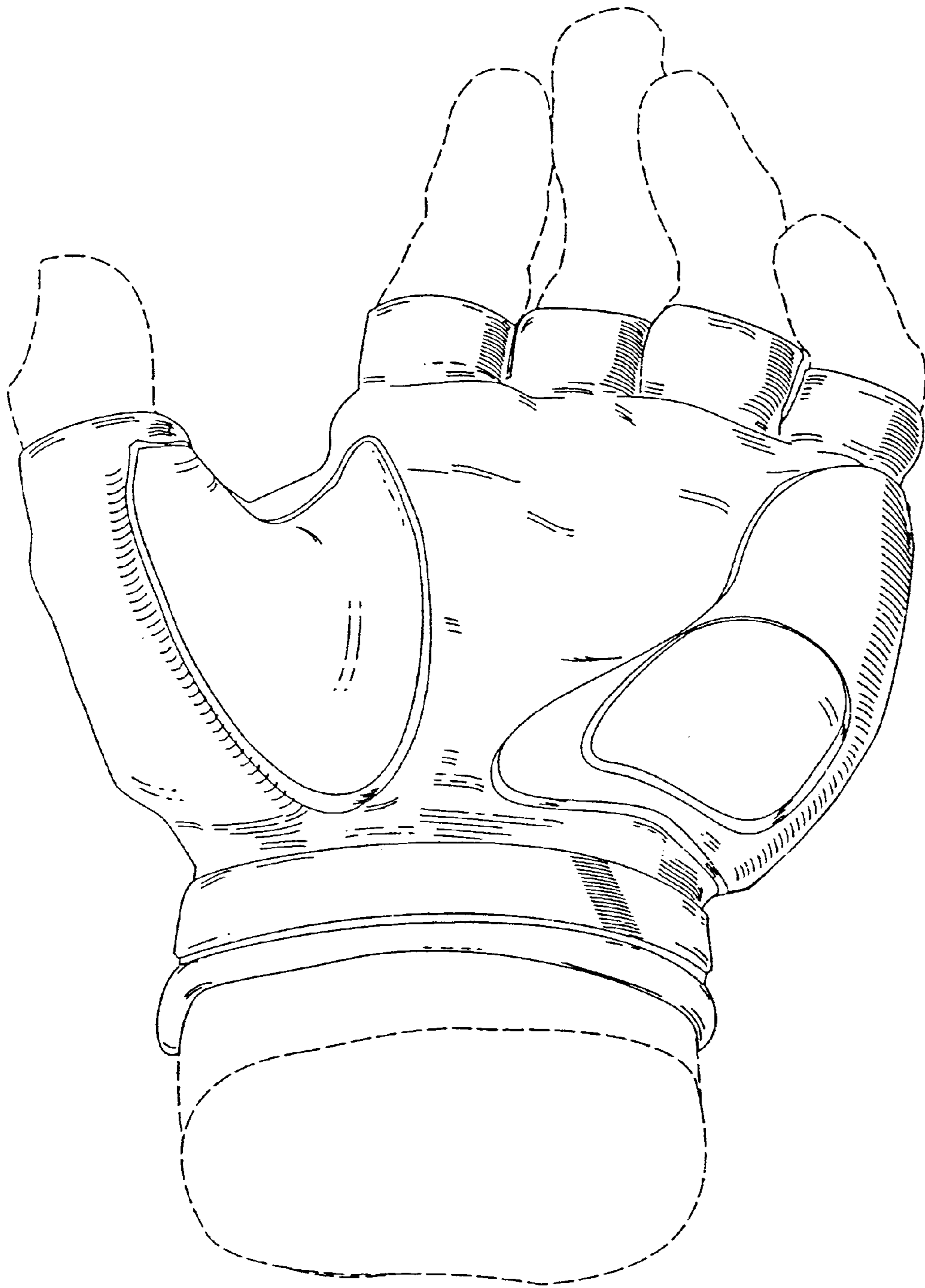

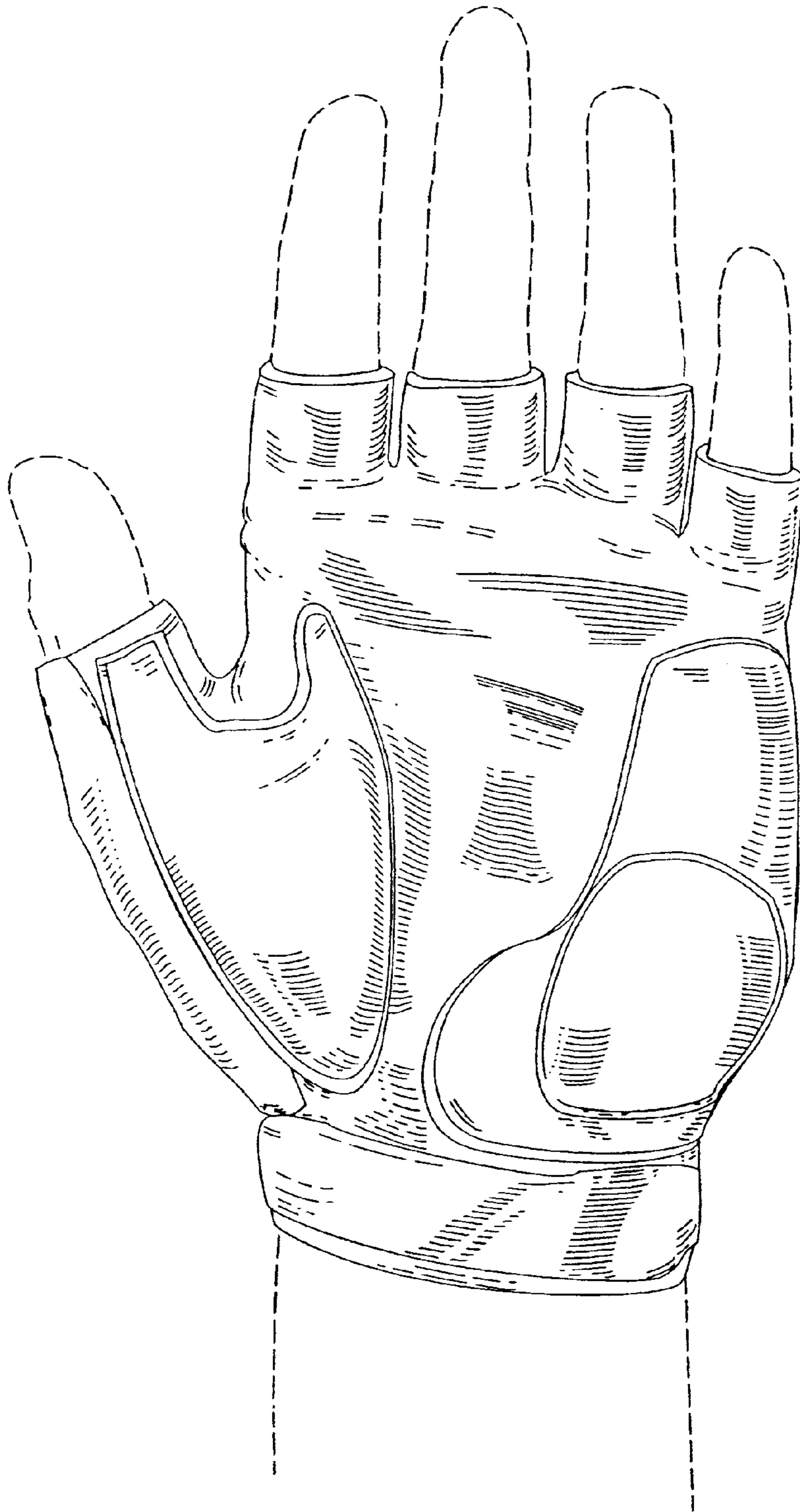

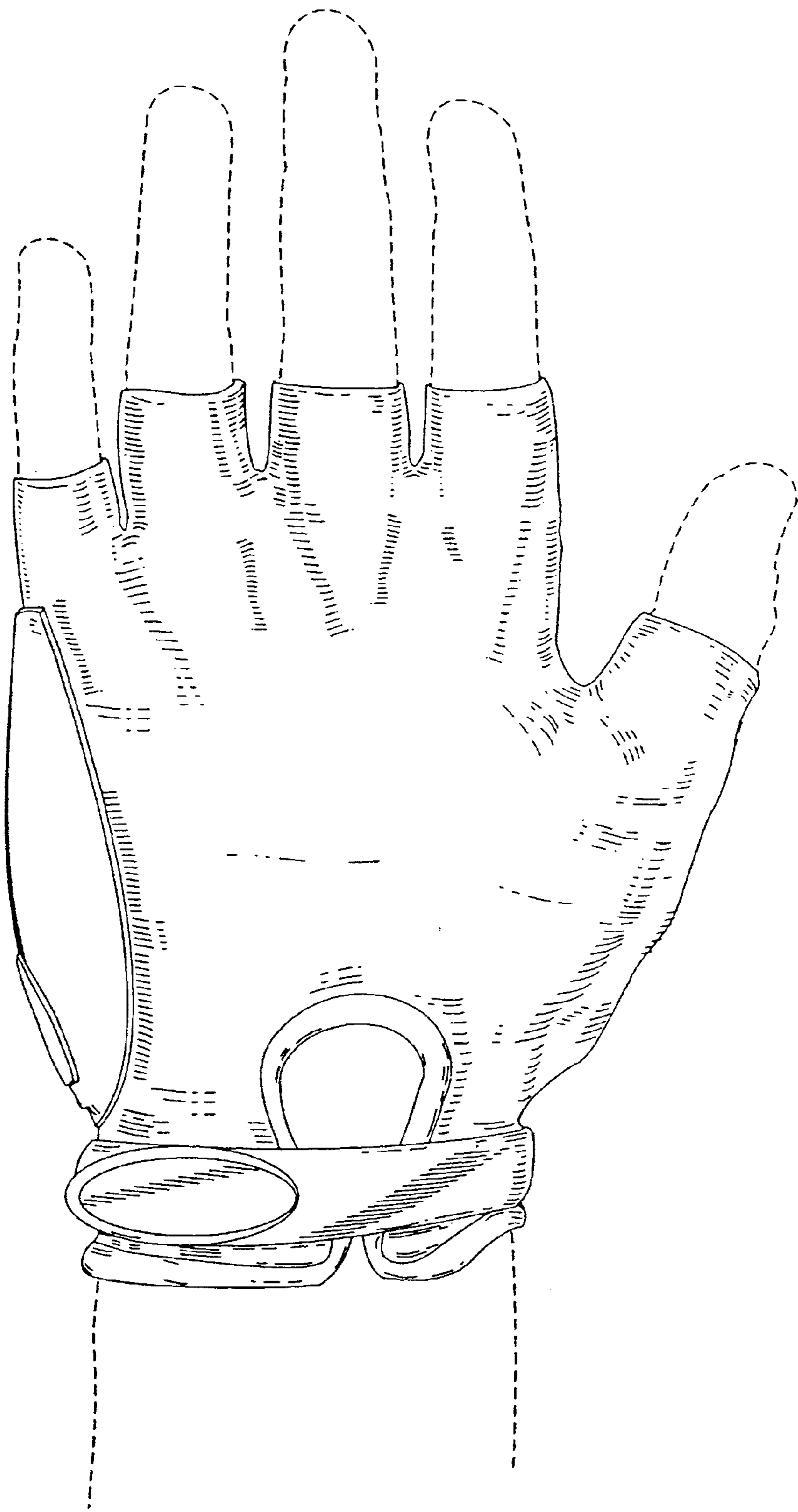

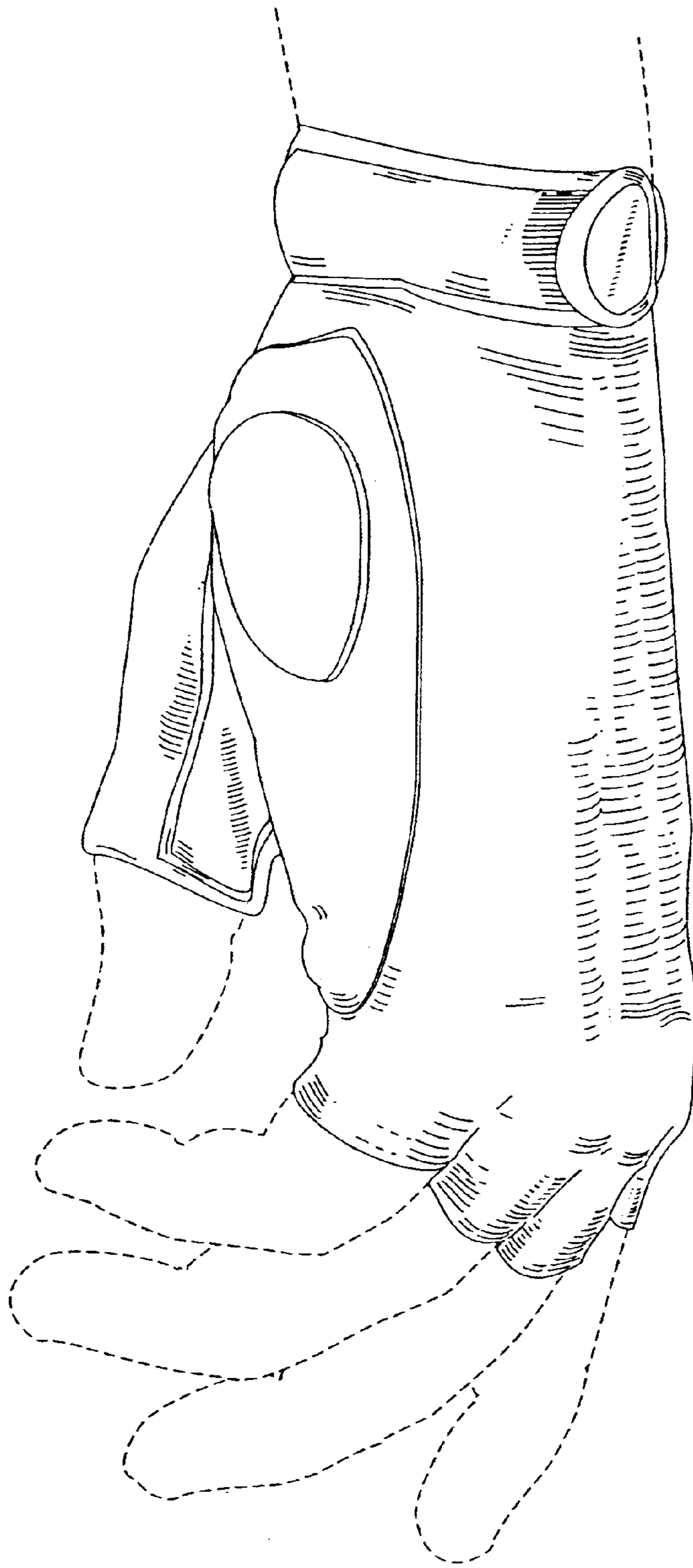

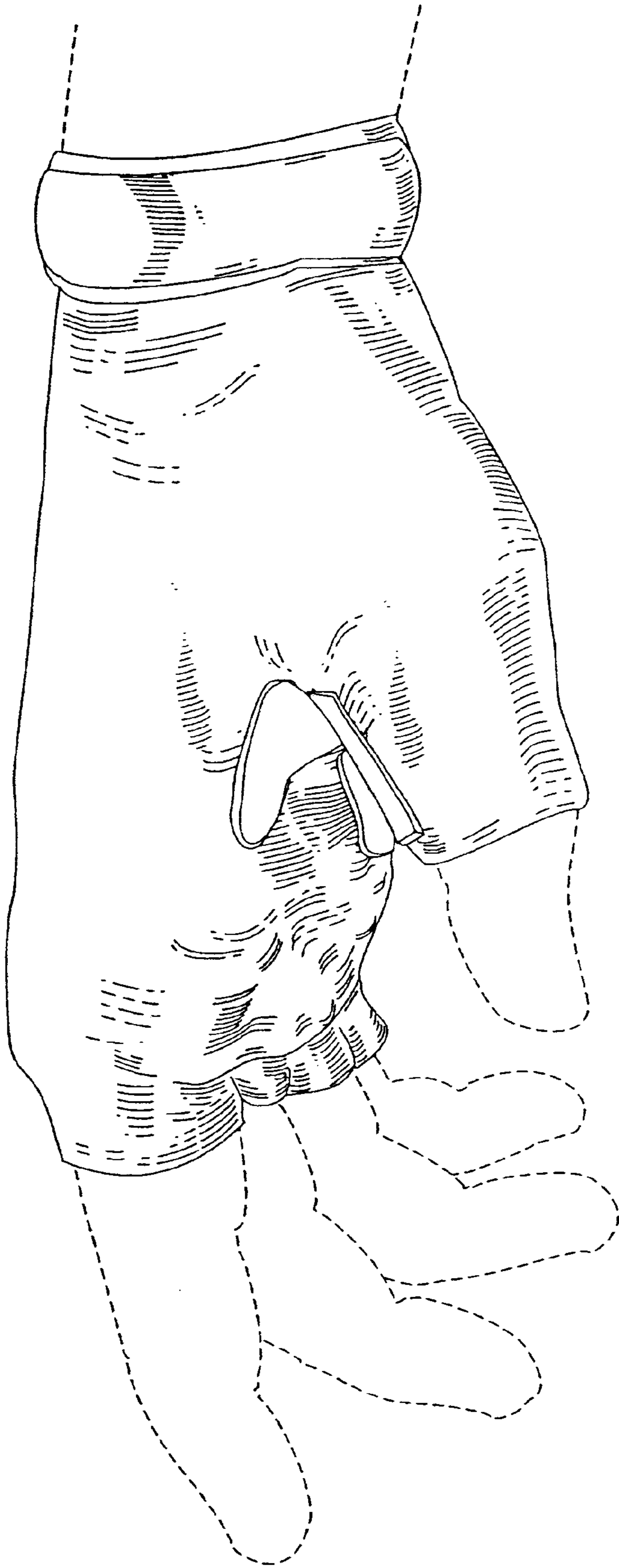

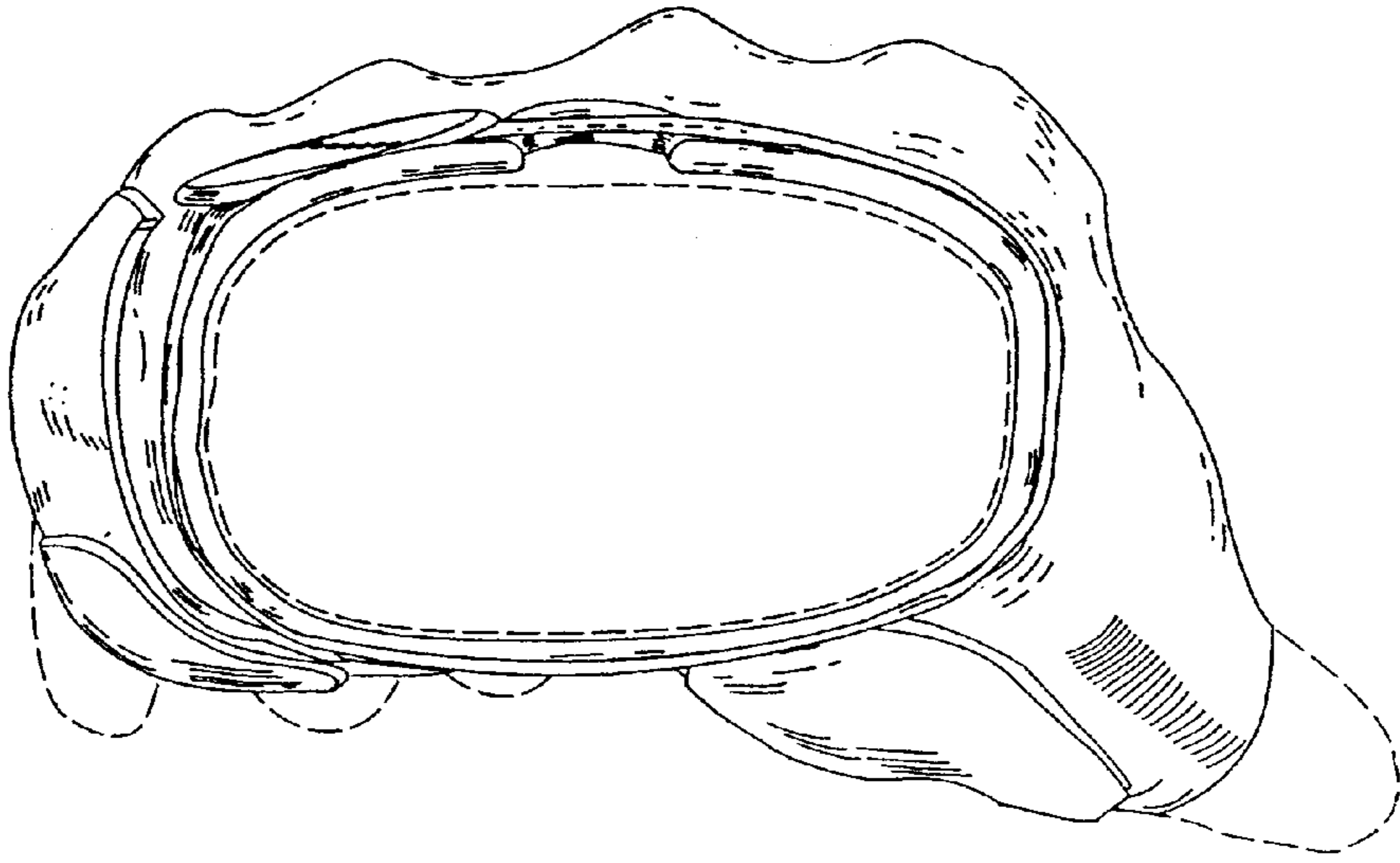

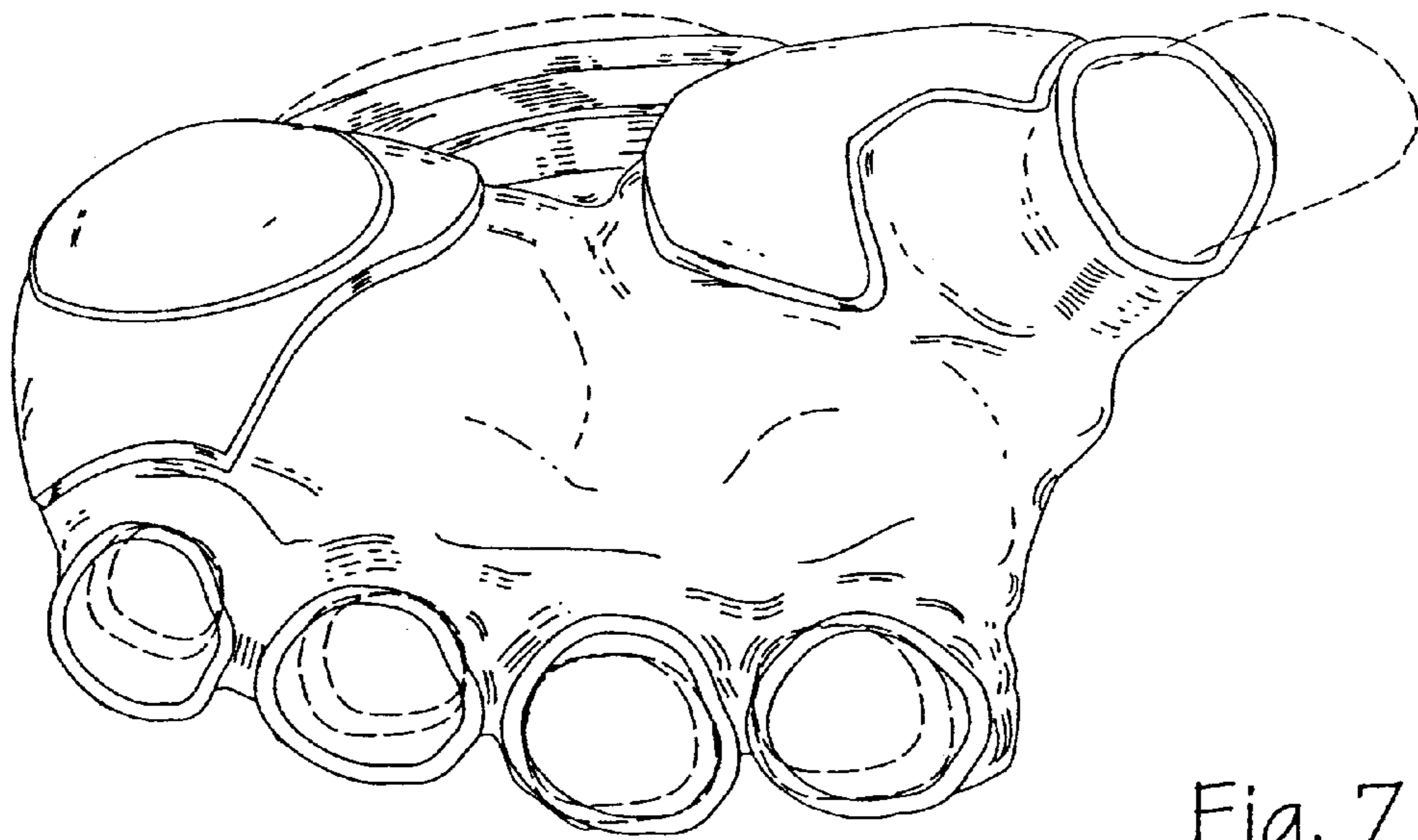
