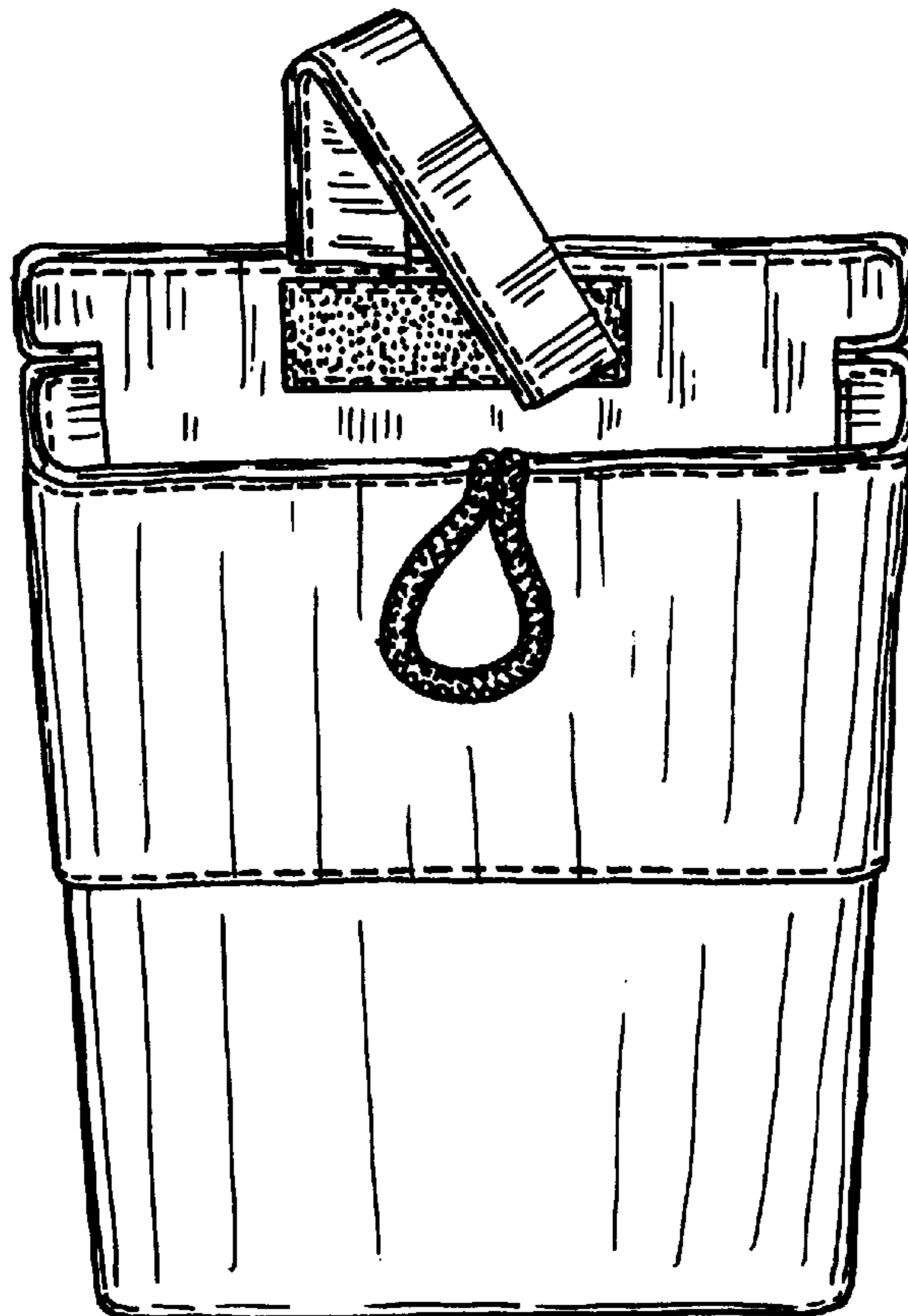
(57) **CLAIM**

The ornamental design for a pet waste container, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a pet waste container showing my new design;
 FIG. 2 is a front elevational view thereof;
 FIG. 3 is a rear elevational view thereof;
 FIG. 4 is a left side elevational view thereof;
 FIG. 5 is a right side elevational view thereof;
 FIG. 6 is a top plan view thereof; and,
 FIG. 7 is a bottom plan view thereof.
 The broken lines in FIG. Nos. 3 and 4 are for purposes of illustration only and form no part of the claimed design. The dashed lines in all of the figures represent conventional stitching.

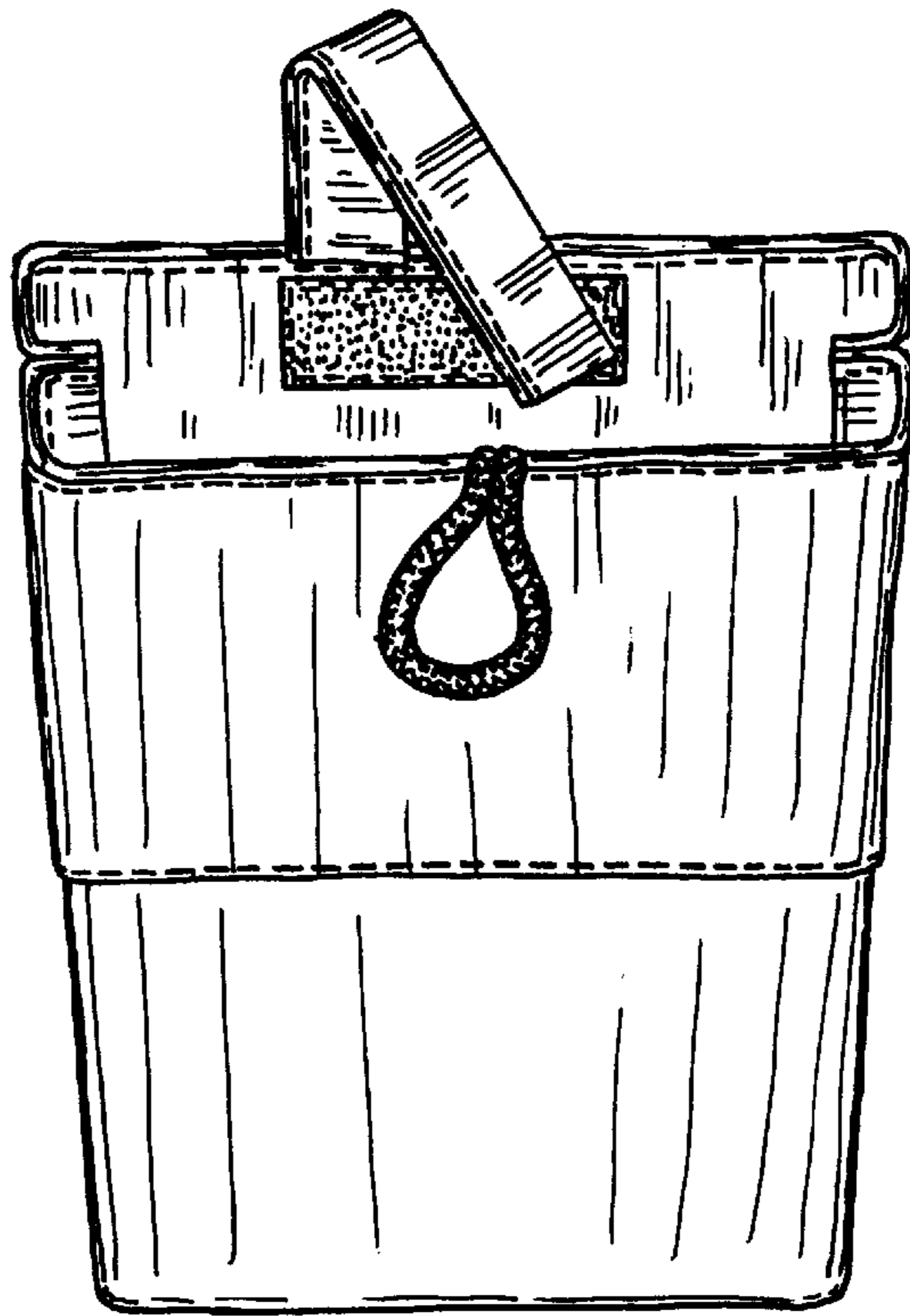

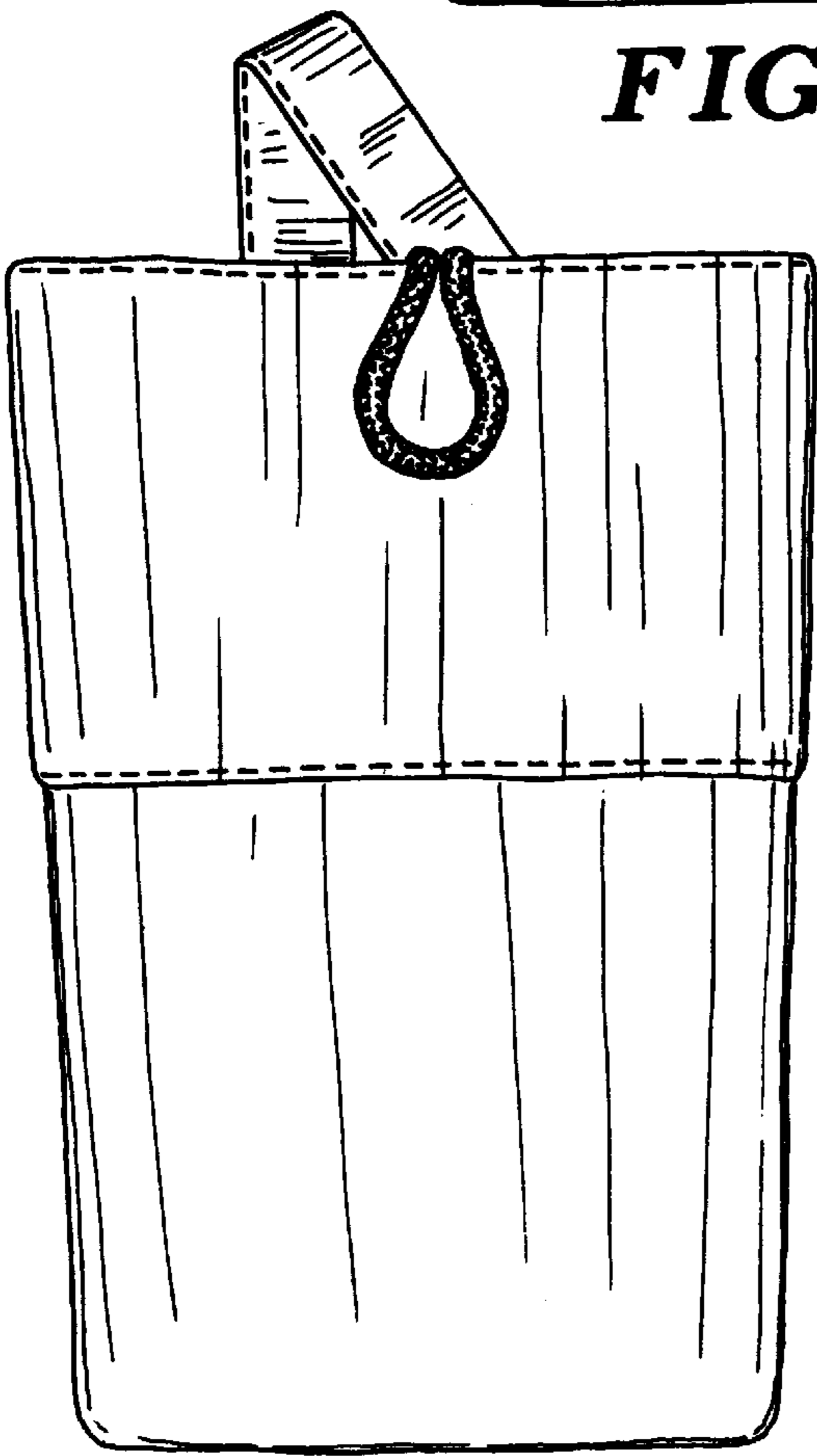

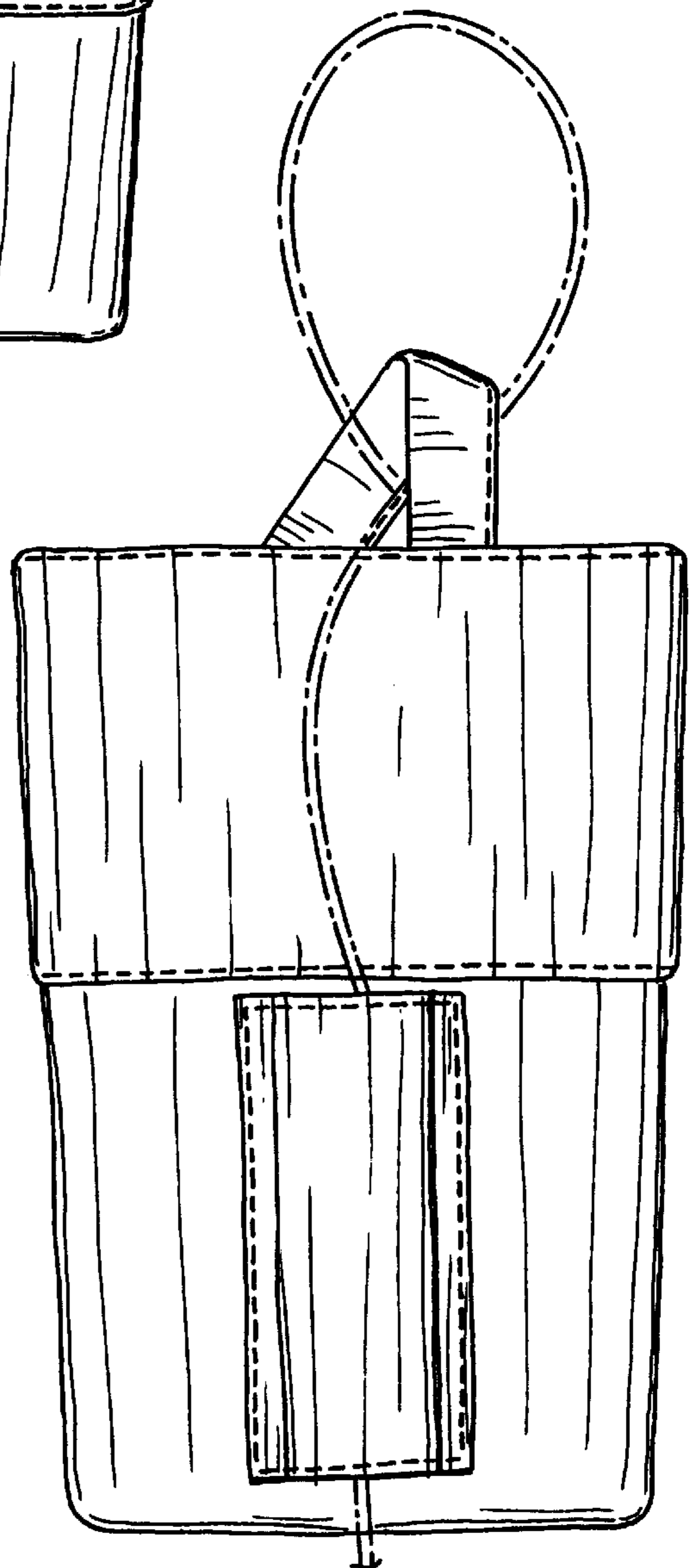

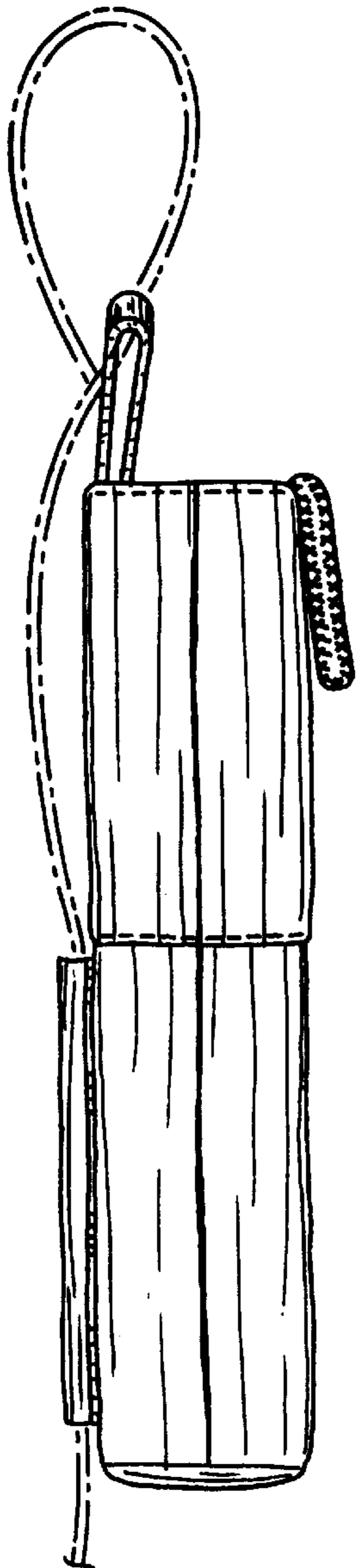

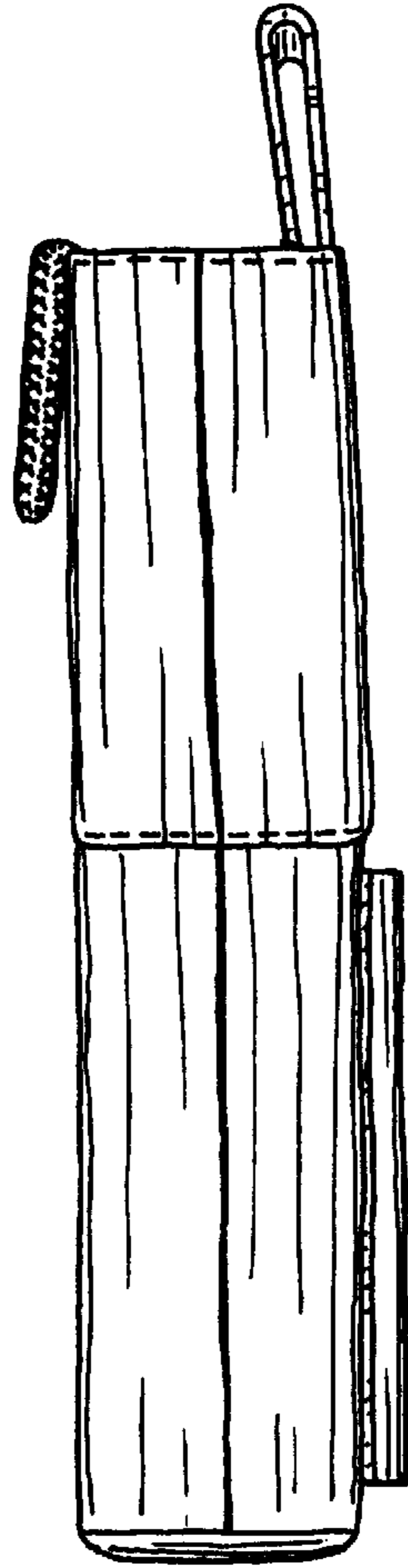

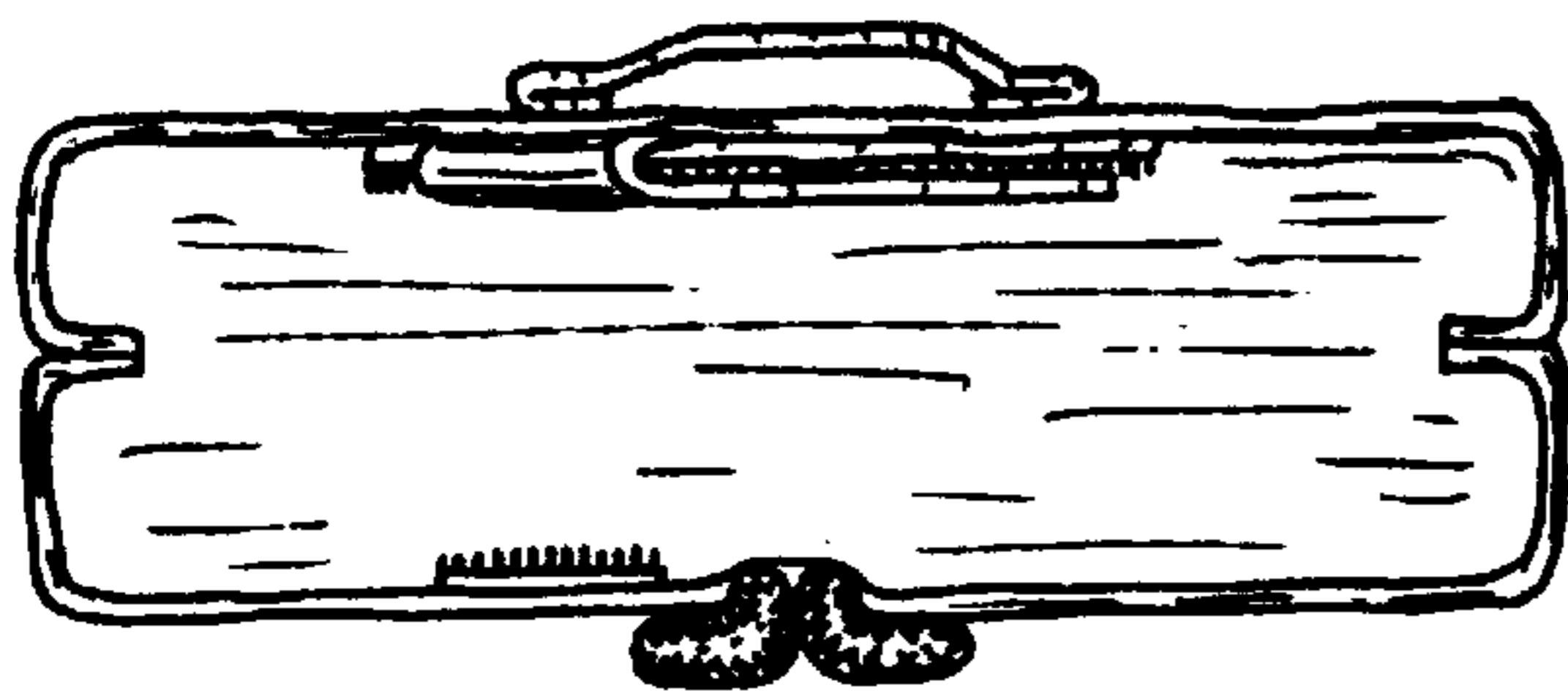

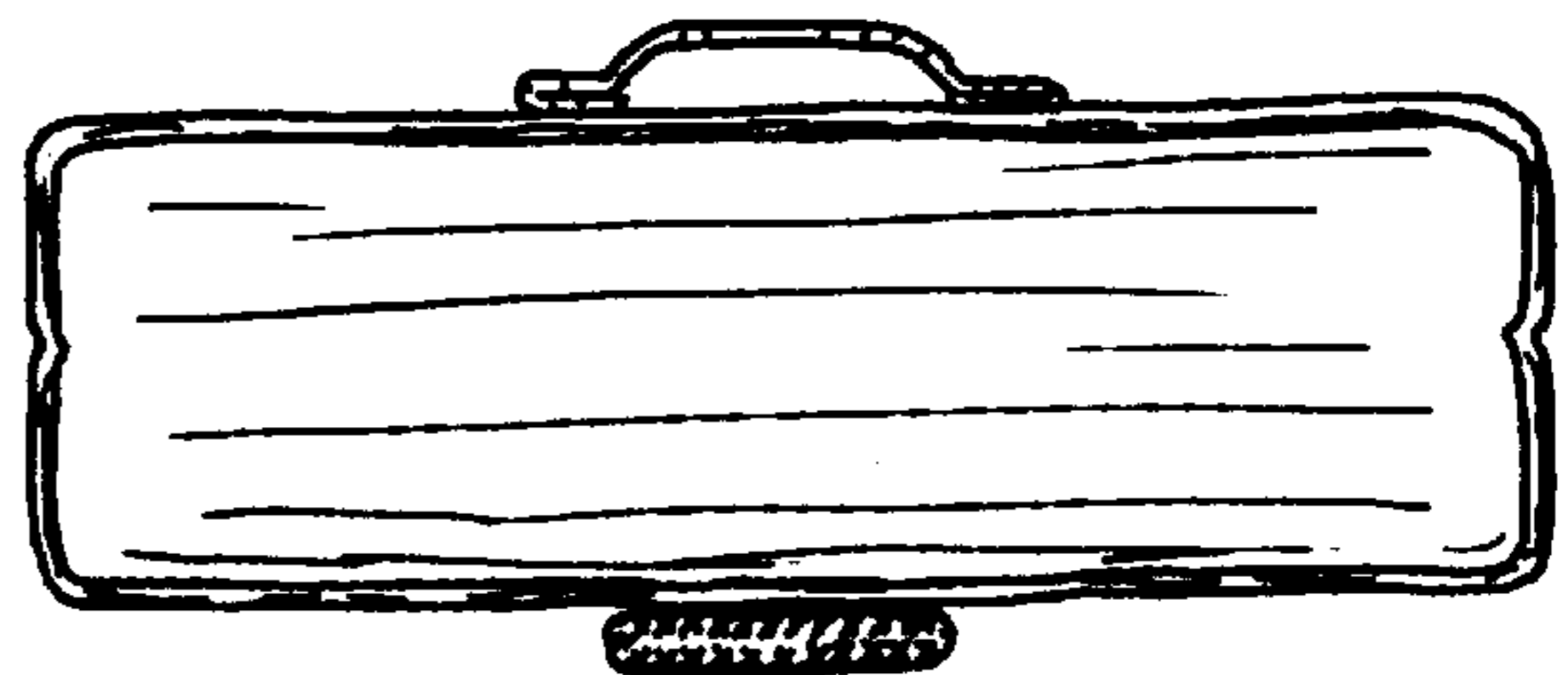
