(57) **CLAIM**

The ornamental design for a removable athletic arm sleeve, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the present invention of a removable athletic arm sleeve;

FIG. 2 is a top plan view of said removable athletic arm sleeve;

FIG. 3 is a bottom plan view of said removable athletic arm sleeve;

FIG. 4 is a front end view of said removable athletic arm sleeve; and,

FIG. 5 is a rear end view of said removable athletic arm sleeve.

The fragmentary criss-cross pattern shown in the drawings is understood to represent fabric and is repeated uniformly throughout the areas shown.

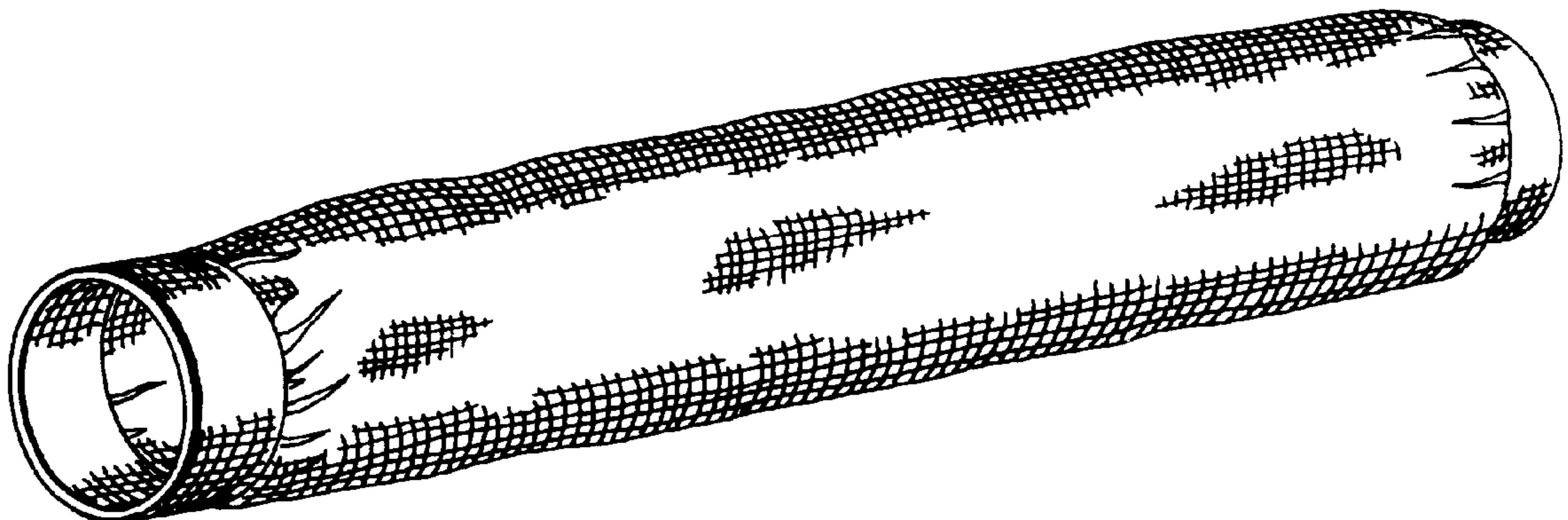

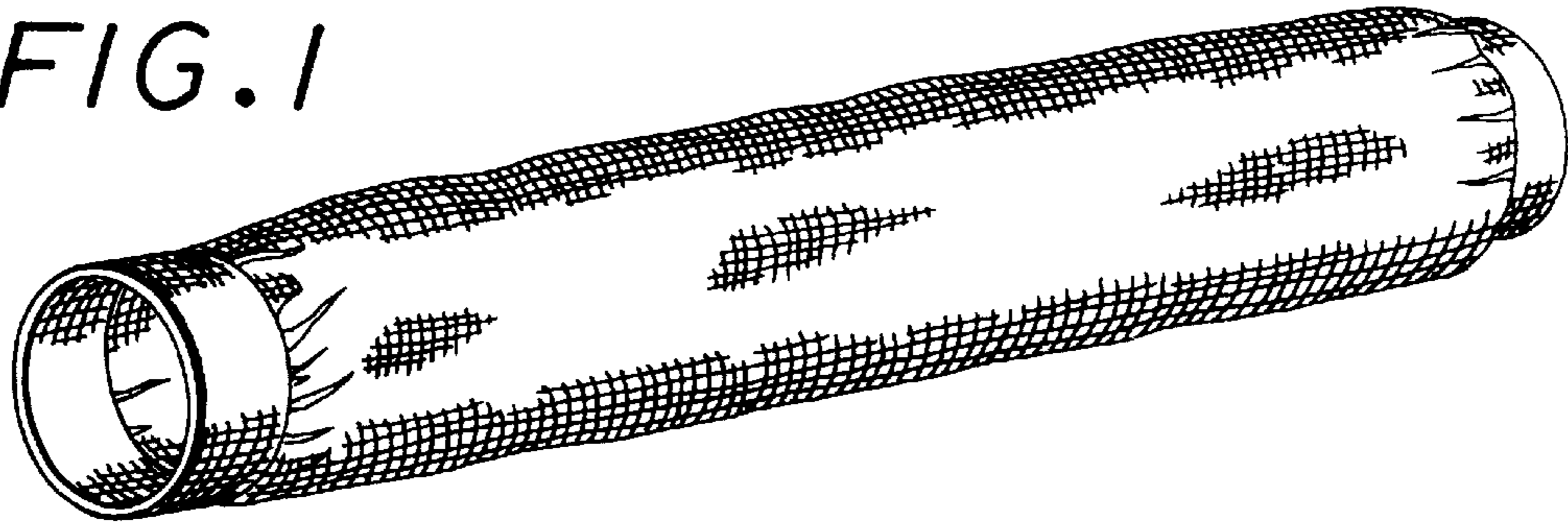

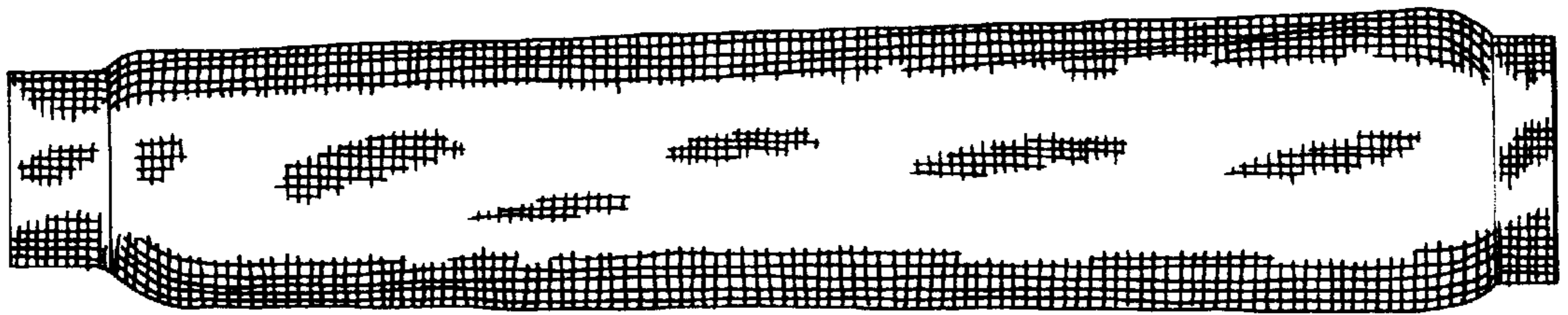

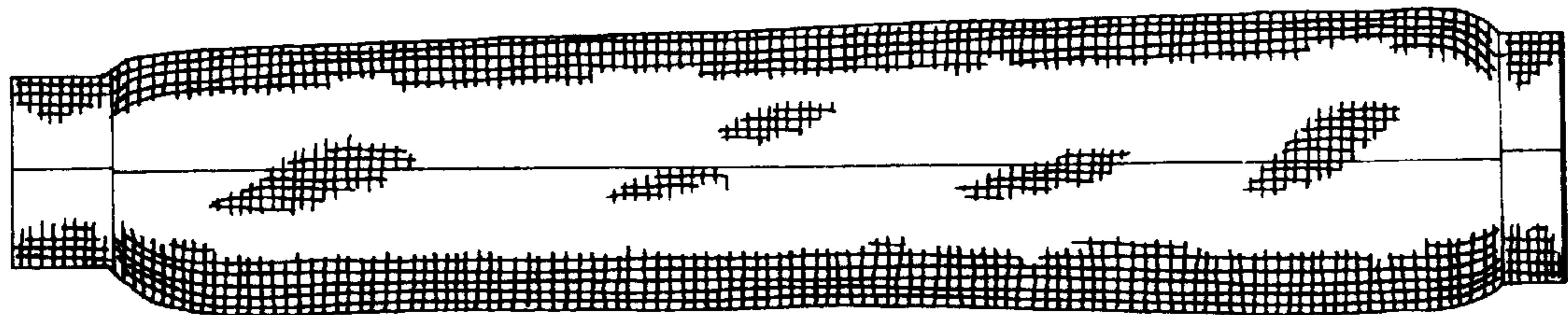

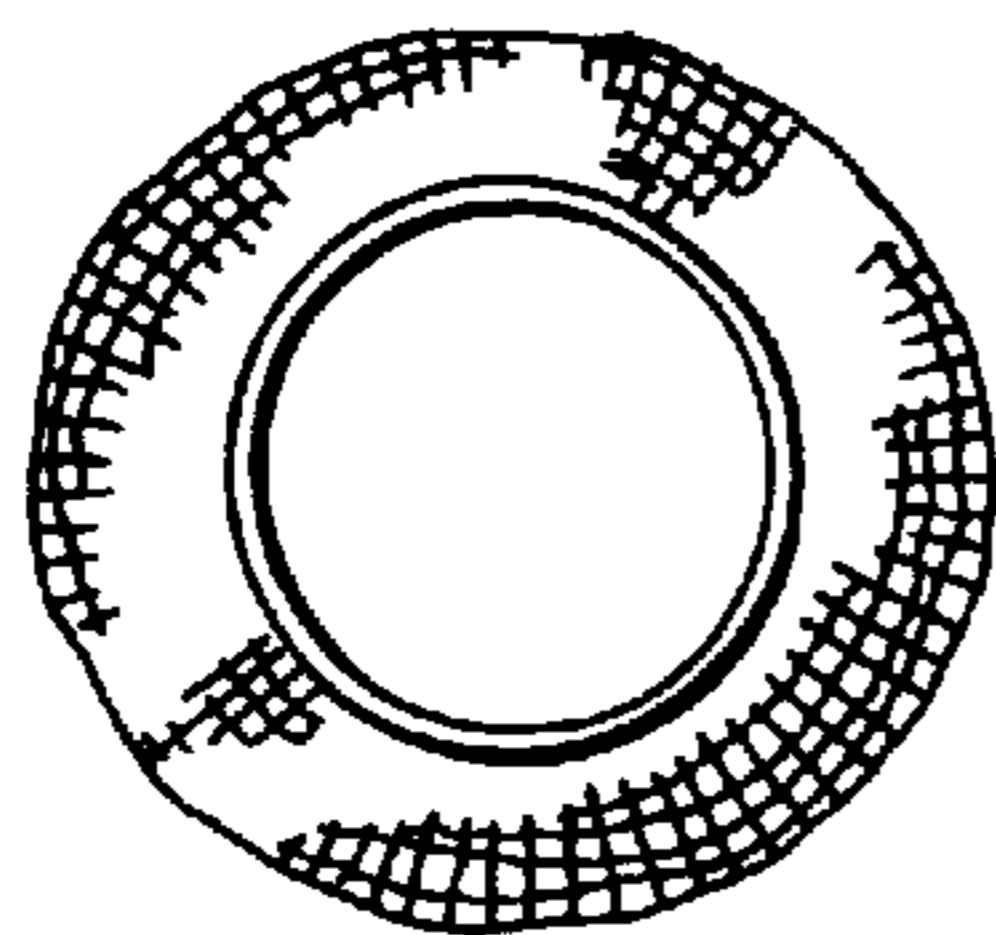
