(57) **CLAIM**

The ornamental design for an ice dispenser, as shown and described.

DESCRIPTION

FIG. 1 is a right, front perspective view of an ice dispenser showing the new design.

FIG. 2 is a front elevational view of the embodiment of FIG. 1.

FIG. 3 is a right side elevational view of the embodiment of FIGS. 1-2, the left side elevational view being a mirror image thereof.

FIG. 4 is a rear elevational view of the embodiment of FIGS. 1-3.

FIG. 5 is a top plan view of the embodiment of FIGS. 1-4 (the dashed lines showing of the internal mechanism in this figure are for illustrative purposes only and form no part of the claimed design); and,

FIG. 6 is a bottom plan view of the embodiment of FIGS. 1-5.

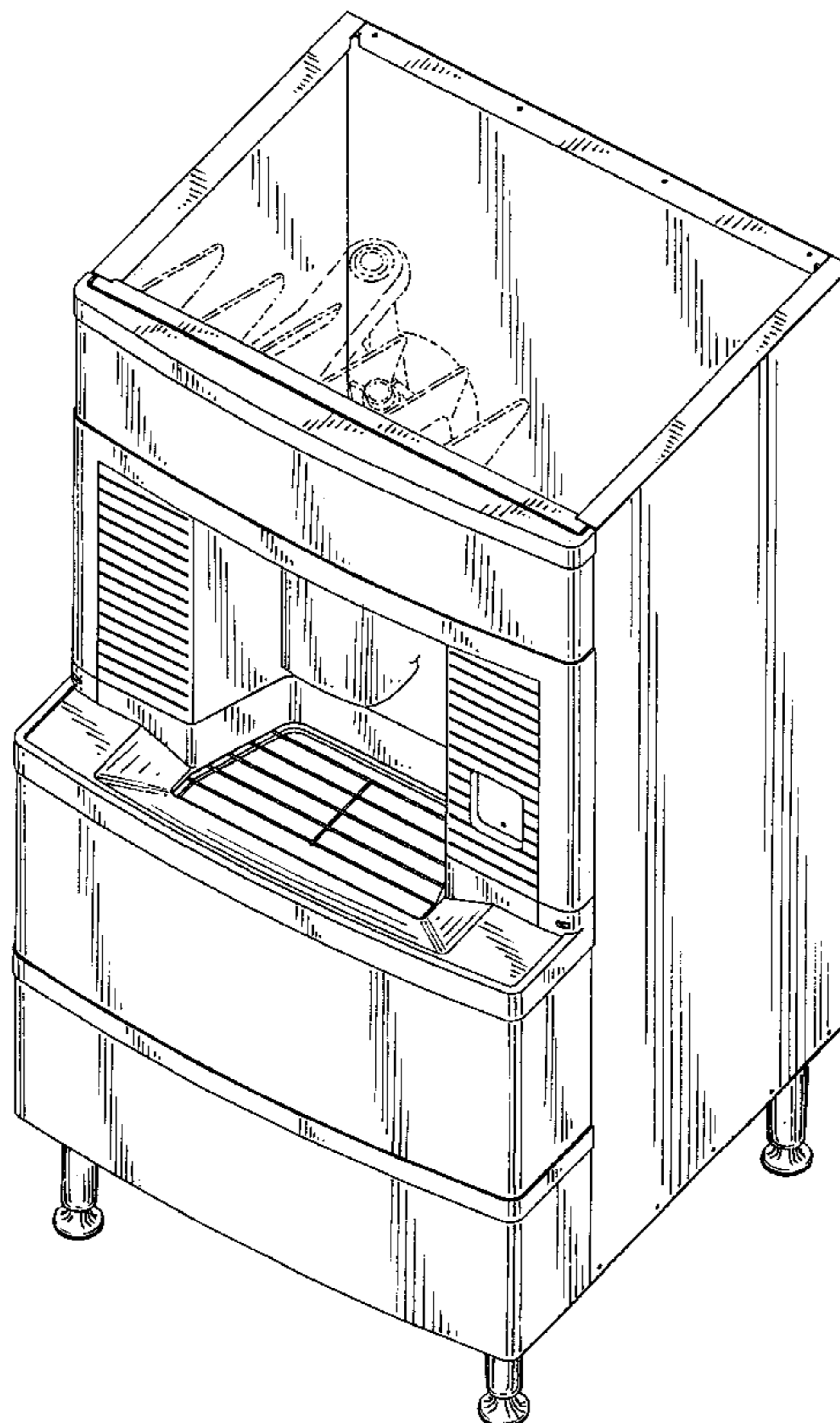

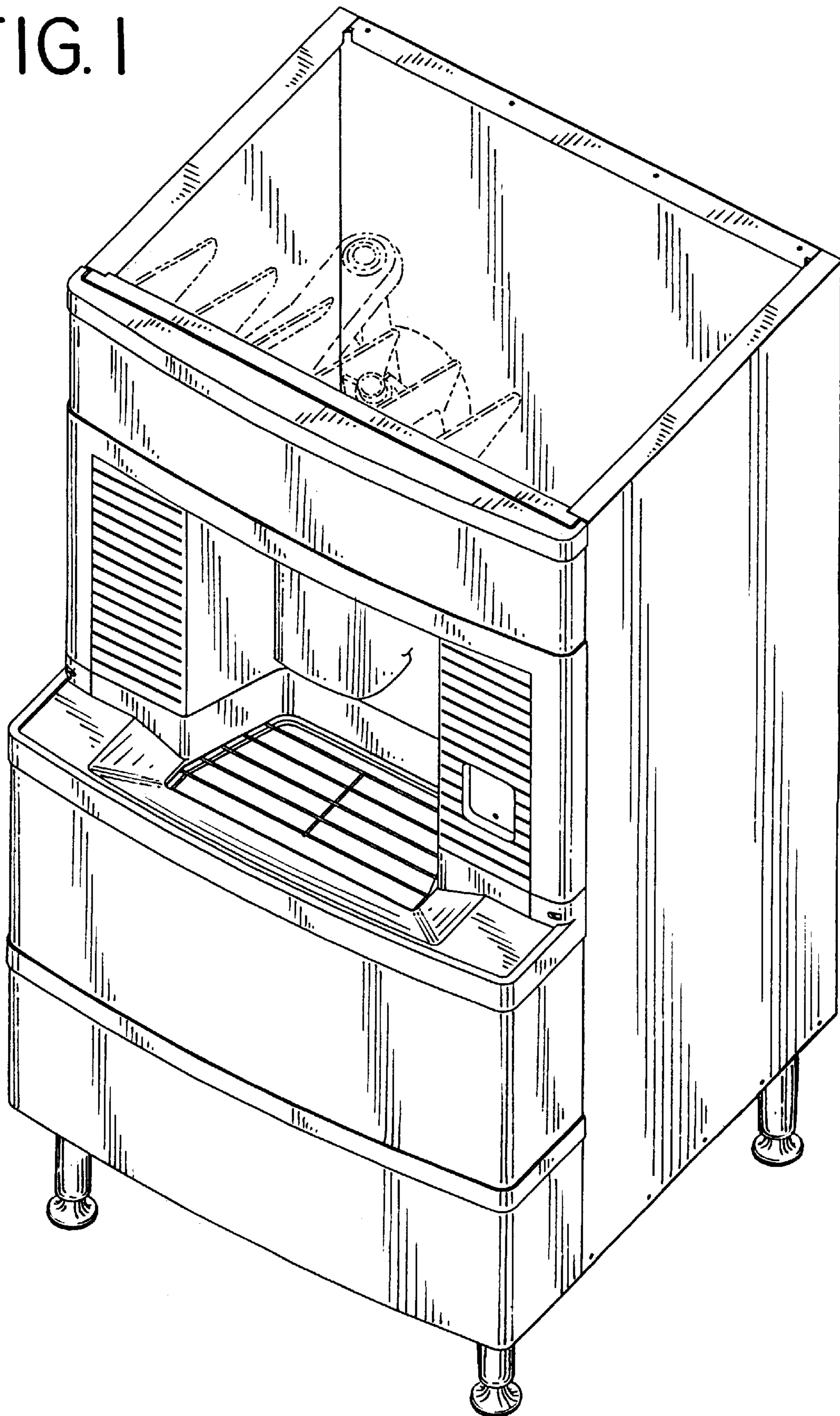

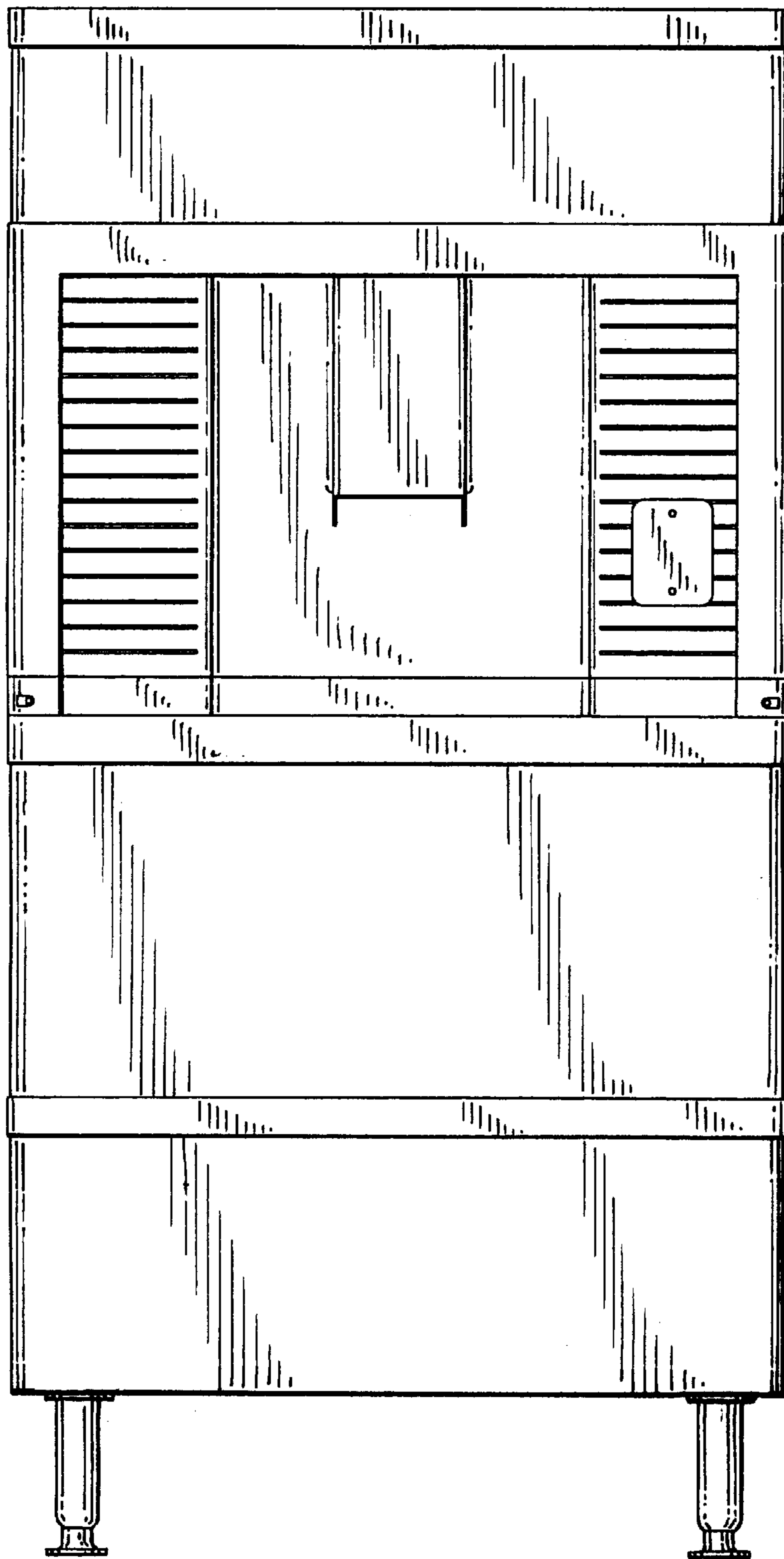

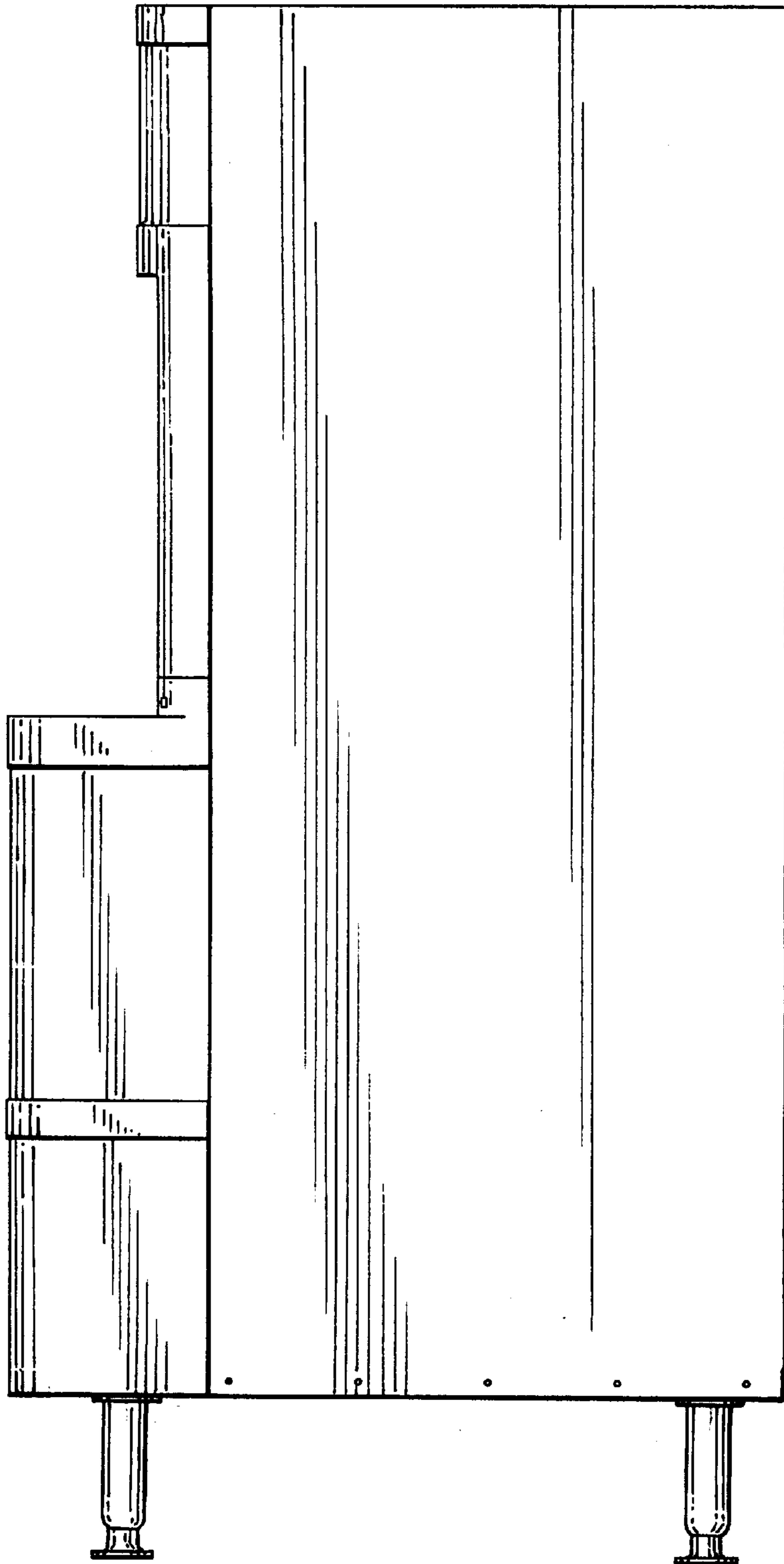

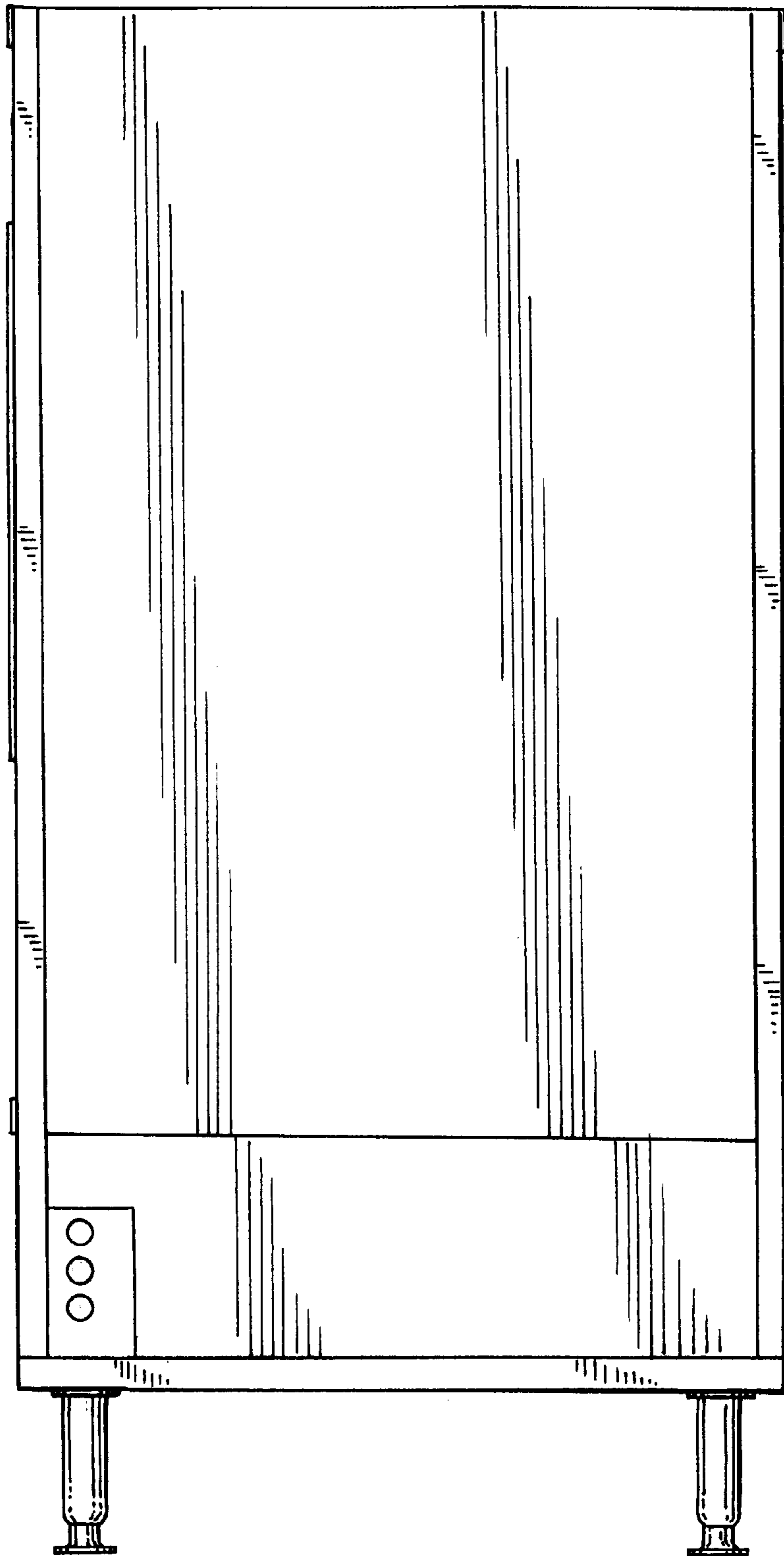

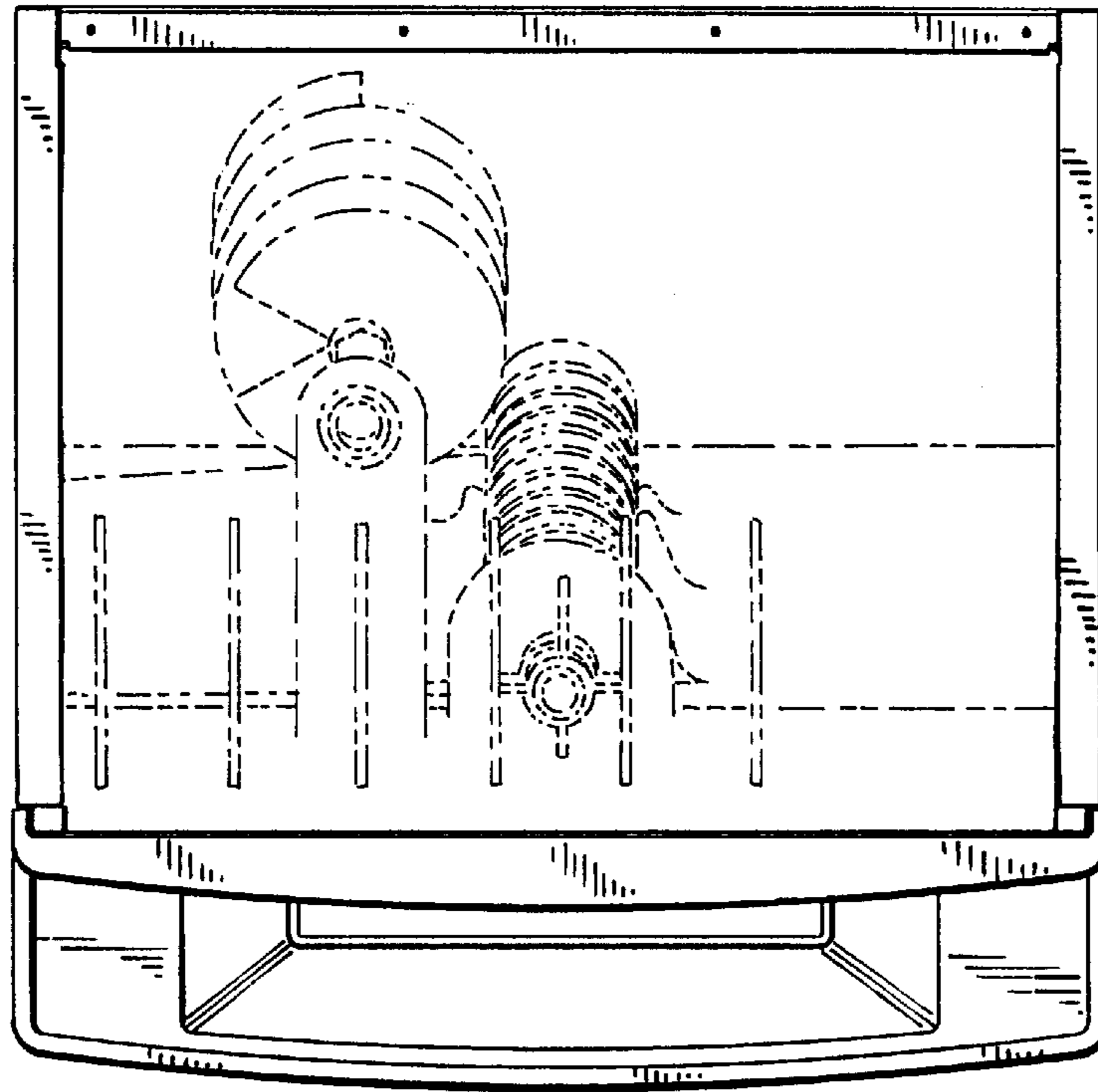
