(57) **CLAIM**

The ornamental design for a 2-piece upright toy vacuum cleaner, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a 2-piece upright toy vacuum cleaner showing my new design;
 FIG. 2 is a front elevational view thereof;
 FIG. 3 is a right side elevational view thereof;
 FIG. 4 is a rear elevational view thereof;
 FIG. 5 is a top plan view thereof;
 FIG. 6 is a bottom plan view thereof;
 FIG. 7 is a front perspective view of a debris canister separated from the toy vacuum cleaner illustrated in FIGS. 1-6;
 FIG. 8 is a top plan view of FIG. 7;
 FIG. 9 is a left side elevational view of FIG. 7;
 FIG. 10 is a front perspective view of FIG. 7;
 FIG. 11 is a rear view of FIG. 7;
 FIG. 12 is a perspective view of an extension nozzle separated from the toy vacuum cleaner shown in FIGS. 1-6;
 FIG. 13 is a side elevational view thereof;
 FIG. 14 is a top plan view thereof; and,
 FIG. 15 is a front elevational view thereof.
 FIGS. 7-11 (hand-held vacuum cleaner) and FIGS. 12-15 (extension nozzle) are shown separate for clarity of illustration.

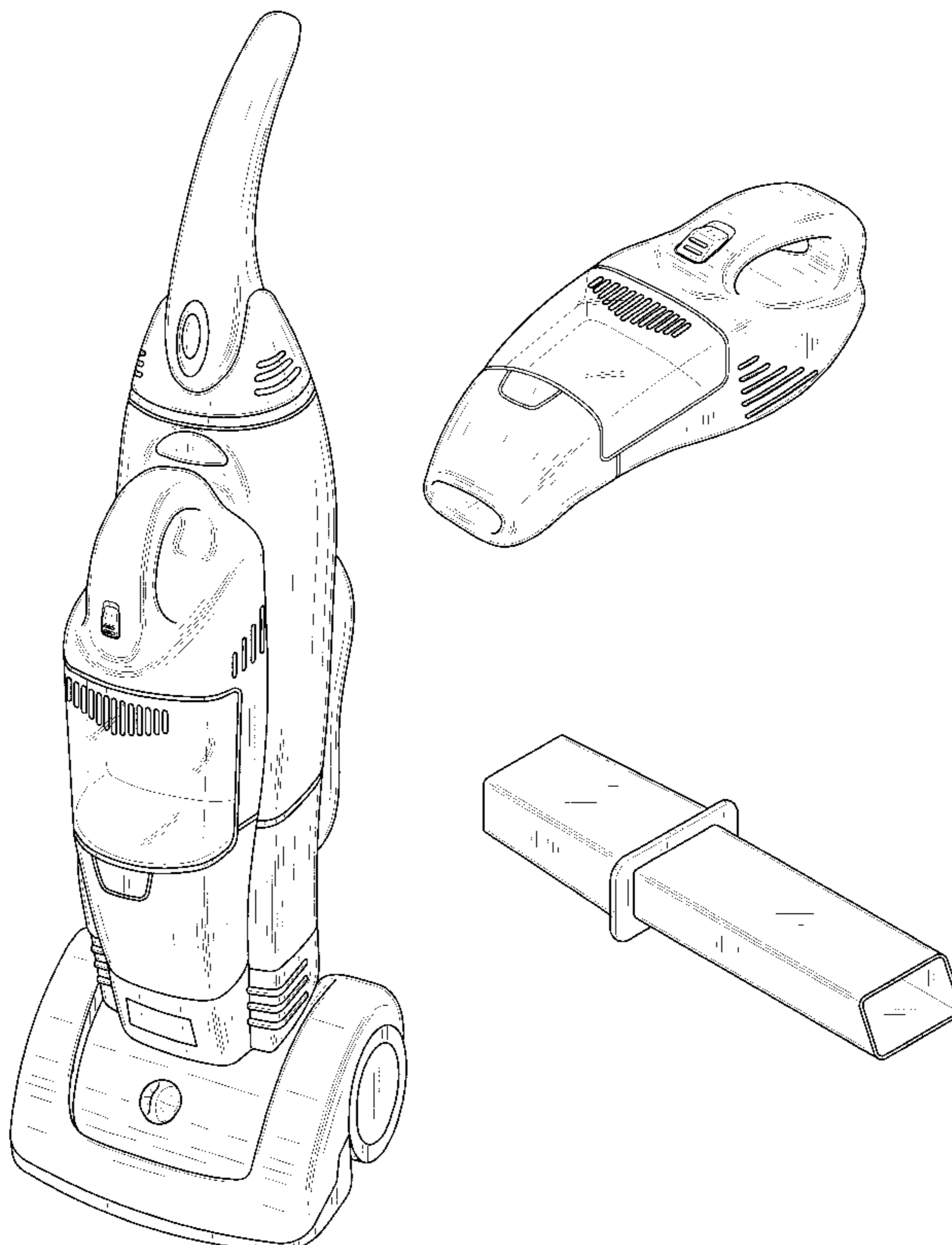

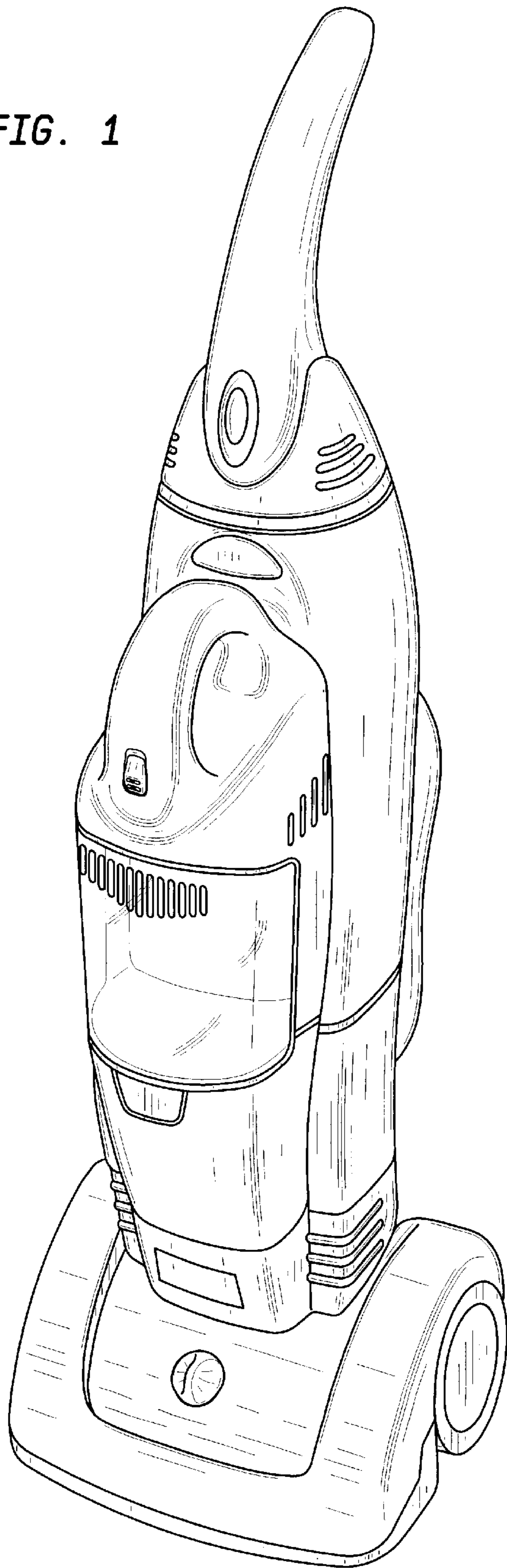

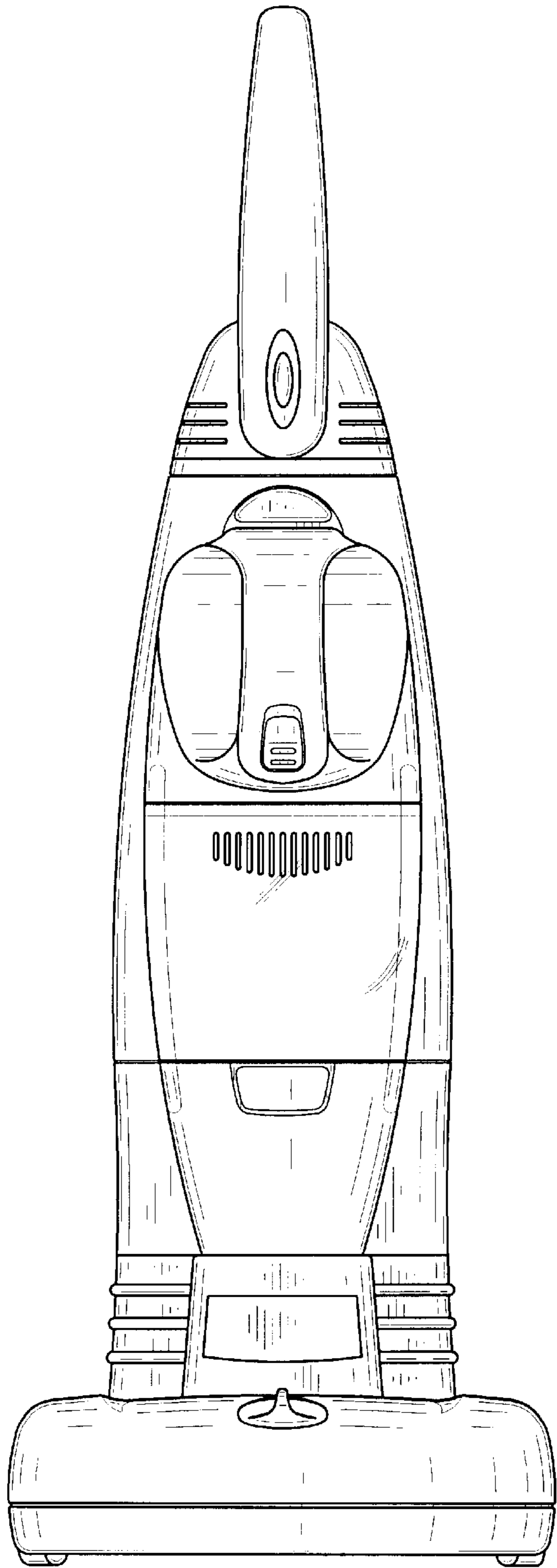

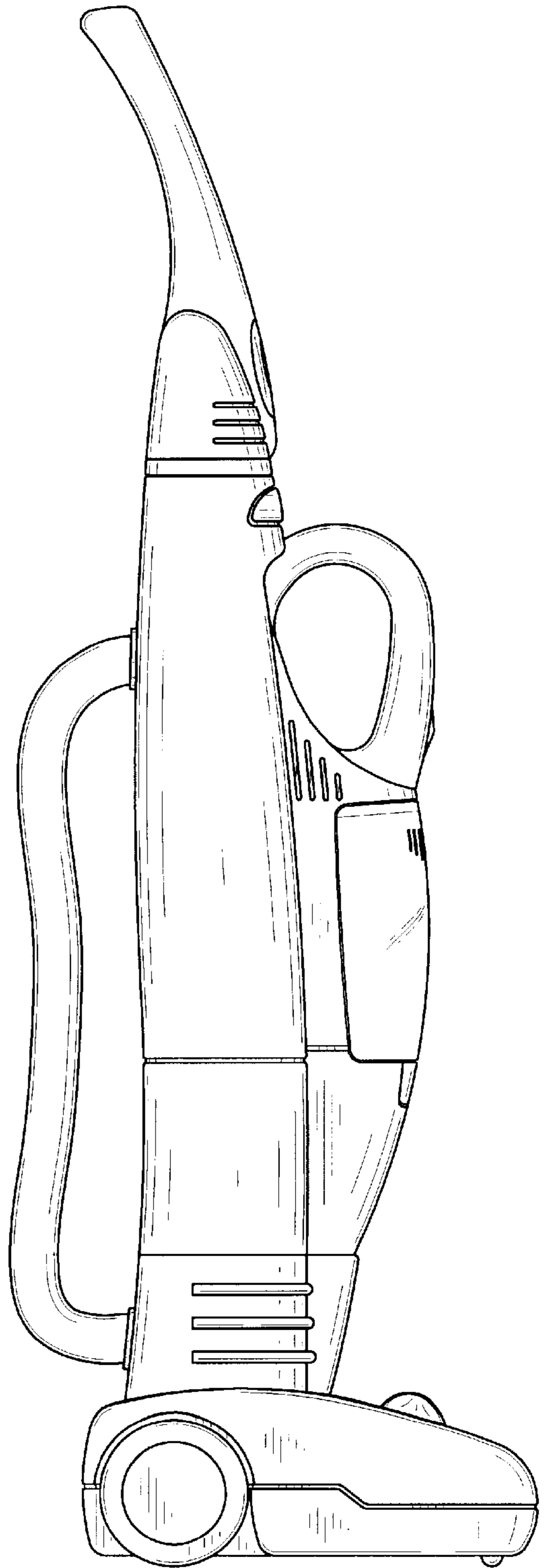

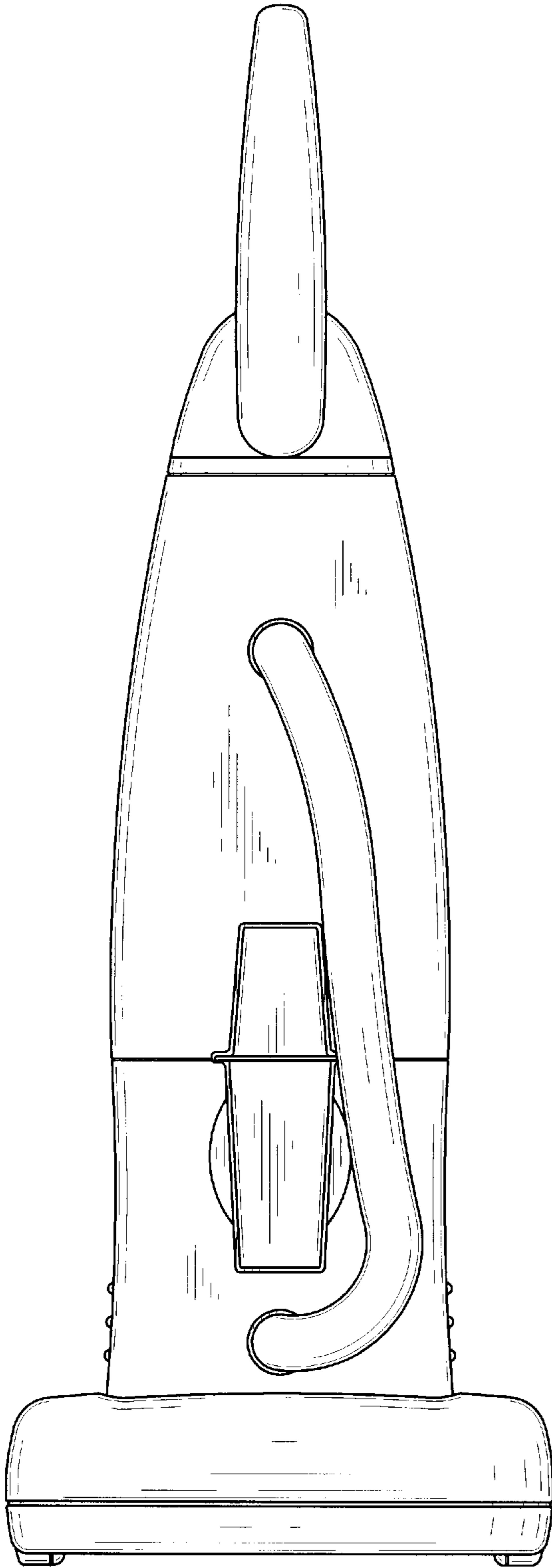

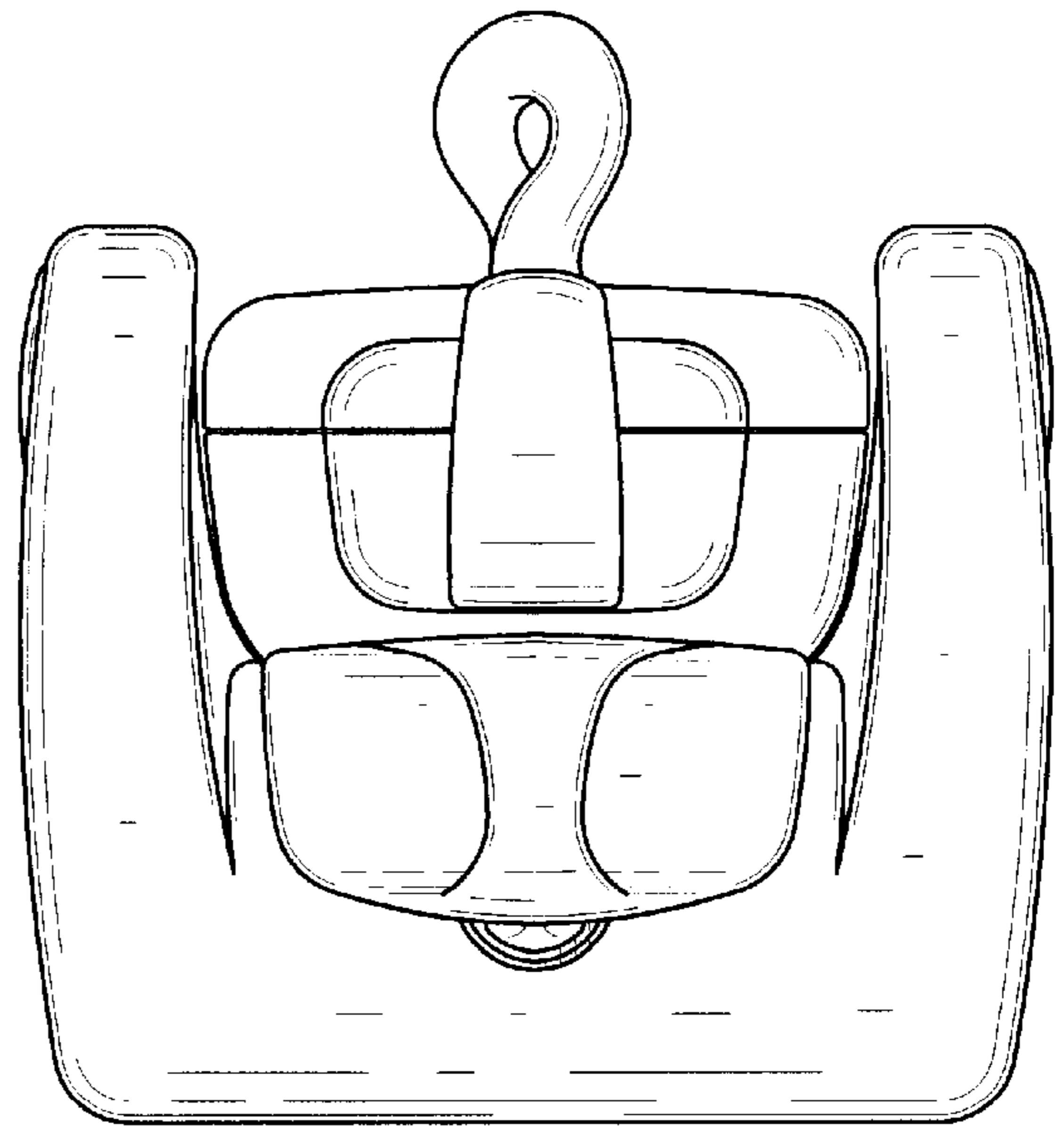

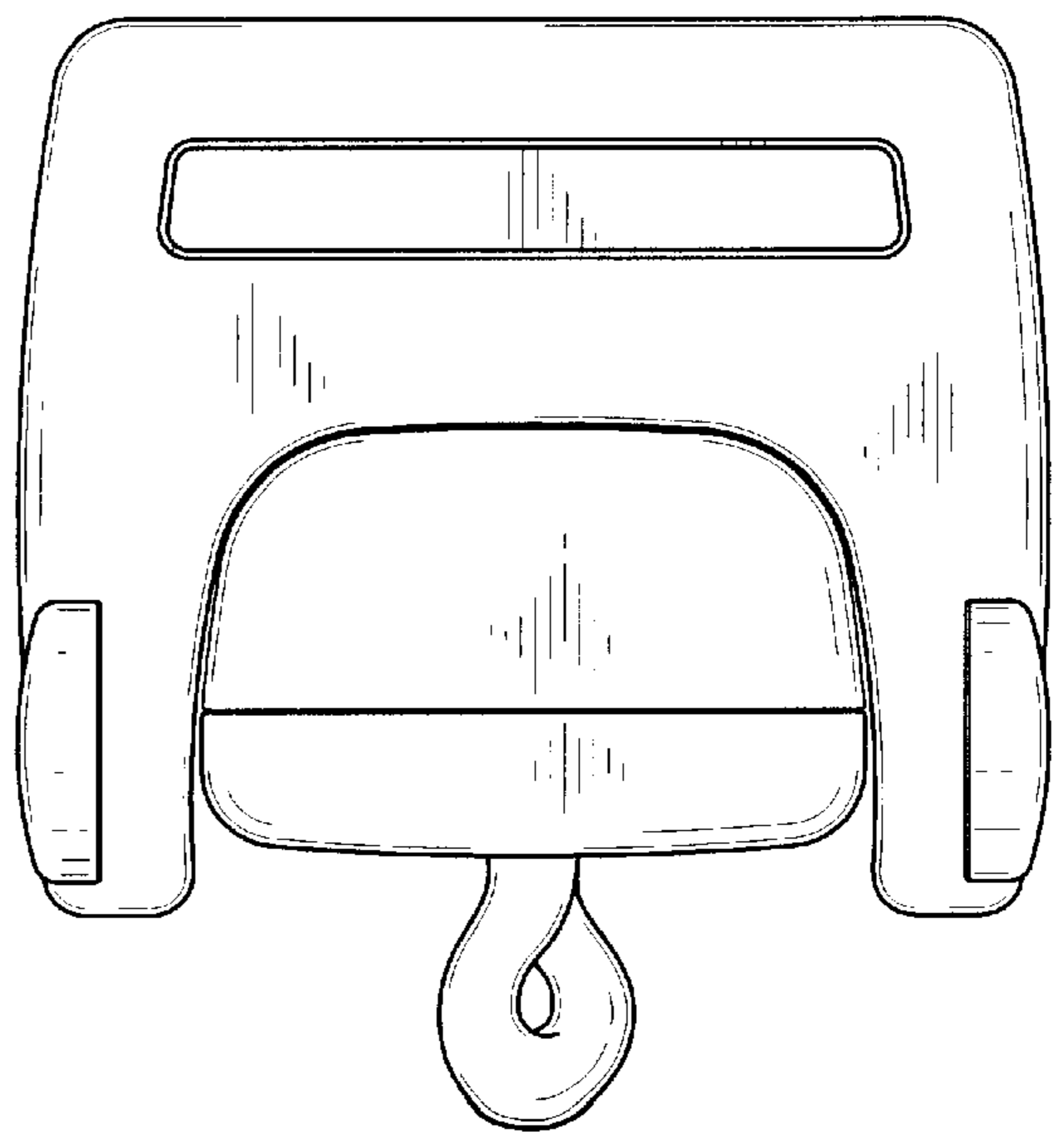

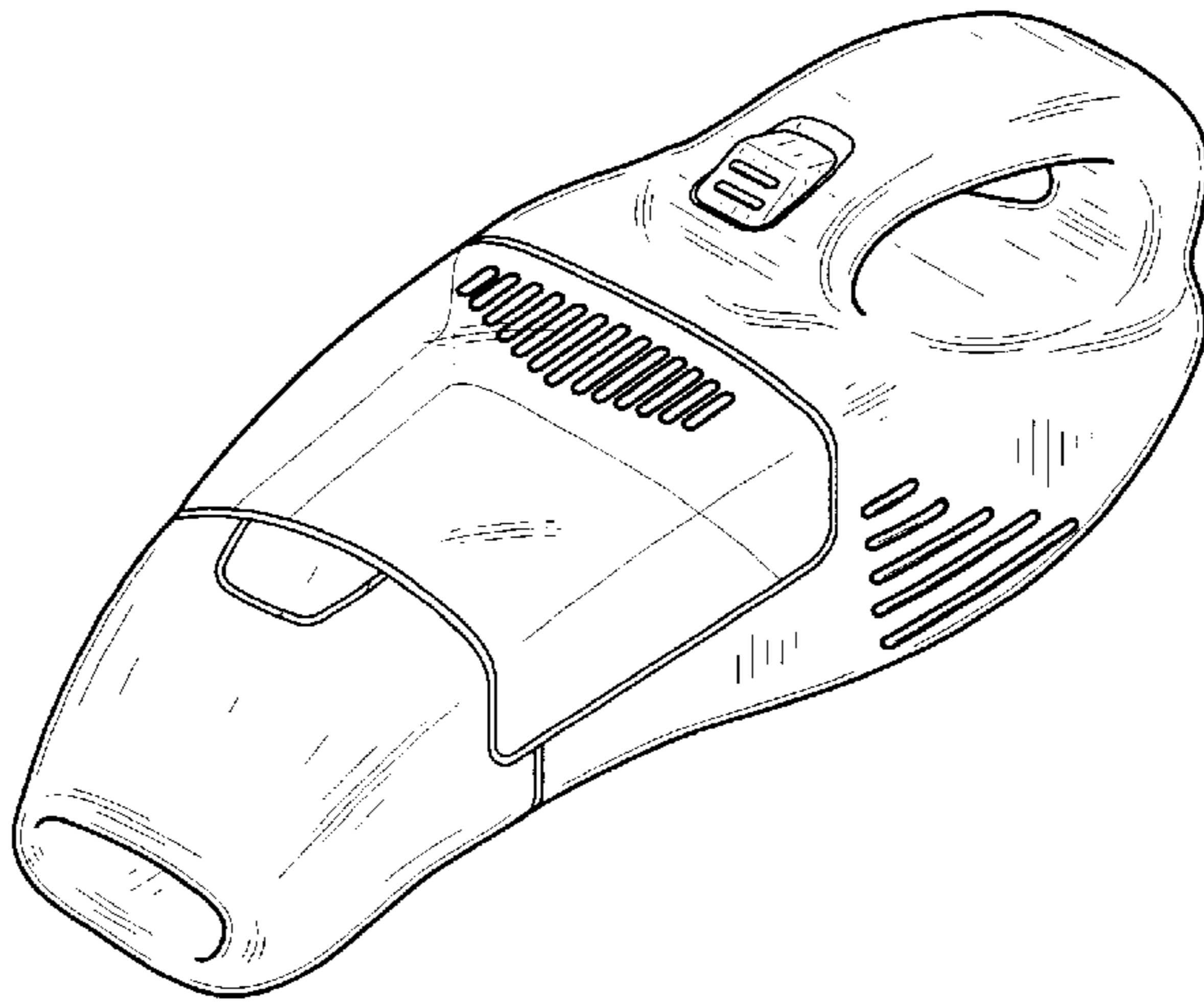

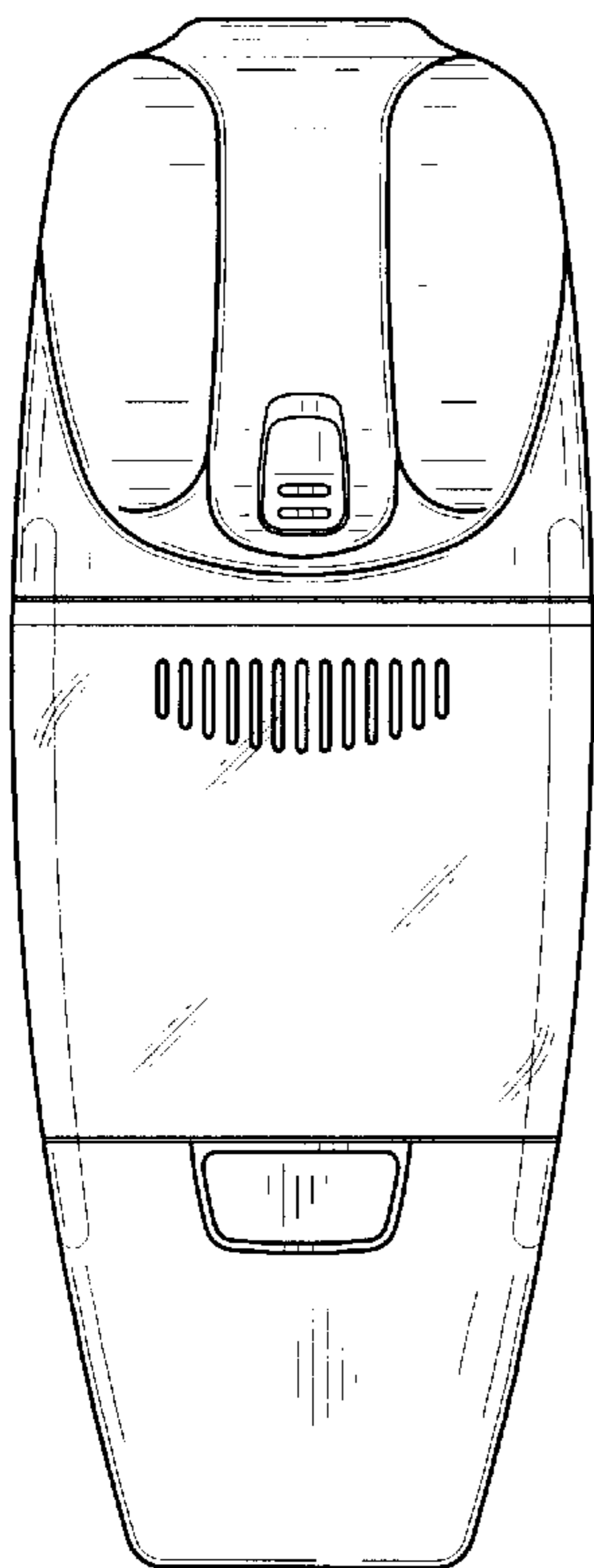

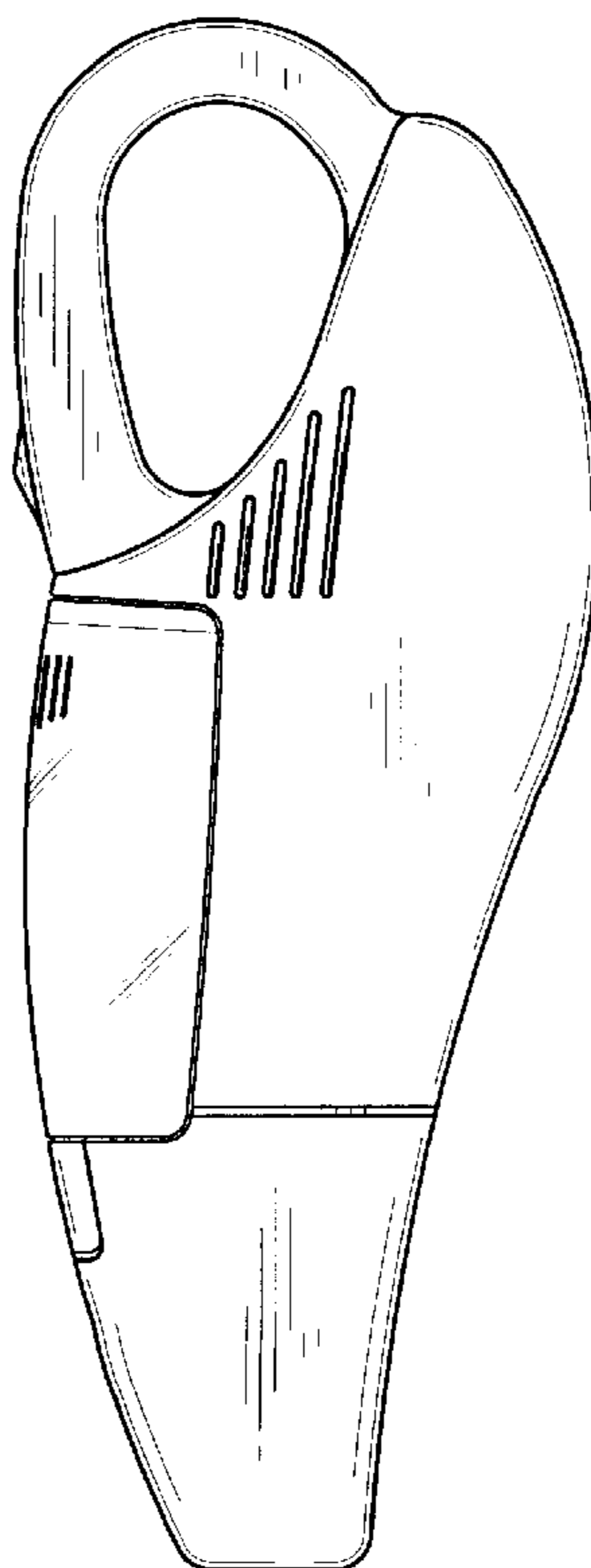

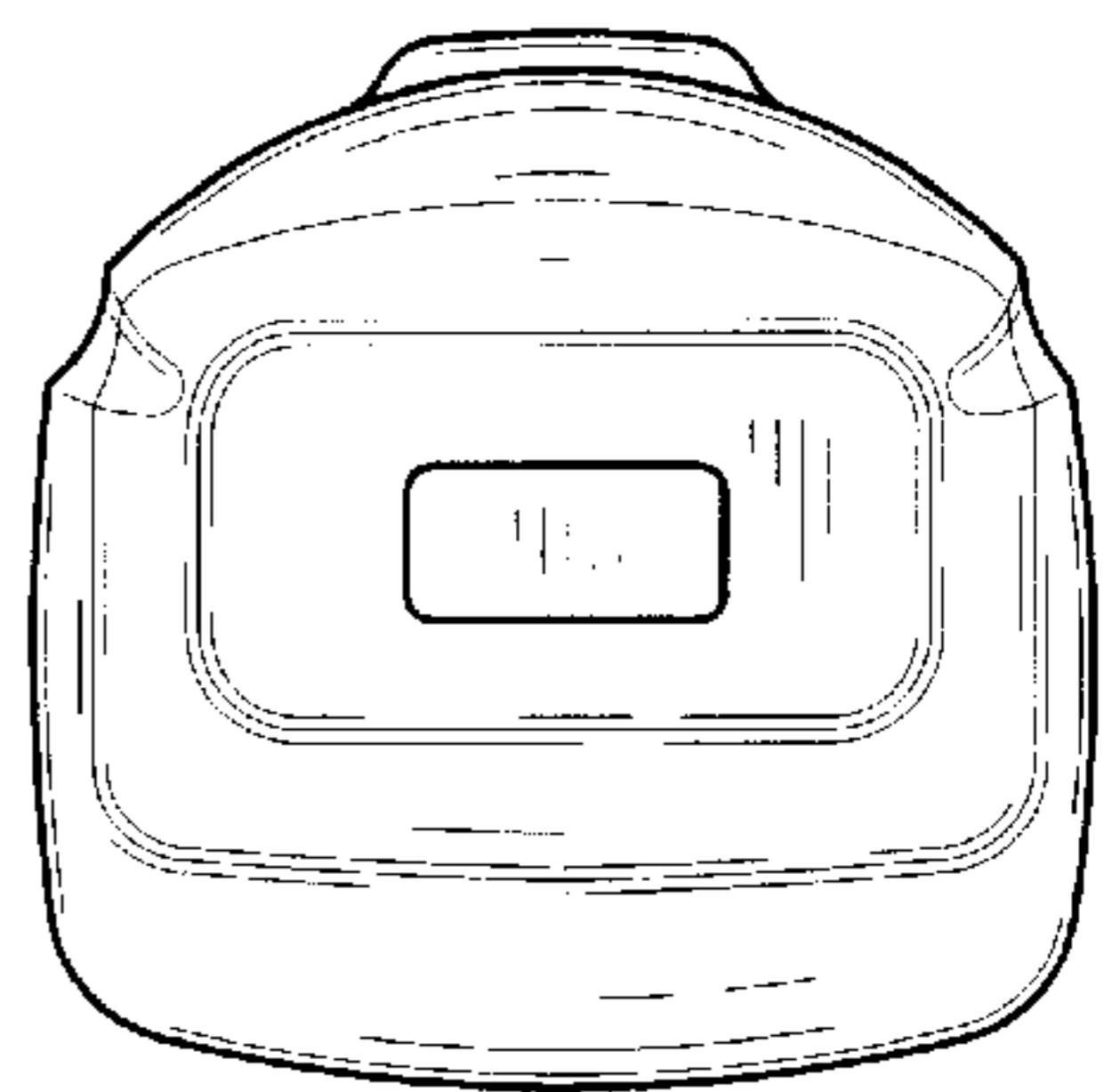

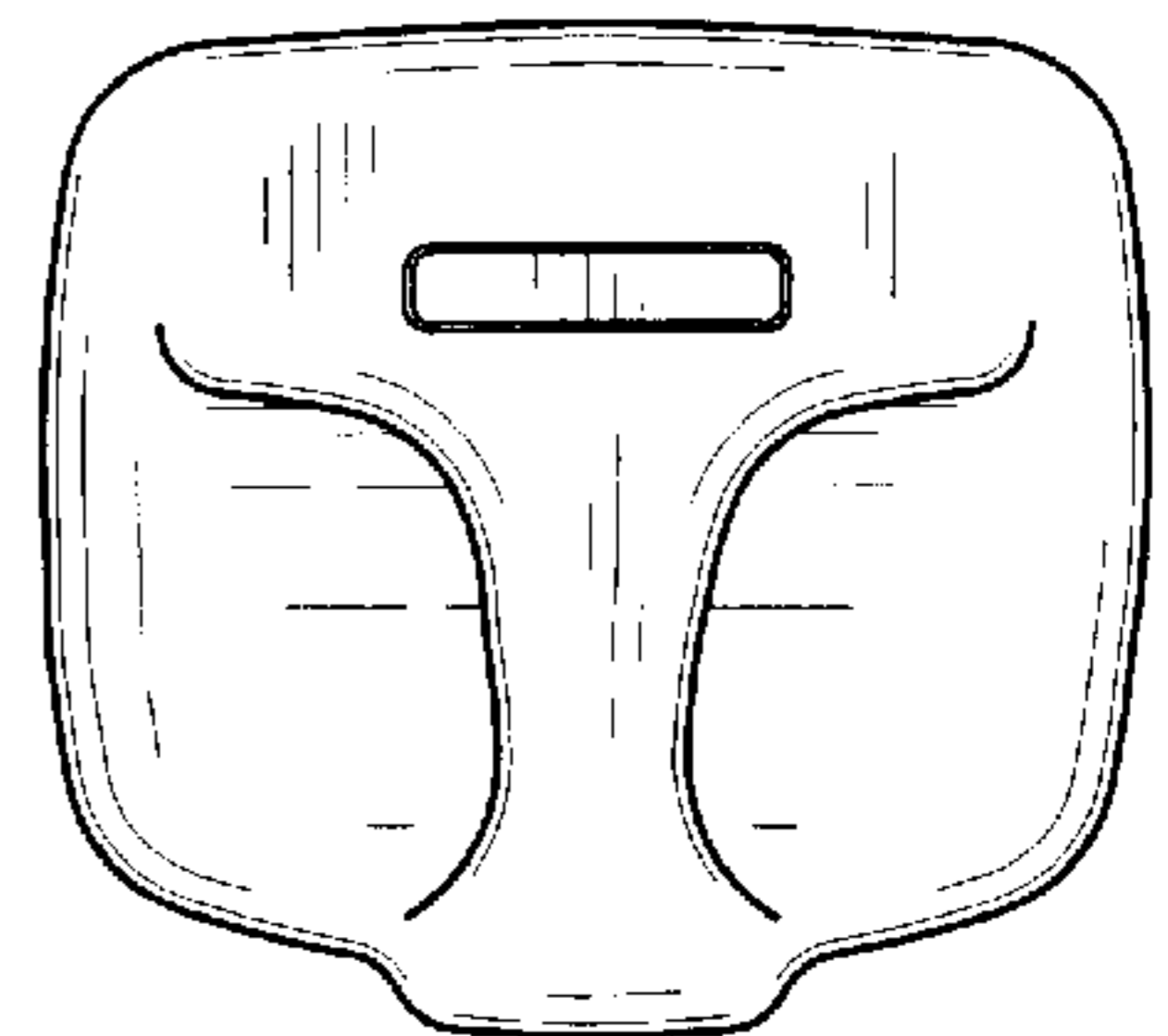

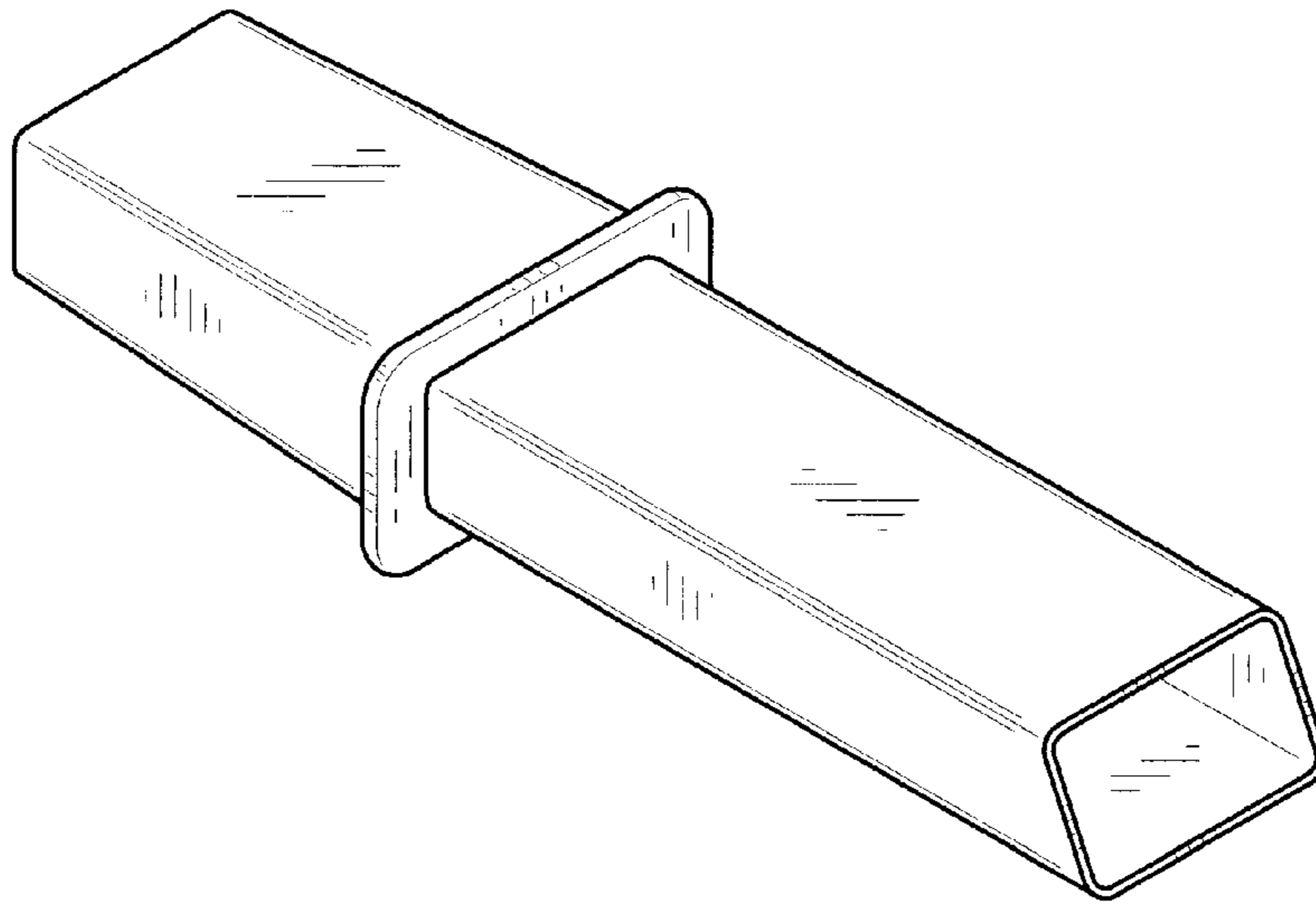

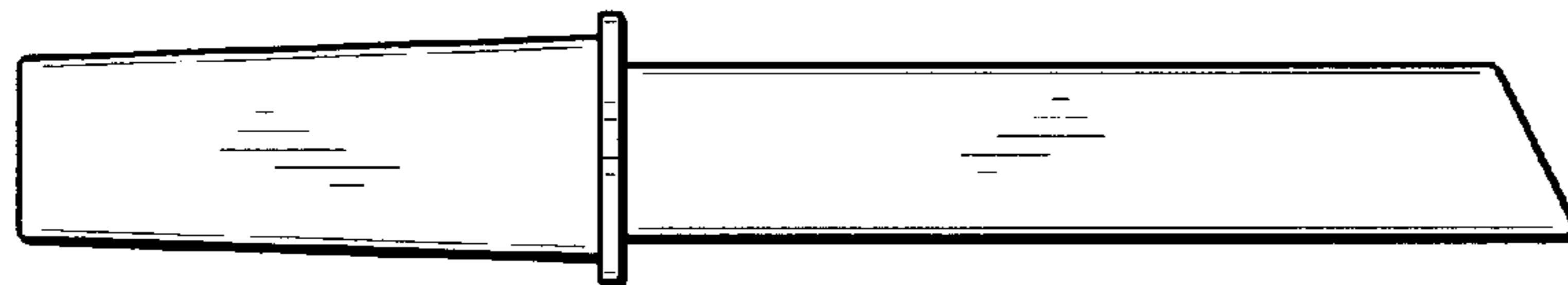

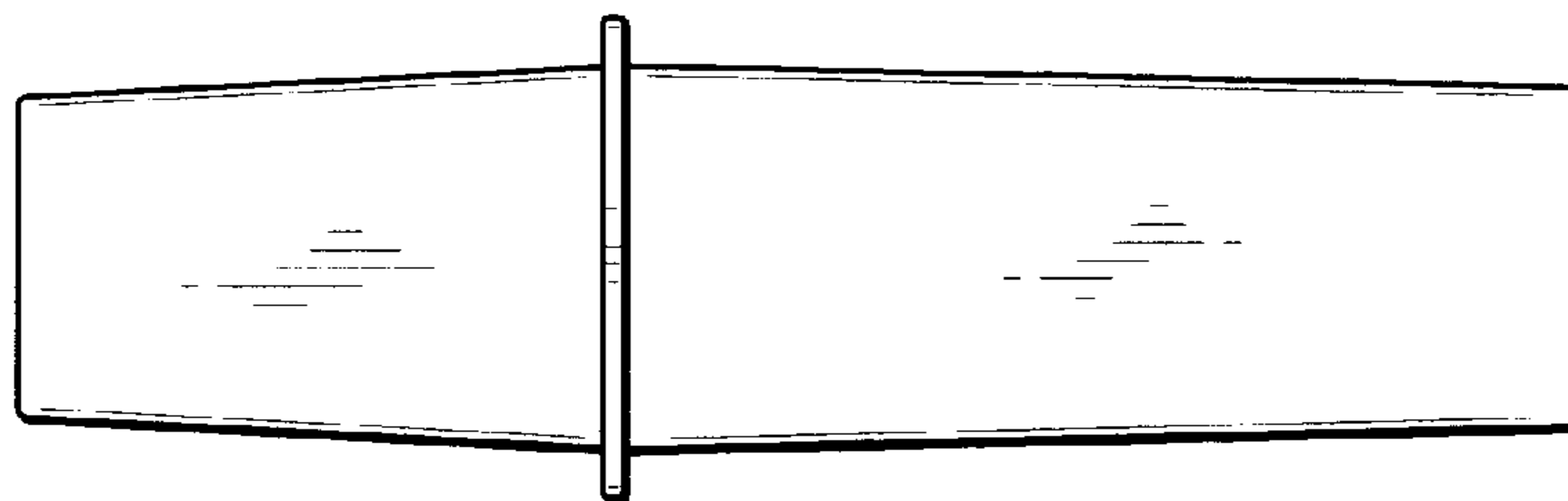
