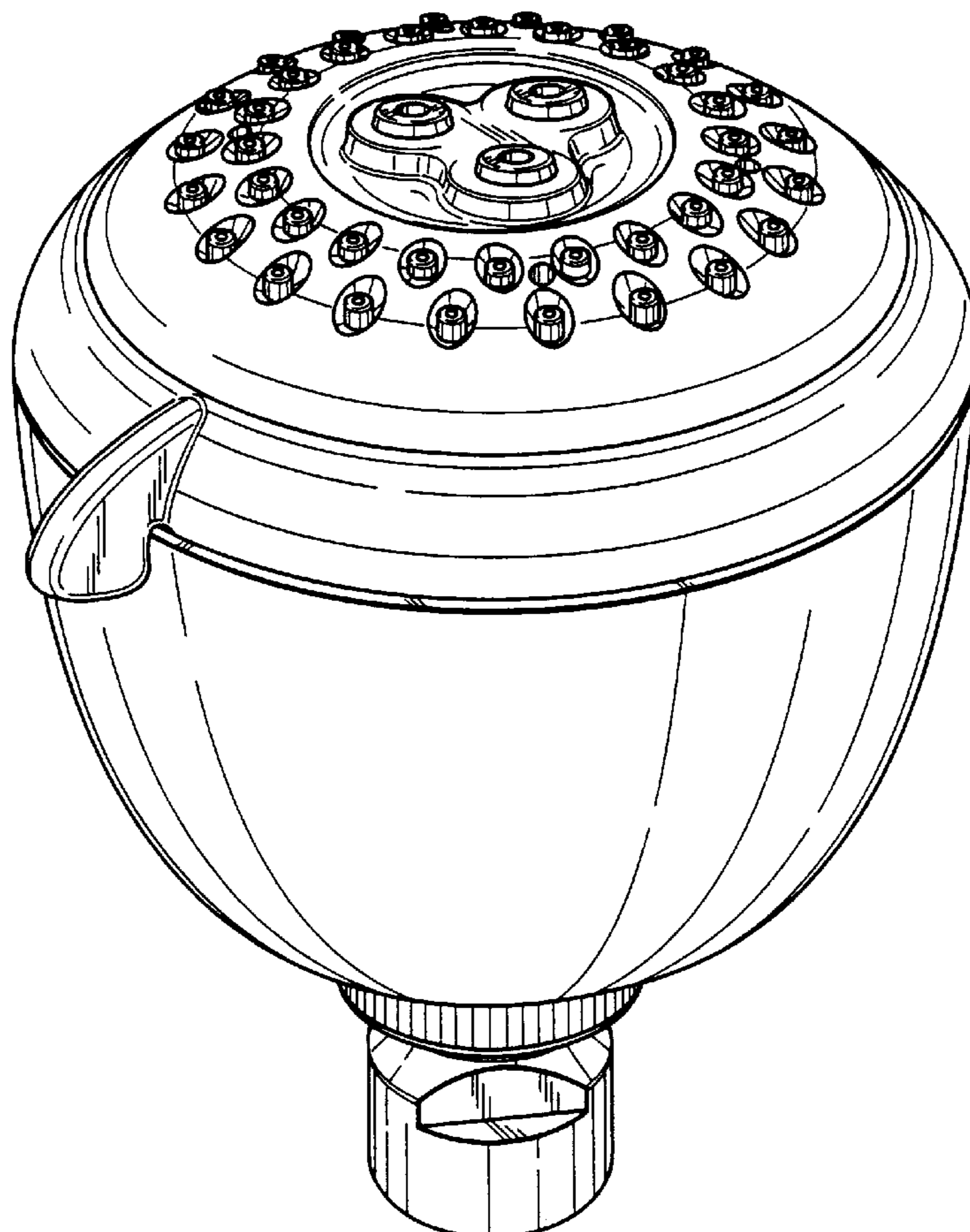
(57) **CLAIM**

The ornamental design for a shower head, especially for head showers, as shown and described.

**DESCRIPTION**

FIG. 1 is a side perspective view of a shower head, especially for head showers, showing our new design;

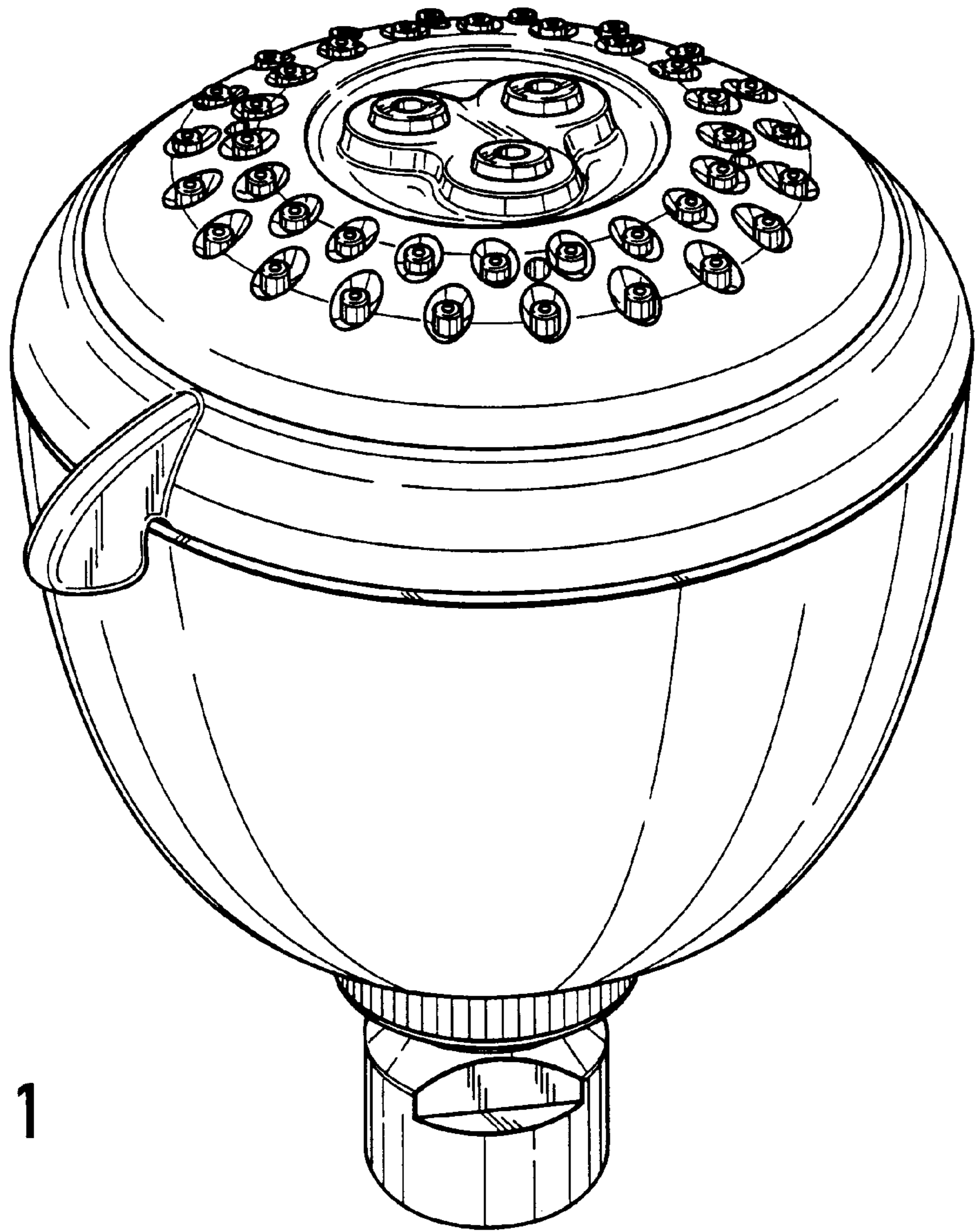

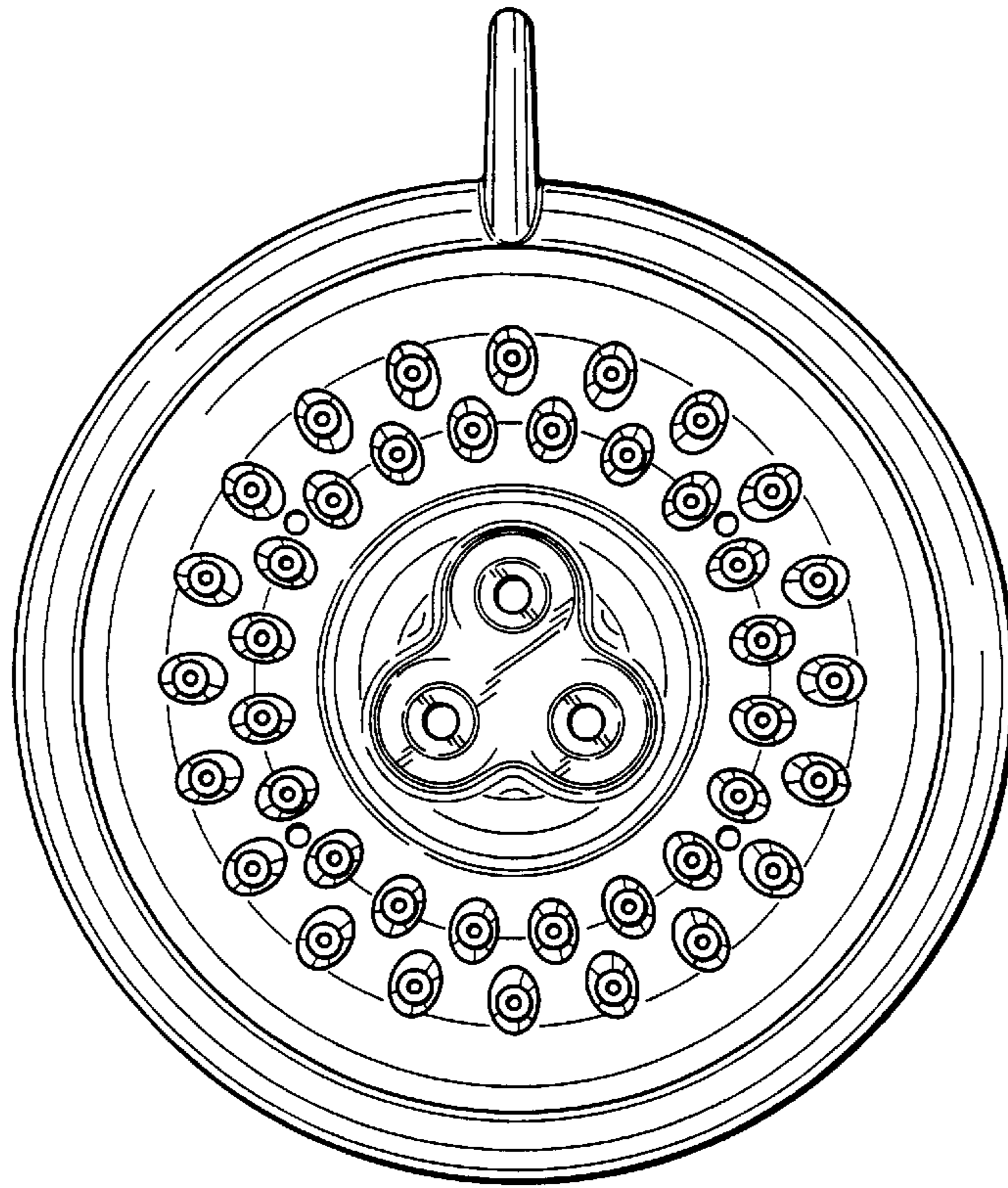

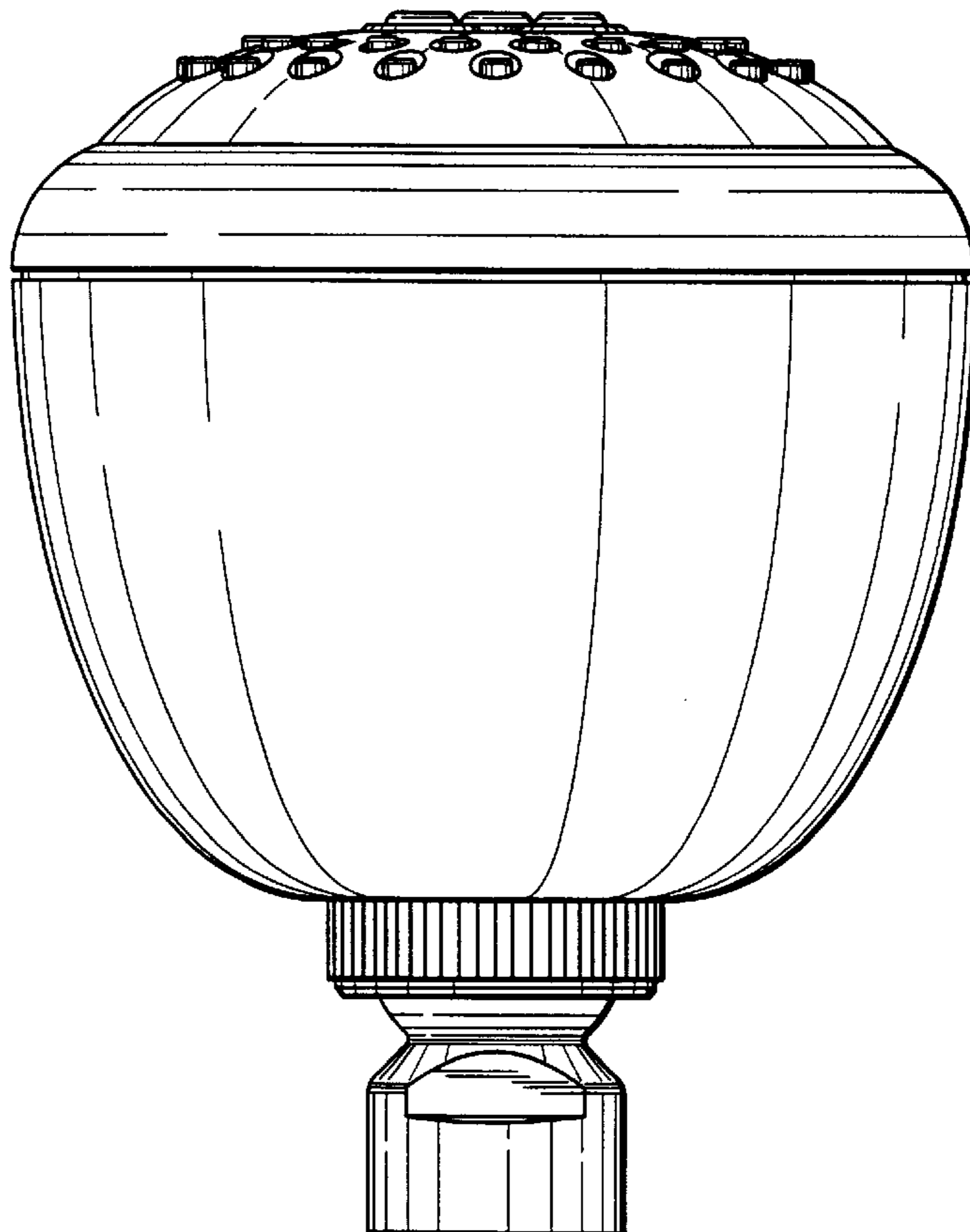

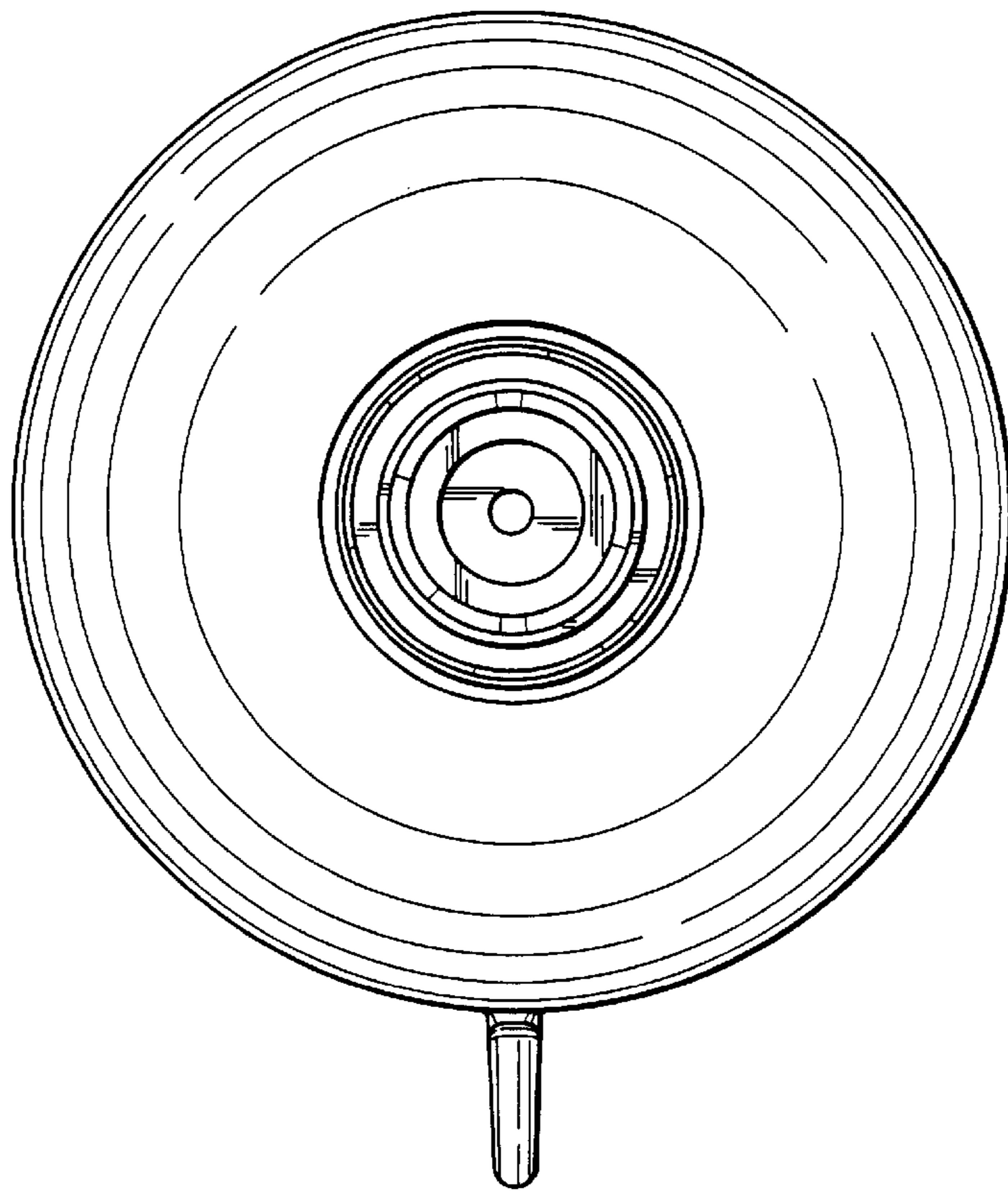

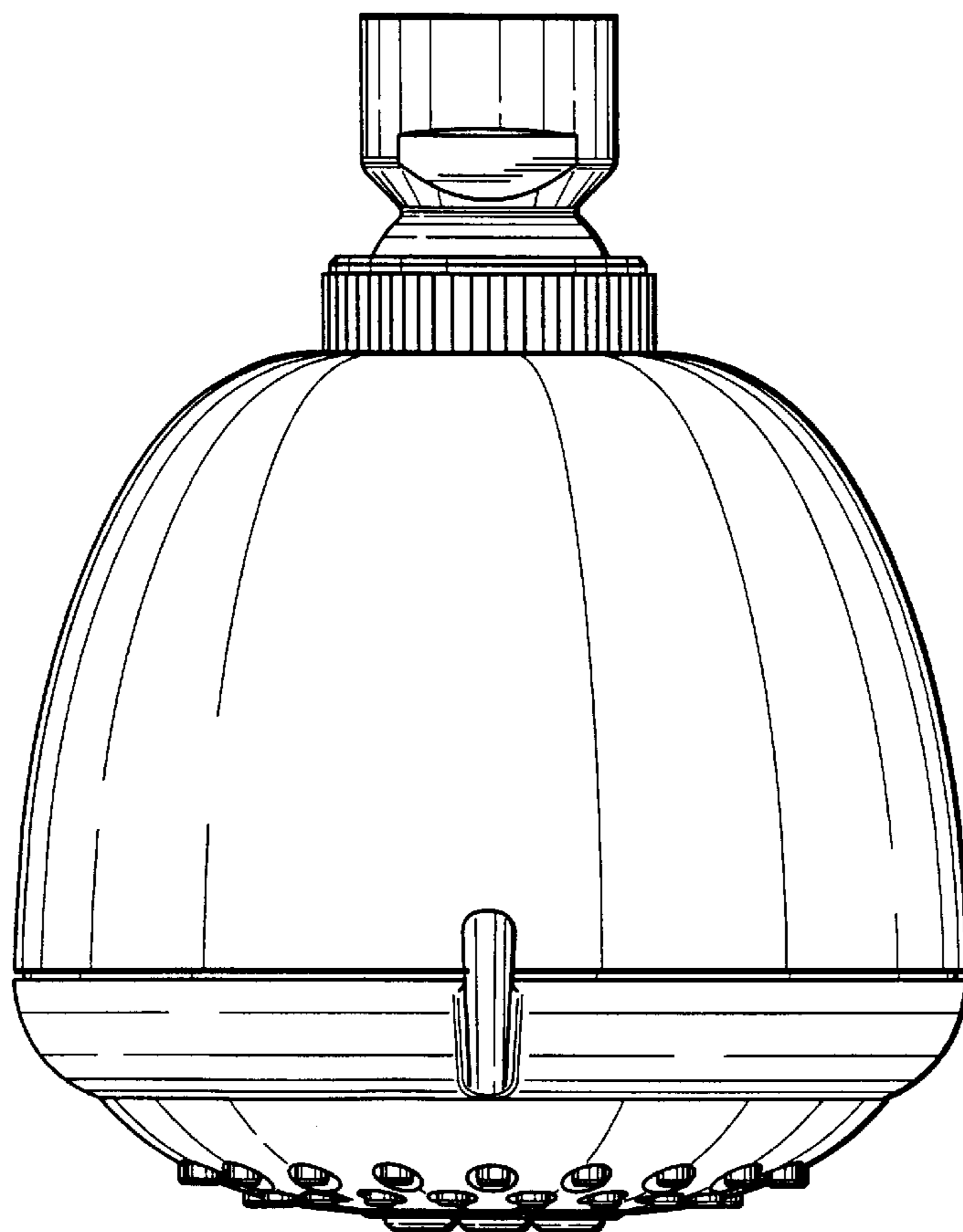

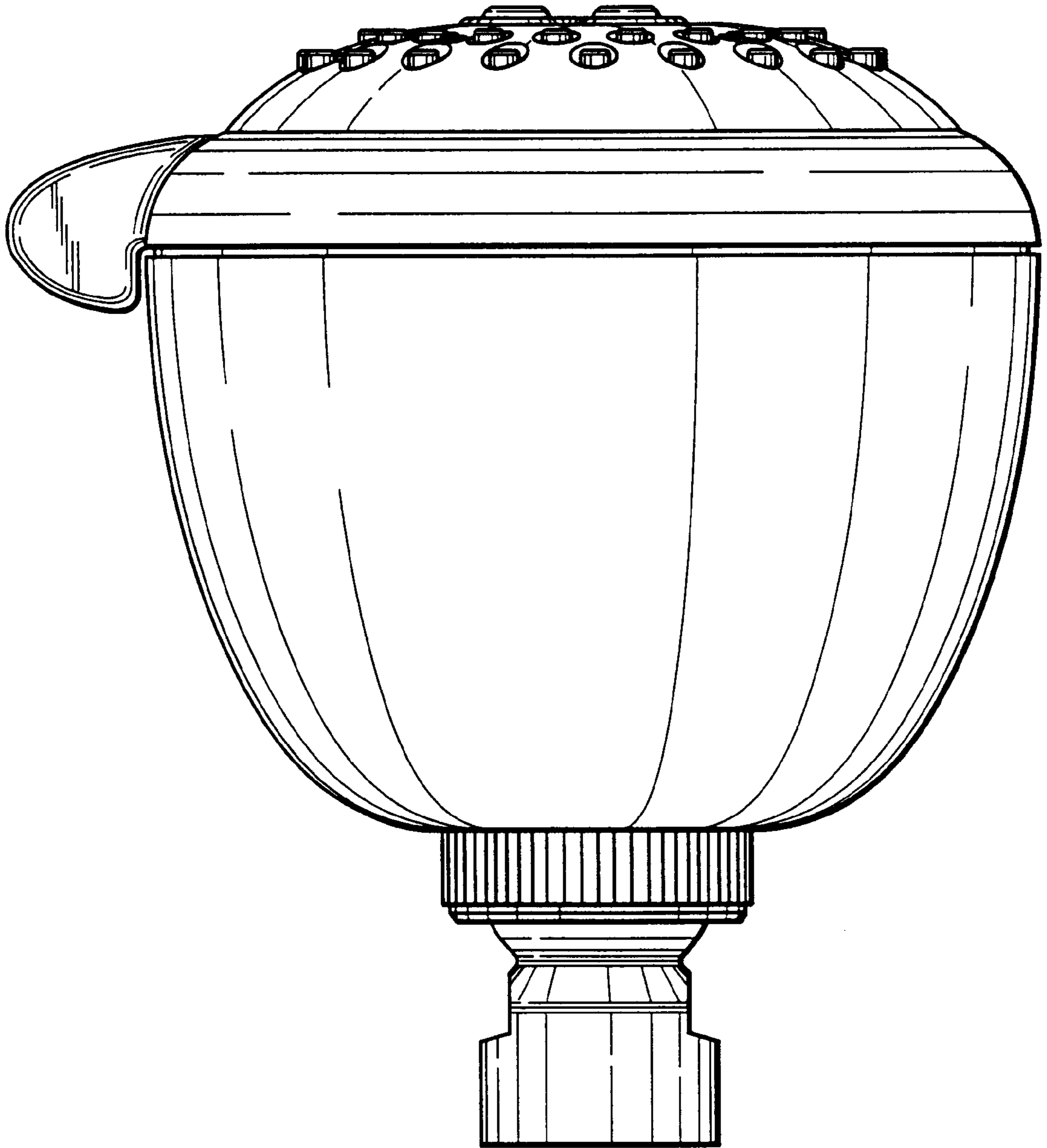
