(57) **CLAIM**

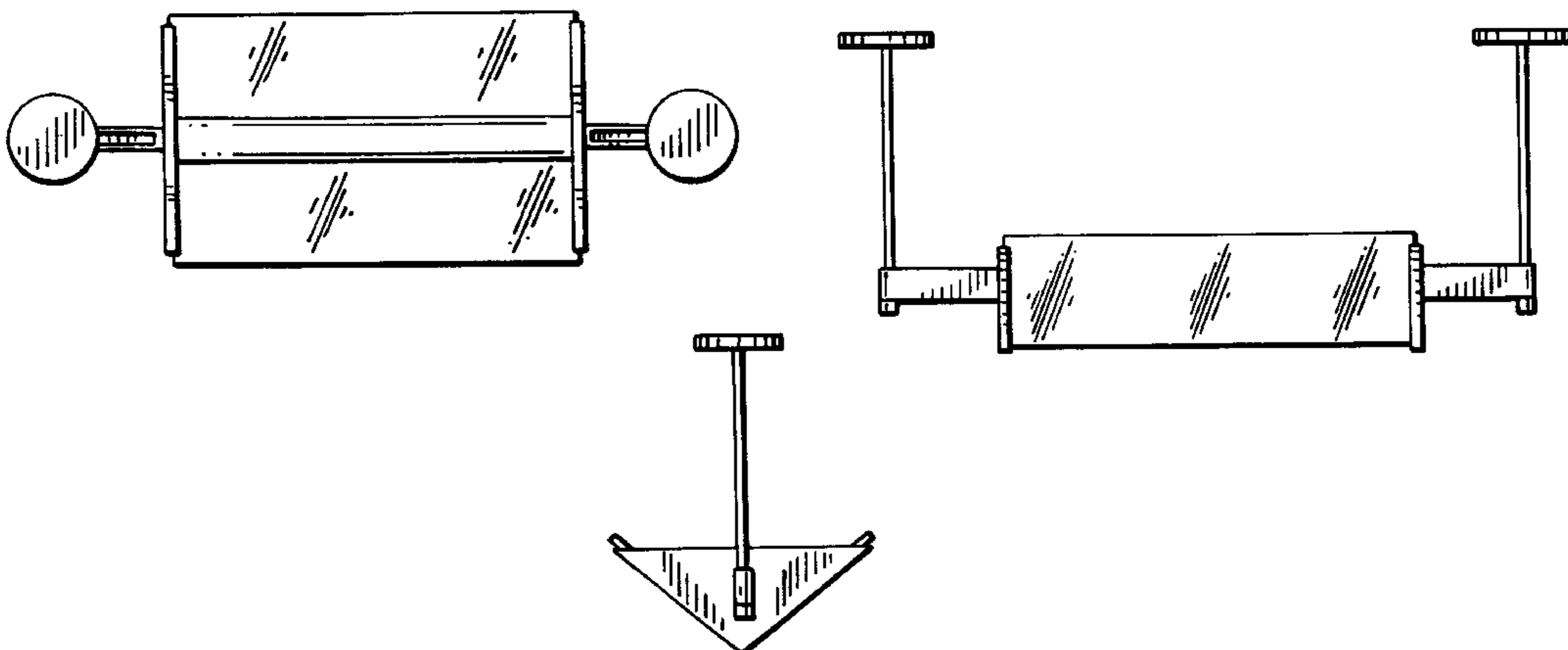
I claim the ornamental design for a lighting fixture, as shown and described.

DESCRIPTION

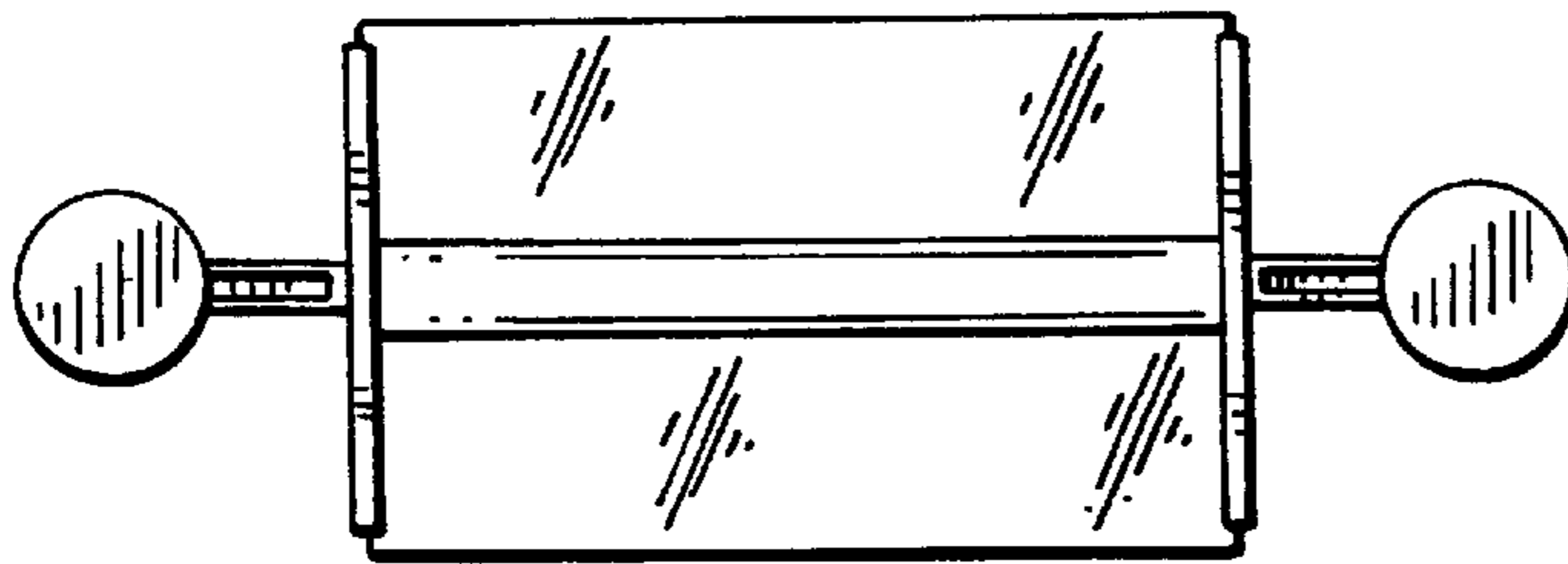

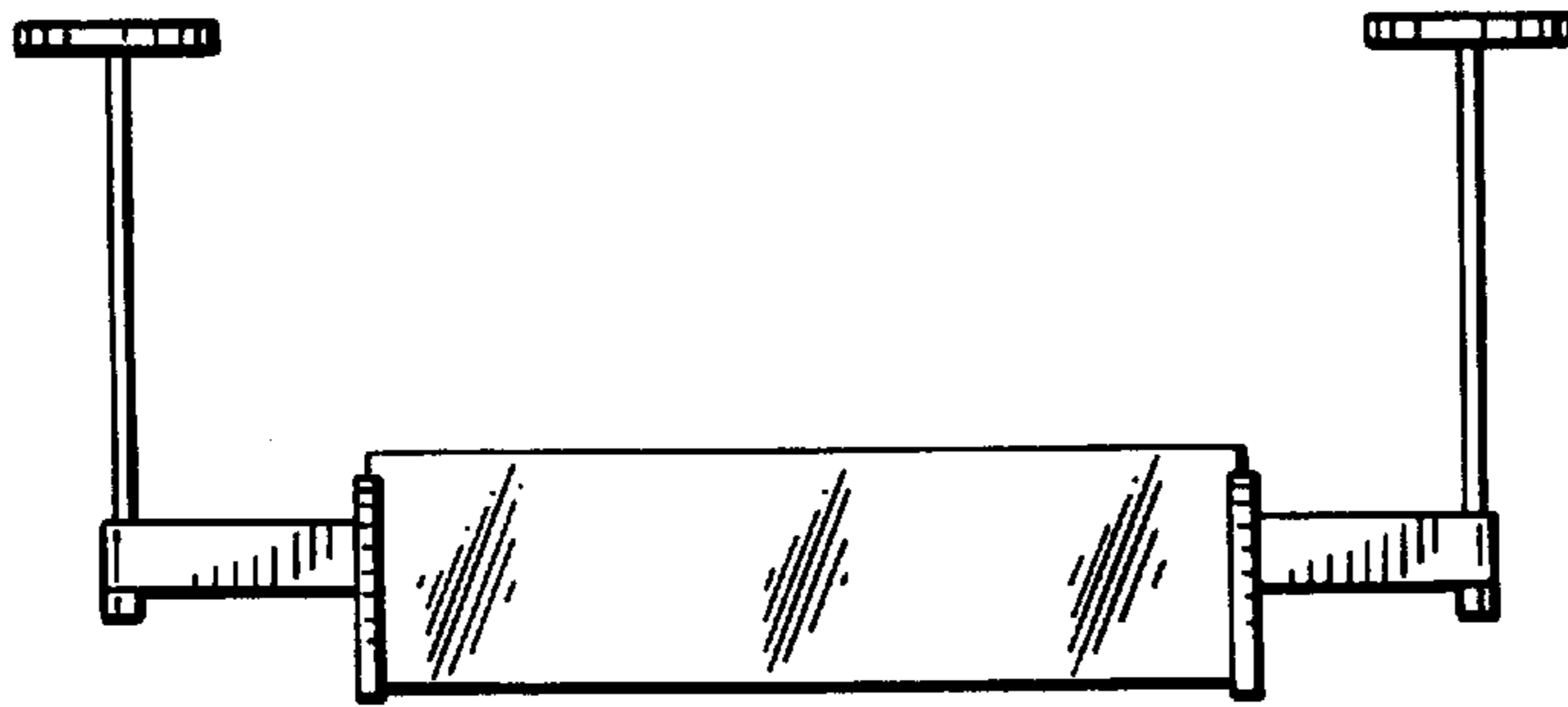

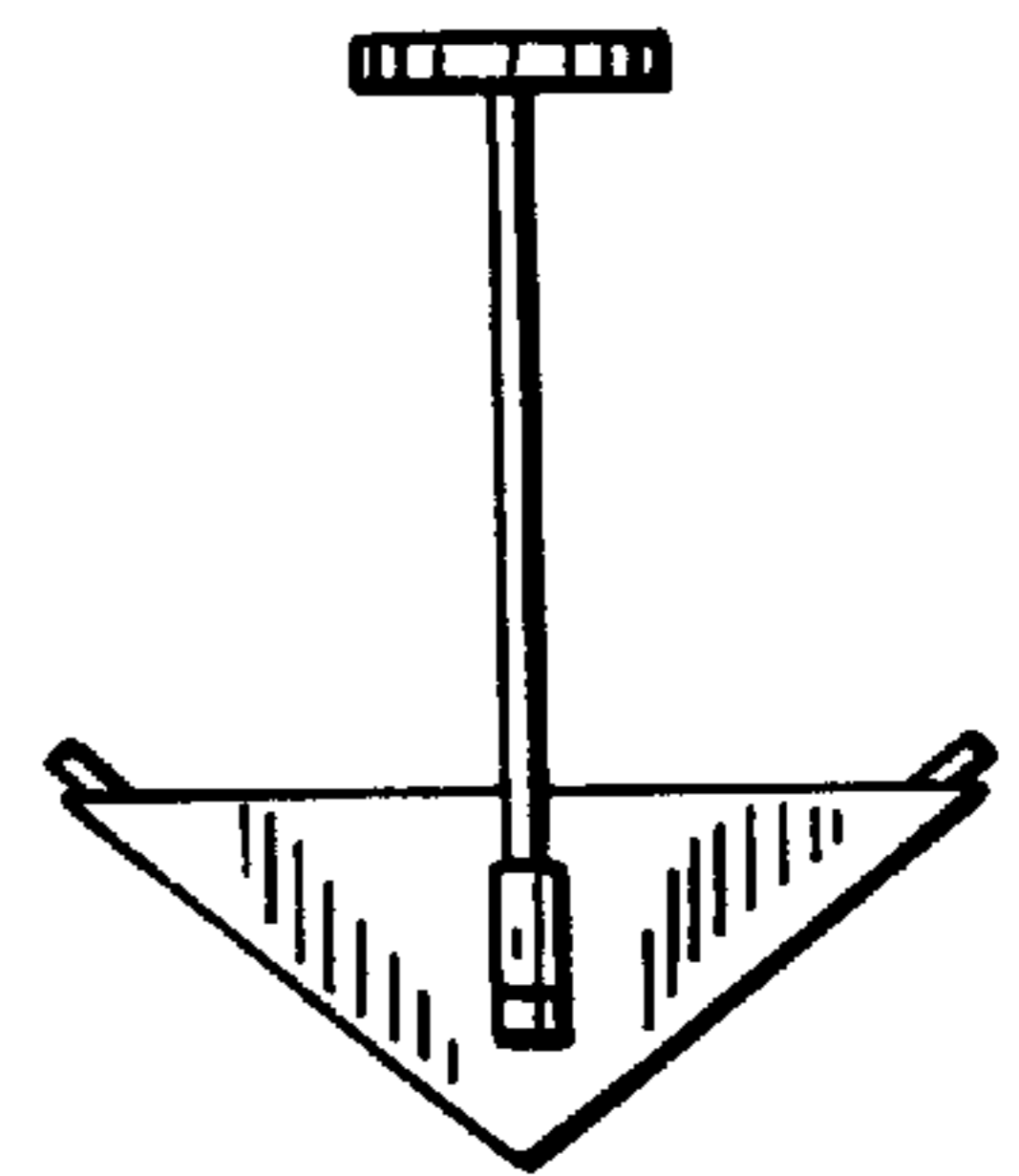

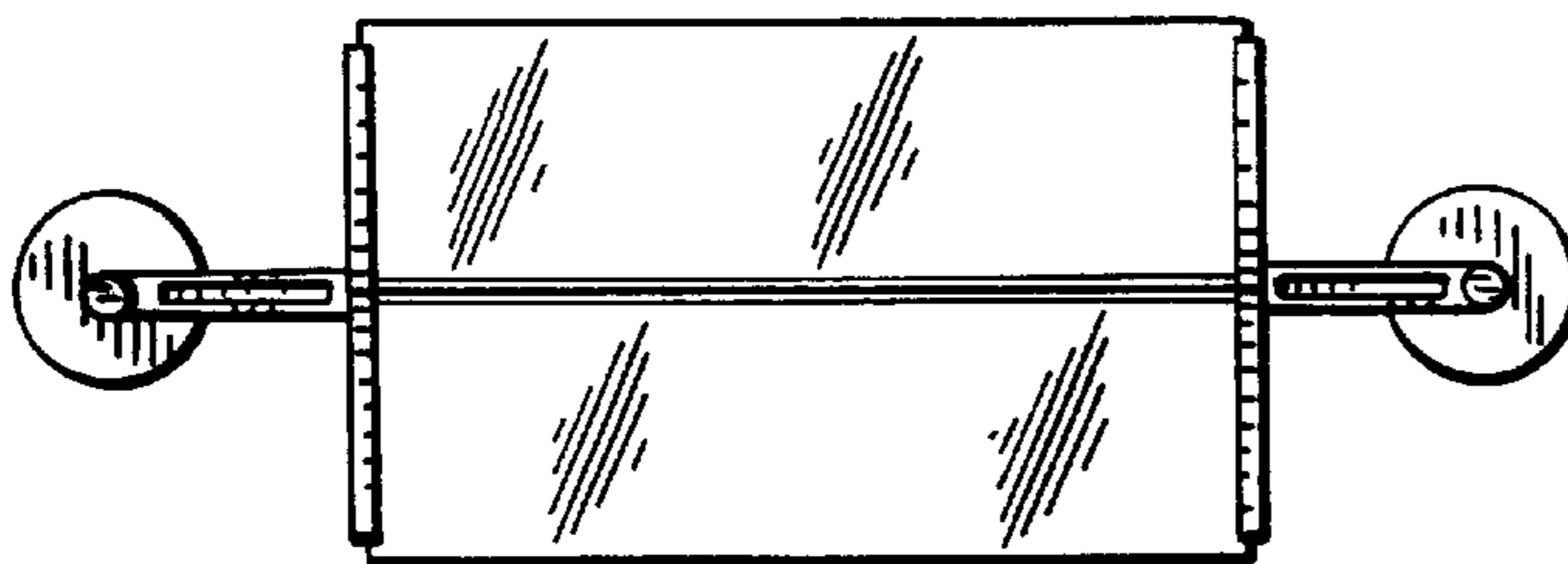

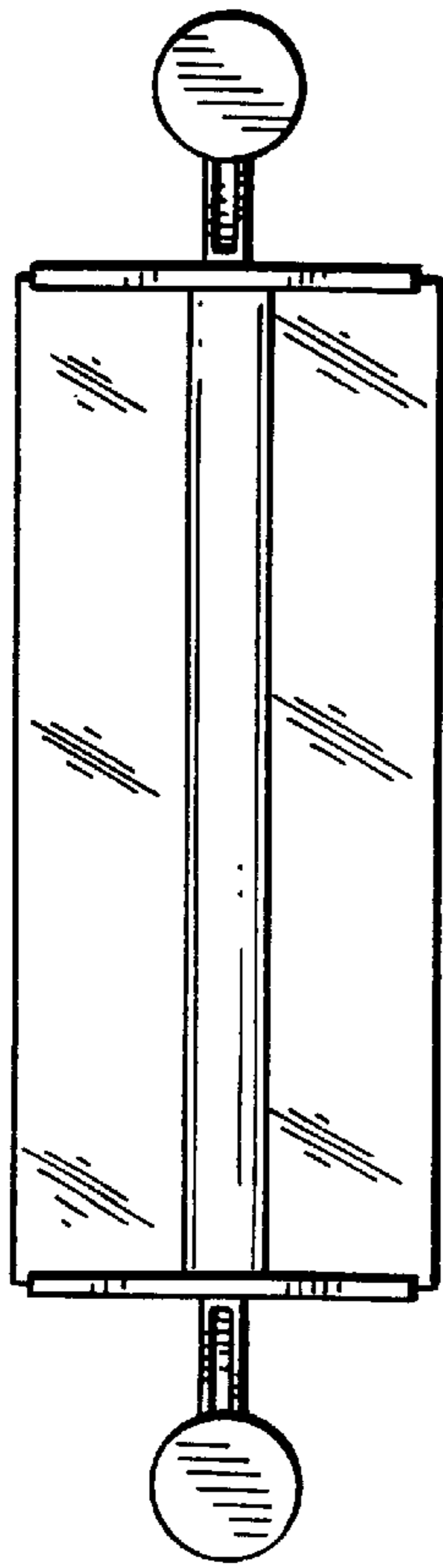

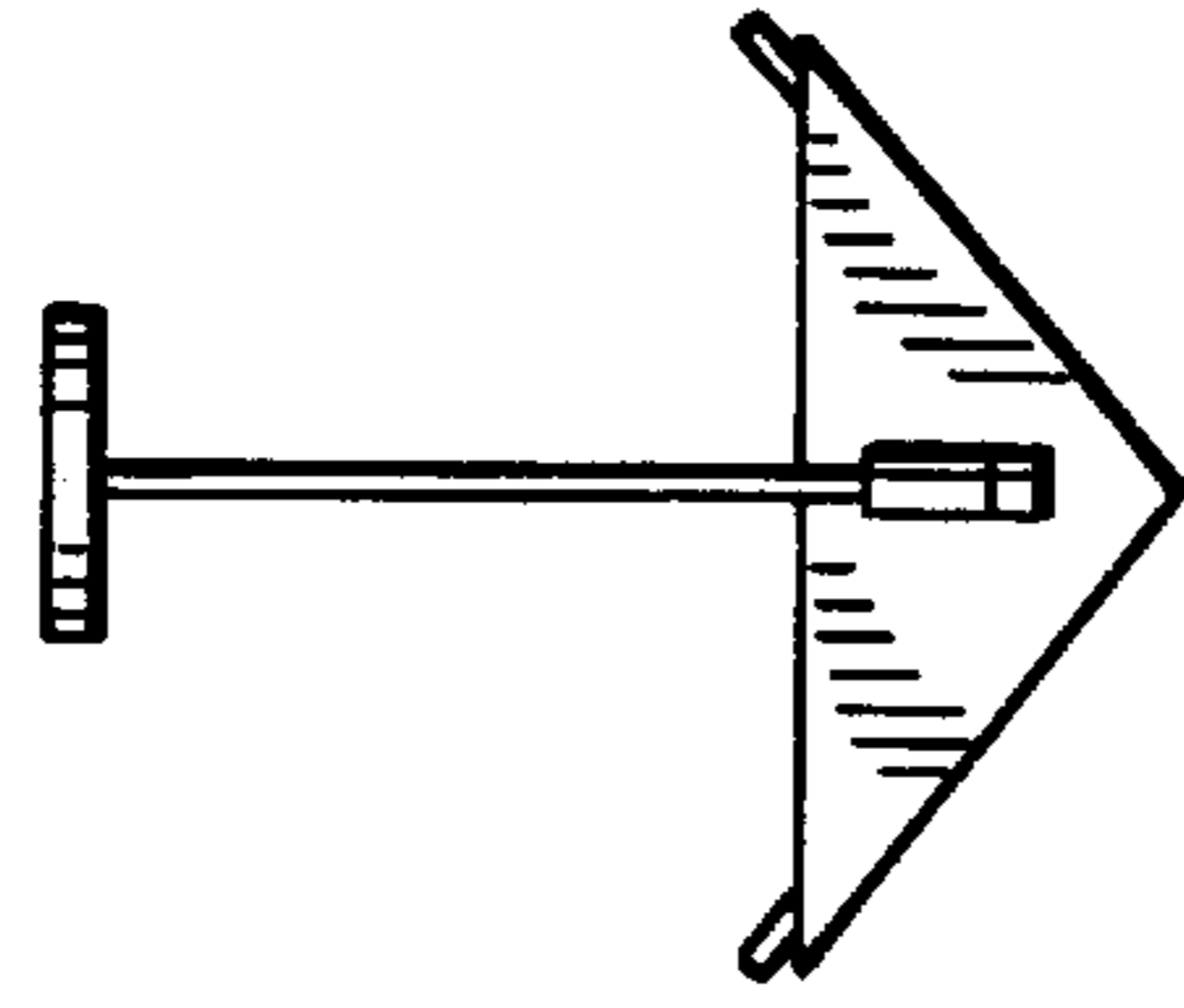

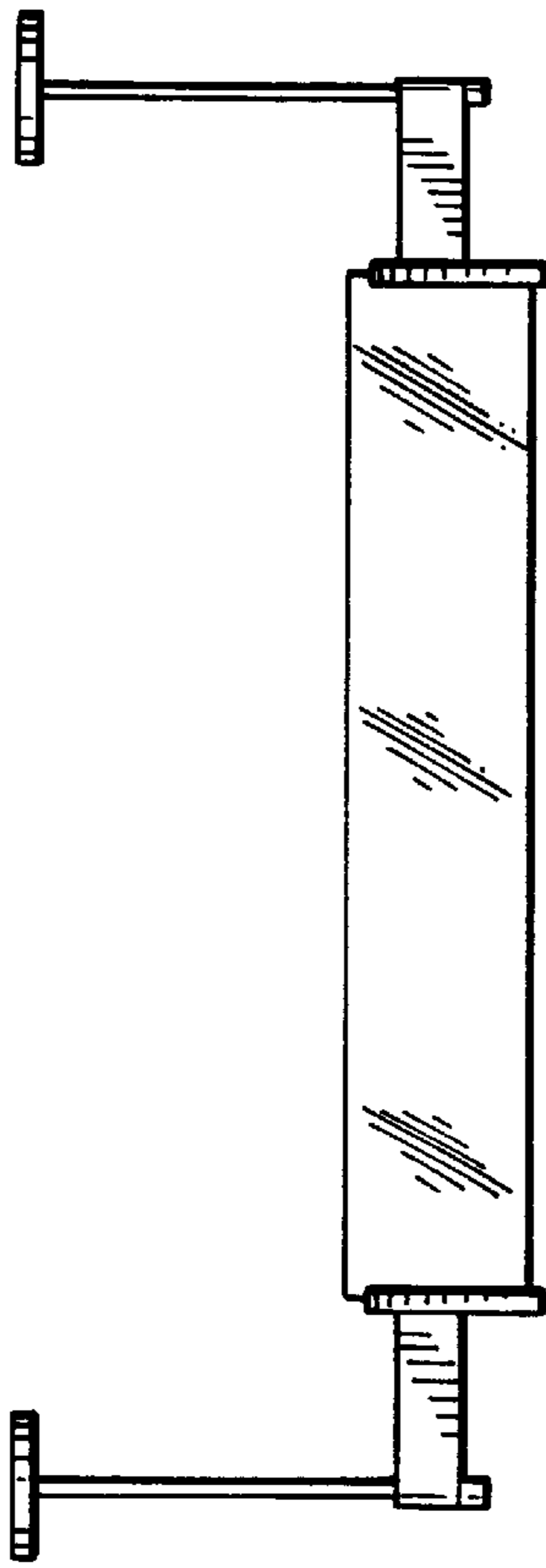

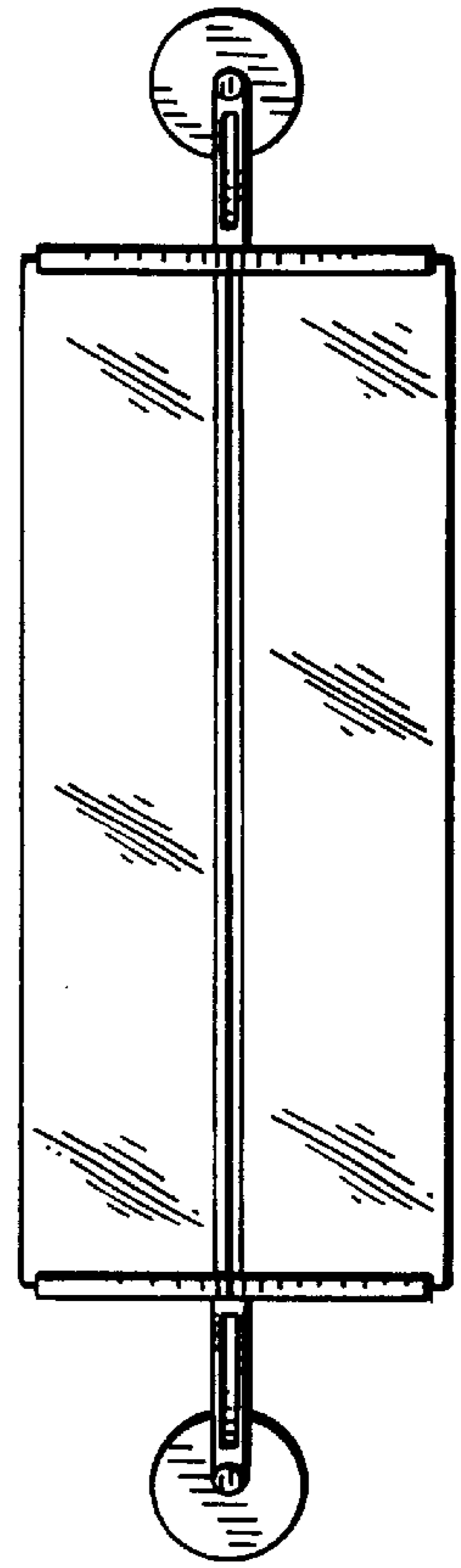

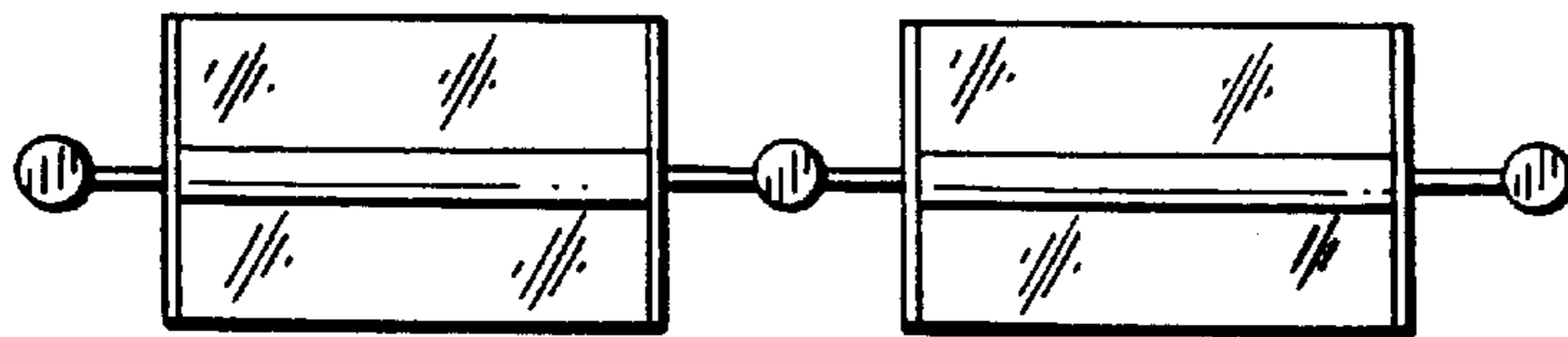

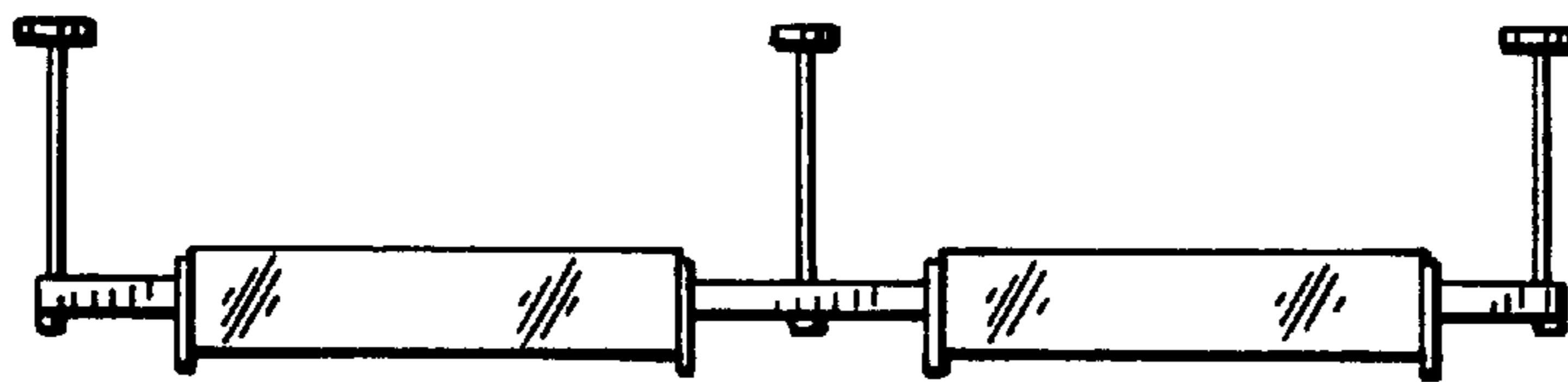

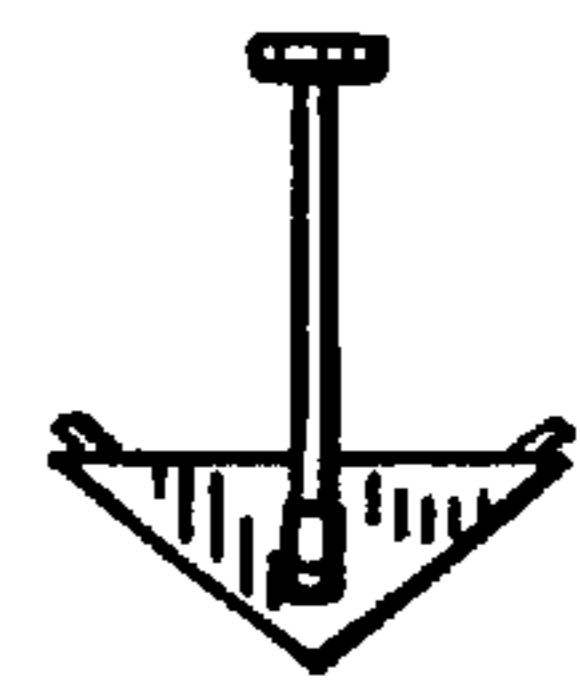

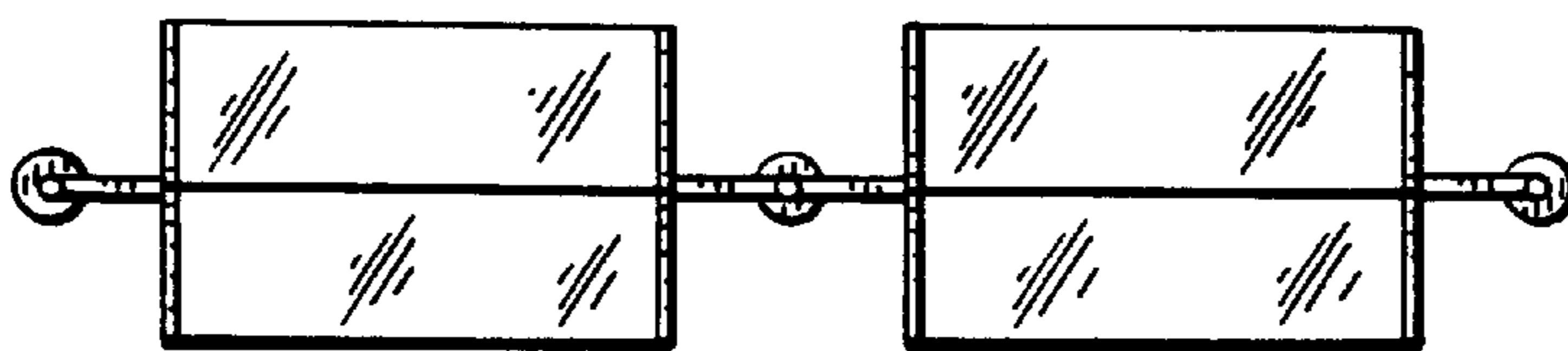

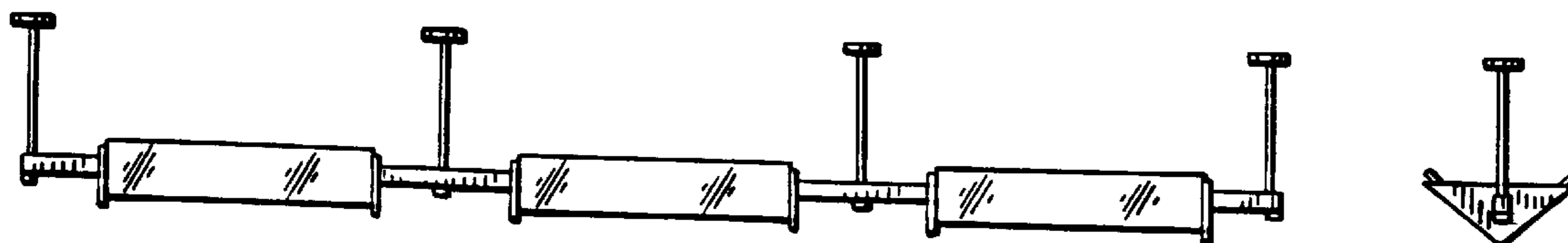
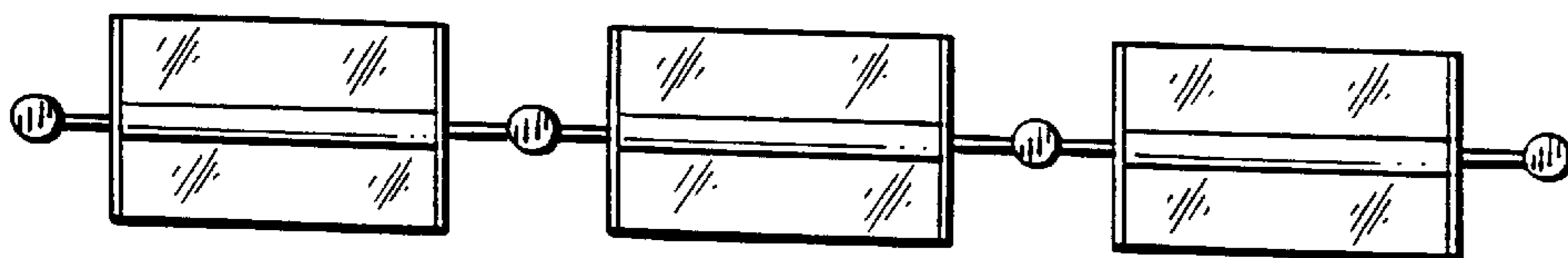

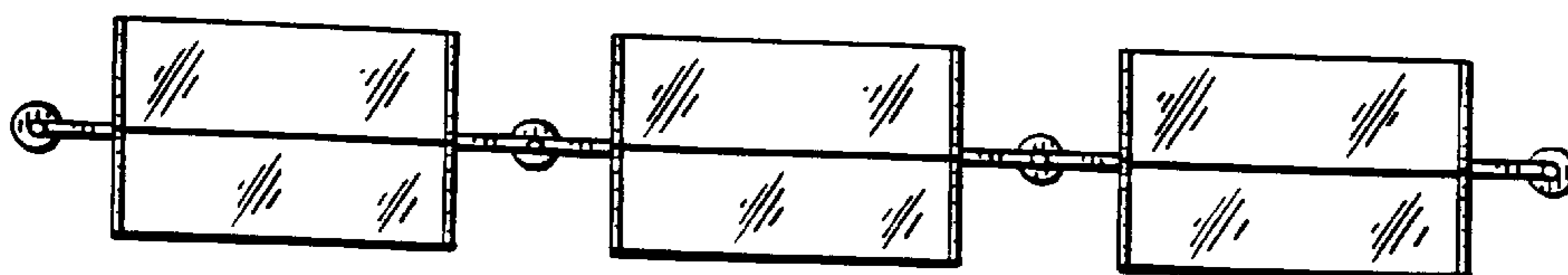

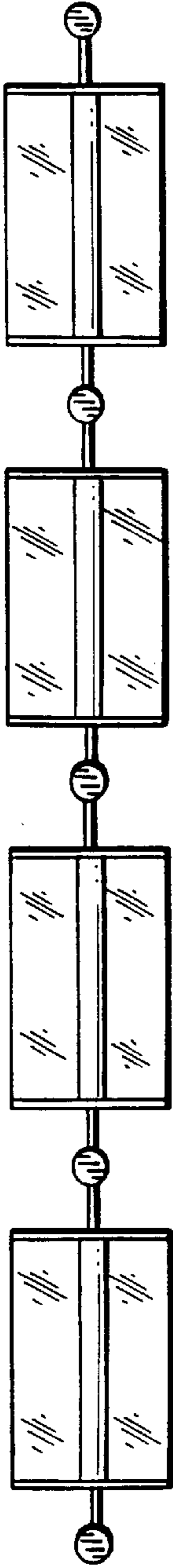

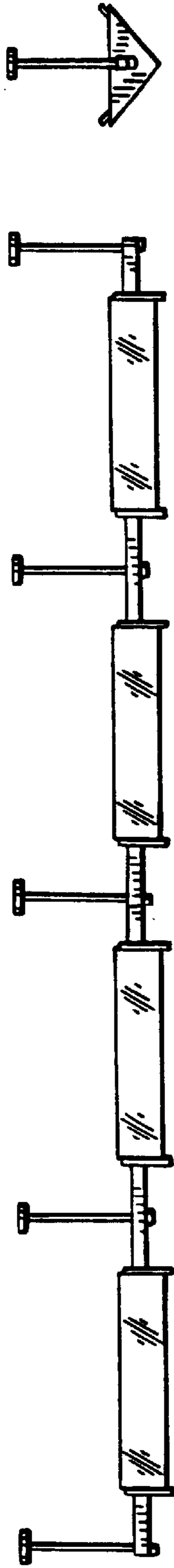
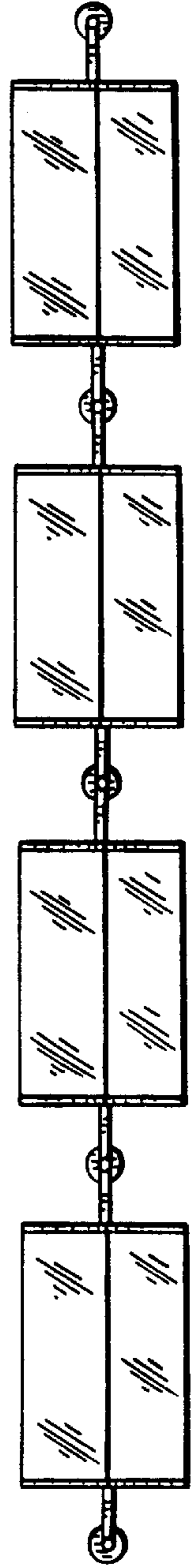

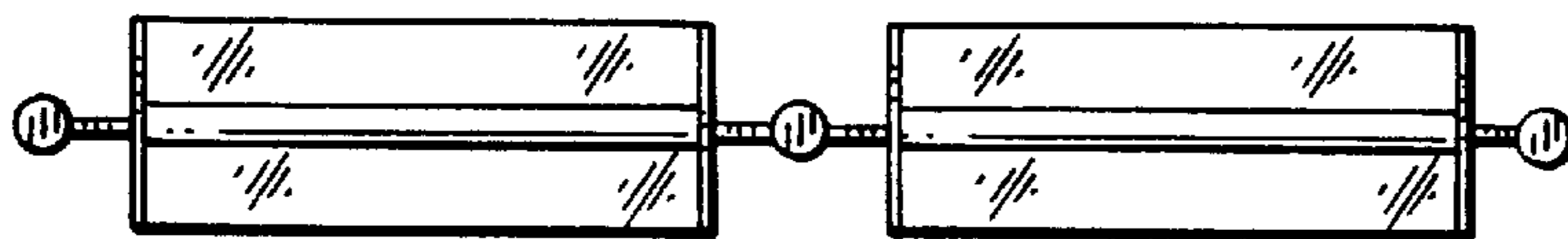

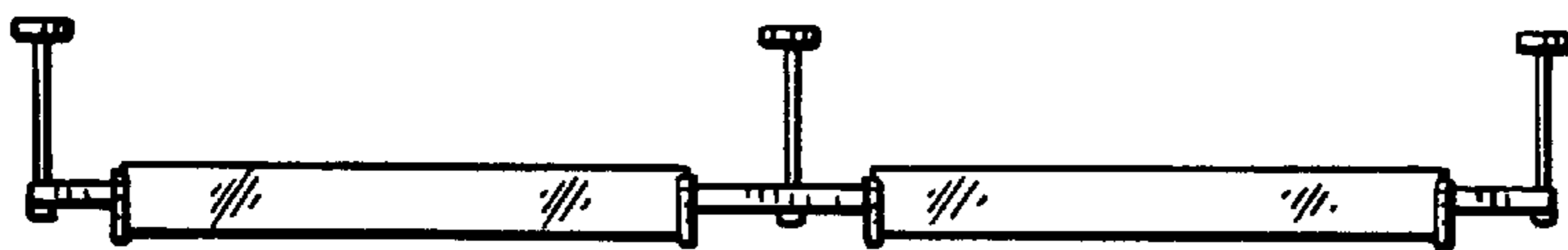

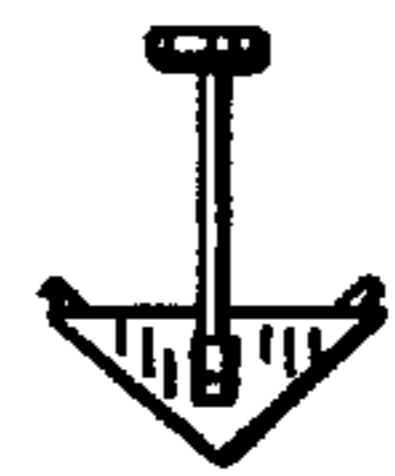

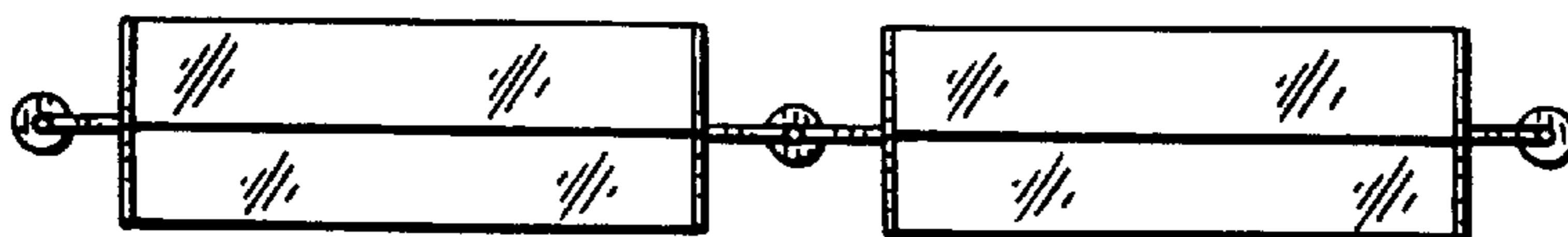

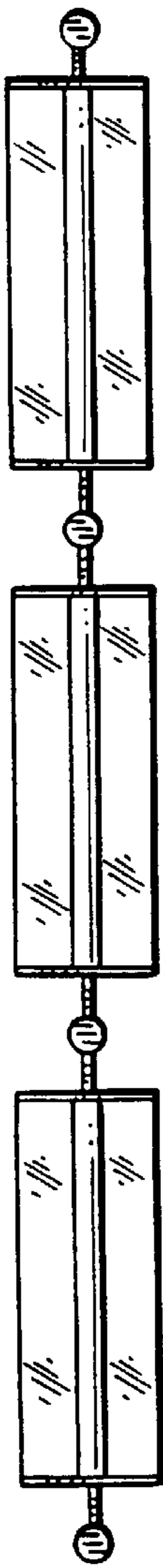

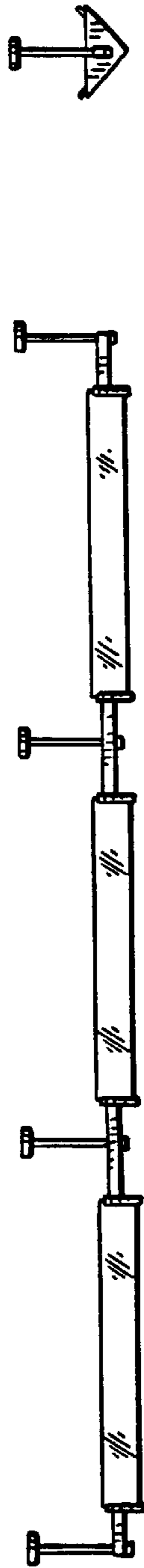

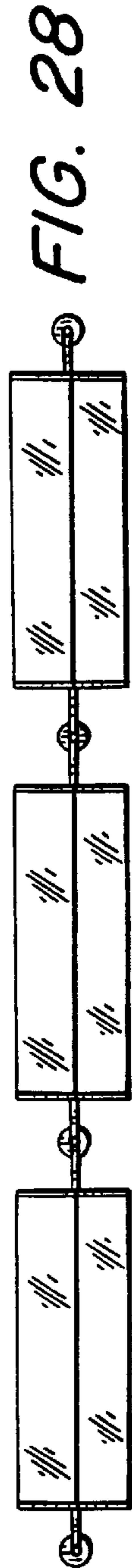

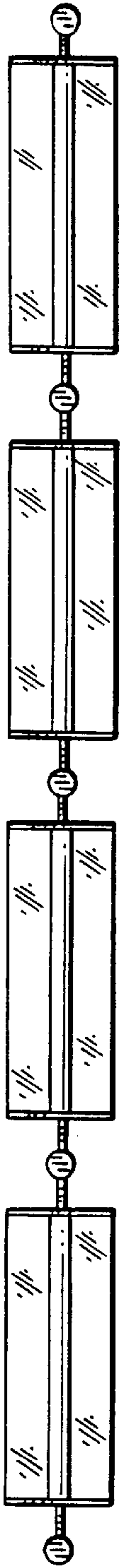

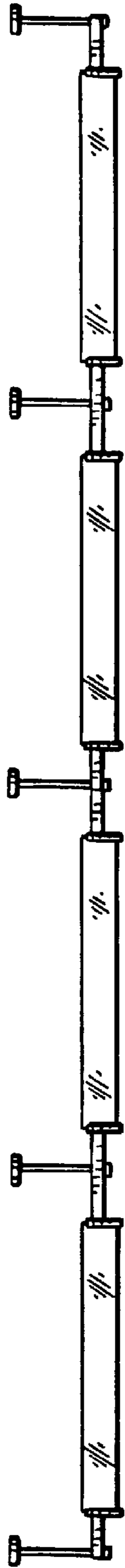

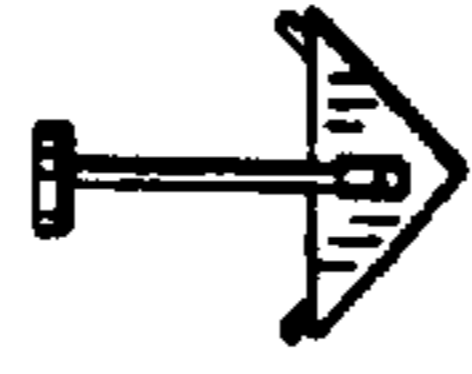

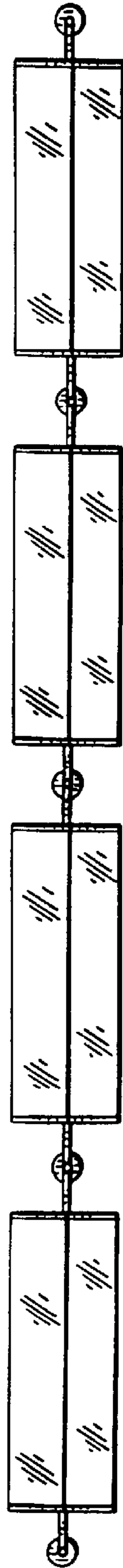

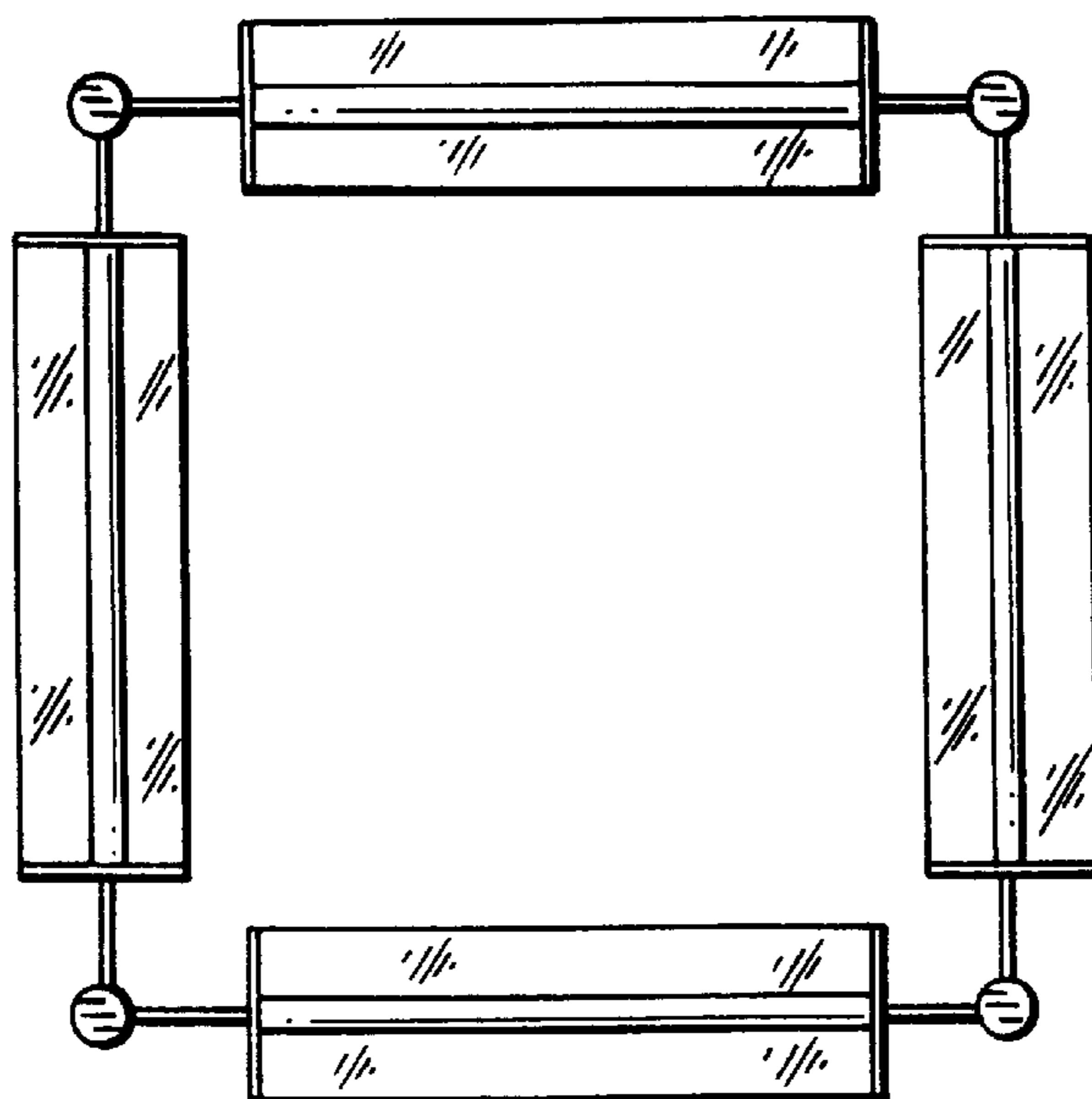

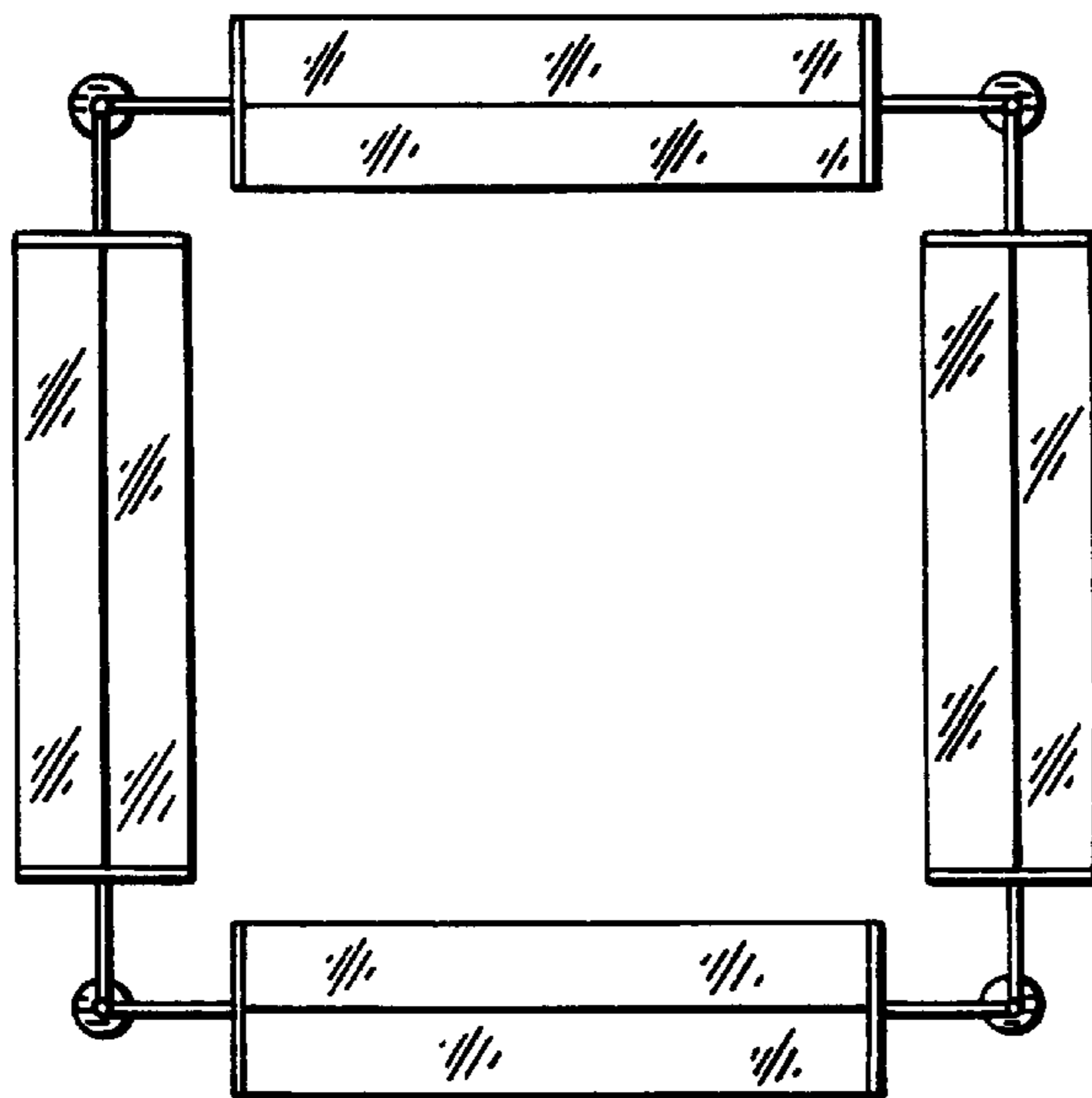

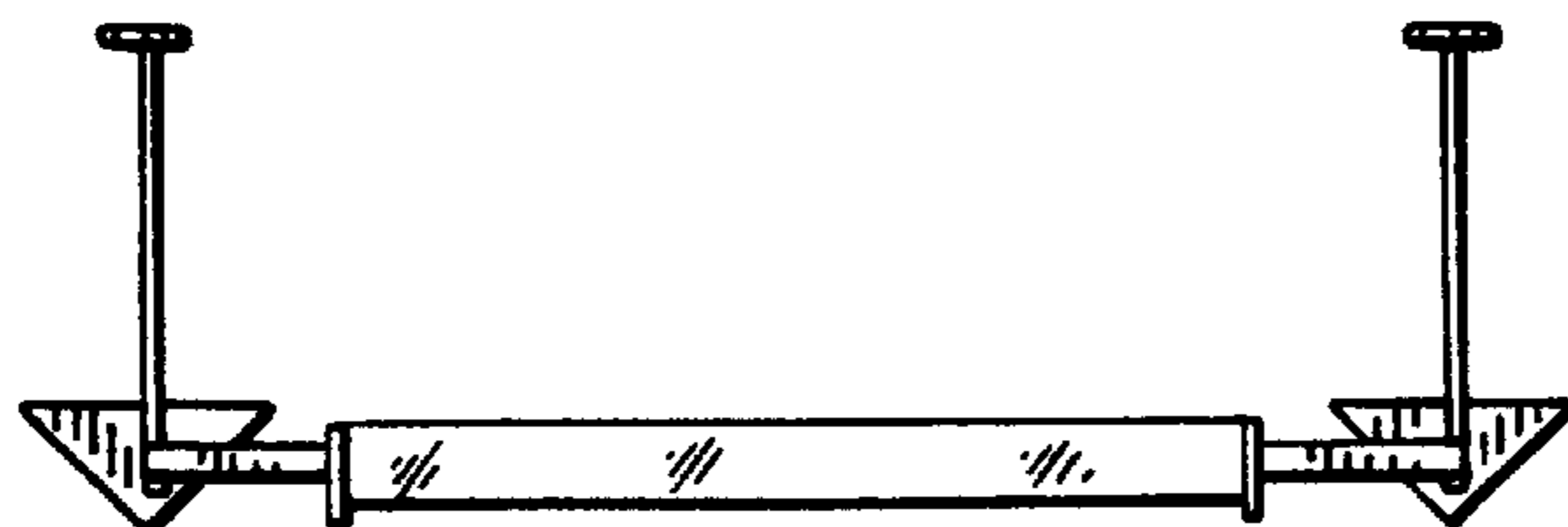
