DESCRIPTION

FIG. 1 is a perspective view of a detergent tablet showing the new design;

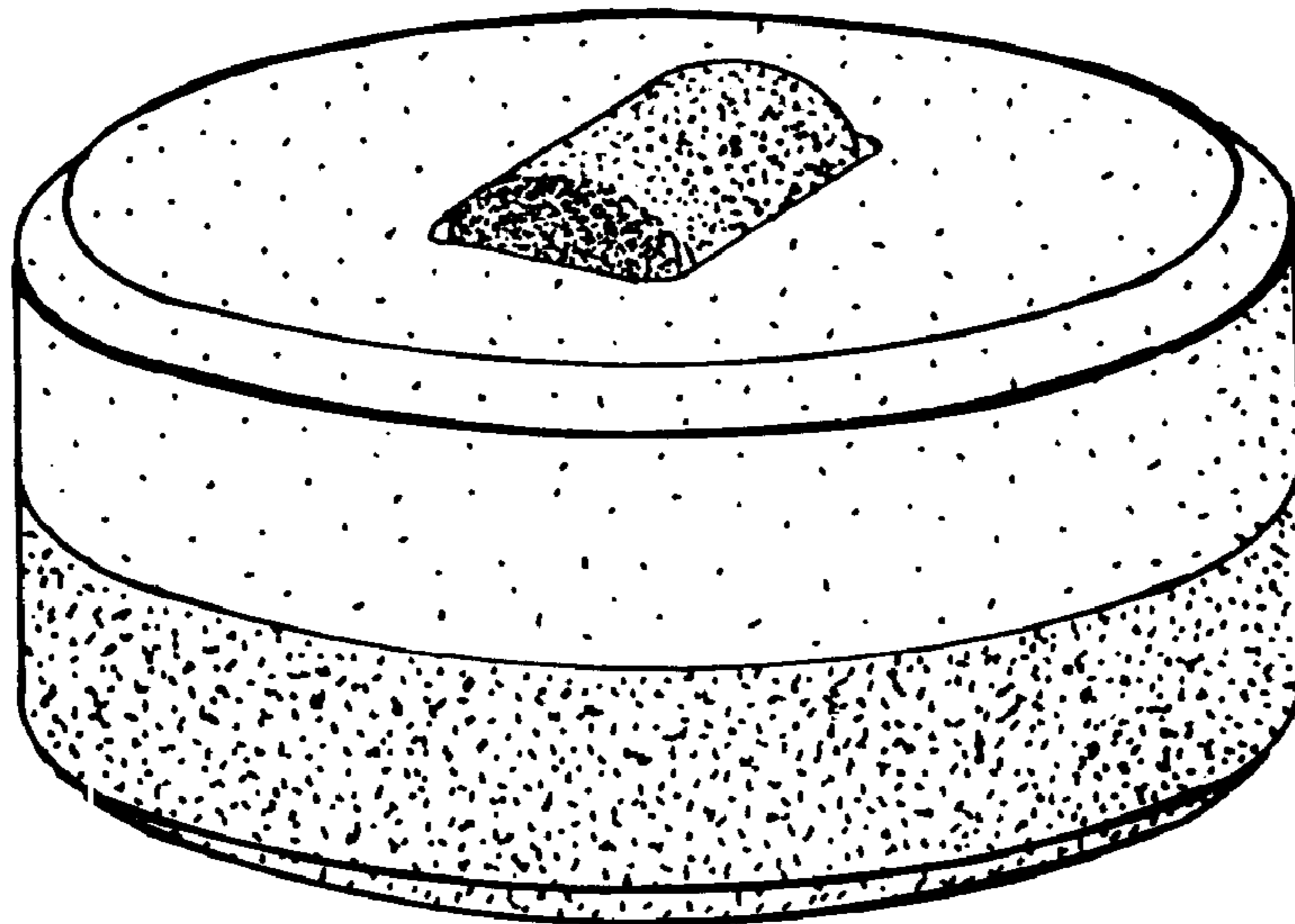
FIG. 2 is an end view thereof both ends appearing the same;

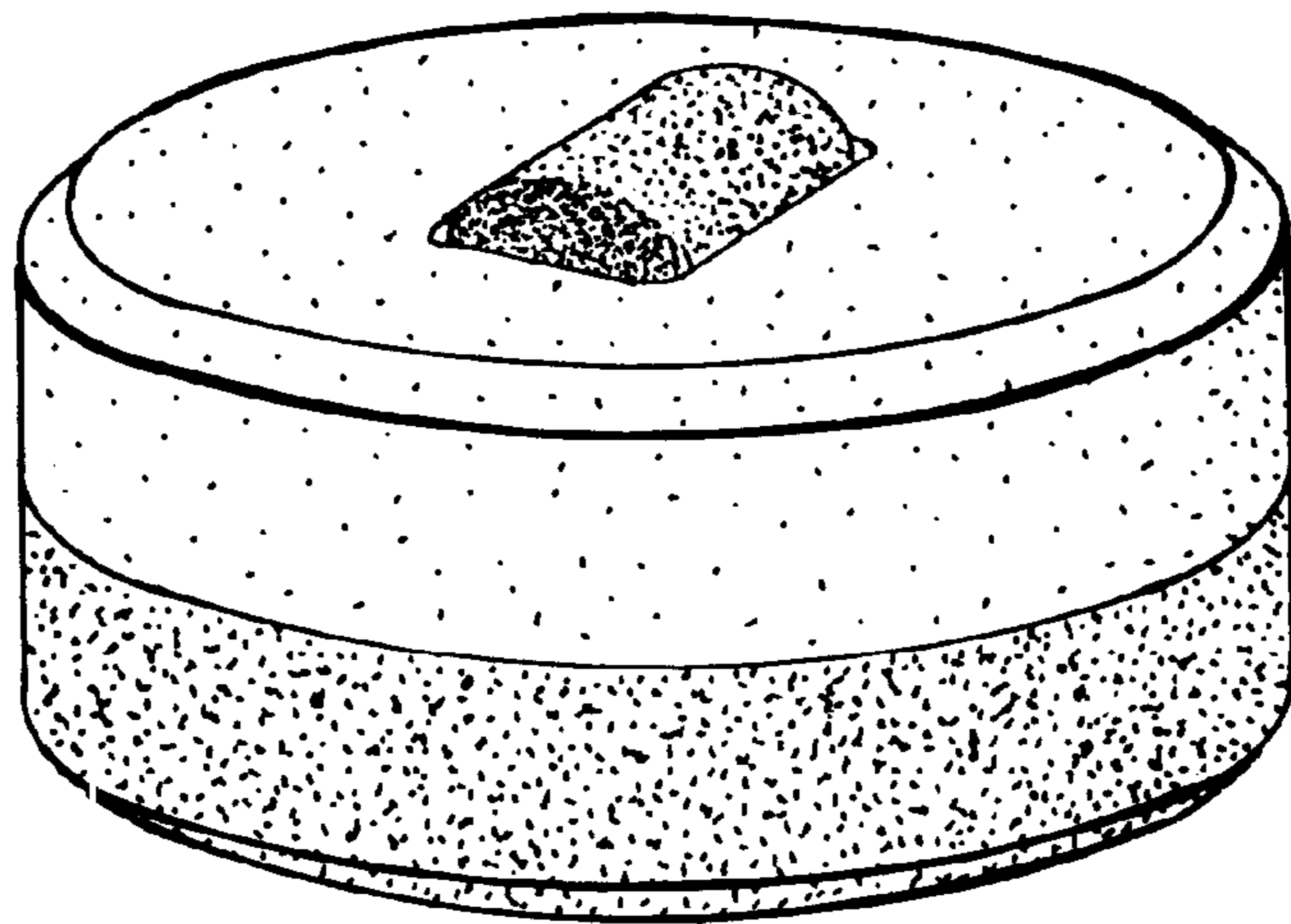

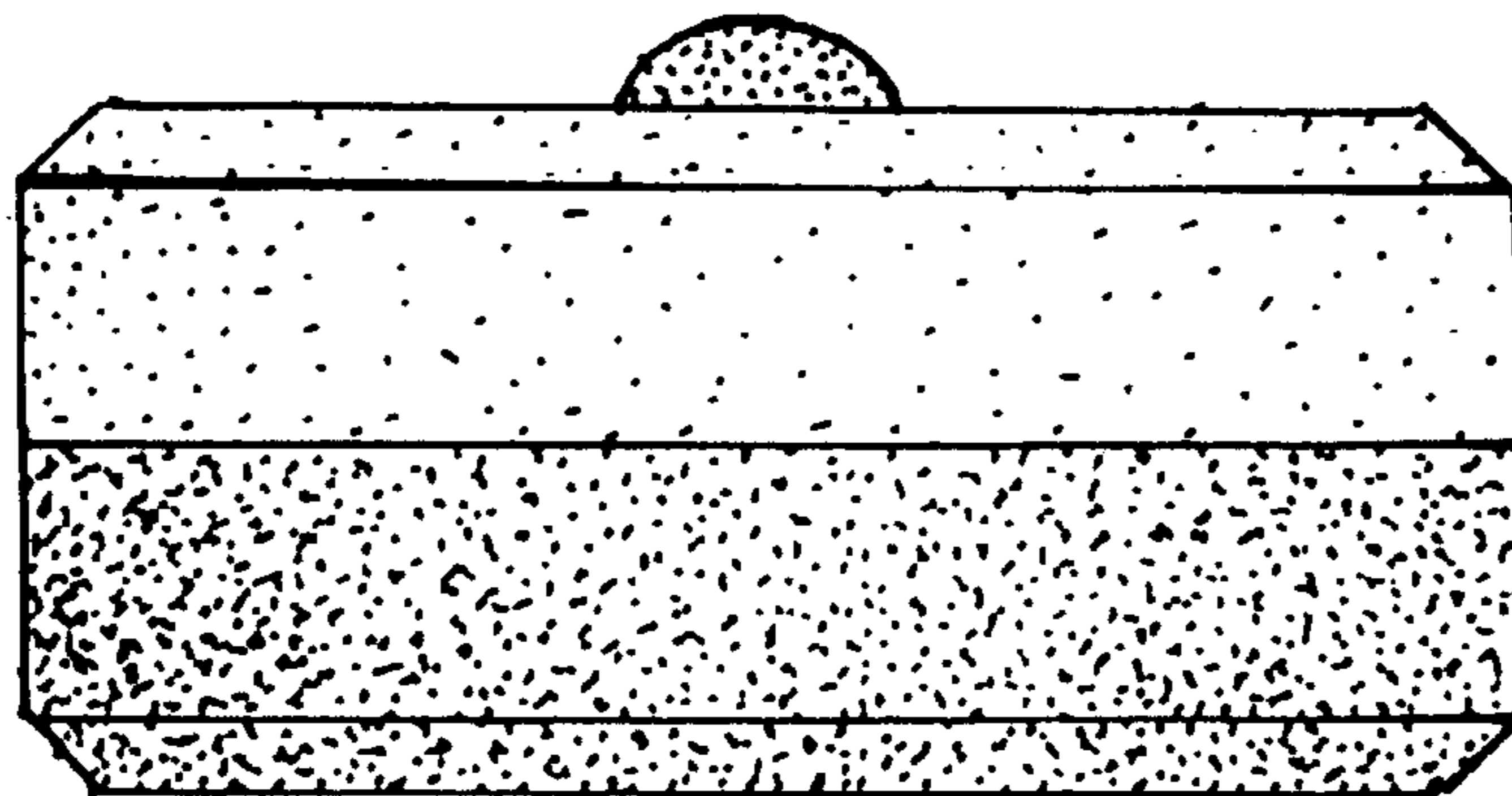

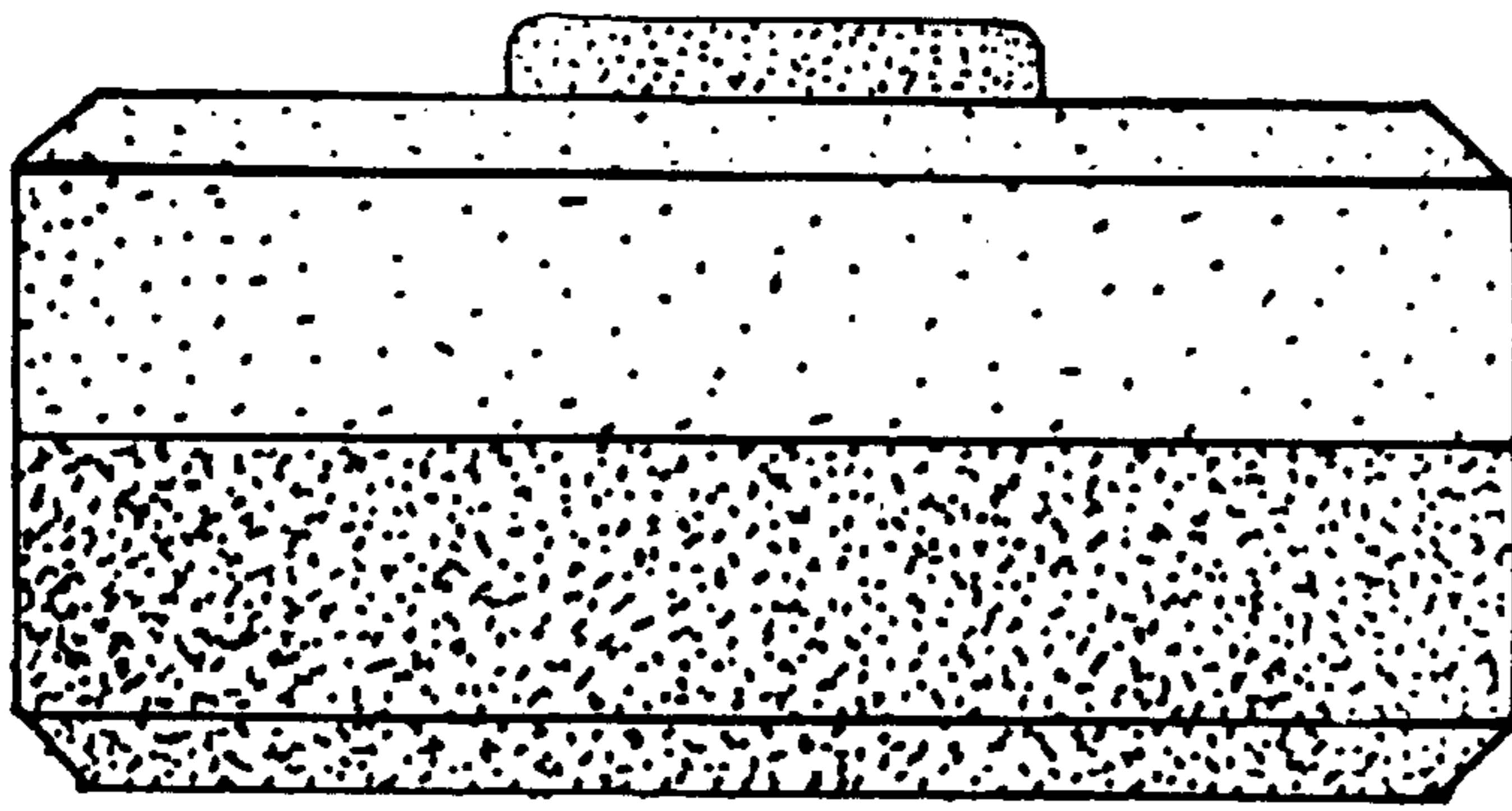

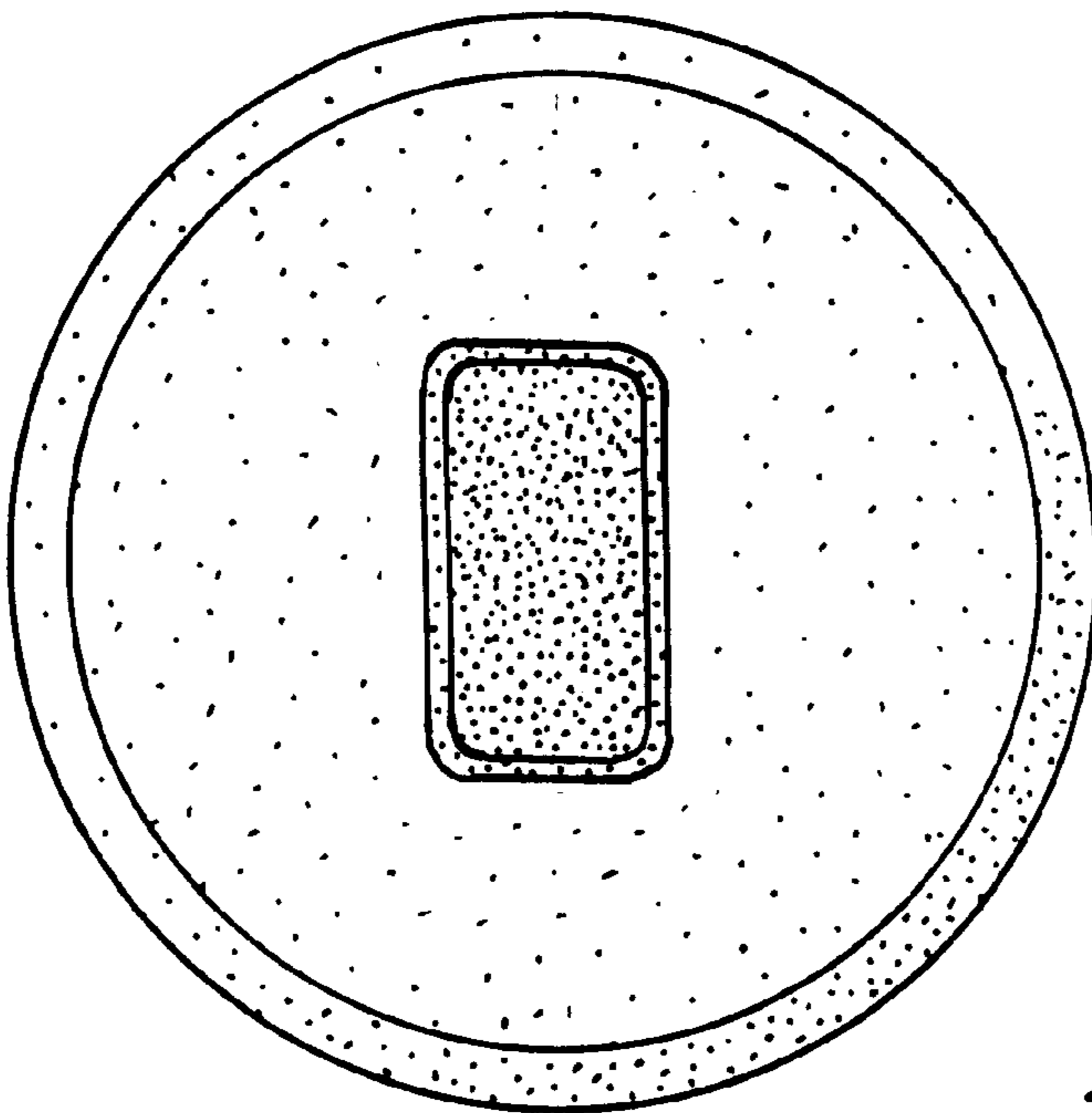
