(57) **CLAIM**

I claim the ornamental design for components of footwear, as shown and described.

**DESCRIPTION**

FIG. 1 is a left side elevation view of the components of footwear, showing my new design;  
 FIG. 2 is a perspective view of the upper from the right front thereof;  
 FIG. 3 is a right side elevation view of the upper;  
 FIG. 4 is a front end view of the upper; and,  
 FIG. 5 is a rear end view thereof.  
 The broken lines shown in FIGS. 1-5 are for illustrative purposes only and form no part of the claimed design.

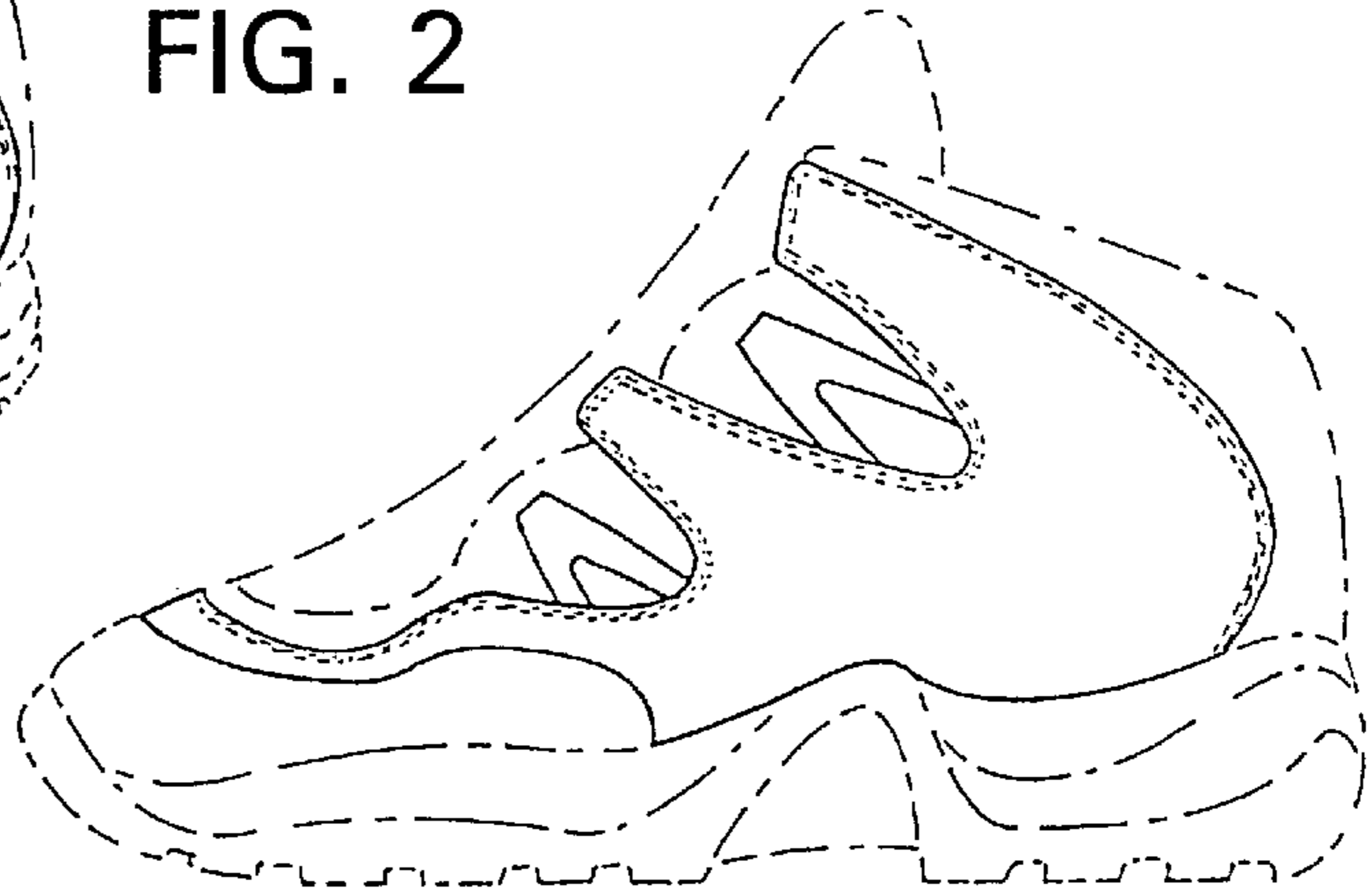

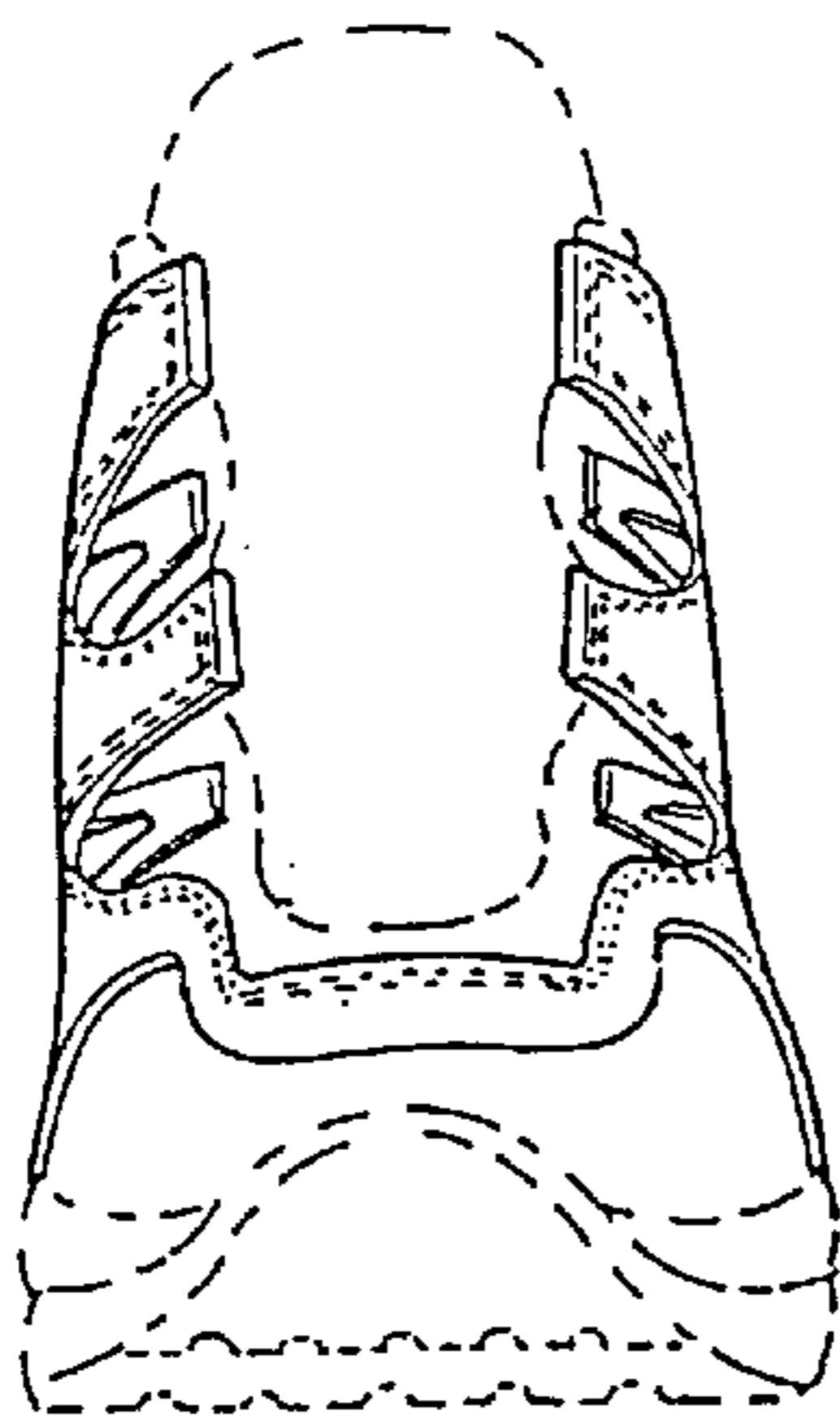

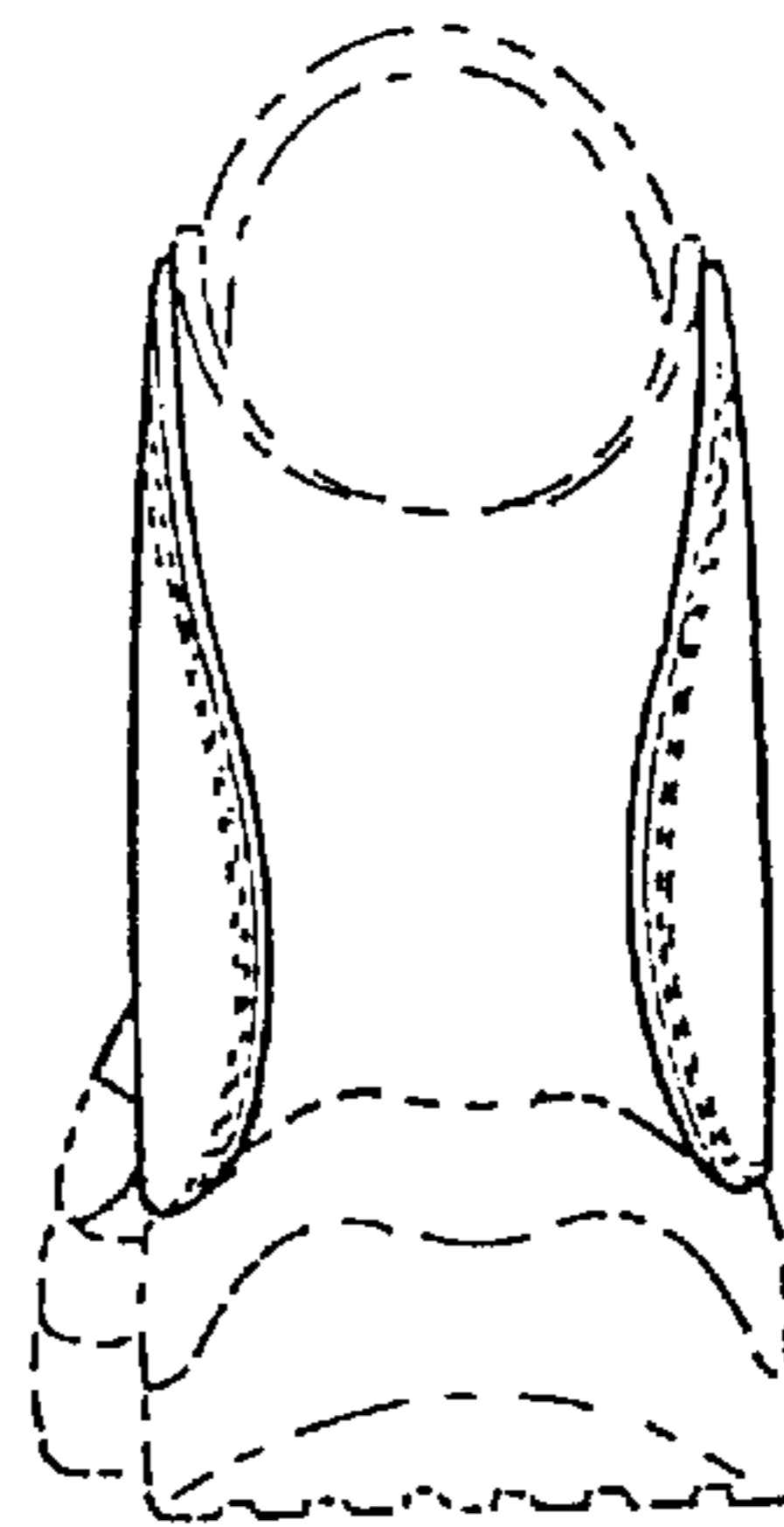
