DESCRIPTION

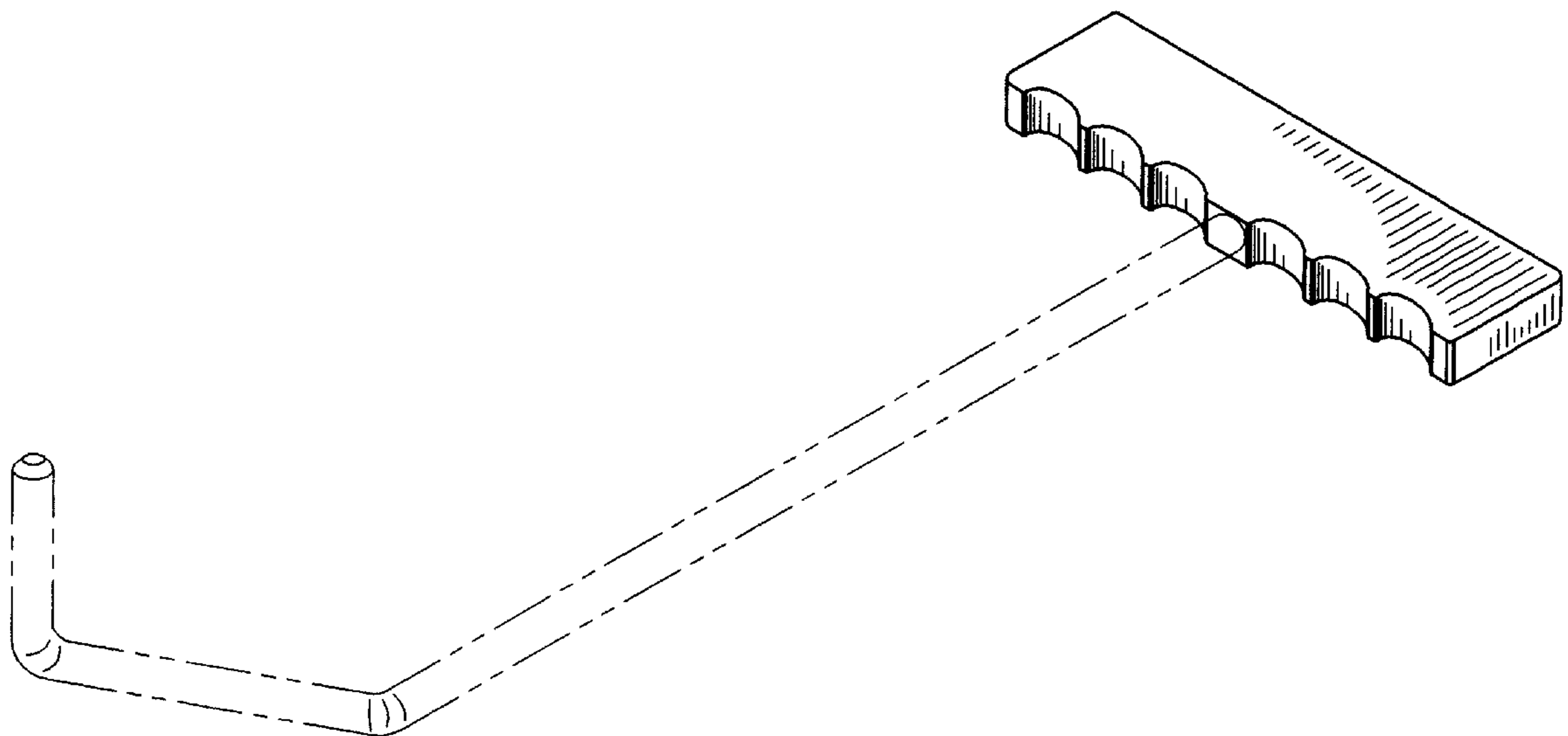
FIG. 1 is an isometric view of a dent removal tool handle showing my new design;
FIG. 2 is a front view thereof;
FIG. 3 is a right side view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a bottom view thereof;
FIG. 6 is an isometric view of a second embodiment of the dent removal tool handle, the sole difference being the off-center placement of the flat surface; and,
FIG. 7 is an isometric view of a third embodiment of the dent removal tool handle, the sole difference being the off-center placement of the flat surface.
The broken line showing of the tool rod is for illustrative purposes only and forms no part of the claimed design.

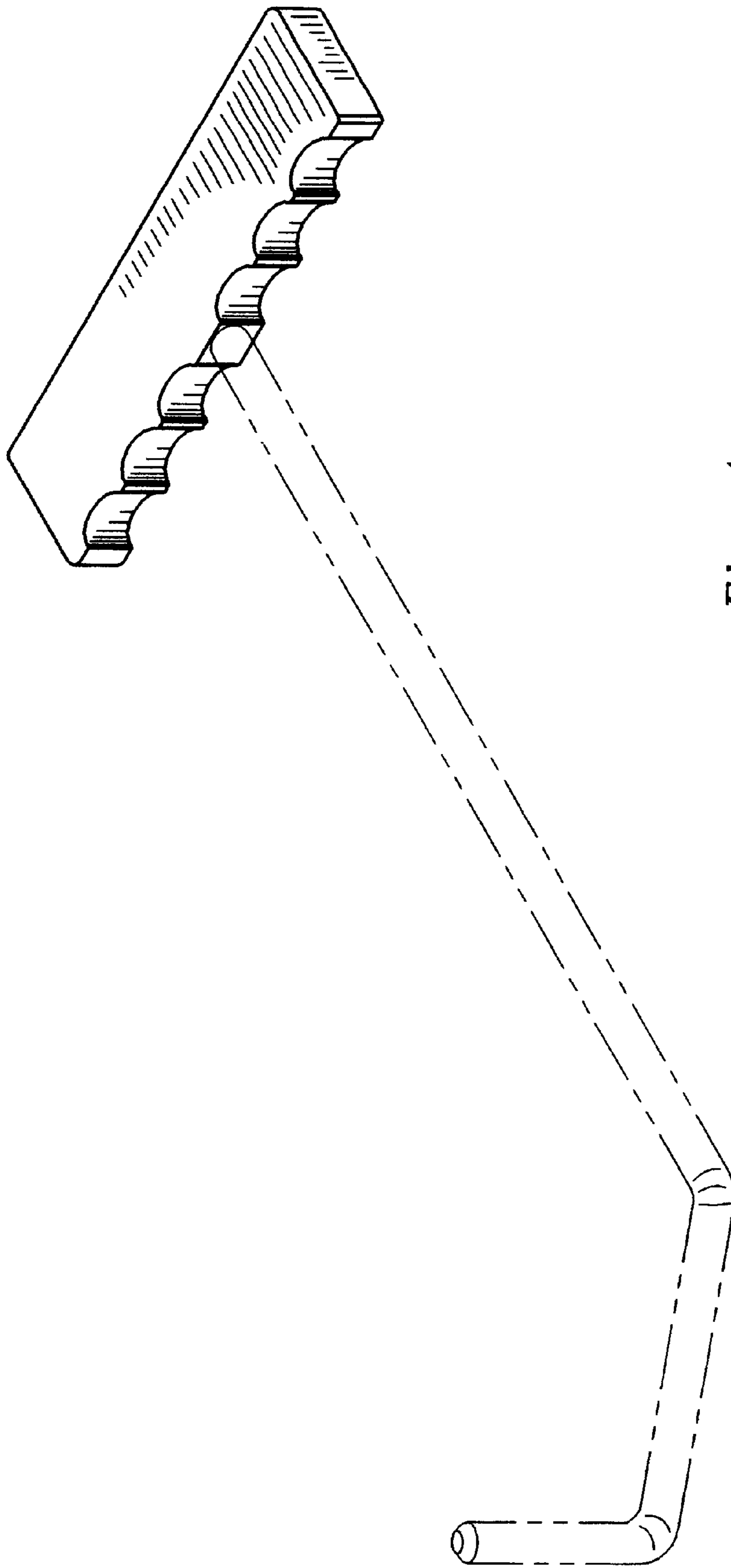

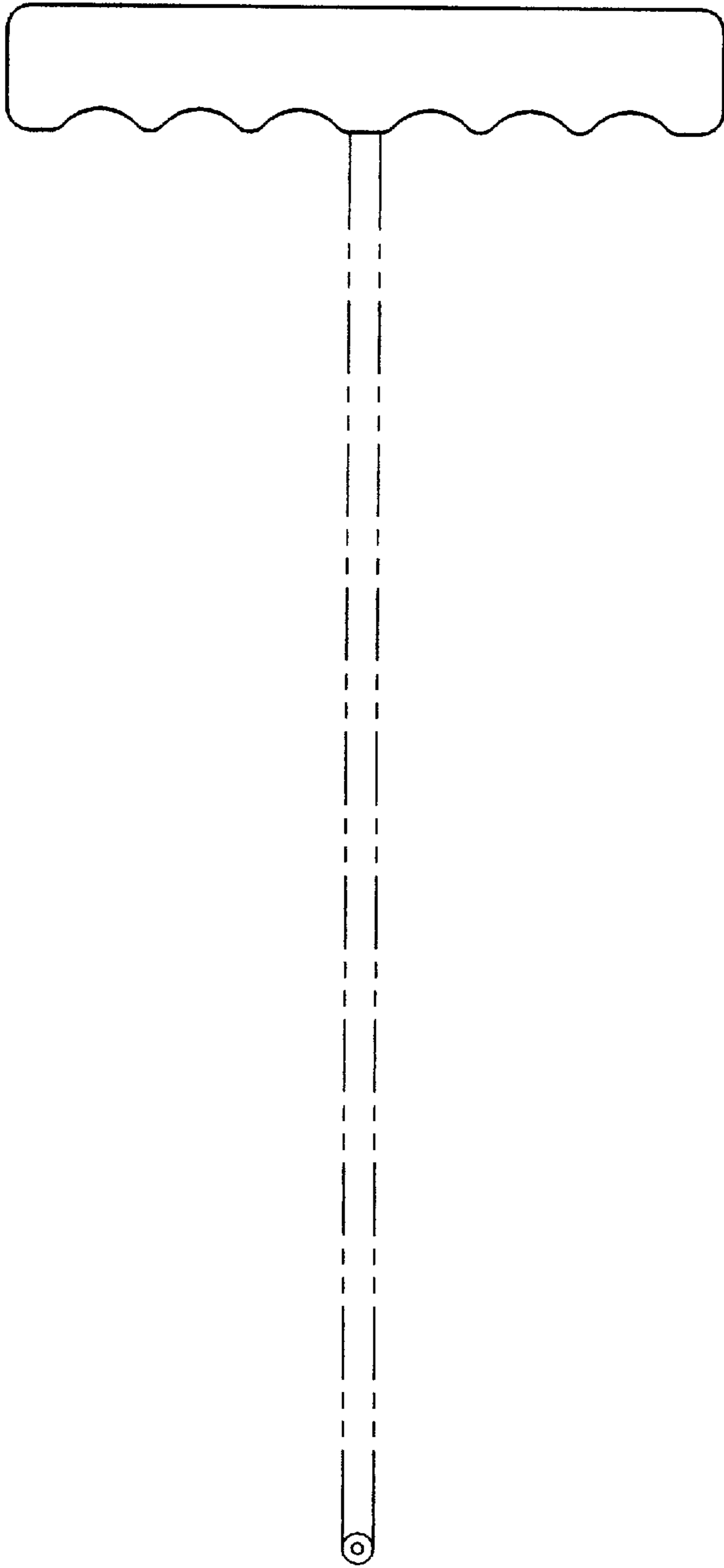

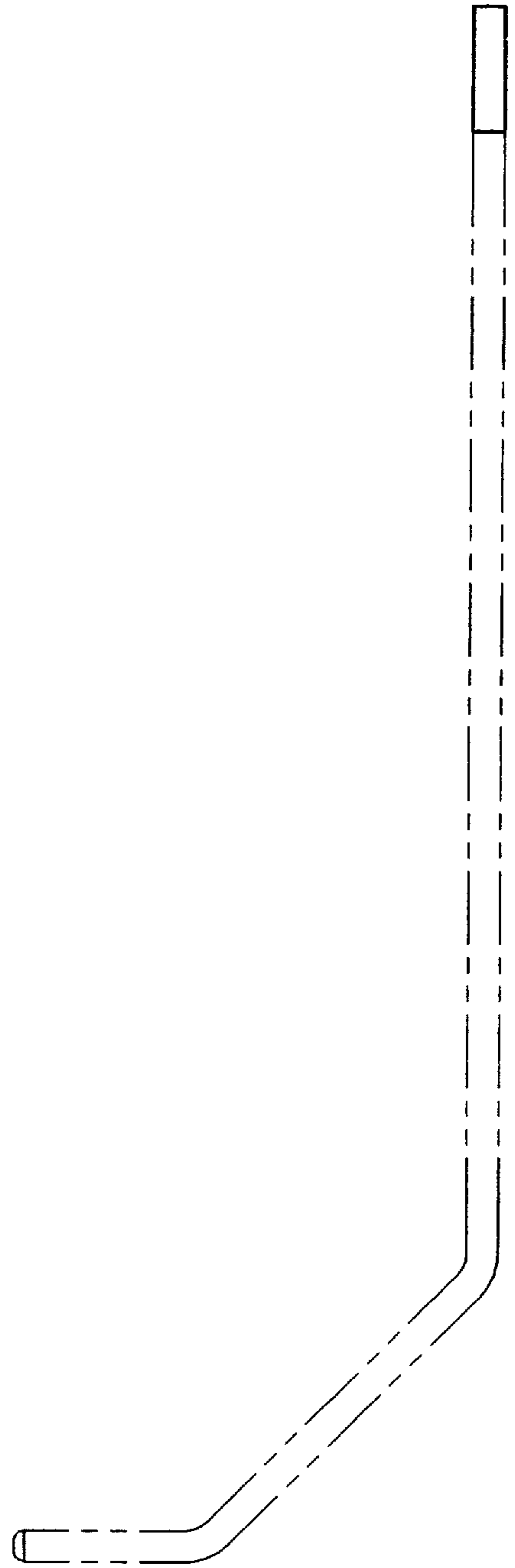

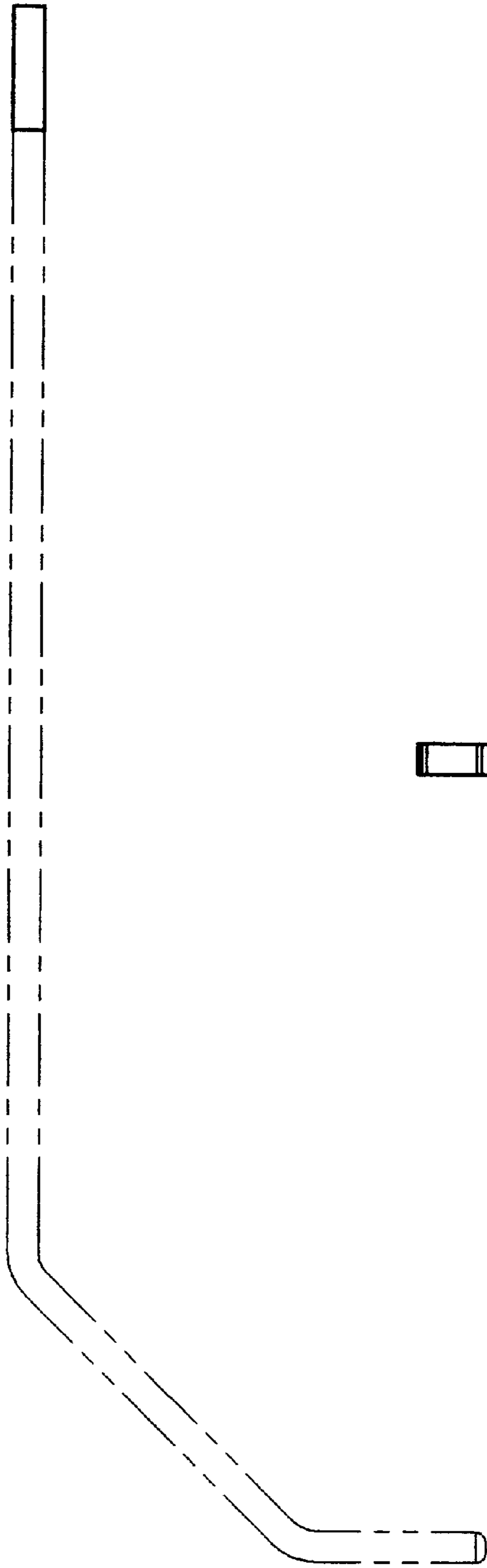

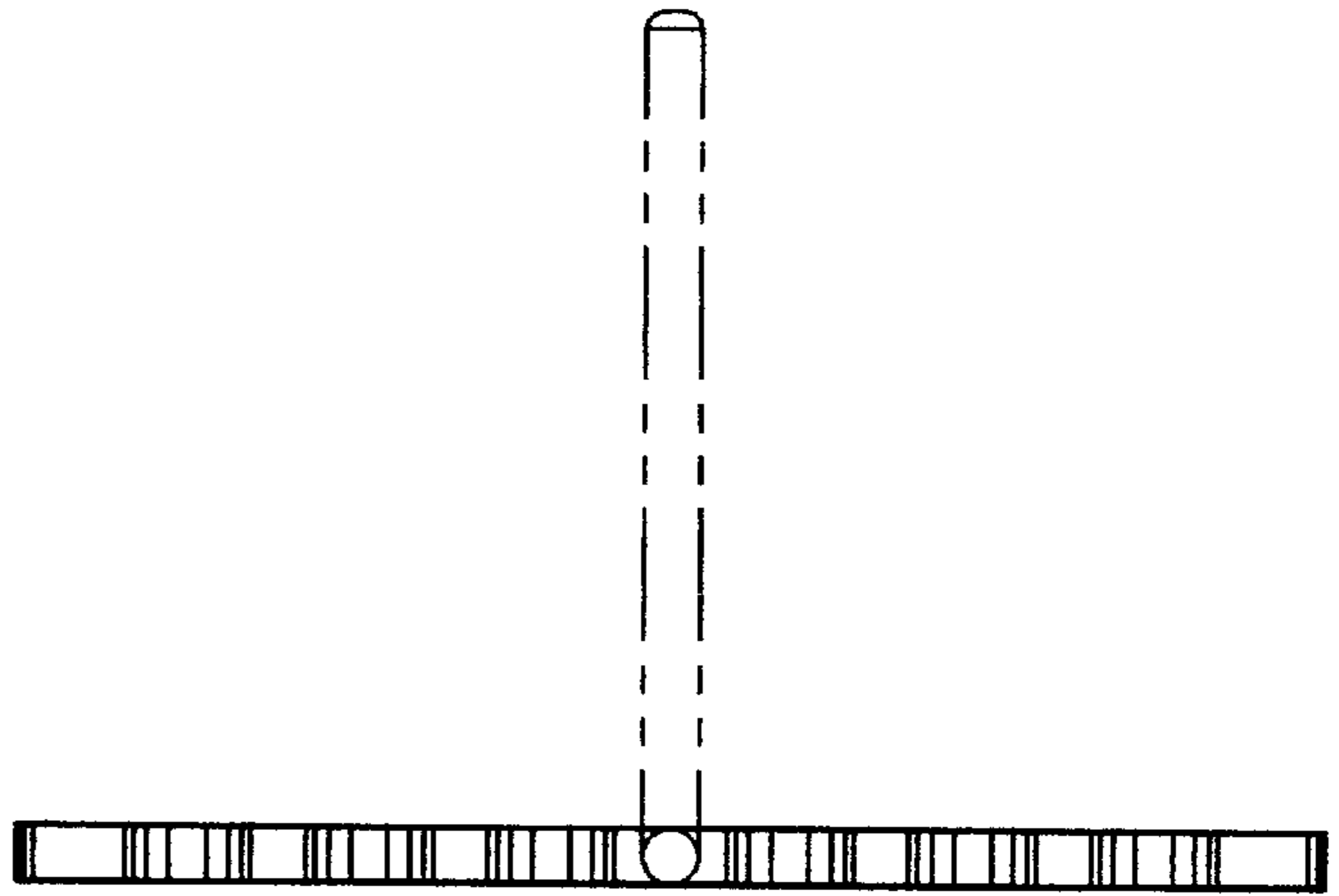

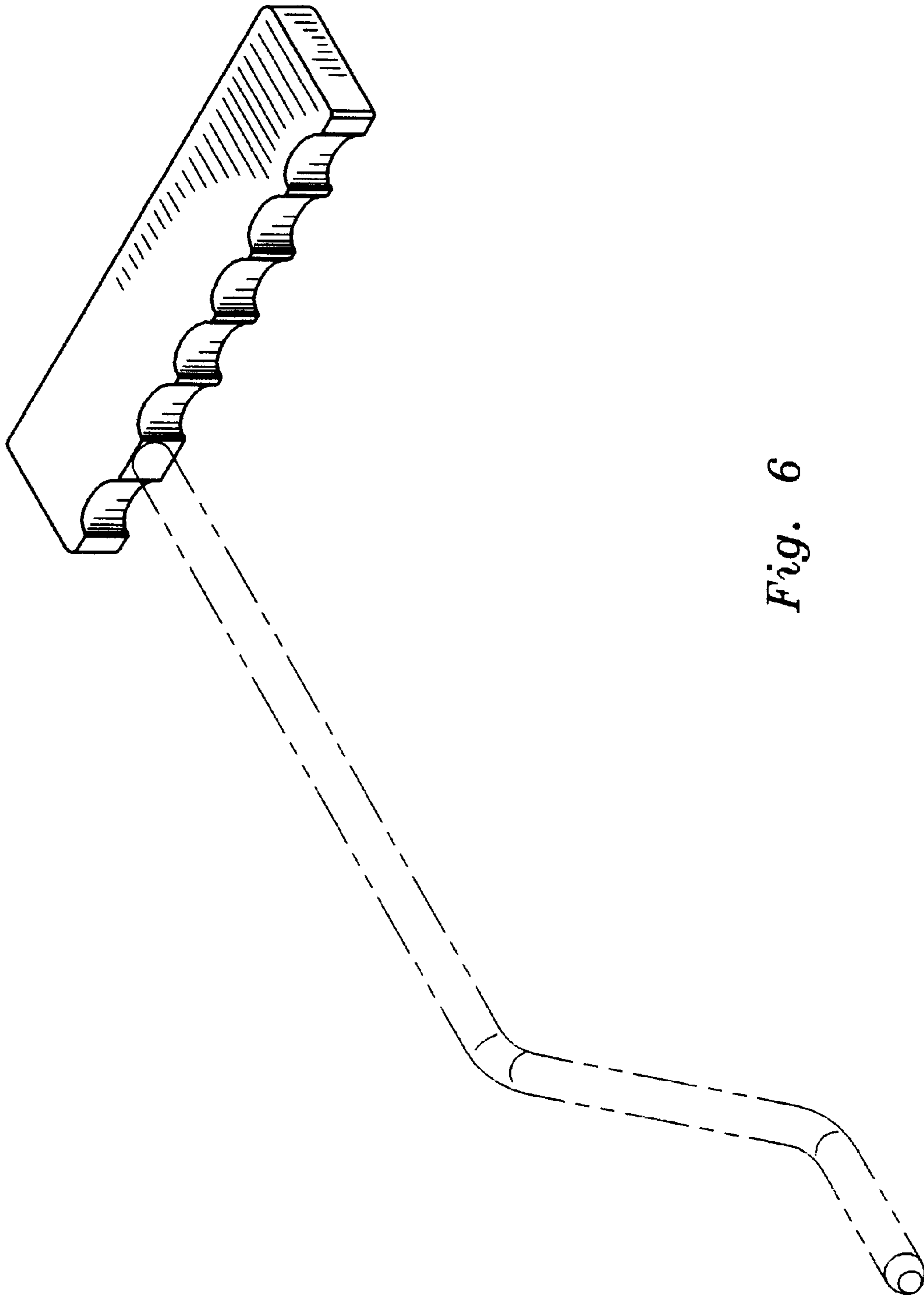

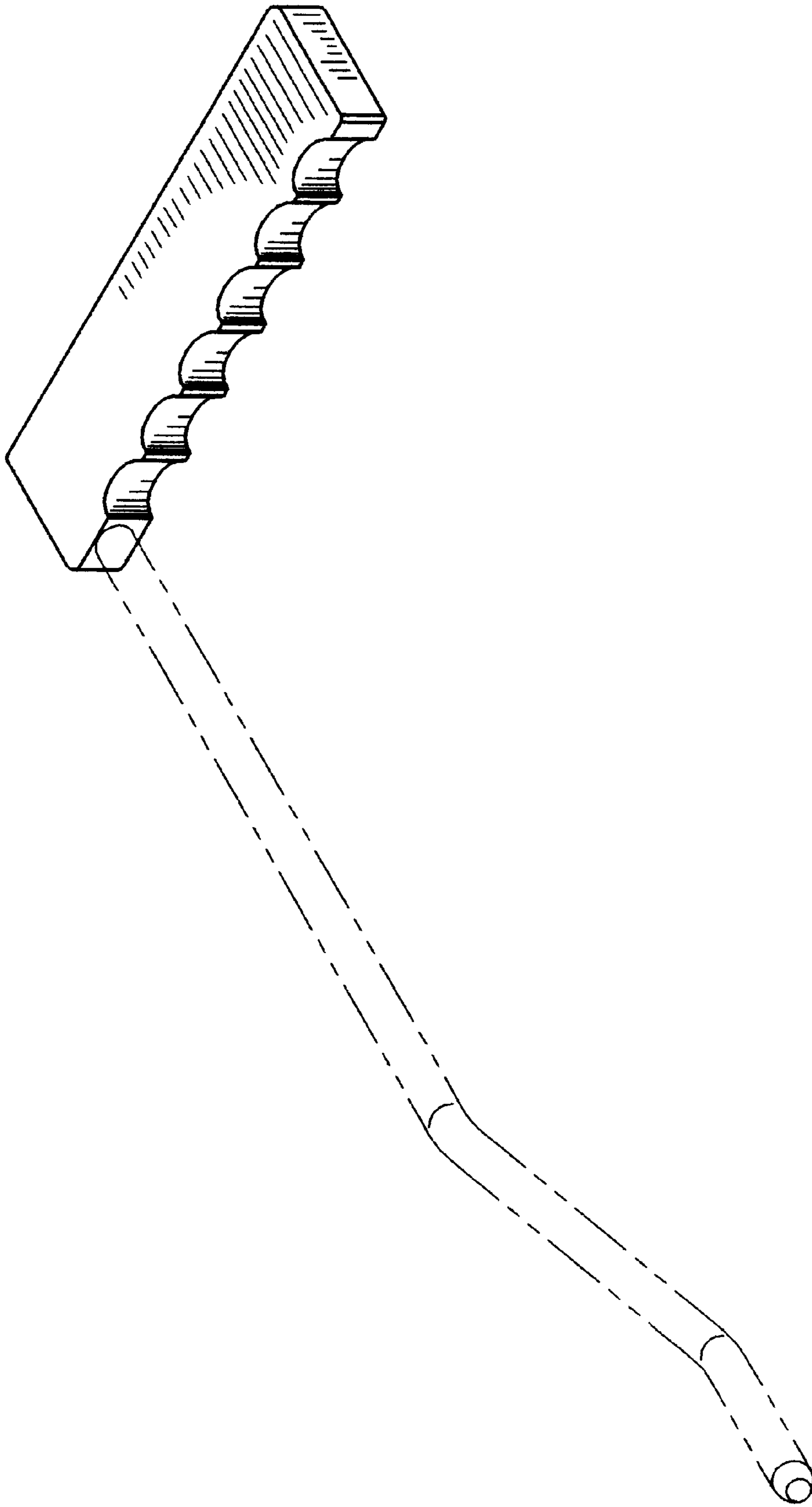
