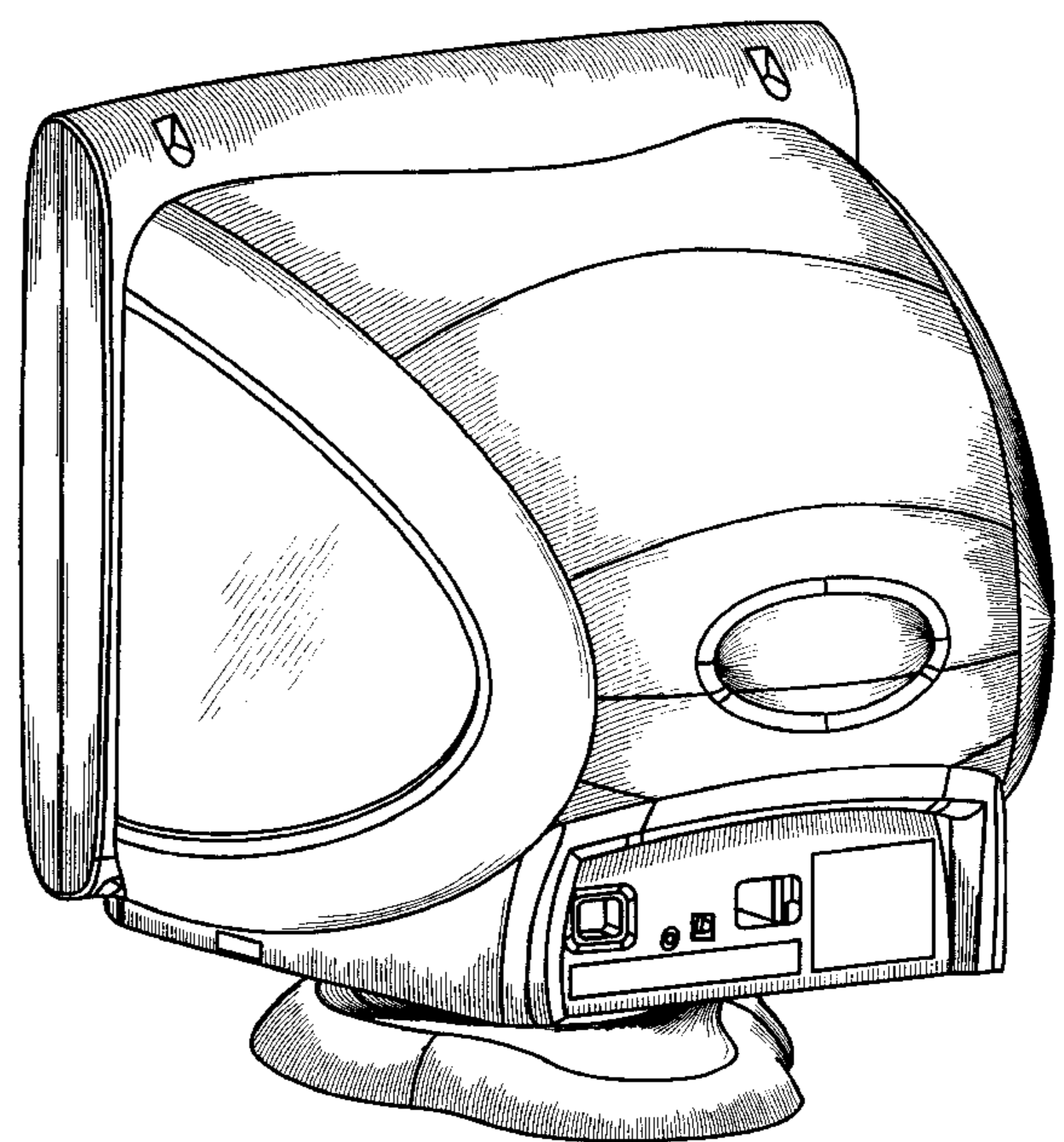
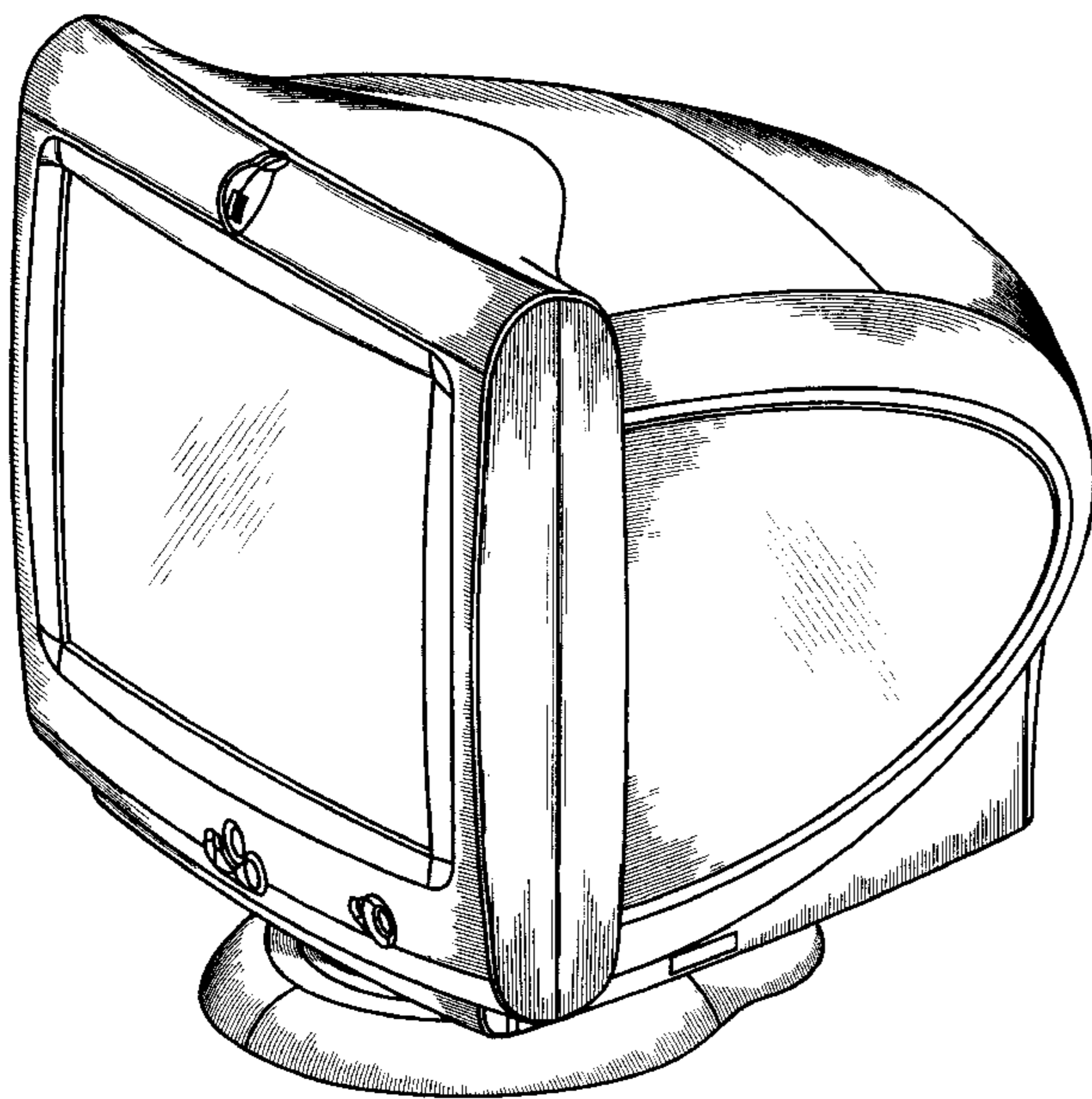
The ornamental design for a monitor, as shown and described.

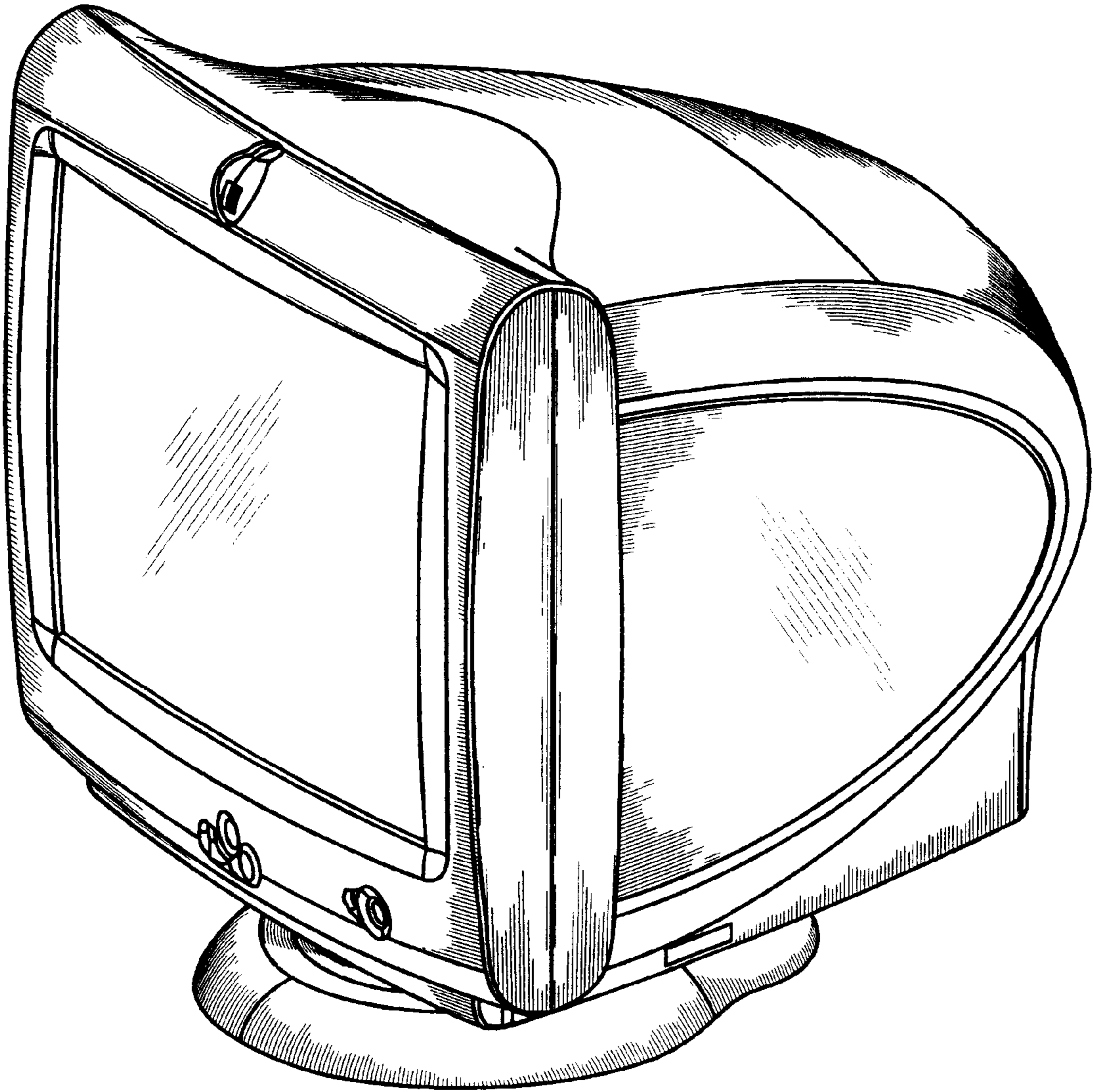
**DESCRIPTION**

 FIG. 8 is a bottom view thereof.

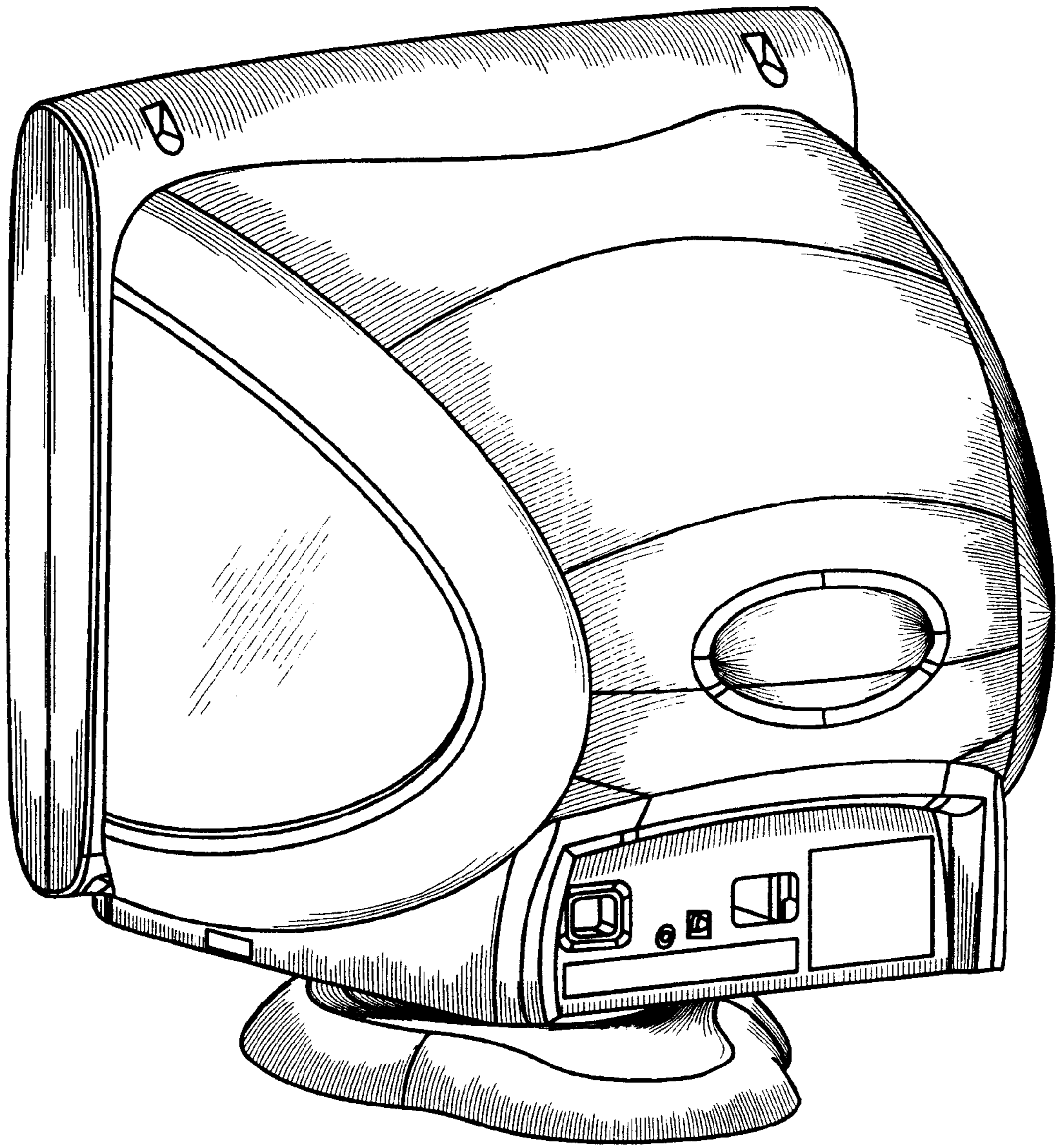
The broken line in FIG. 8 is for illustrative purposes and forms no part of the claimed design.

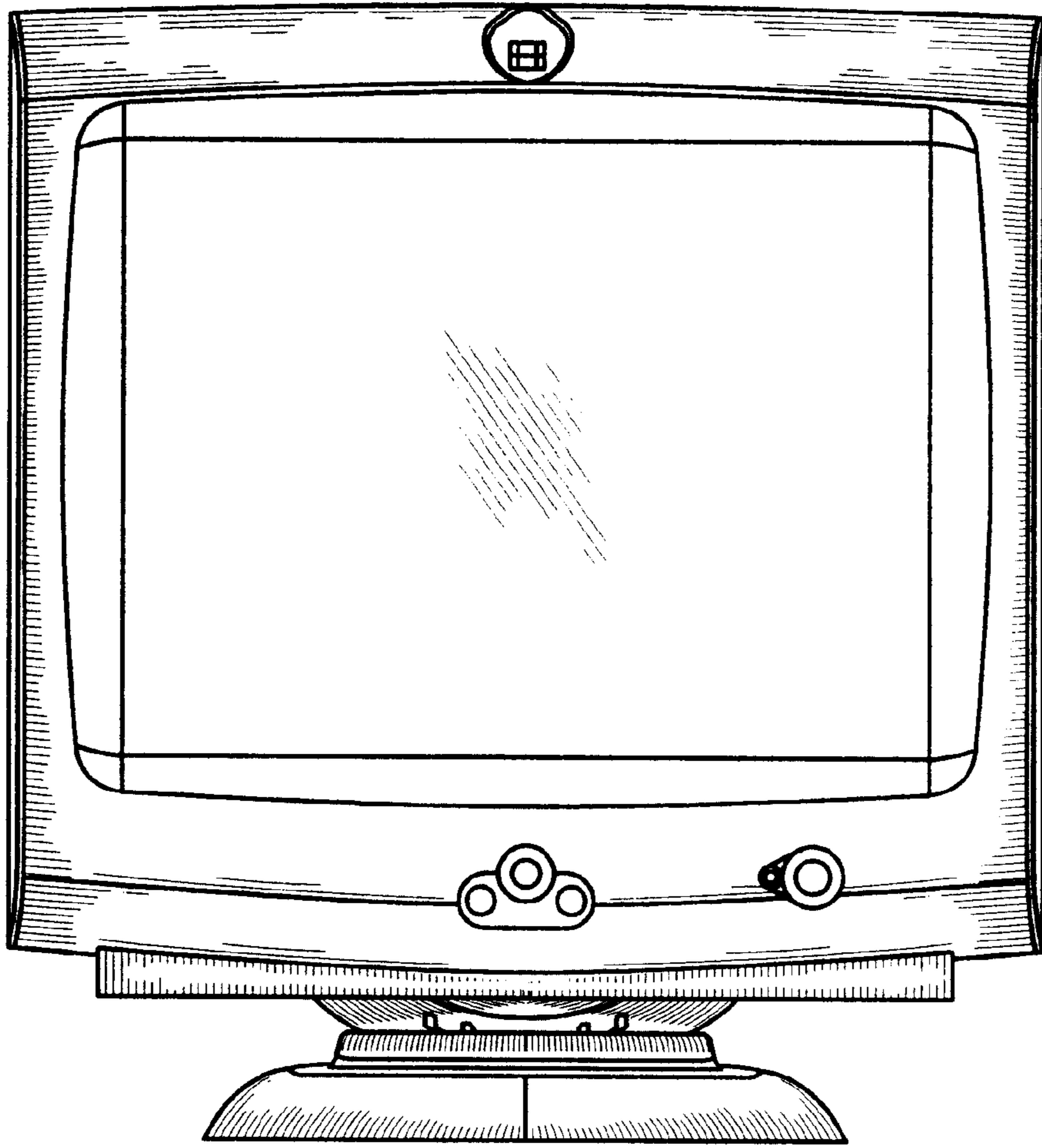




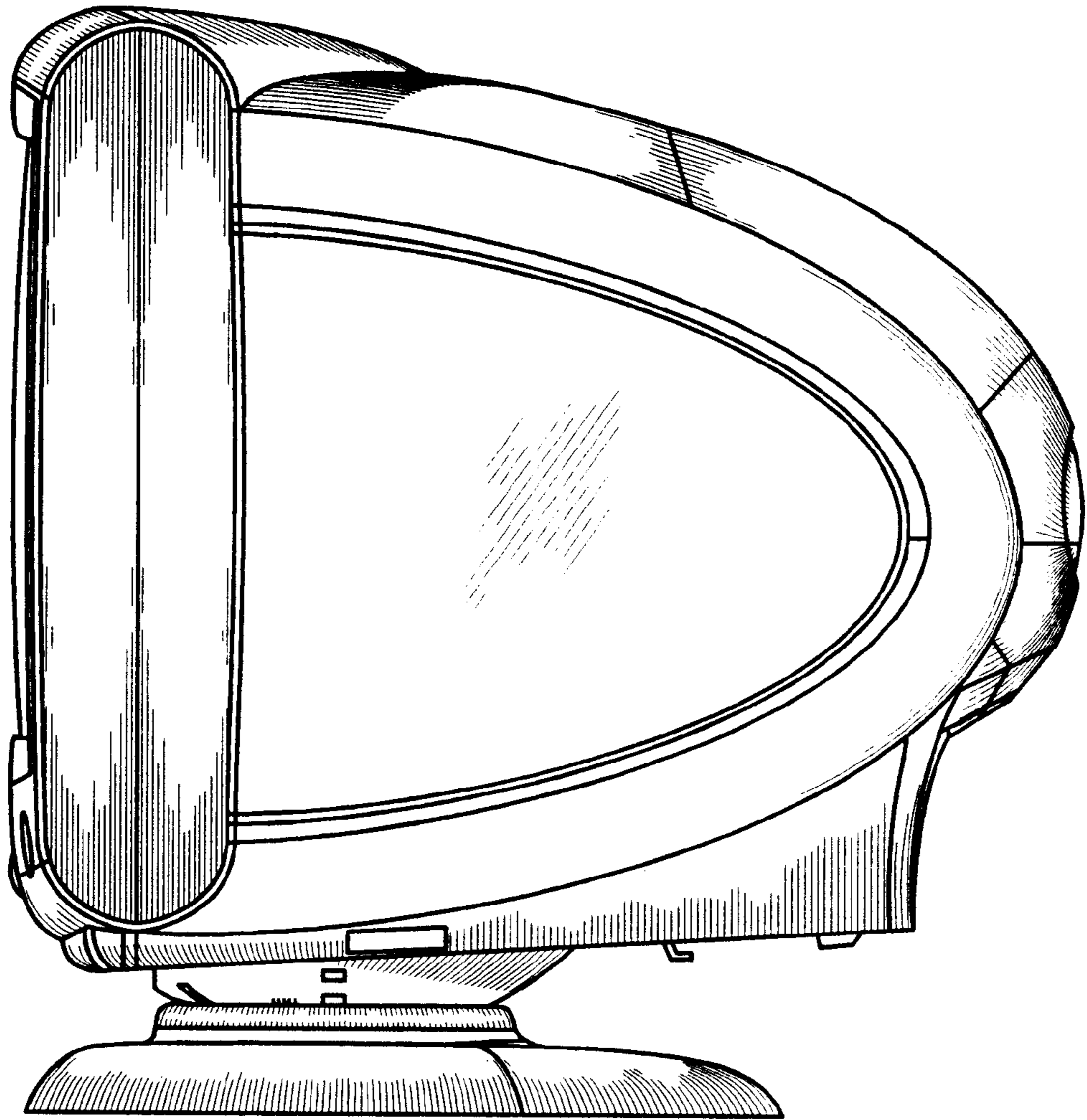

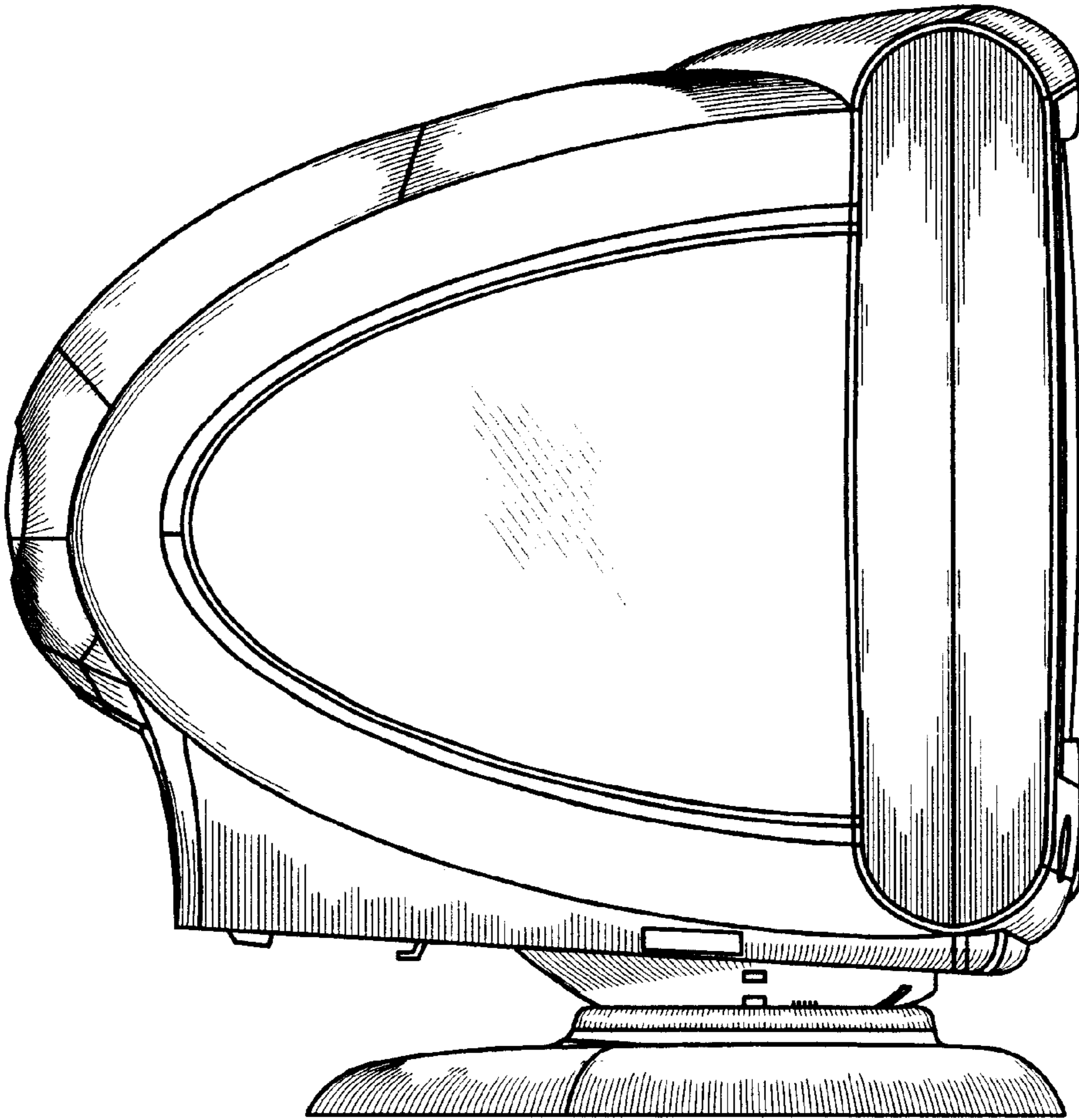

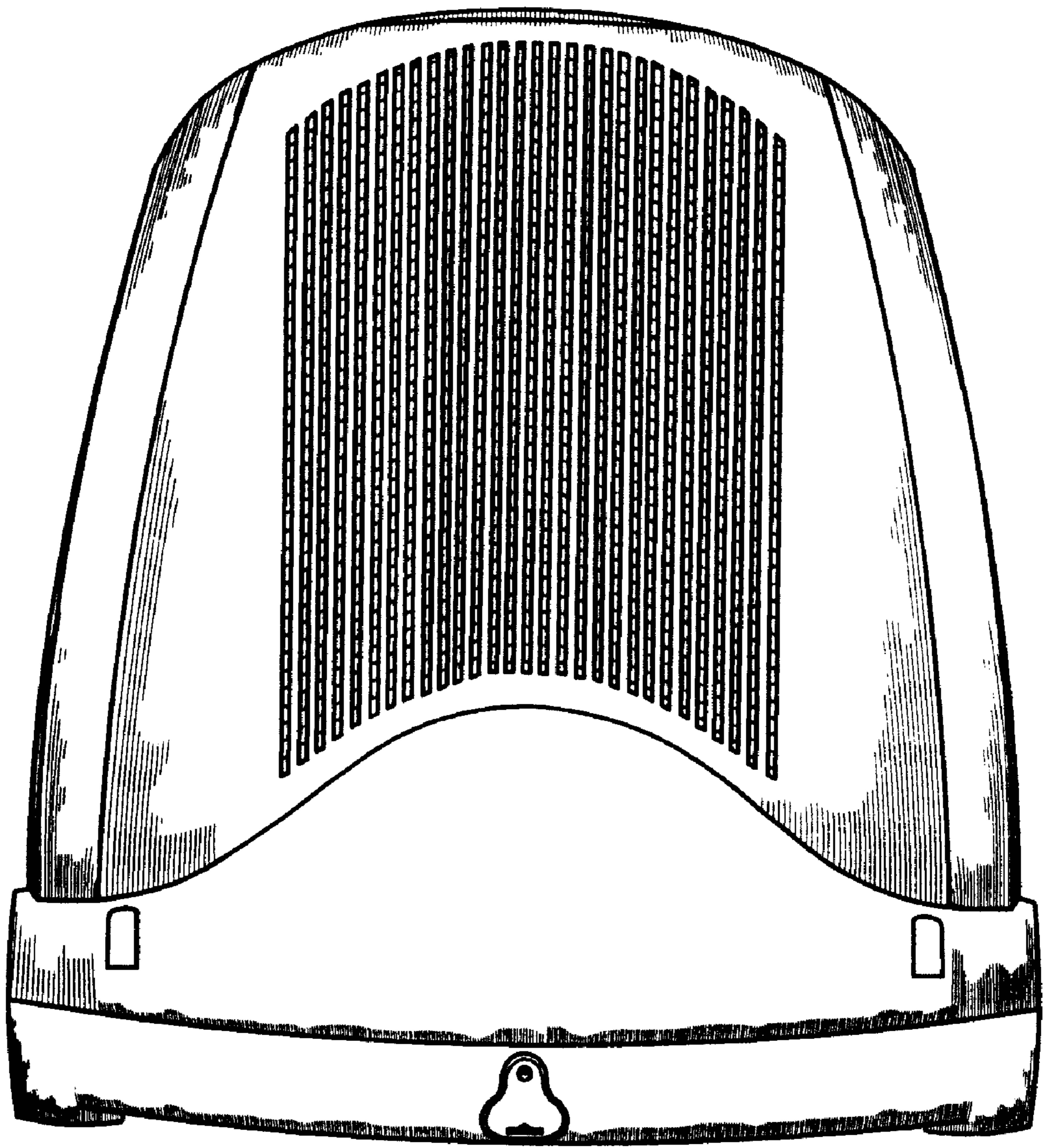

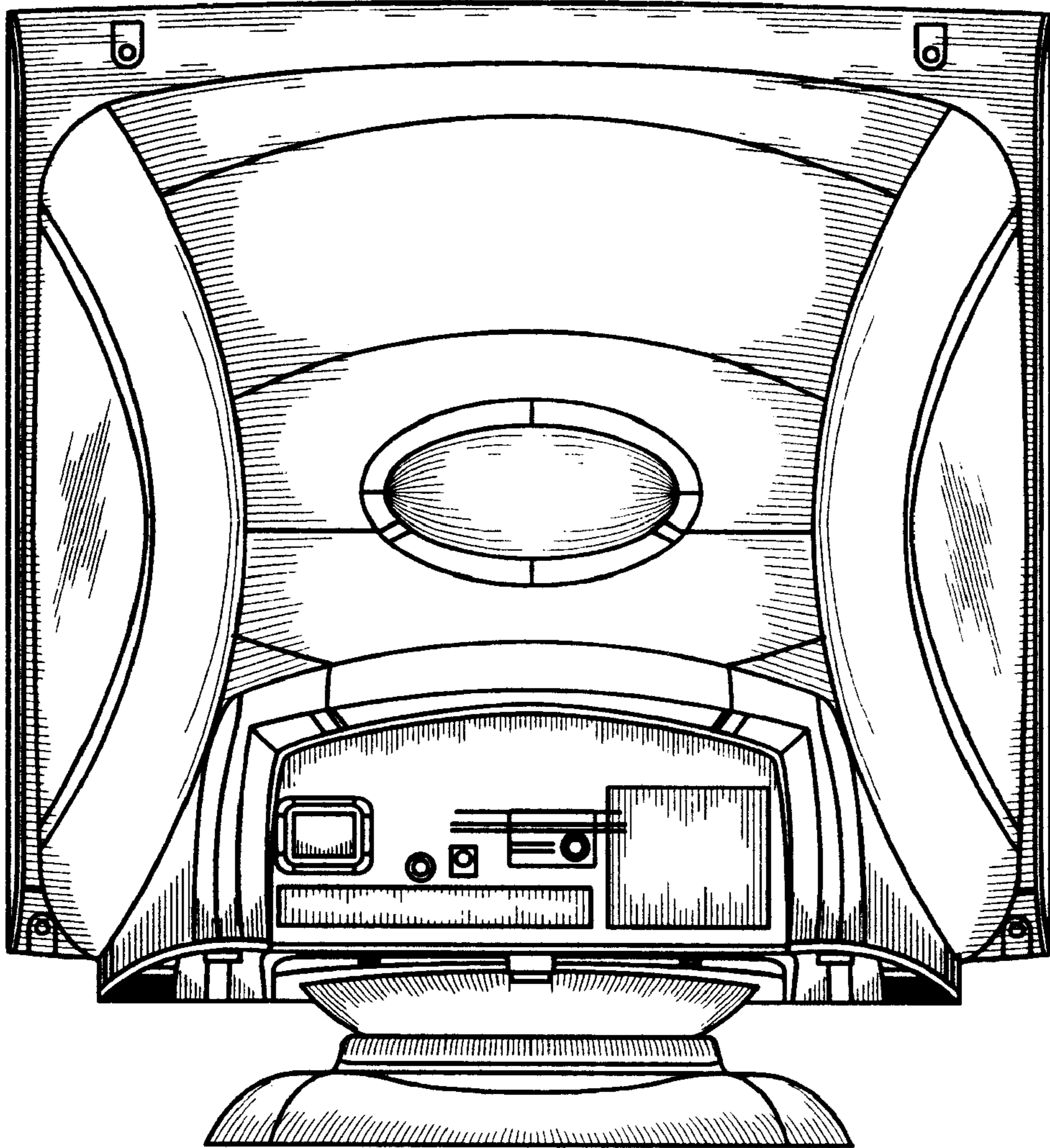

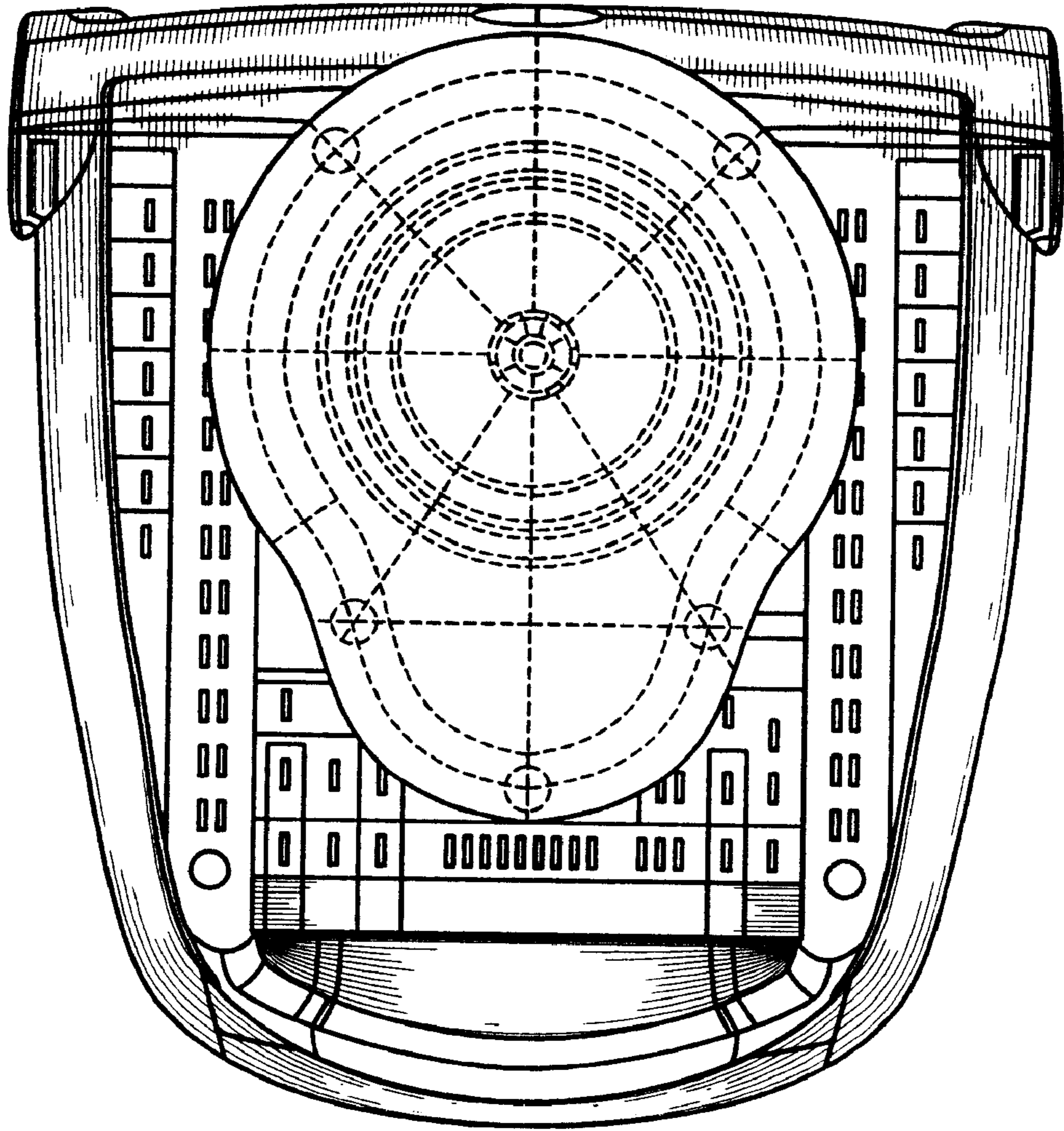
