The new and ornamental design for a safety guide, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a first embodiment of a safety guide showing my new design;

FIG. 2 is a top plan view of the safety guide of FIG. 1;

FIG. 3 is a bottom plan view of the safety guide of FIG. 1;

FIG. 4 is a left side elevation view of the safety guide of FIG. 1;

FIG. 5 is a right side elevation view of the safety guide of FIG. 1;

FIG. 6 is a front elevation view of the safety guide of FIG. 1;

FIG. 7 is a rear elevation view of the safety guide of FIG. 1;

FIG. 8 is a perspective view of a second embodiment of a safety guide showing my new design;

FIG. 10 is a bottom plan view of the safety guide of FIG. 8;

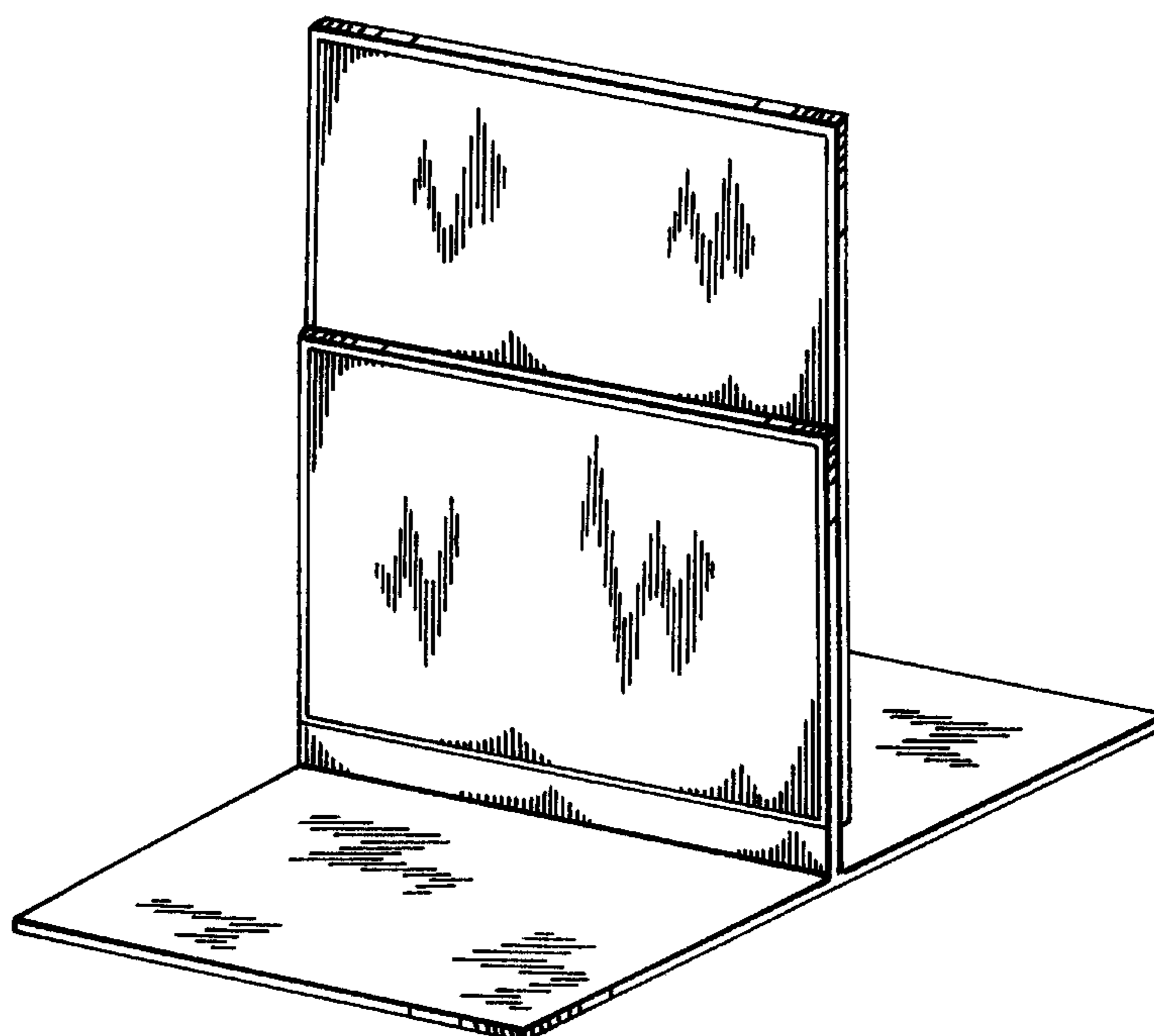
FIG. 11 is a left side elevation view of the safety guide of FIG. 8;

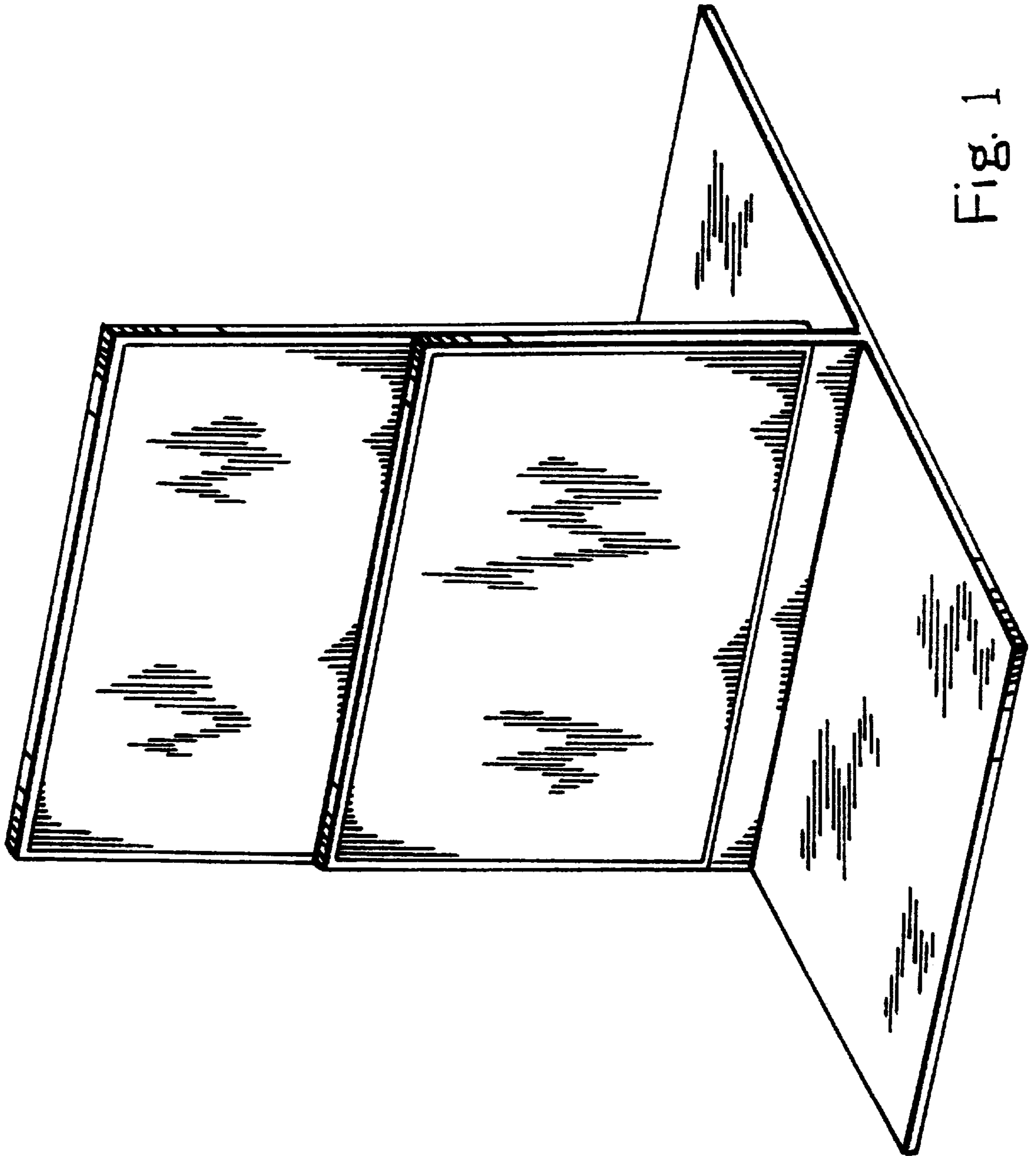

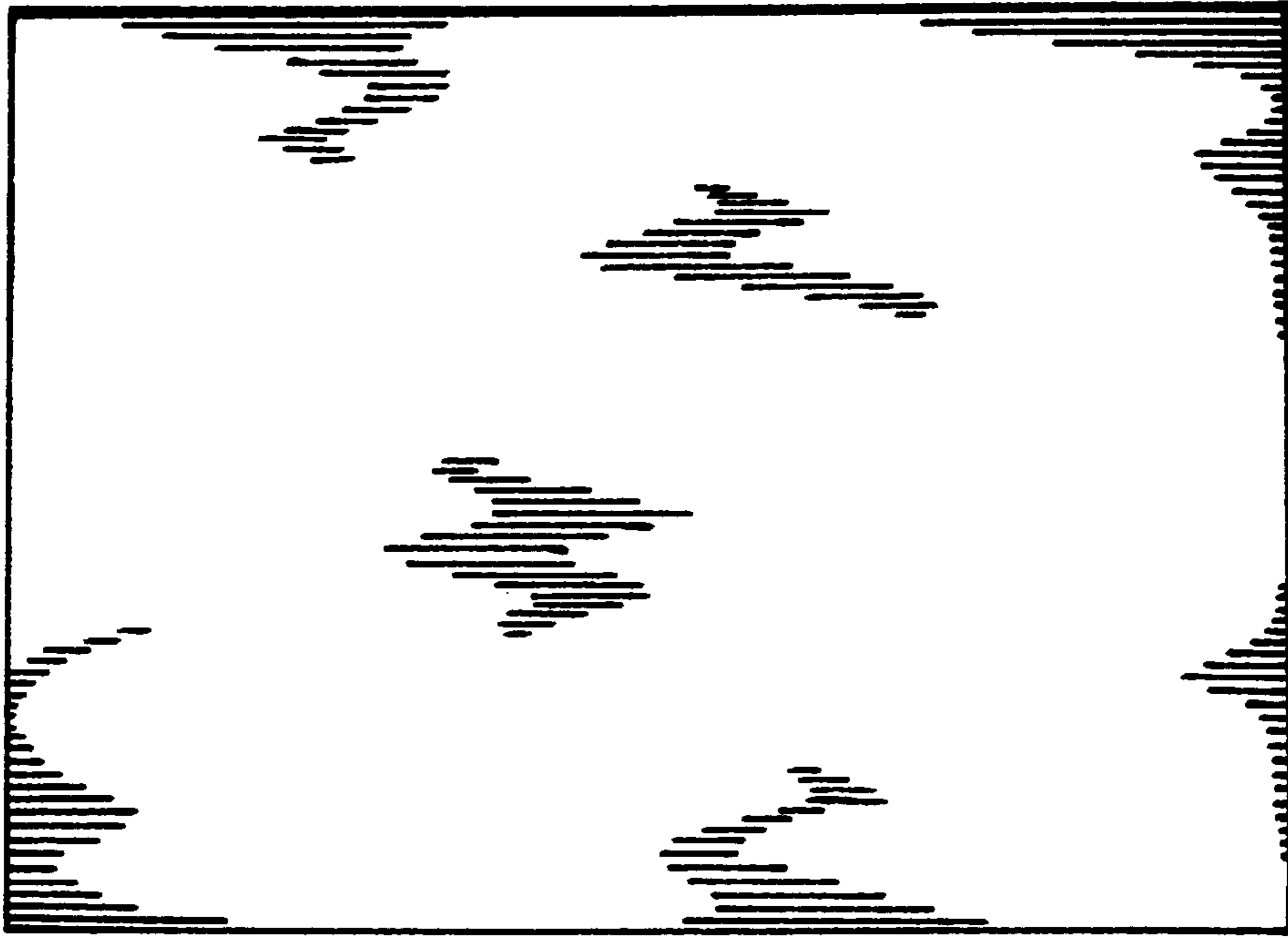

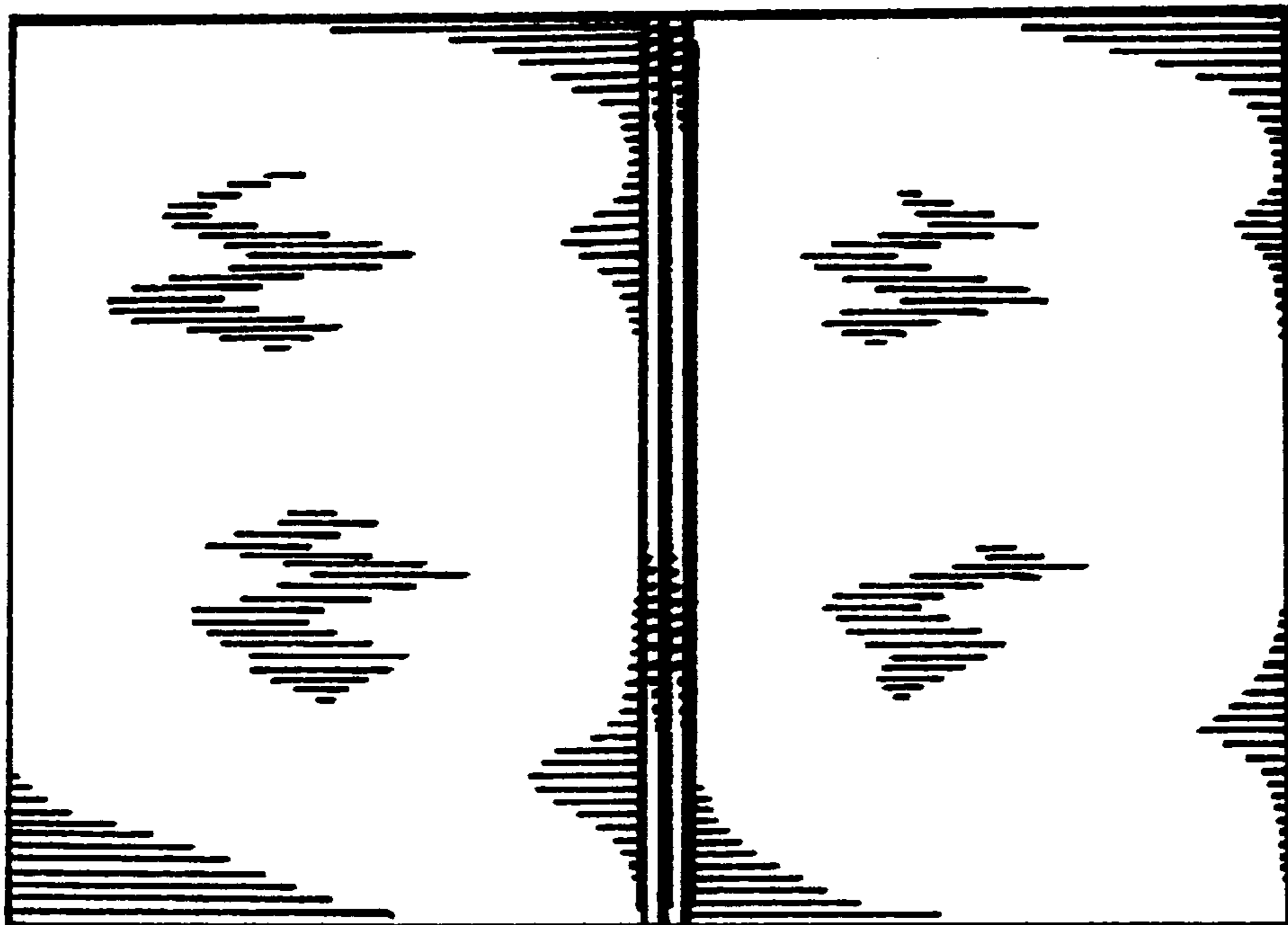

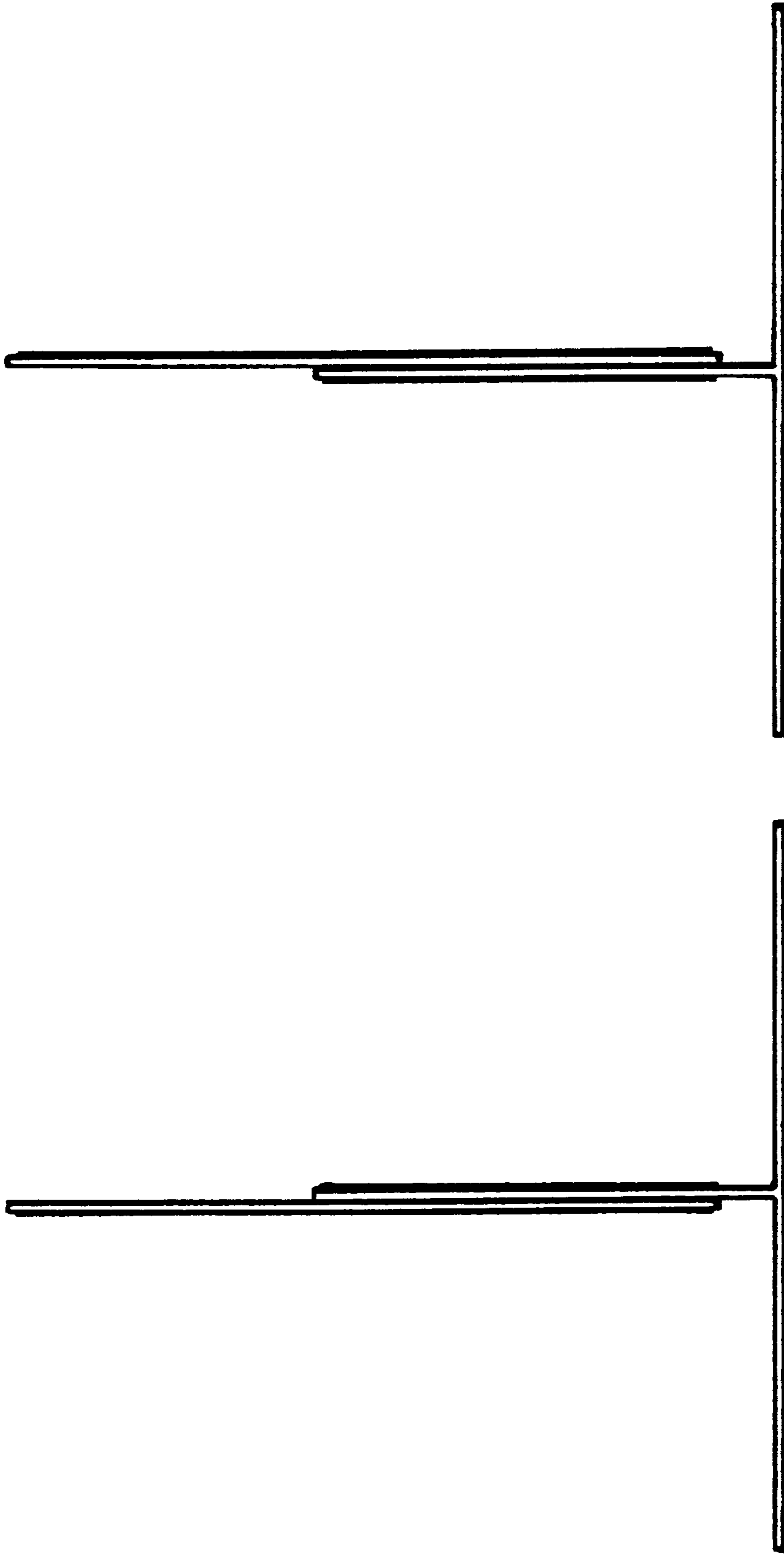

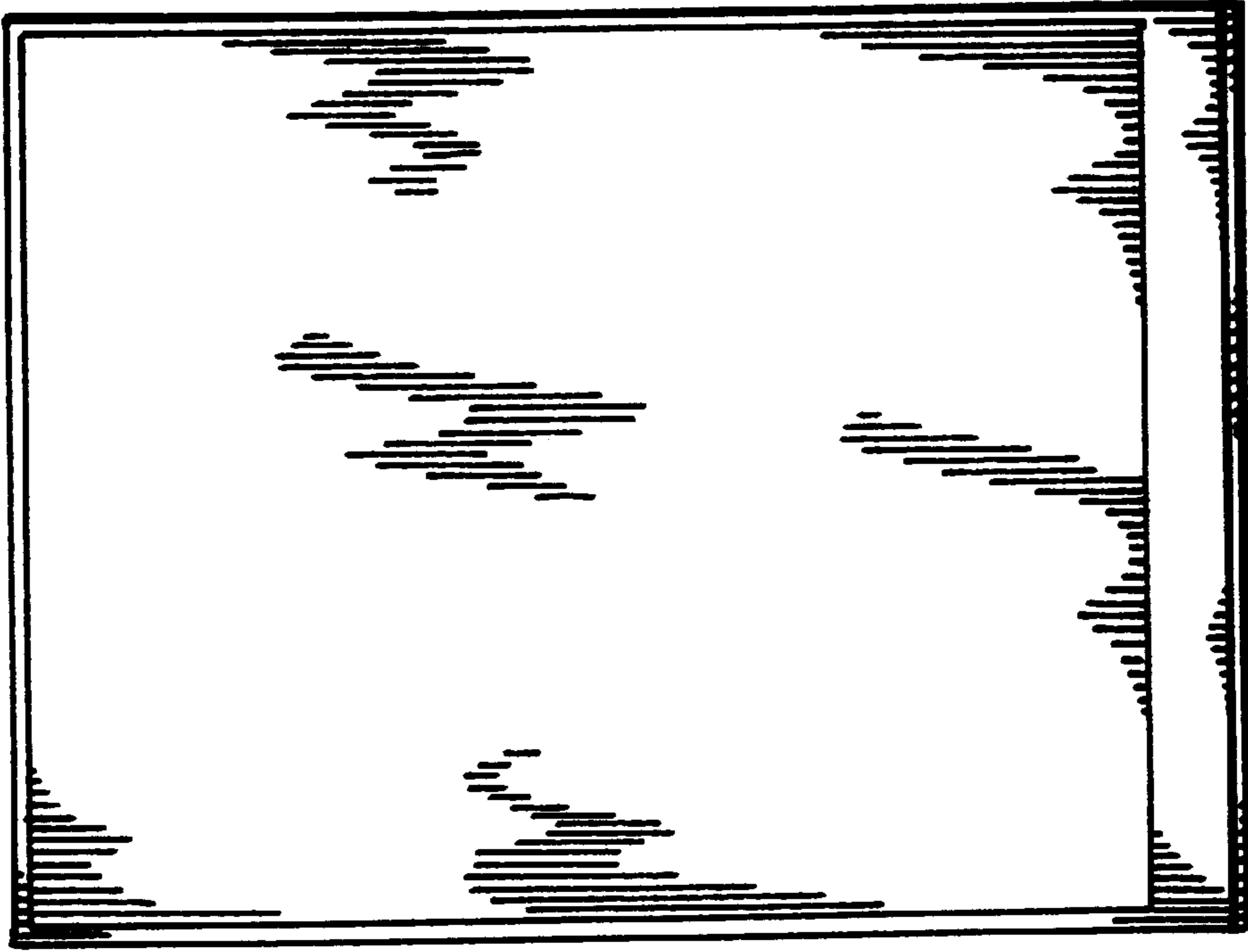

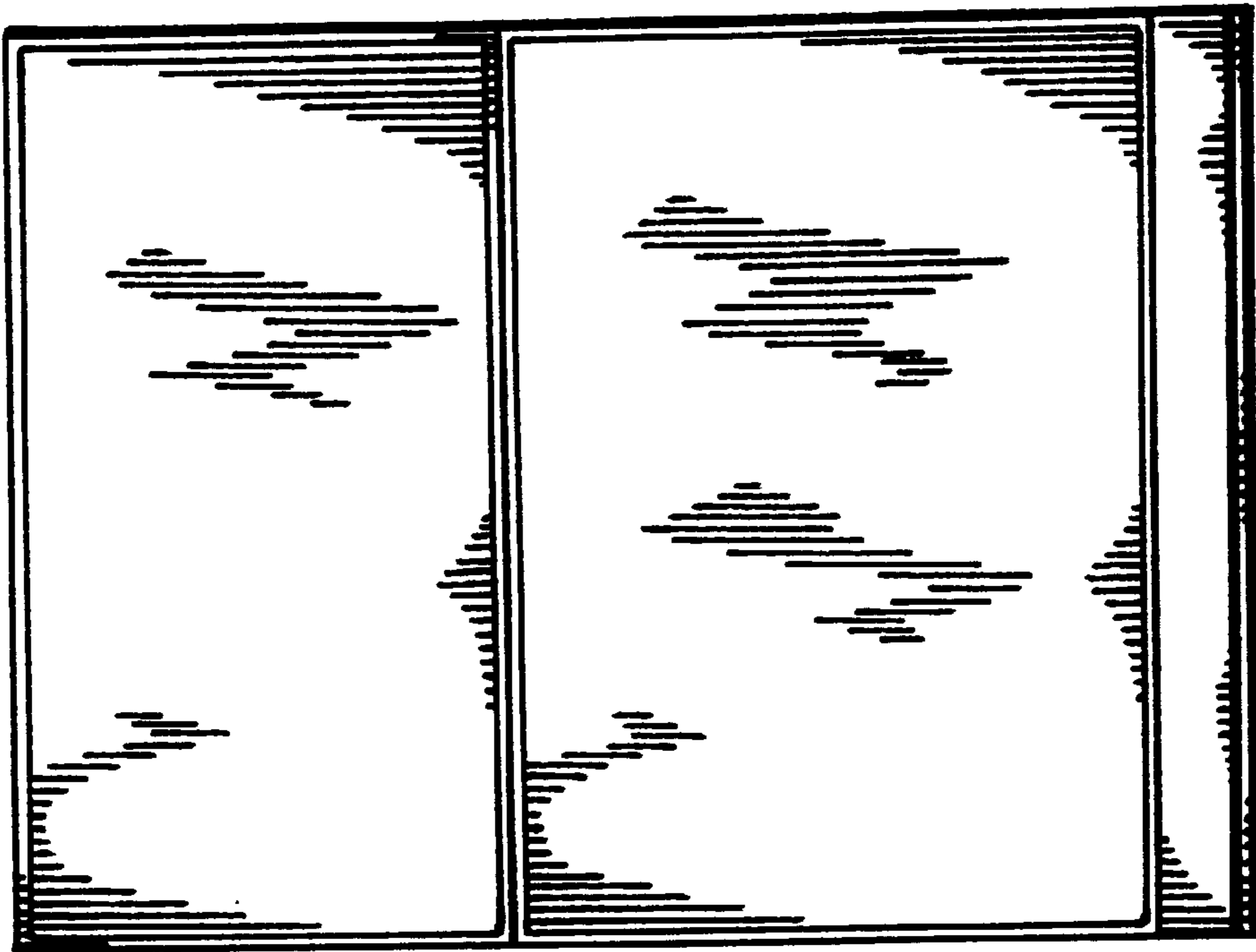

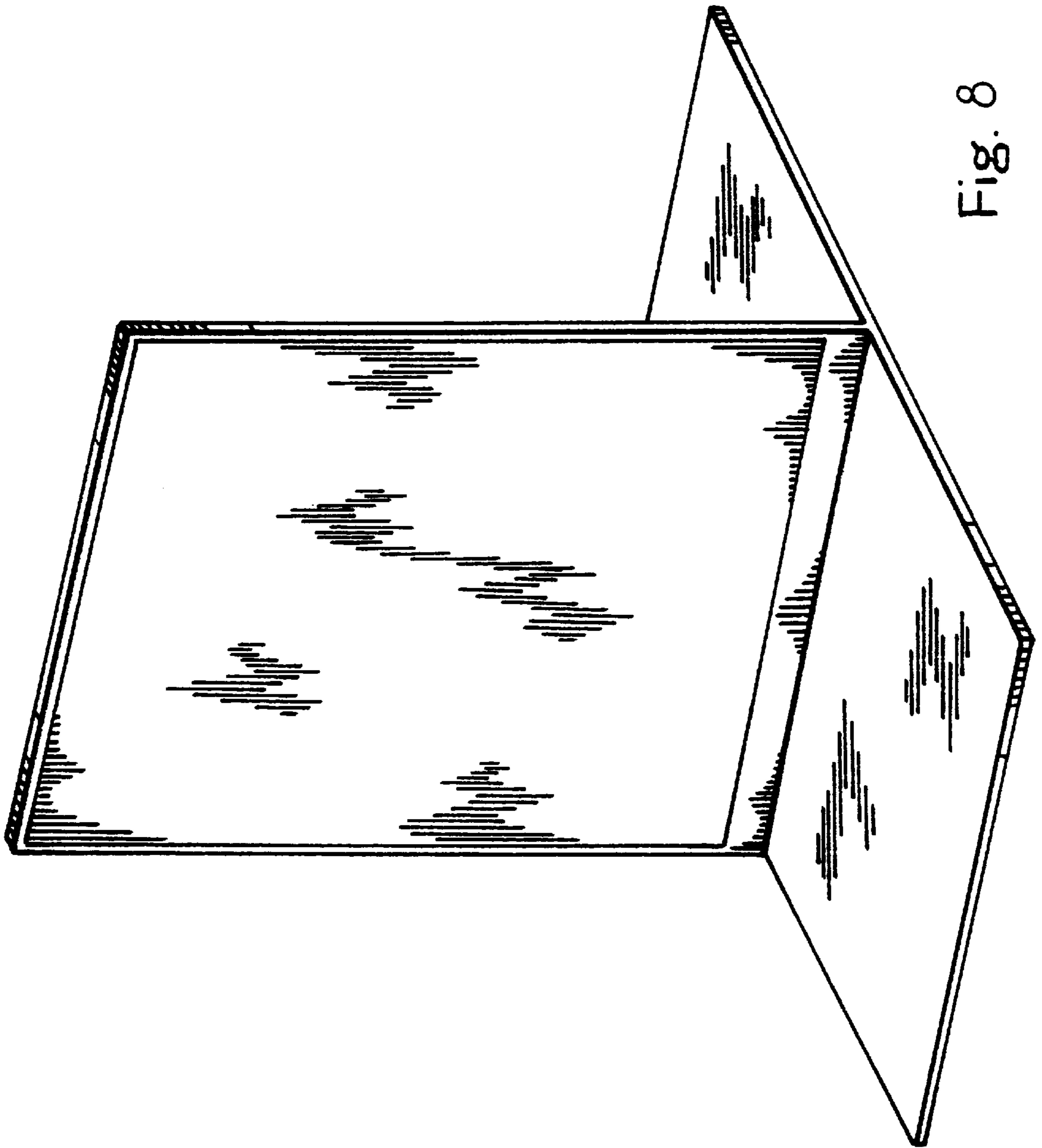

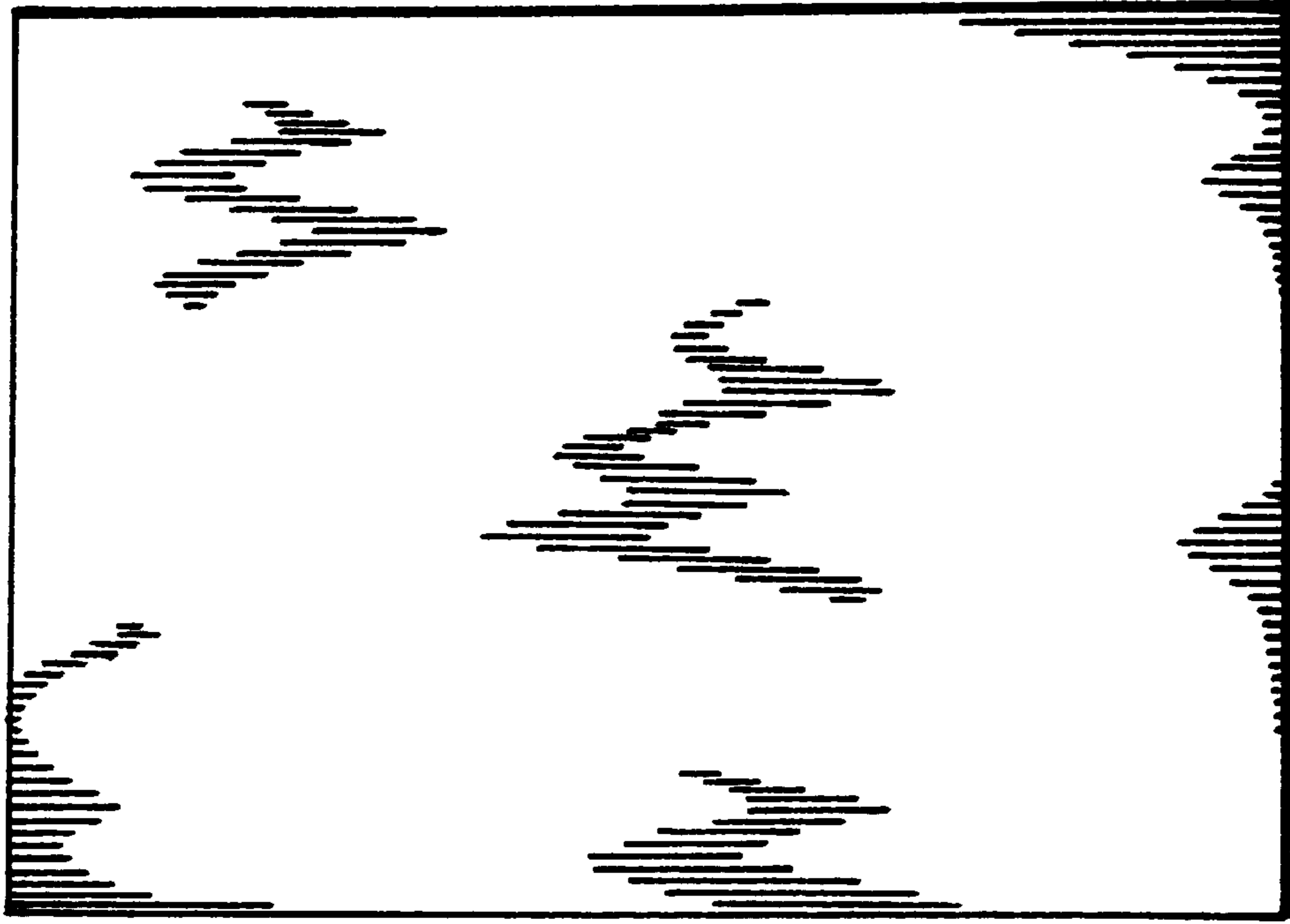

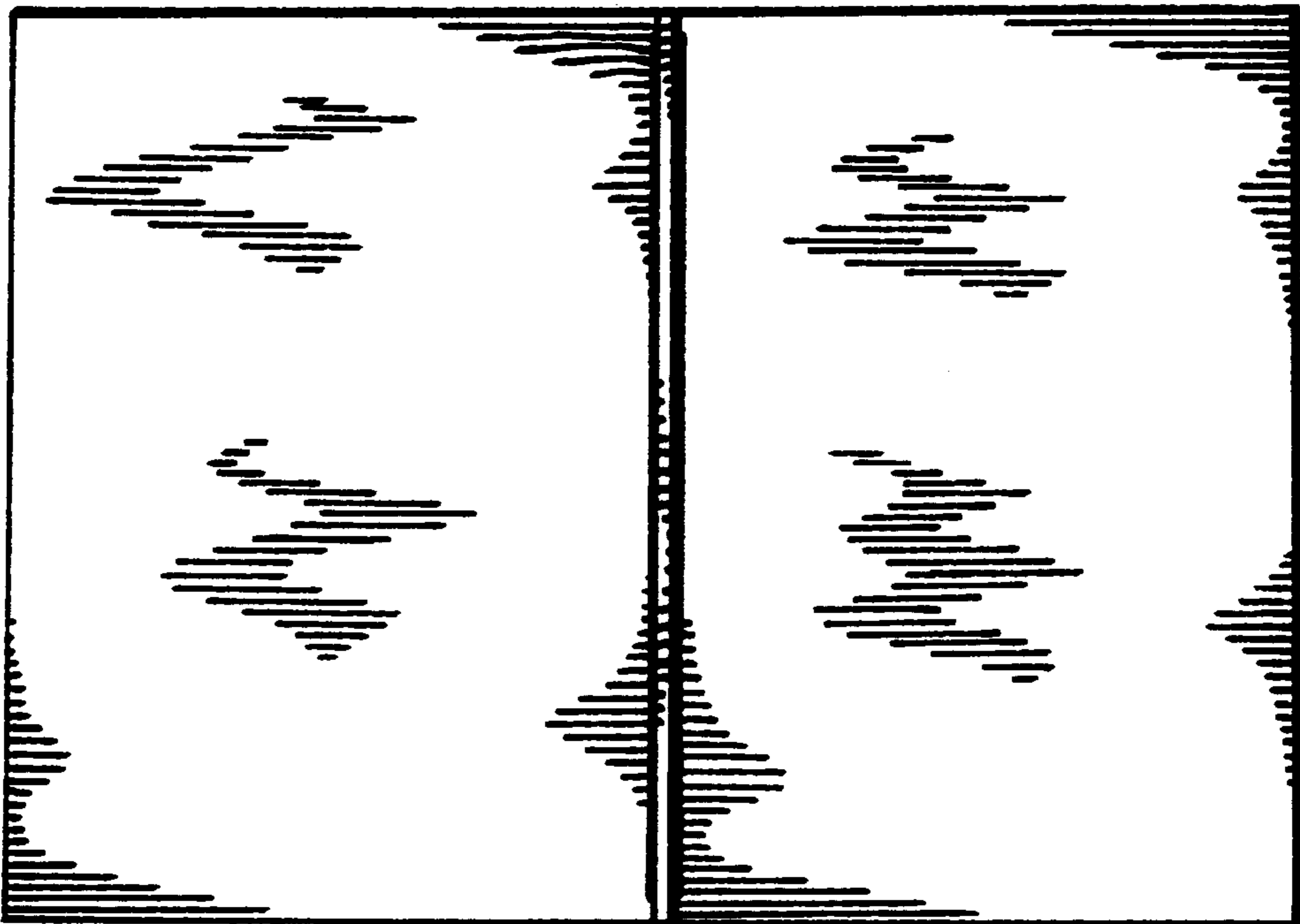

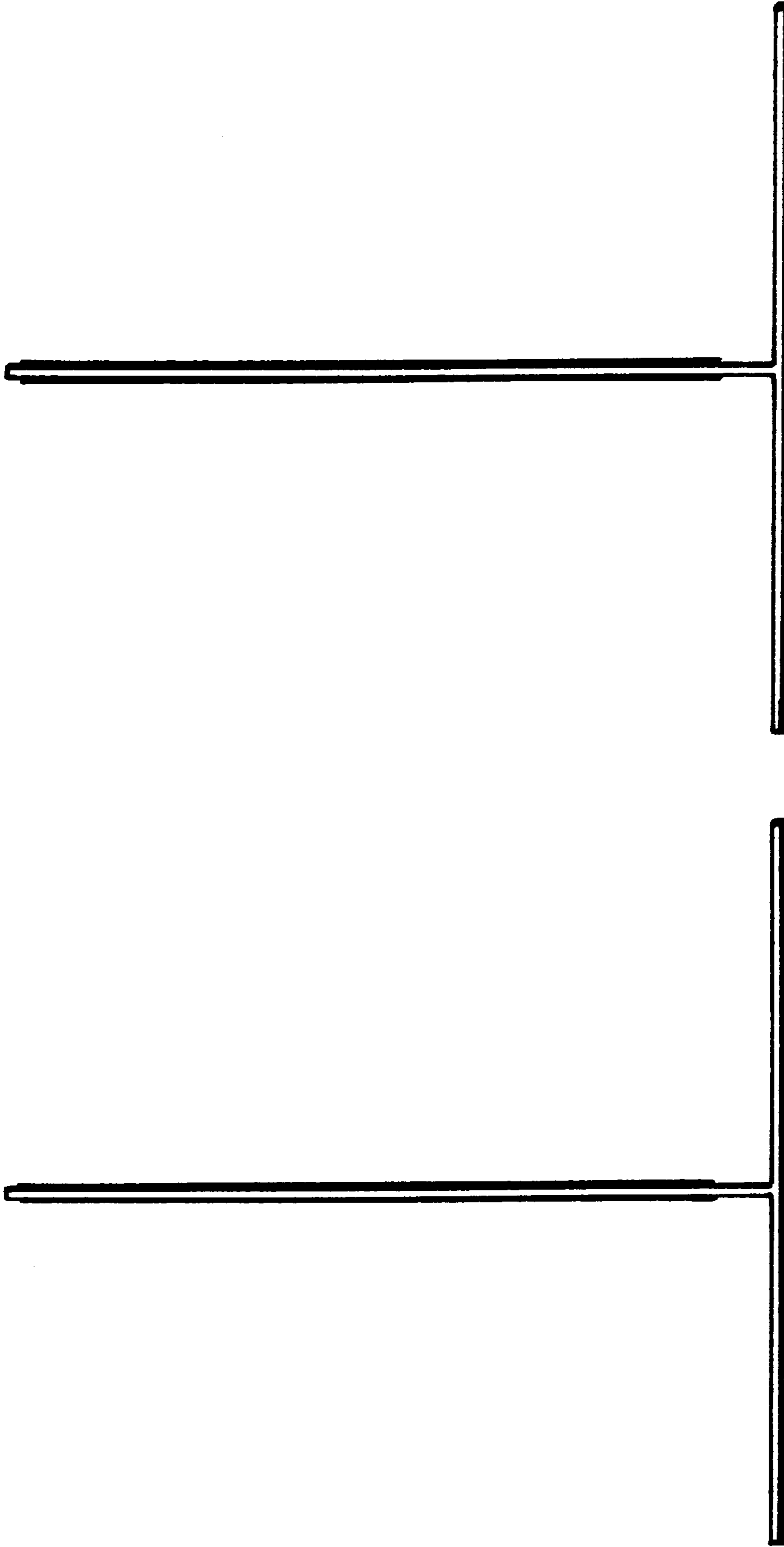

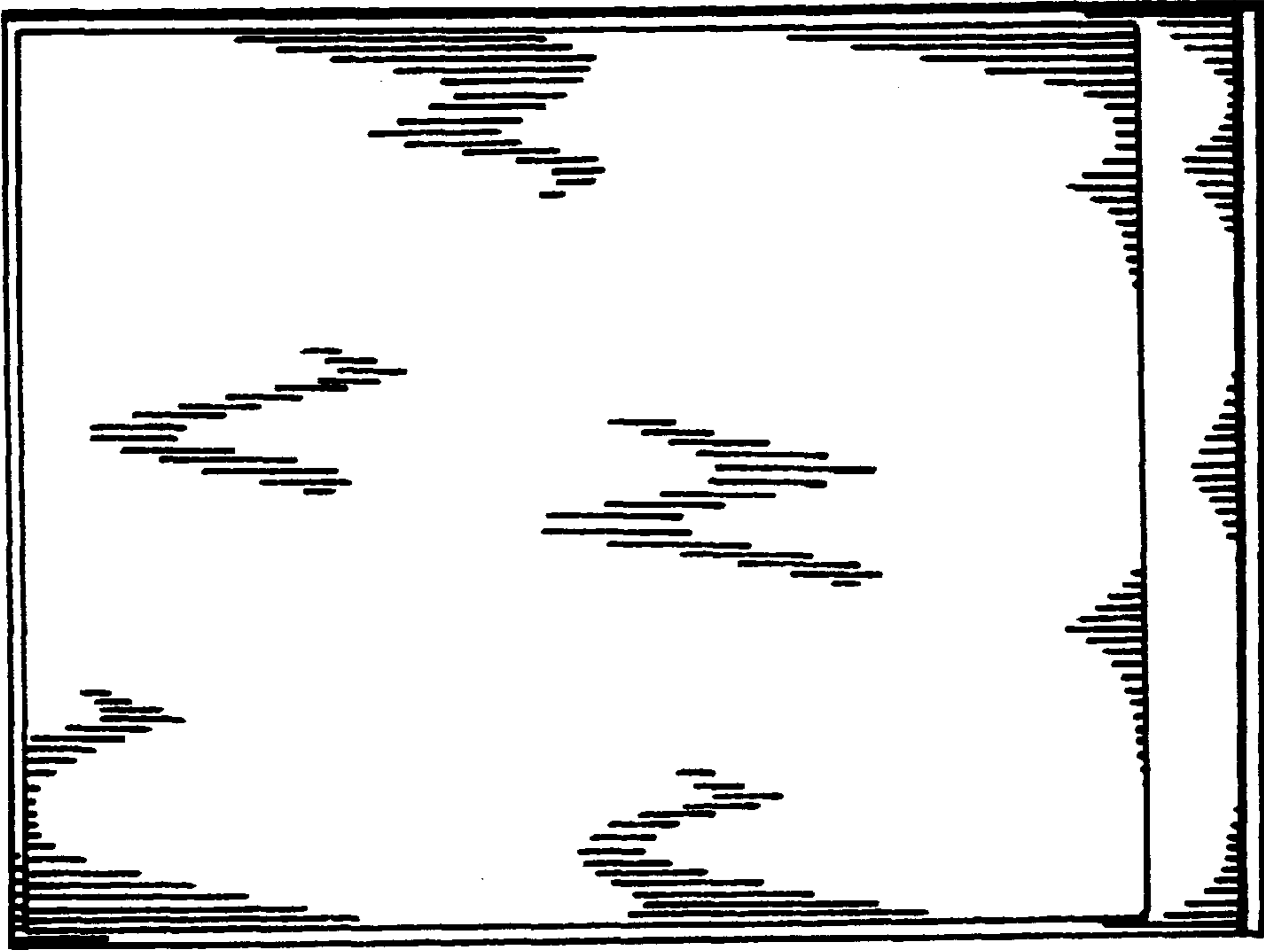

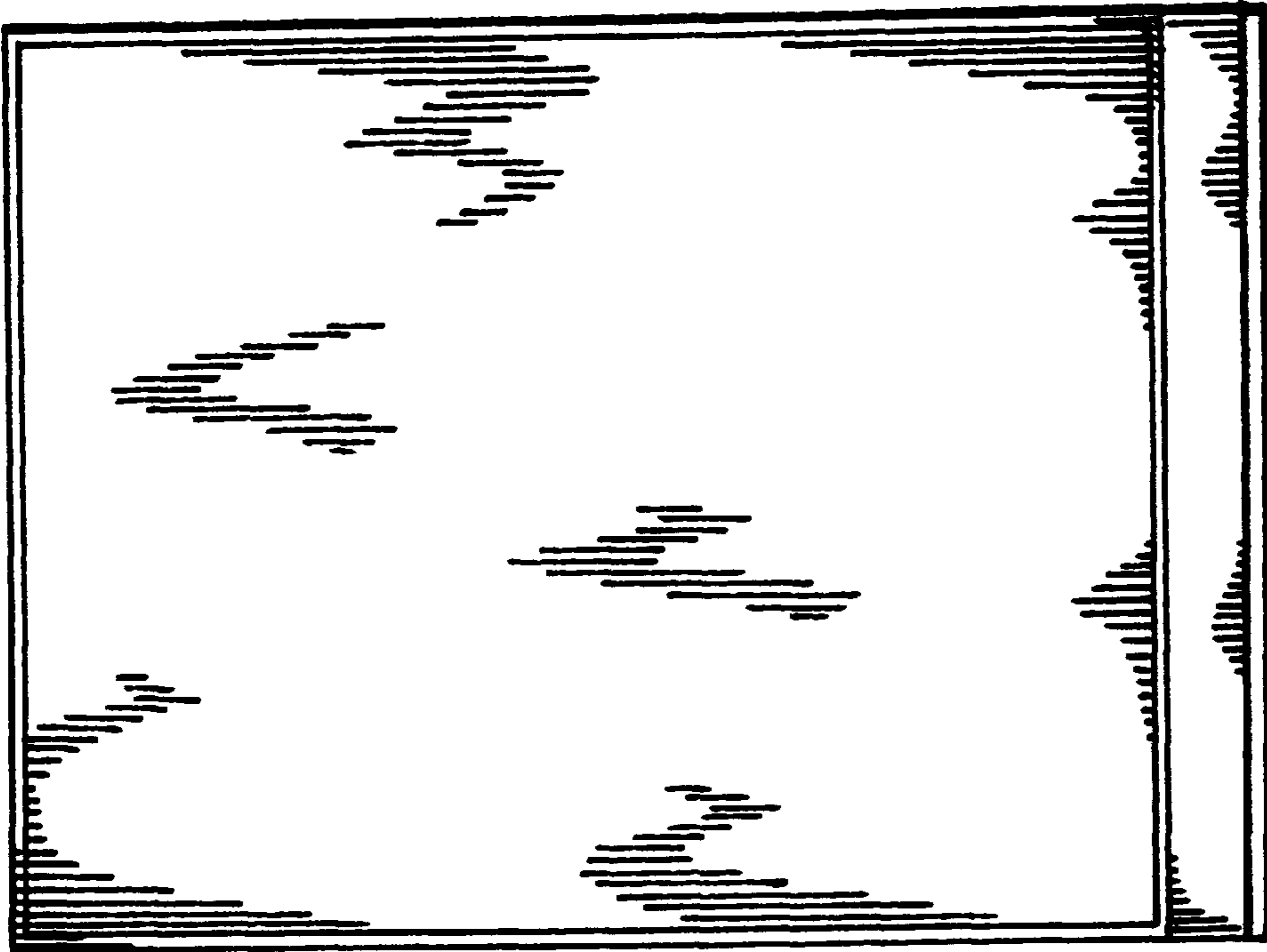
