(57) **CLAIM**

The ornamental design for a label for a computer diskette and a CD-ROM, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a first embodiment of an index print label showing my new design.

FIG. 2 is a front elevational view of a portion of the index print label of FIG. 1 disposed on a front side of a computer diskette.

FIG. 3 is a front elevational view of a portion of the index print label of FIG. 1 disposed on a rear side of a computer diskette.

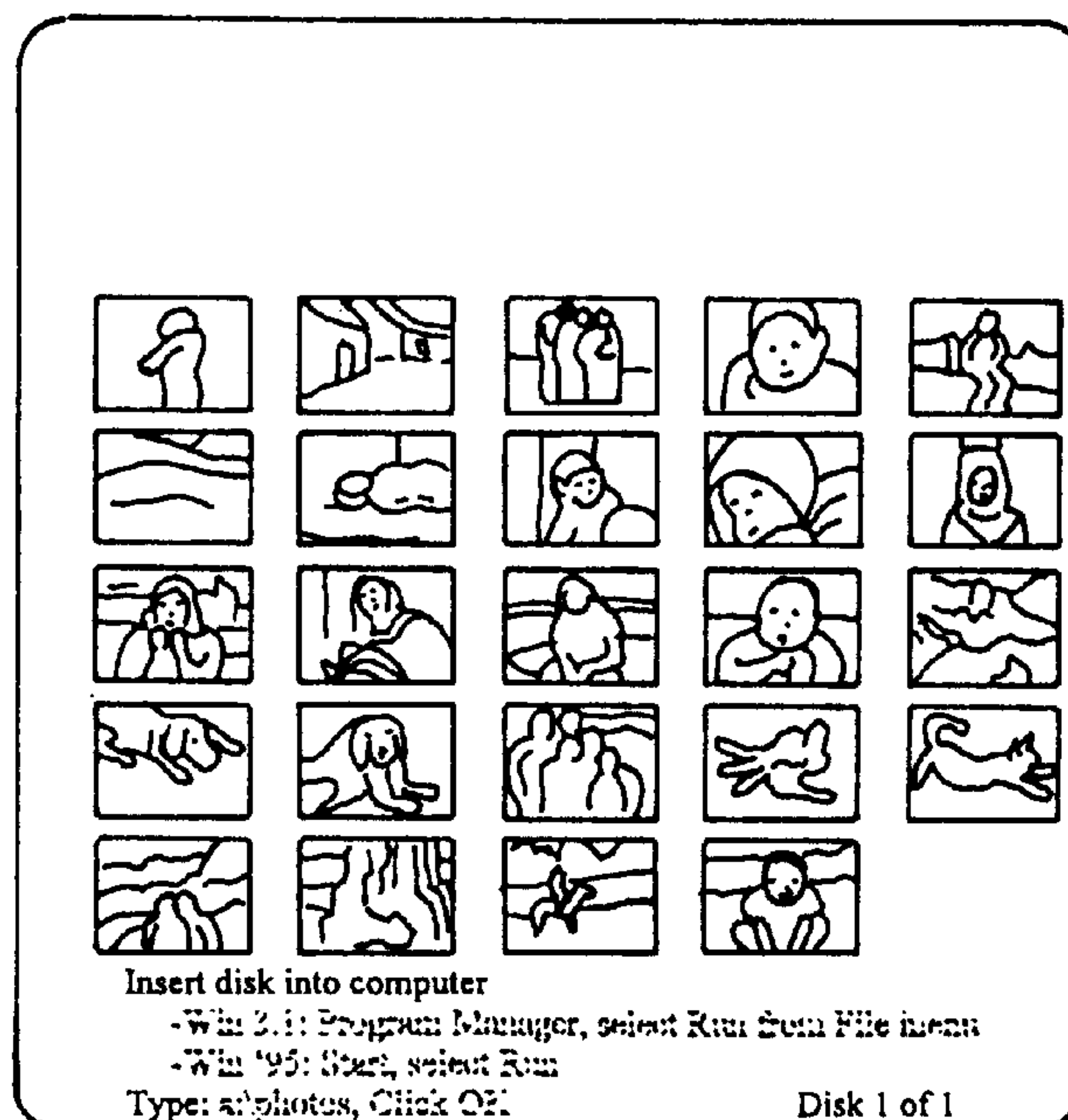
FIG. 4 is a front elevational view of a second embodiment of an index print label disposed on a CD-ROM showing my new design; and,

FIG. 5 is a side view of the index print label of FIG. 4.

The broken lines and broken text are shown for illustrative purposes only and form no part of the claimed design. The unbroken text forms part of the claimed design.

In particular, the text shown in broken lines in FIG. 1 serves only to illustrate, and forms no part of the claimed design. The text and diskette in FIGS. 2 and 3 represented in broken lines serves only to illustrate, and forms no part of the claimed design. The text and CD-ROM shown in broken lines in FIG. 4 serves only to illustrate, and forms no part of the claimed design. The CD-ROM shown in broken lines in FIG. 5 serves only to illustrate, and forms no part of the claimed design.

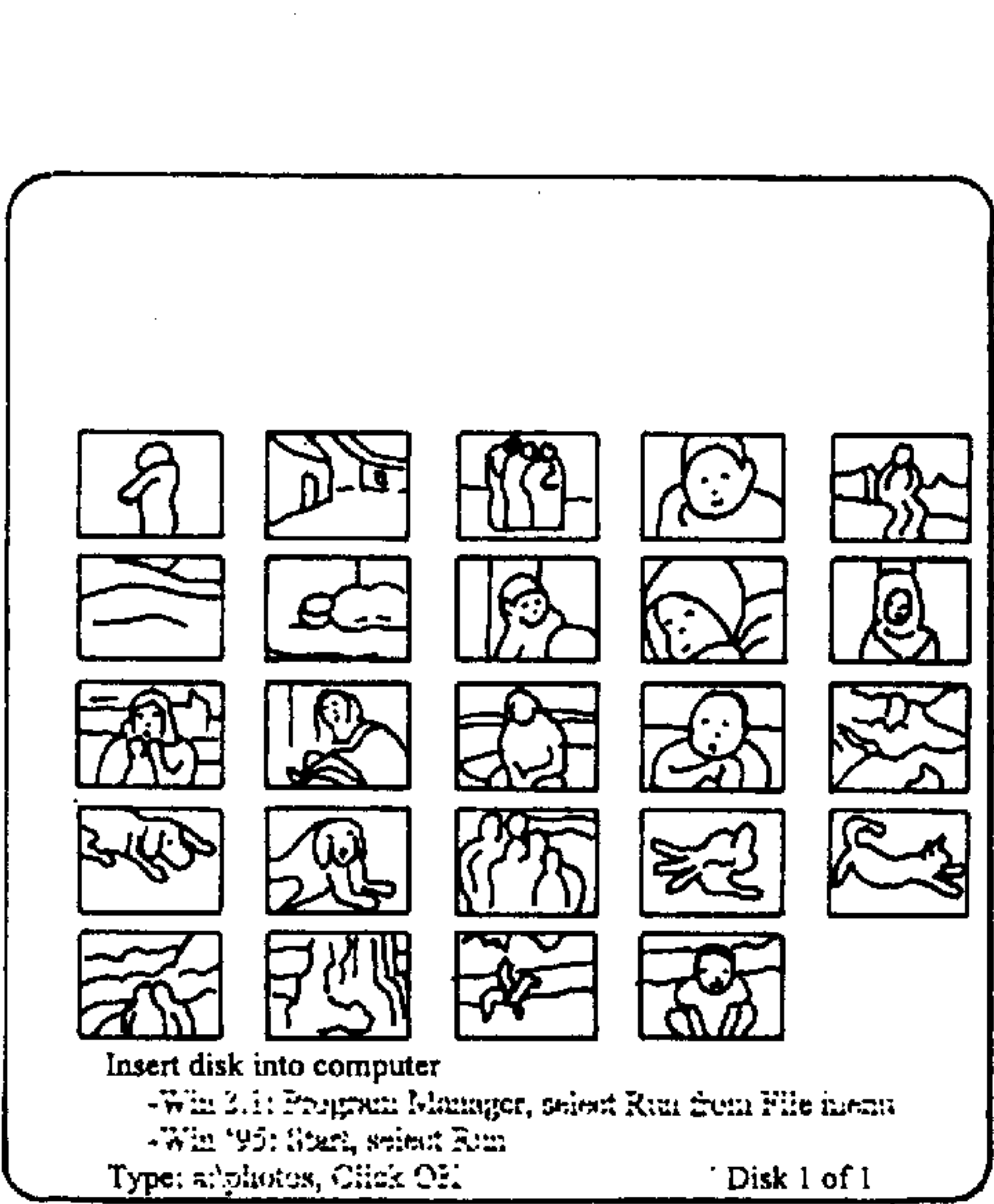

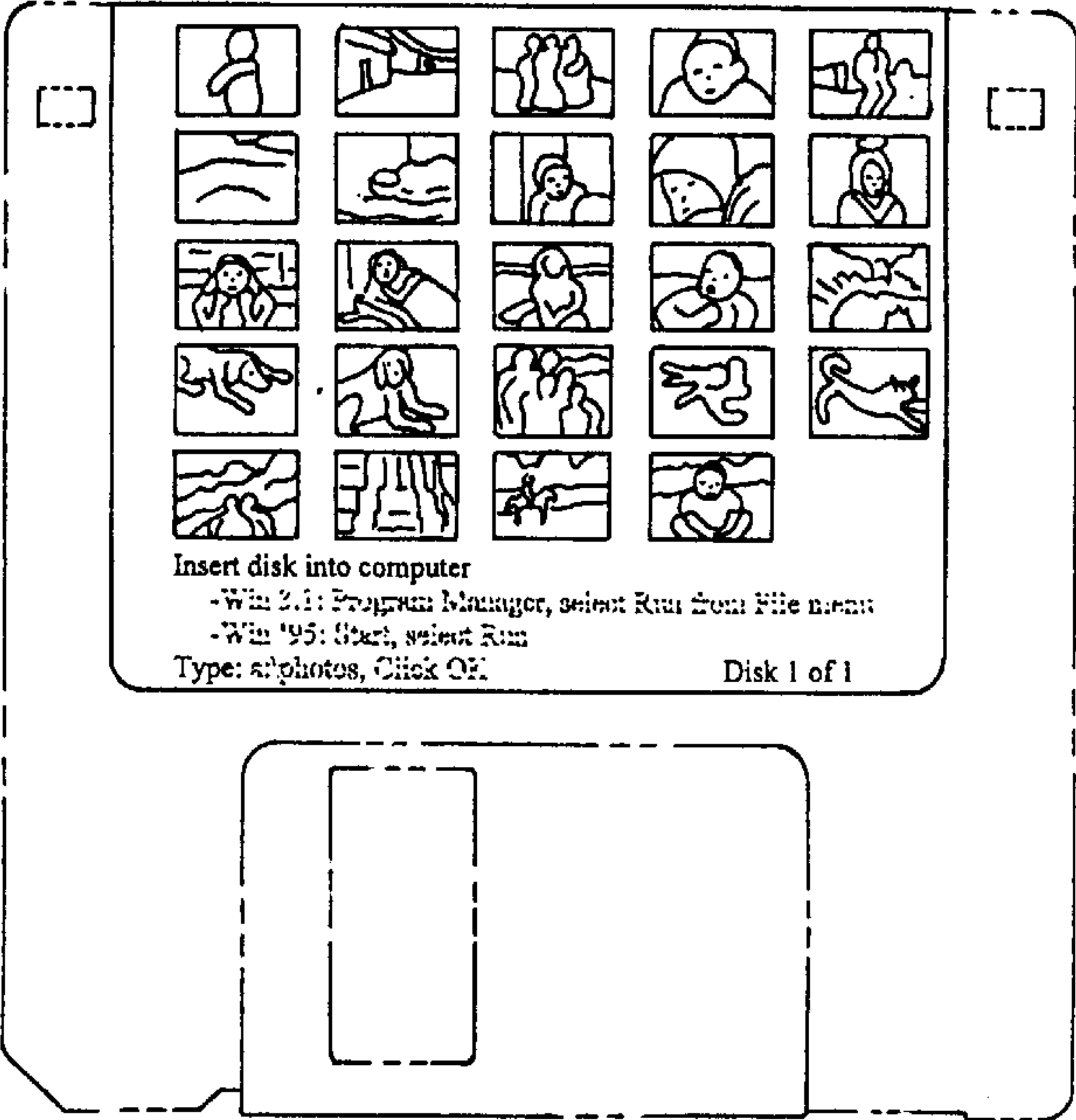

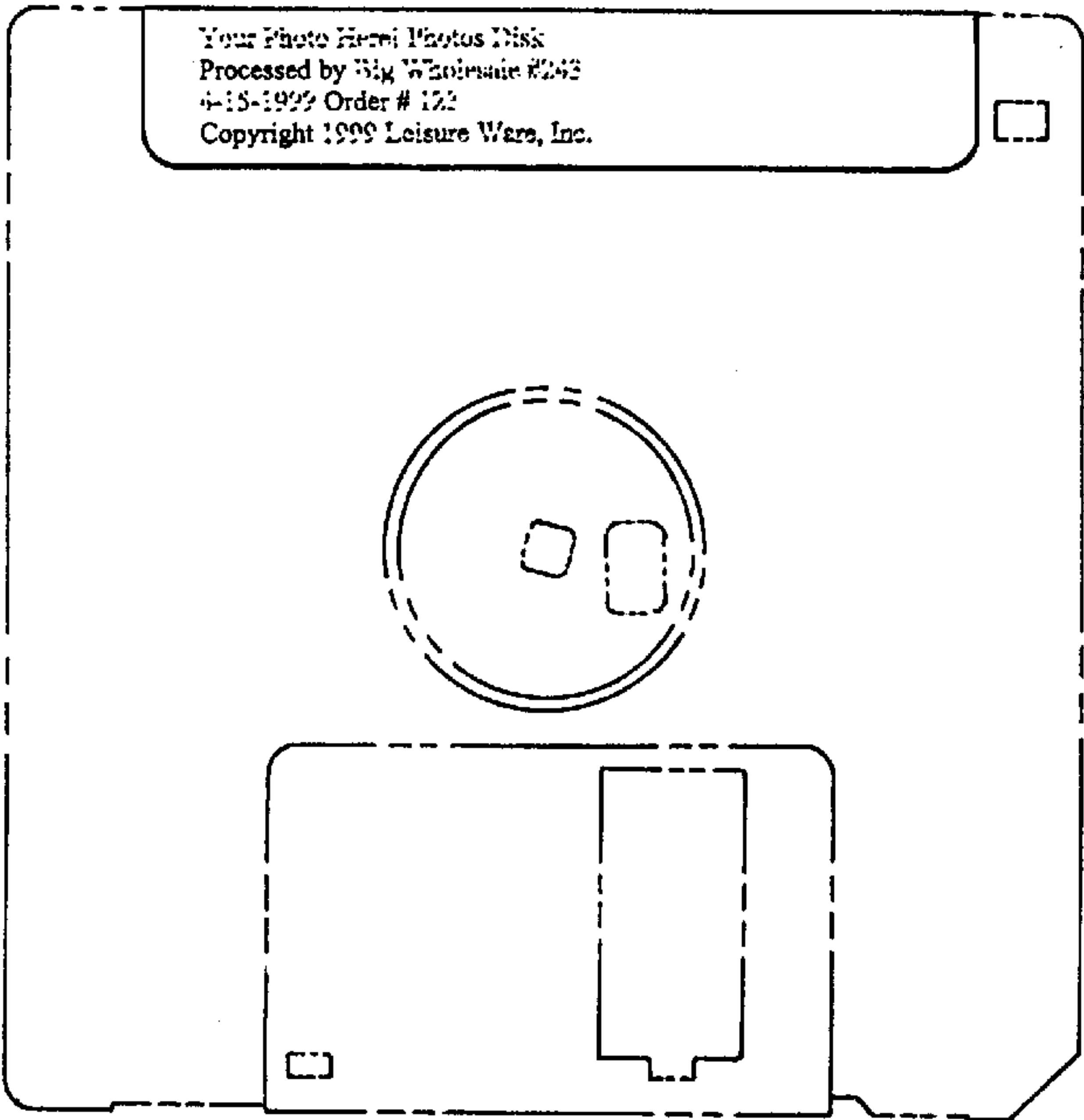

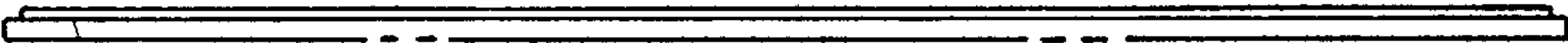
