(57) **CLAIM**

I claim the ornamental design for a light fixture, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a light fixture showing my new design.

FIG. 2 is a side elevational view thereof.

FIG. 3 is a top plan view thereof.

FIG. 4 is a bottom plan view thereof.

FIG. 5 is a side elevation view taken from the opposite side from FIG. 2.

FIG. 6 is an end elevational view with the opposite end being a mirror image thereof.

FIG. 7 is a front perspective view of a modification of the light fixture of FIG. 1.

FIG. 8 is a side elevational view thereof.

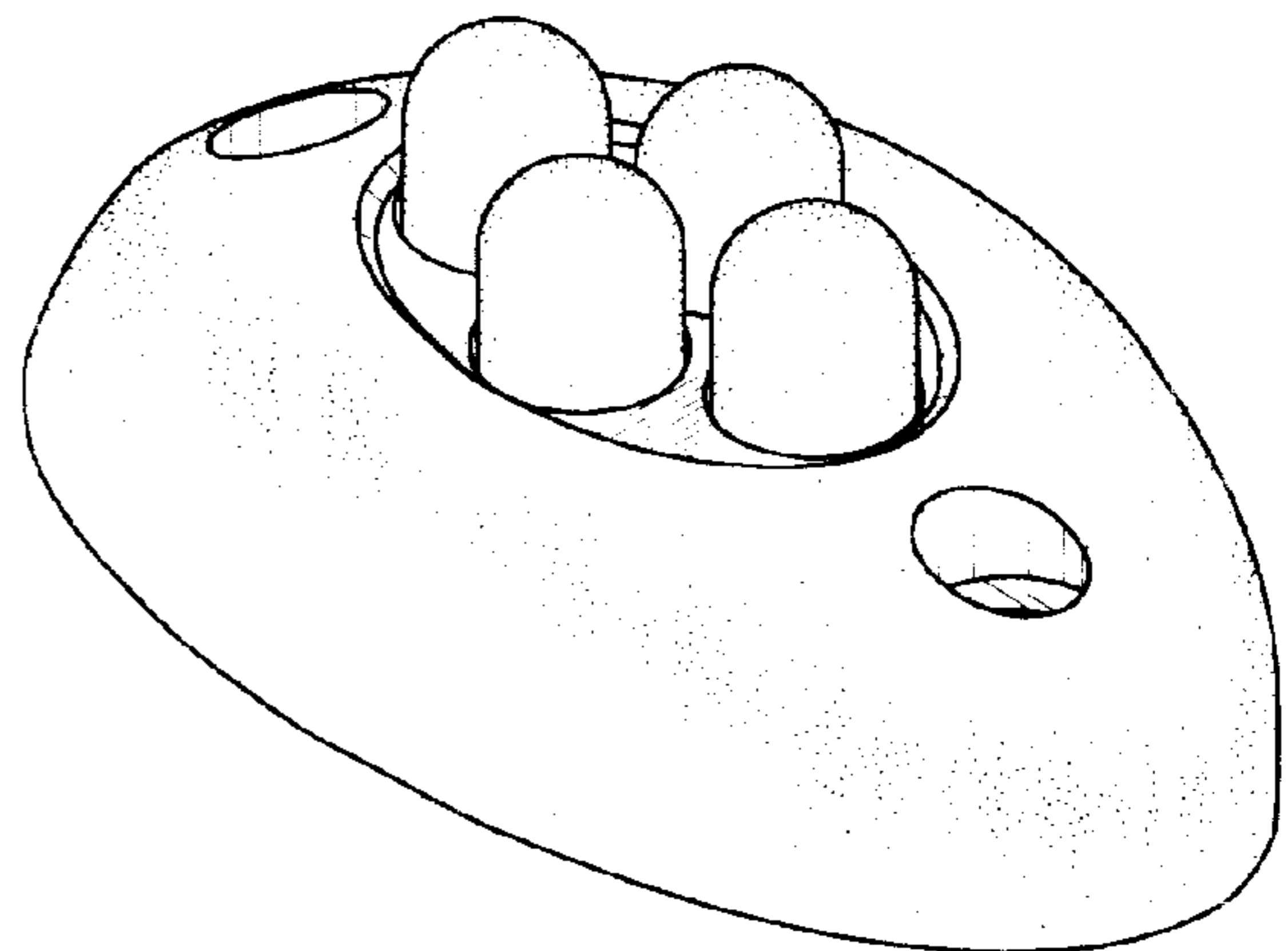
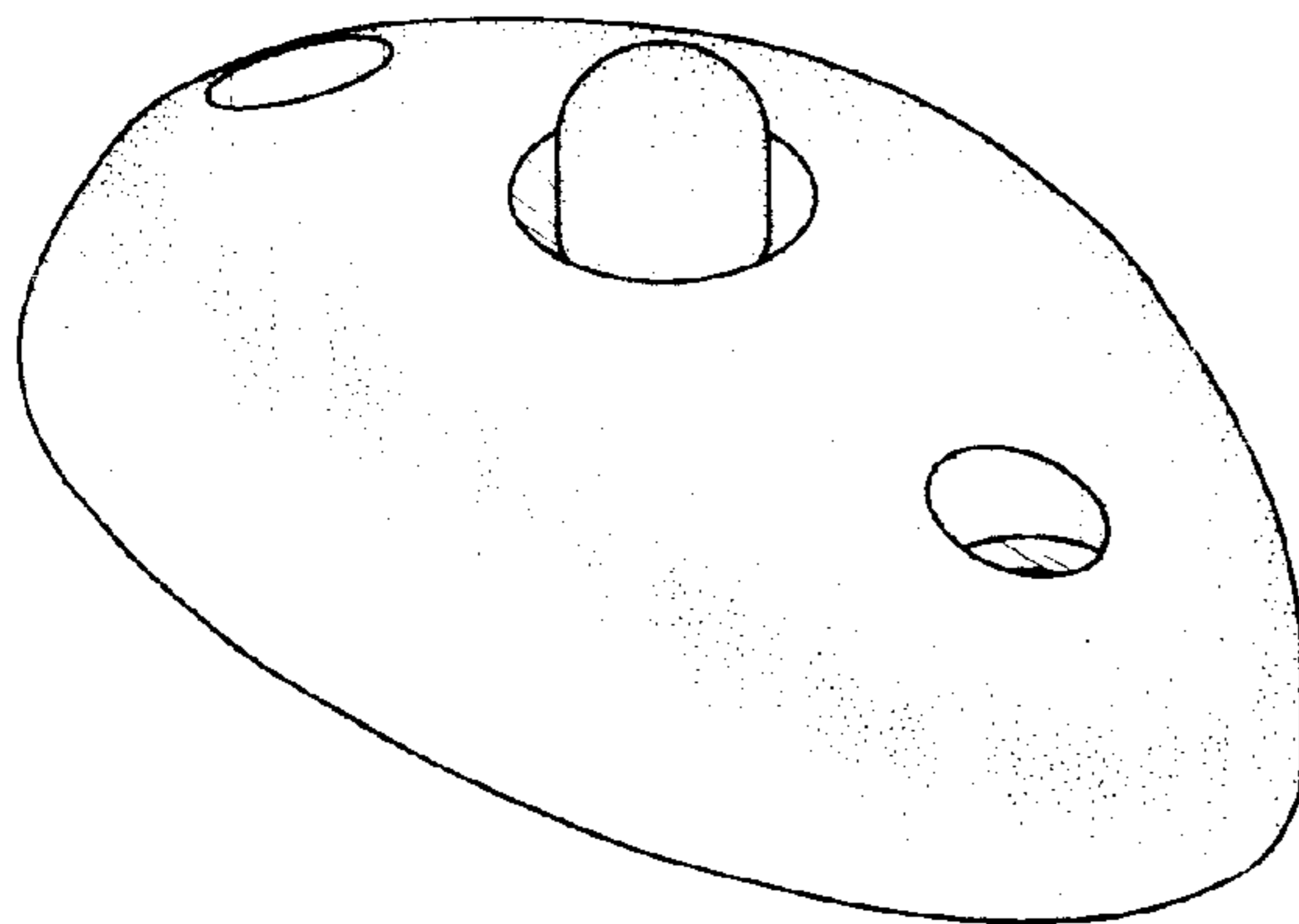
FIG. 9 is a top plan view thereof.

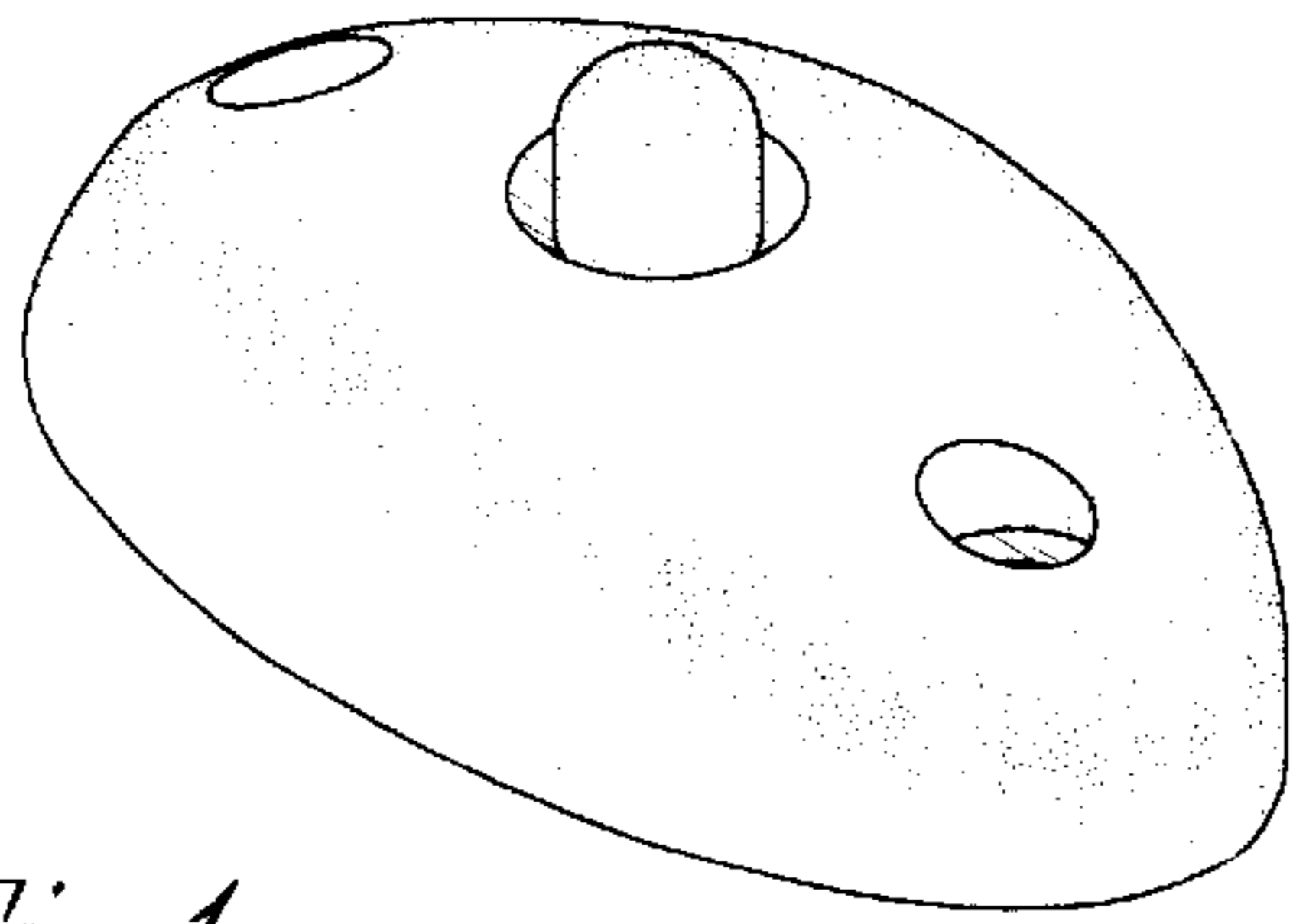
FIG. 10 is a bottom plan view thereof.

FIG. 11 is a side elevation view taken from the opposite side from FIG. 8; and,

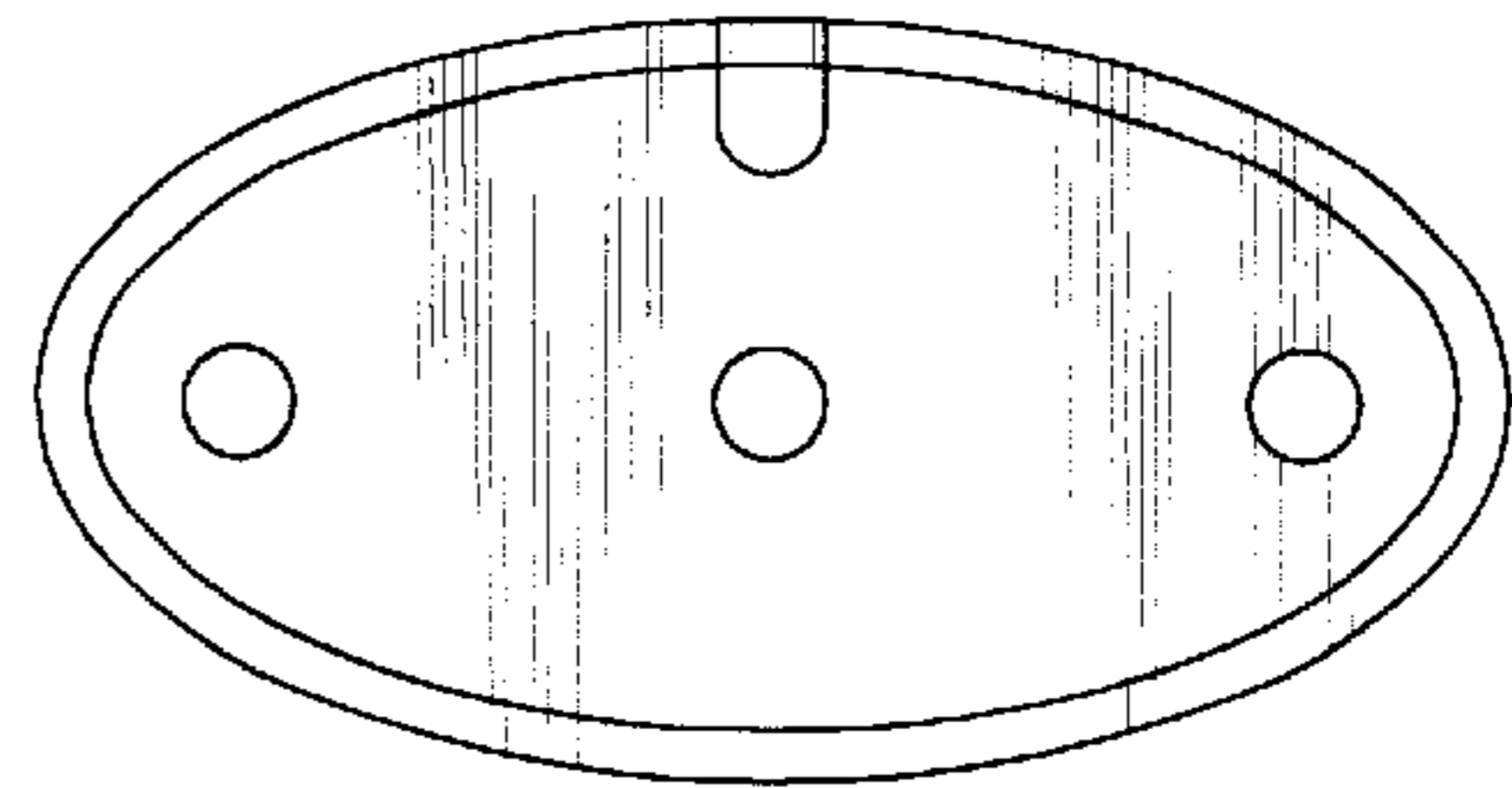
FIG. 12 is an end elevational view with the opposite end being a mirror image thereof.

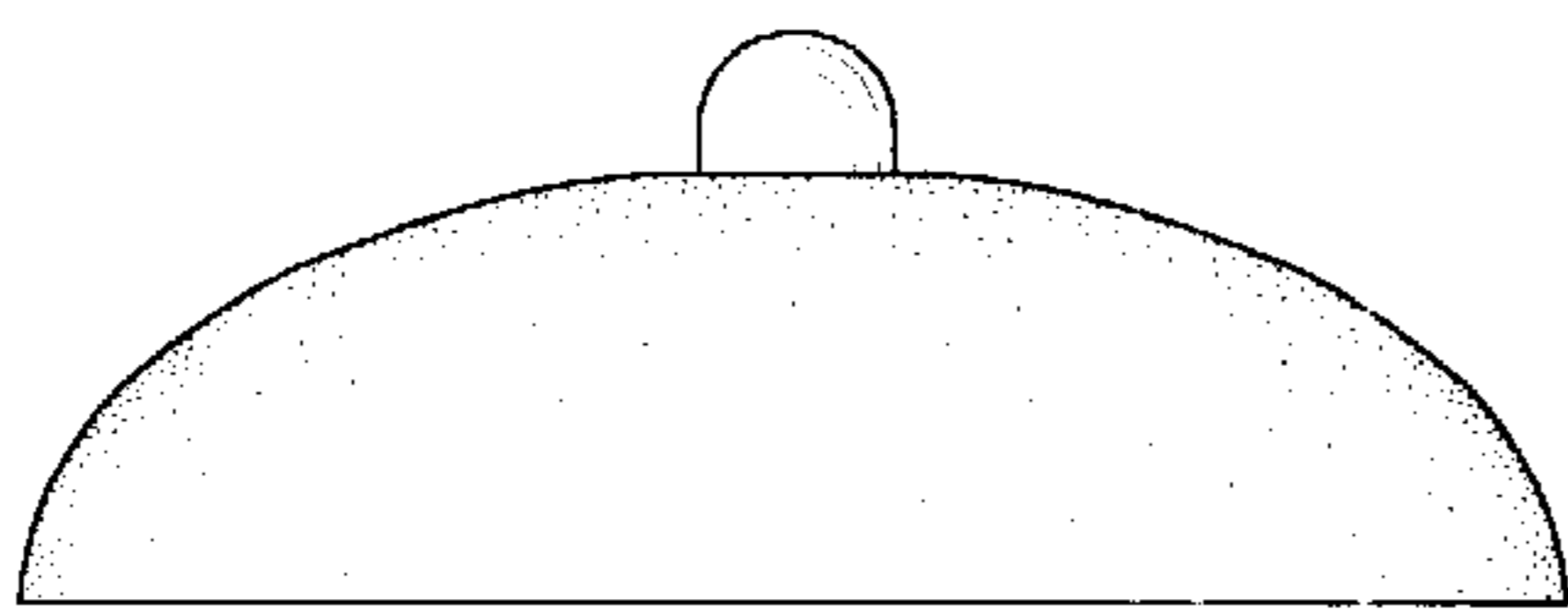




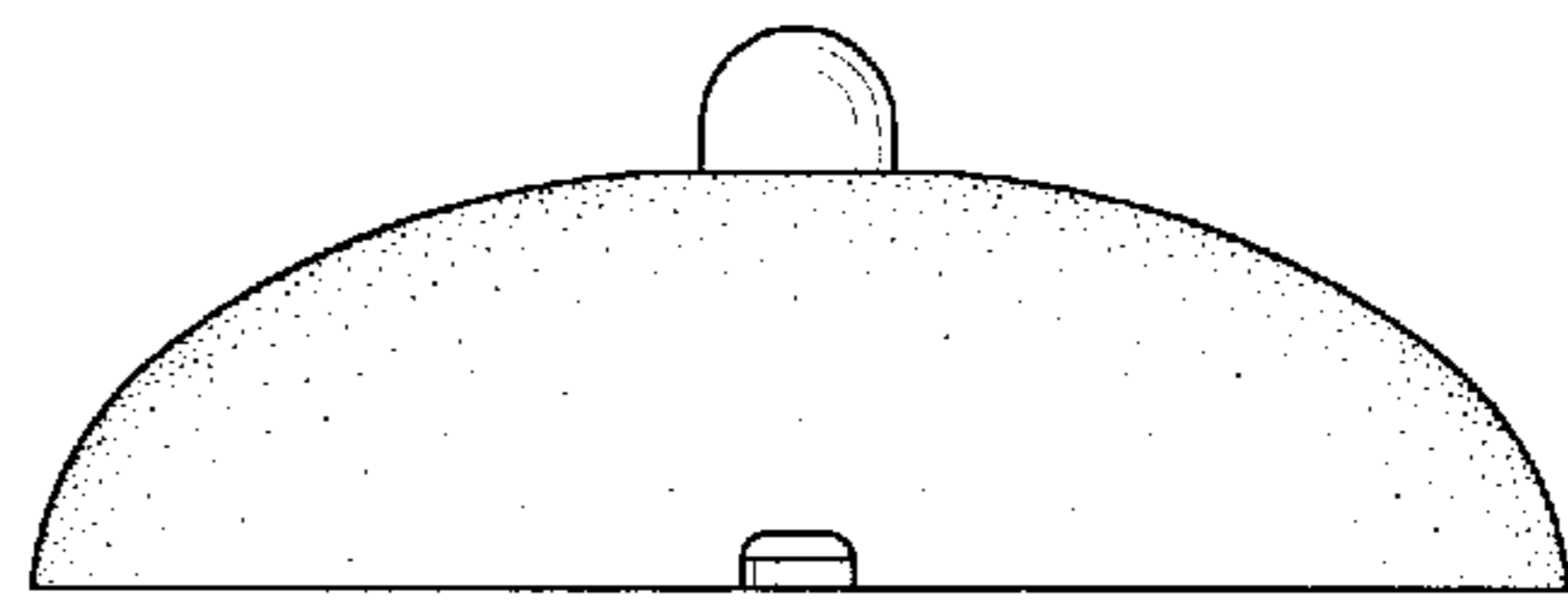

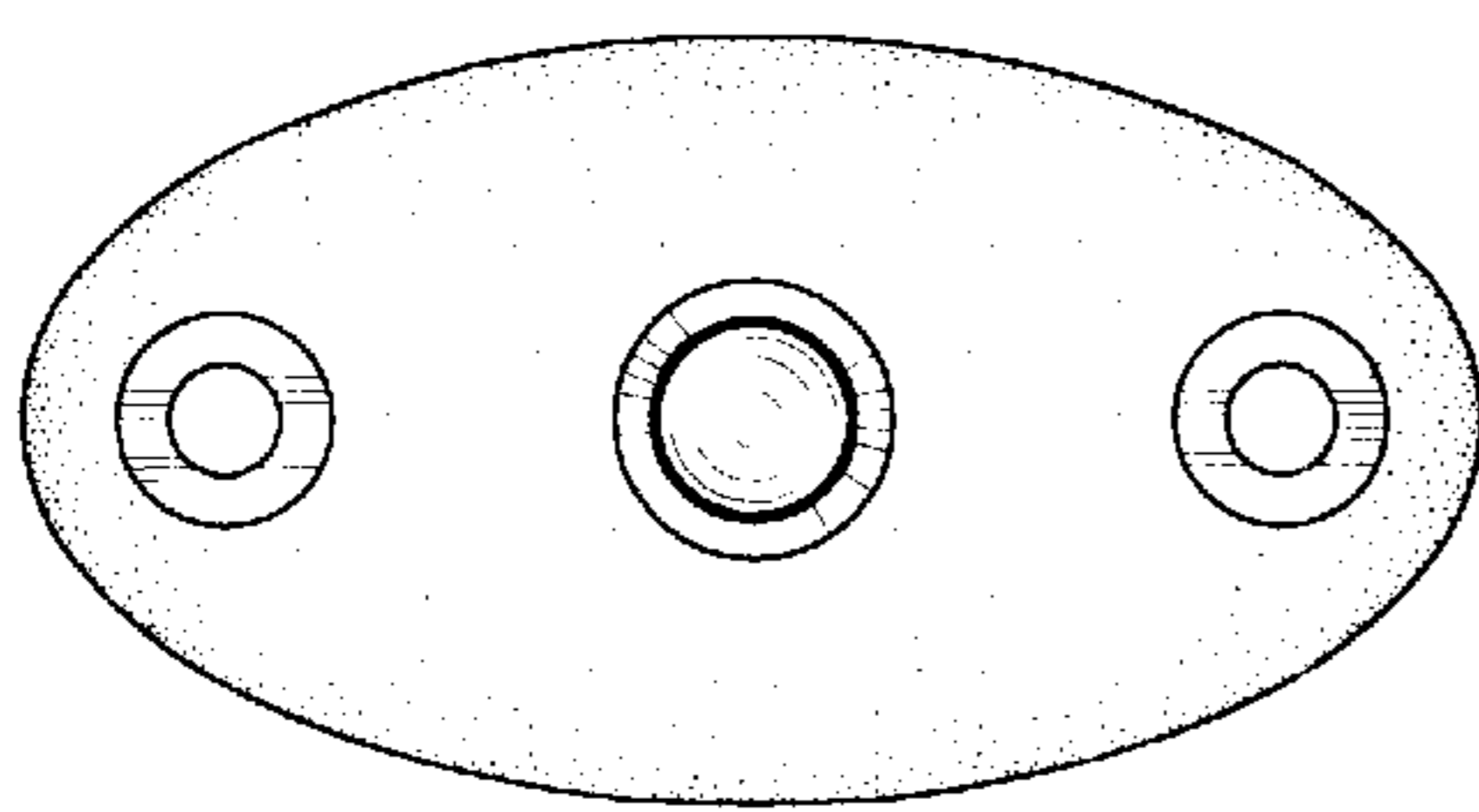

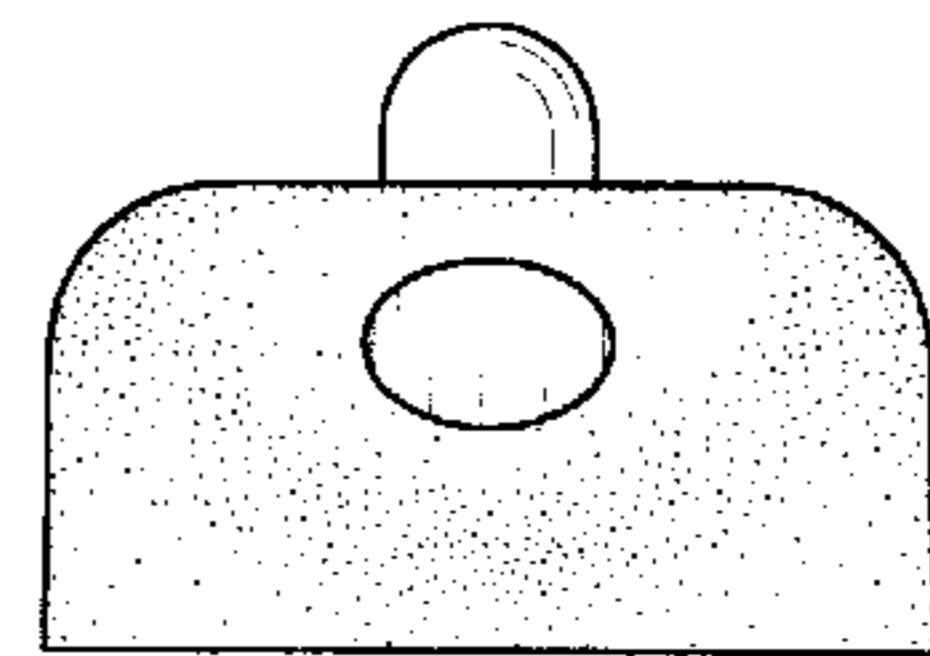

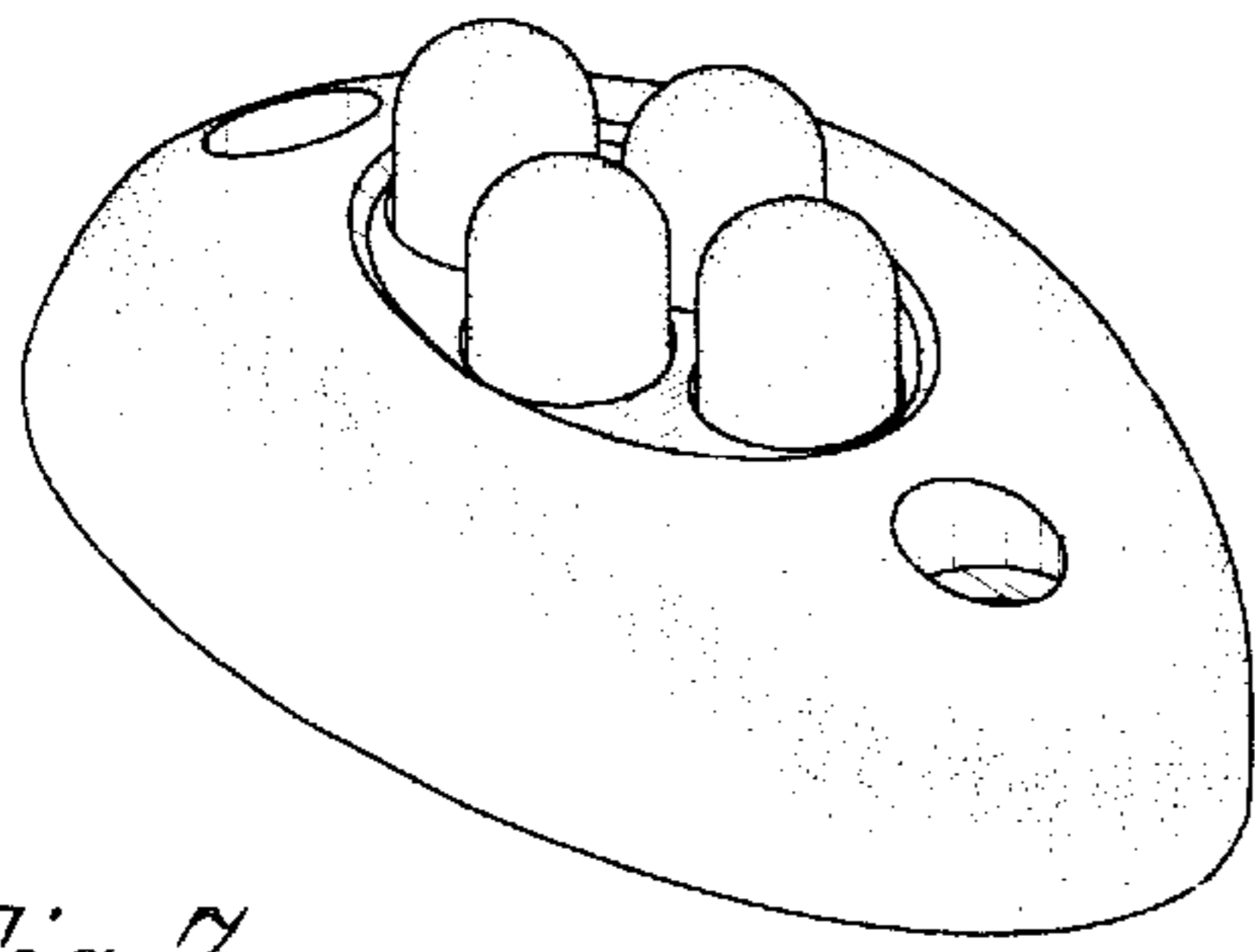

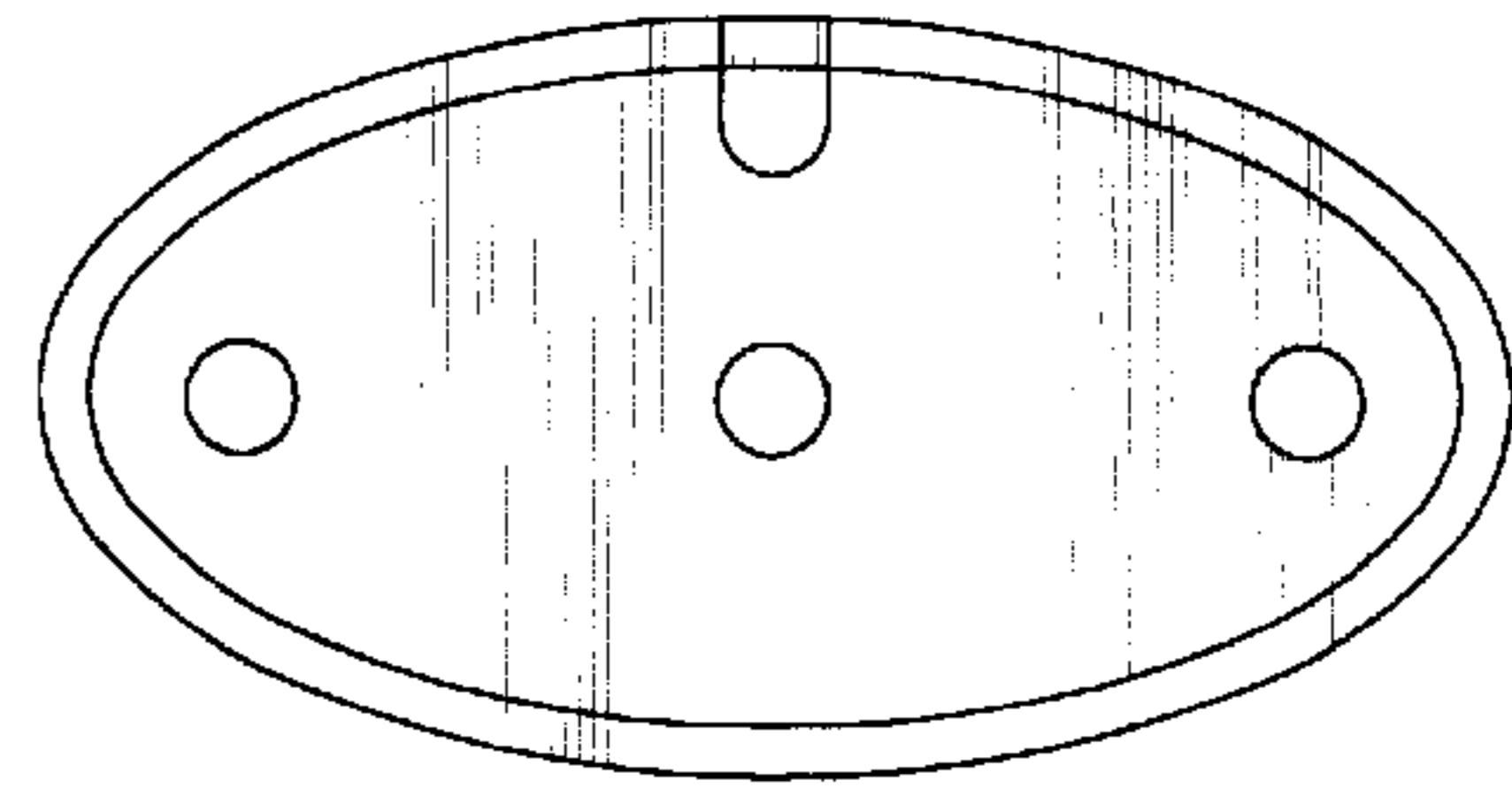

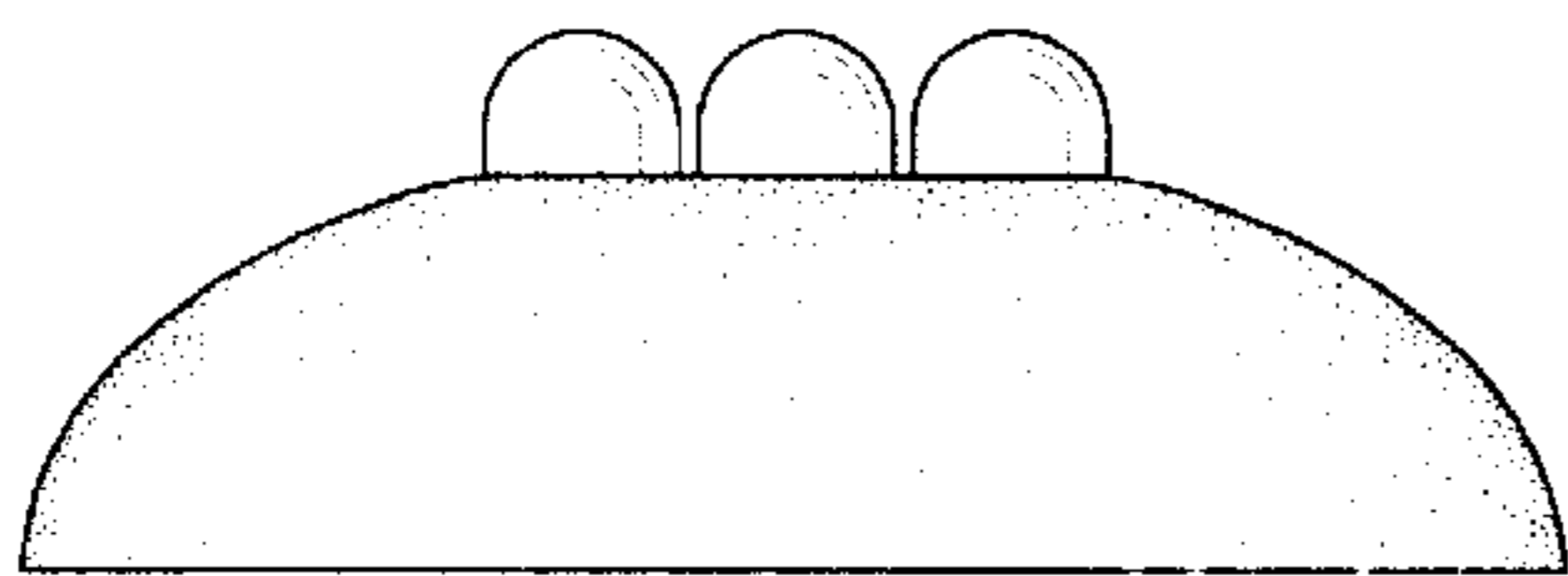

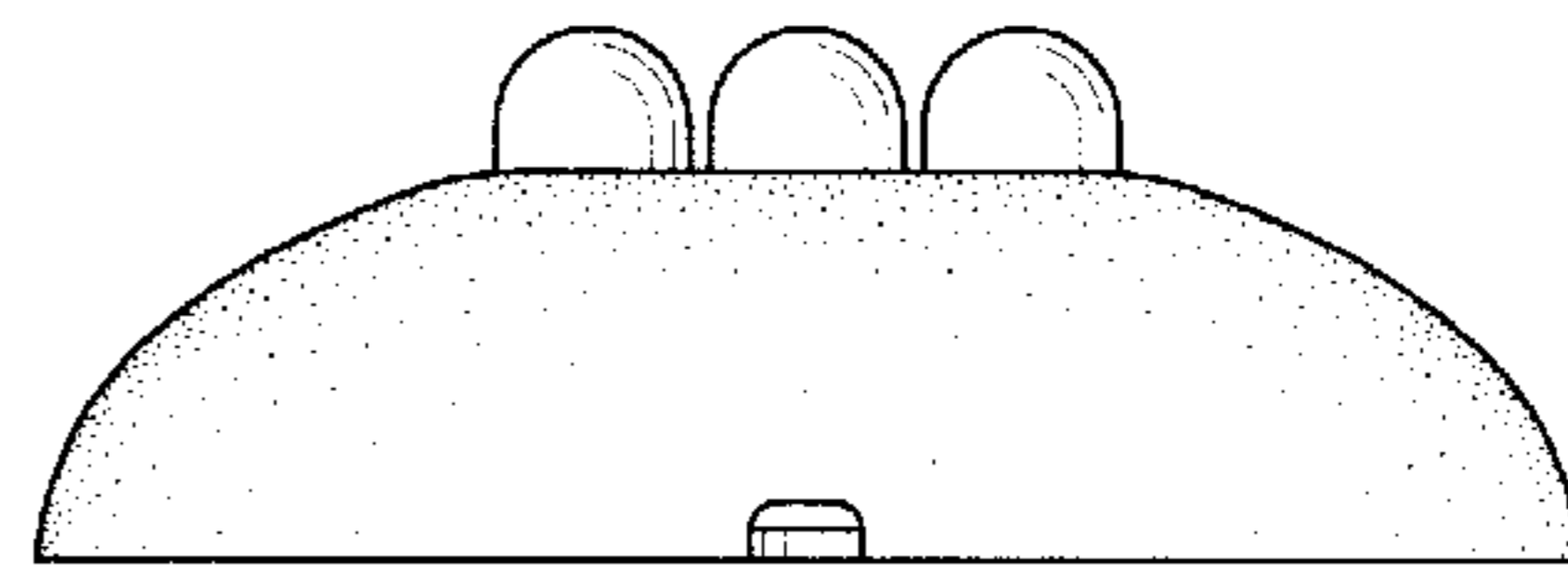

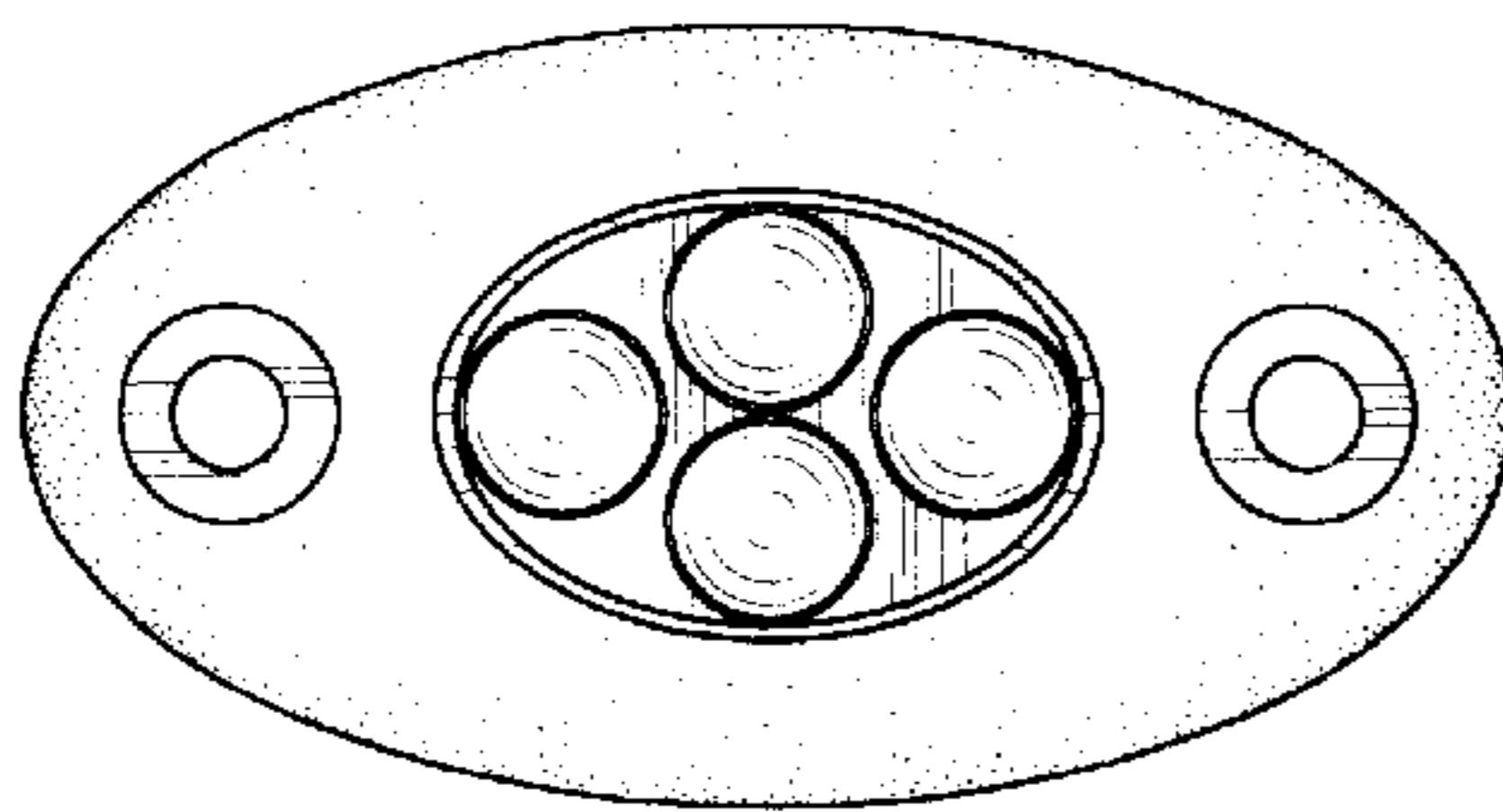

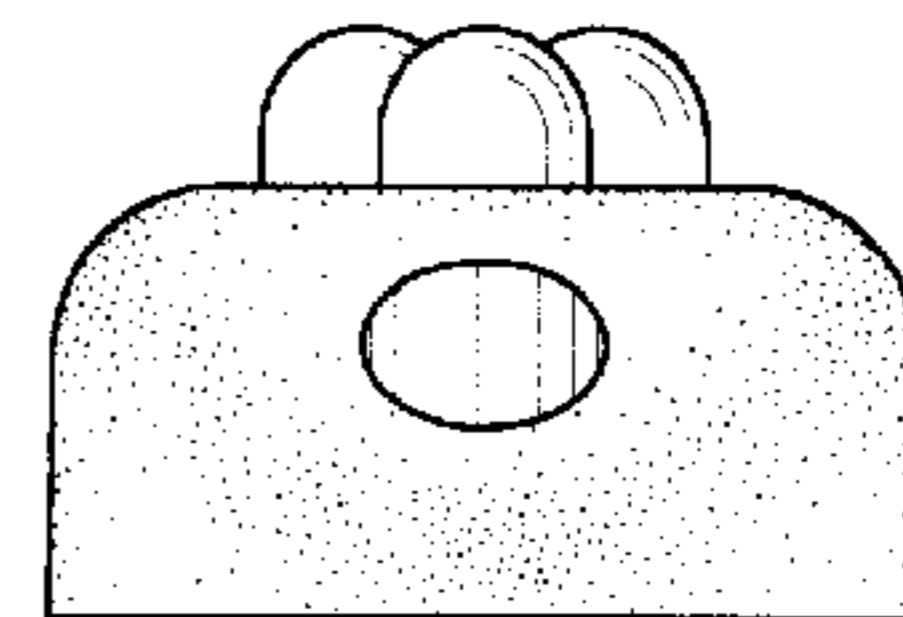
