## DESCRIPTION

FIG. 1 is a perspective view of a bracket according to the present invention;

FIG. 2 is a front view of the bracket shown in FIG. 1; FIG. 3 is a rear view of the bracket shown in FIG. 1; FIG. 4 is a right side view of the bracket shown in FIG. 2; FIG. 5 is a left side view of the bracket shown in FIG. 2; FIG. 6 is a top view of the bracket shown in FIG. 2; FIG. 7 is a bottom view of the bracket shown in FIG. 2; and, FIG. 8 is a reduced, environmental perspective view of the bracket with the broken line showing of structure and additional brackets being for illustrative purposes only and forming no part of the claimed design.
