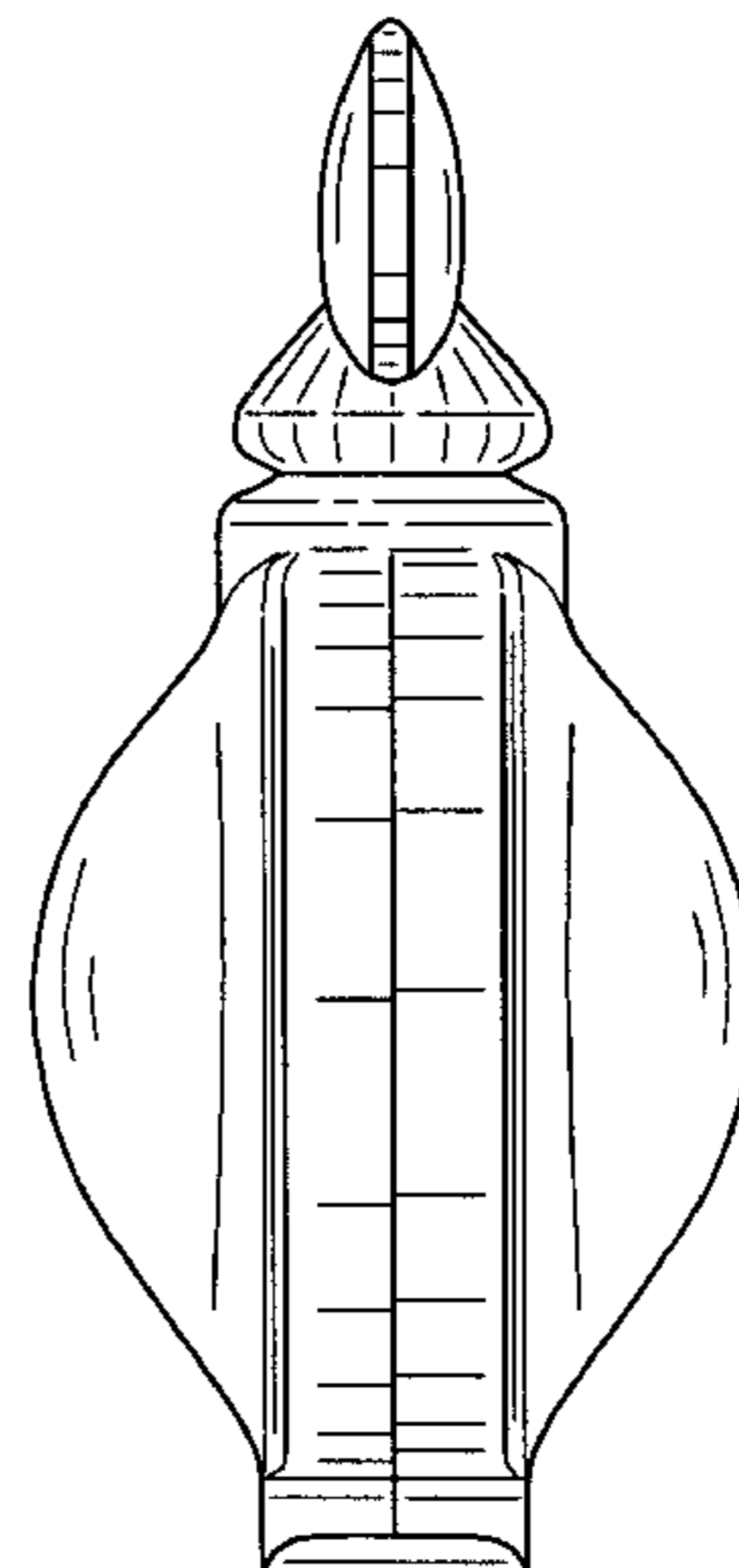
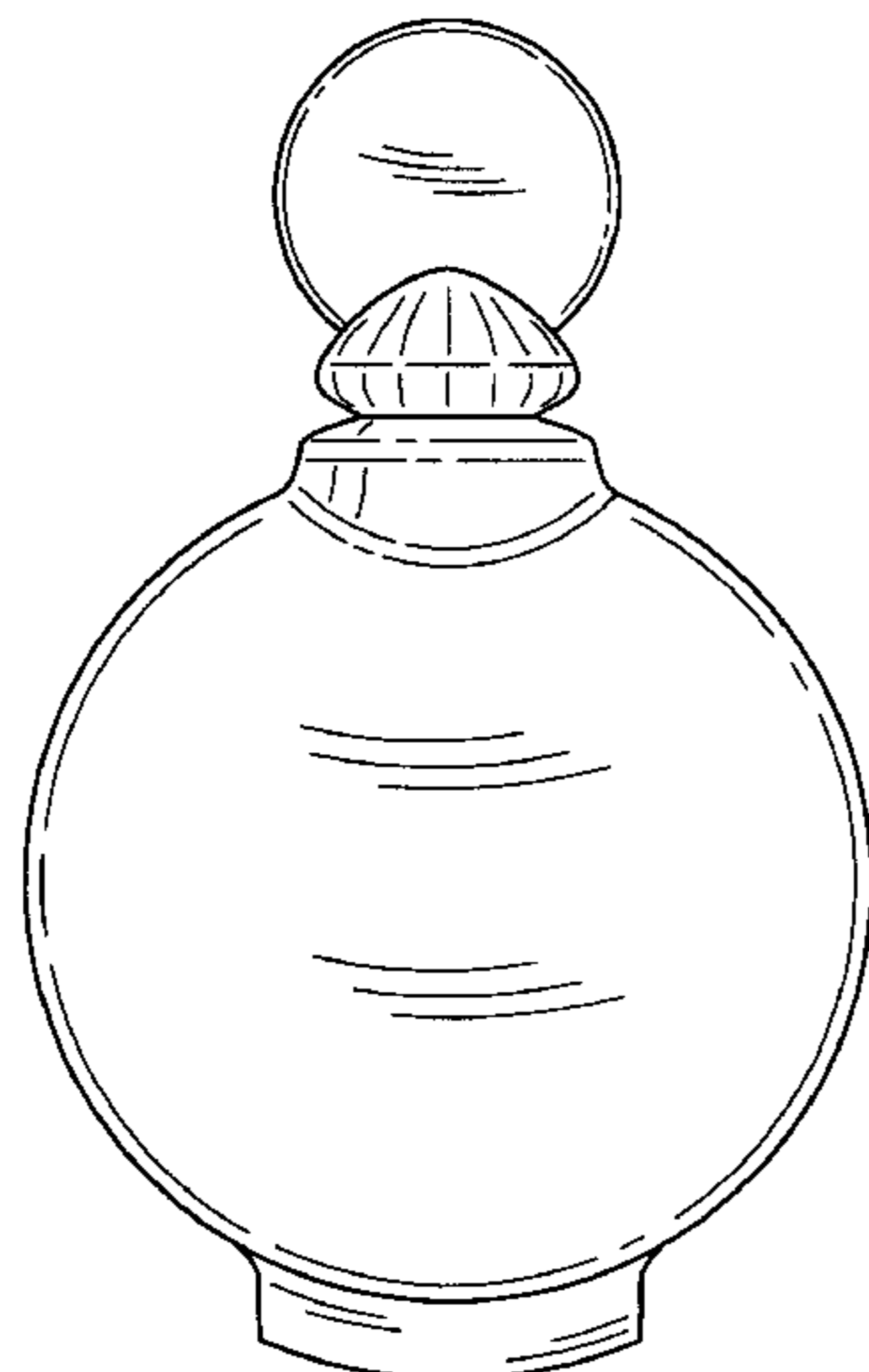
(57) **CLAIM**

FIG. 1 is a front view of my capsule, the rear view being identical;

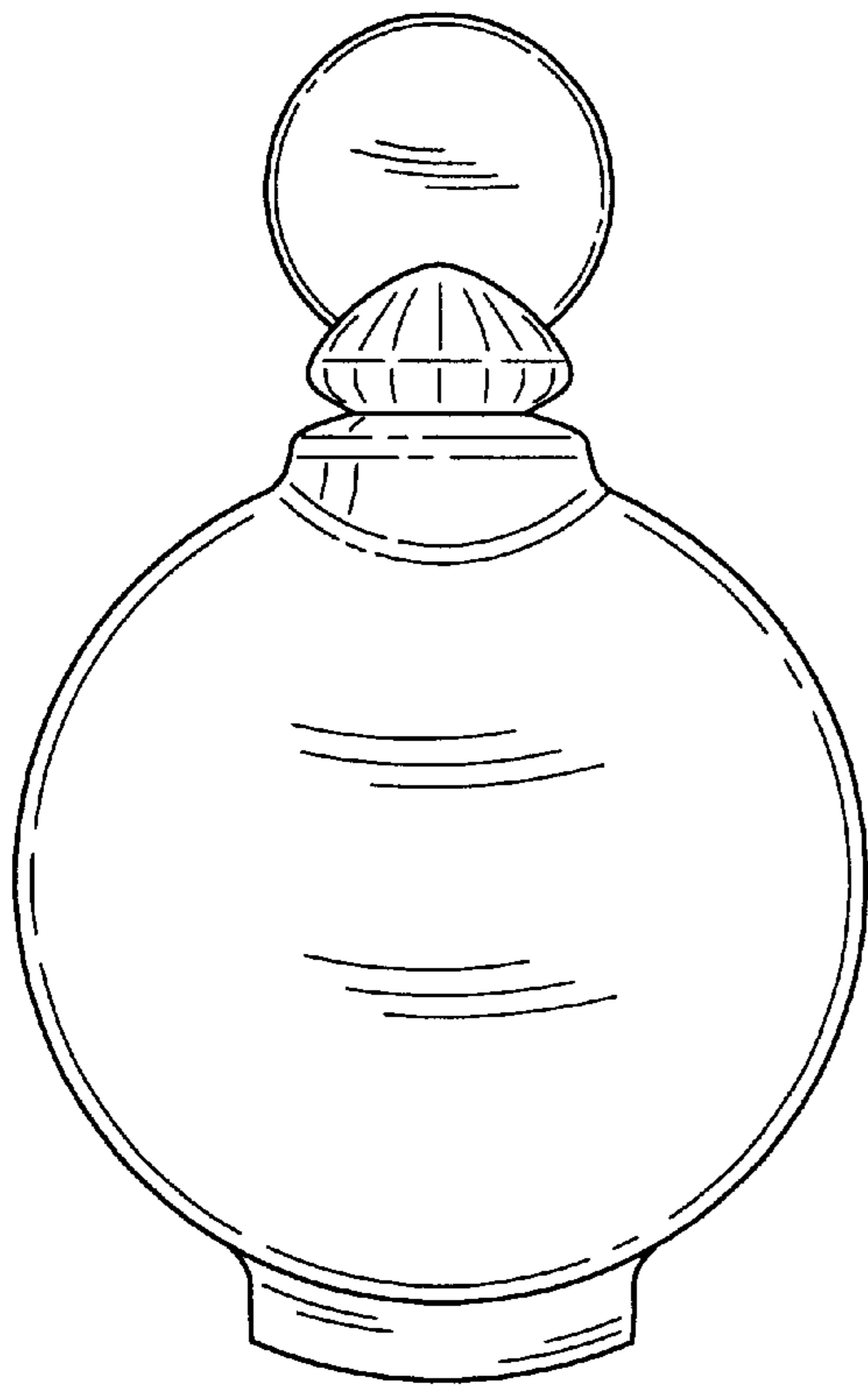

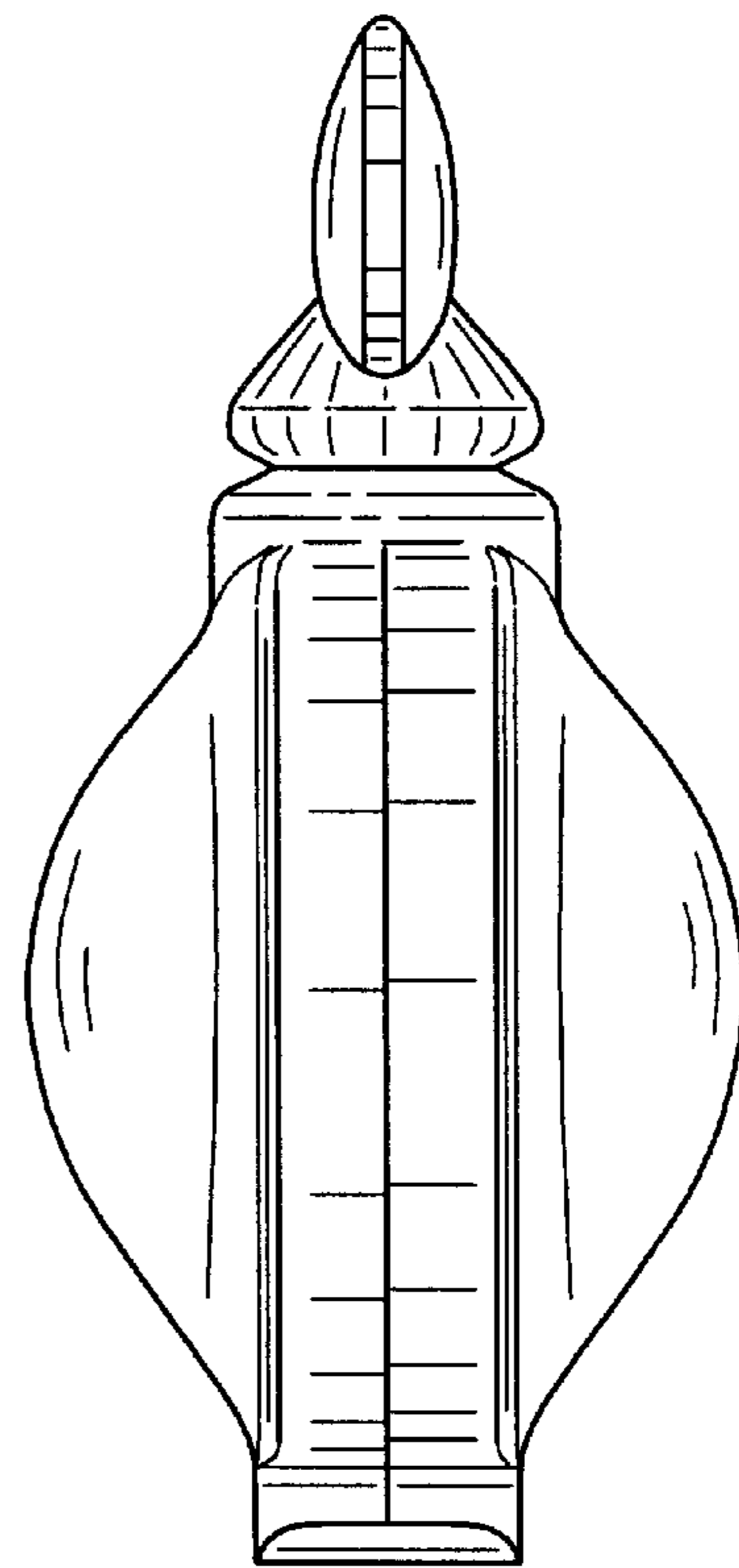

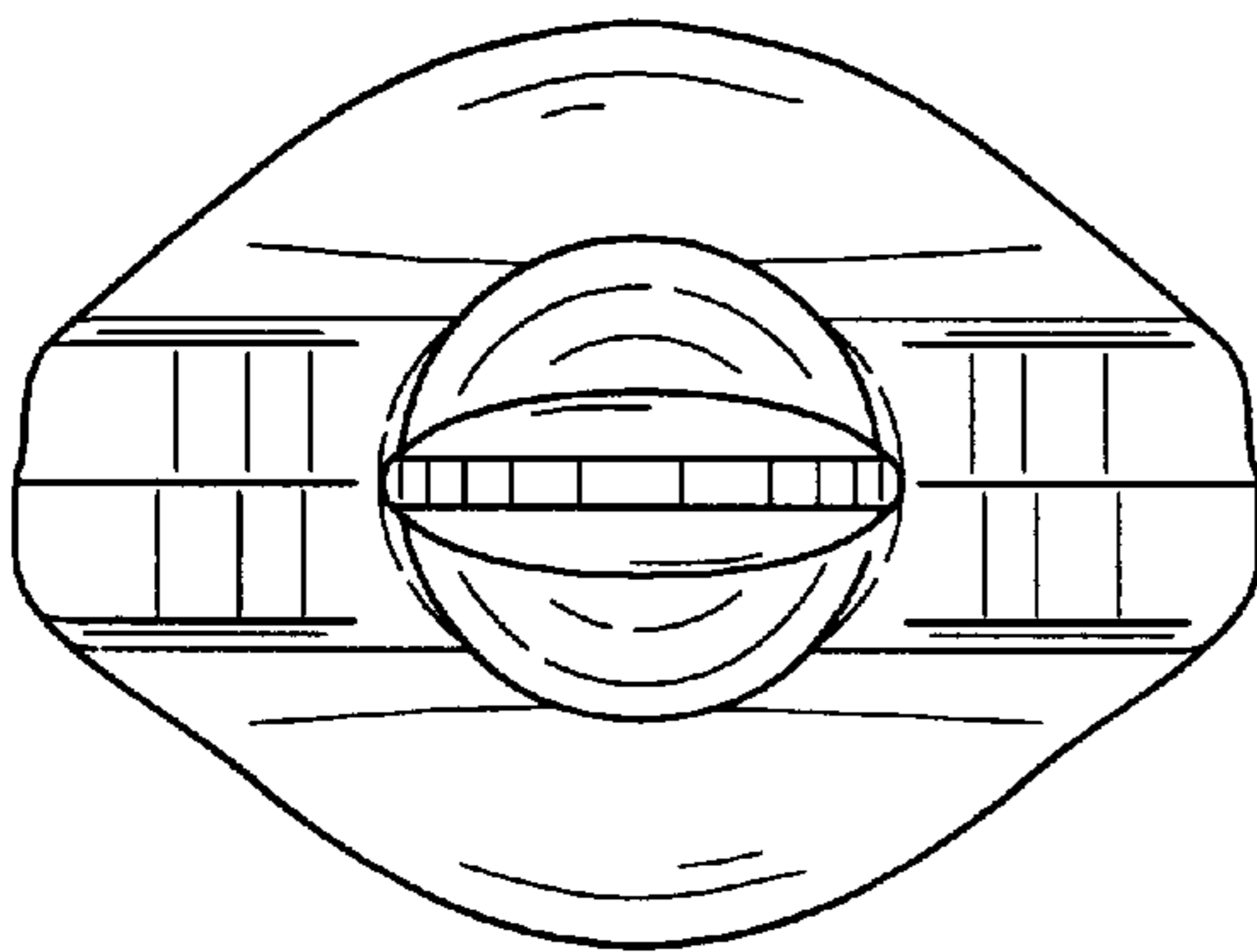

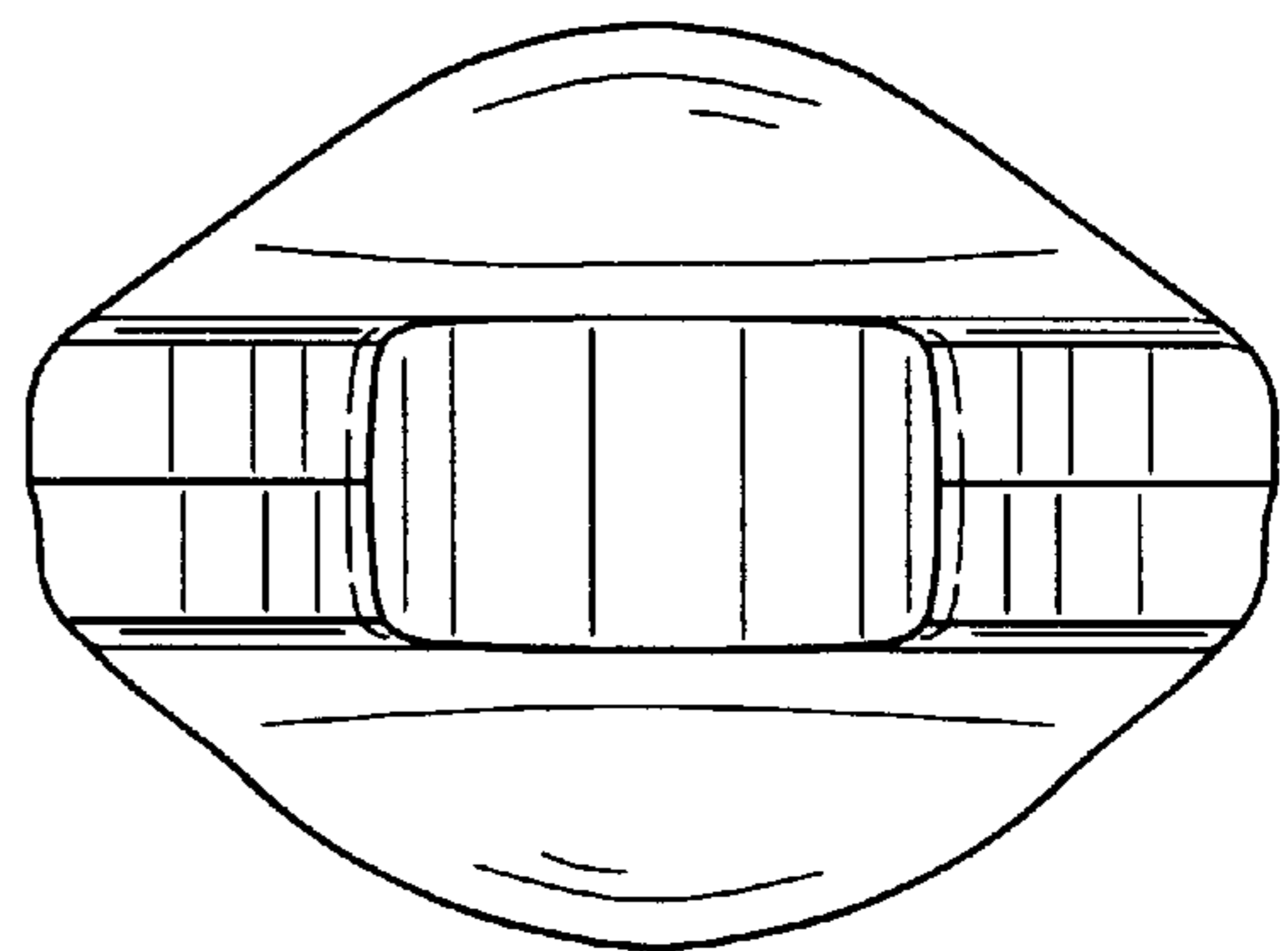
